FIG. 17 is the seventeenth image thereof;

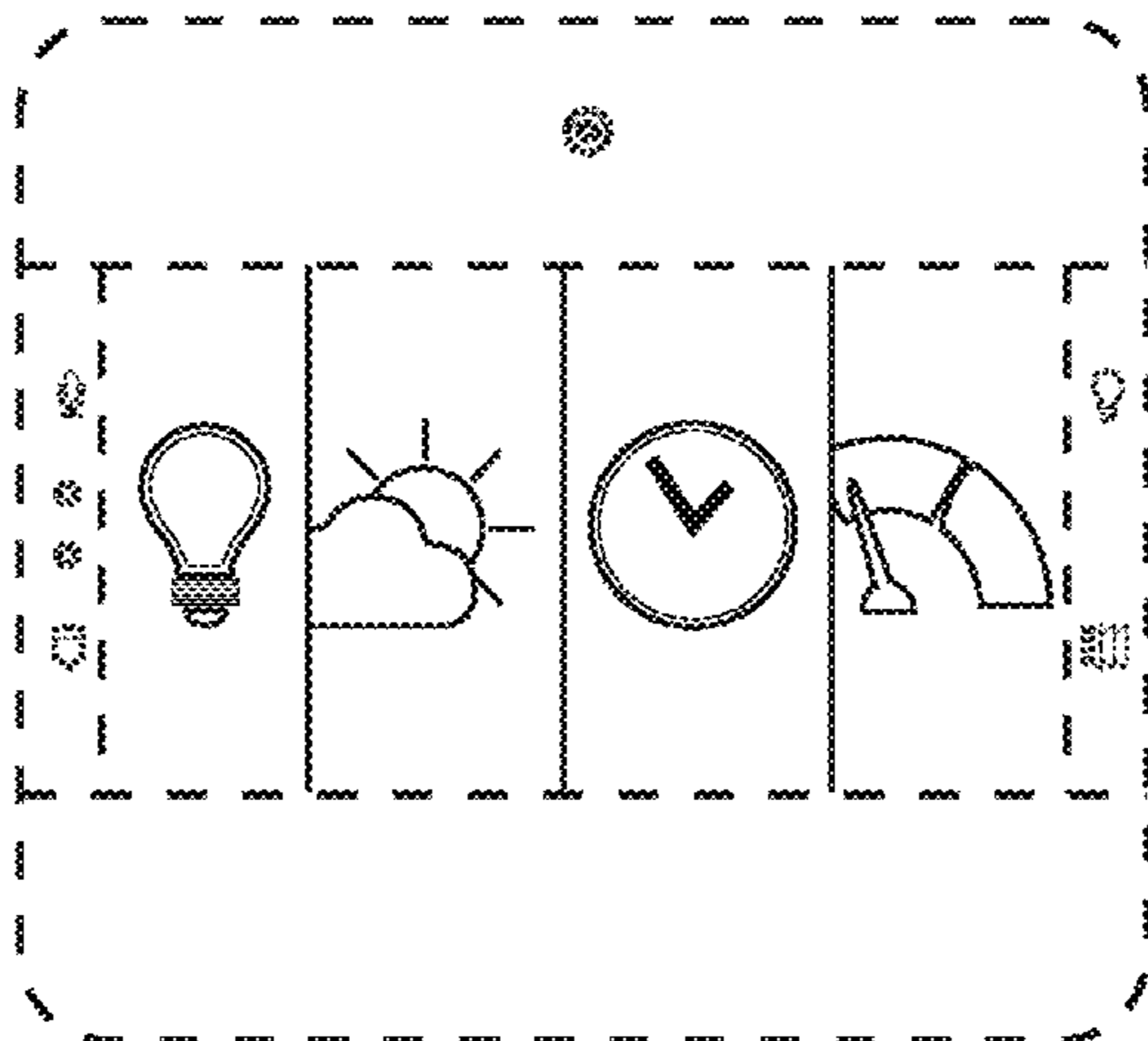

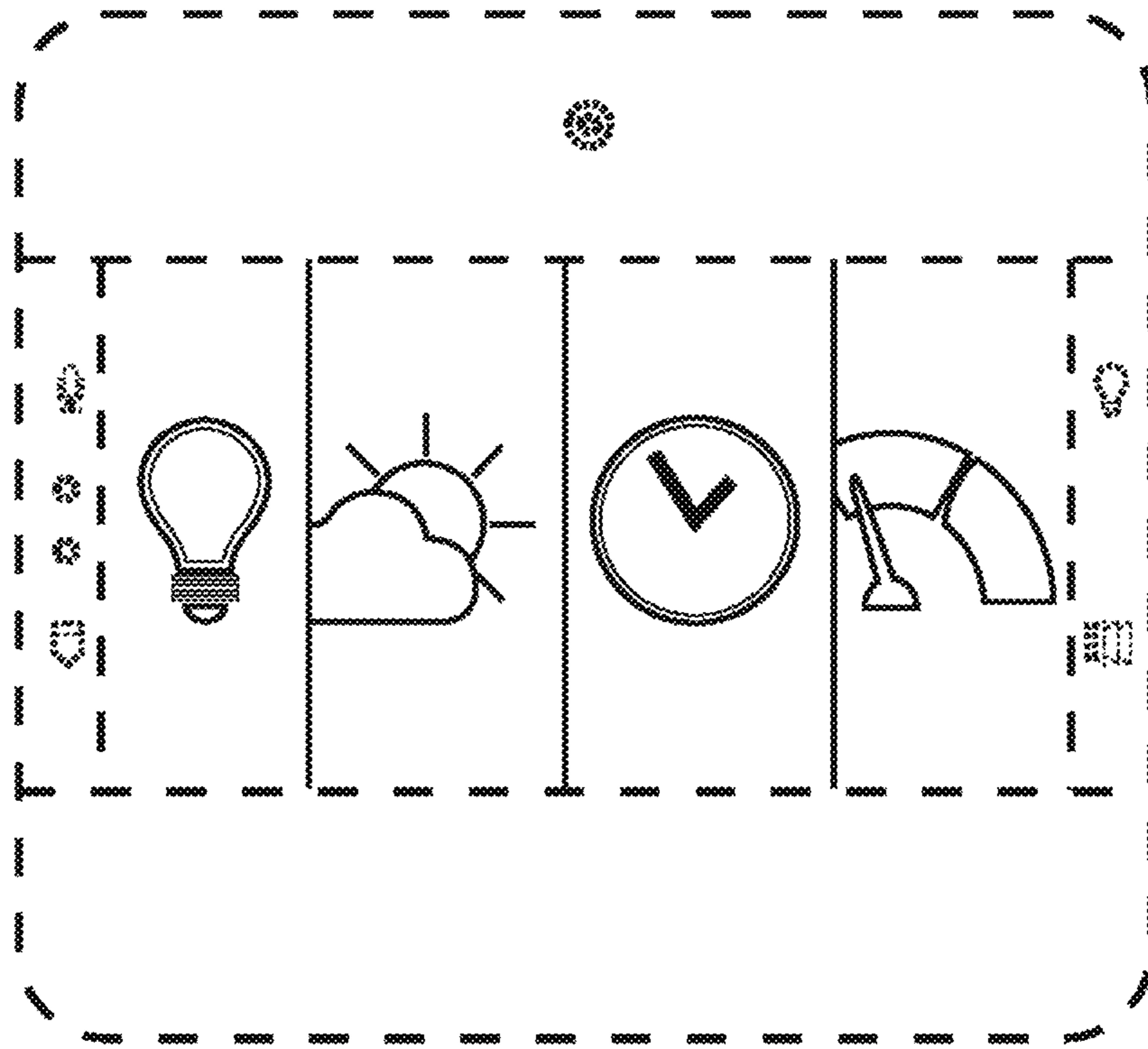

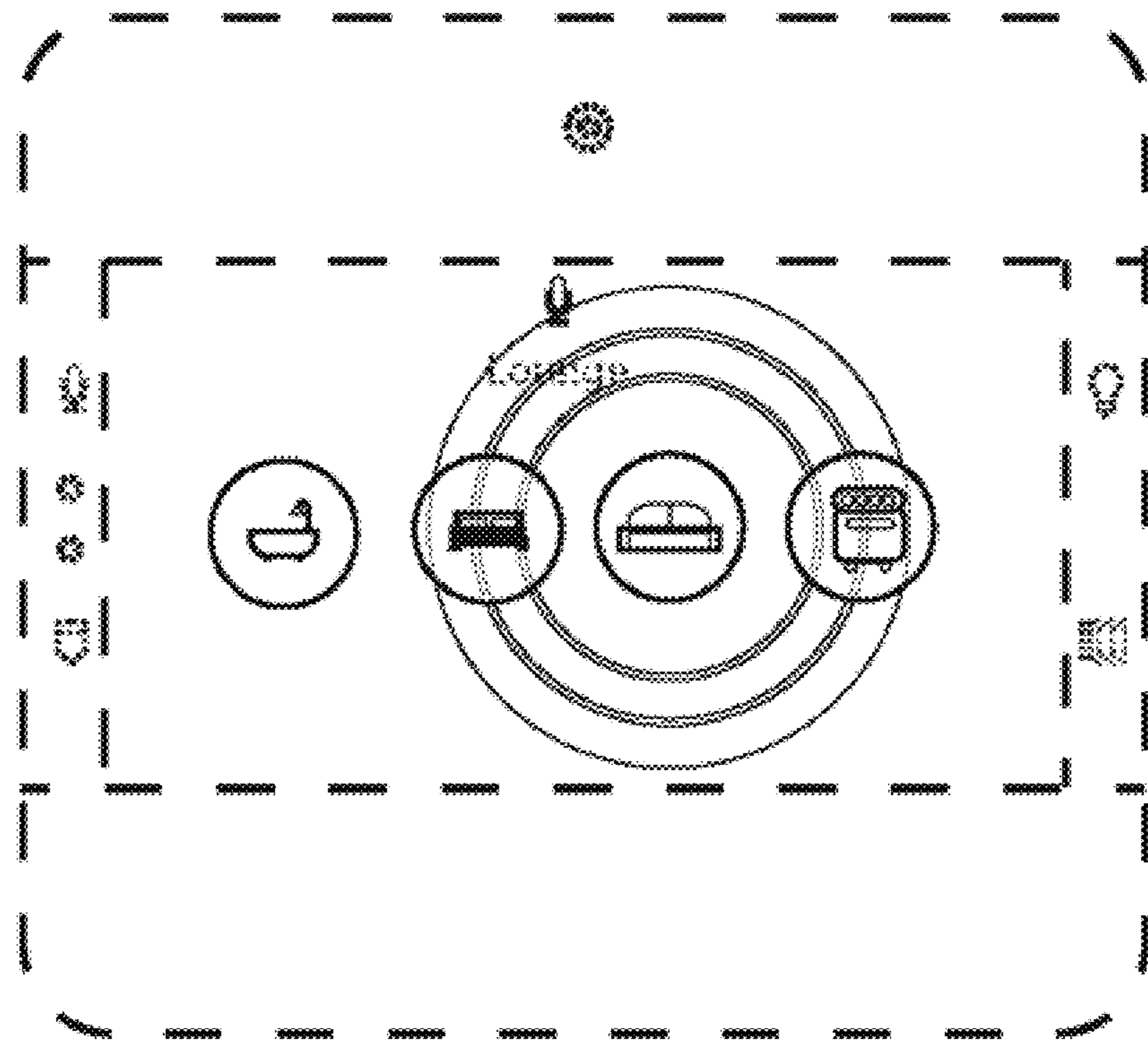

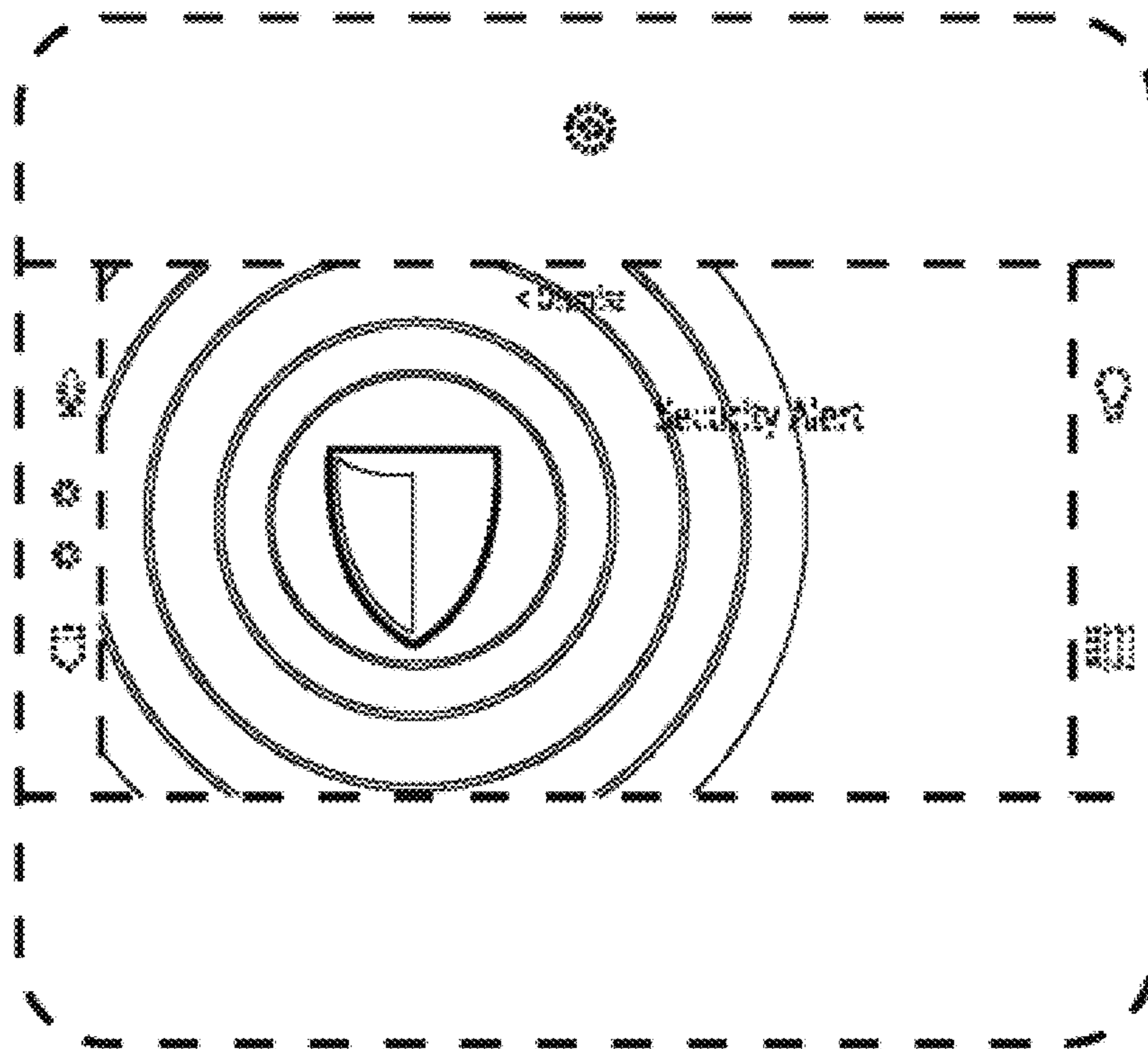

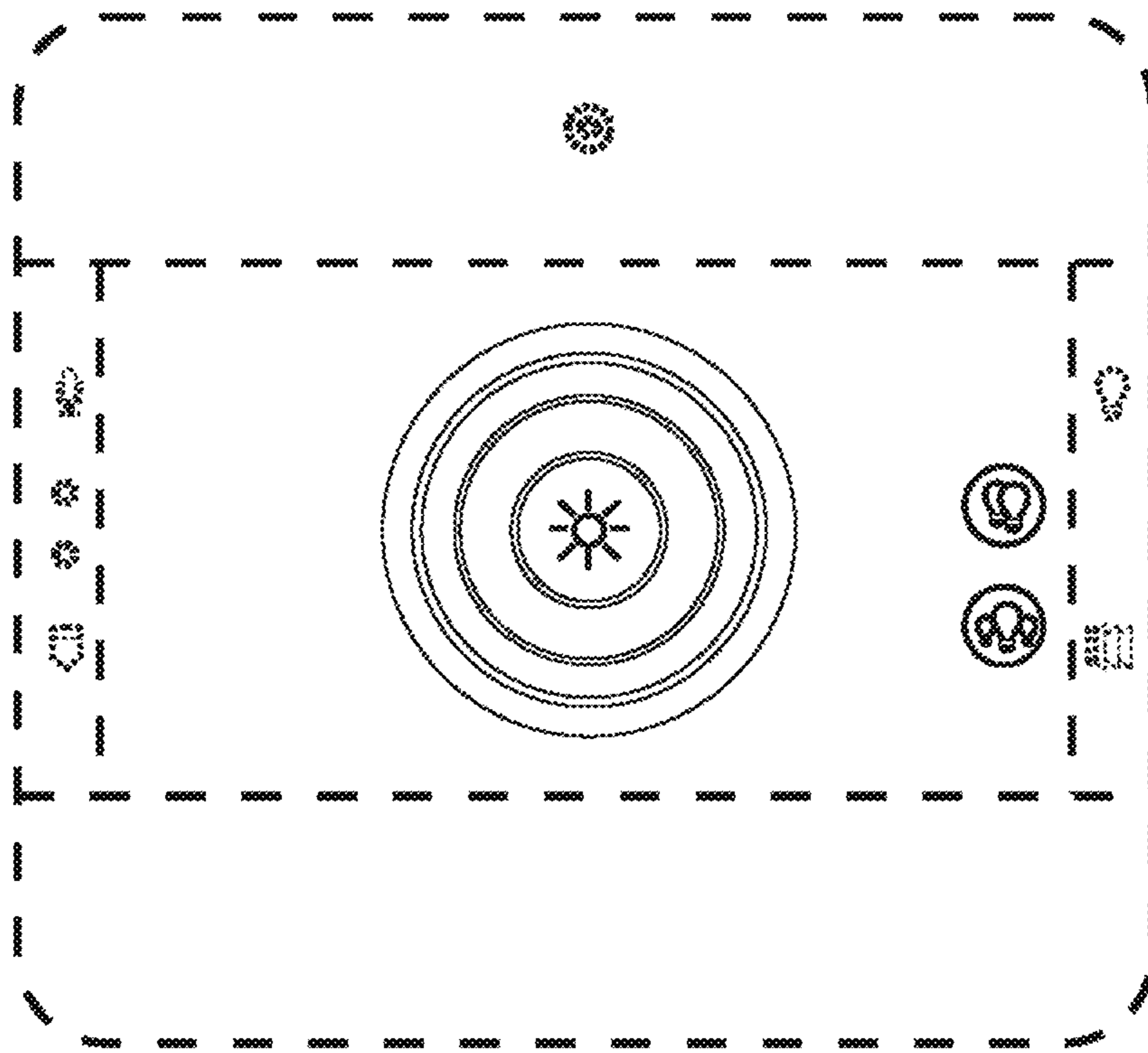

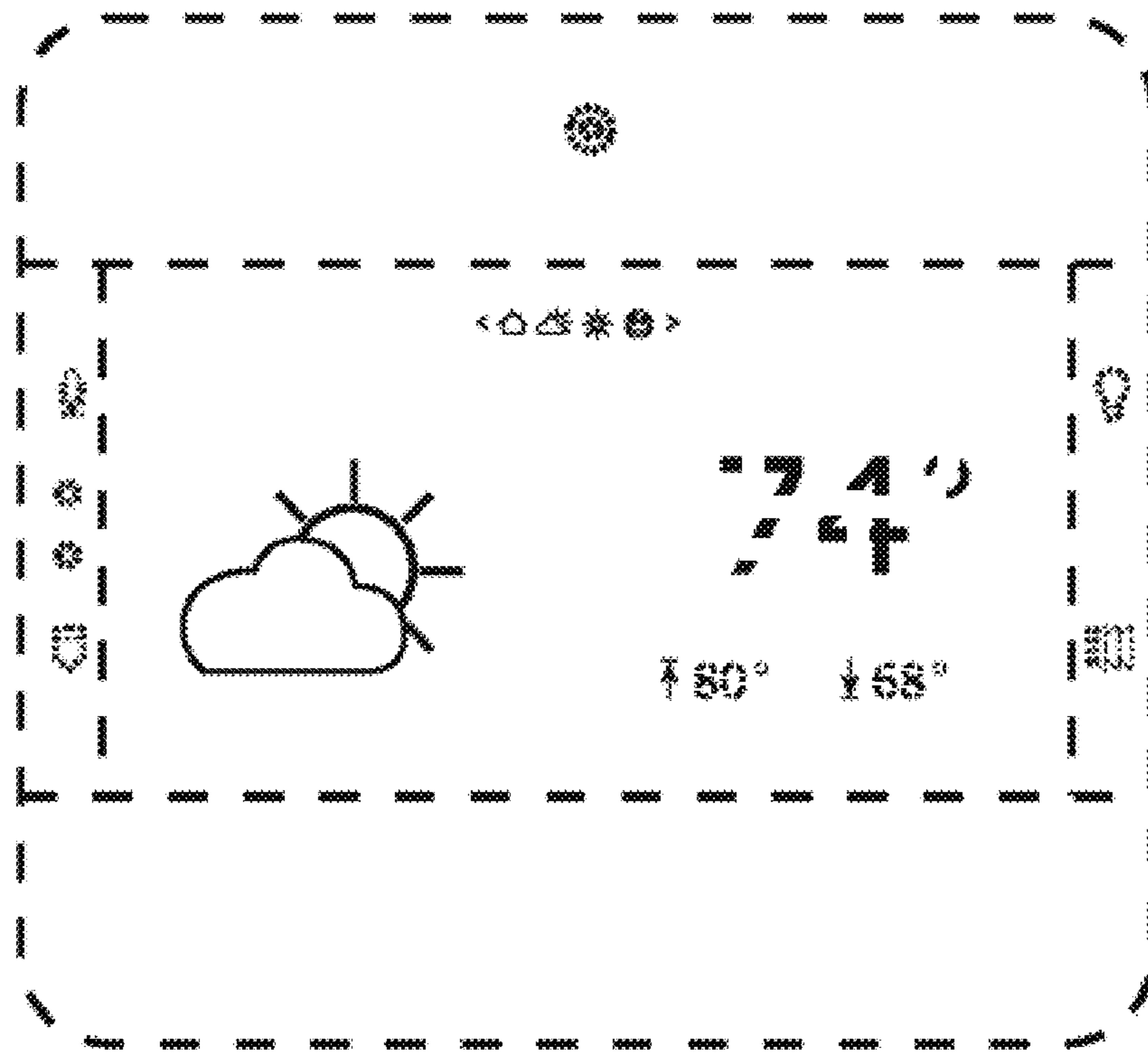

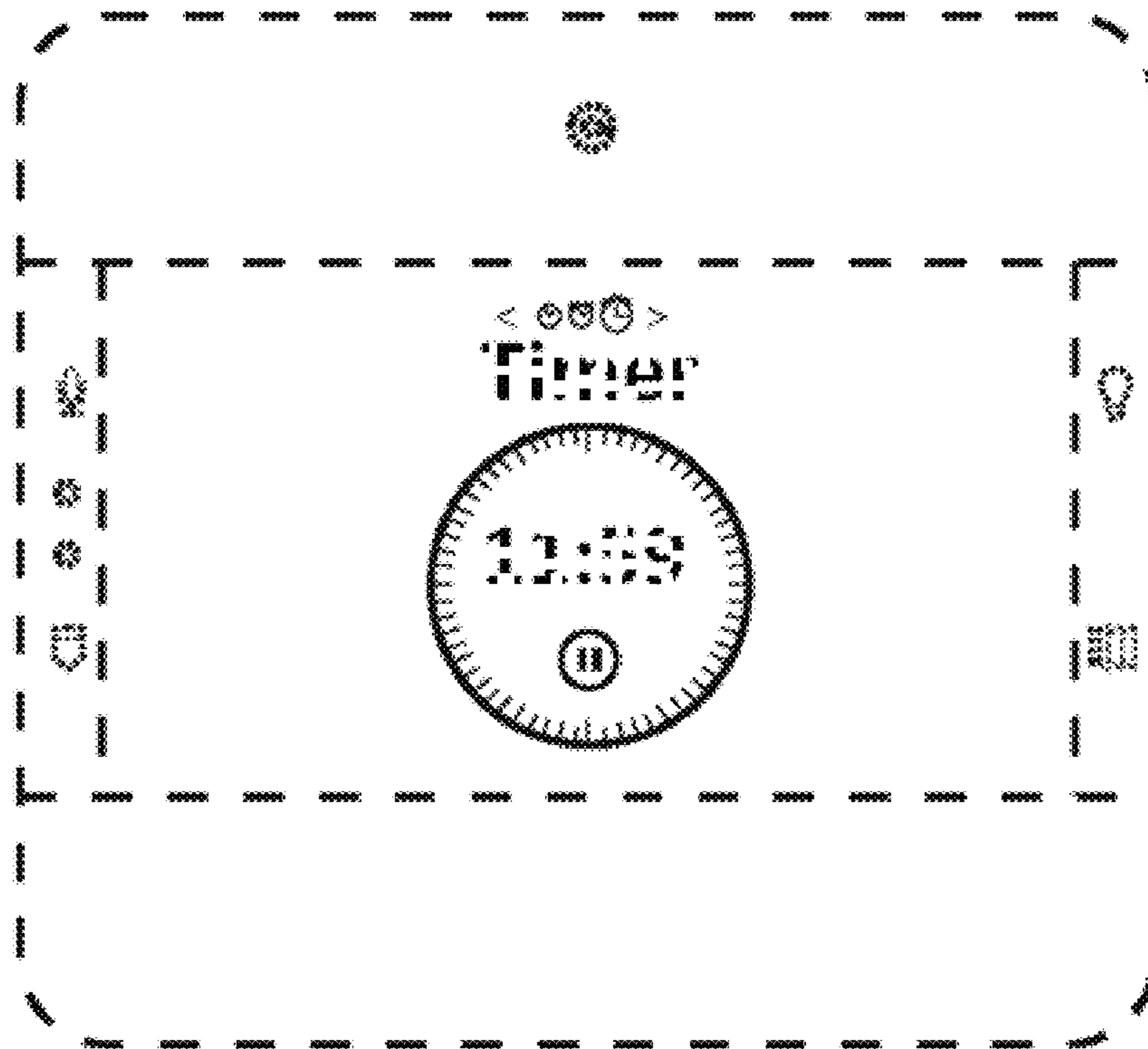

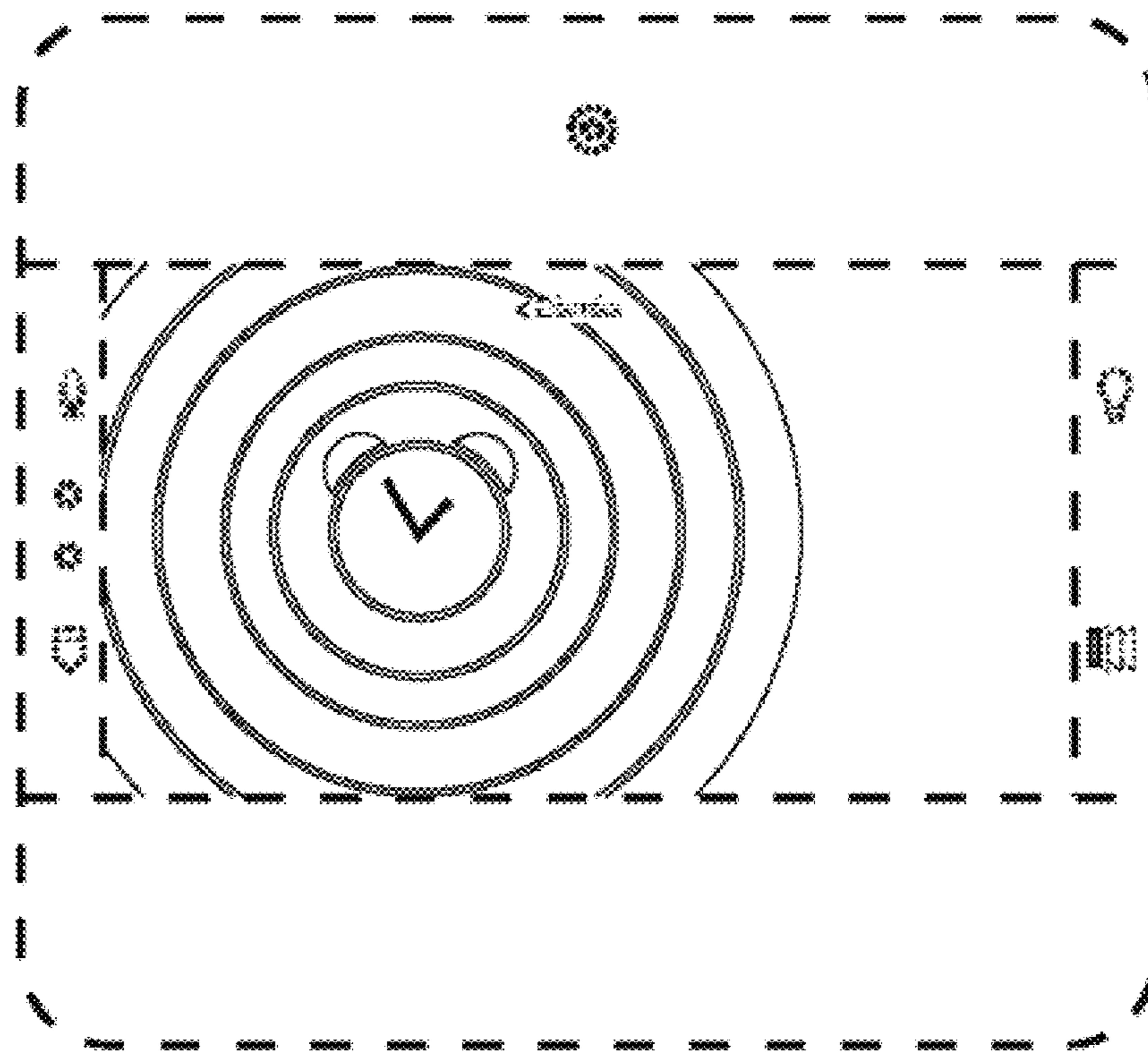

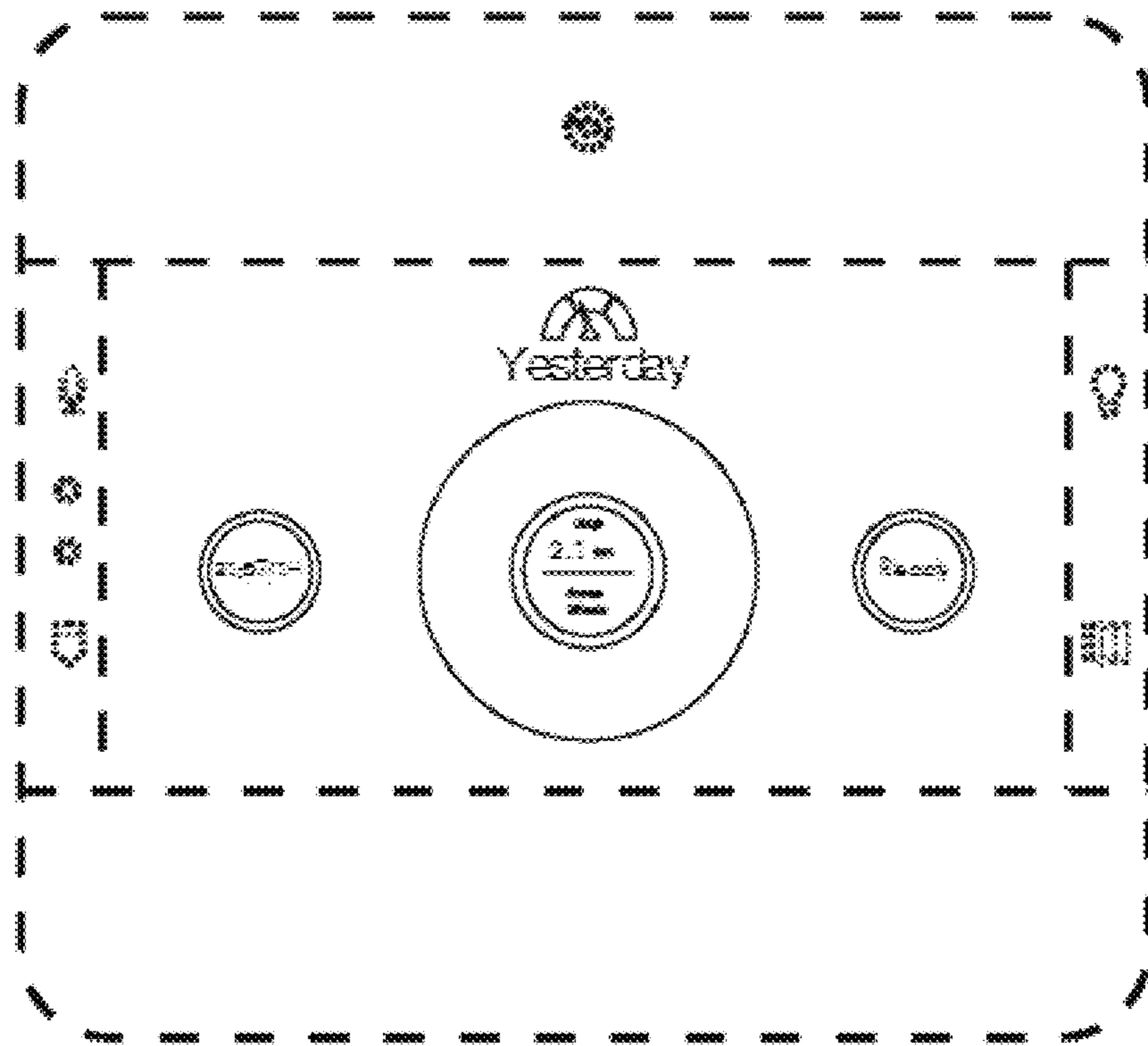

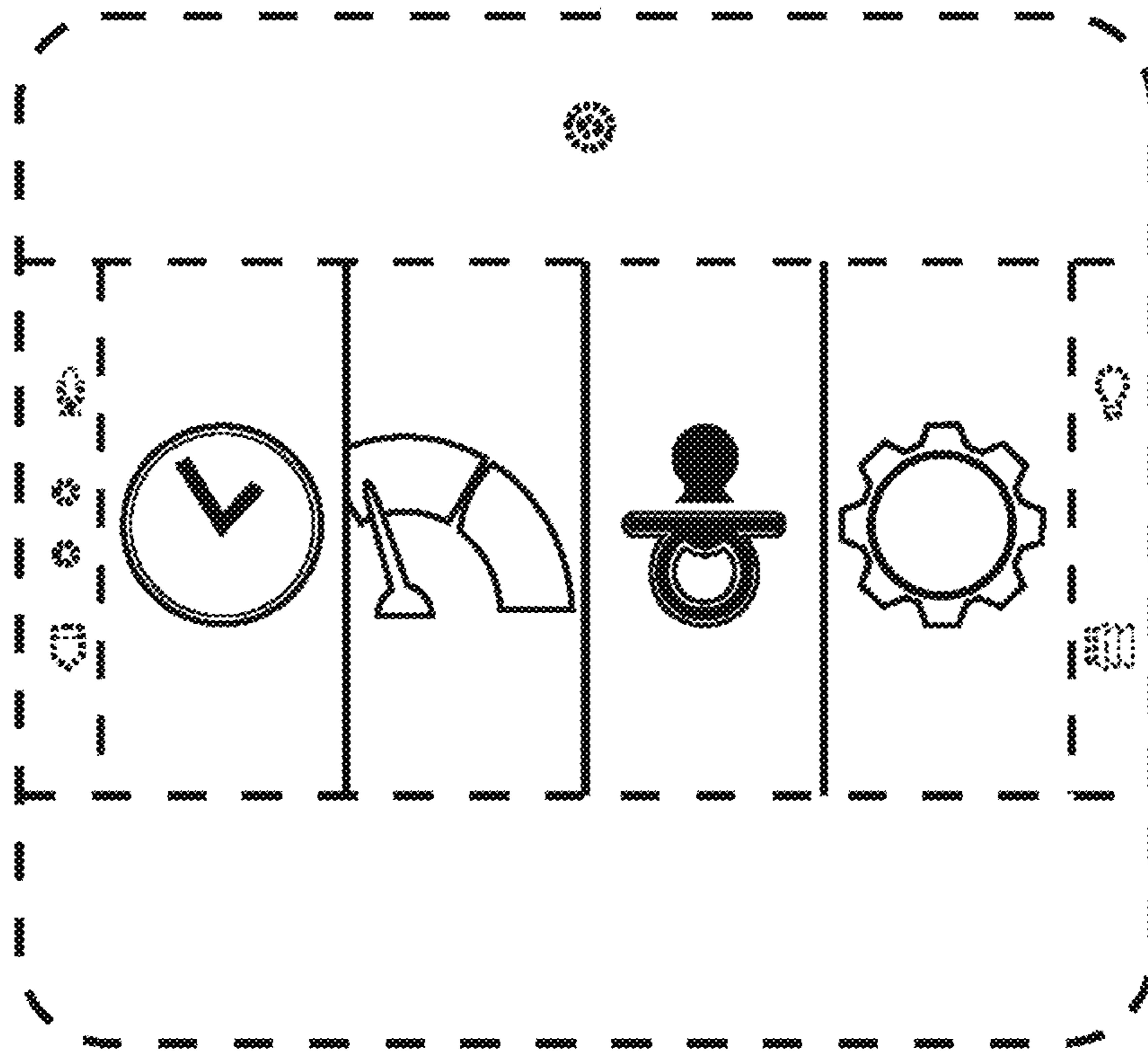

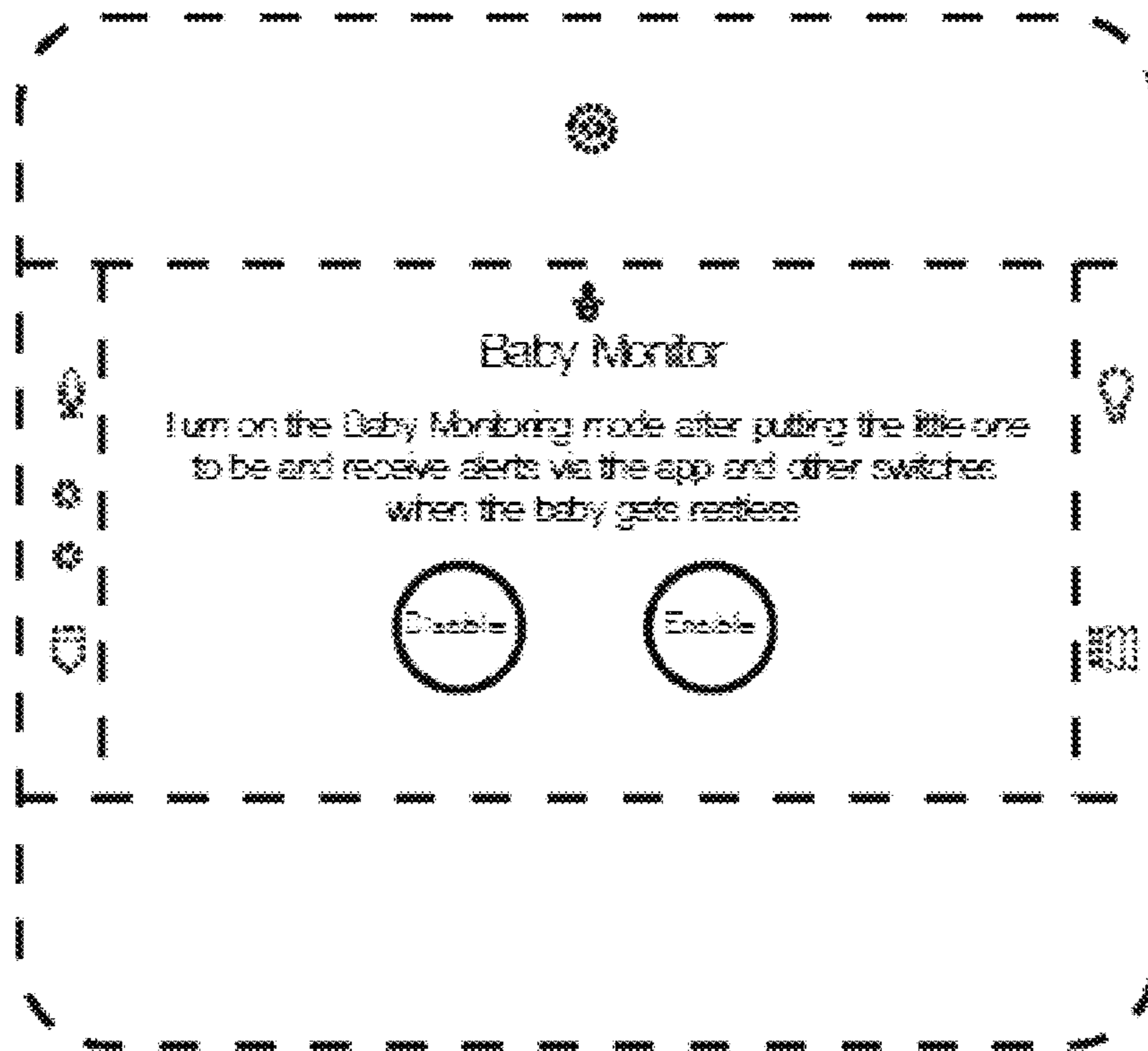

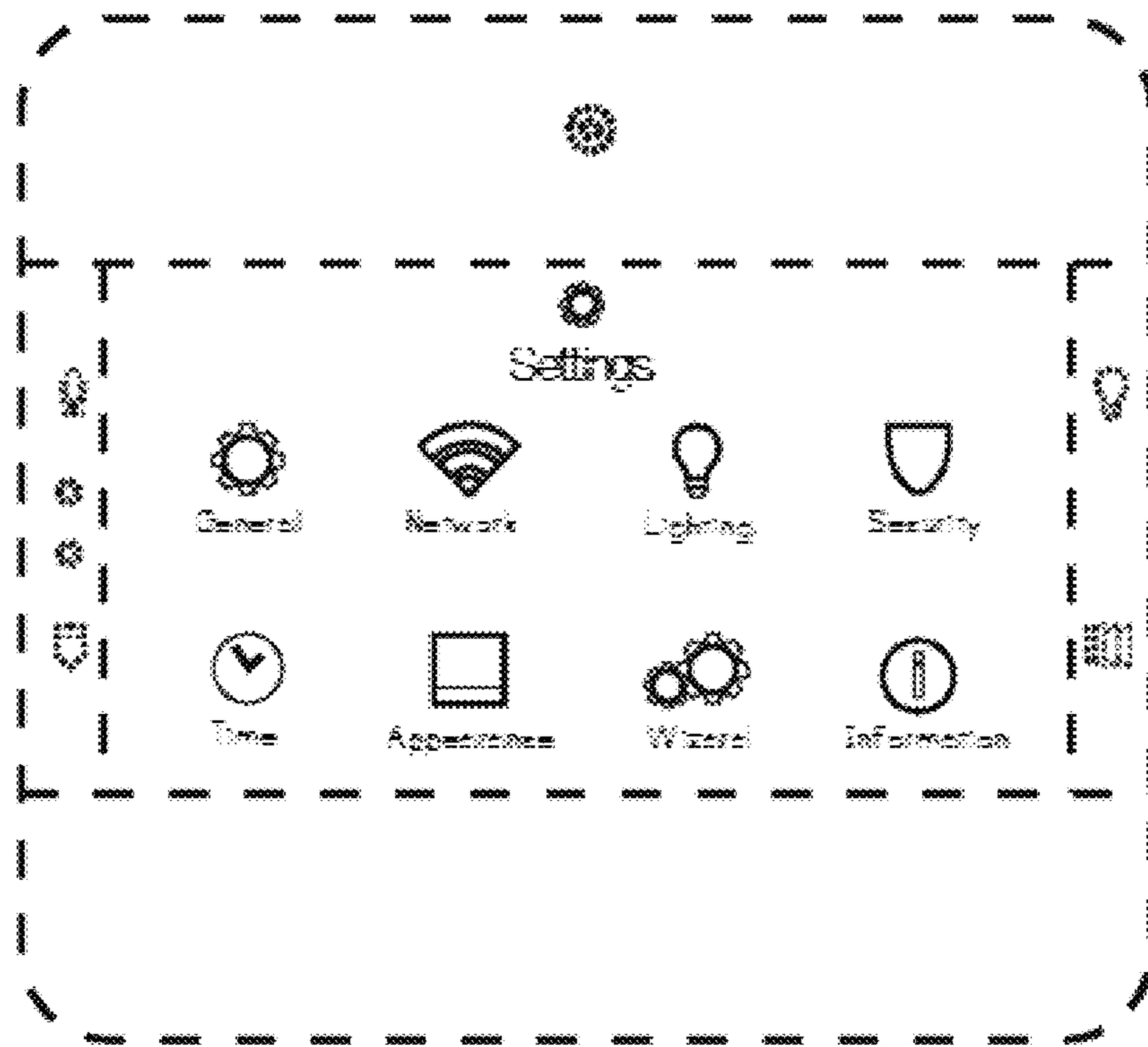

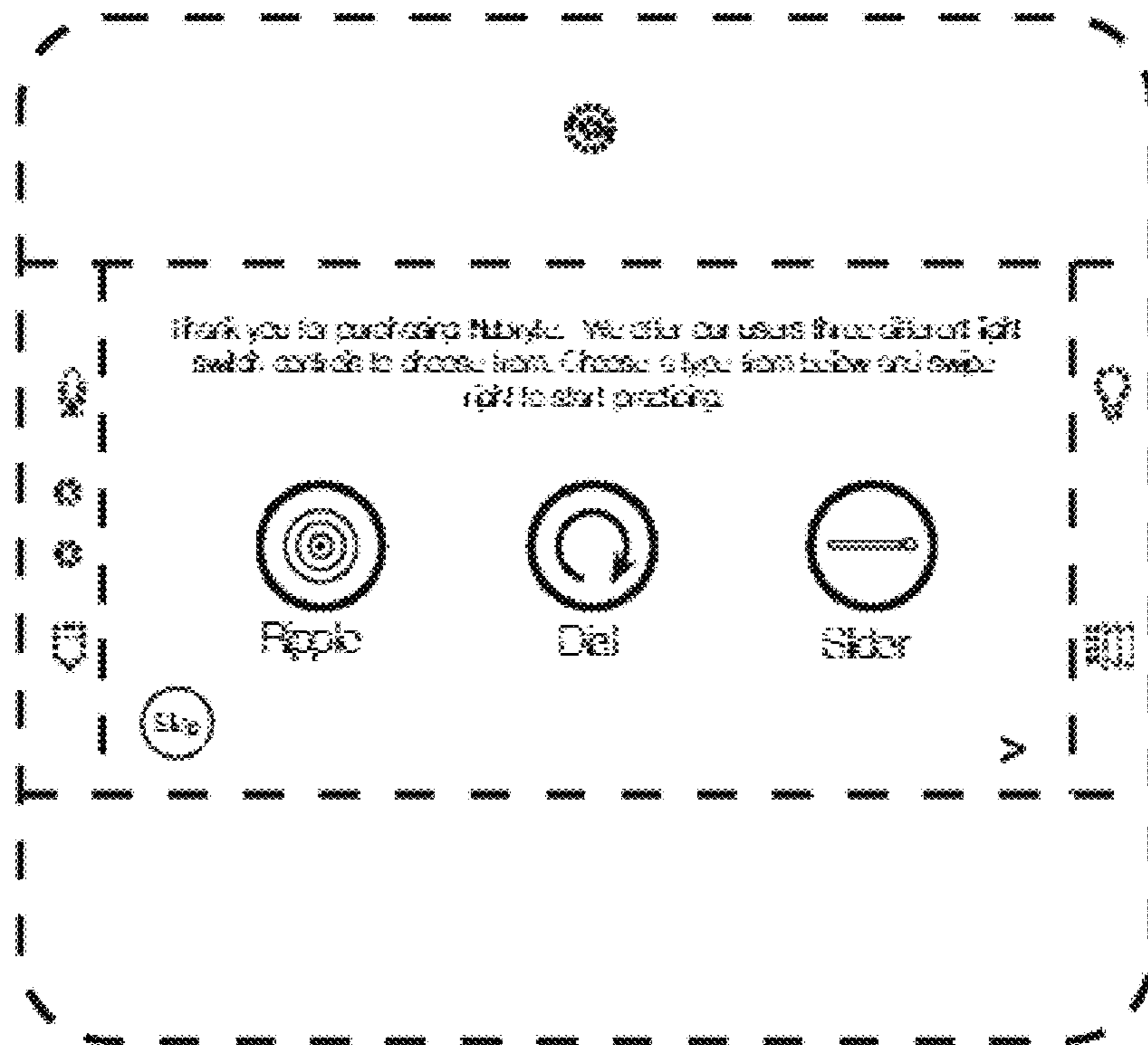

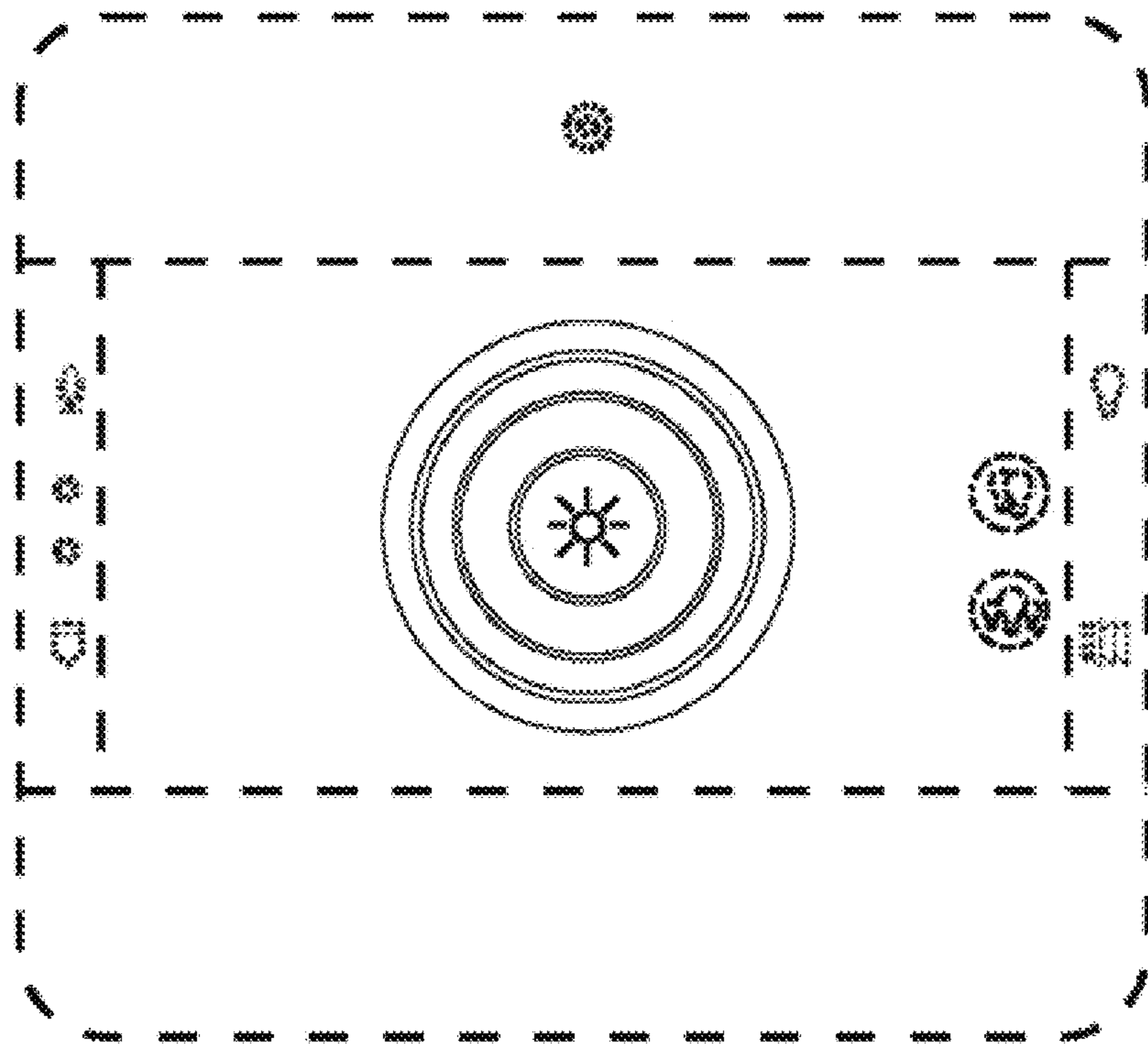

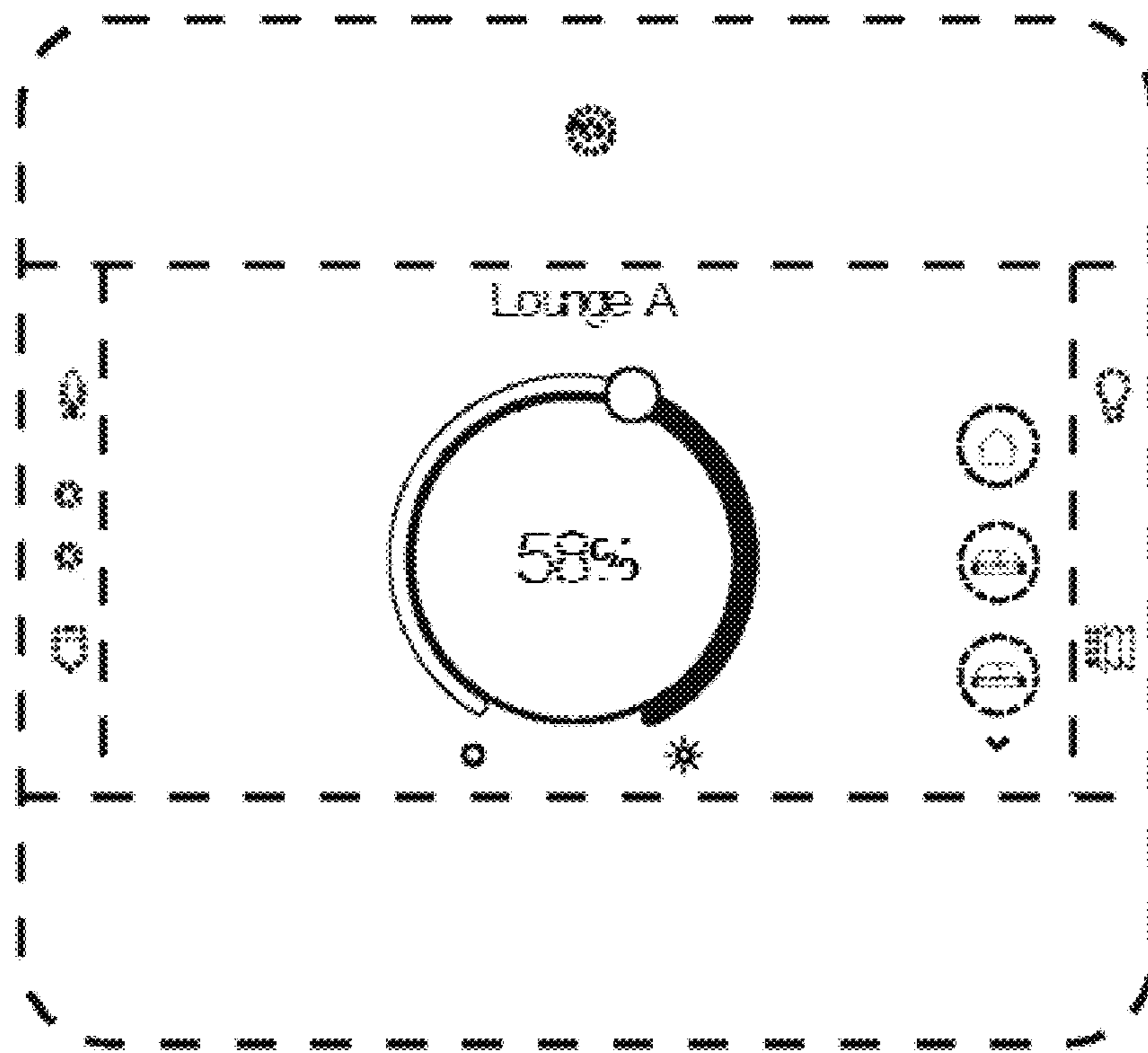

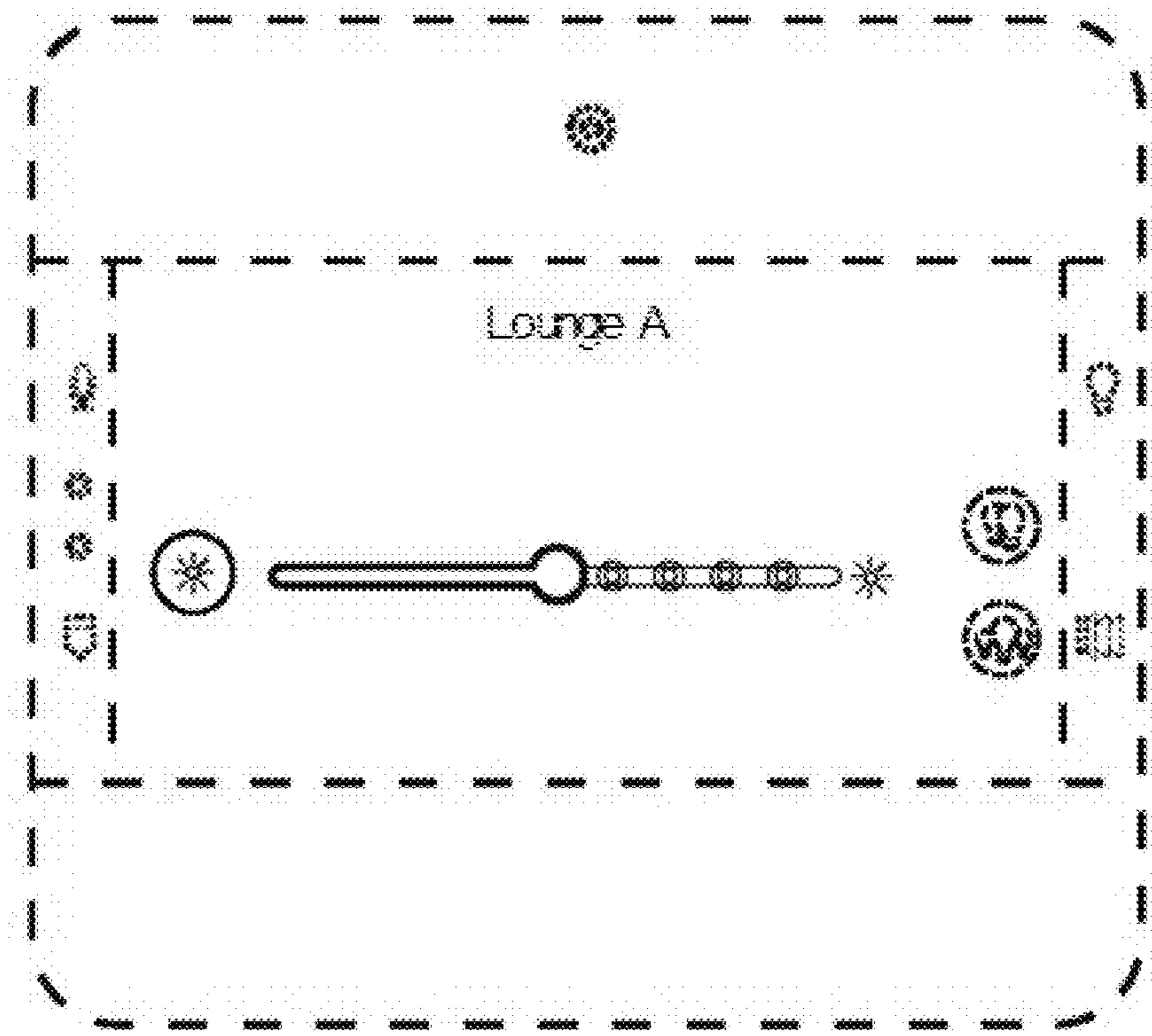

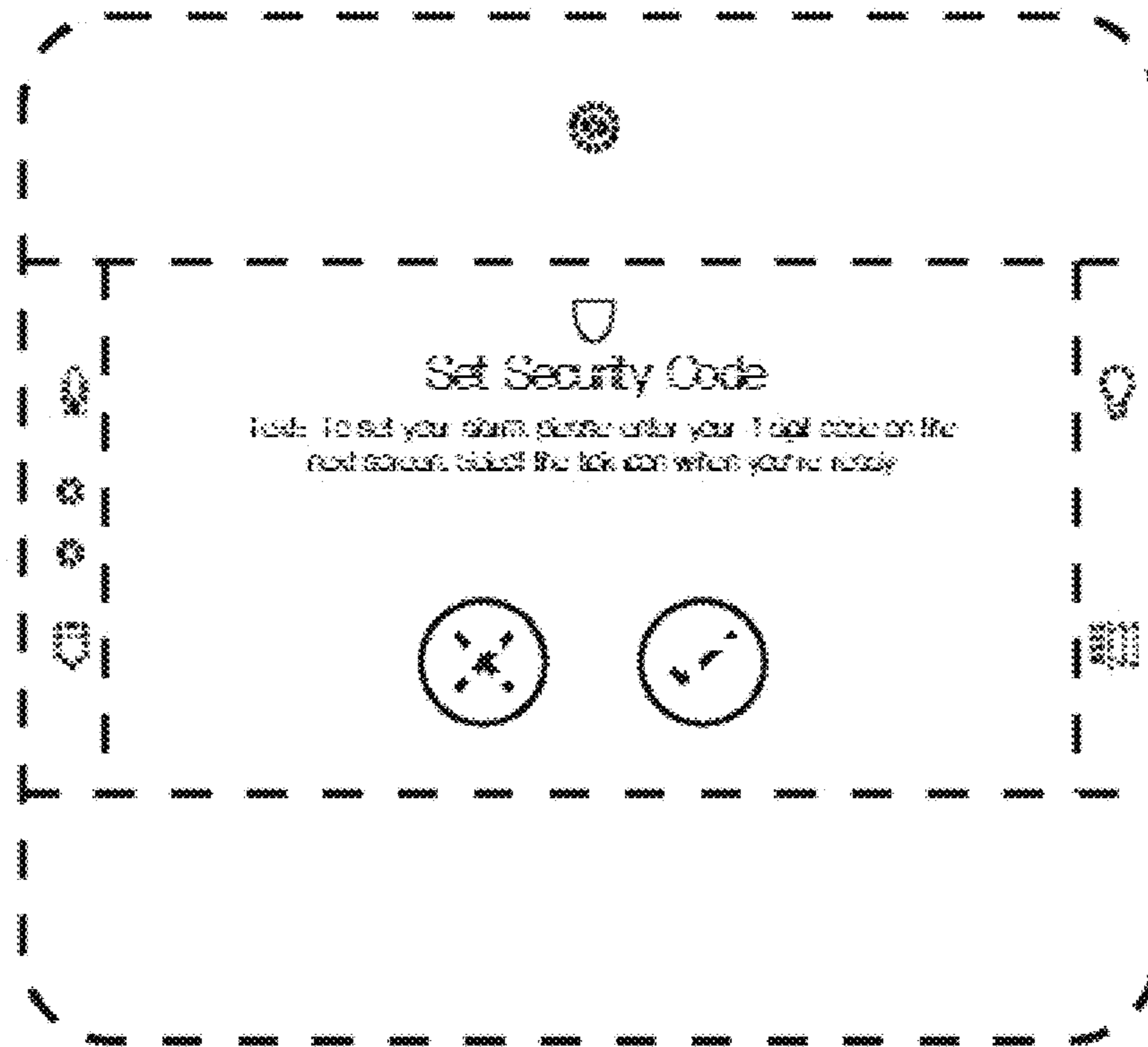

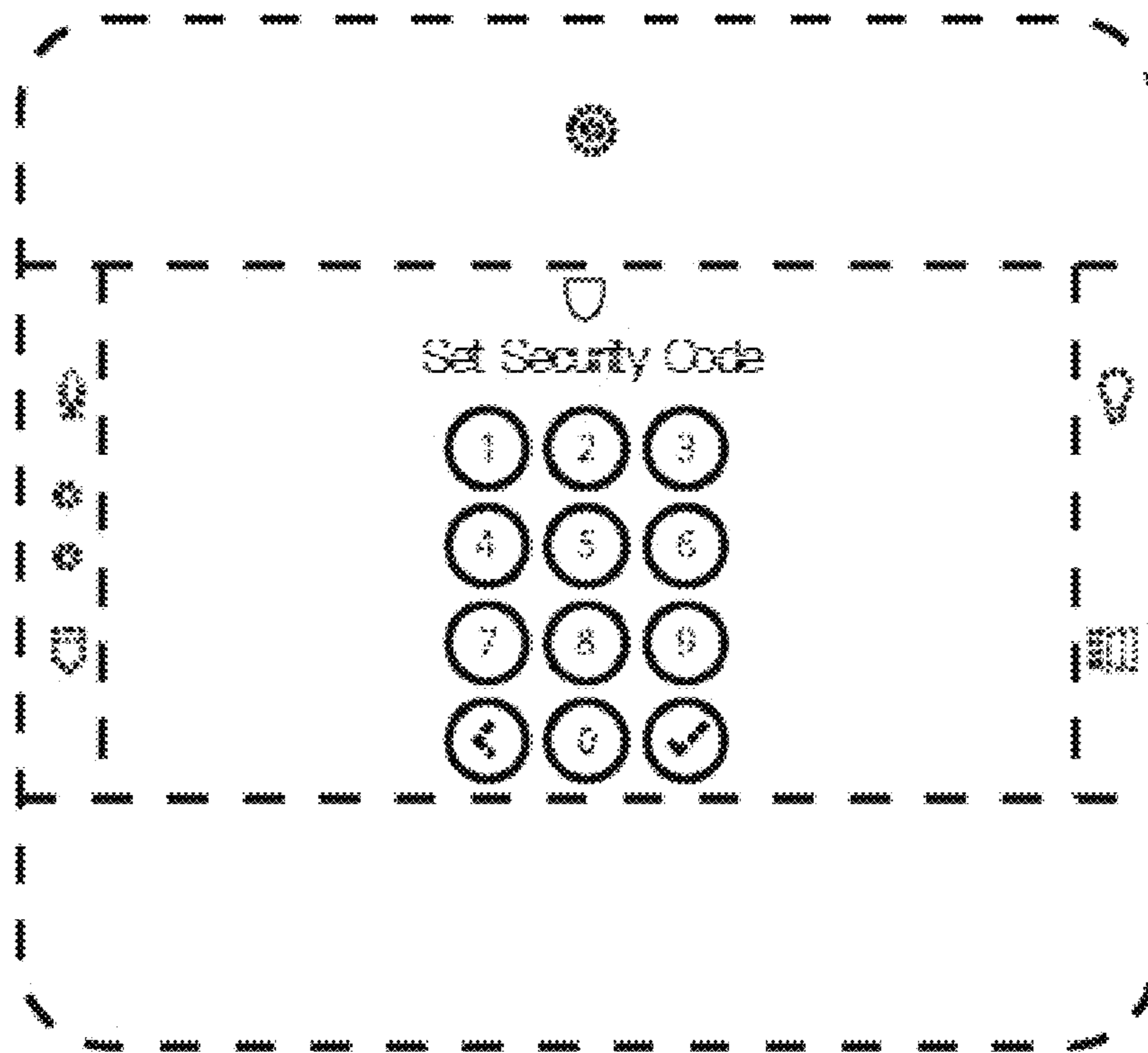

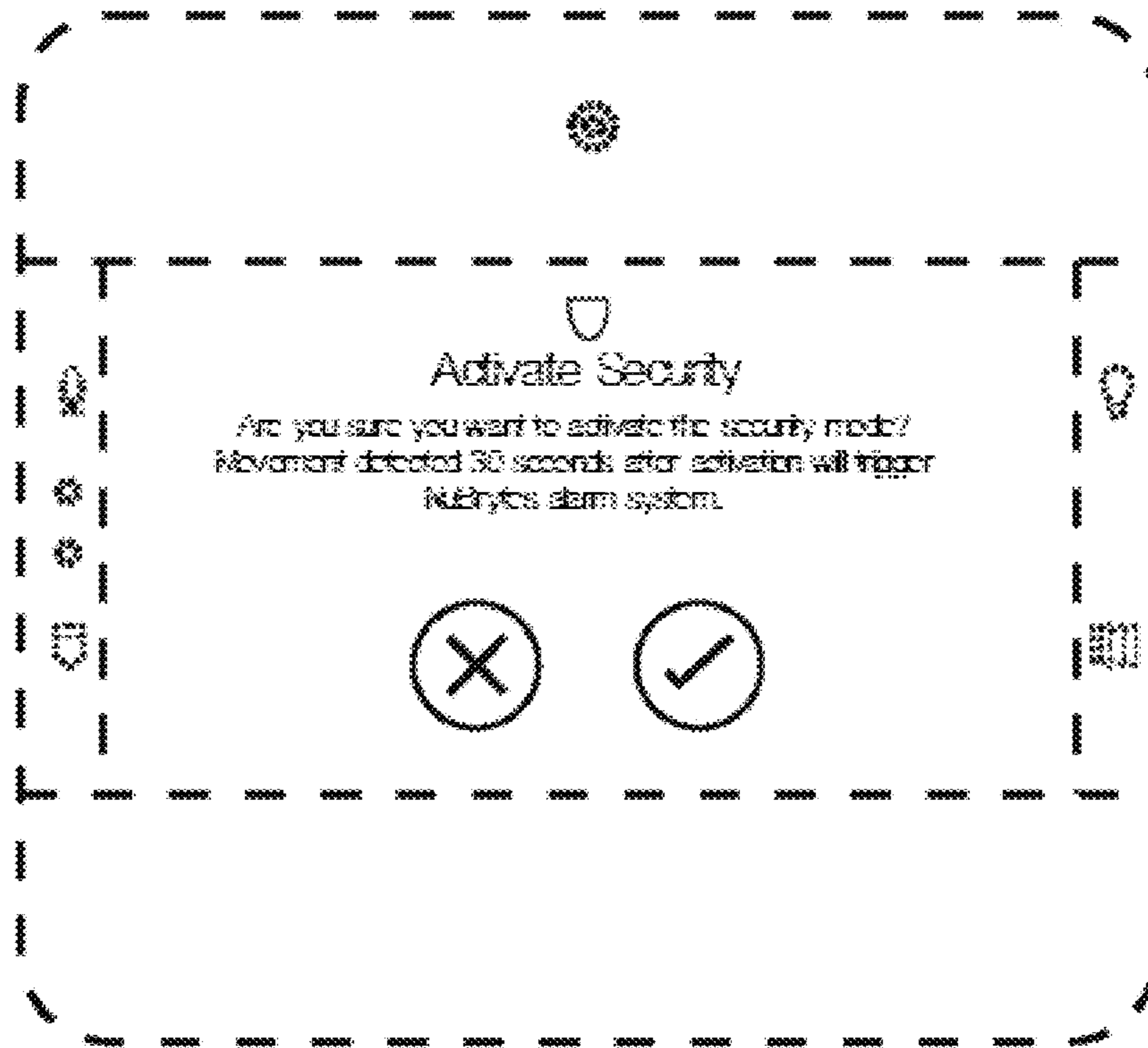

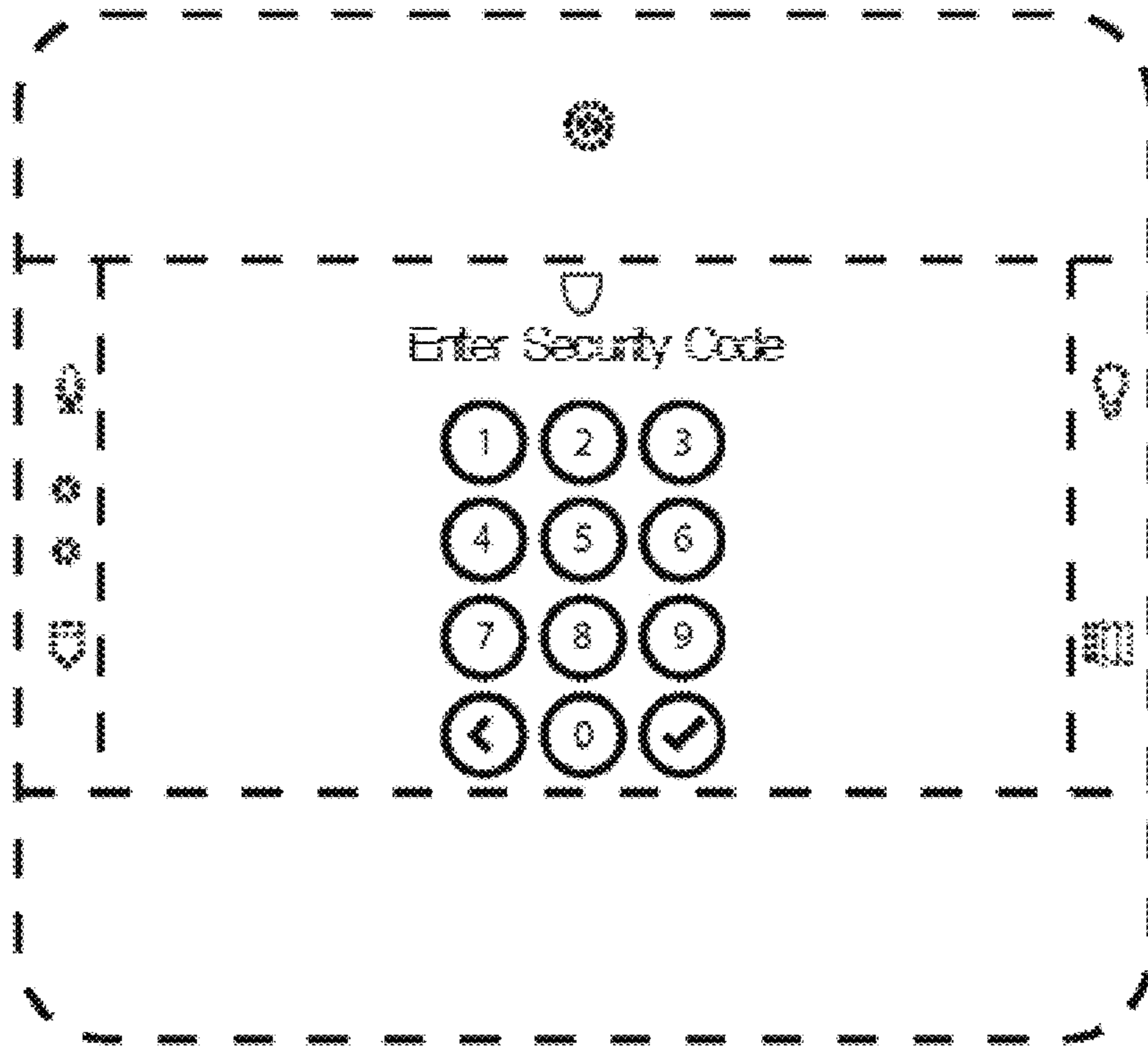

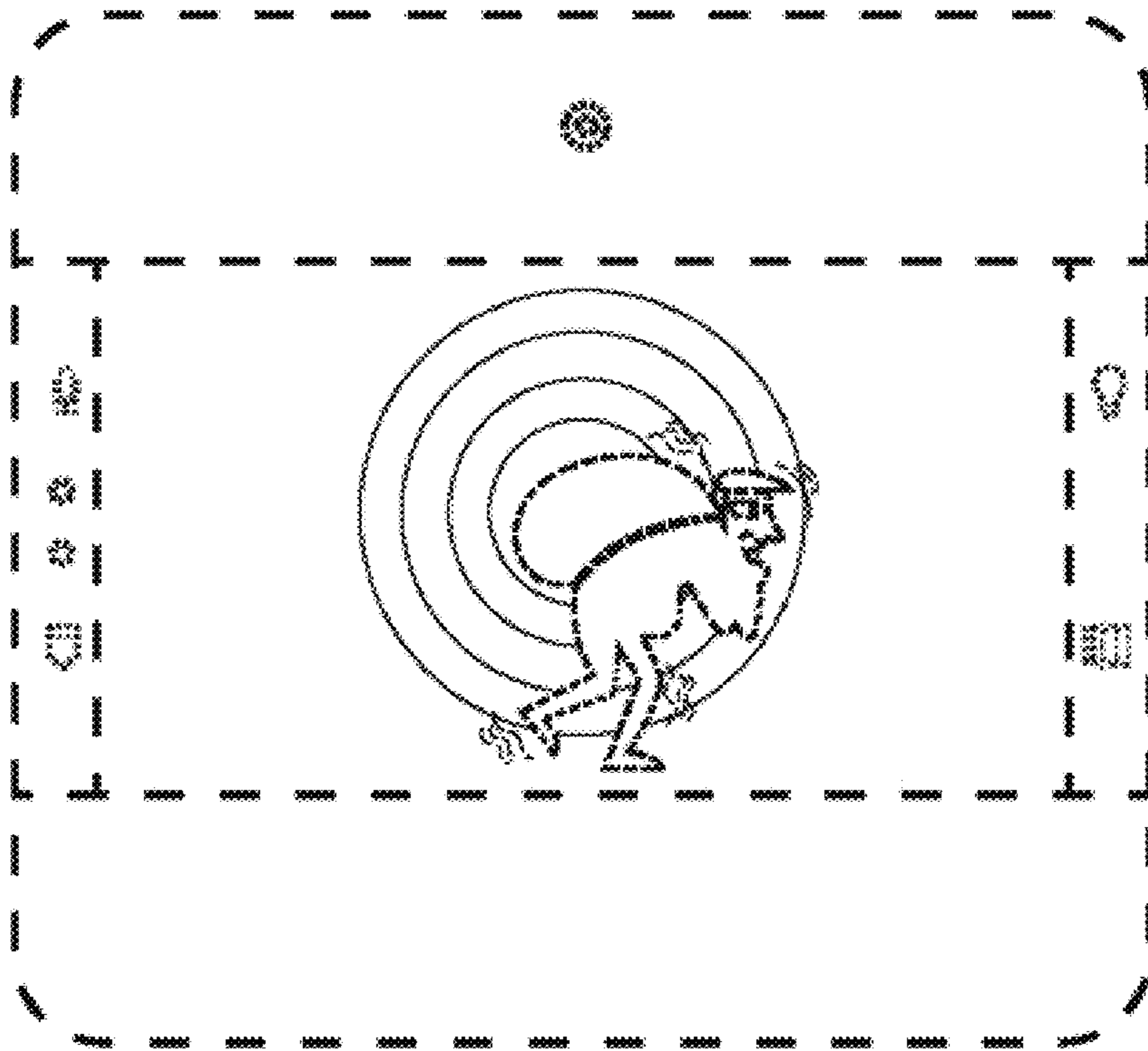
