(57) **CLAIM**

I claim the ornamental design for a display hanger, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the first embodiment of a display hanger, showing my new design;

FIG. 2 is a front planar view depicting the display hanger of FIG. 1.

FIG. 3 is a back planar view depicting the display hanger of FIG. 1.

FIG. 4 is a top planar view depicting the display hanger of FIG. 1.

FIG. 5 is a bottom planar view depicting the display hanger of FIG. 1.

FIG. 6 is a right side planar view depicting the display hanger of FIG. 1.

FIG. 7 is a left side planar view depicting the display hanger of FIG. 1.

FIG. 8 is a perspective view of the second embodiment of a display hanger;

FIG. 20 is a perspective view of the fourth embodiment of a display hanger;

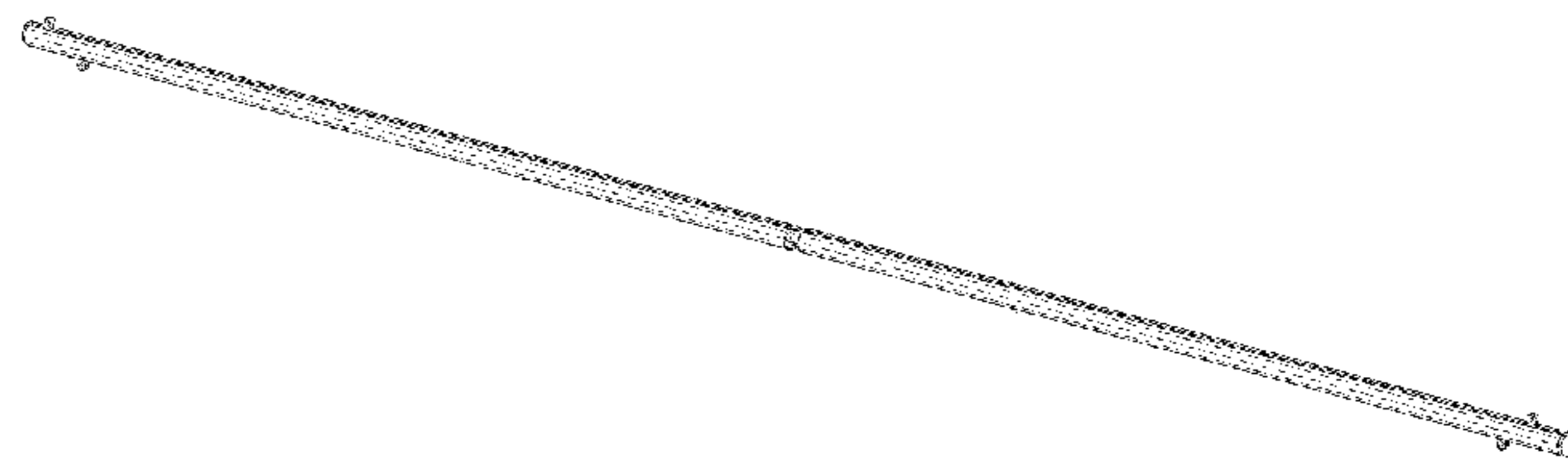
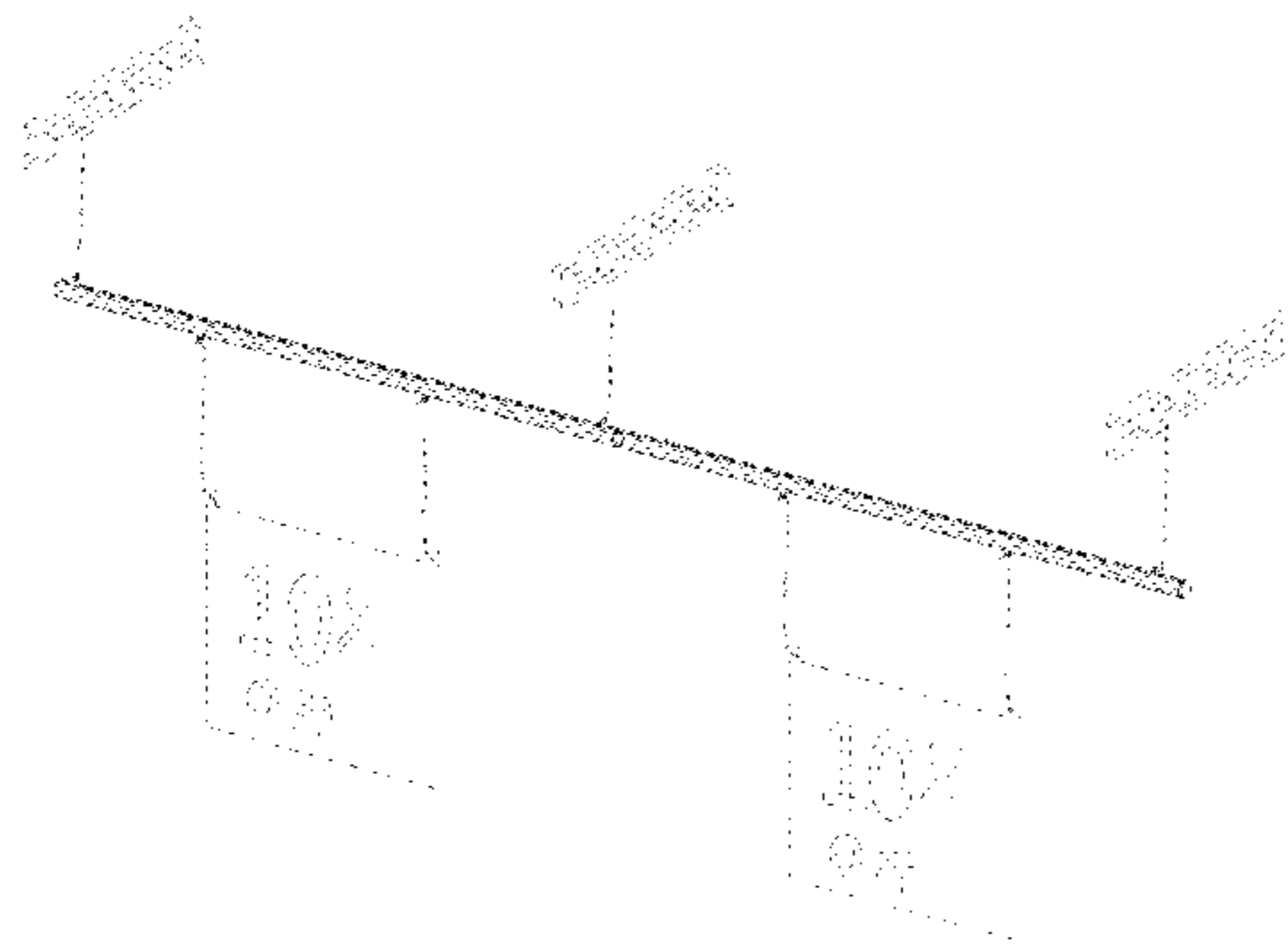


FIG. 22 is a top planar view depicting the display hanger of FIG. 20.

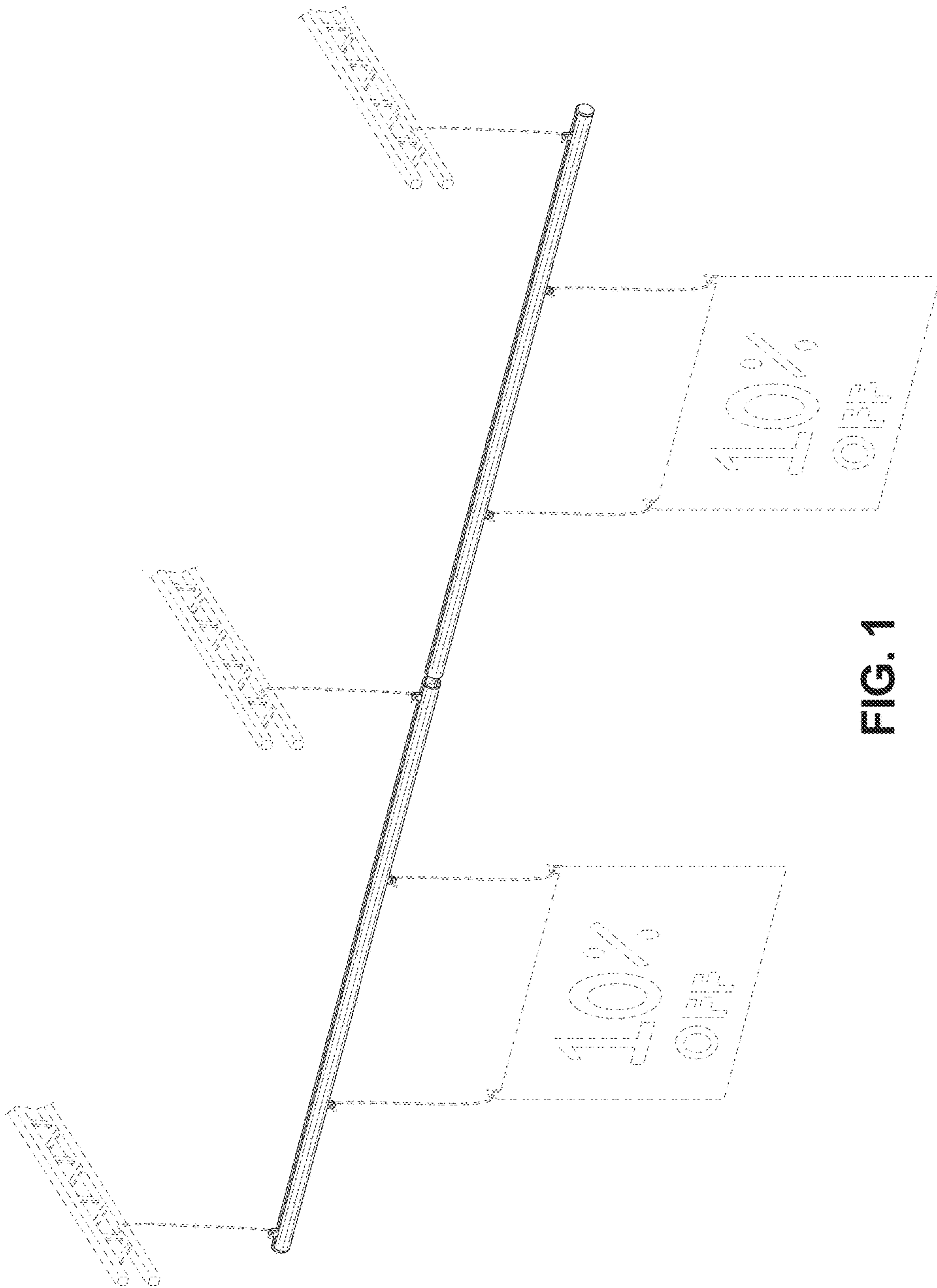

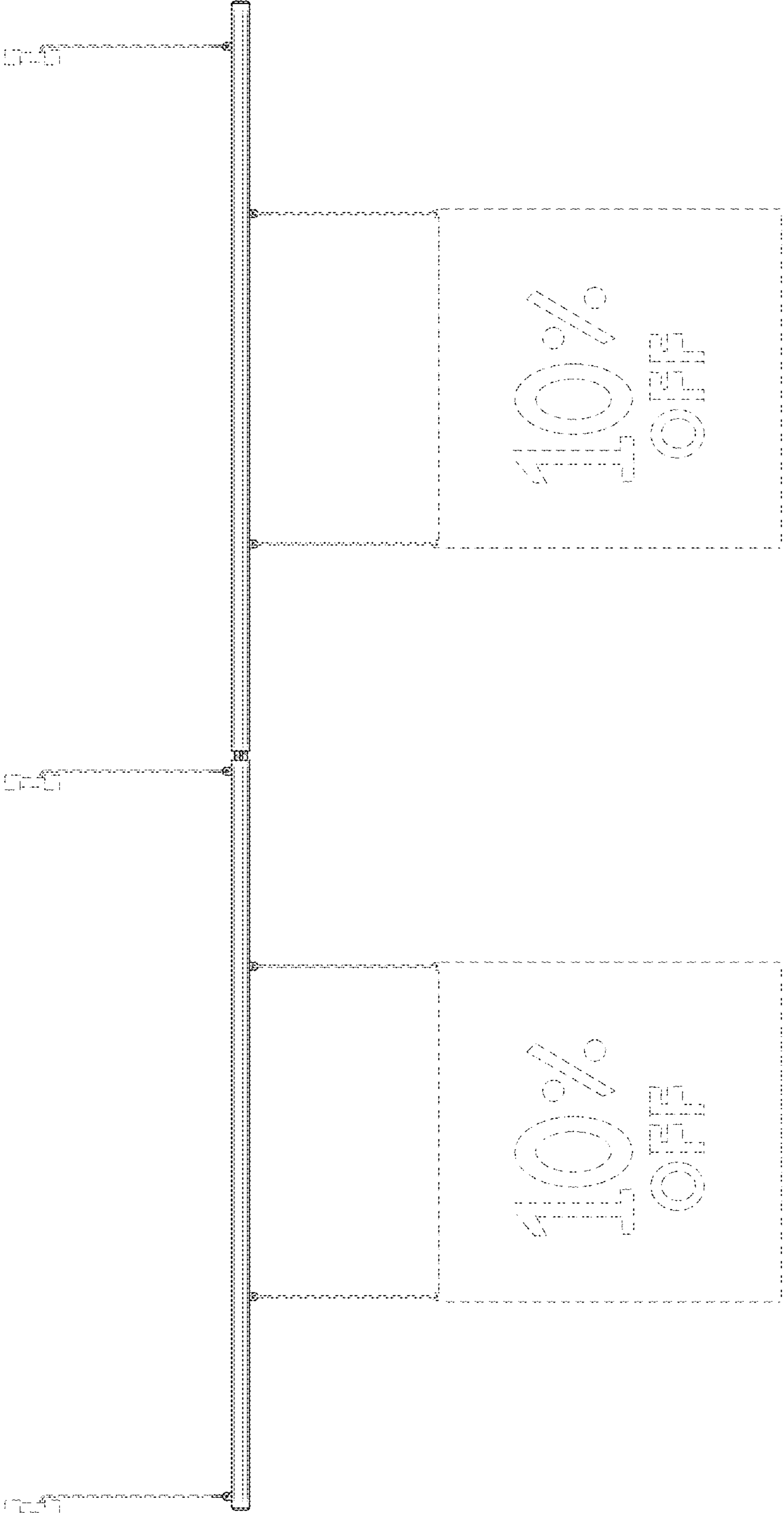
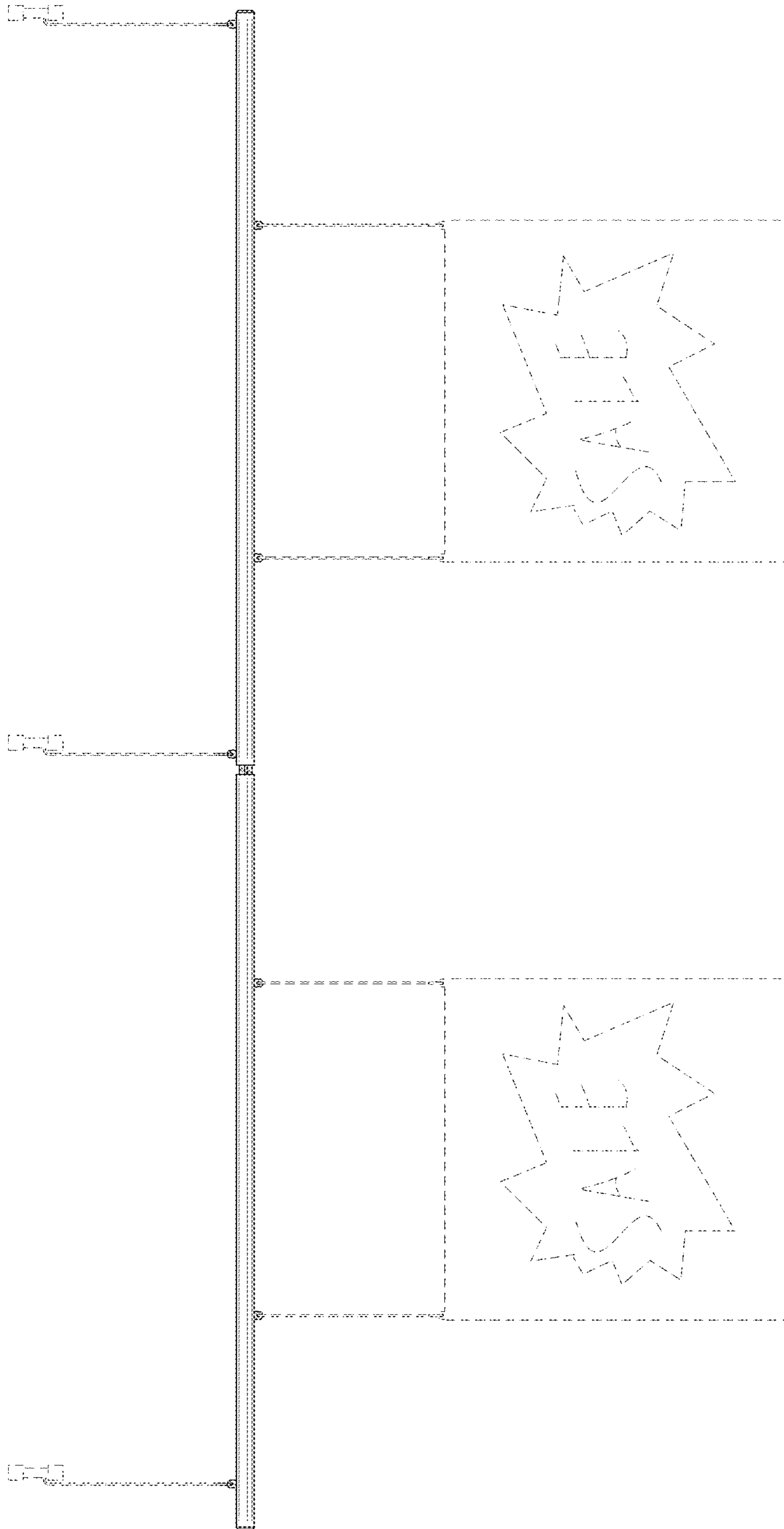
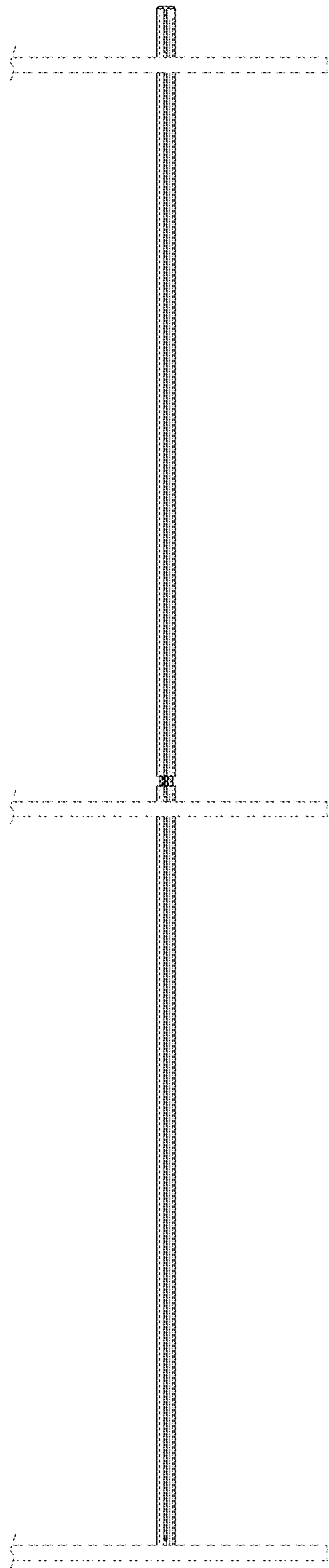


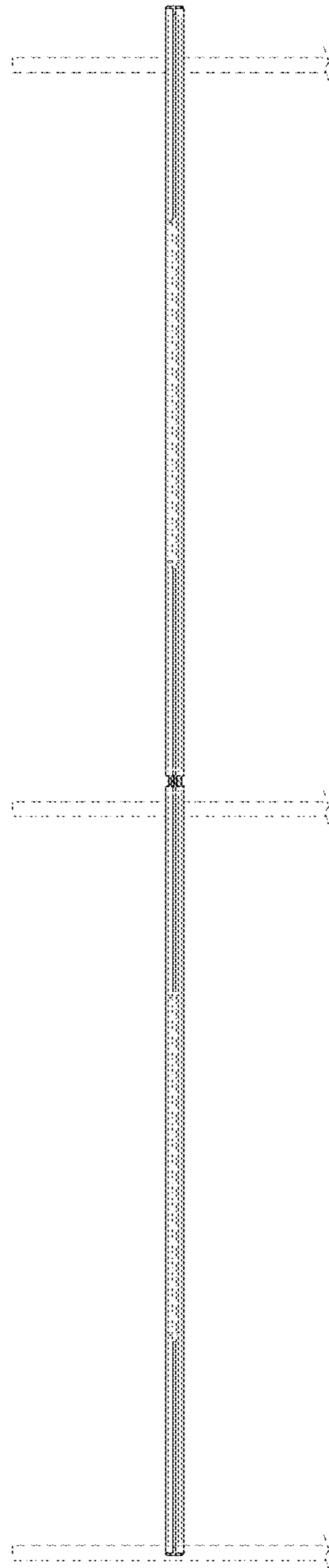

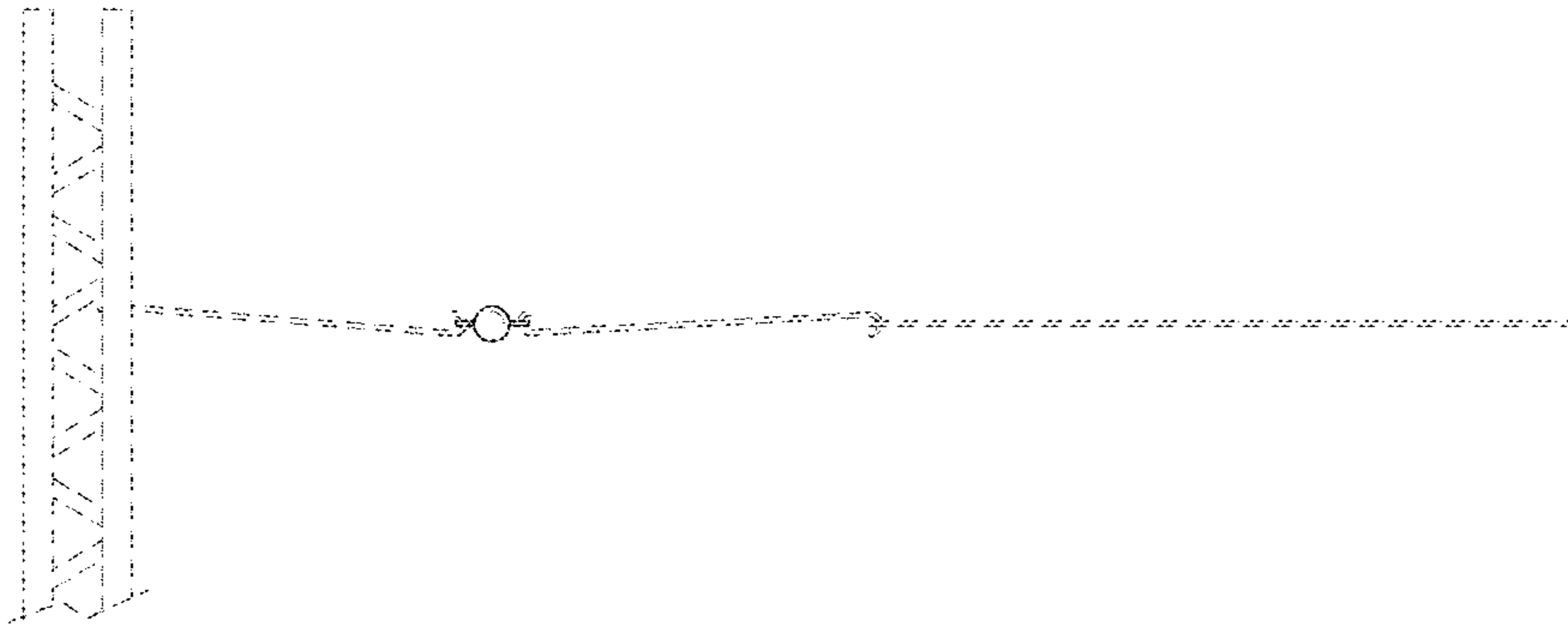

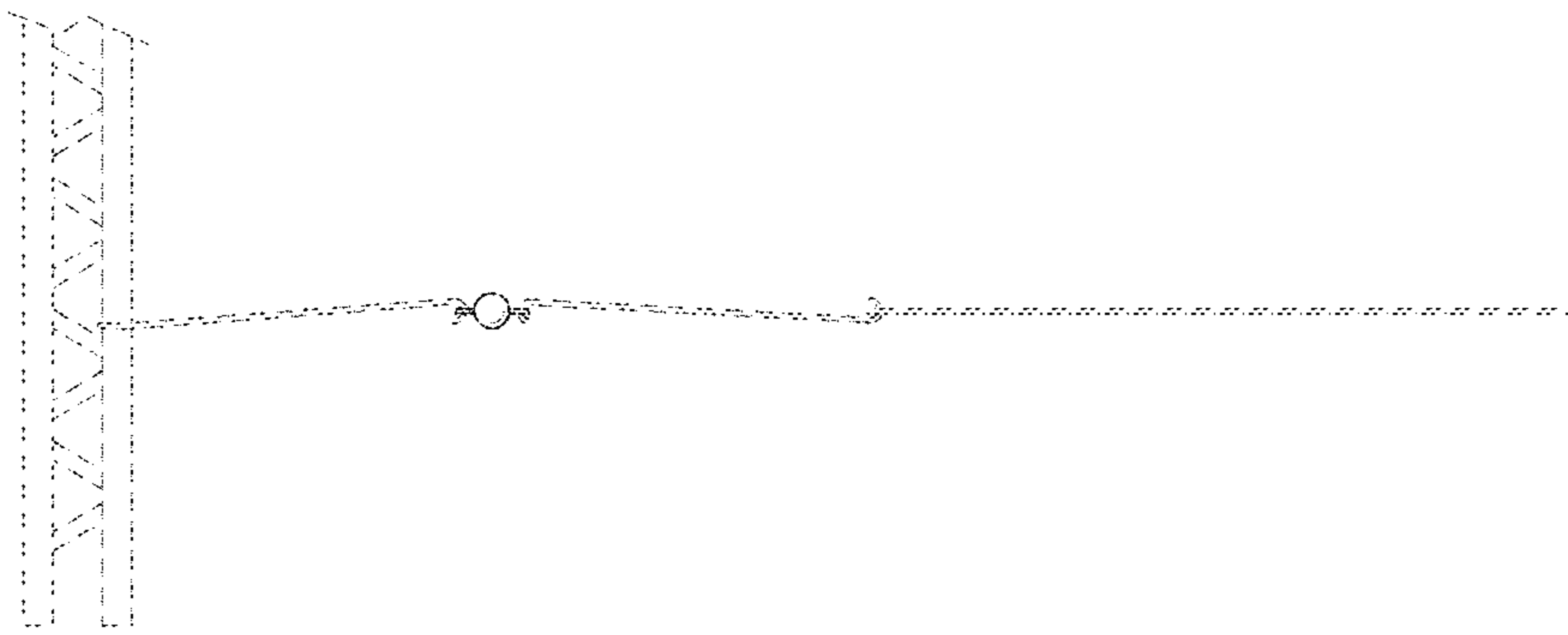

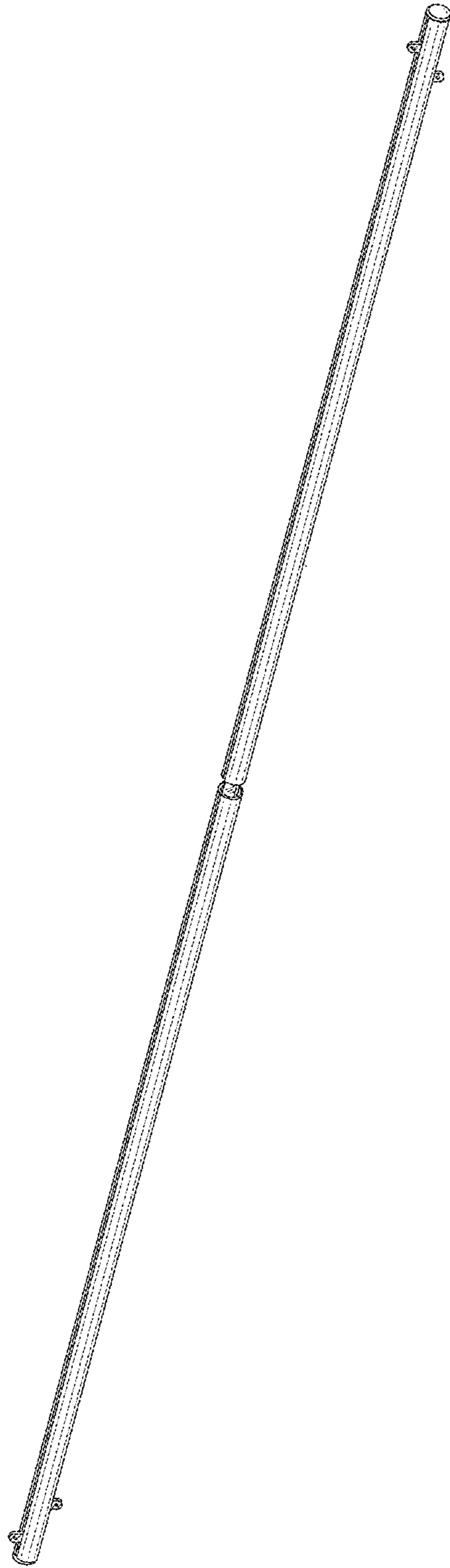

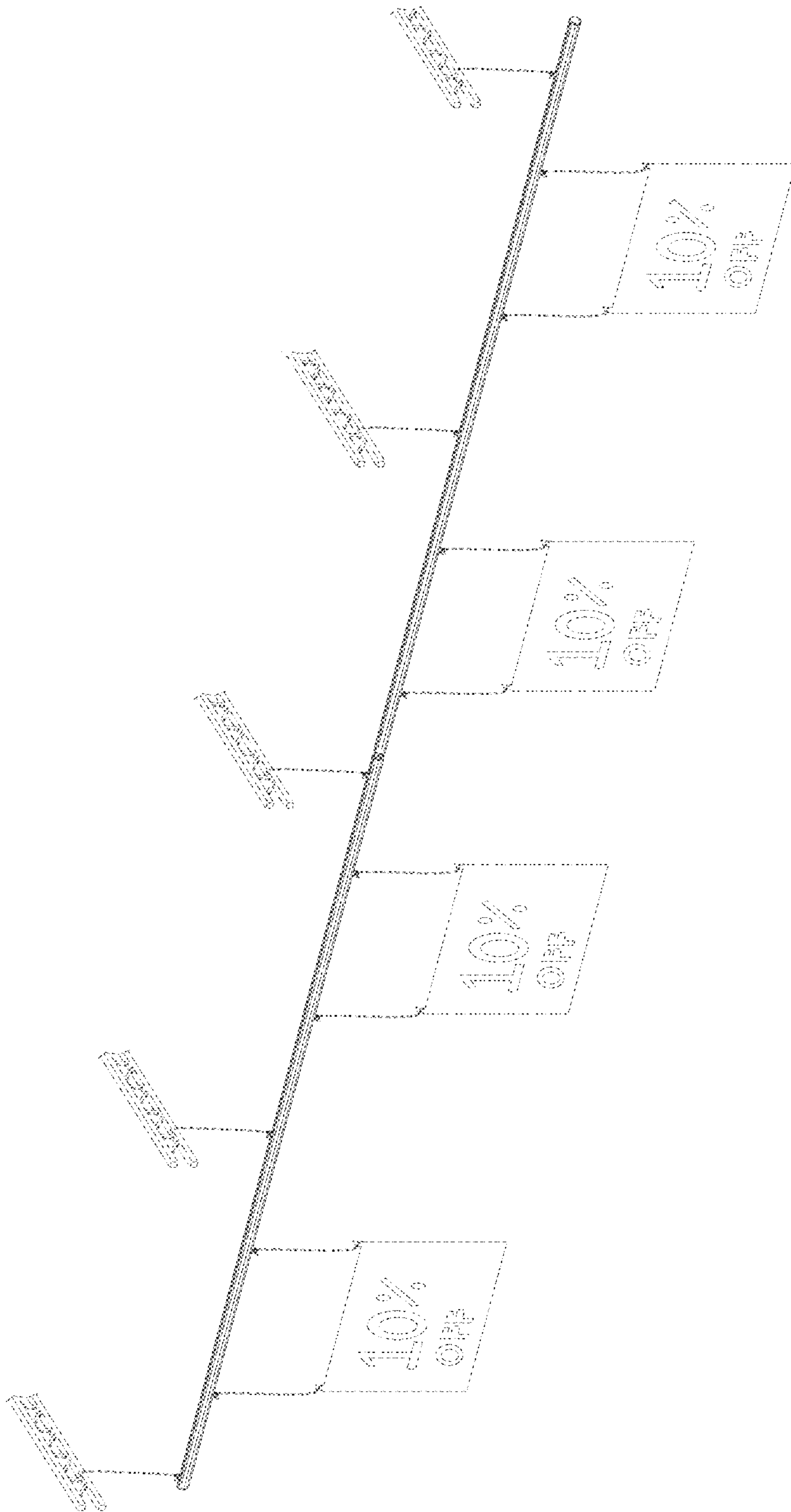

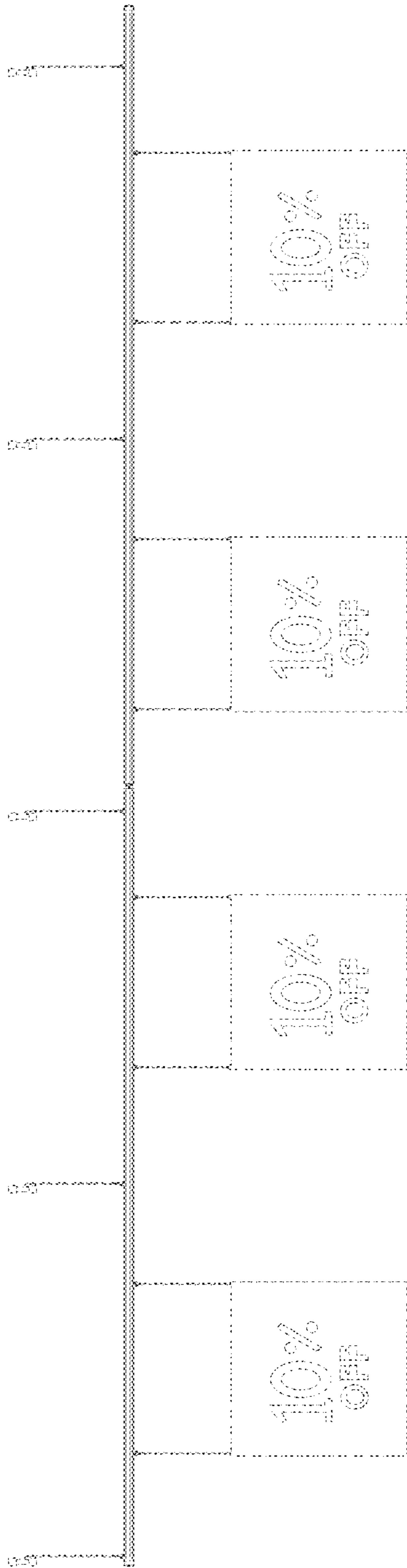

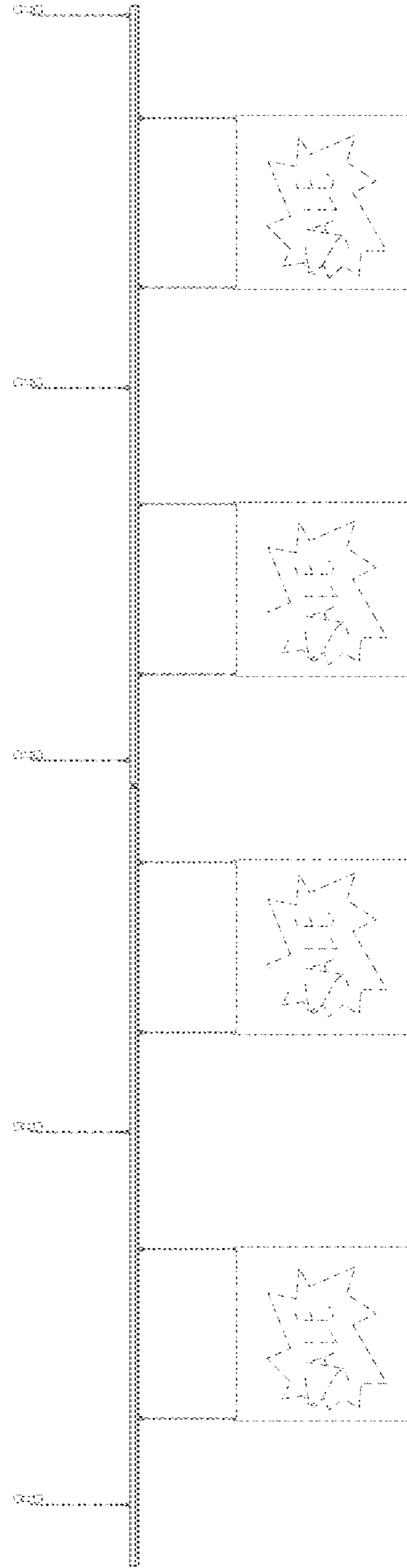

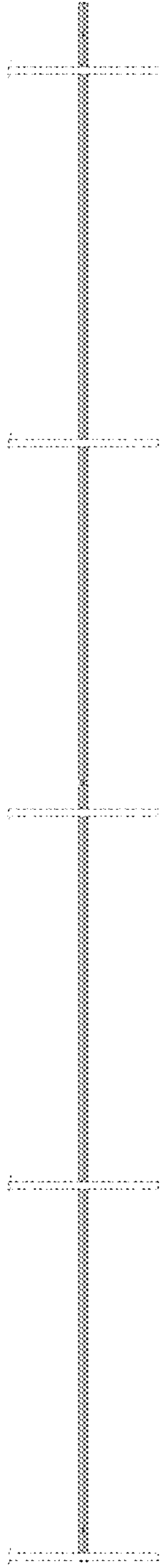

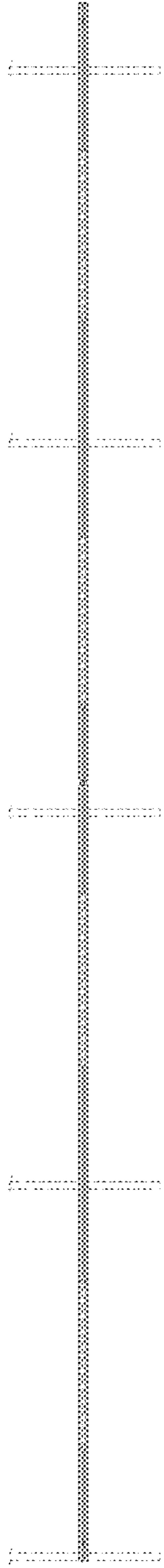

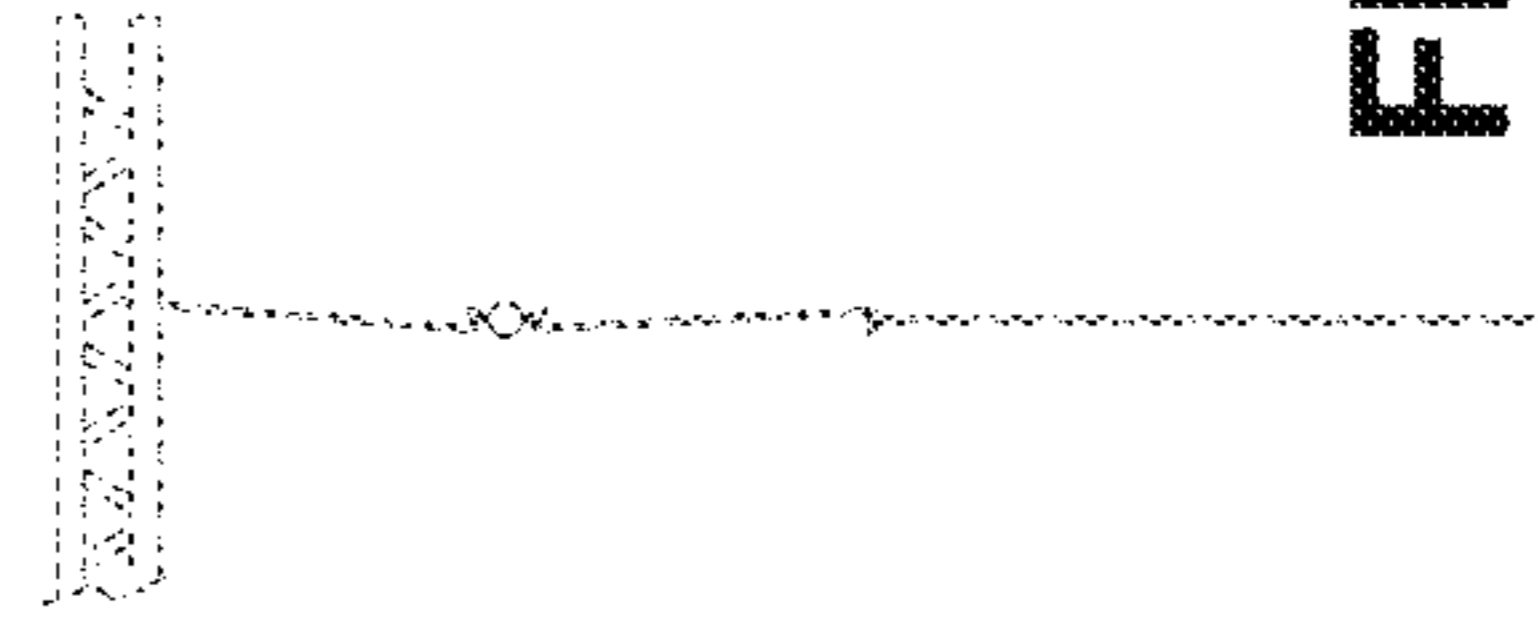

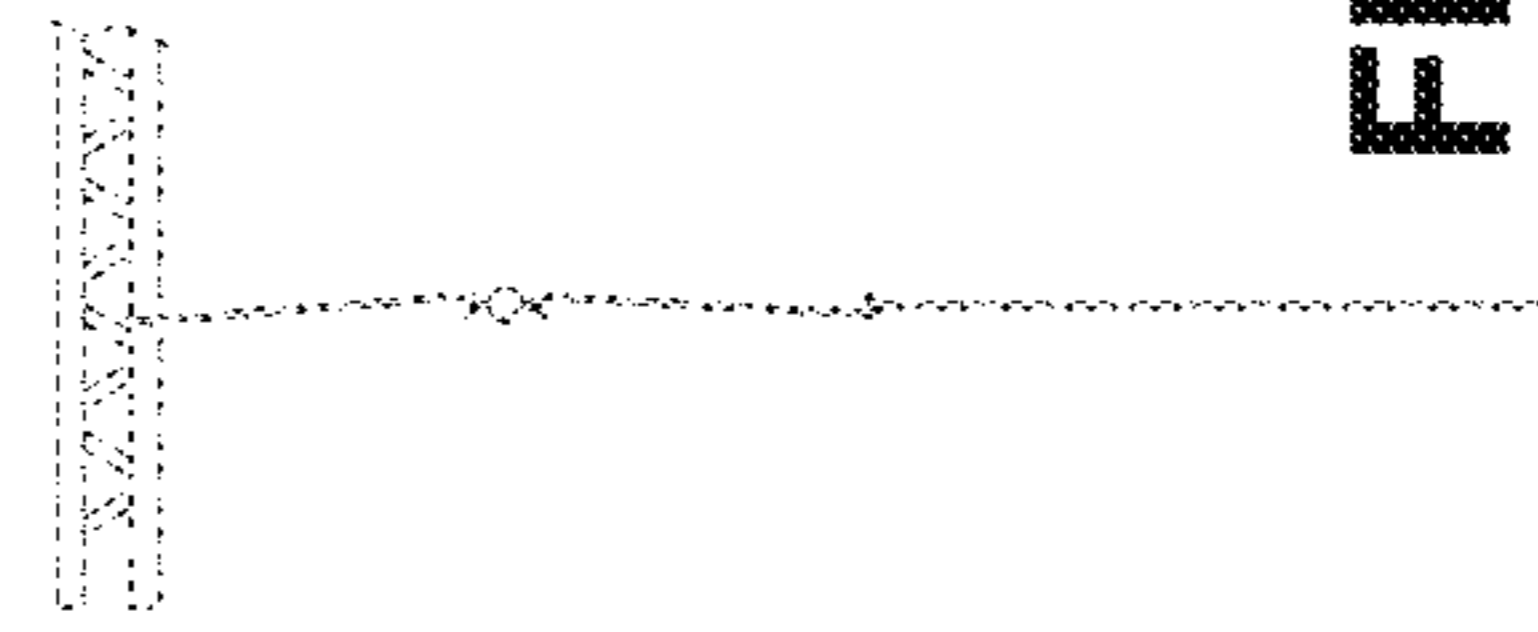
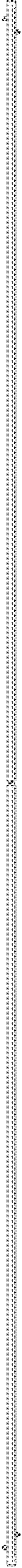
