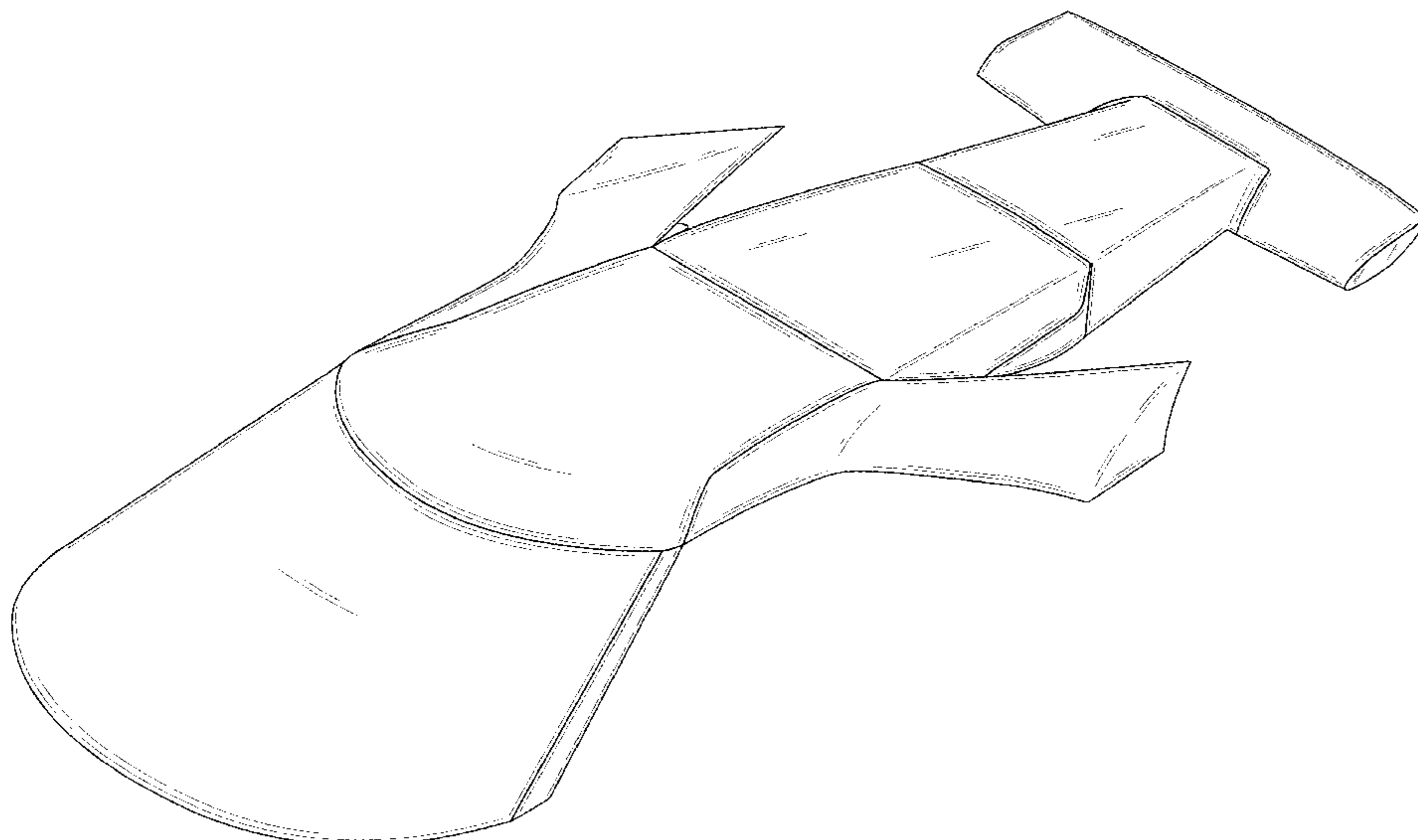
(57) **CLAIM**

We claim the ornamental design for a modular body for a model vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, right, front perspective view of a modular body for a model vehicle;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a left side elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a top, right, front perspective view of a modular body for a model vehicle mounted on a model vehicle.

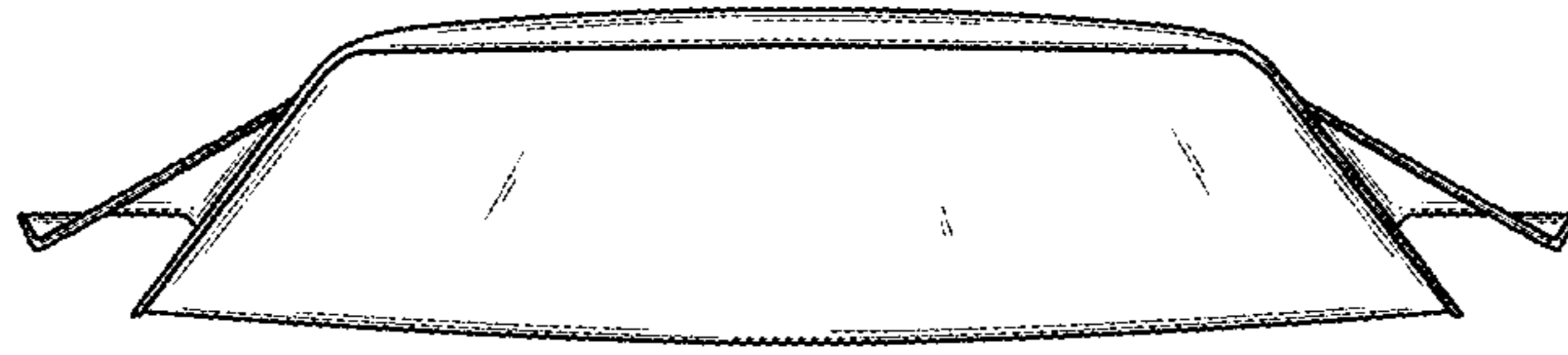

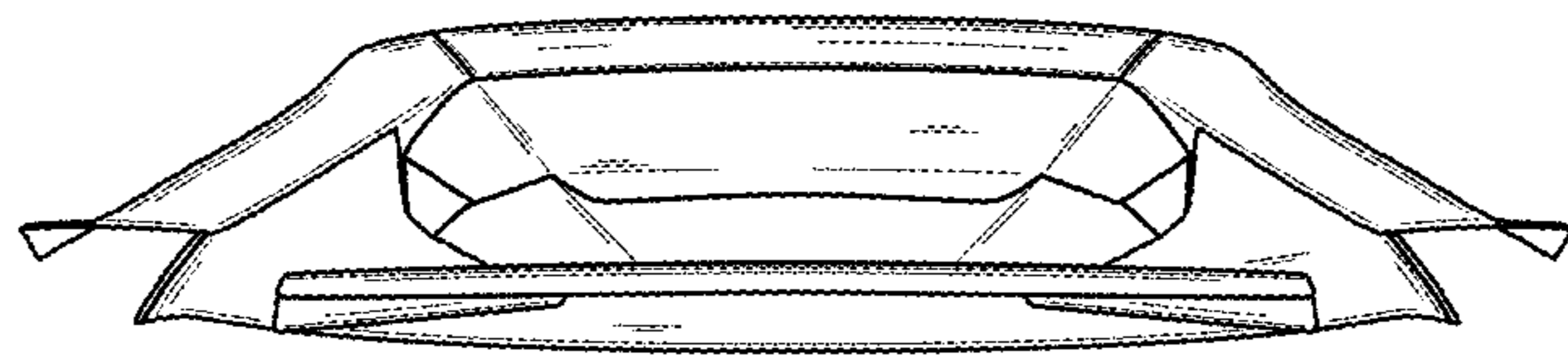

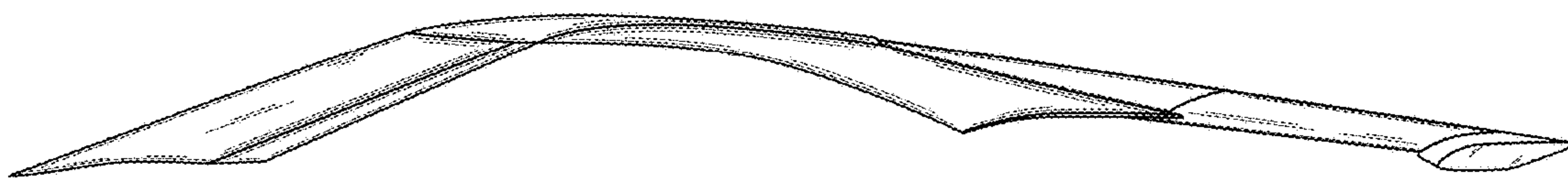

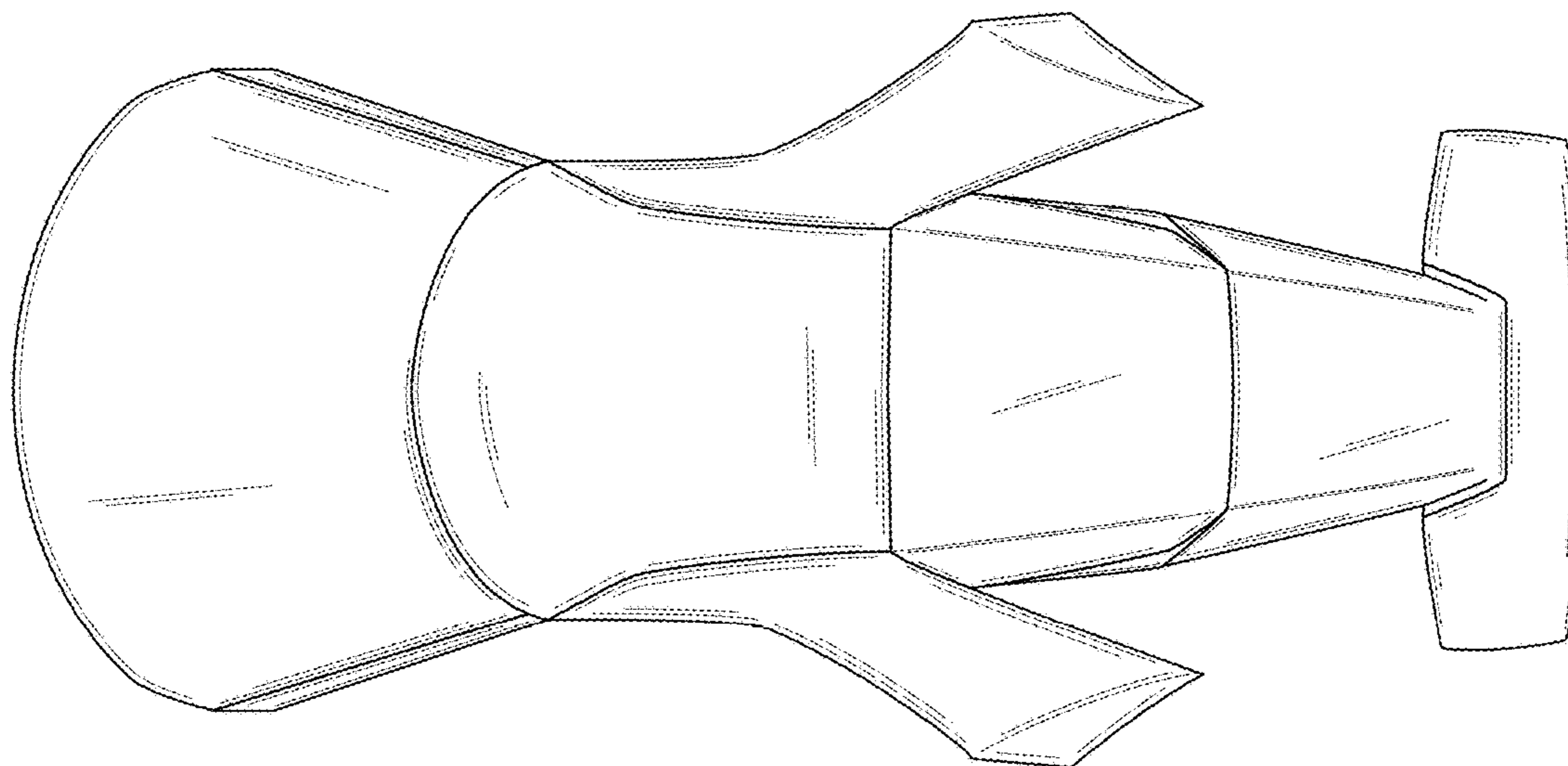

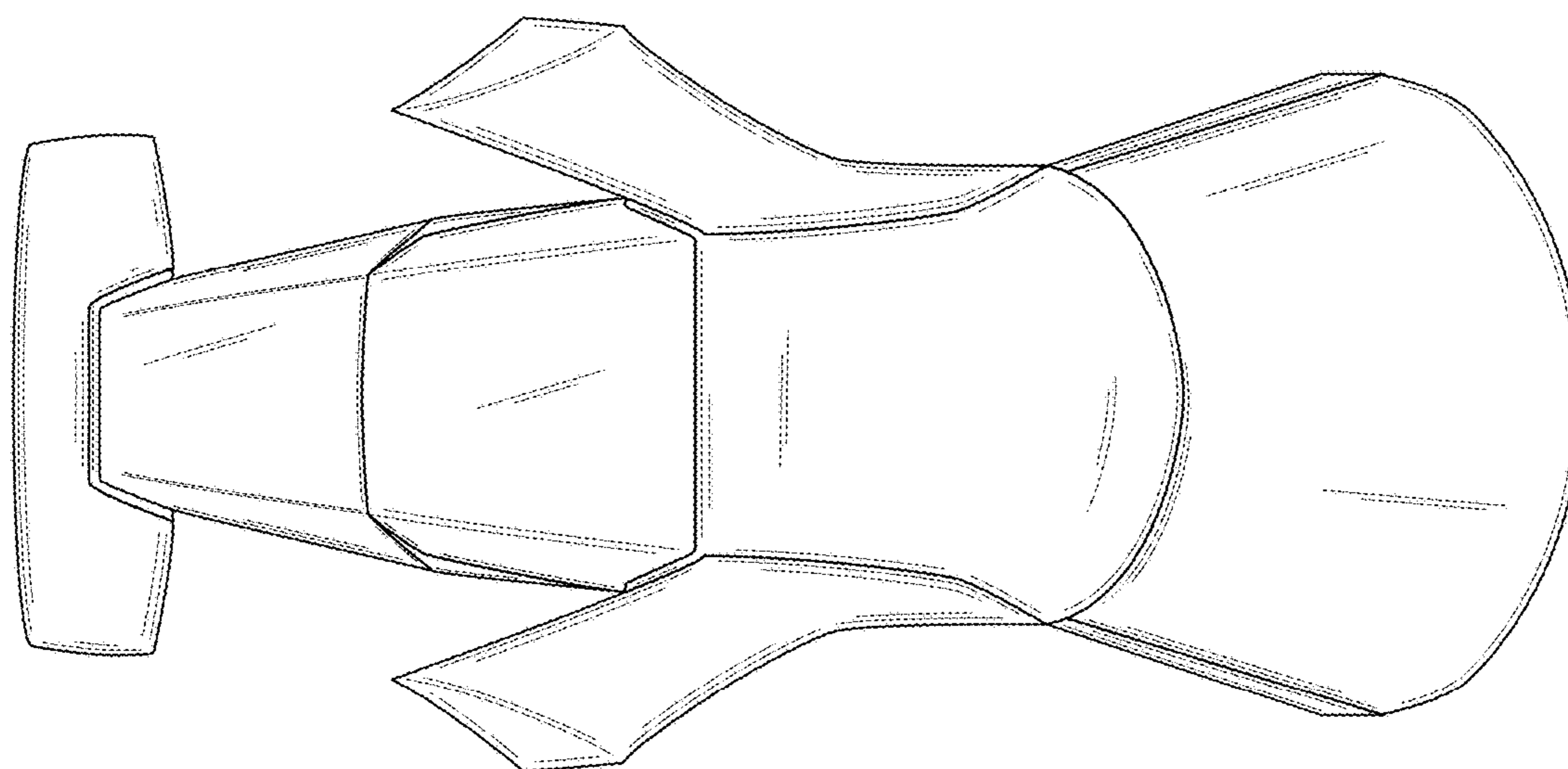

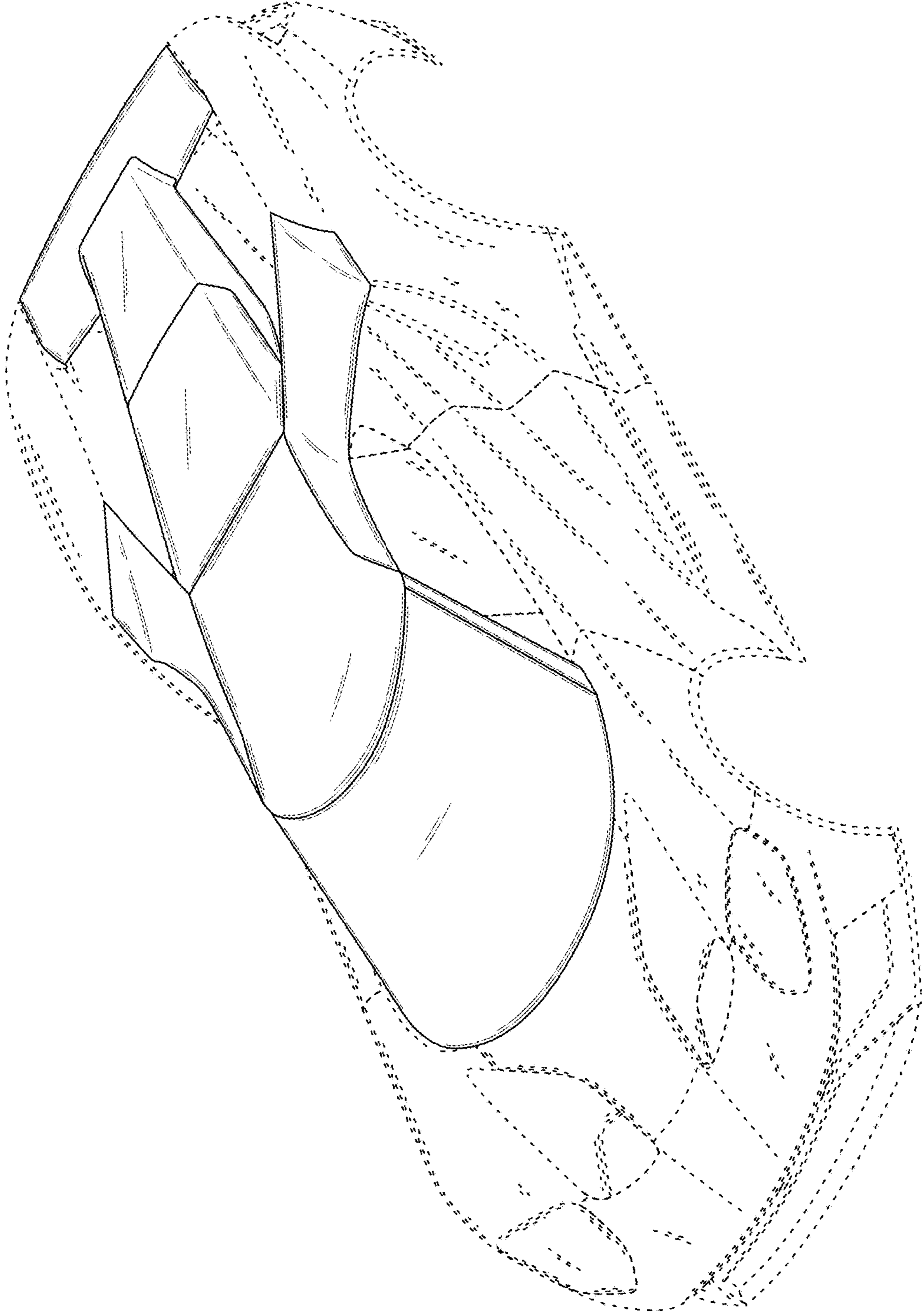
