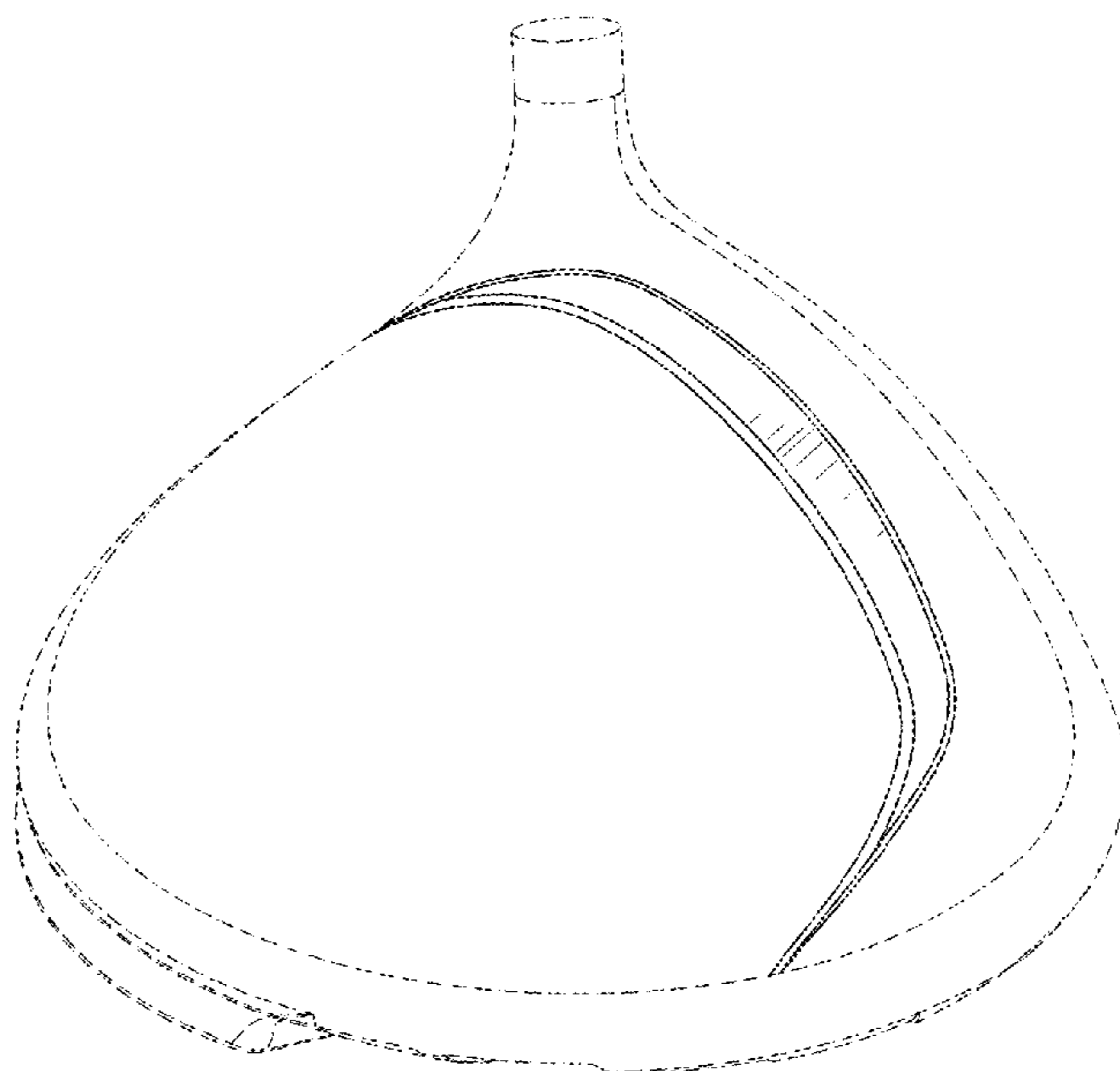
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a top, toe-side, rear perspective view of the golf club head;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a toe-side elevational view thereof; and,
 FIG. 5 is a heel-side elevational view thereof.
 The broken lines depict unclaimed parts of the golf club head, and thus form no part of the claimed design.

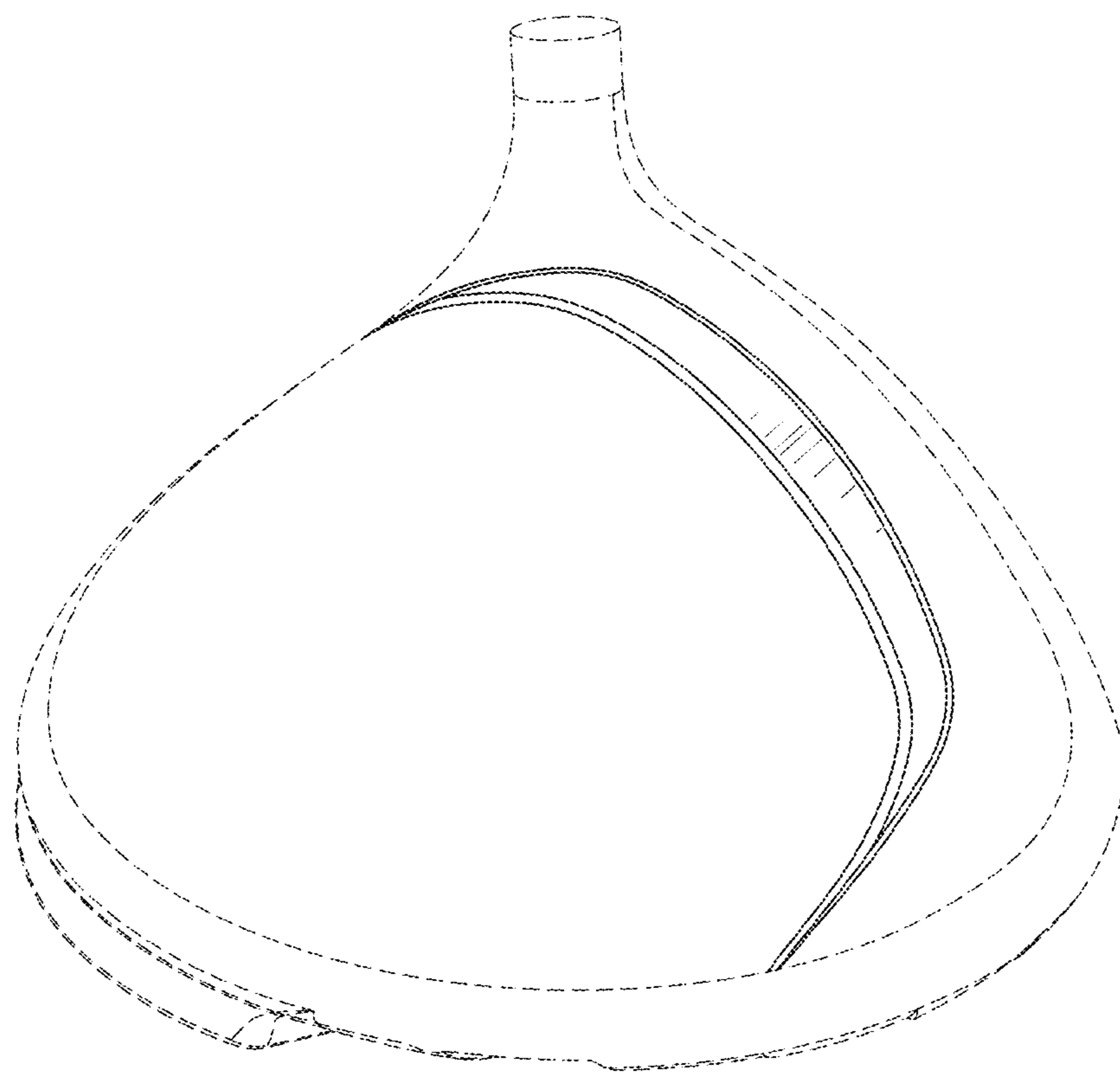

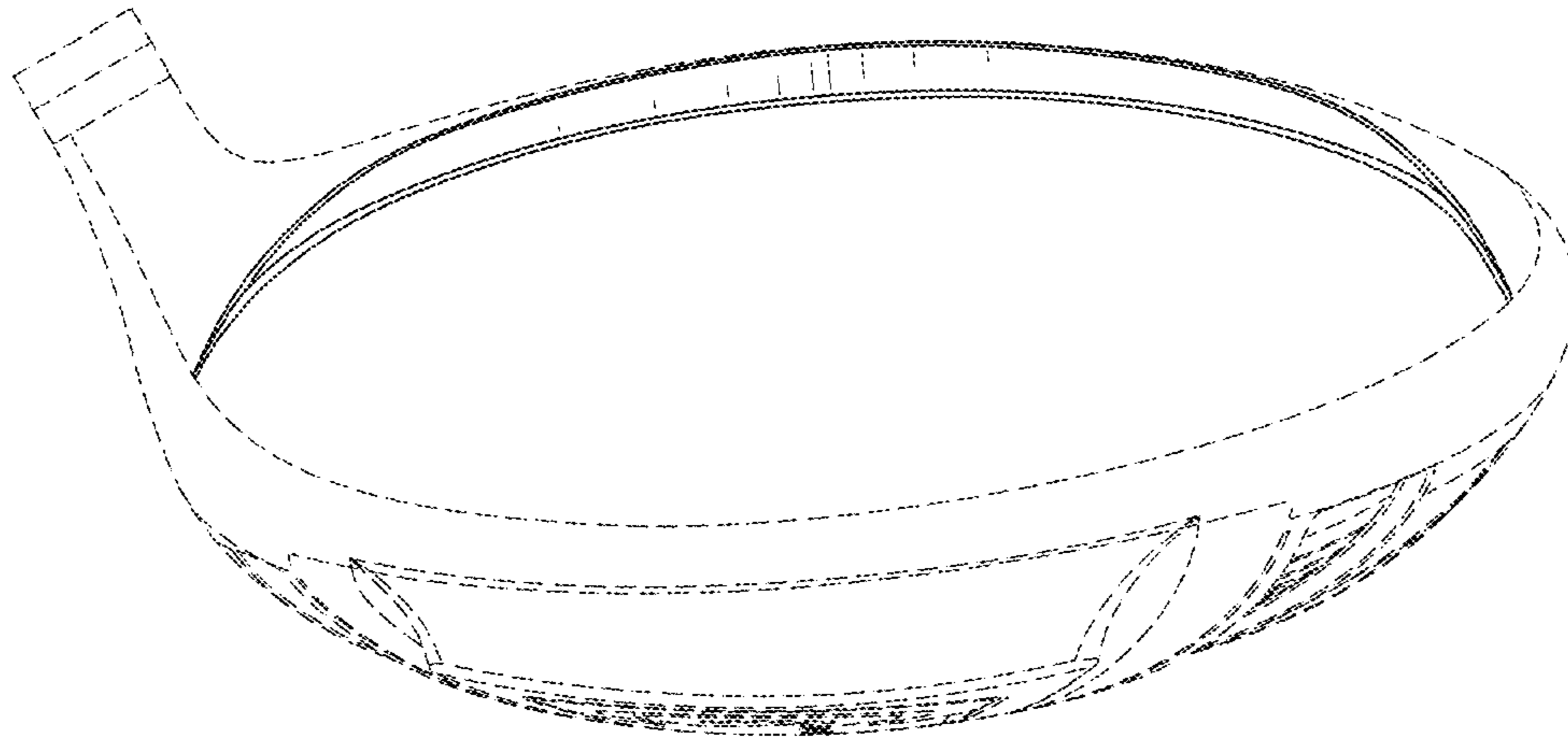

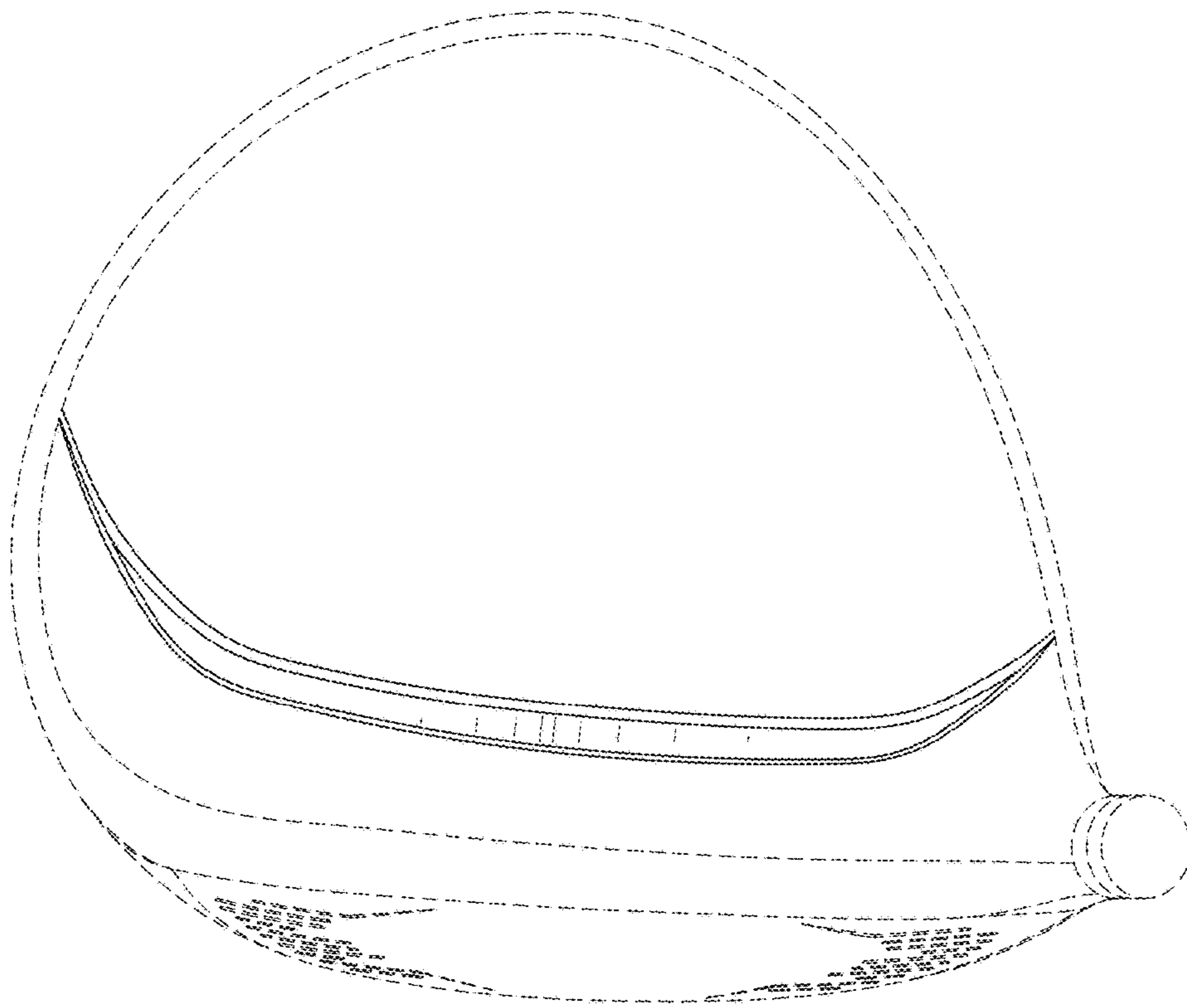

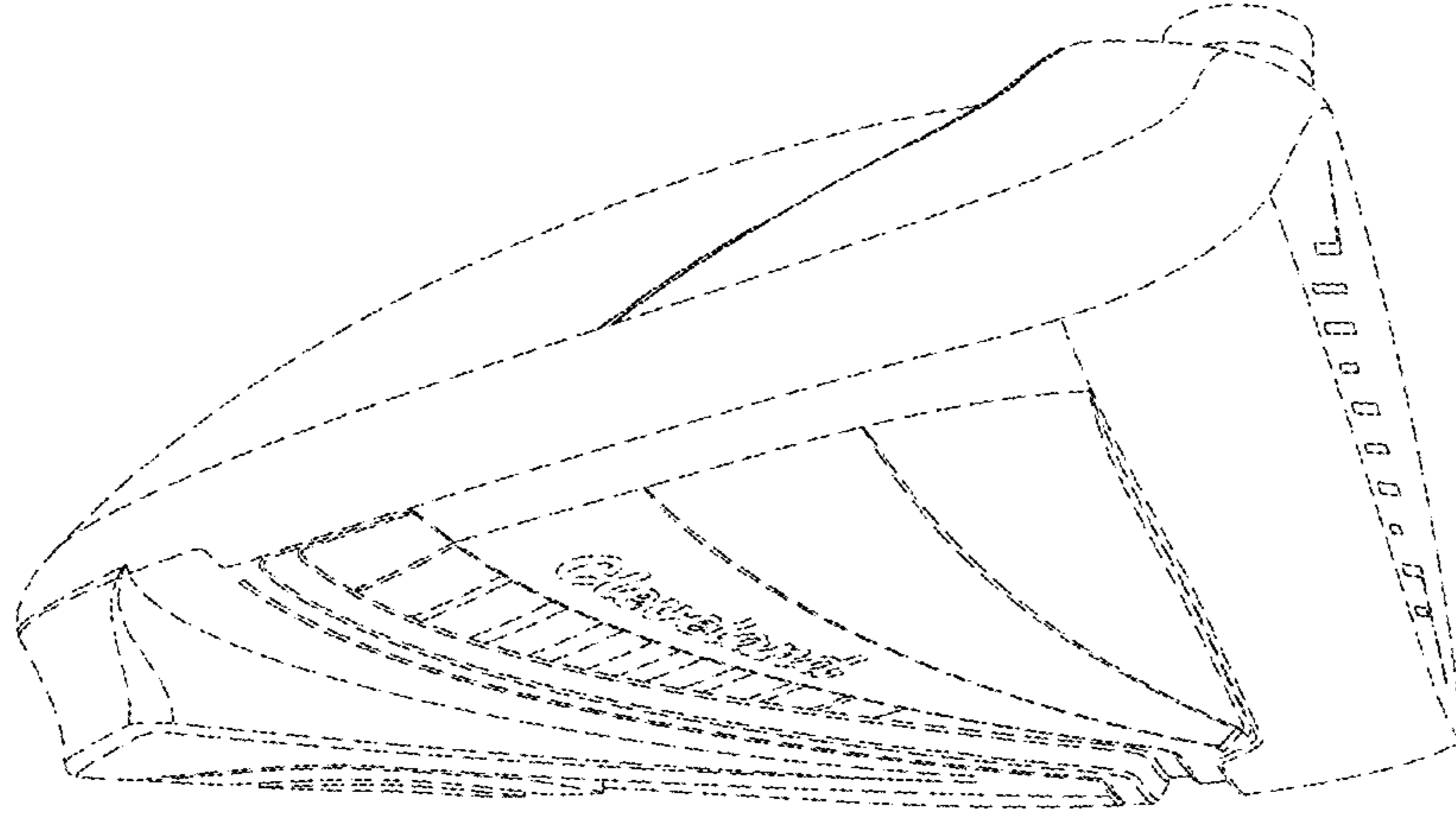

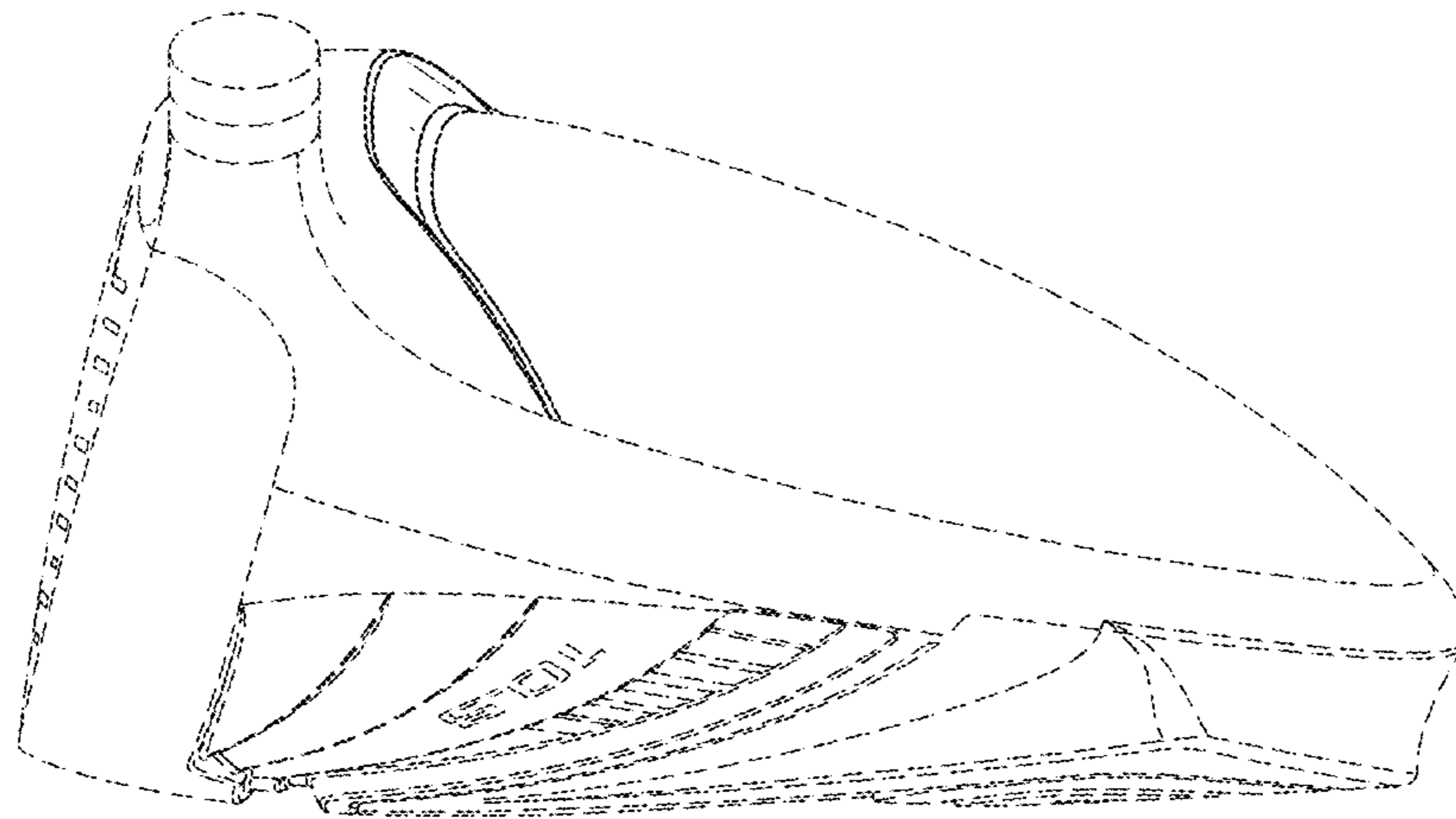
