The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, heel-side, rear perspective view of the golf club head;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a heel-side elevational view thereof;

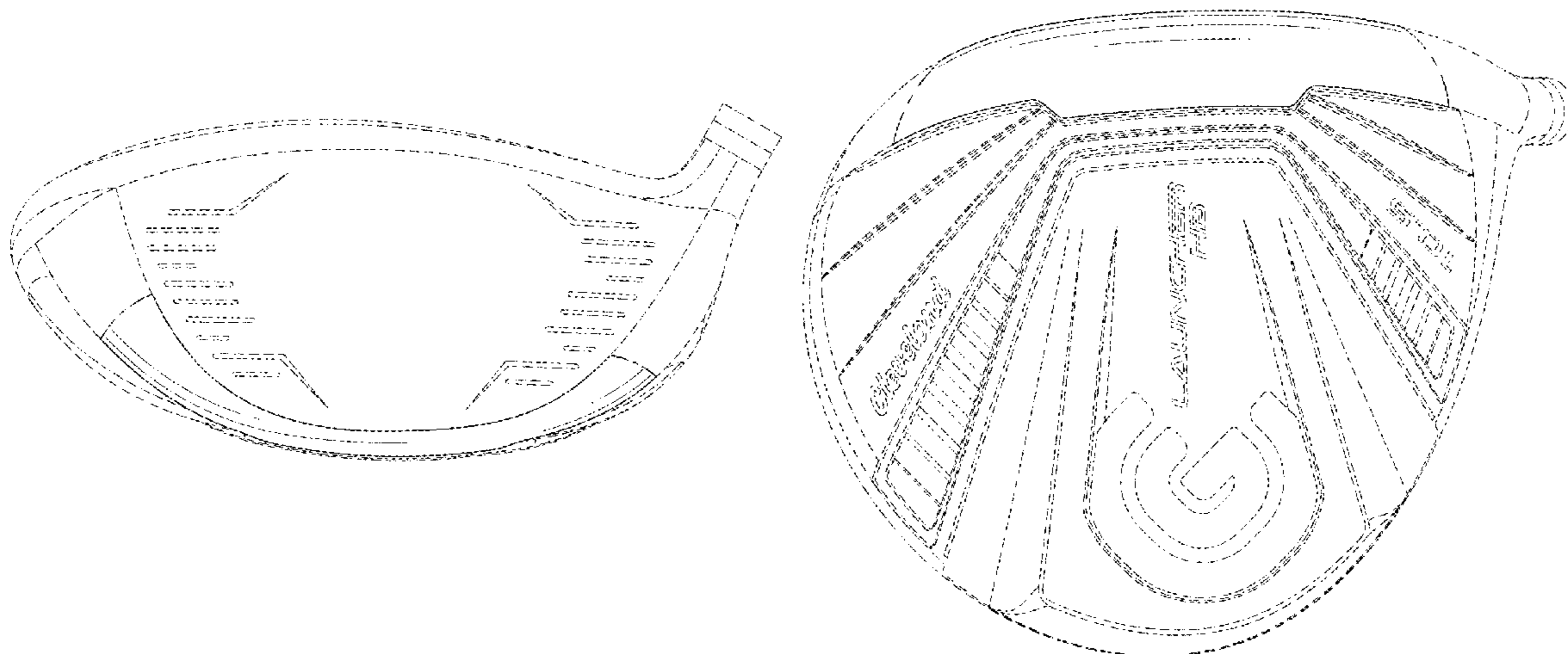
FIG. 4 is a toe-side elevational view thereof; and,

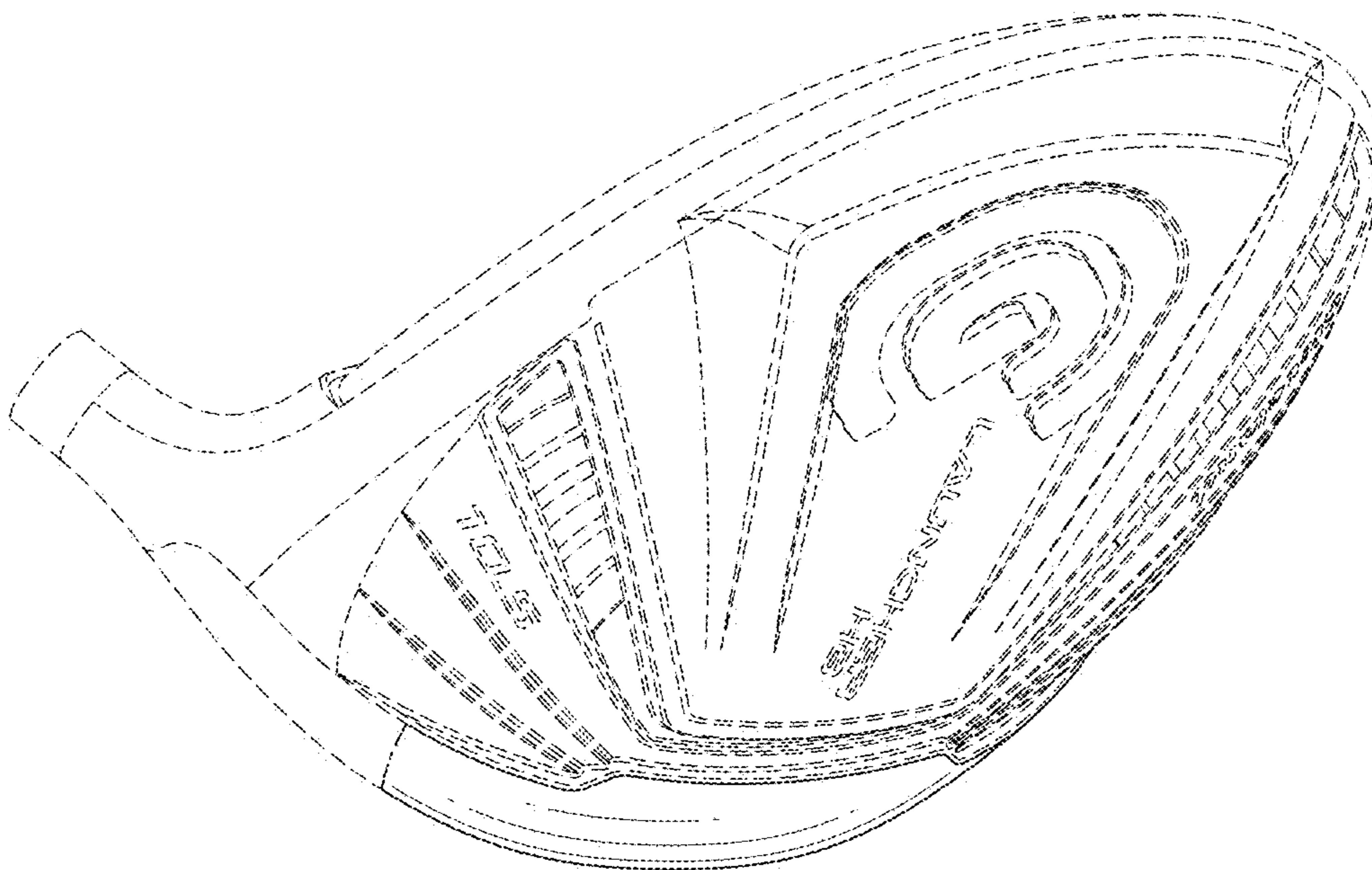

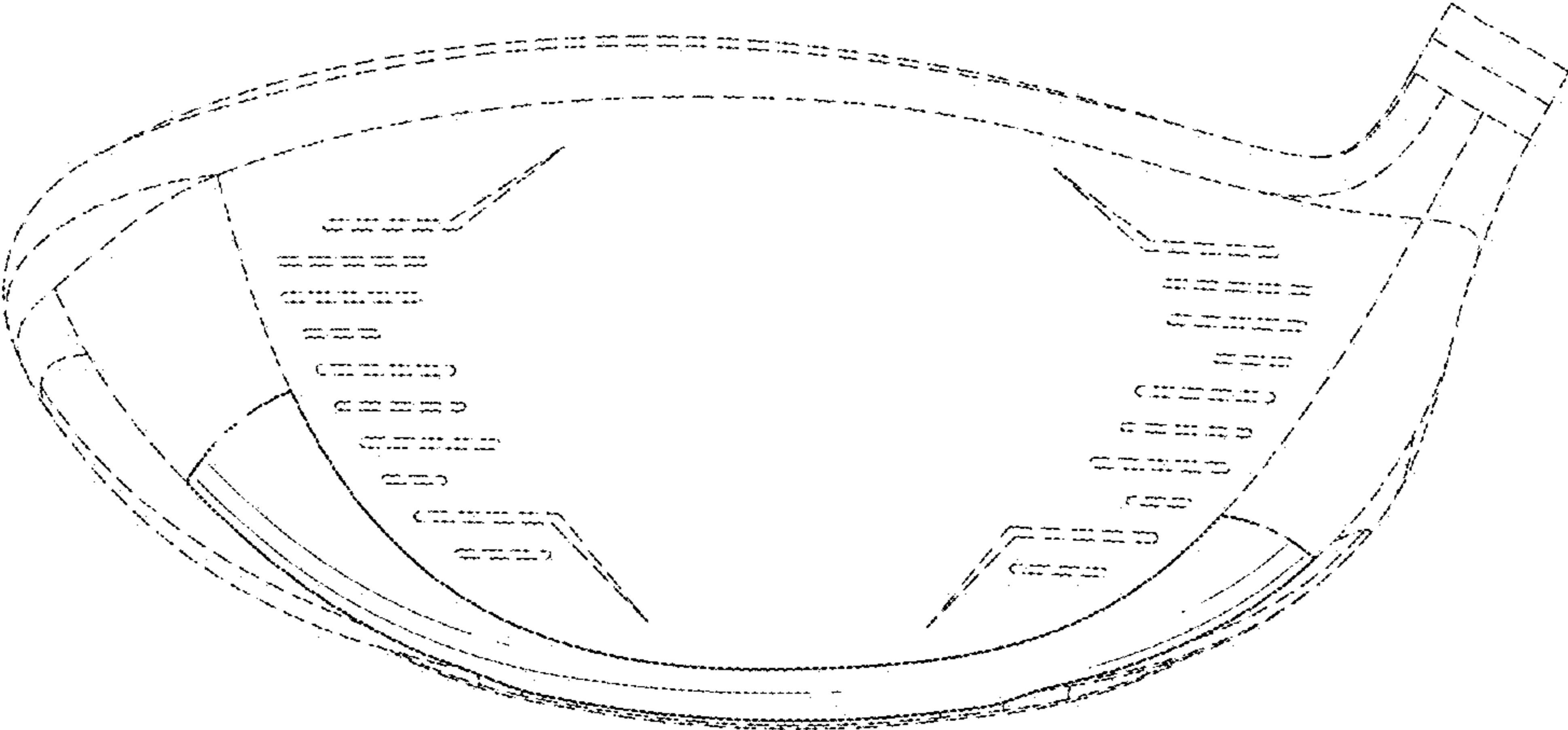

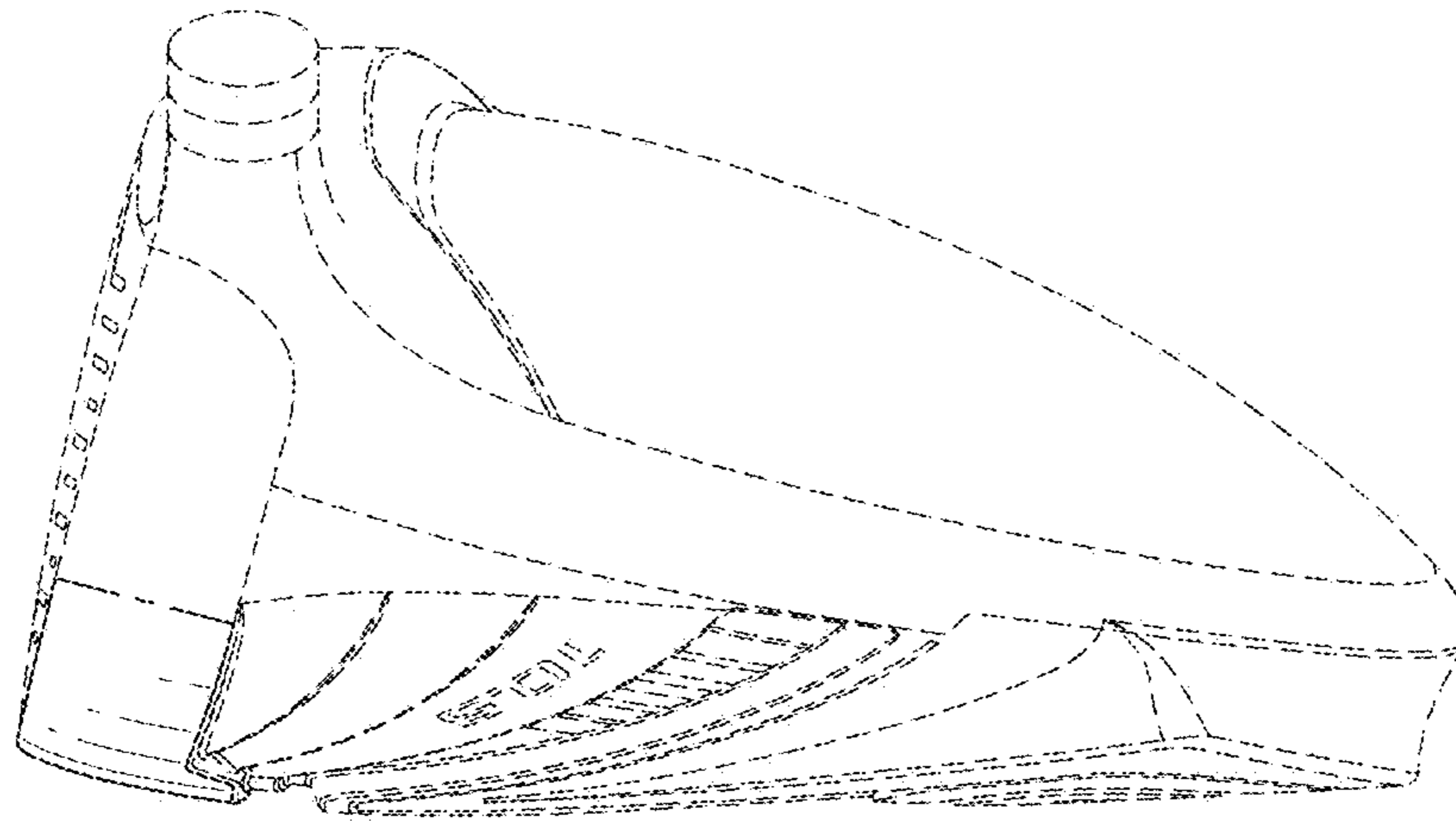

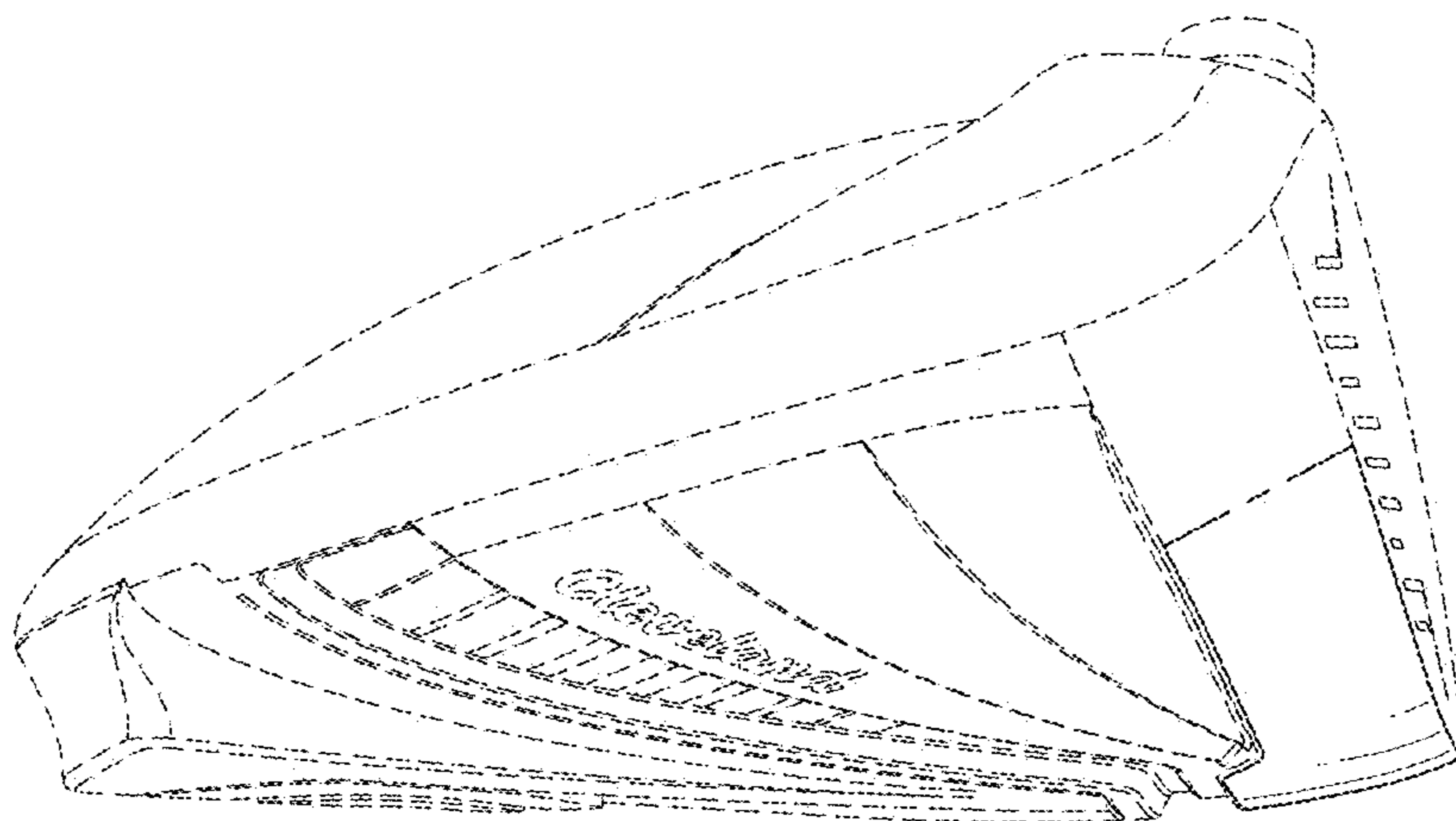

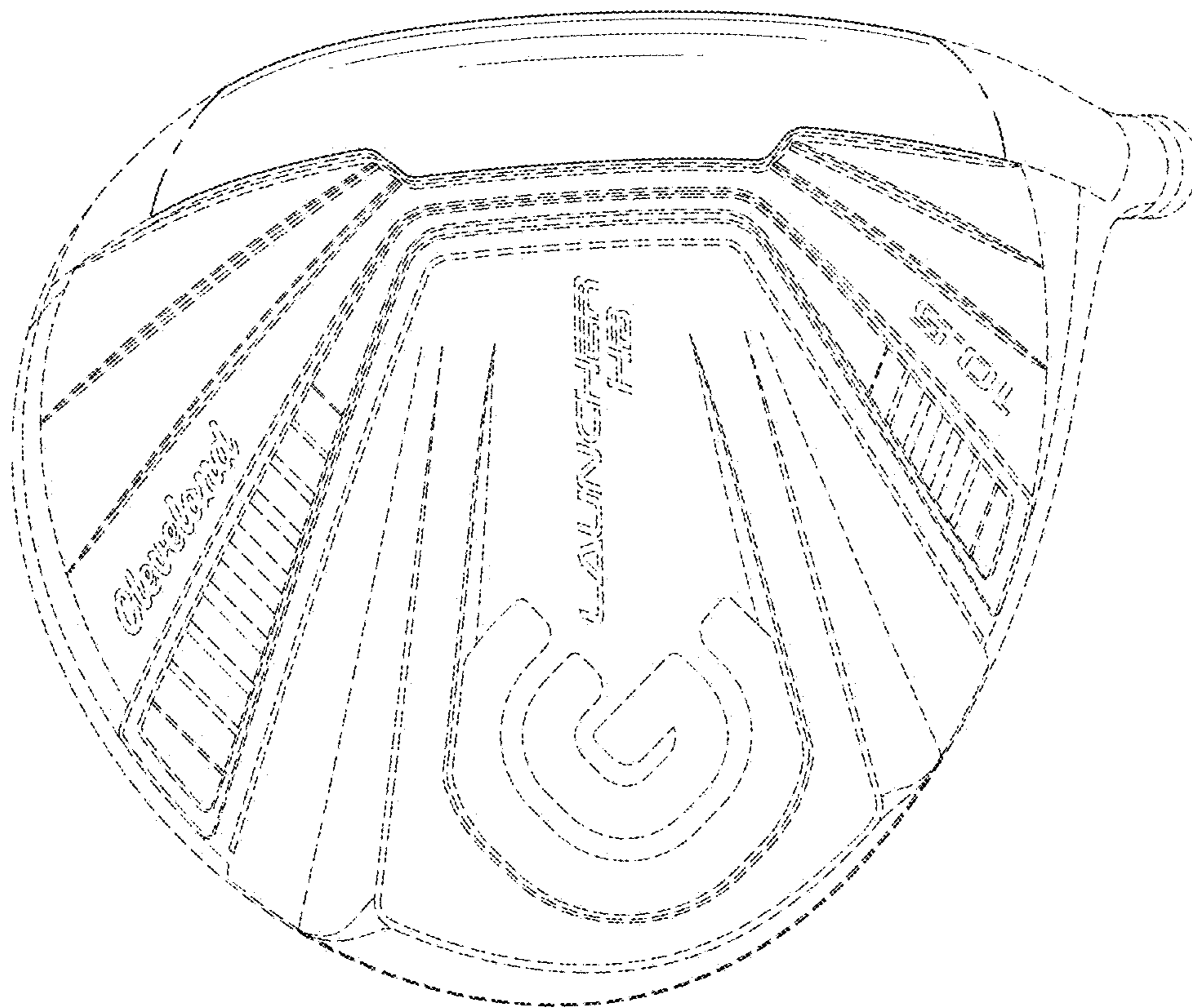
