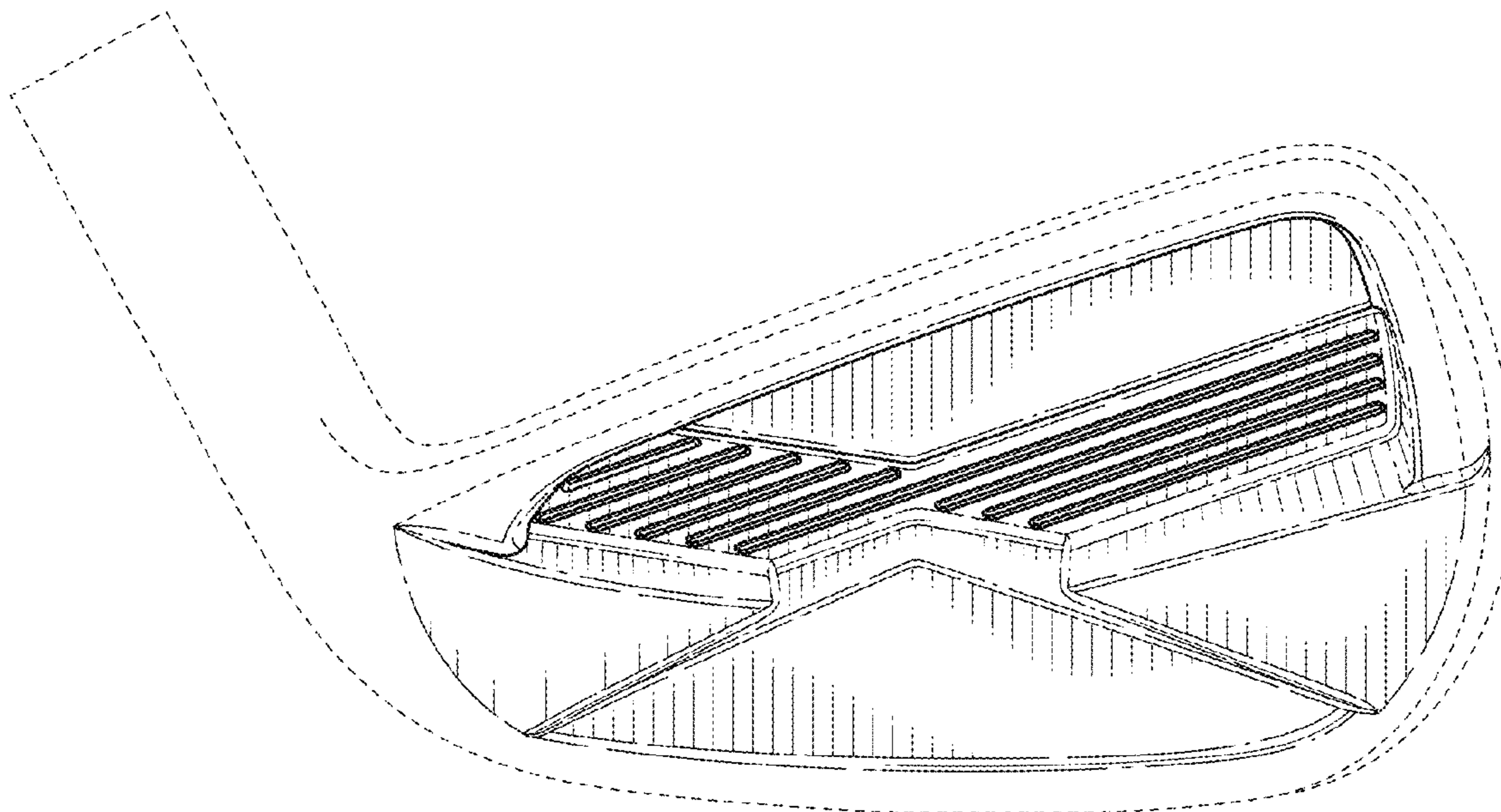
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of the golf club head claimed herein;

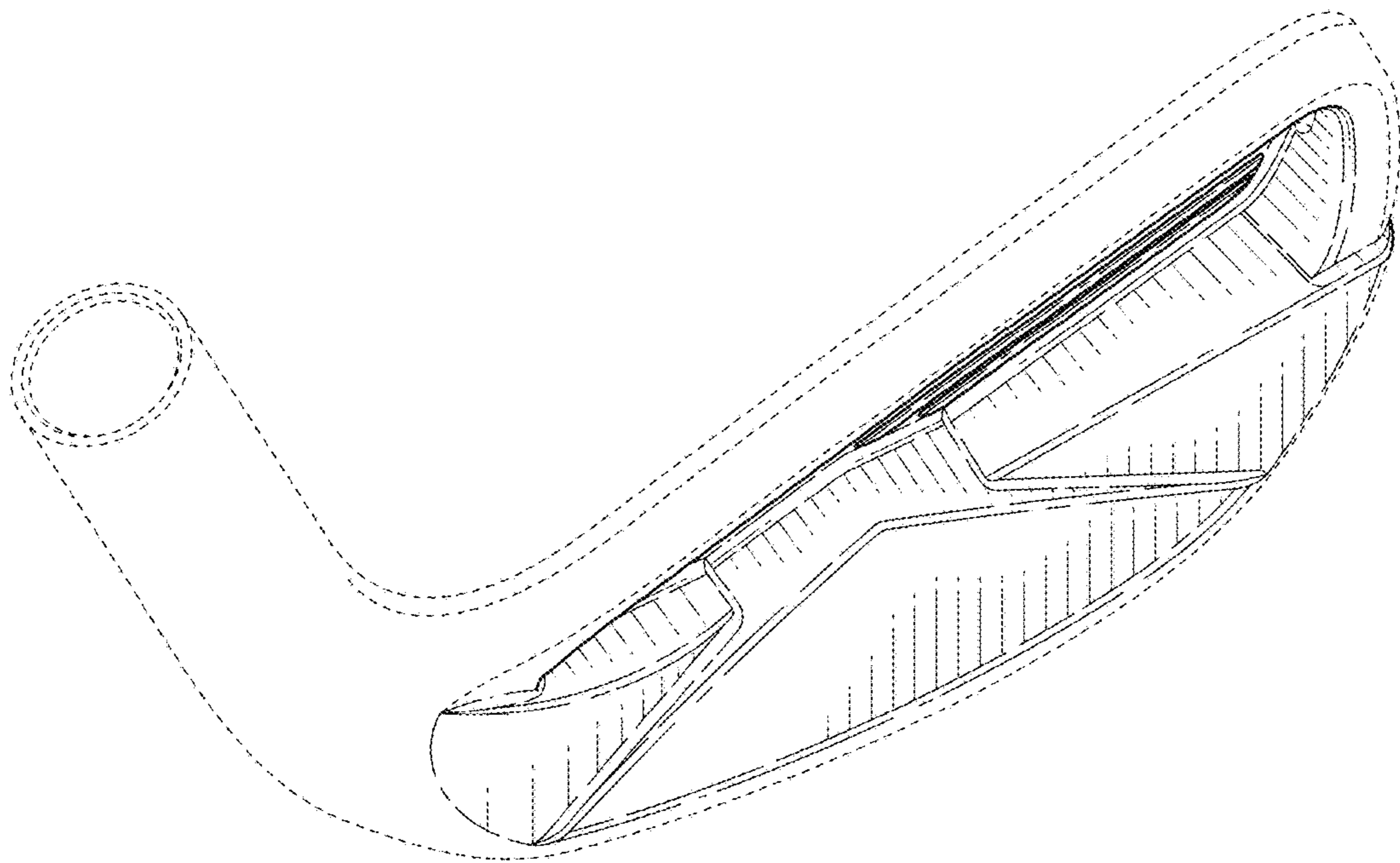

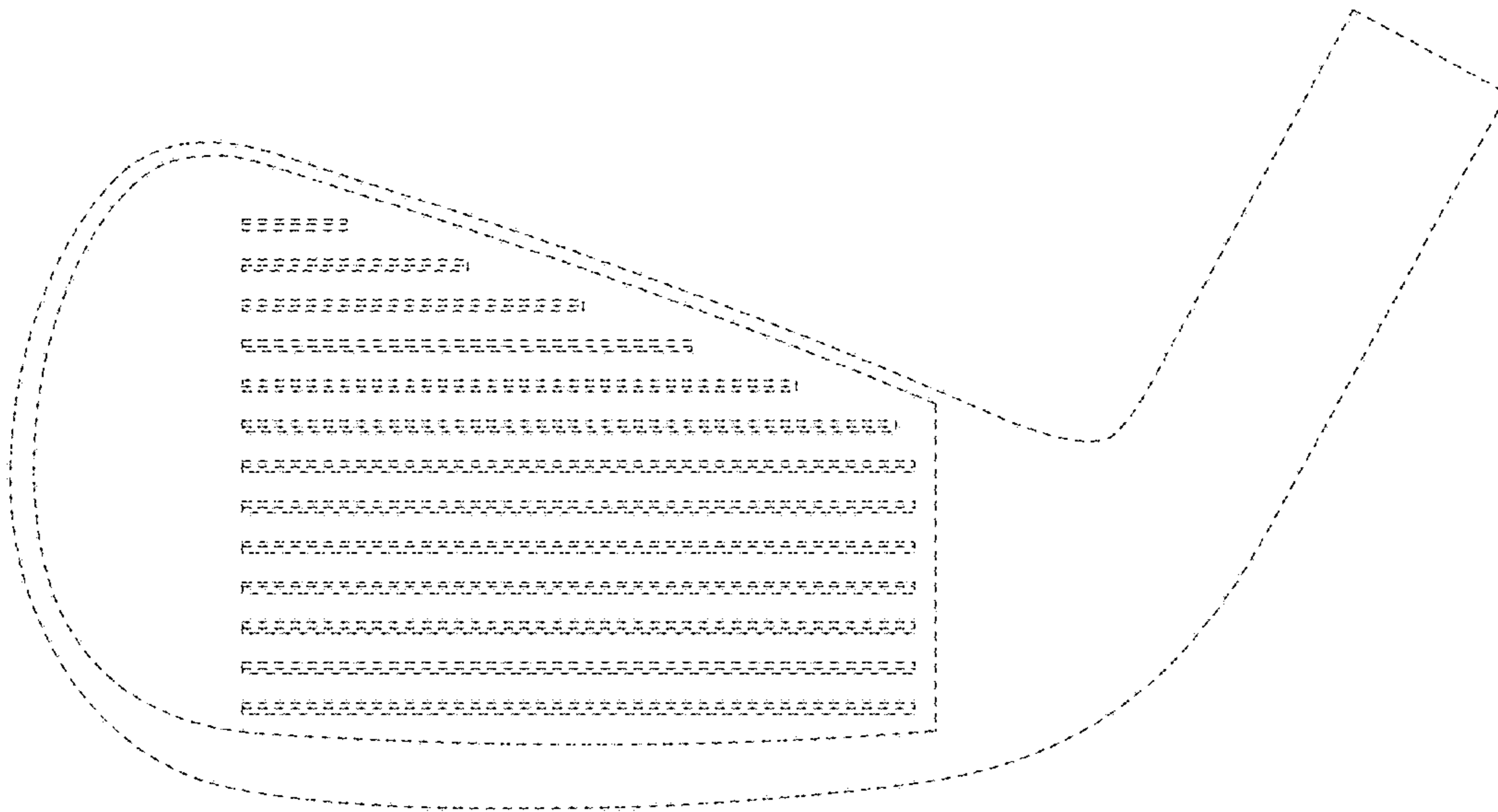

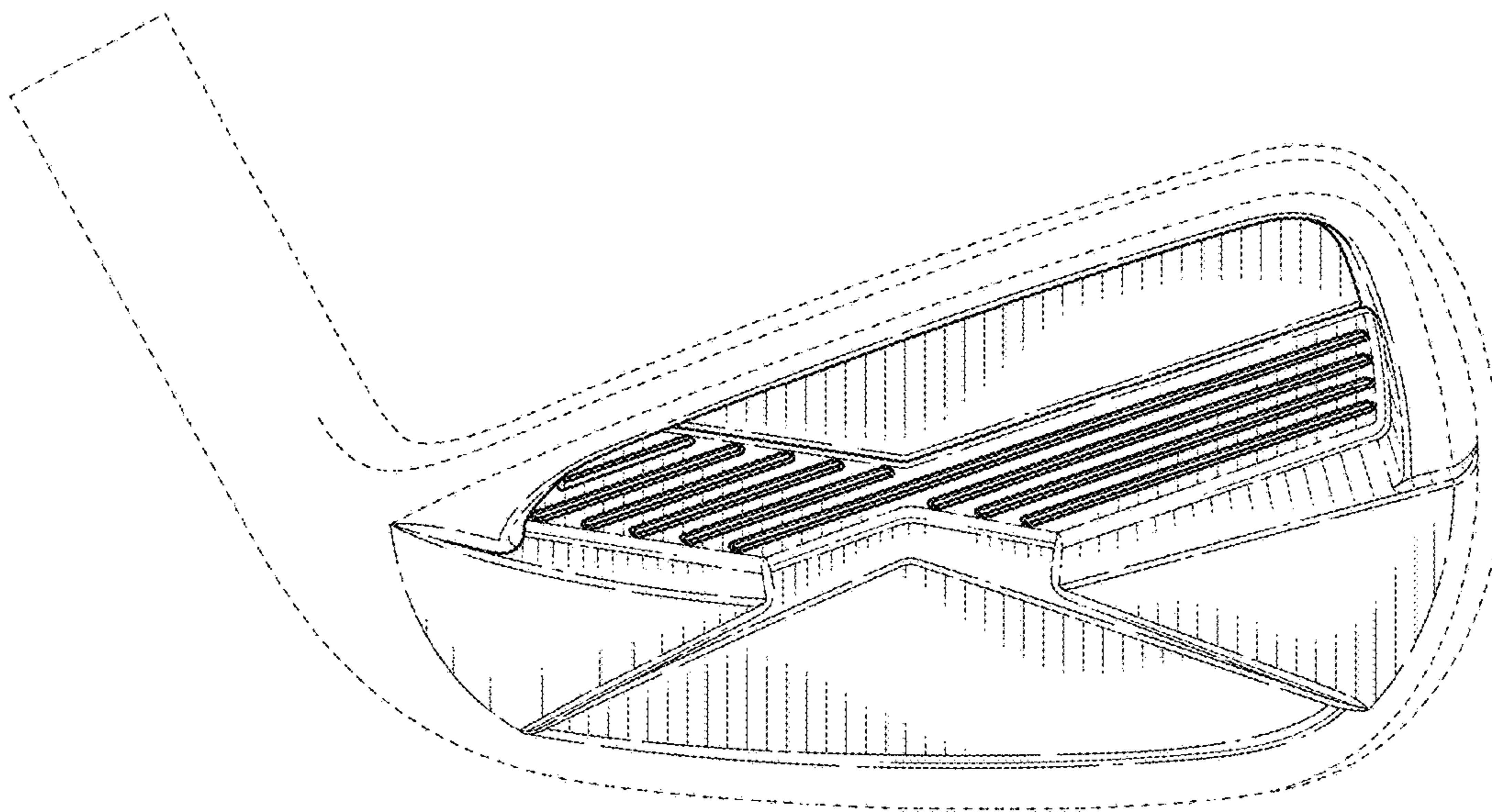

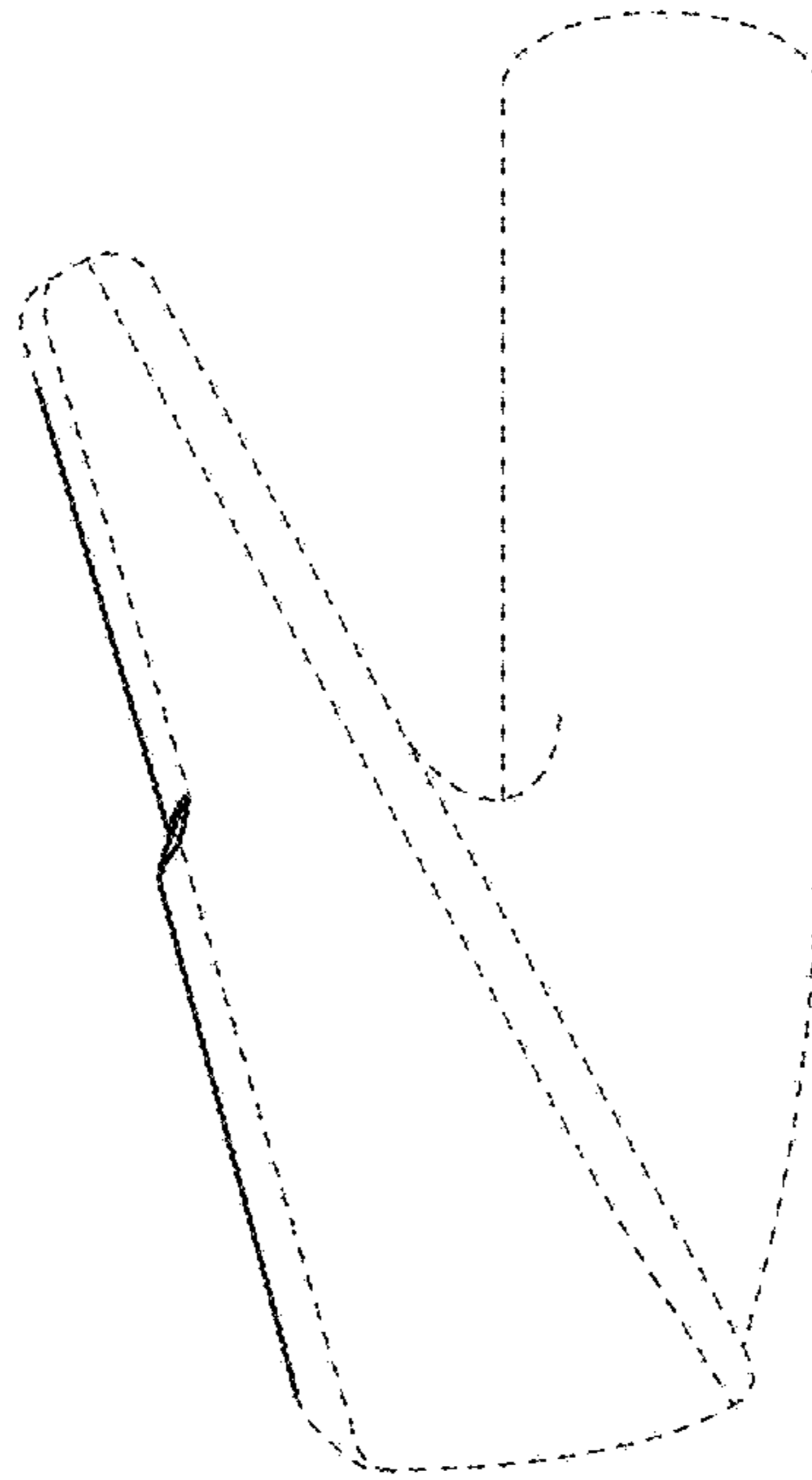

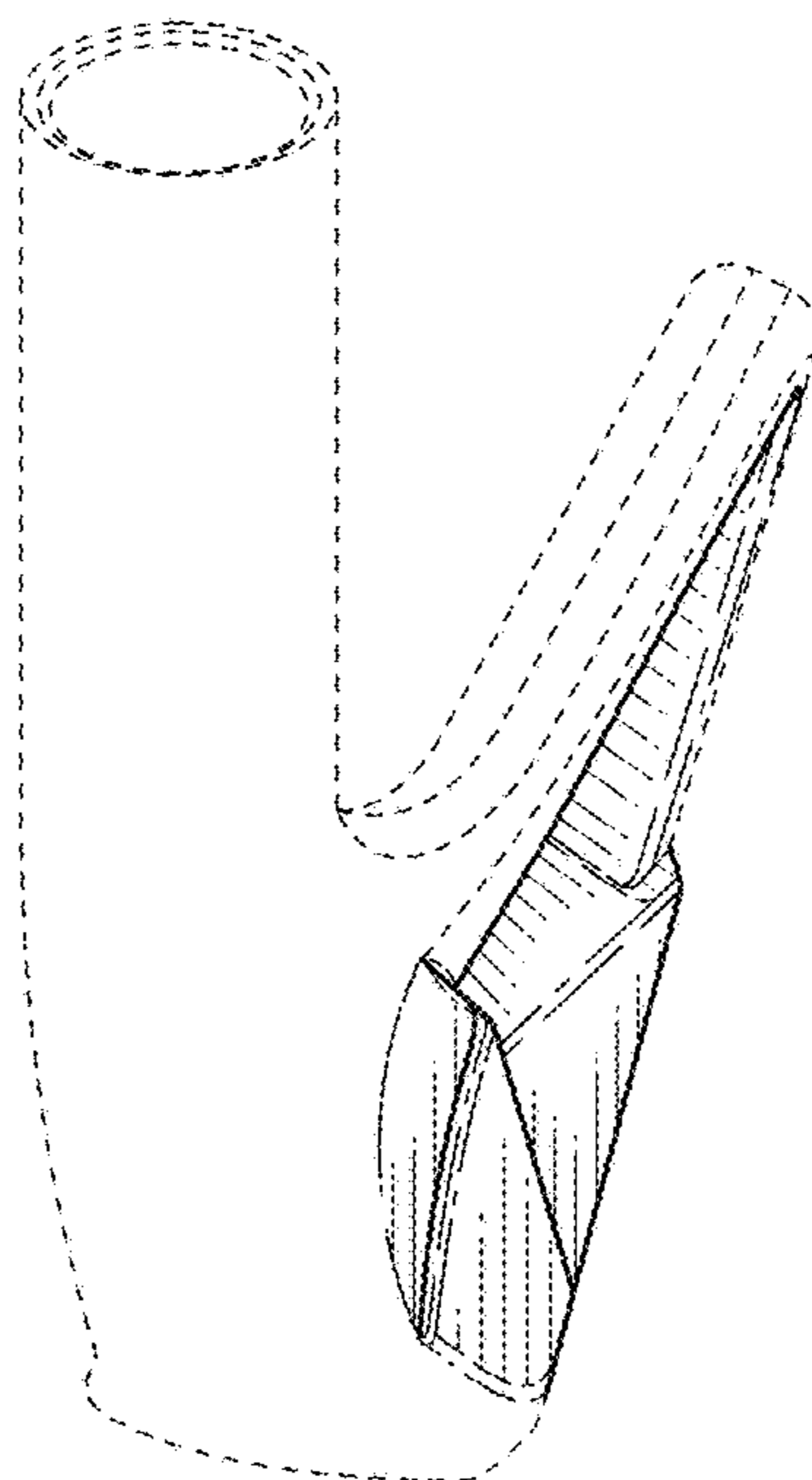

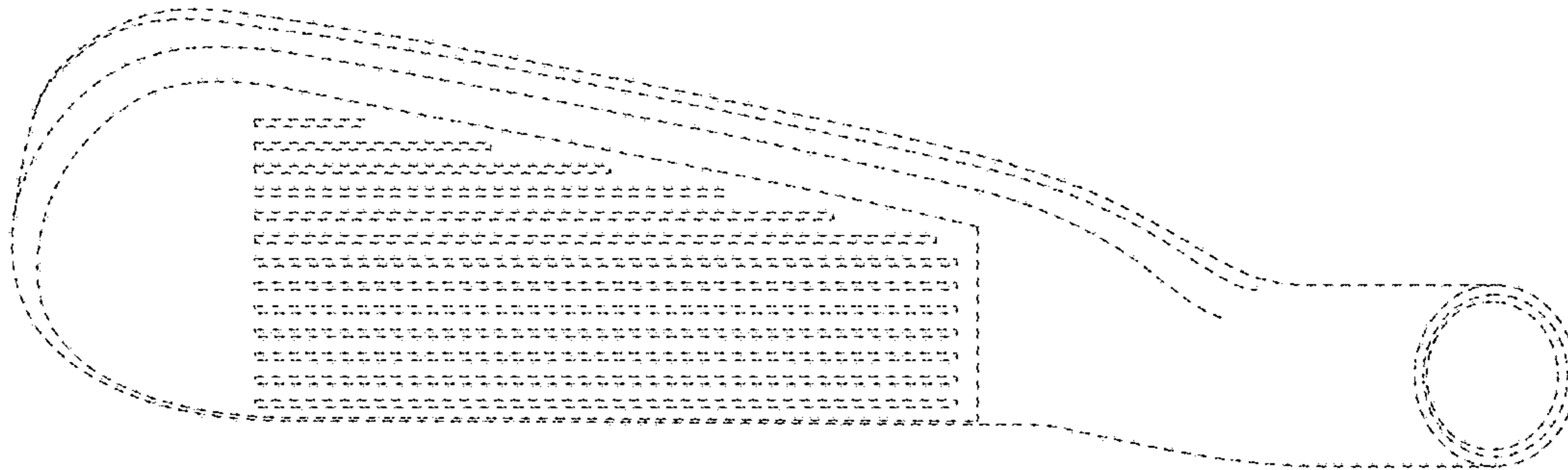

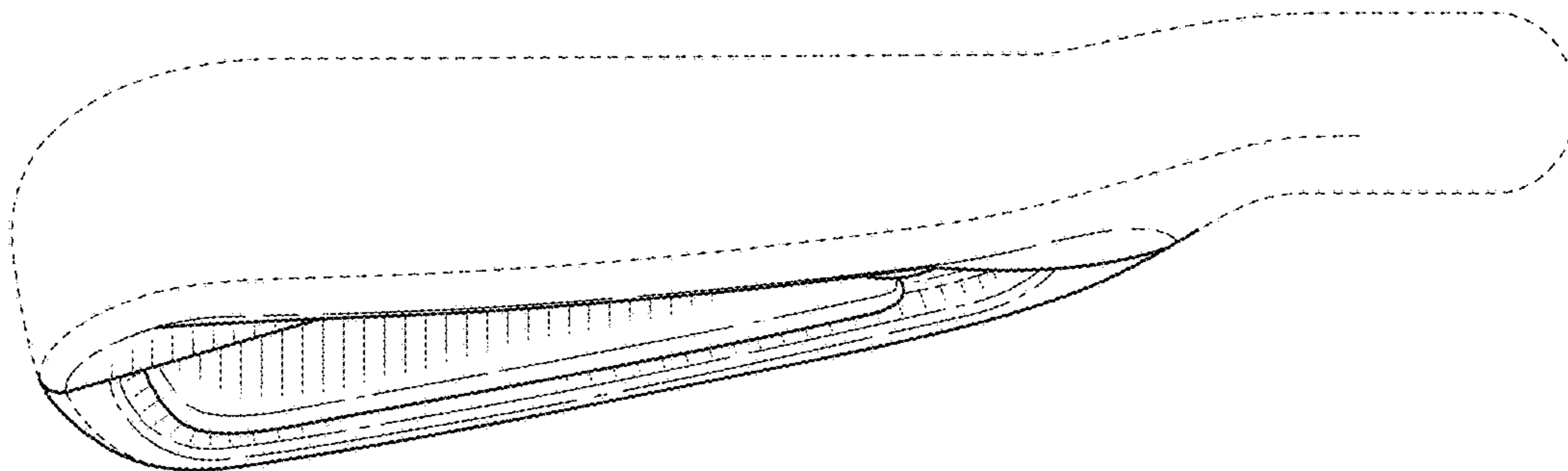
