The ornamental design for a rectal plug, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a rectal plug showing our new design;
 FIG. 2 is a rear, top, and right side perspective view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a left side view thereof;
 FIG. 7 is a top view thereof; and,
 FIG. 8 is a bottom view thereof.

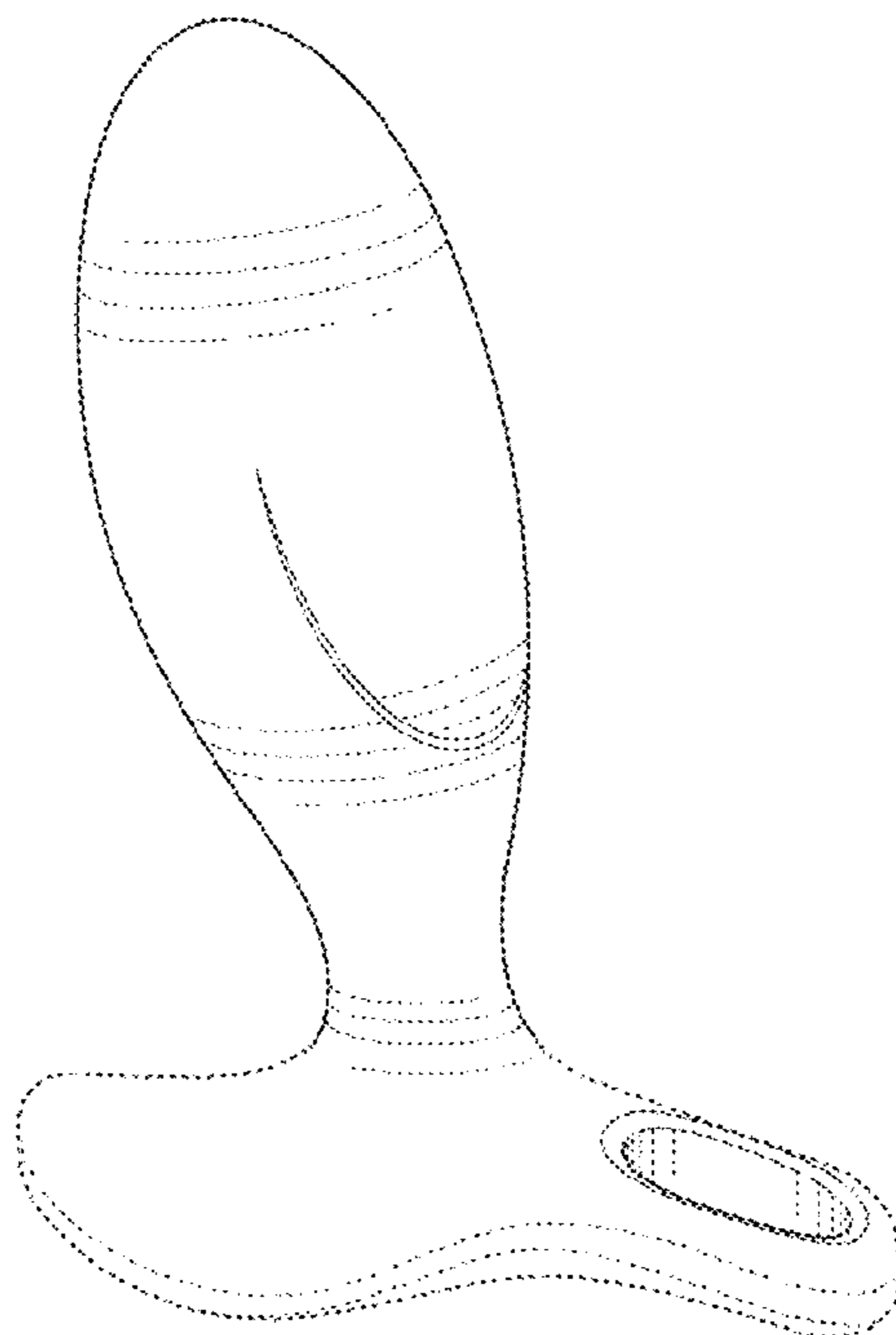

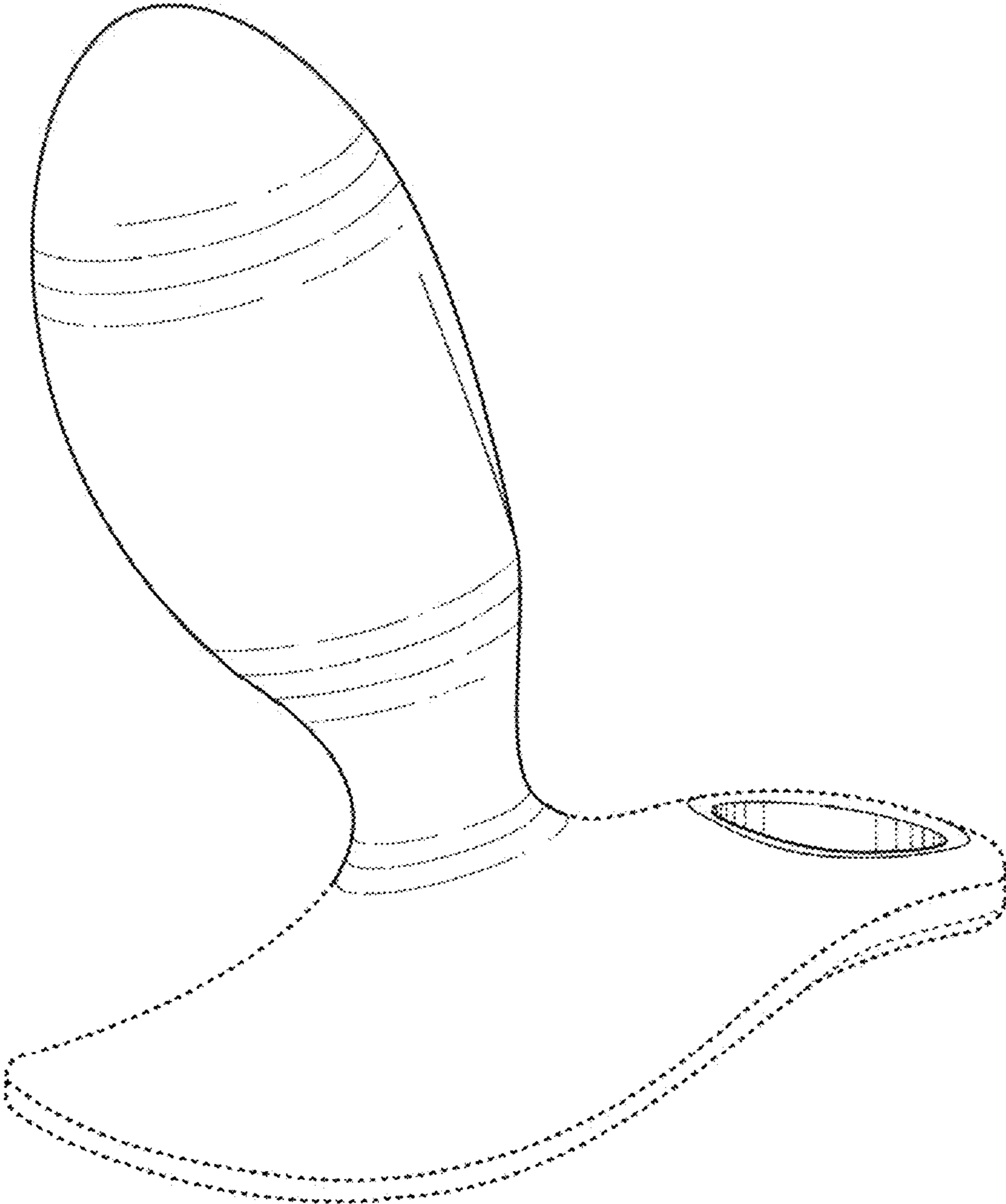

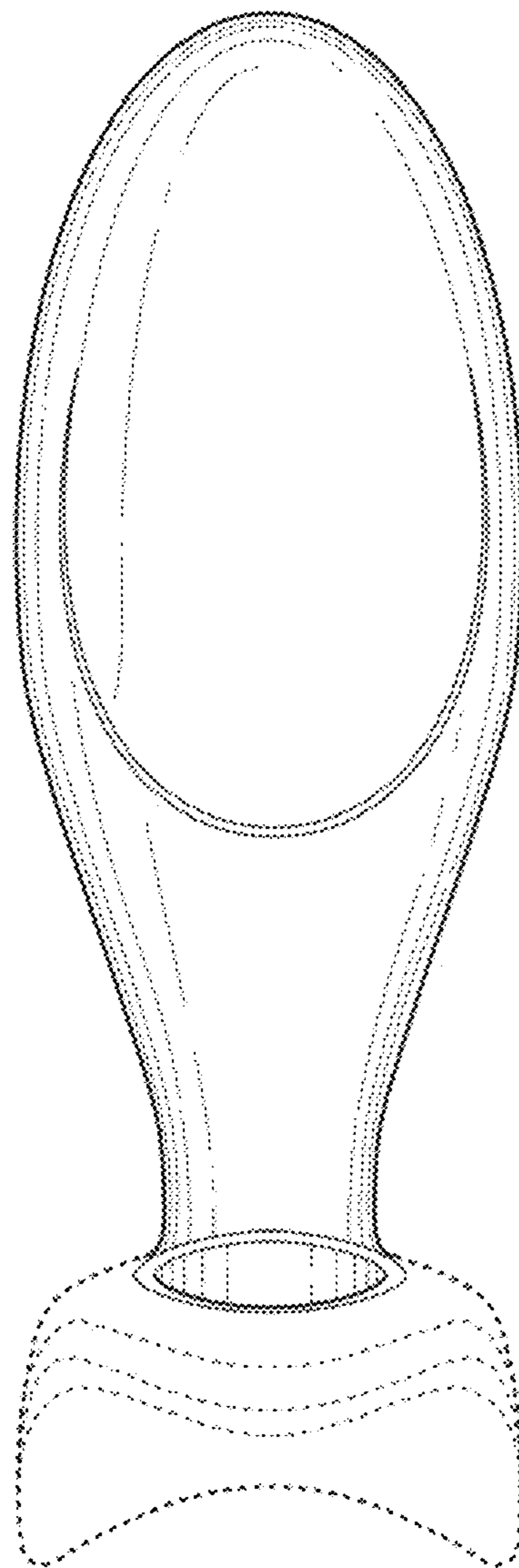

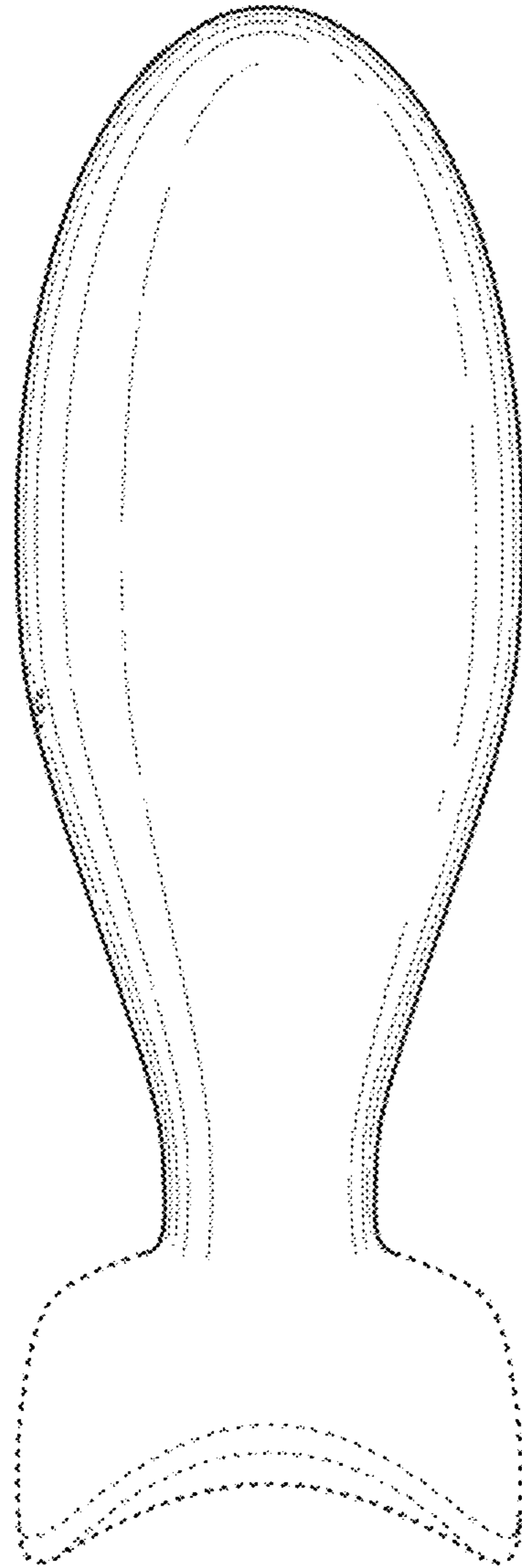

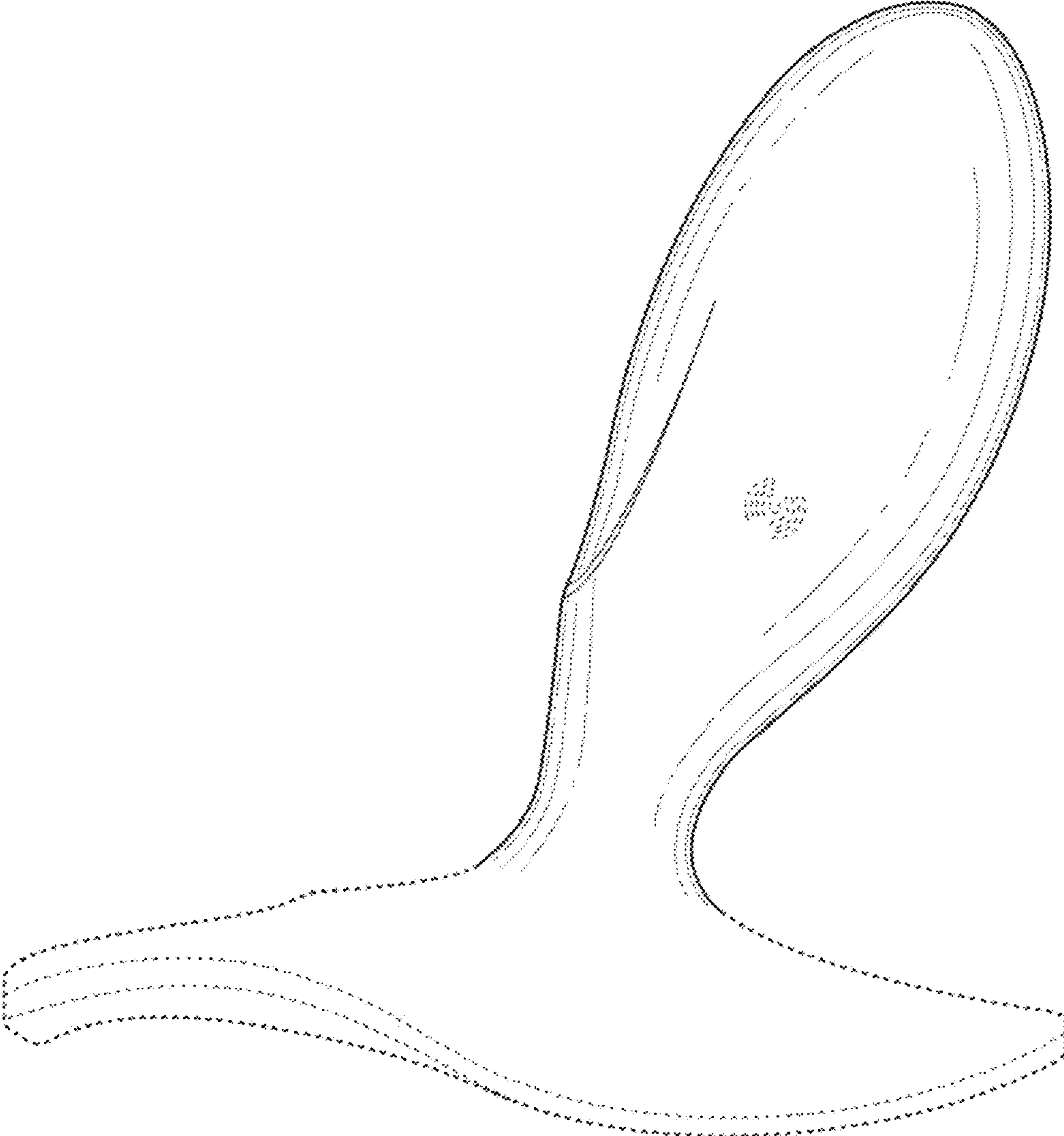

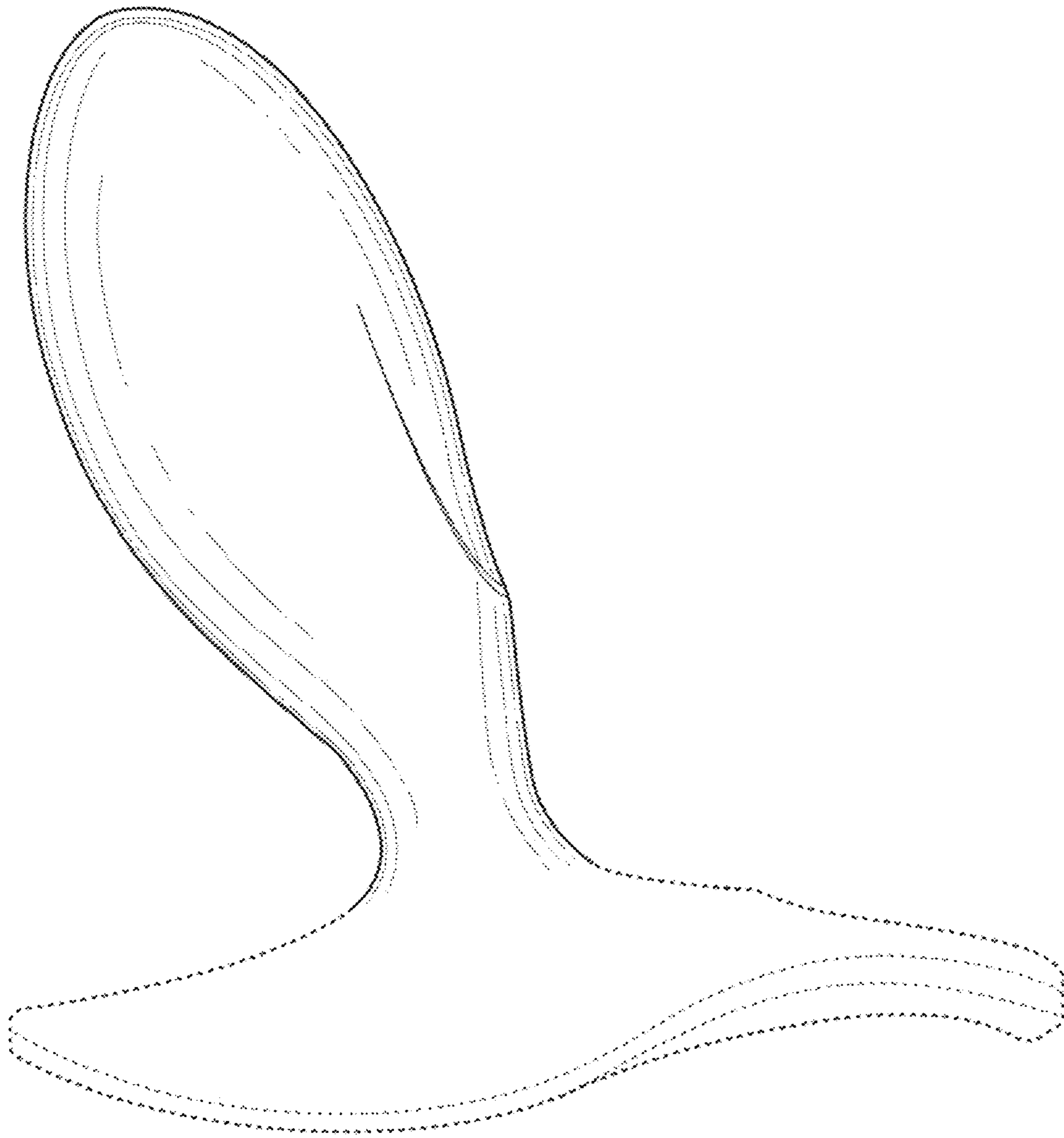

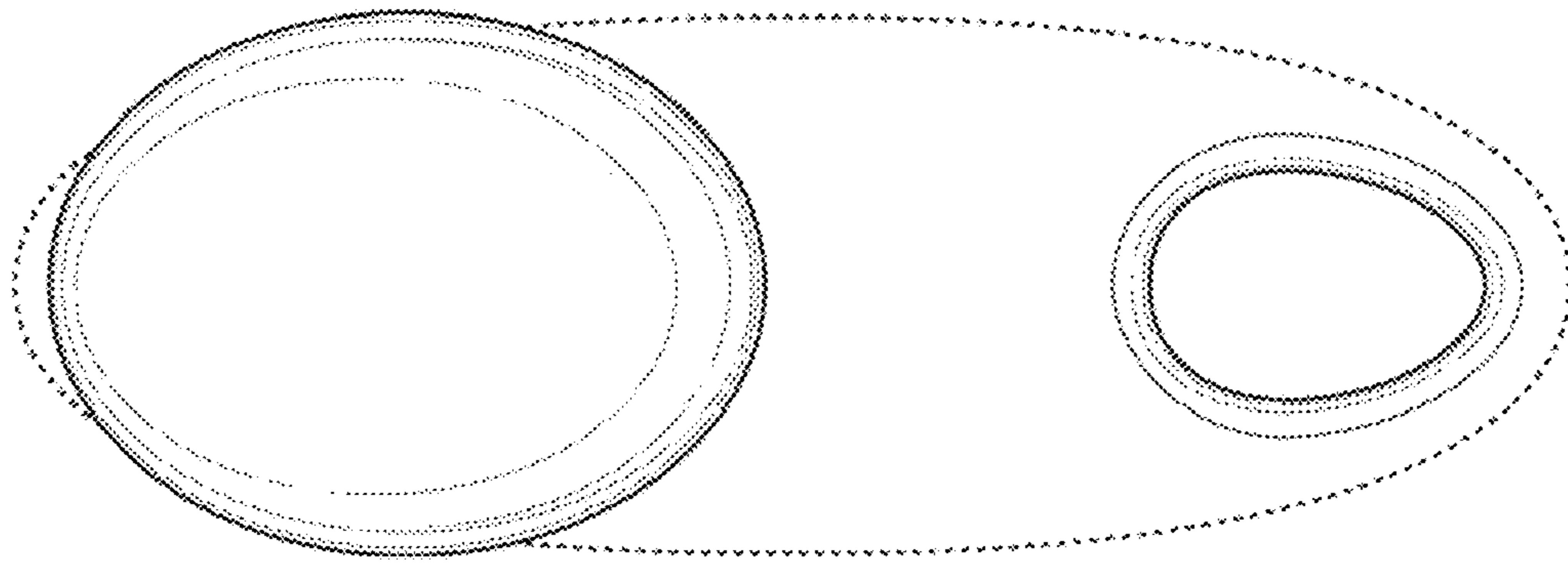

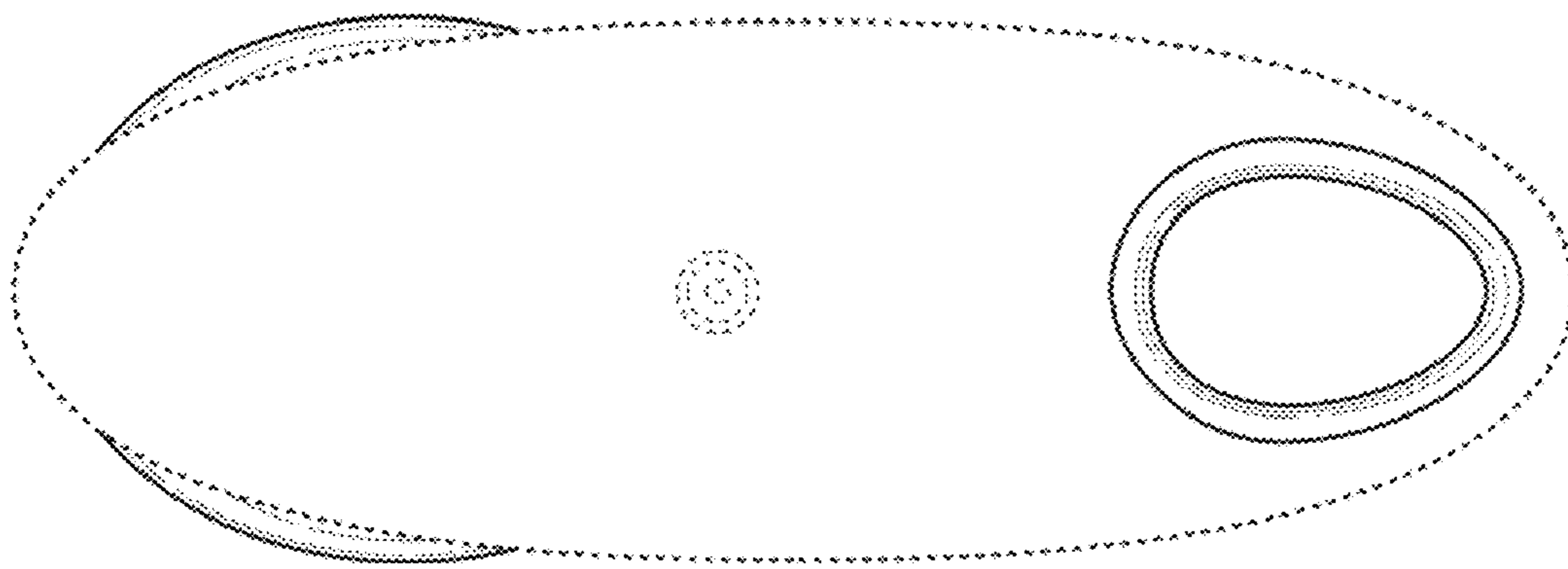
