(57) **CLAIM**

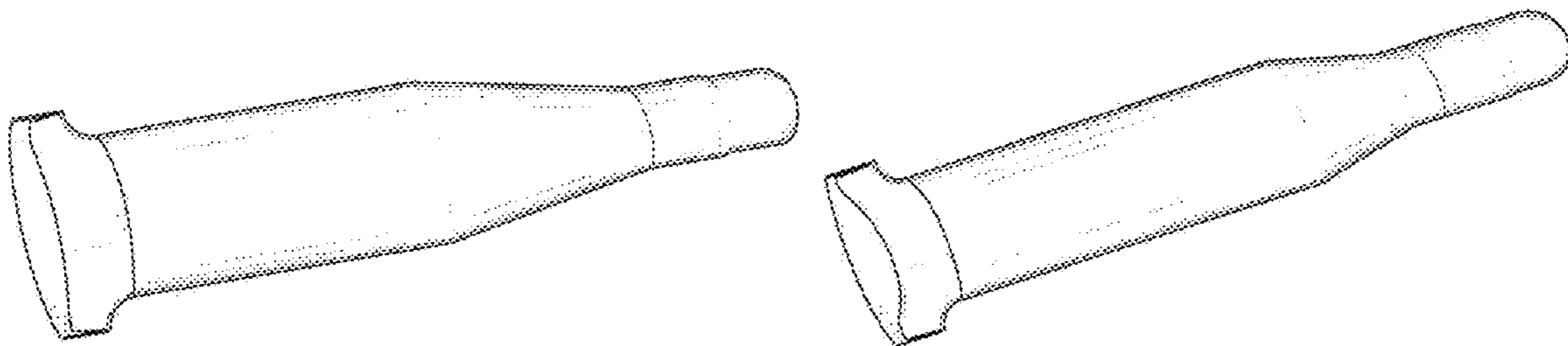
The ornamental design for a sleeve for use with a dental instrument, as shown and described.

DESCRIPTION

FIG. 1 illustrates an isometric view of a sleeve for use with a dental instrument;
FIG. 2 illustrates a side elevation view of the sleeve of FIG. 1;

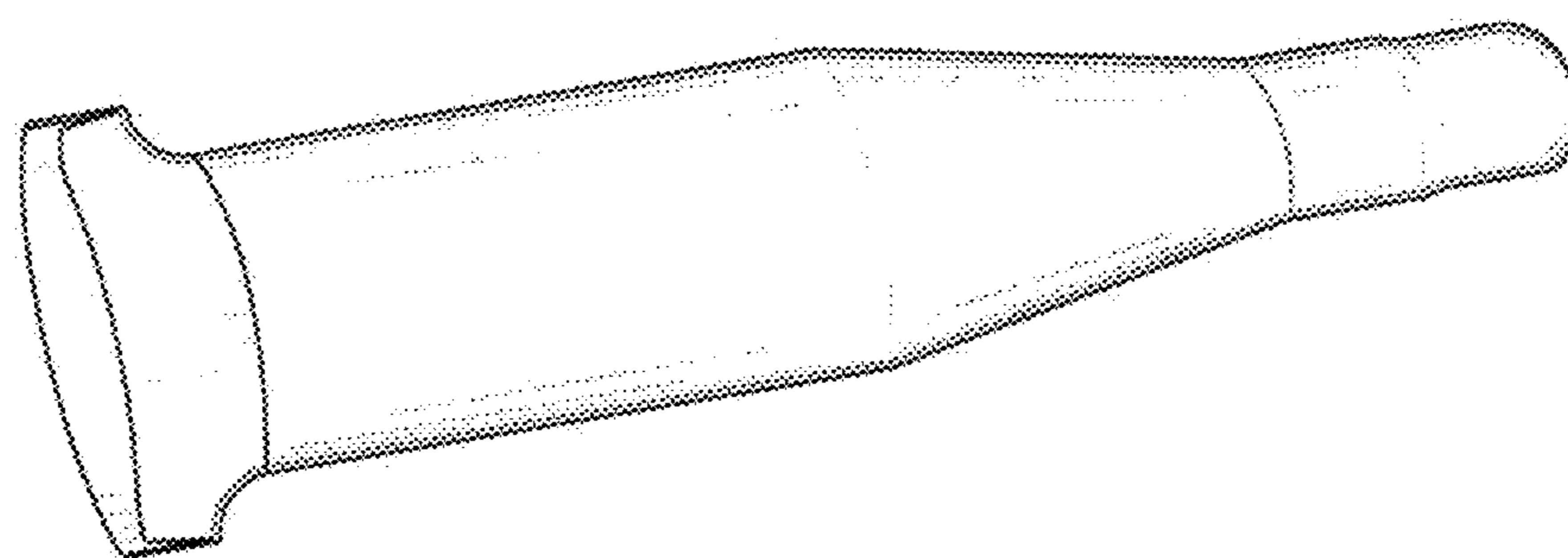

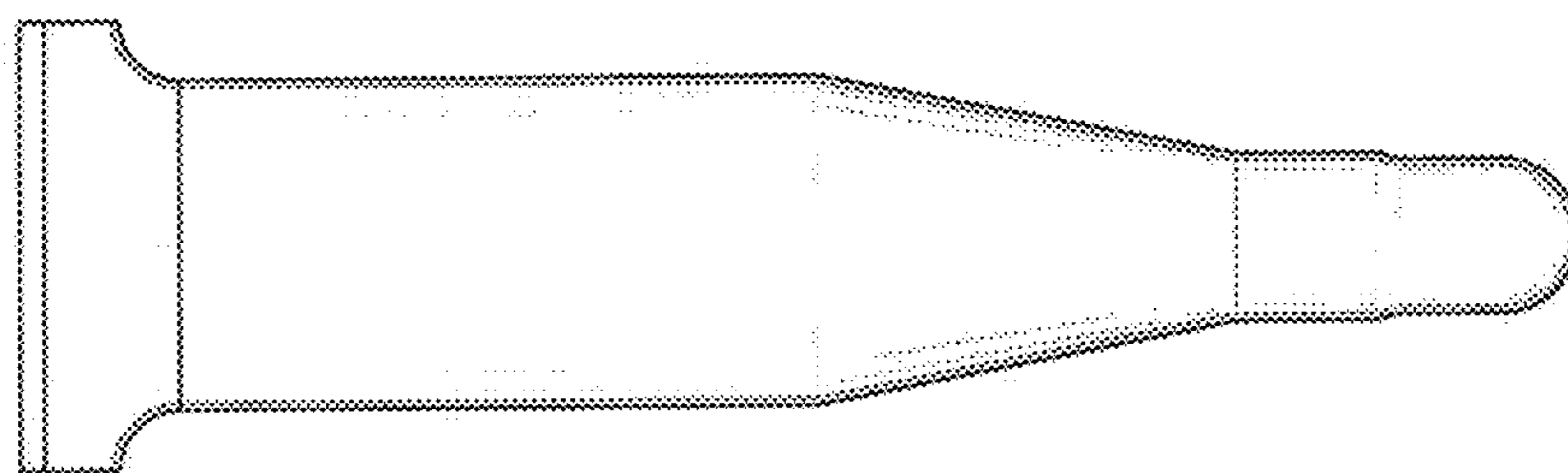

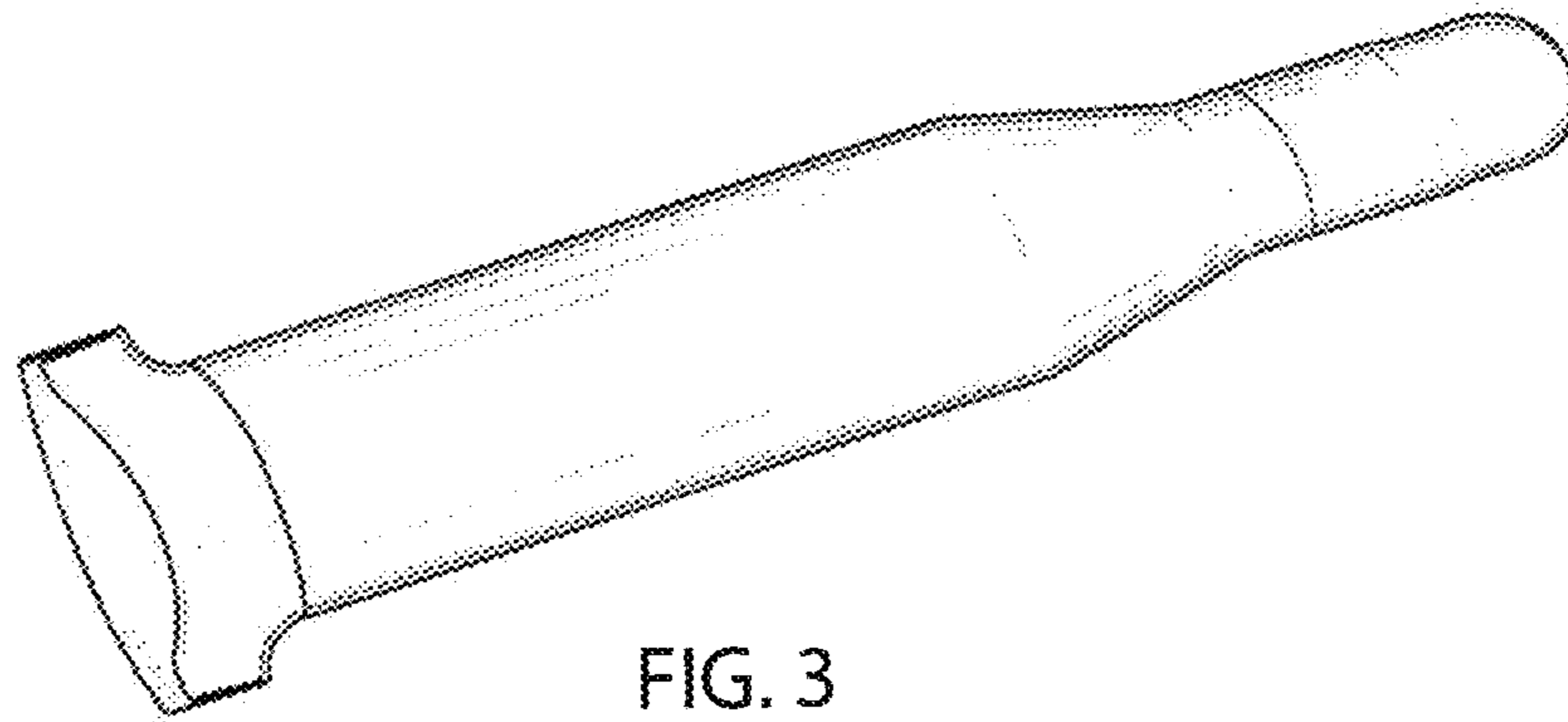

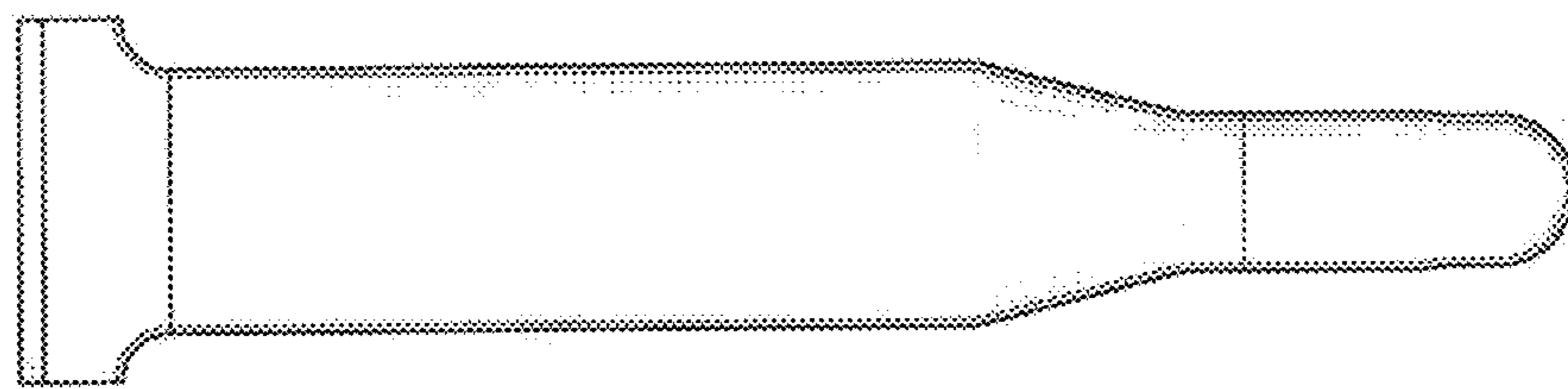
