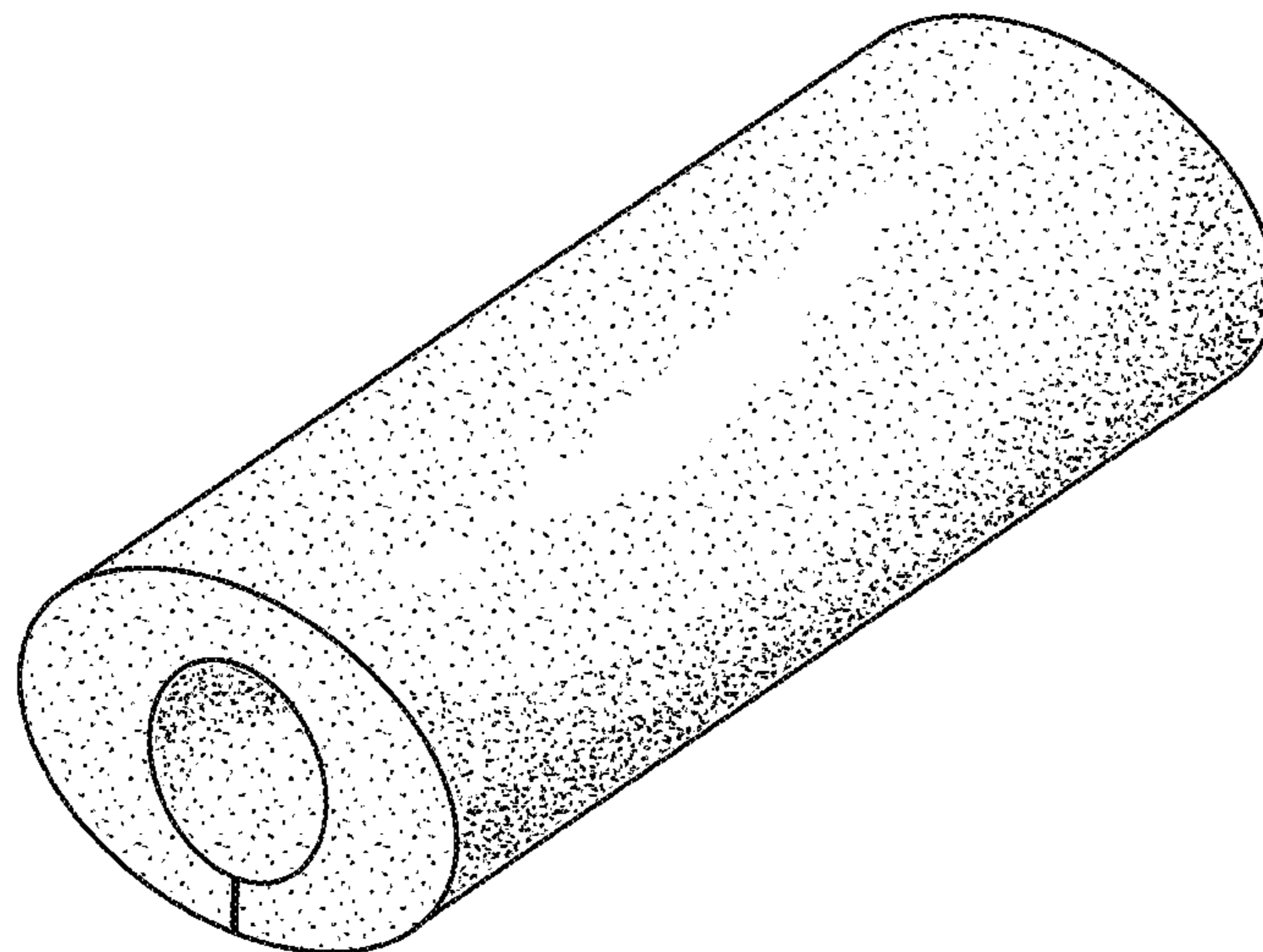
CLAIM

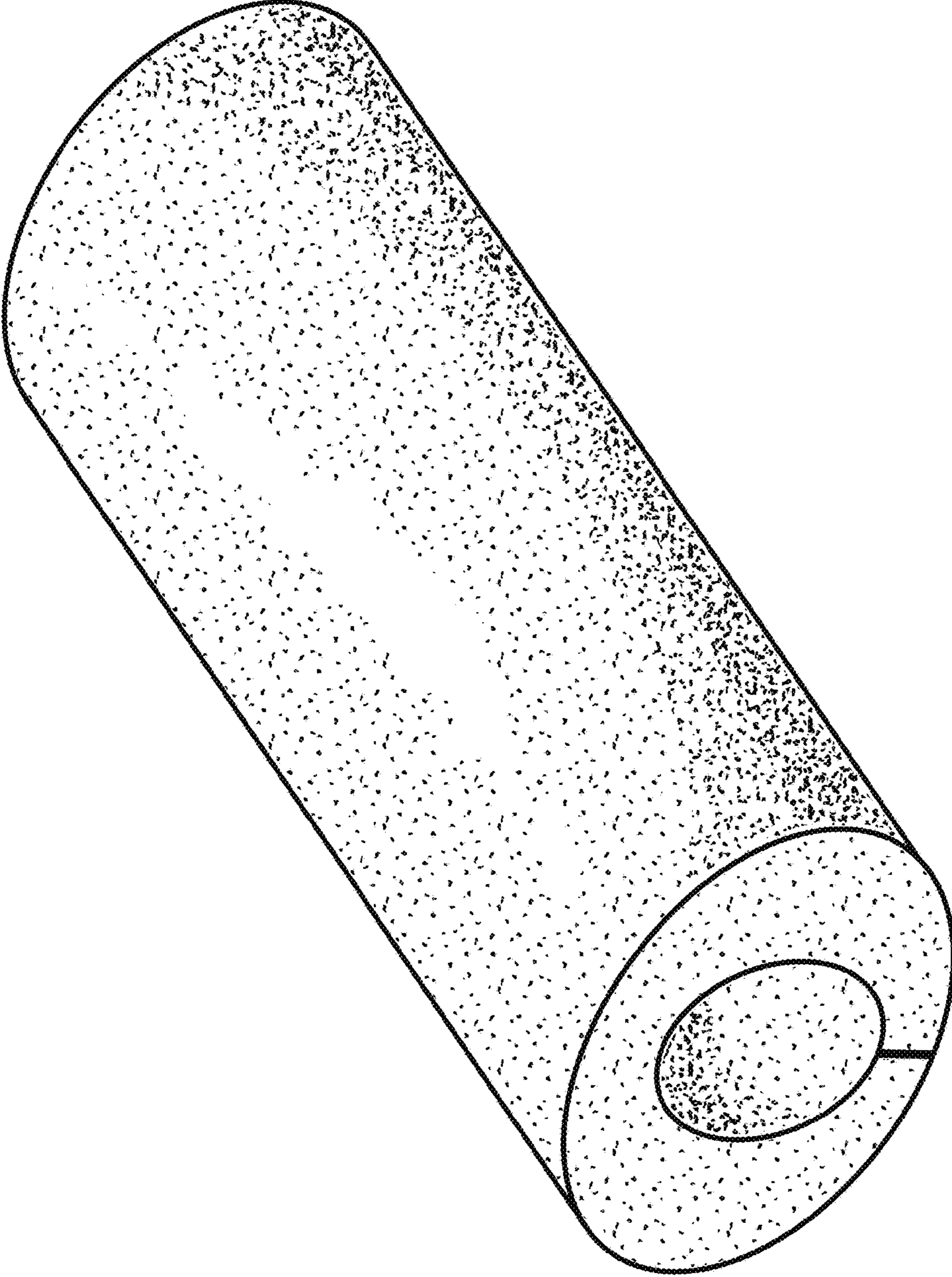

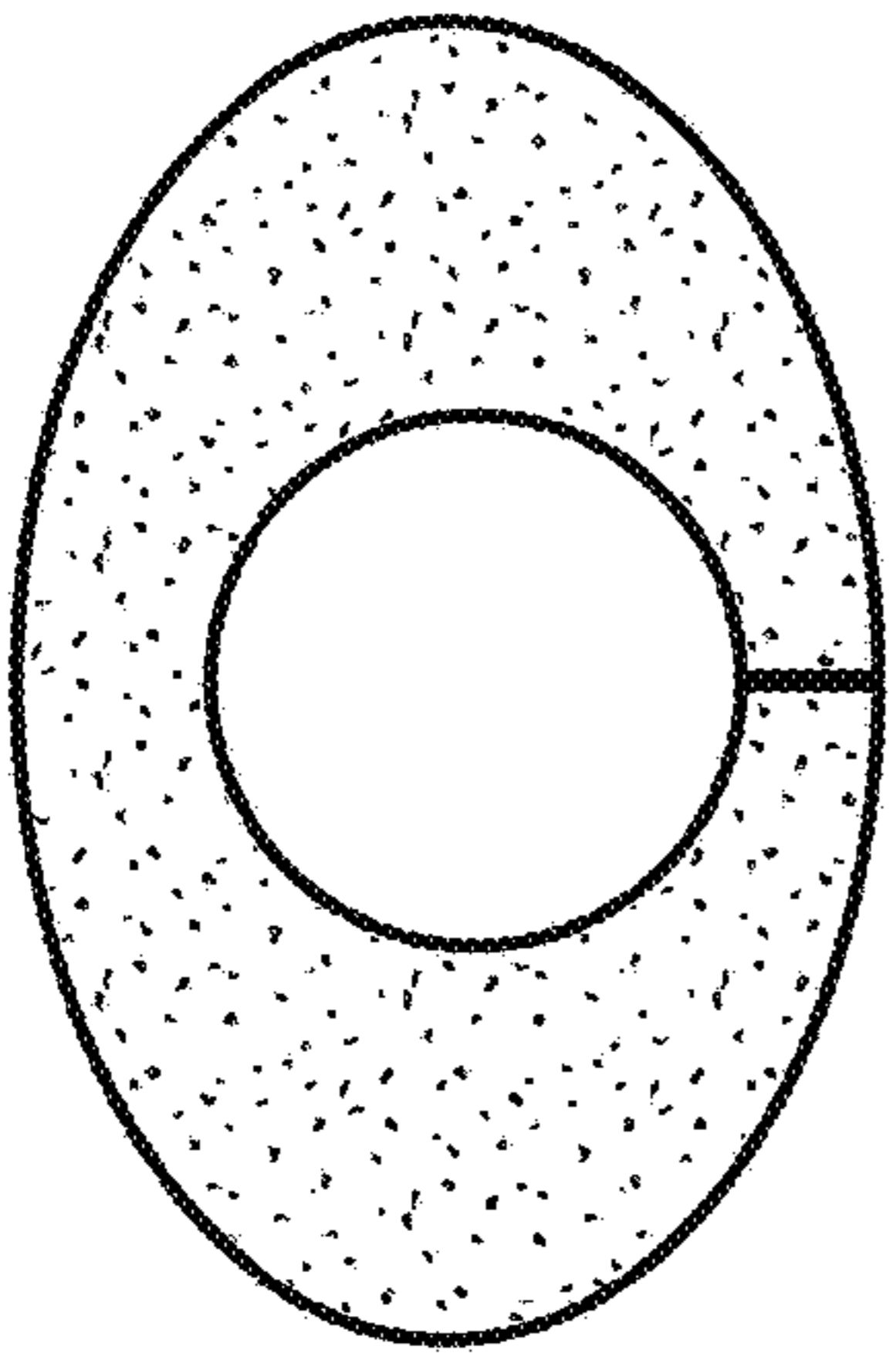

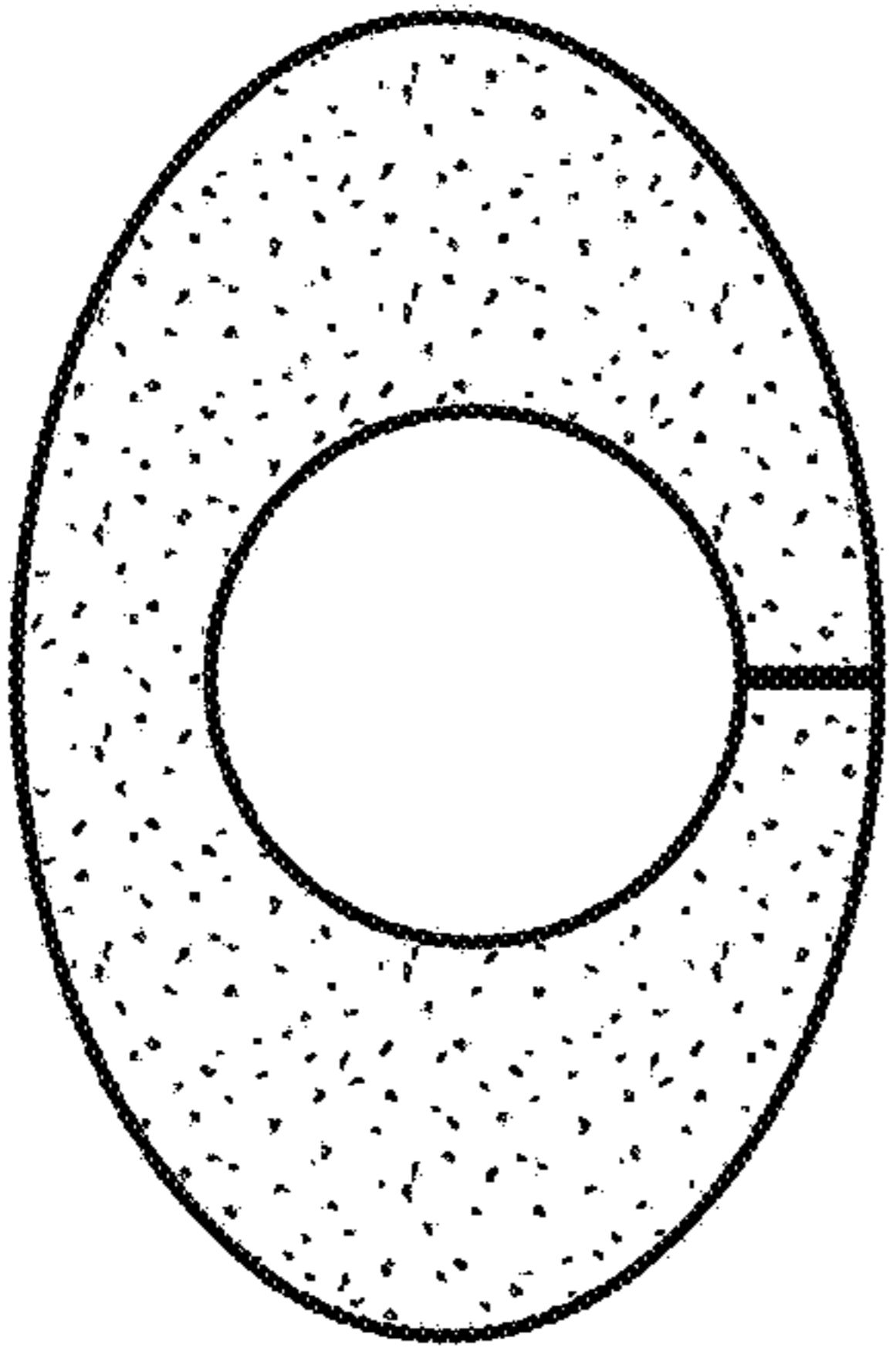

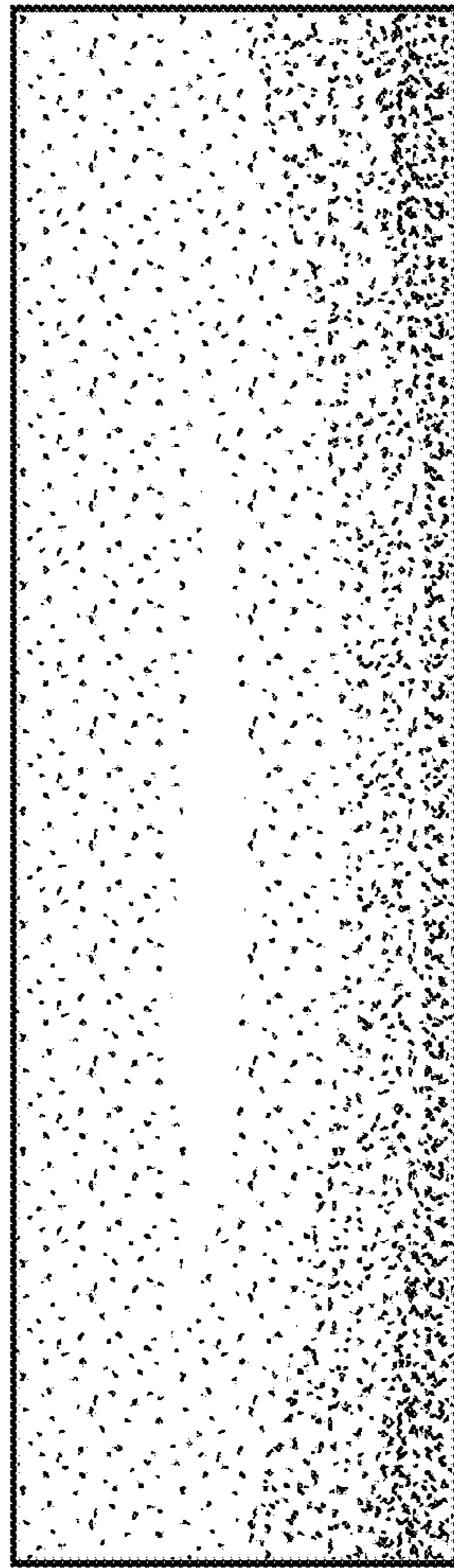

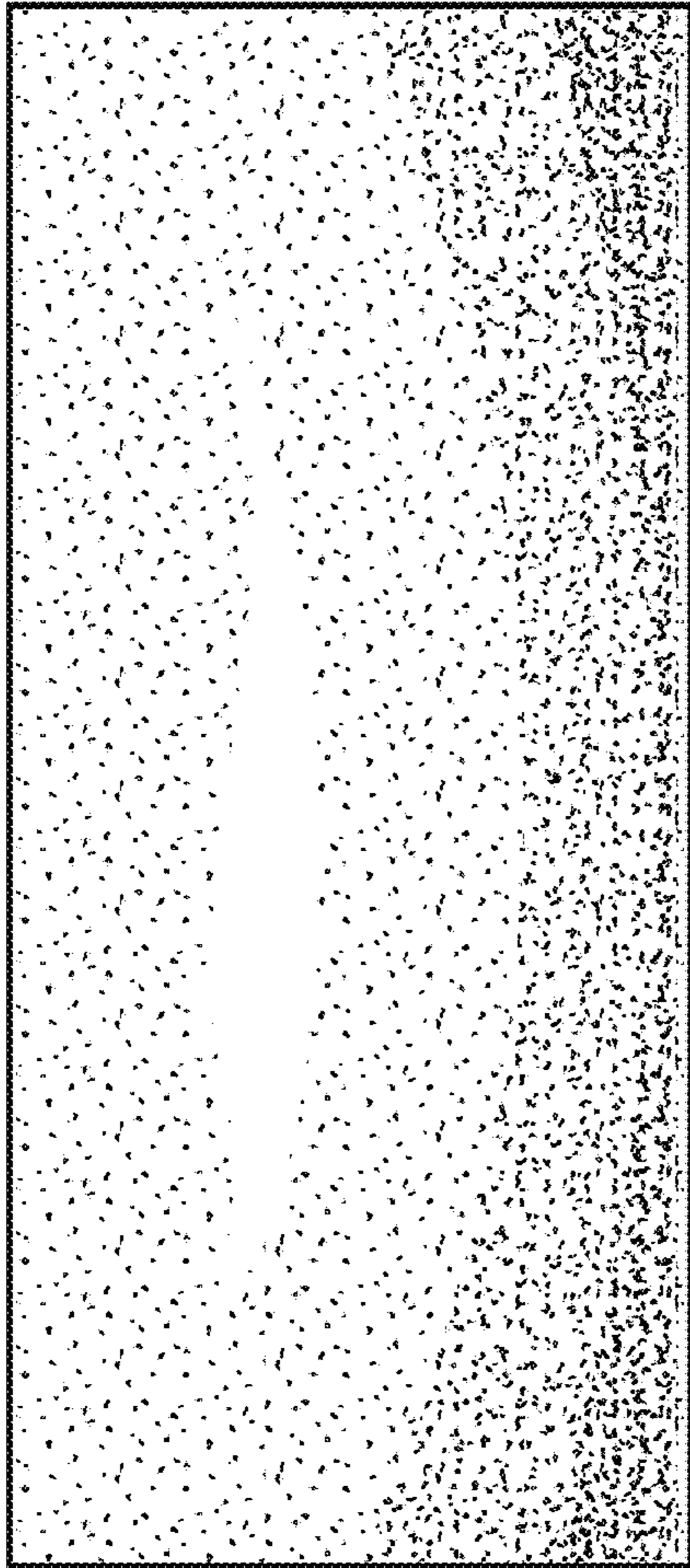

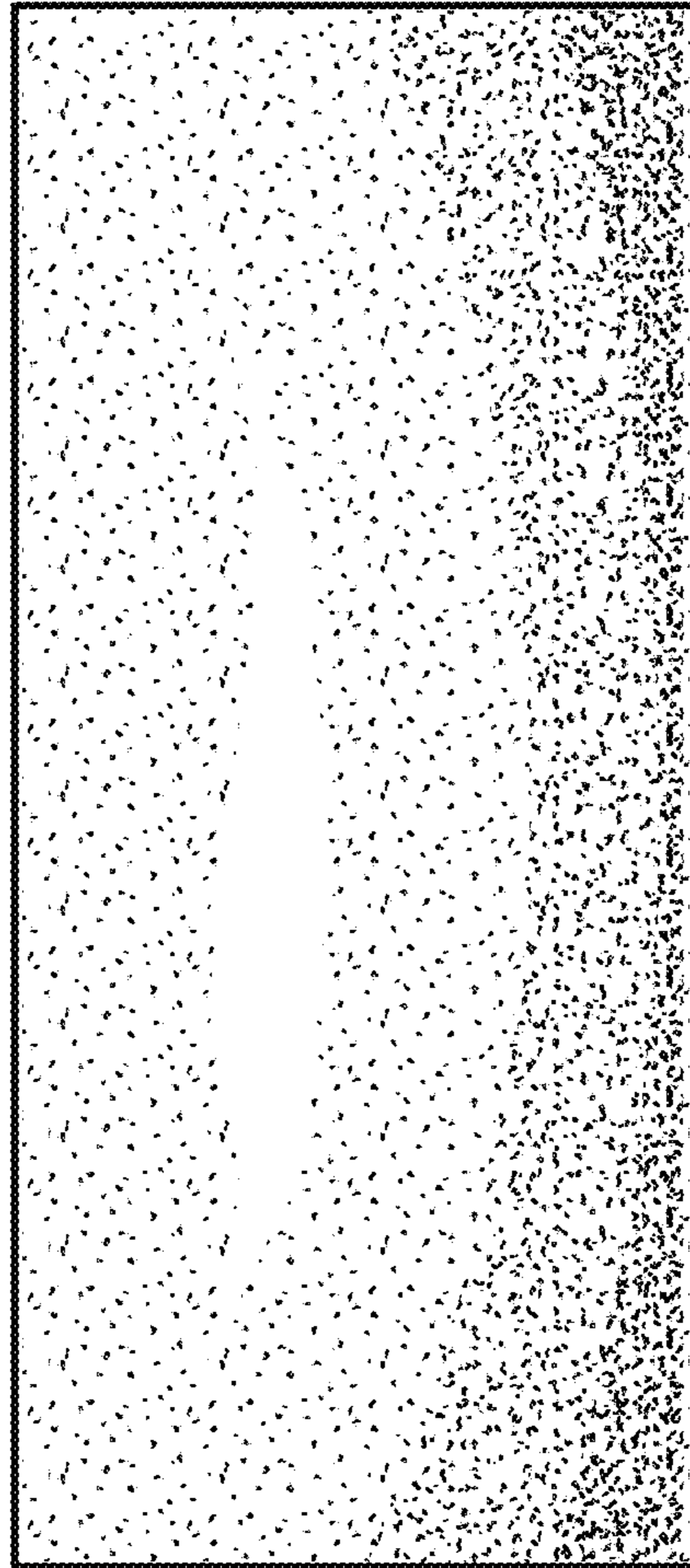
