DESCRIPTION

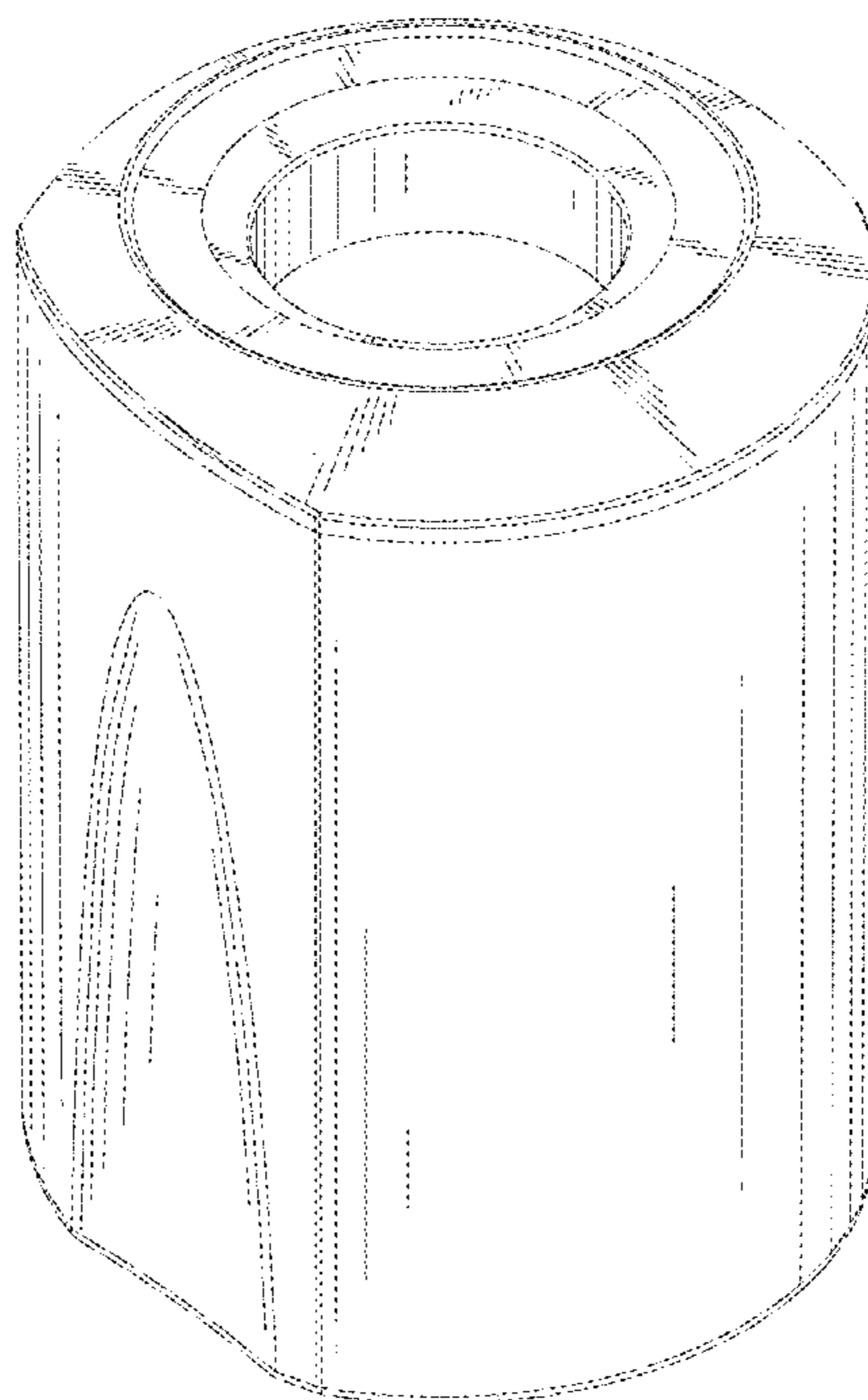
FIG. 1 is a front, right, and top perspective view of a light-magnetism harmonizer showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a cross-sectional view of the light-magnetism harmonizer, taken along line 8-8 in FIG. 6. thereof; and, FIG. 9 is a left, front, and bottom perspective view. The broken lines in the drawings illustrate portions of the light-magnetism harmonizer which form no part of the claimed design.

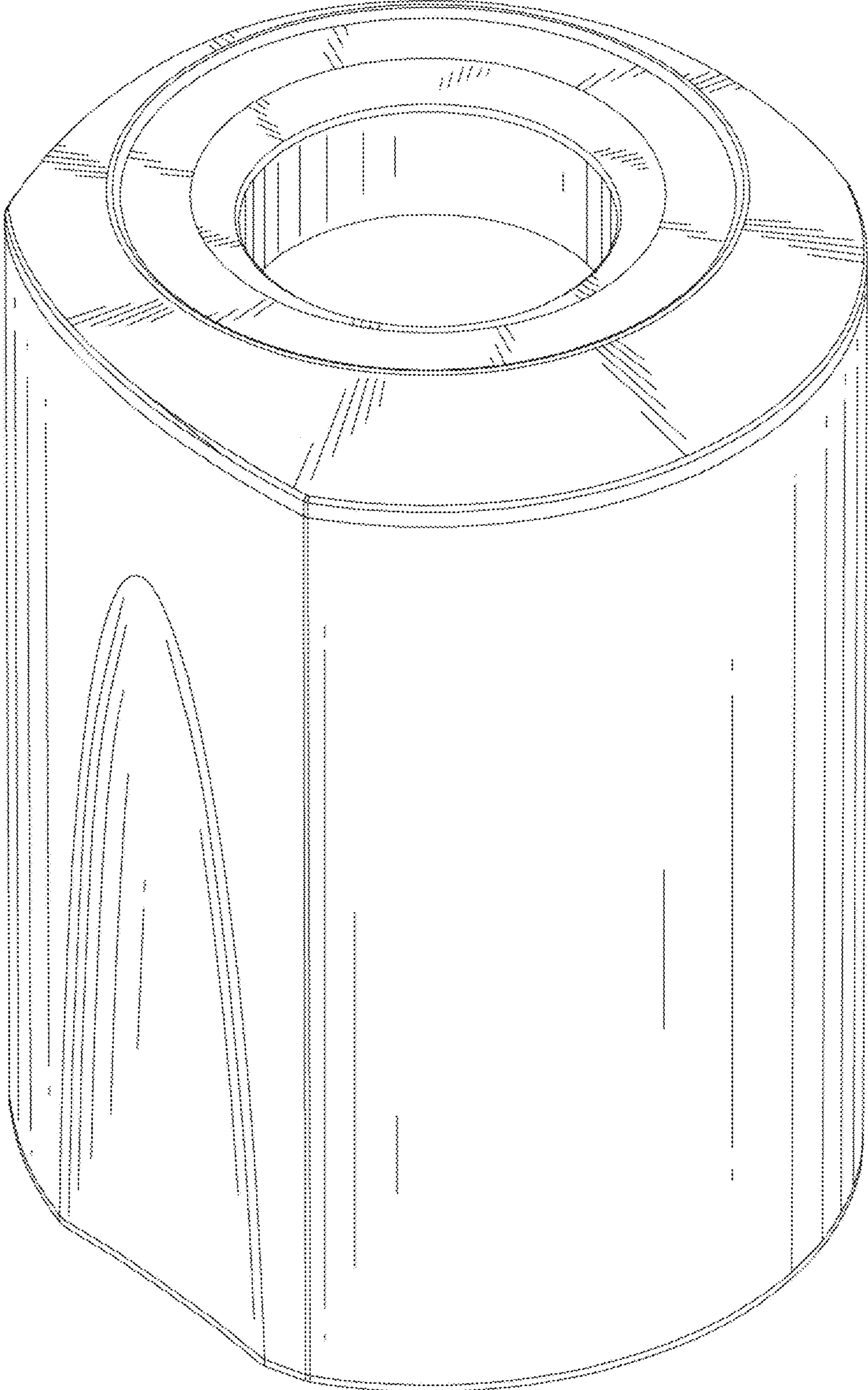

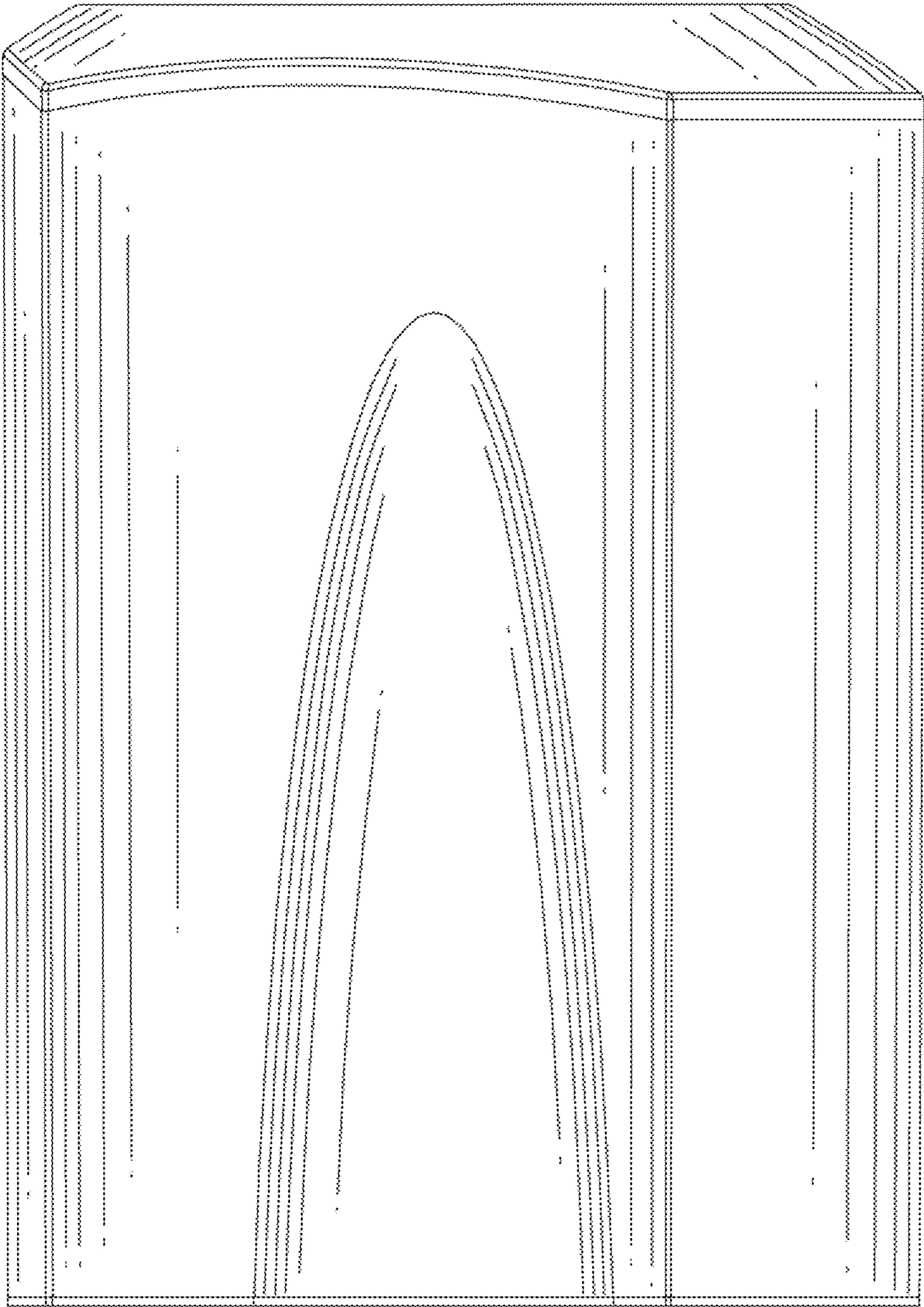

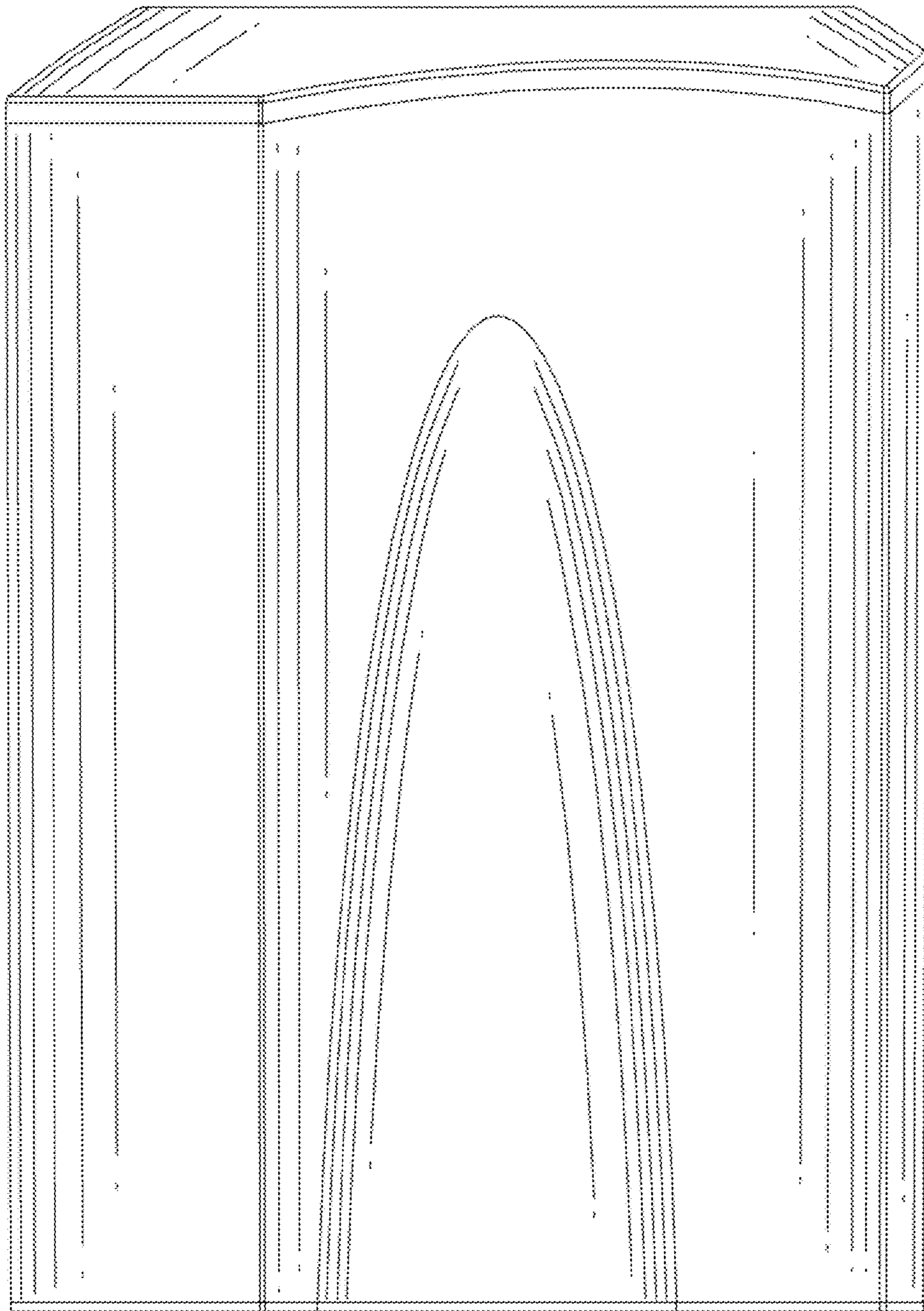

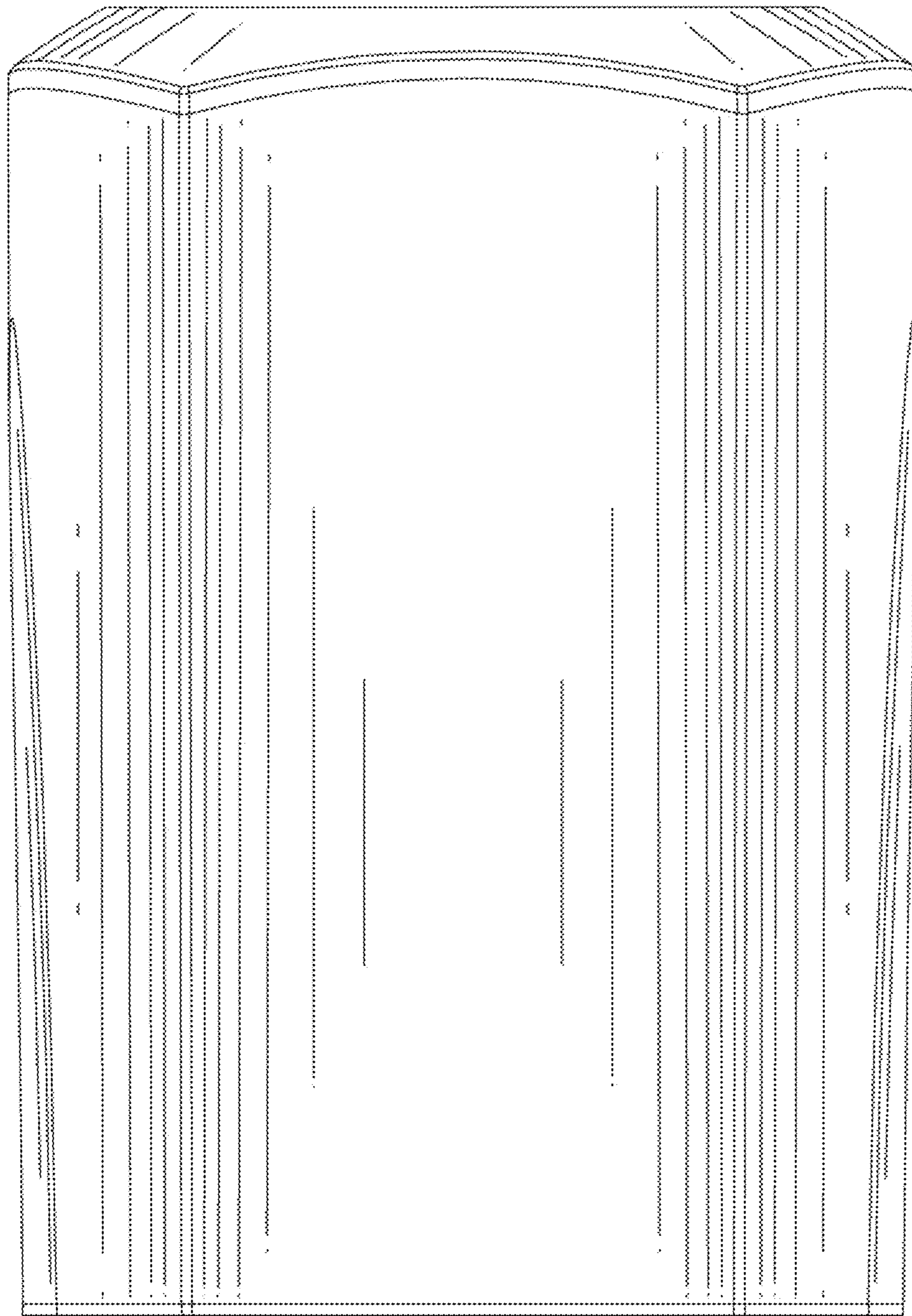

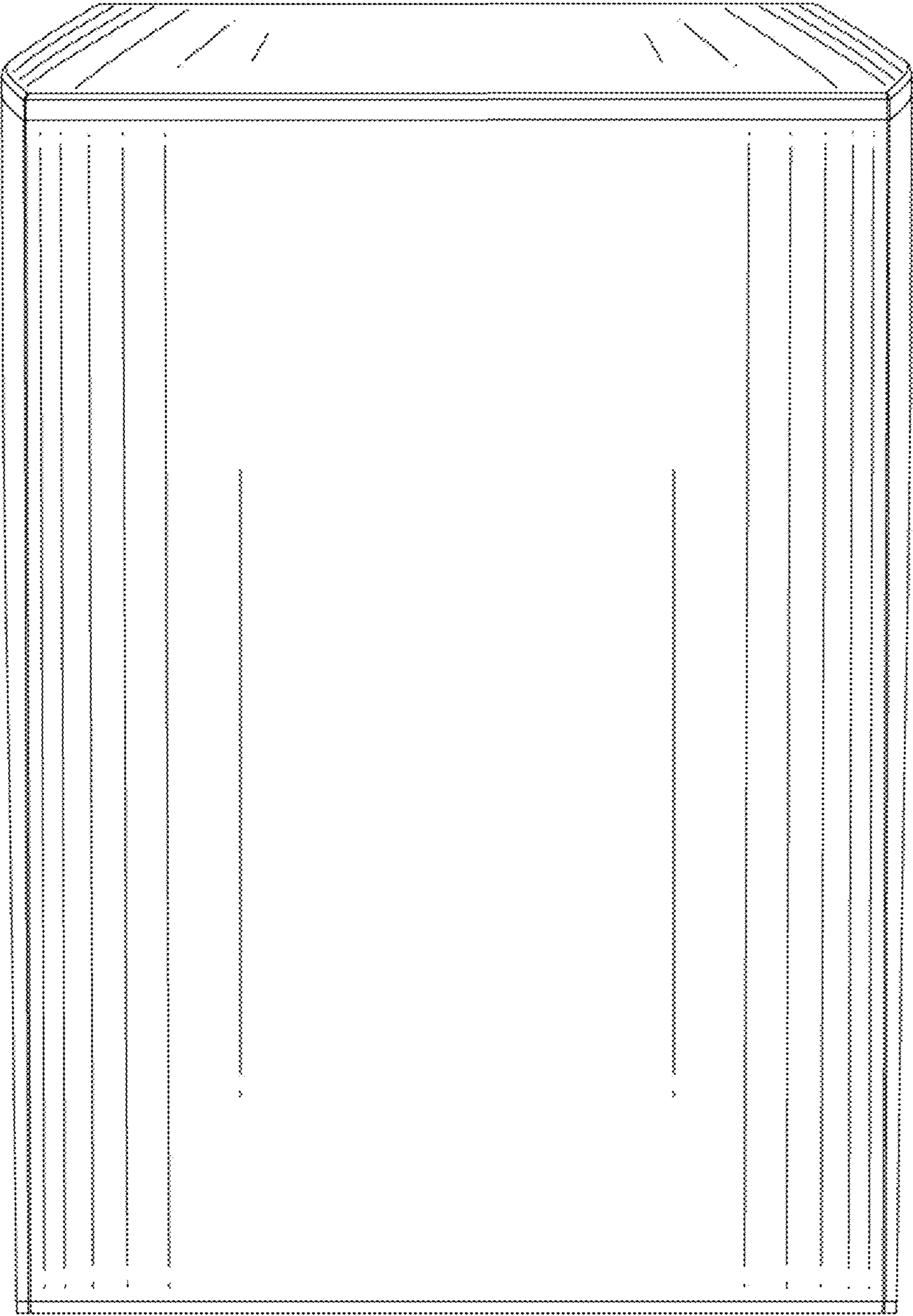

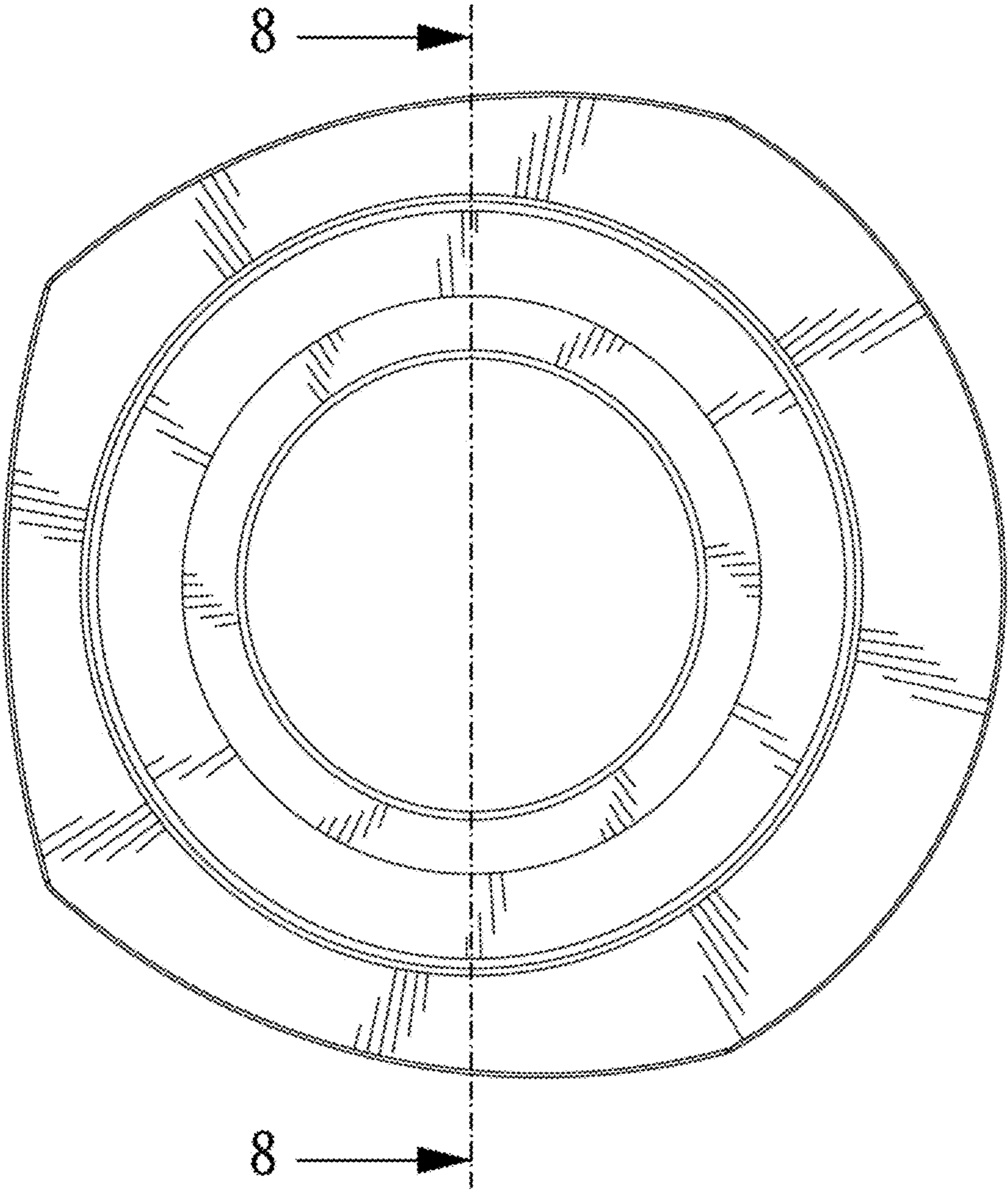

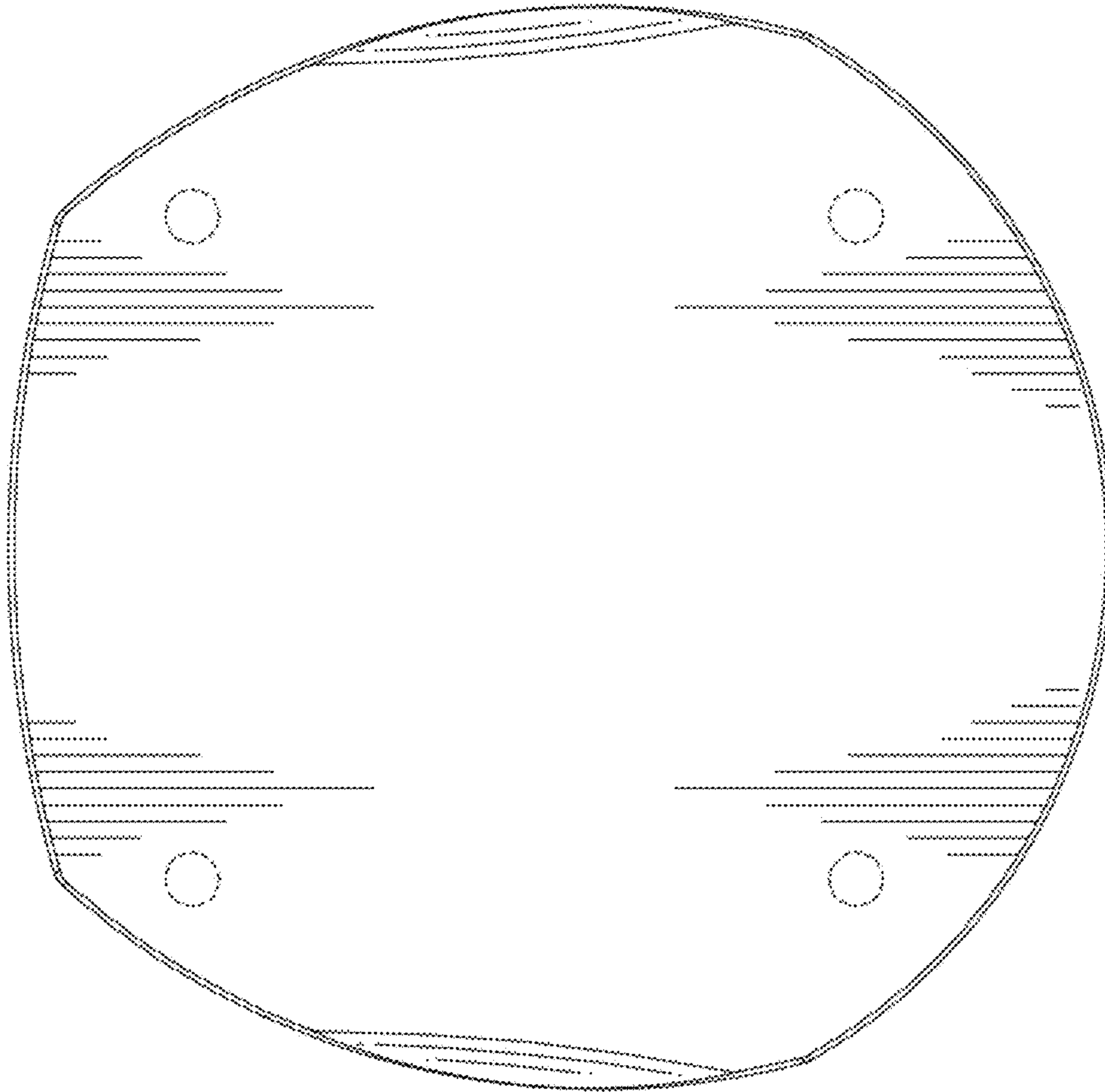

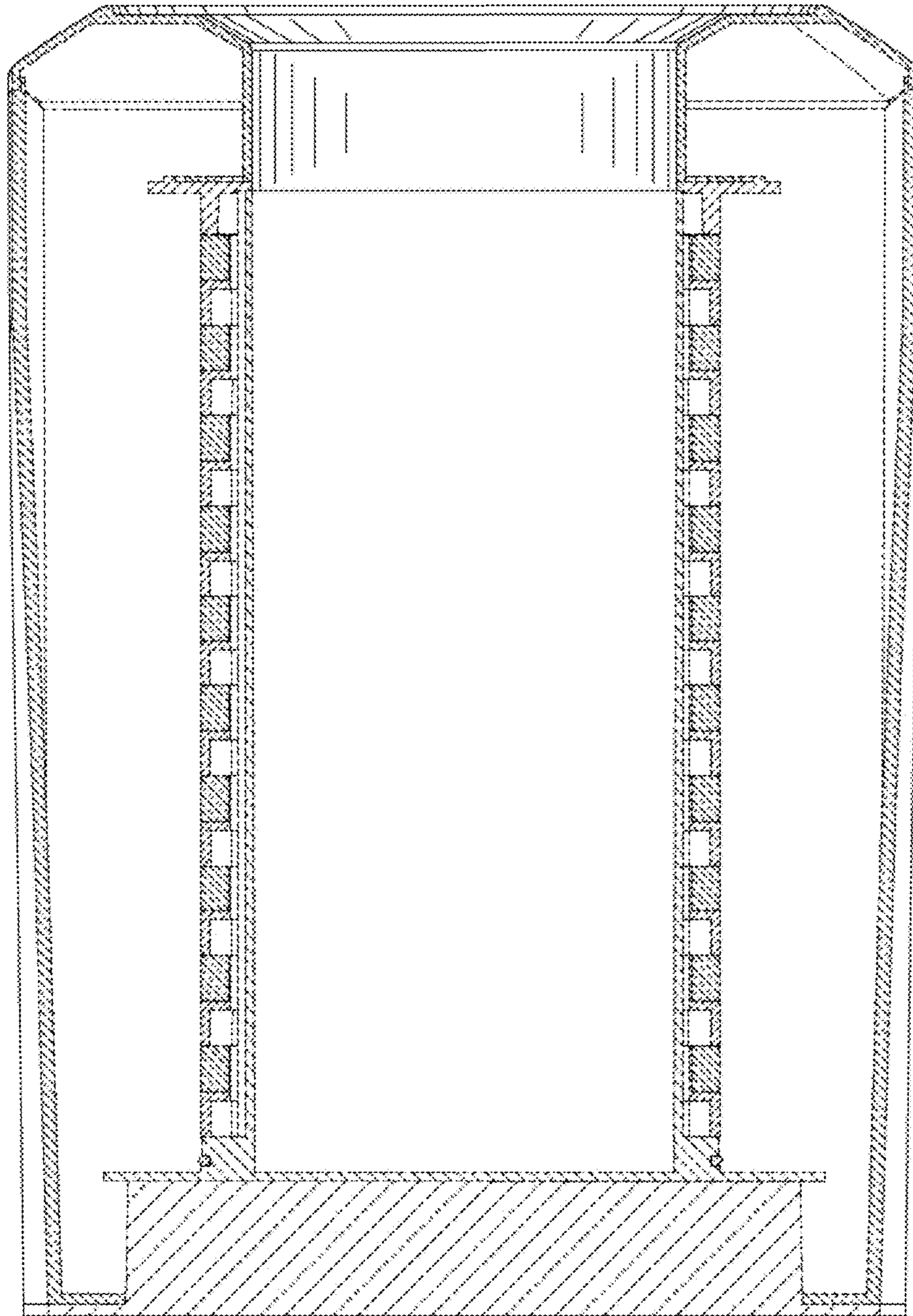

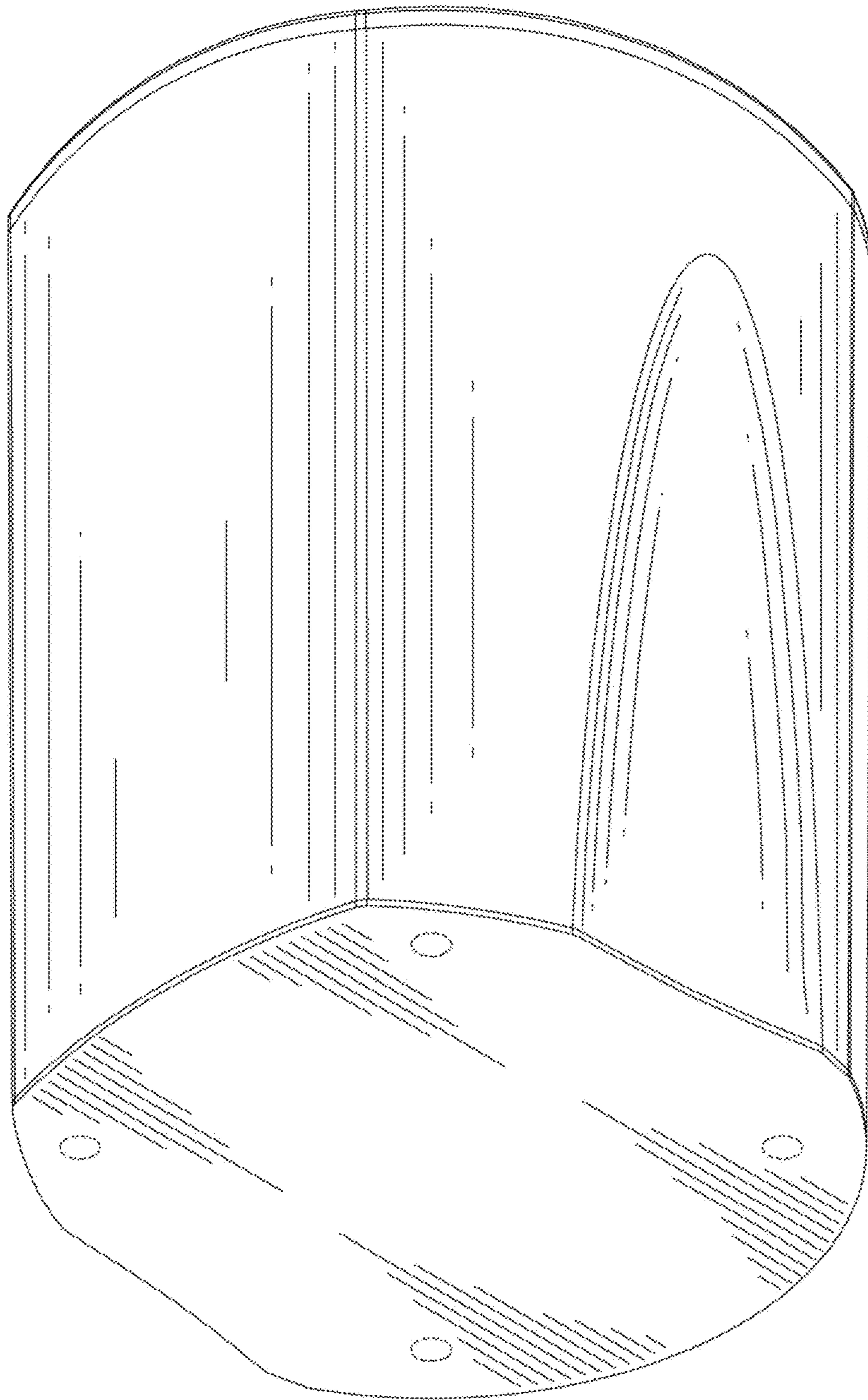
