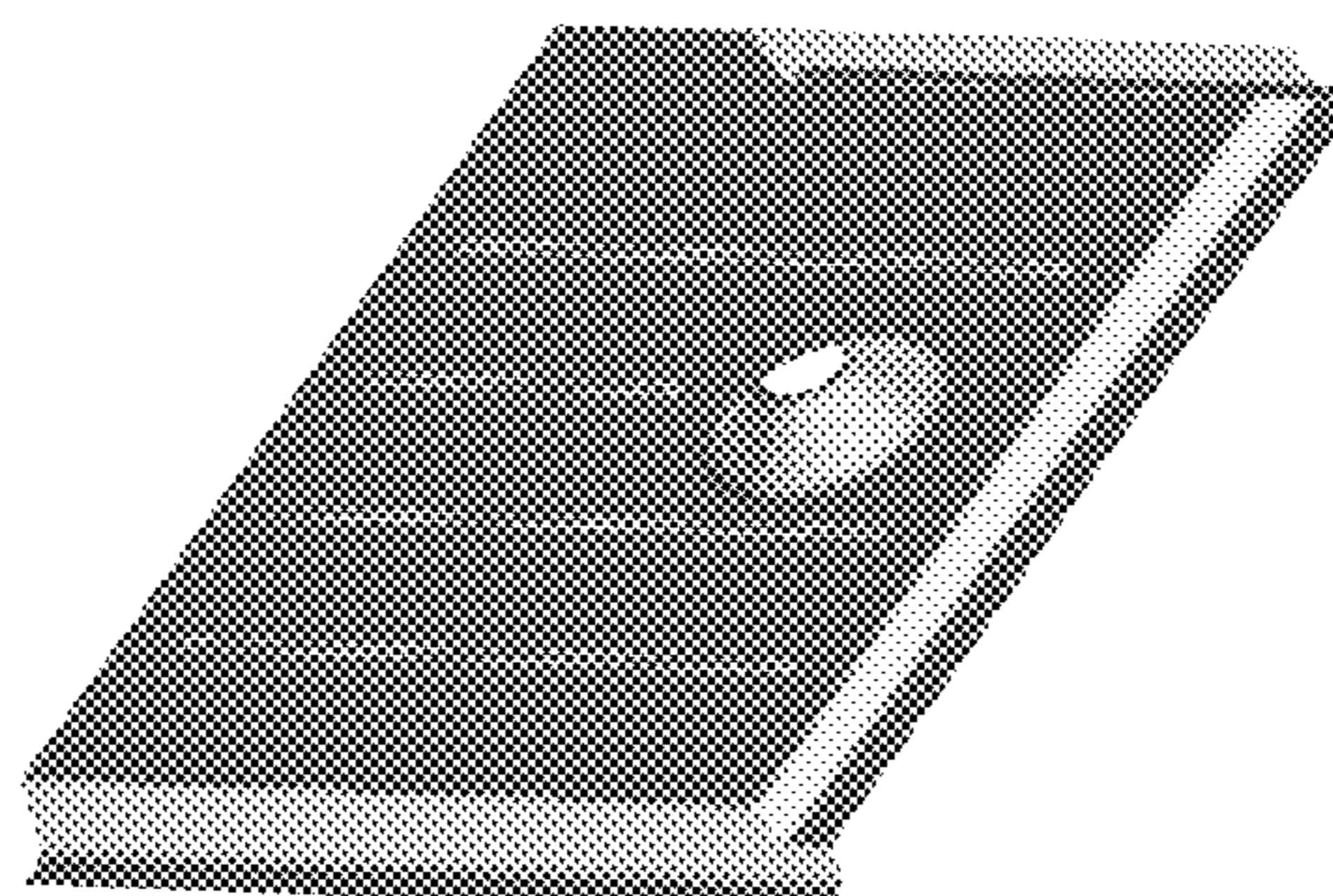
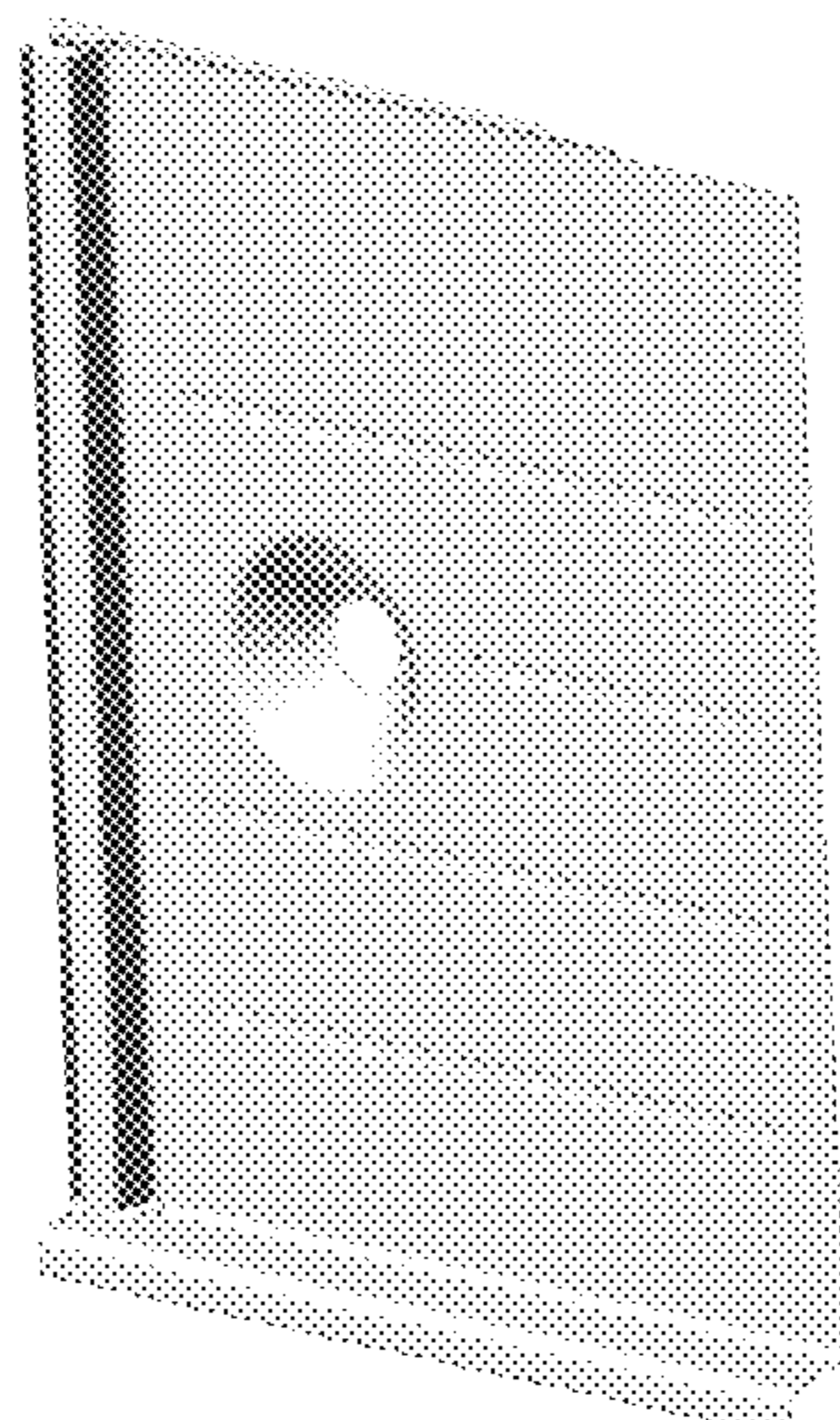
(57) **CLAIM**

I claim the ornamental design for a flat replacement tile, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a flat replacement tile, showing my new design;

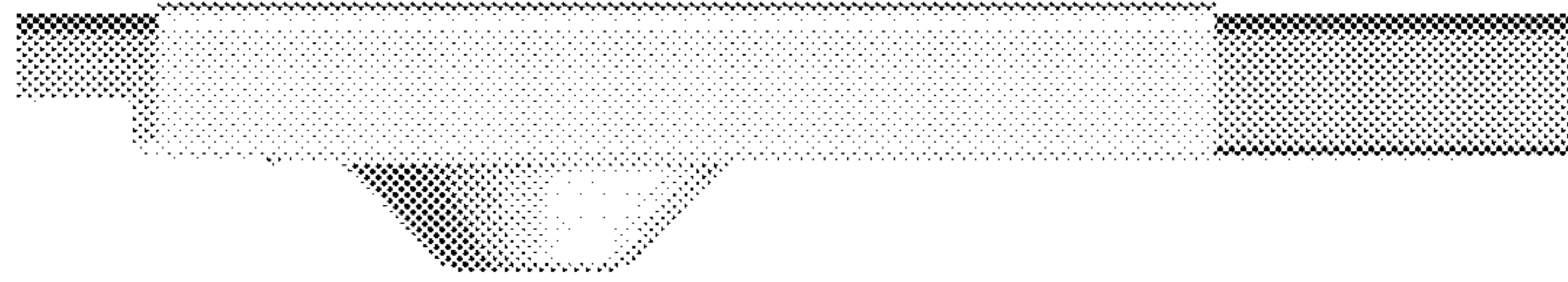

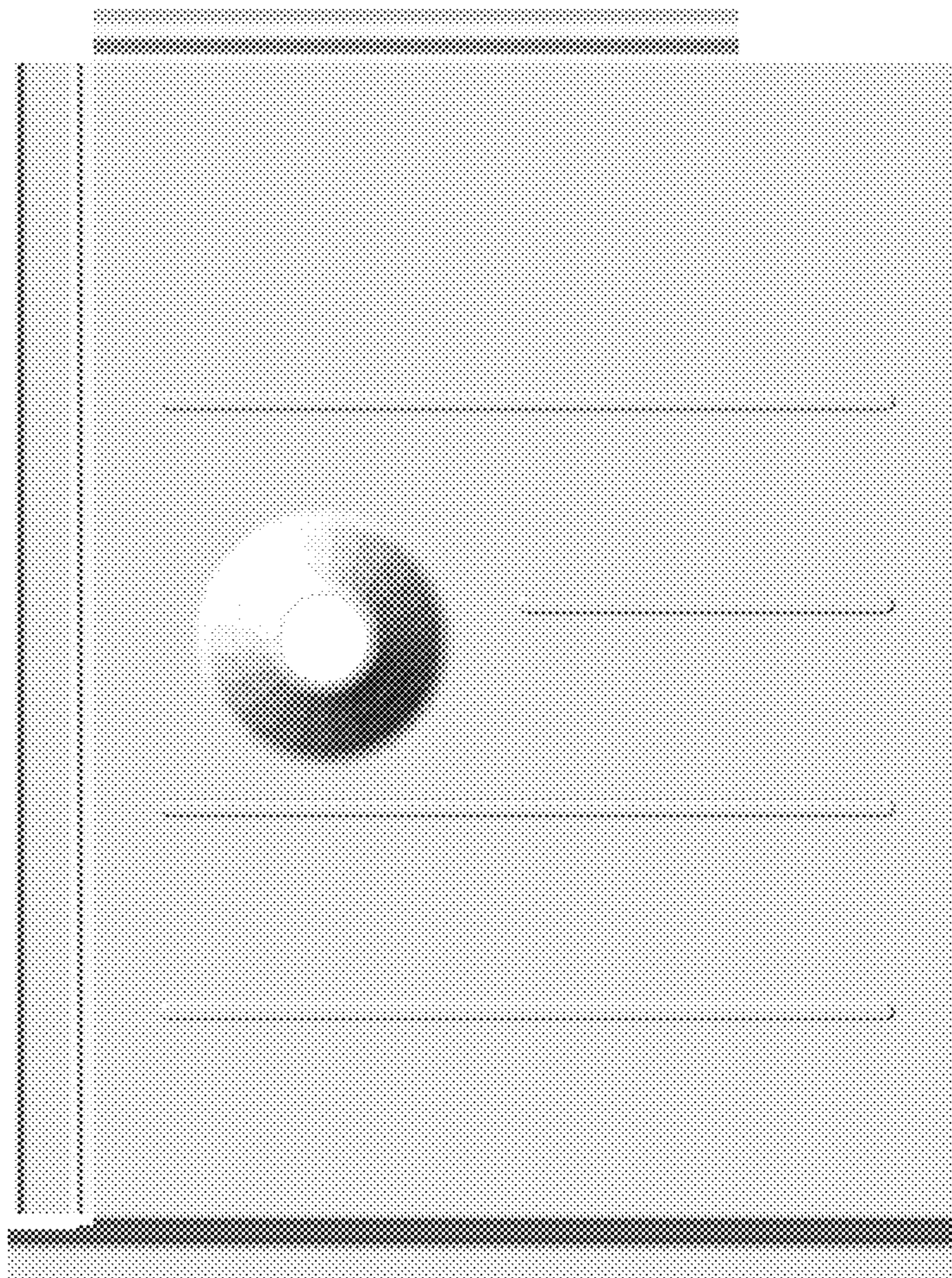

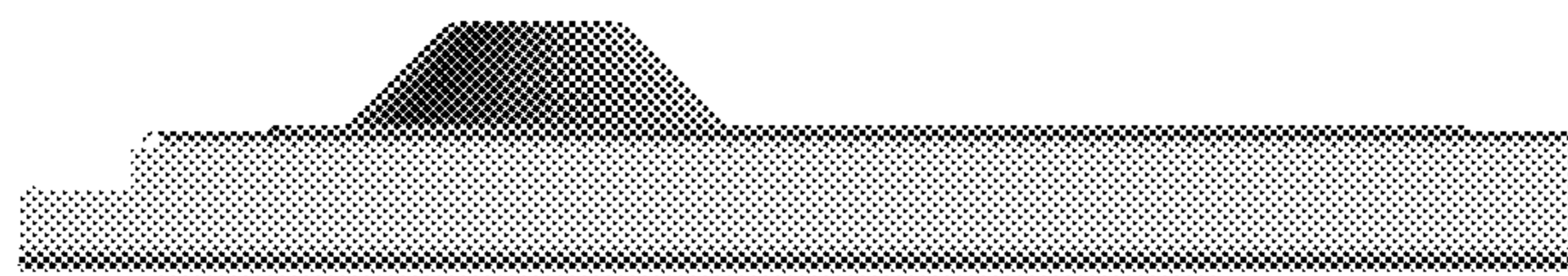

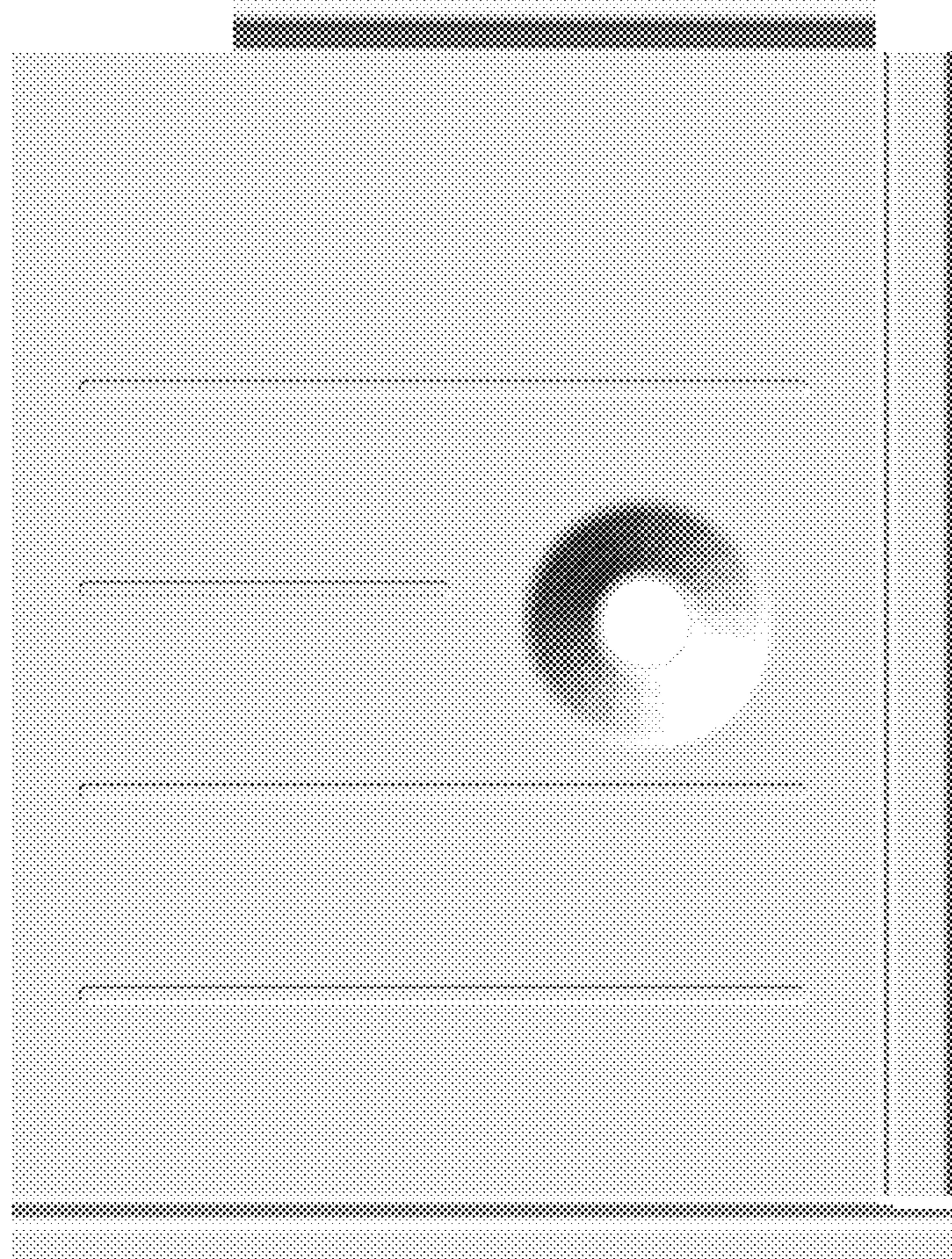

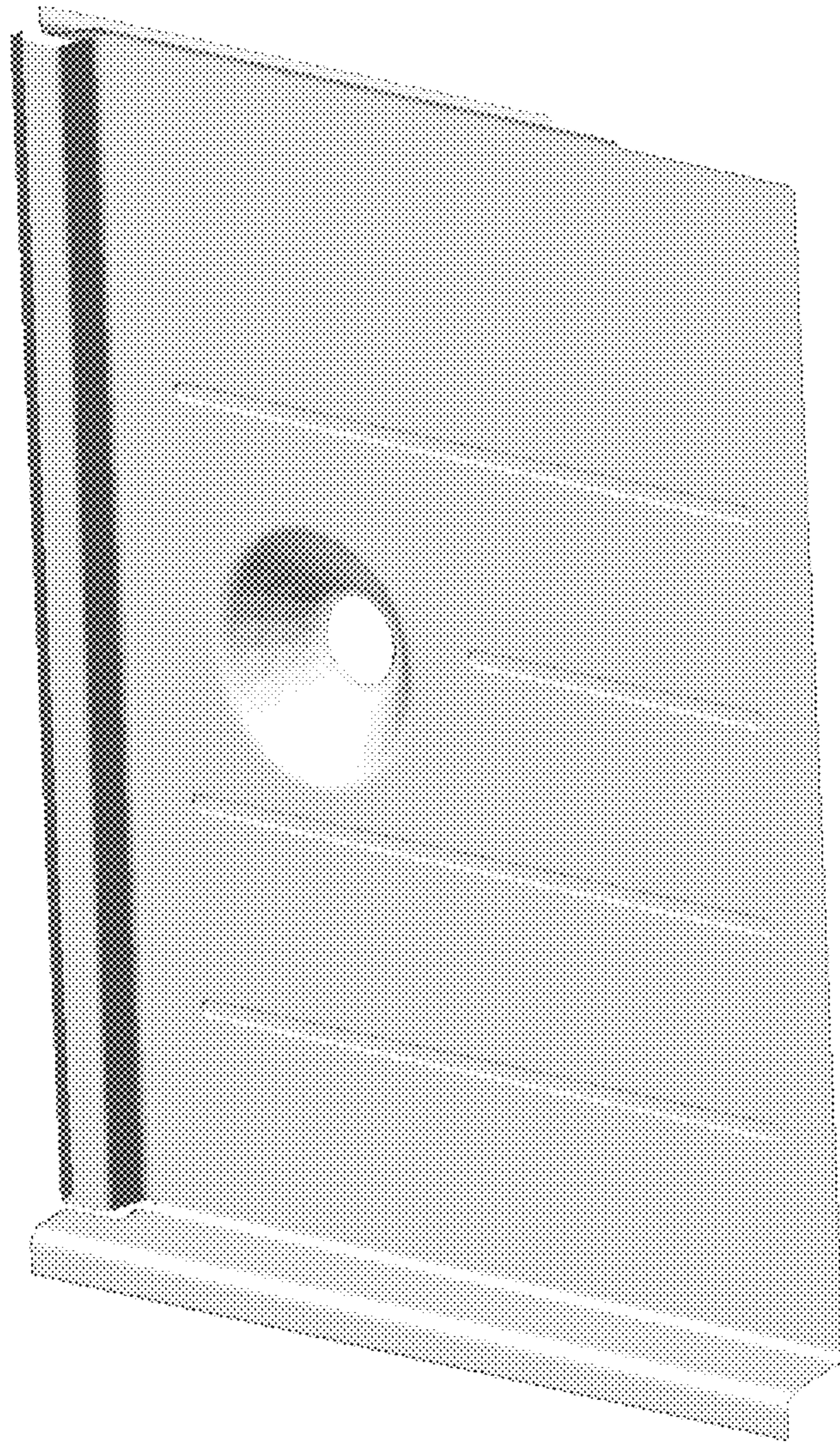

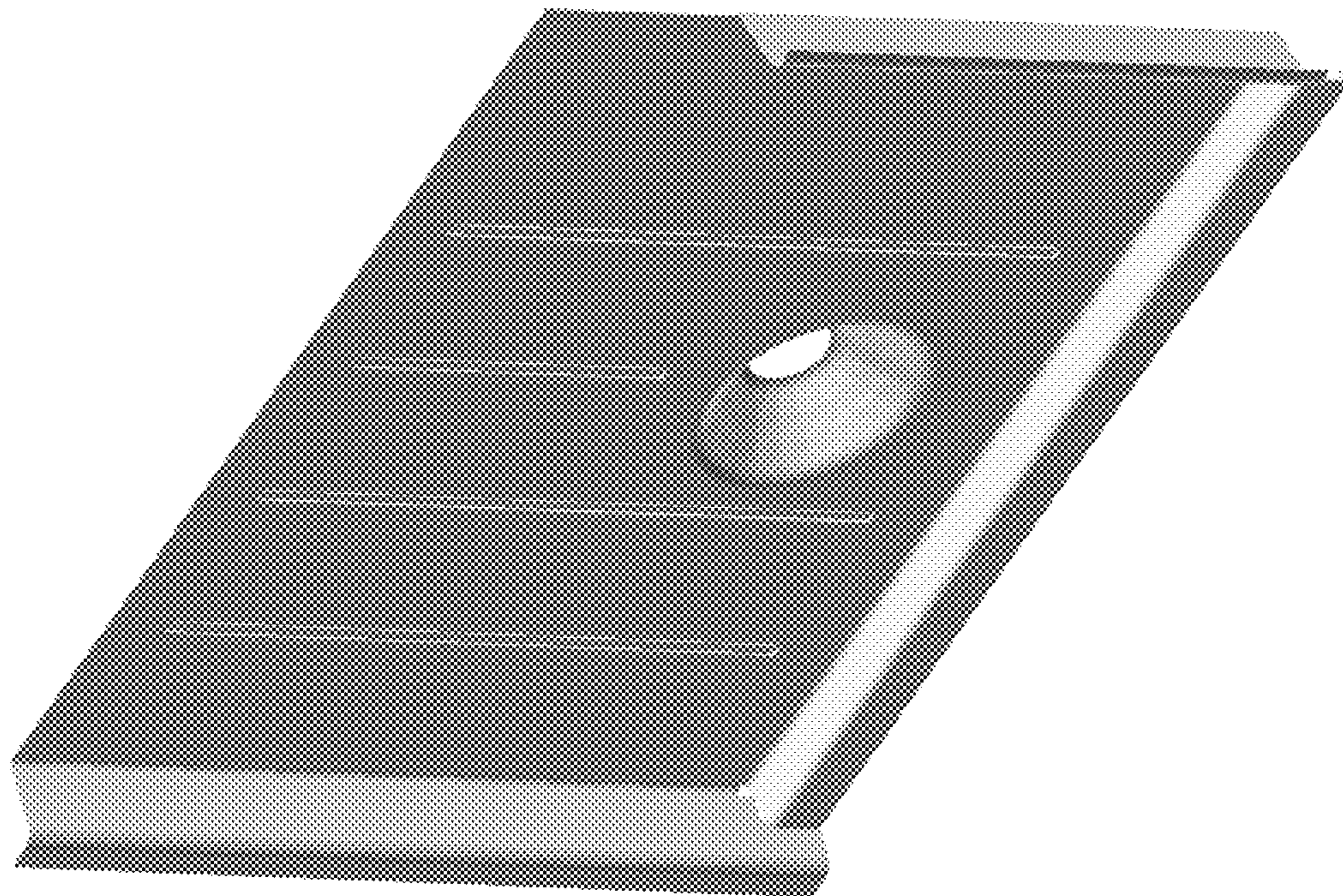

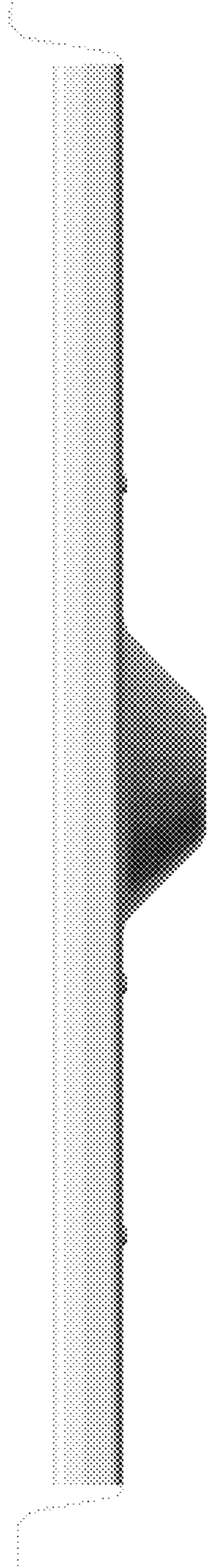

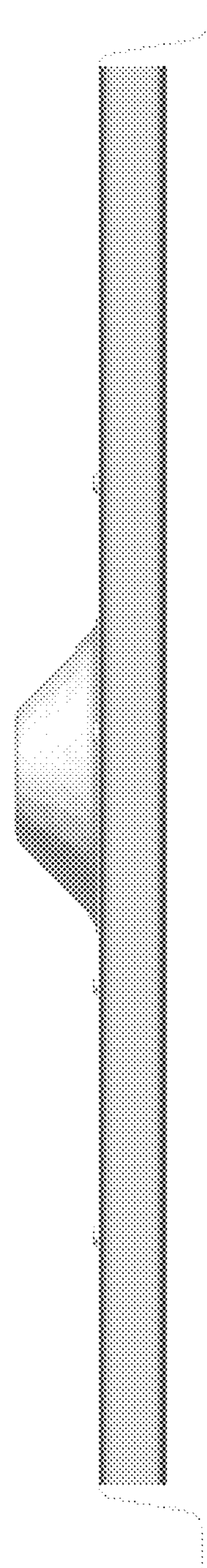
