The ornamental design for a discharging plate for compact container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the discharging plate for compact container showing my new design;  
FIG. 2 is a front view thereof;

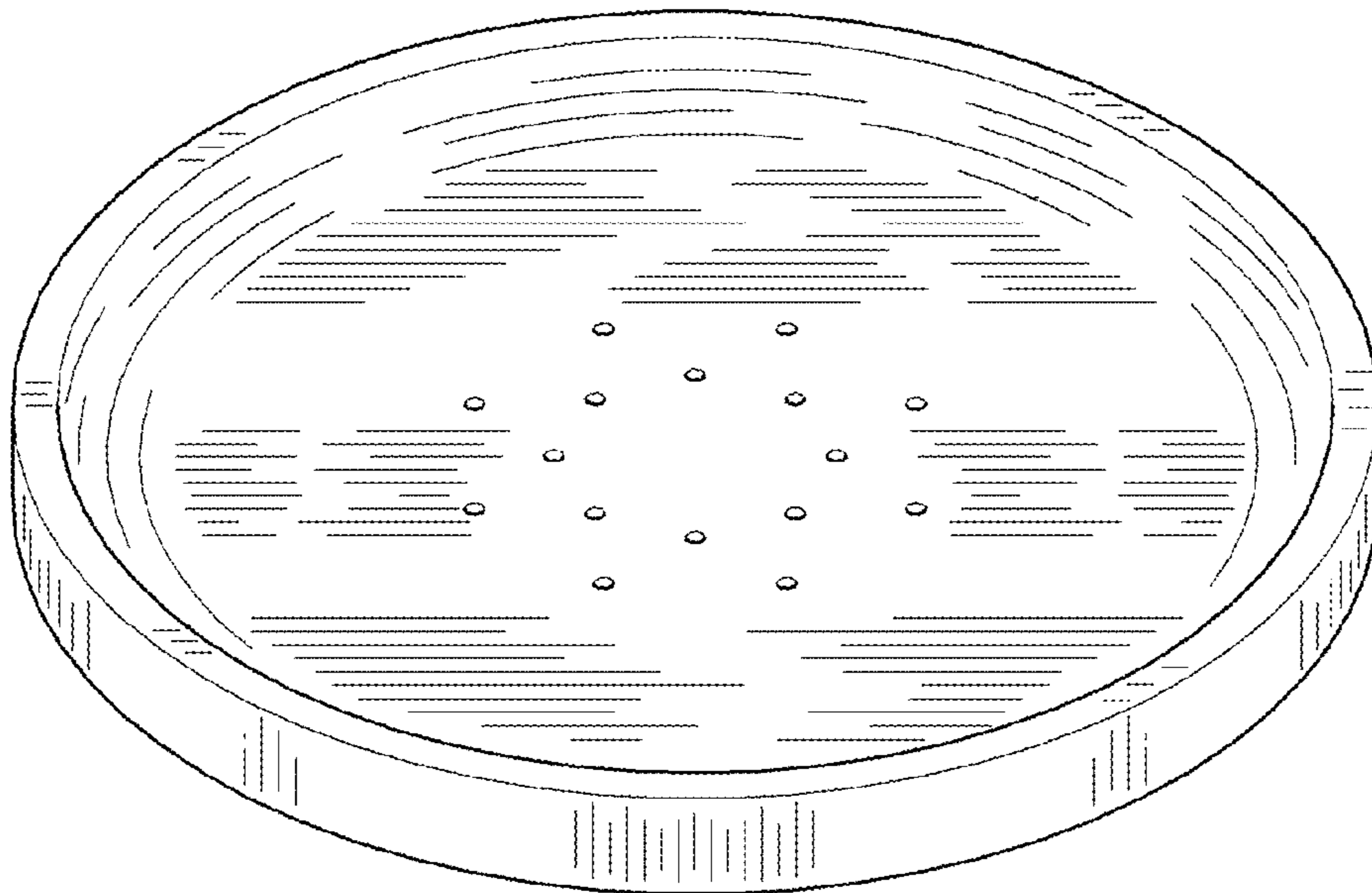

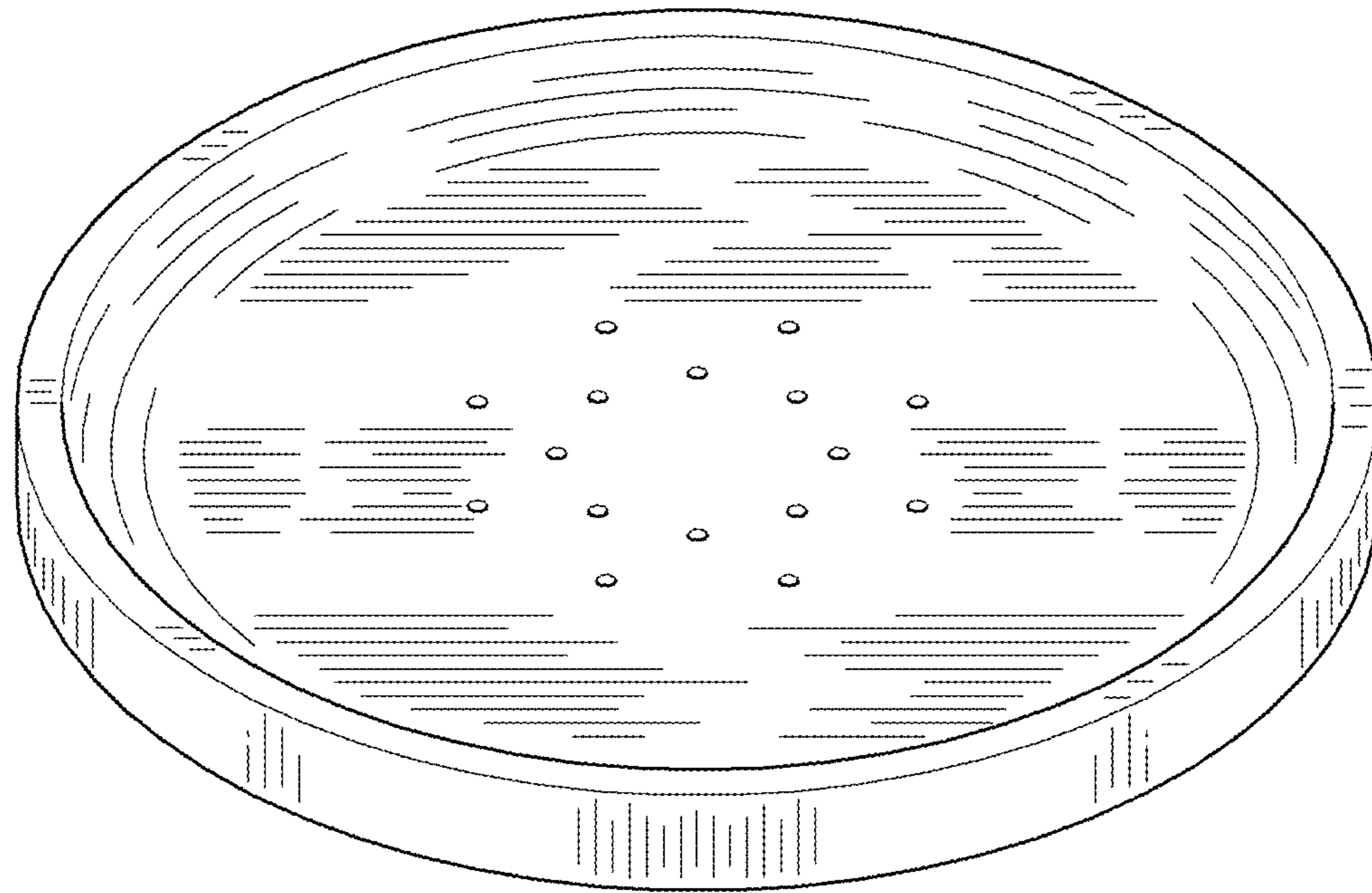

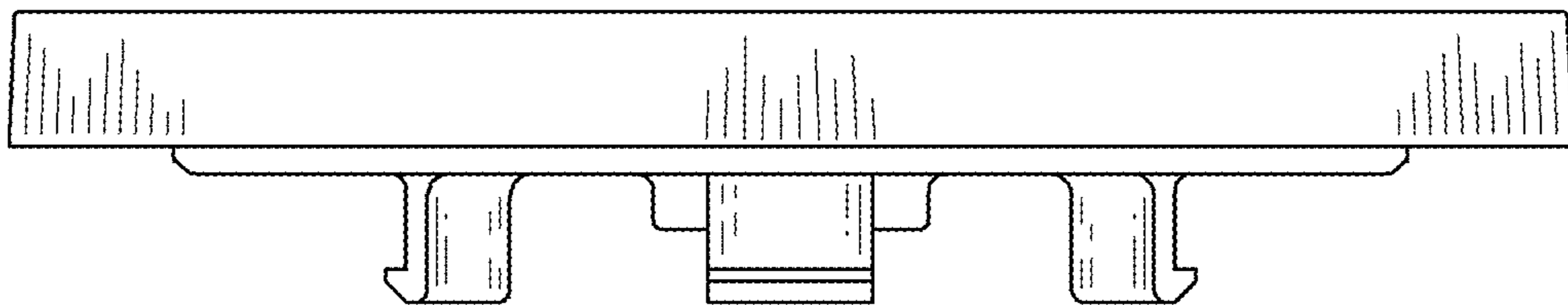

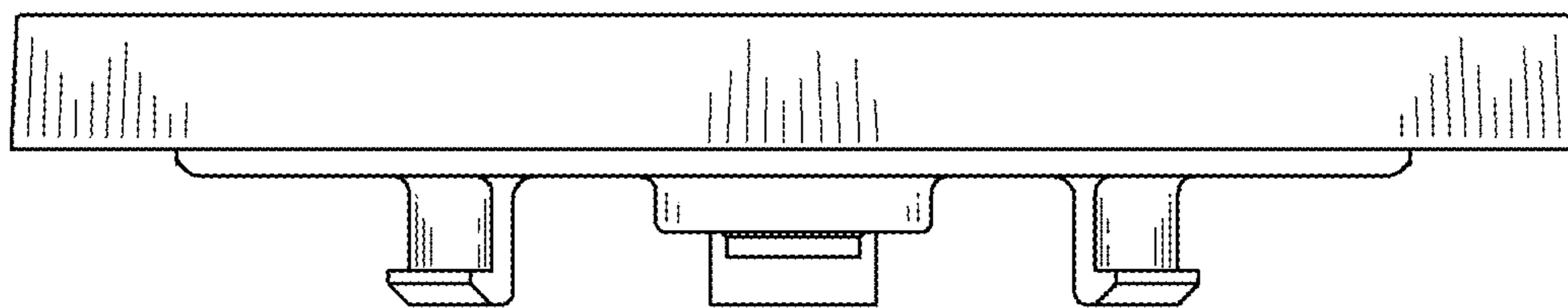

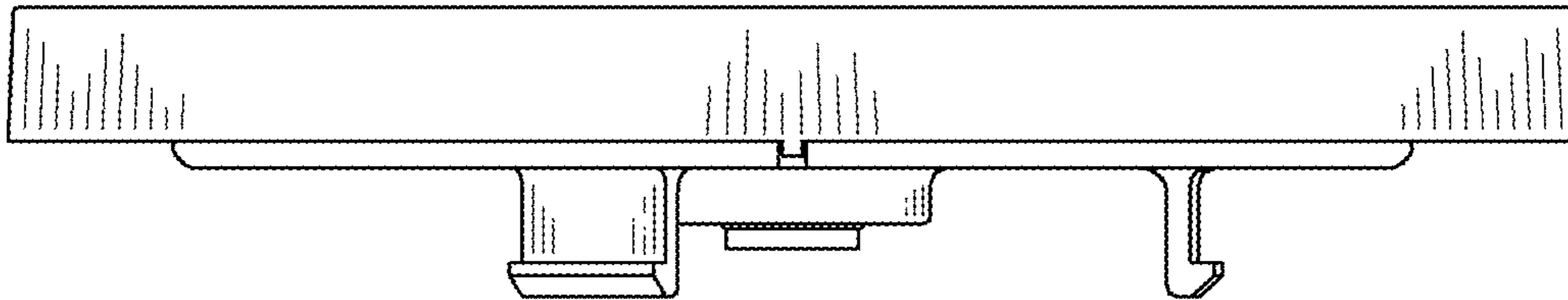

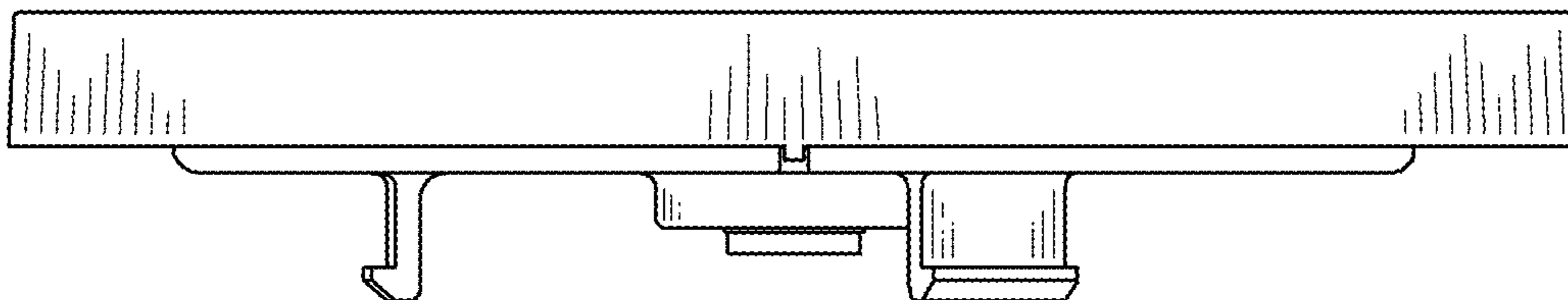

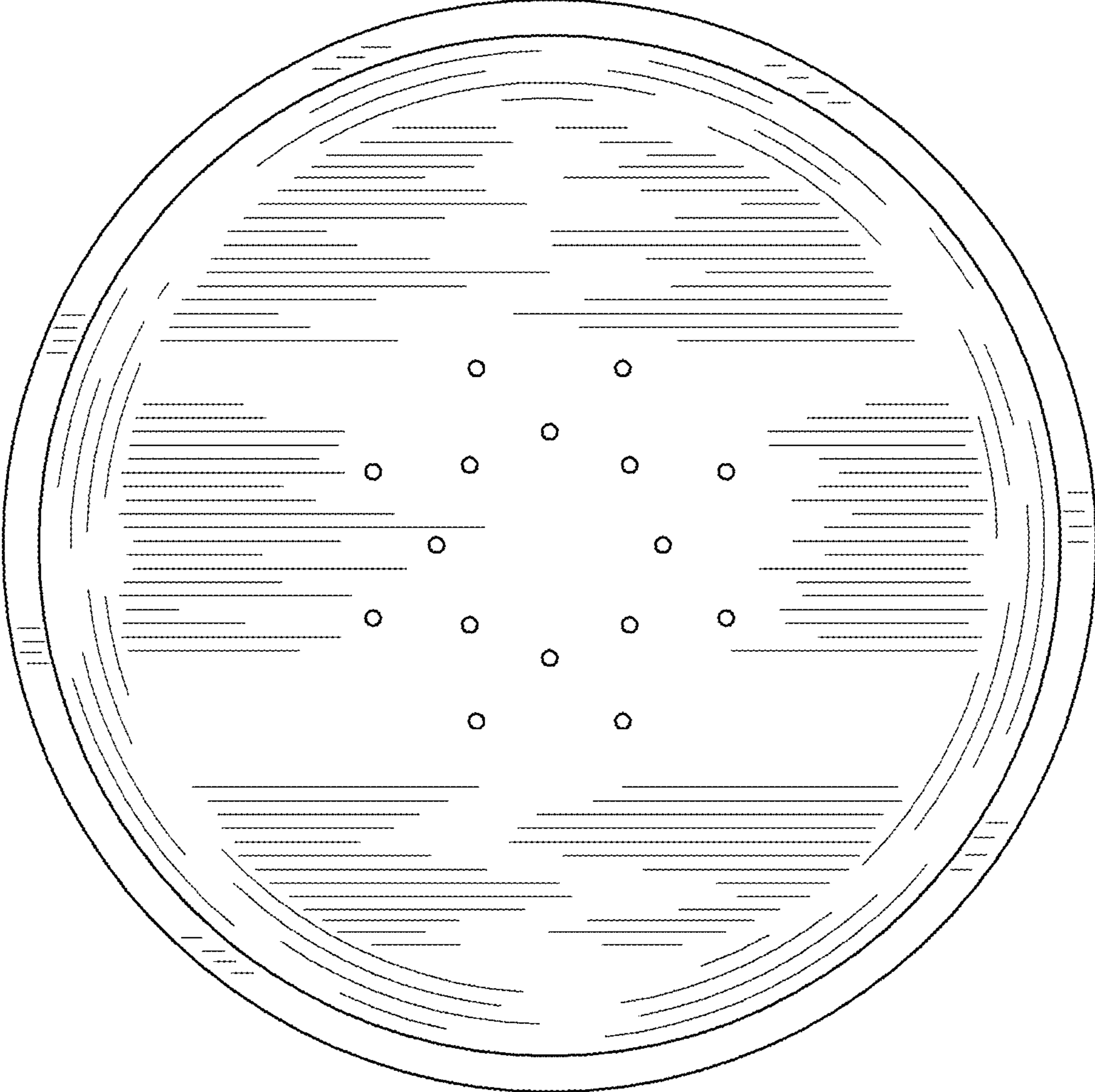
