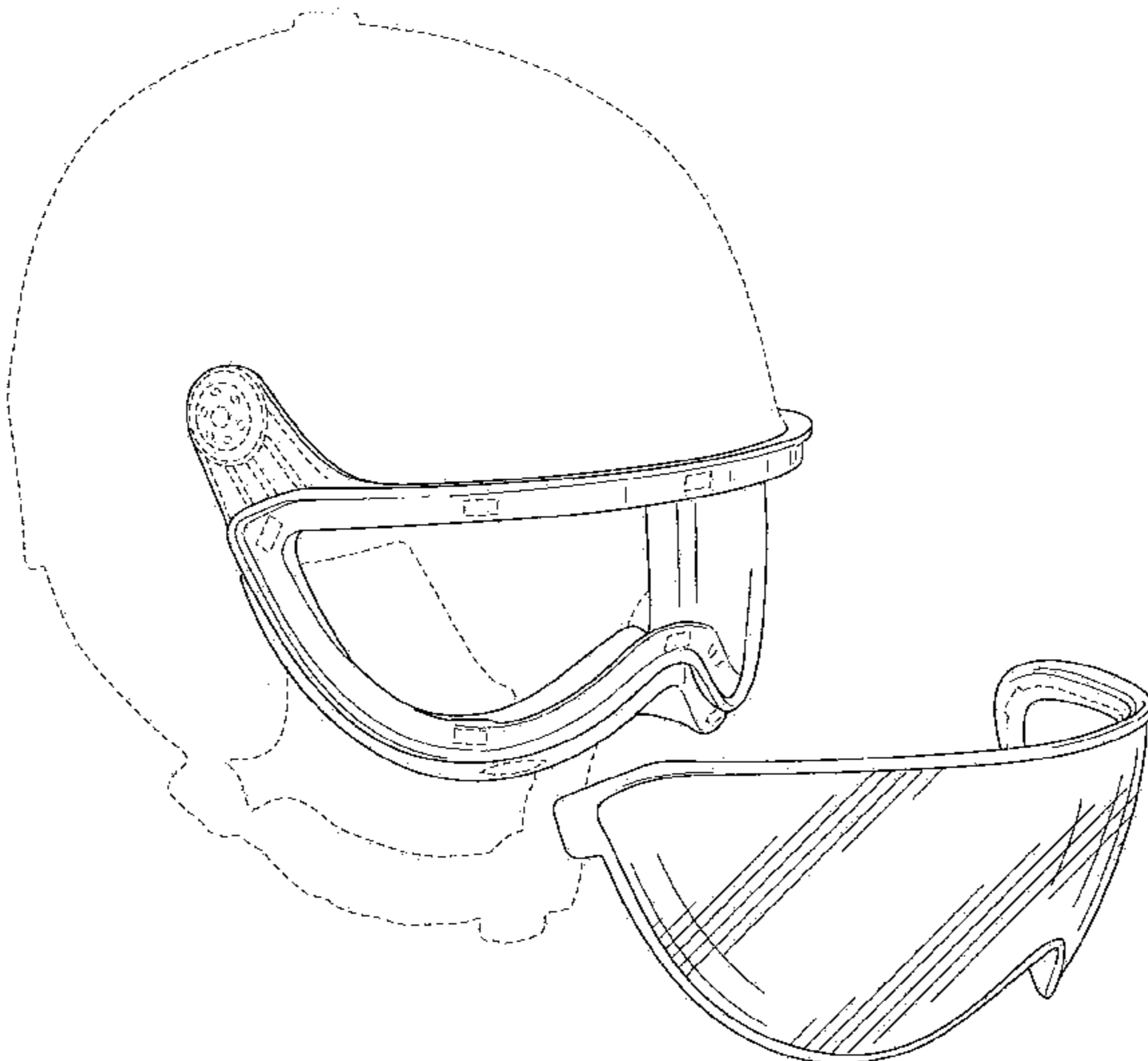

(57) **CLAIM**  
I claim, the ornamental design for a ski helmet visor, as shown and described.

**DESCRIPTION**

**1.1** is a front view of a ski helmet visor, showing my new design;  
**1.2** is a side view thereof taken from the left of **1.1**;  
**1.3** is a side view thereof taken from the right of **1.1**;  
**1.4** is an exploded perspective view thereof; and  
**1.5** is a front view thereof.  
Portions of the ski helmet visor shown in broken lines form no part of the claimed subject matter.

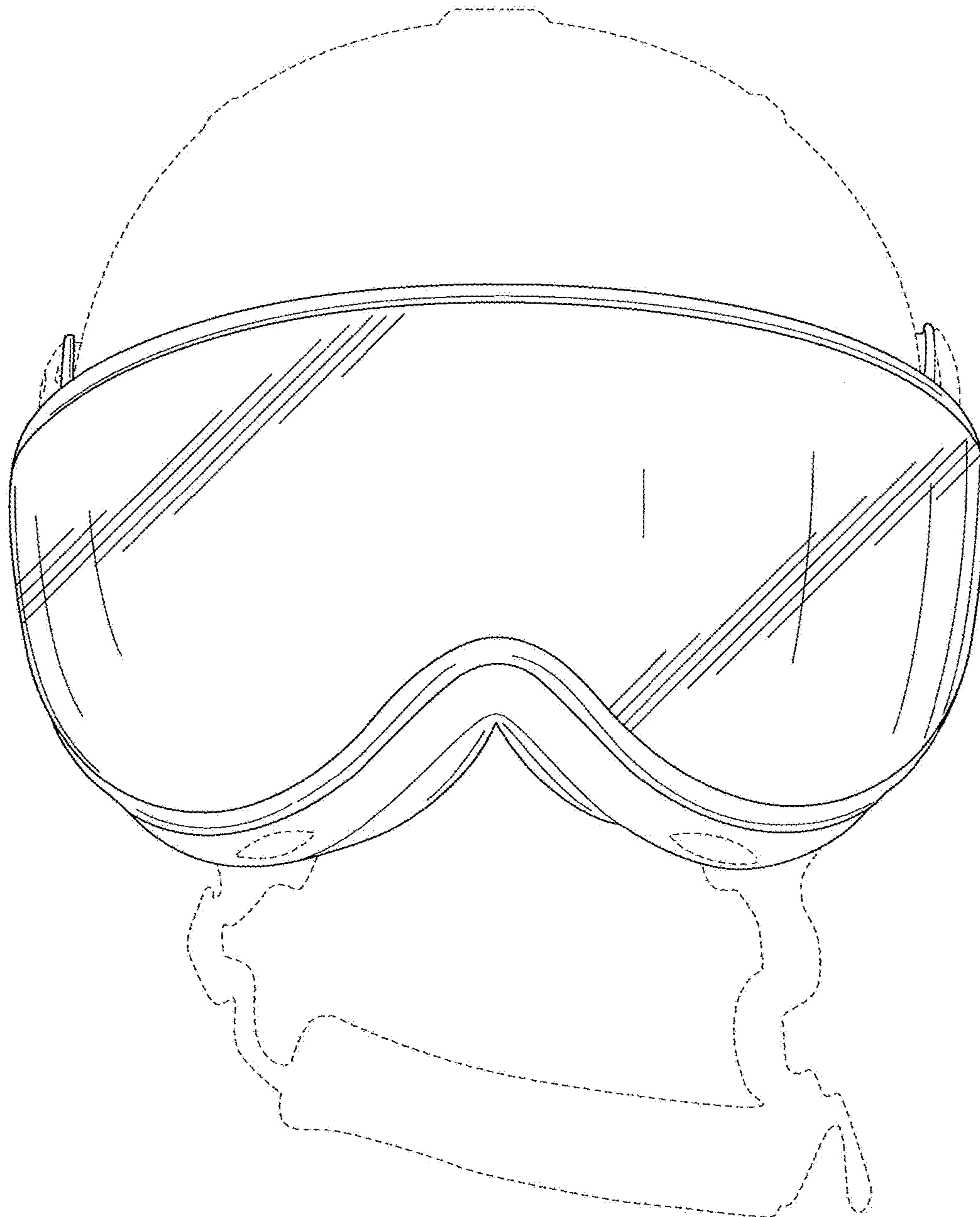

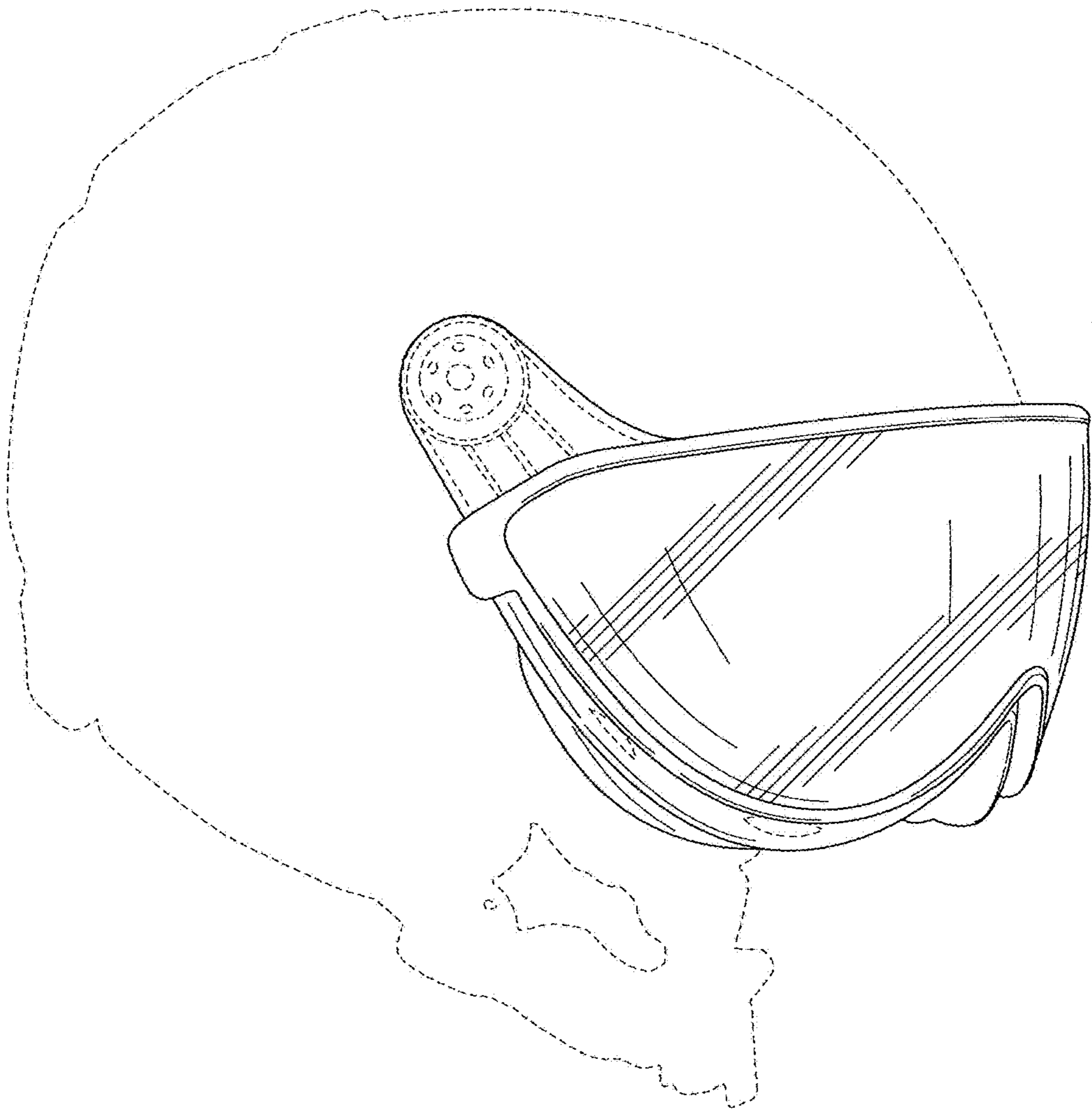

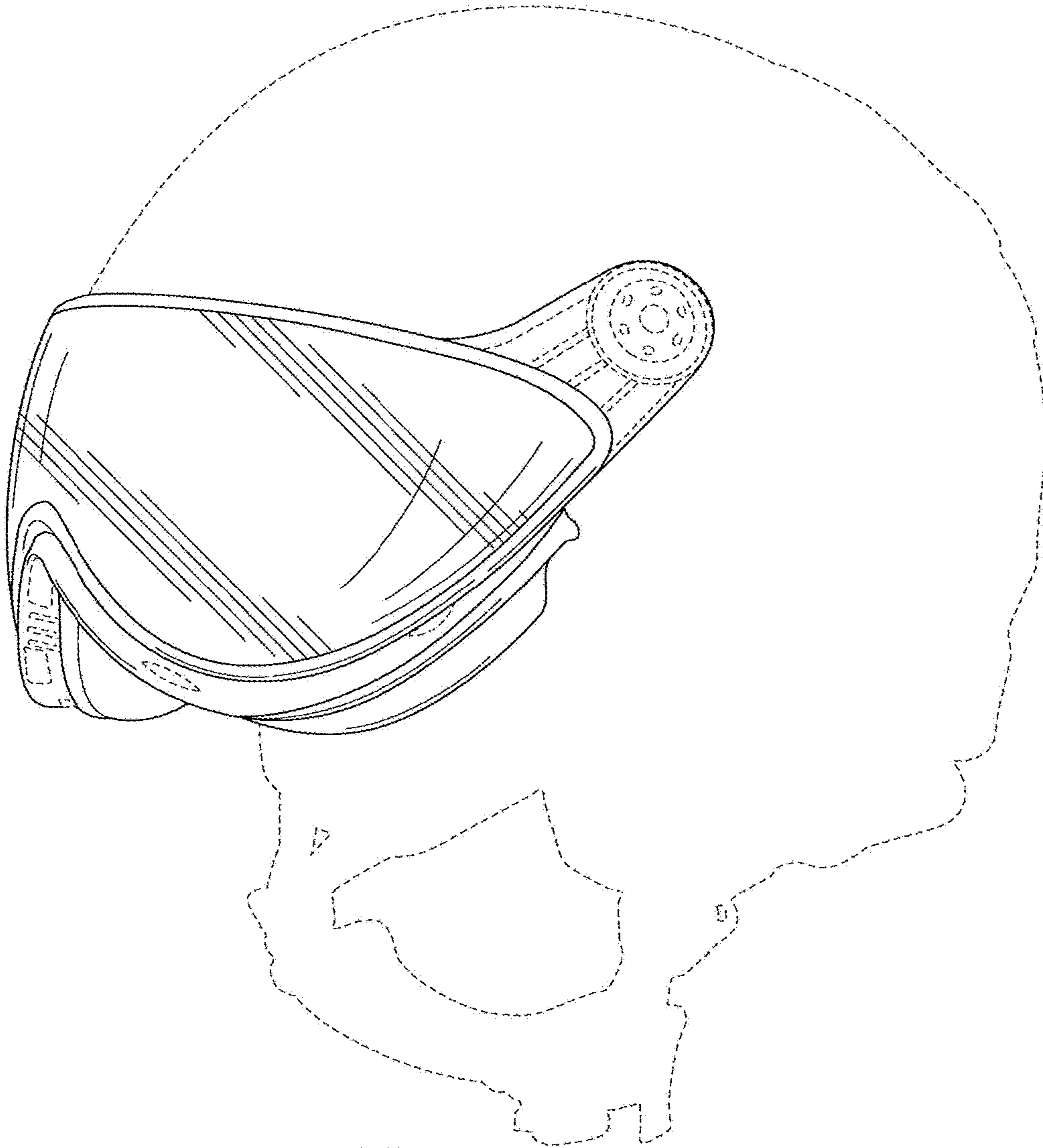

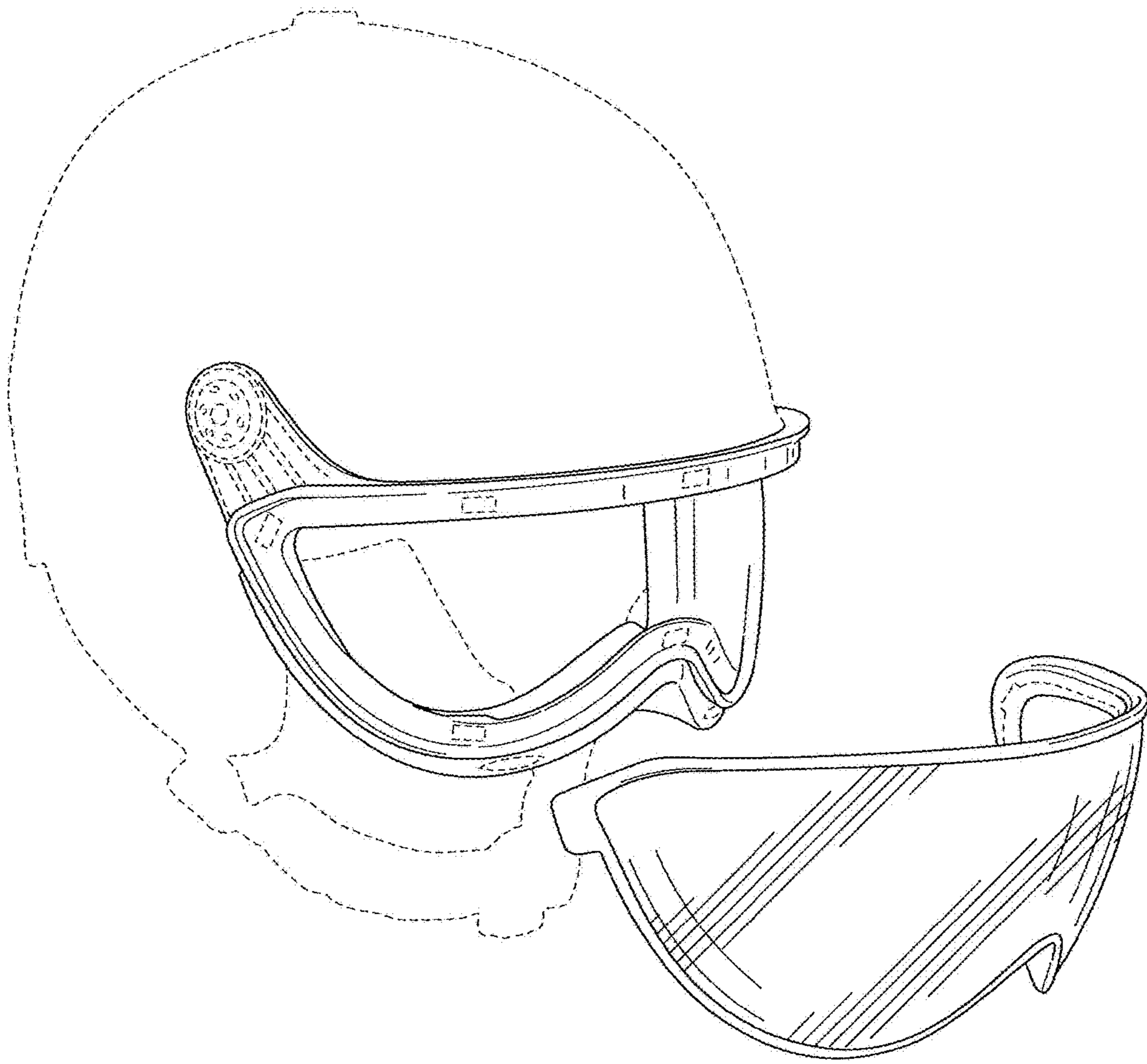

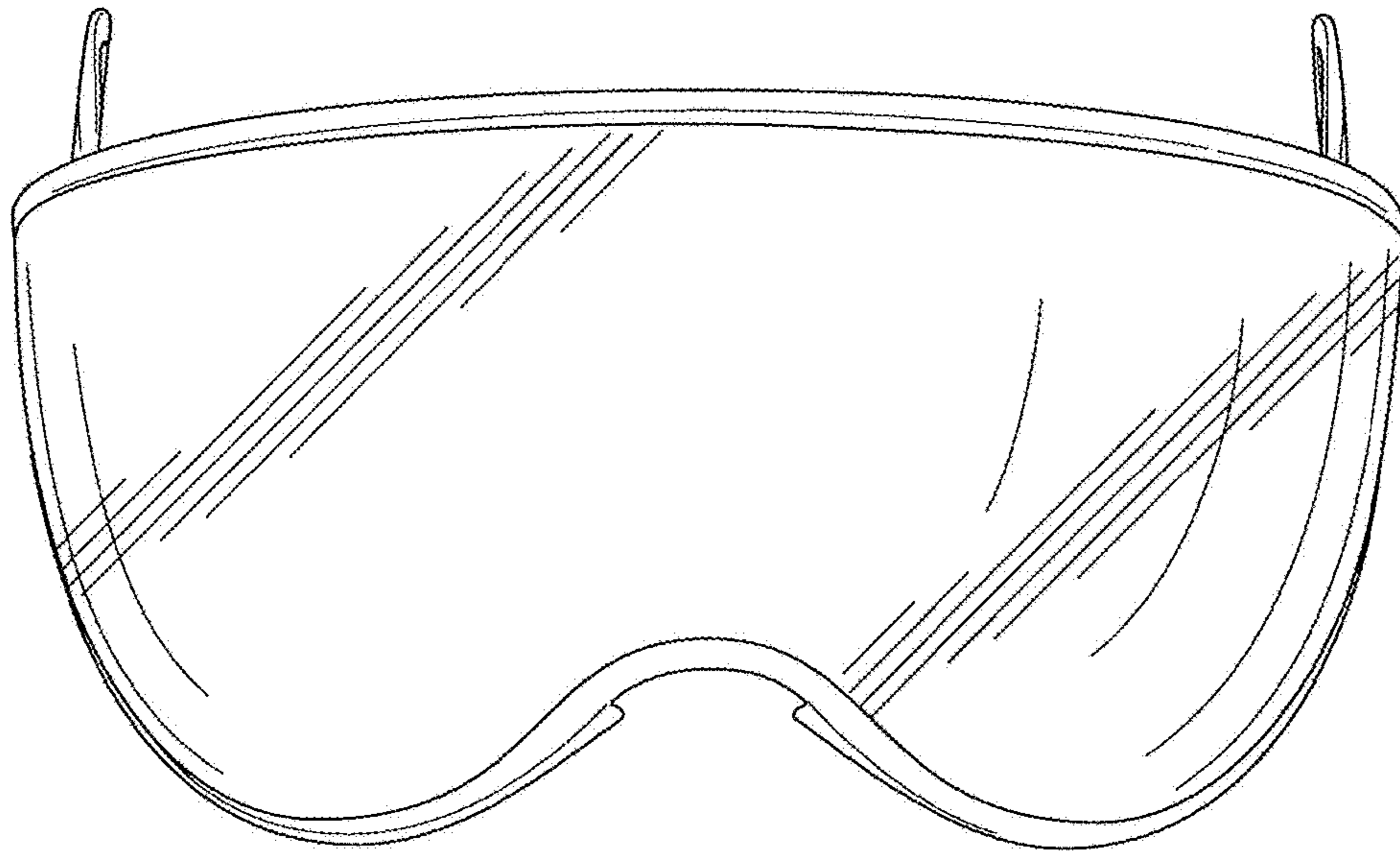
