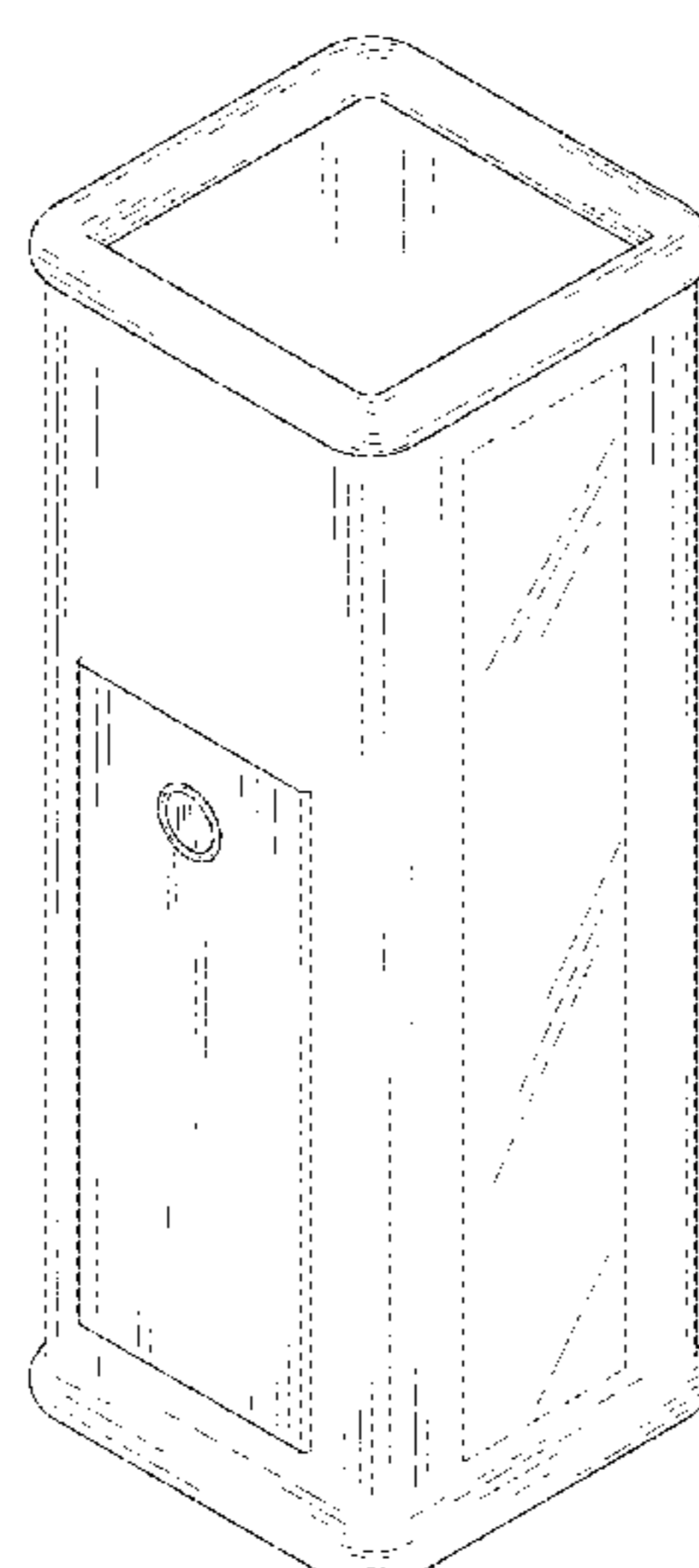
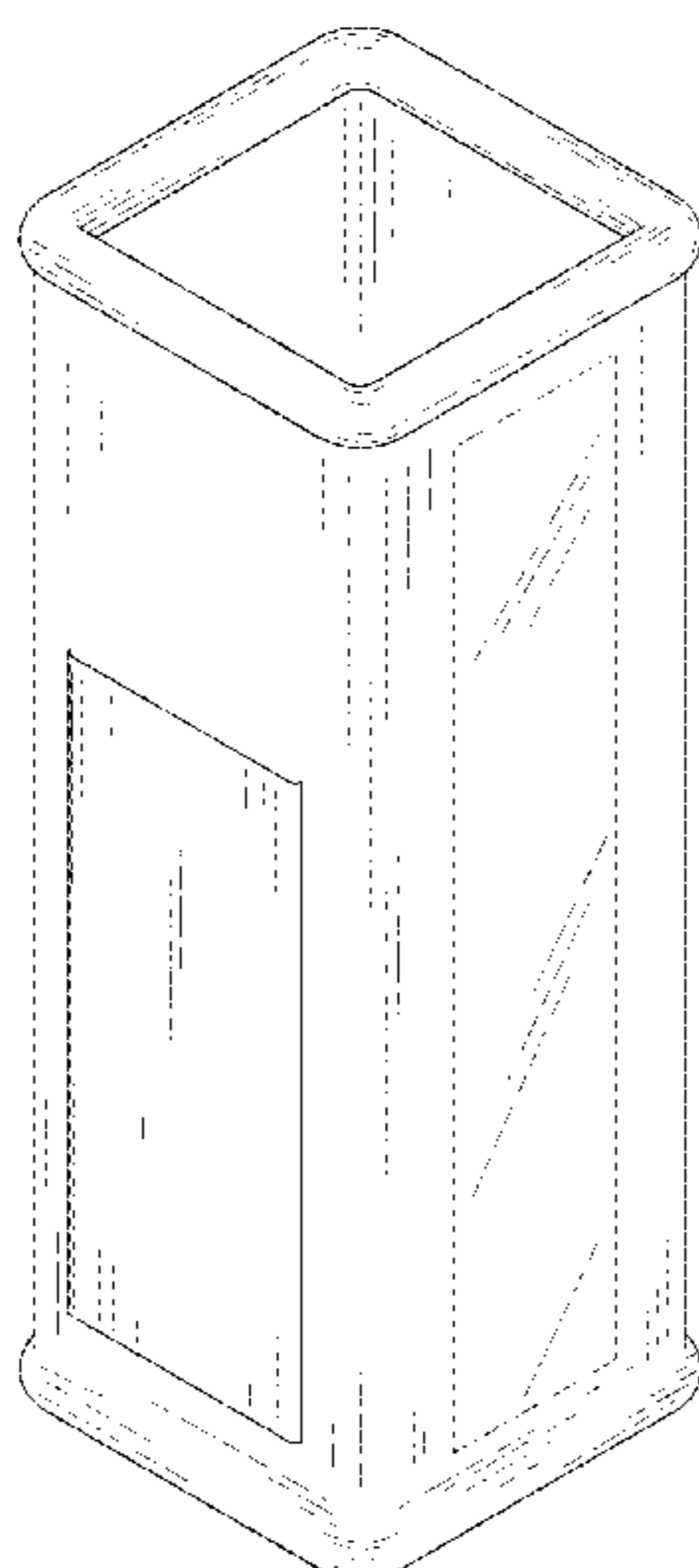
The ornamental design for a pet leash attachment, as shown and described.

DESCRIPTION

FIG. 1 is a top left perspective view of a pet leash showing my new design;
FIG. 2 is a top right perspective view thereof;
FIG. 3 is a top left perspective view of the pet leash attachment with a strap attached;
FIG. 4 is a top view of the pet leash attachment of FIG. 1;
FIG. 5 is a bottom view thereof;
FIG. 6 is a front view thereof;
FIG. 7 is a back view thereof;
FIG. 8 is a left view thereof; and,
FIG. 9 is a right view thereof.

The broken lines showing the strap in FIG. 3 are included for the purpose of showing environmental structure and form no part of the claimed design.

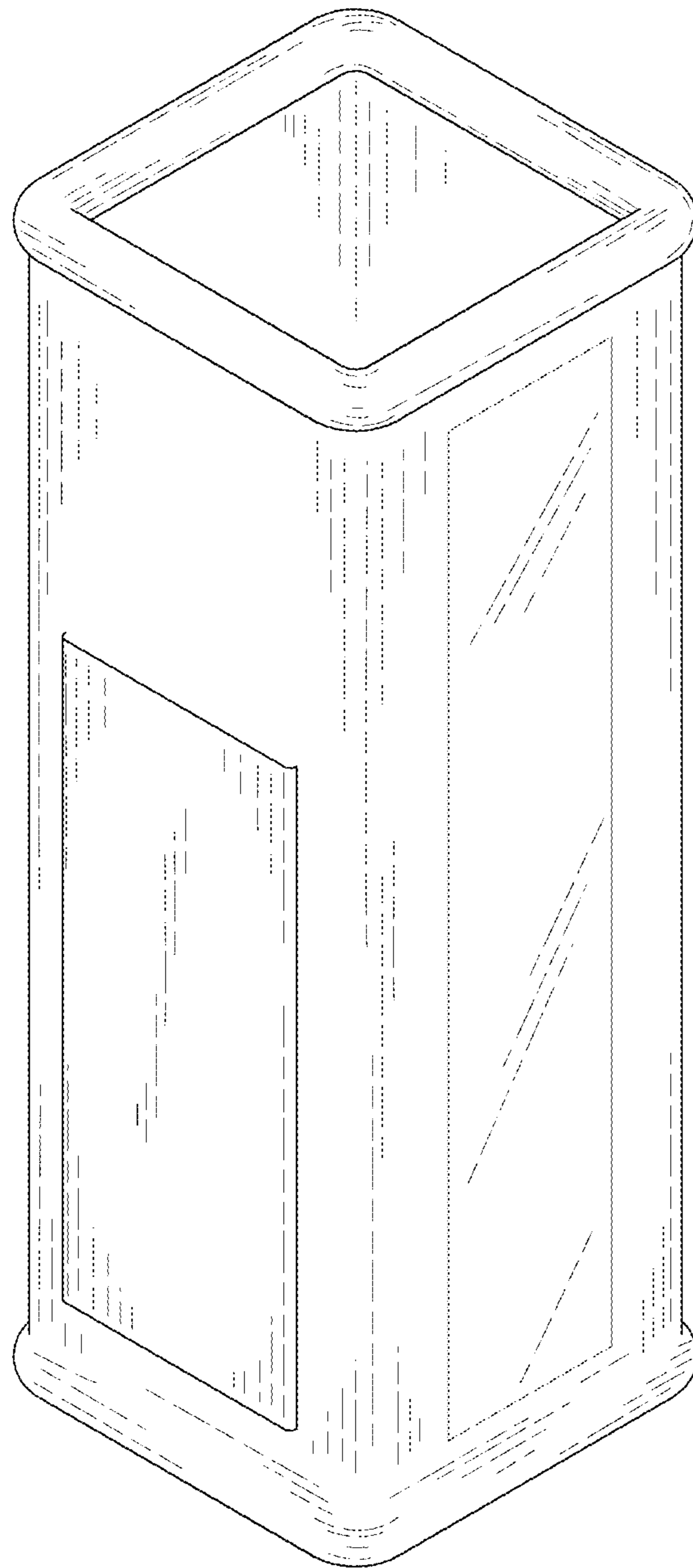

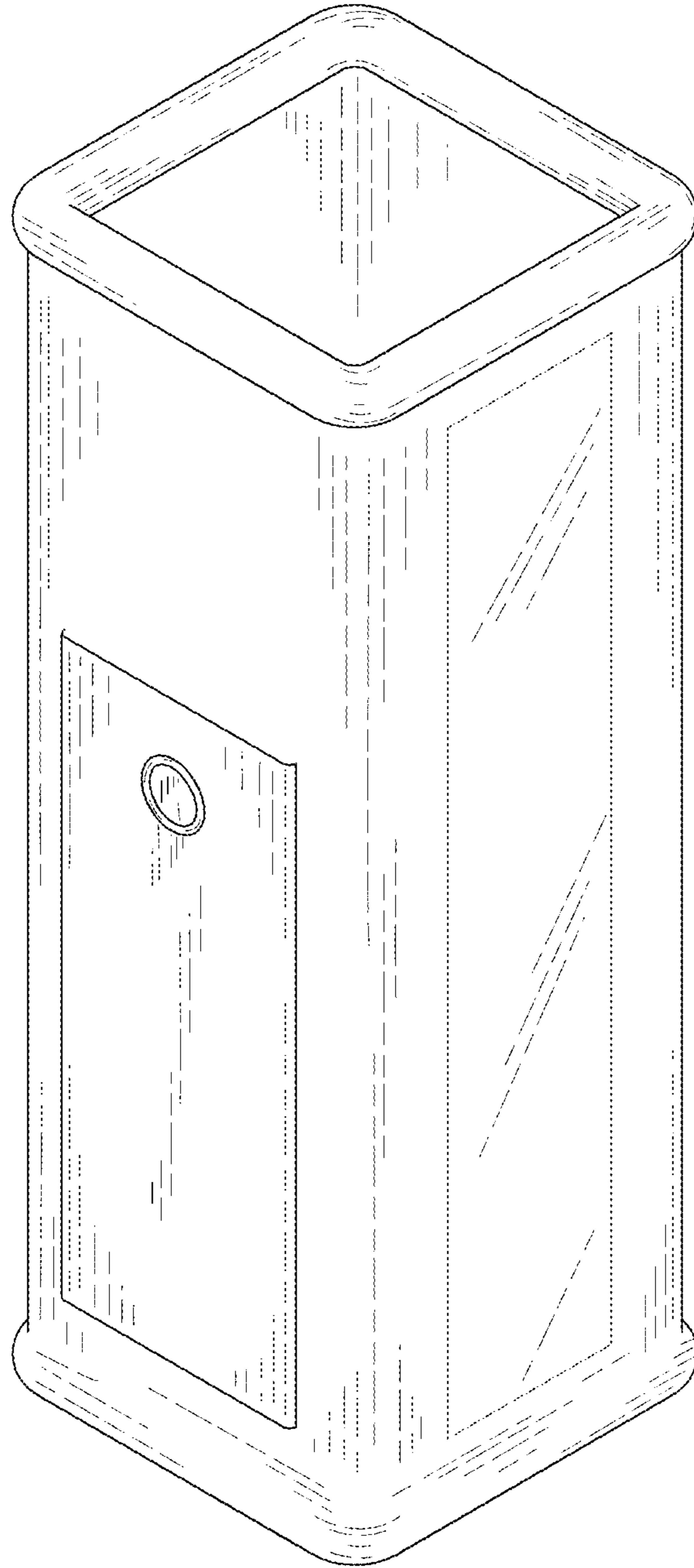

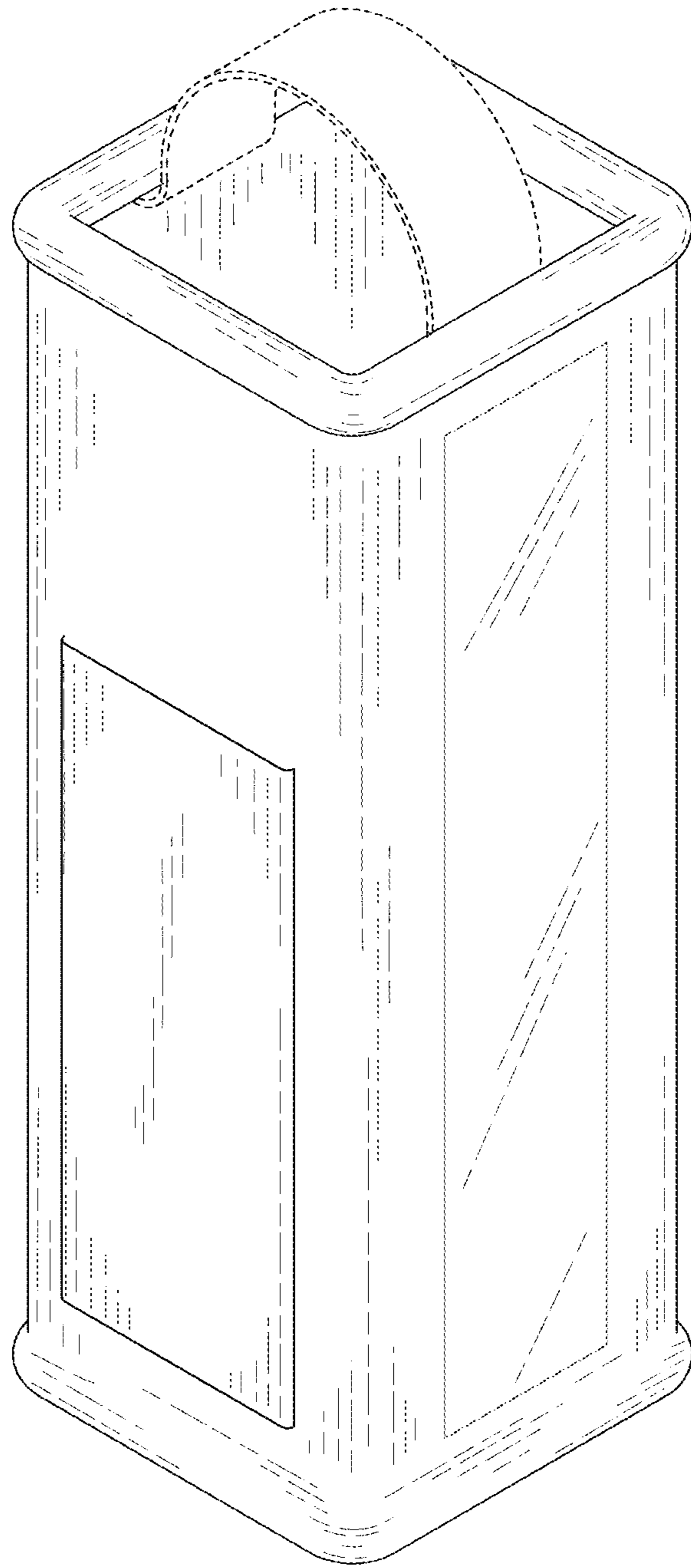

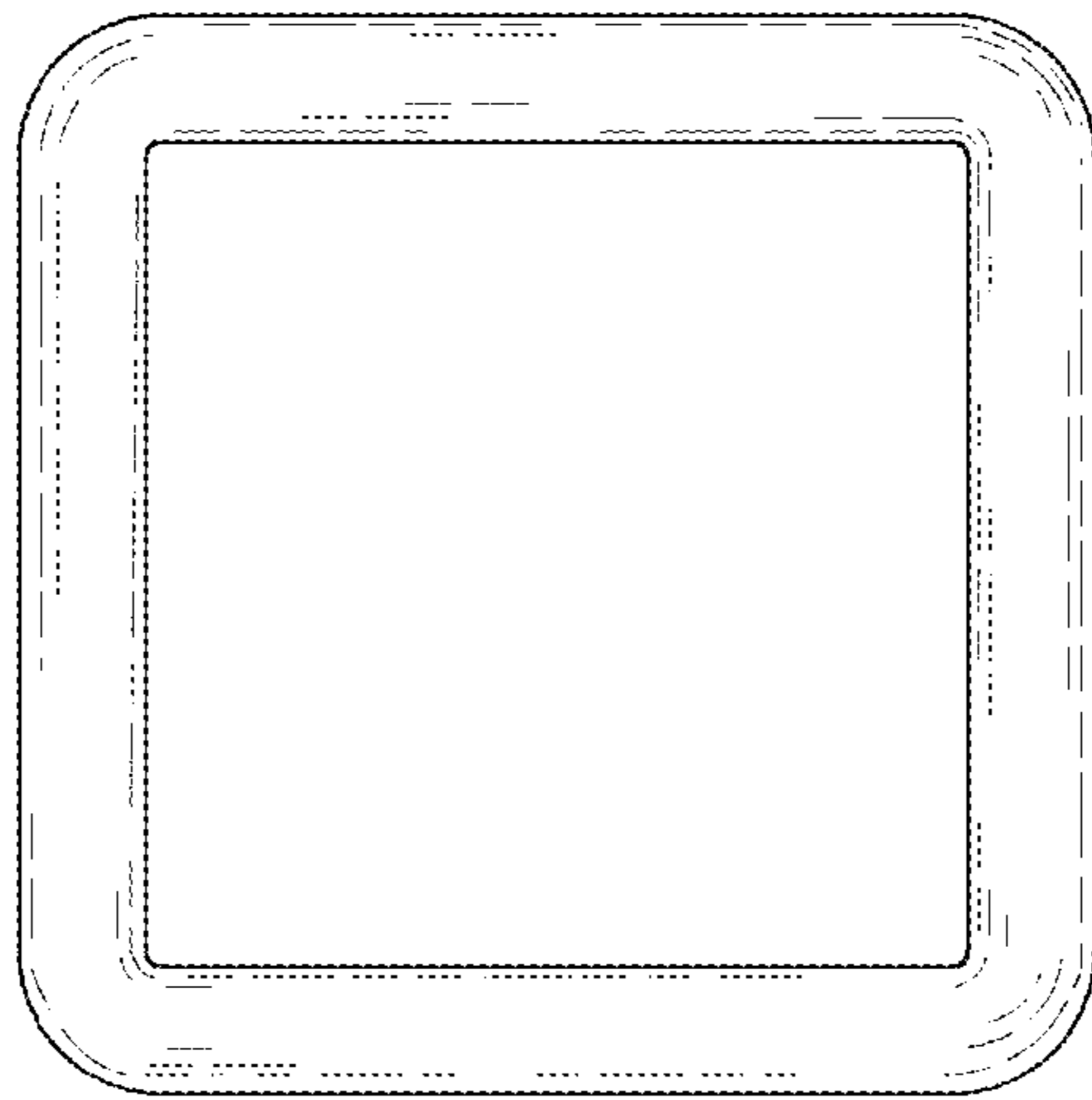

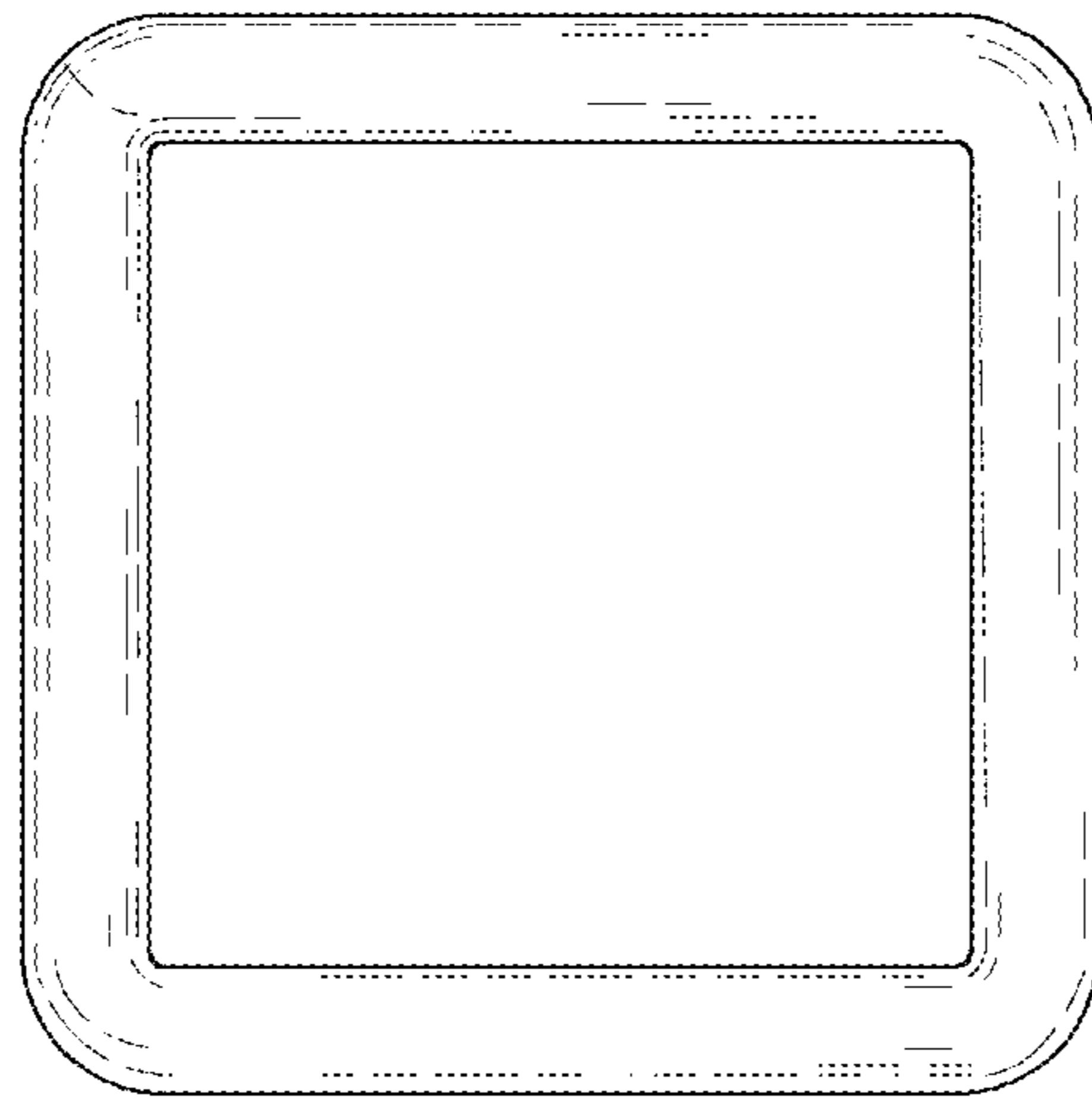

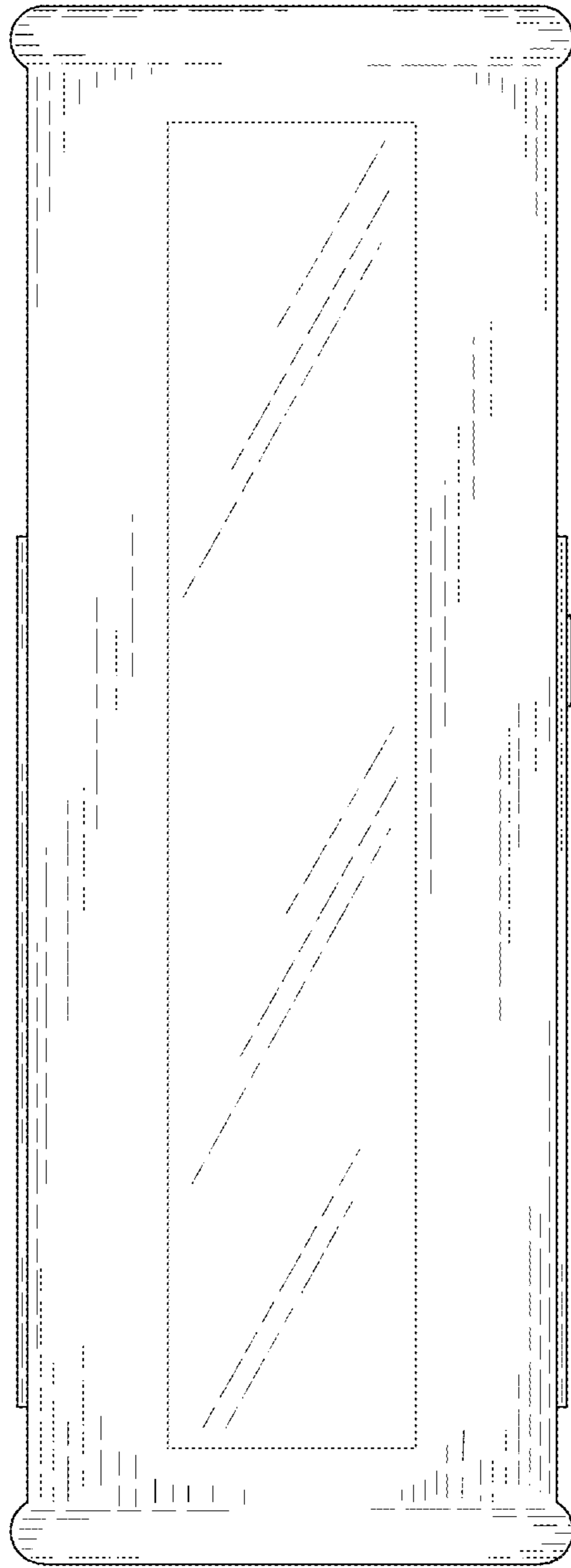

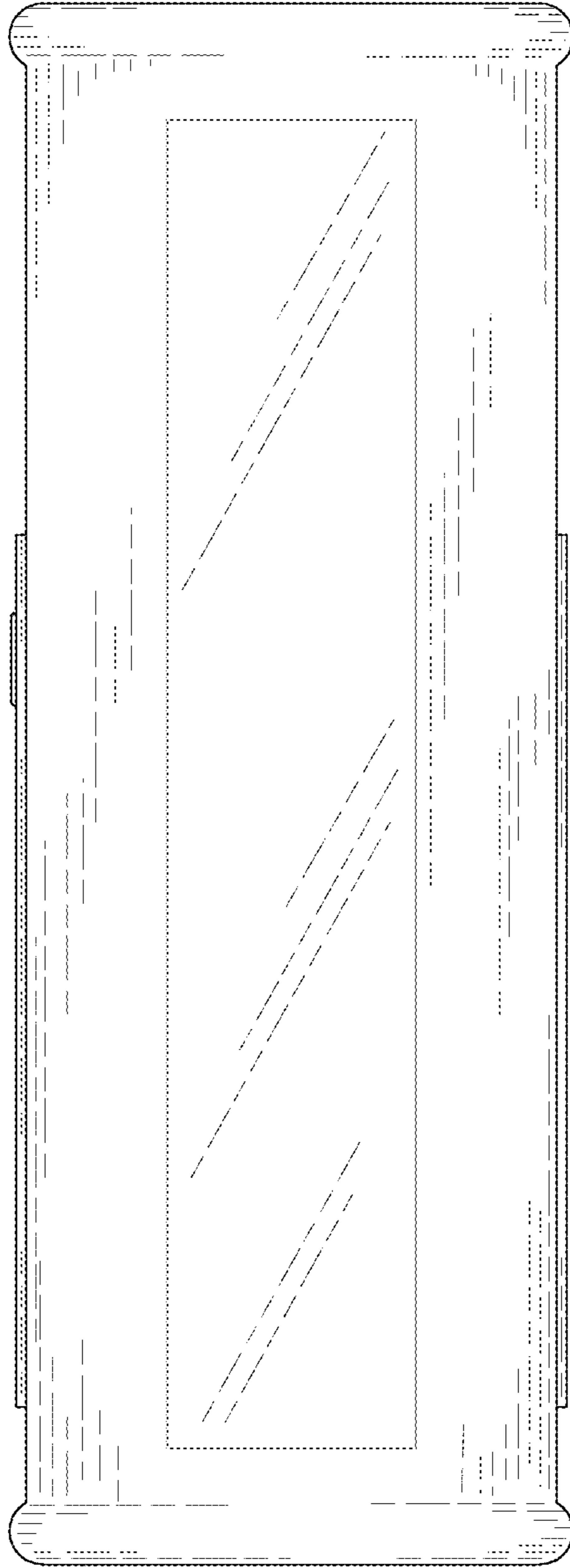

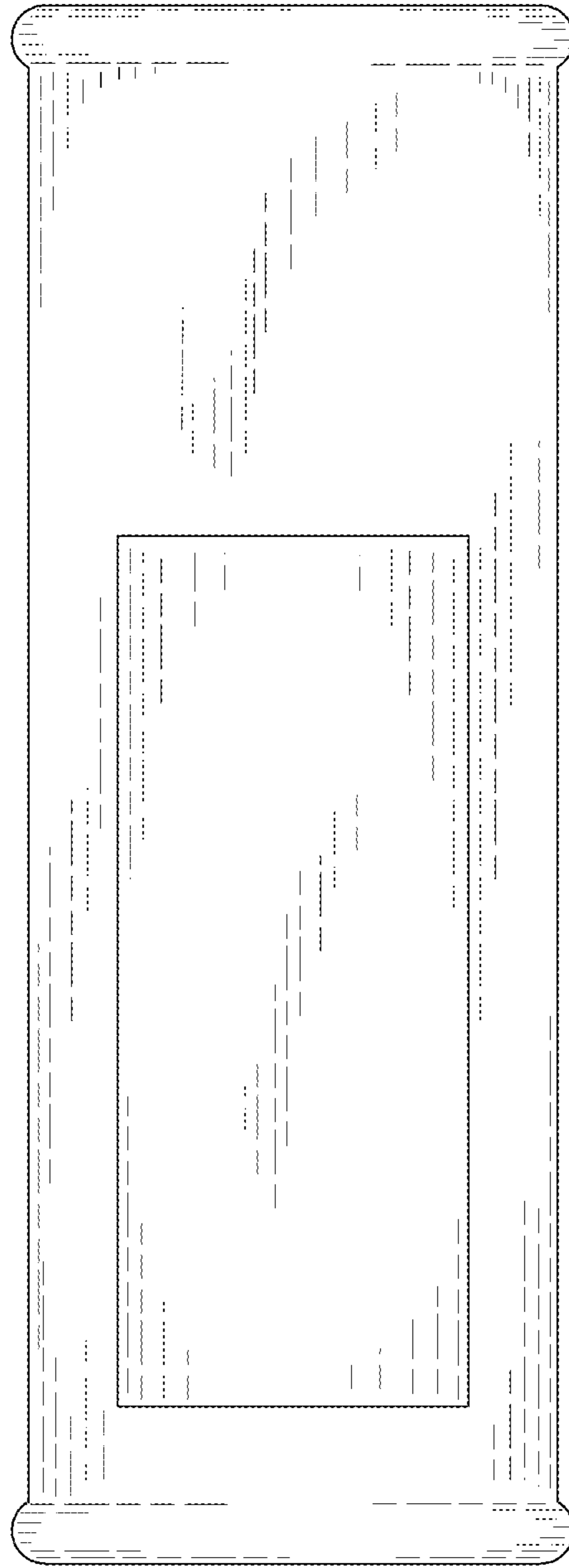

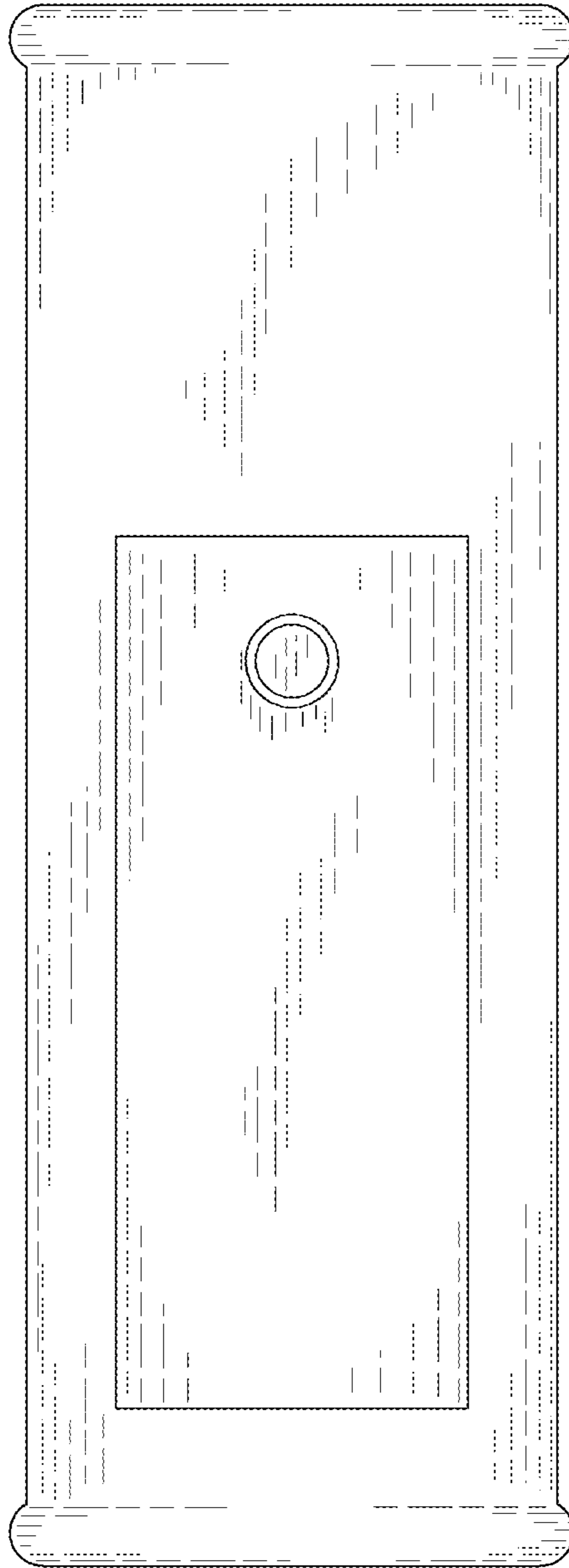
