(57) **CLAIM**

The ornamental design for a garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right perspective view of a garment that is in an in-use configuration showing the present design, wherein a first sleeve of the garment is shown in a raised position;

FIG. 2 is a front view thereof, wherein the first sleeve of the garment is shown in a non-raised position;

FIG. 3 is a first side view of the garment of FIG. 1;

FIG. 4 is a second side view of the garment of FIG. 1, wherein the first sleeve of the garment is shown in a non-raised position; and,

FIG. 5 is a back view thereof.

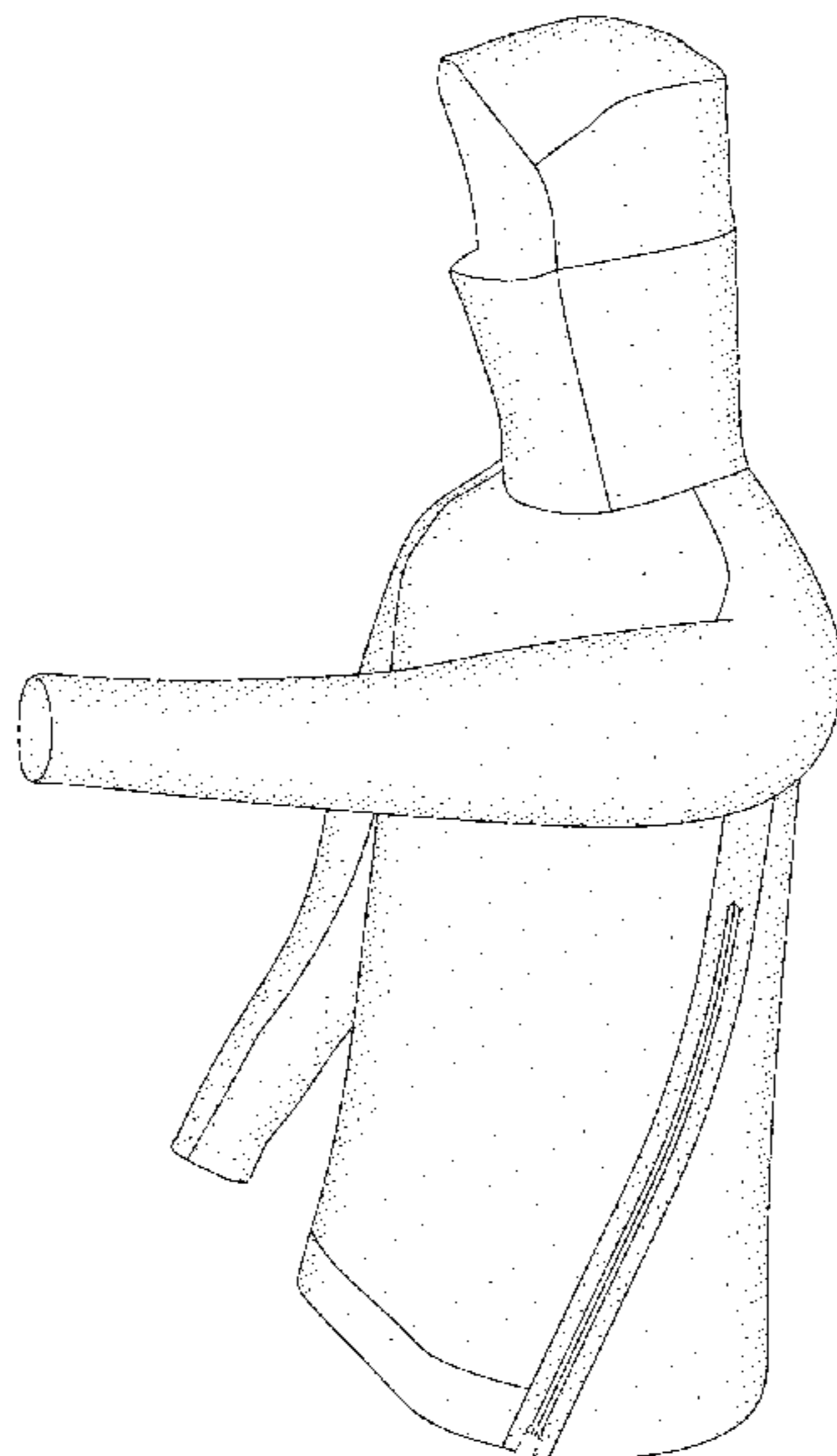
The denser stipple shading on the portion surrounding the zipper represents a contrast in appearance and does not represent any particular color, material, texture, or finish. The stipple shading on the remaining portions of the claimed subject matter represents the surface contour. The broken lines shown in the drawings illustrate the zipper pull tab and form no part of the claimed design.

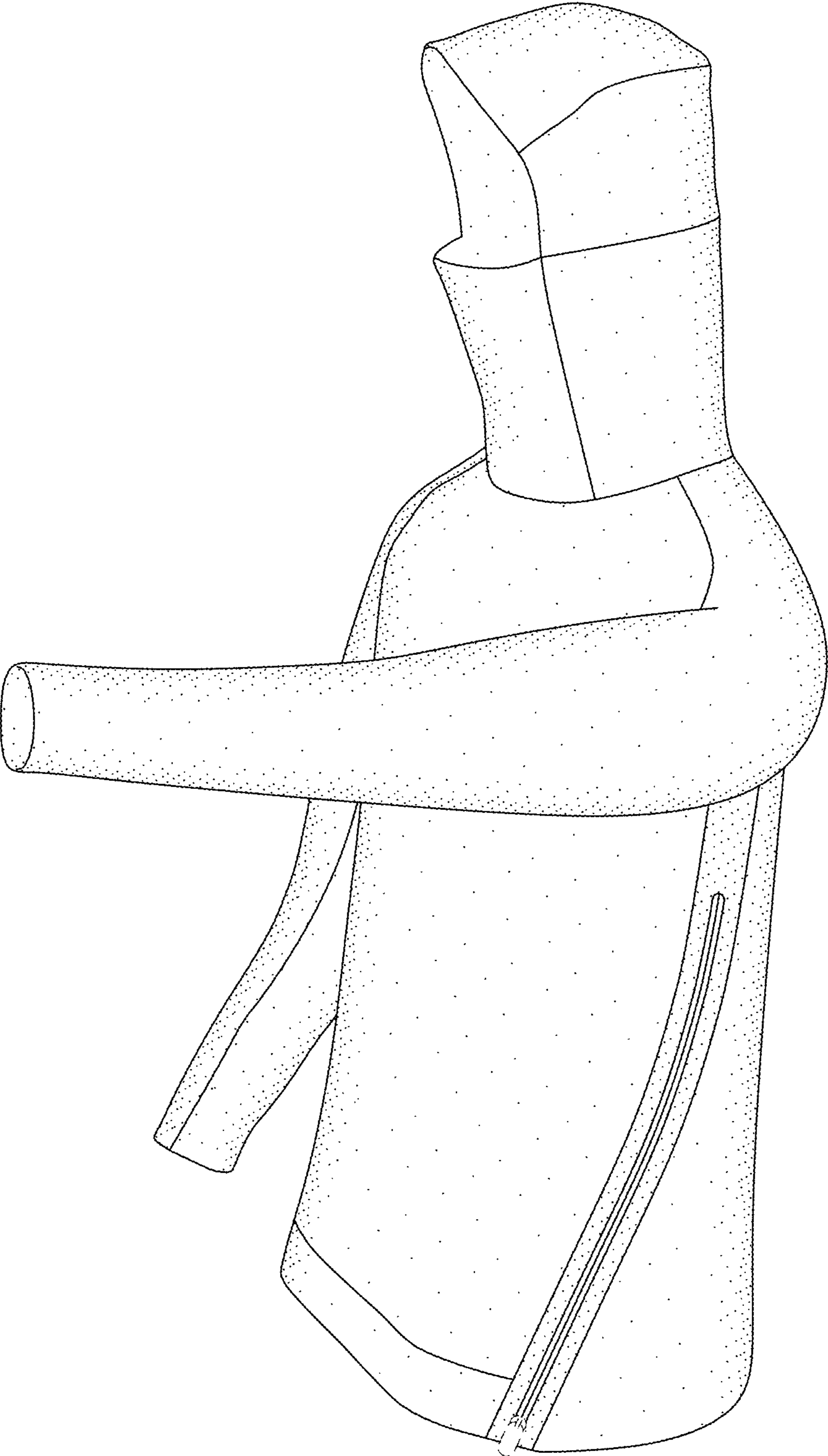

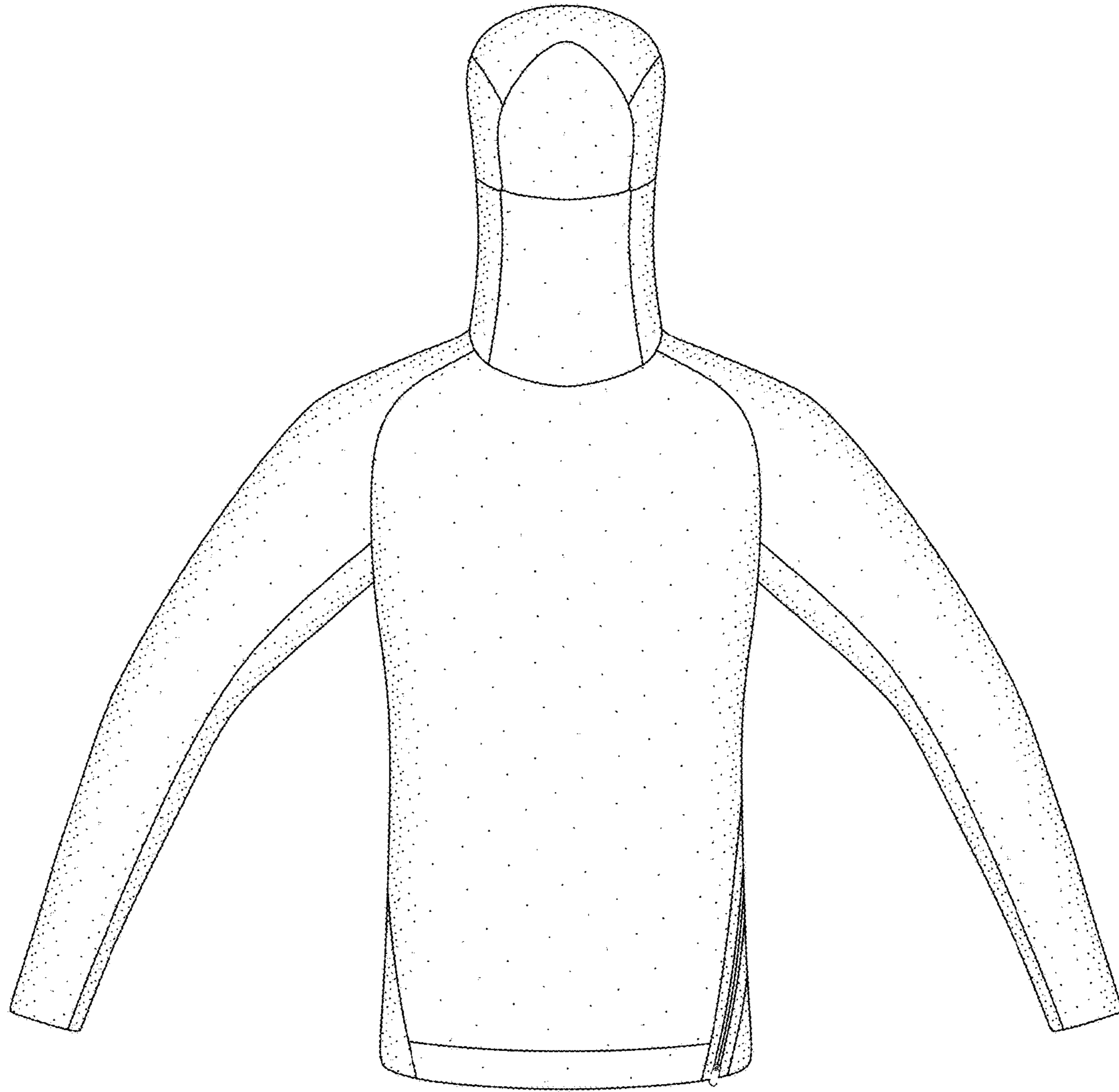

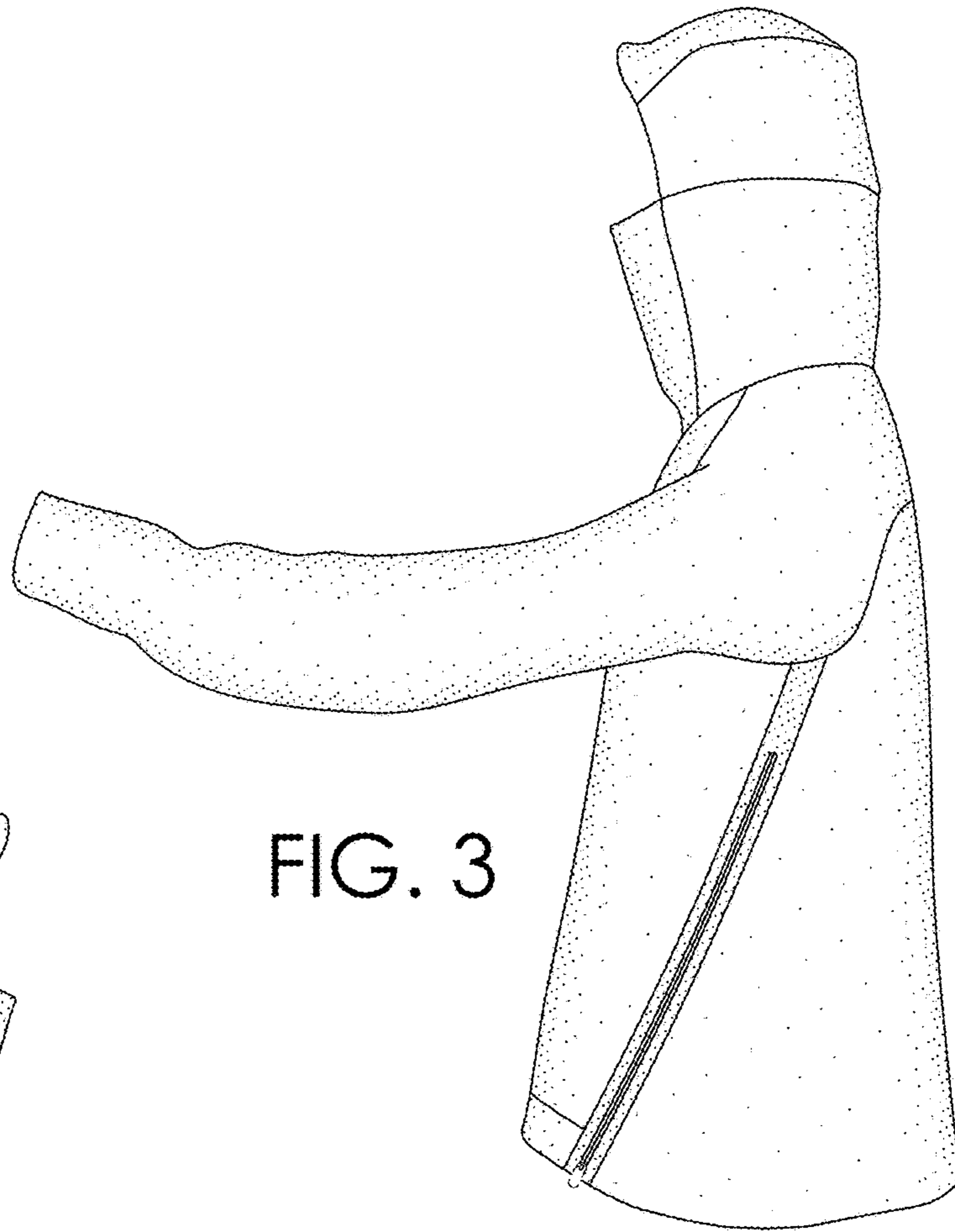

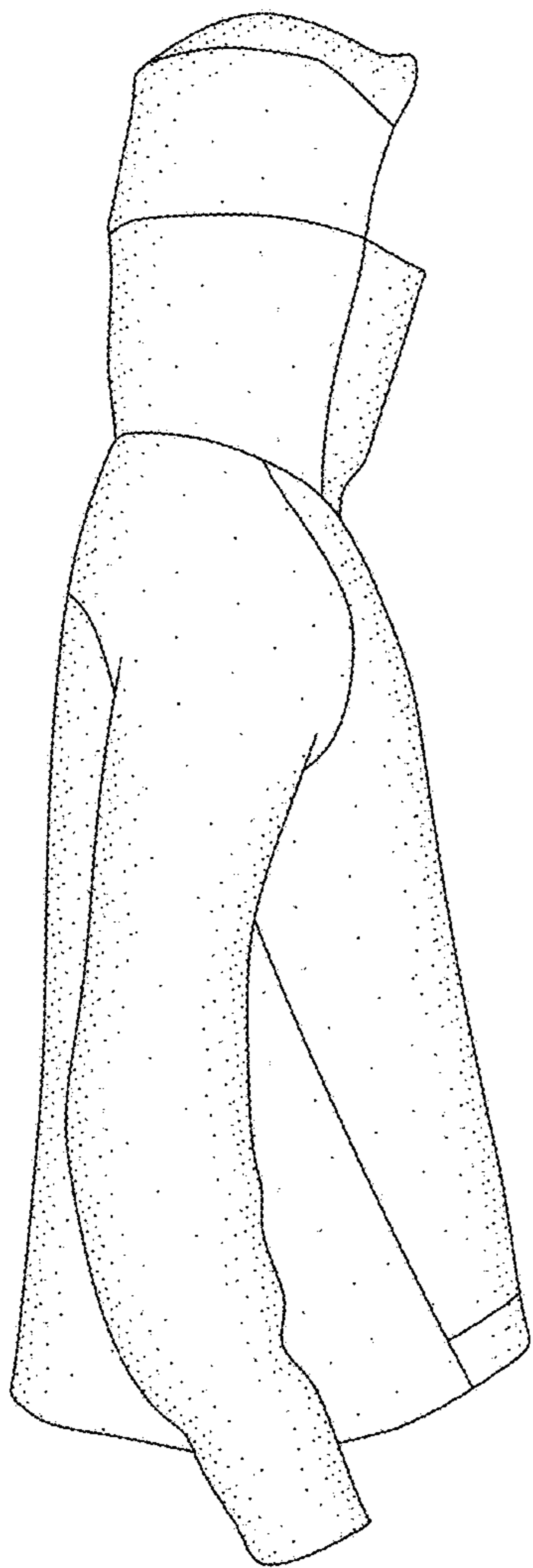

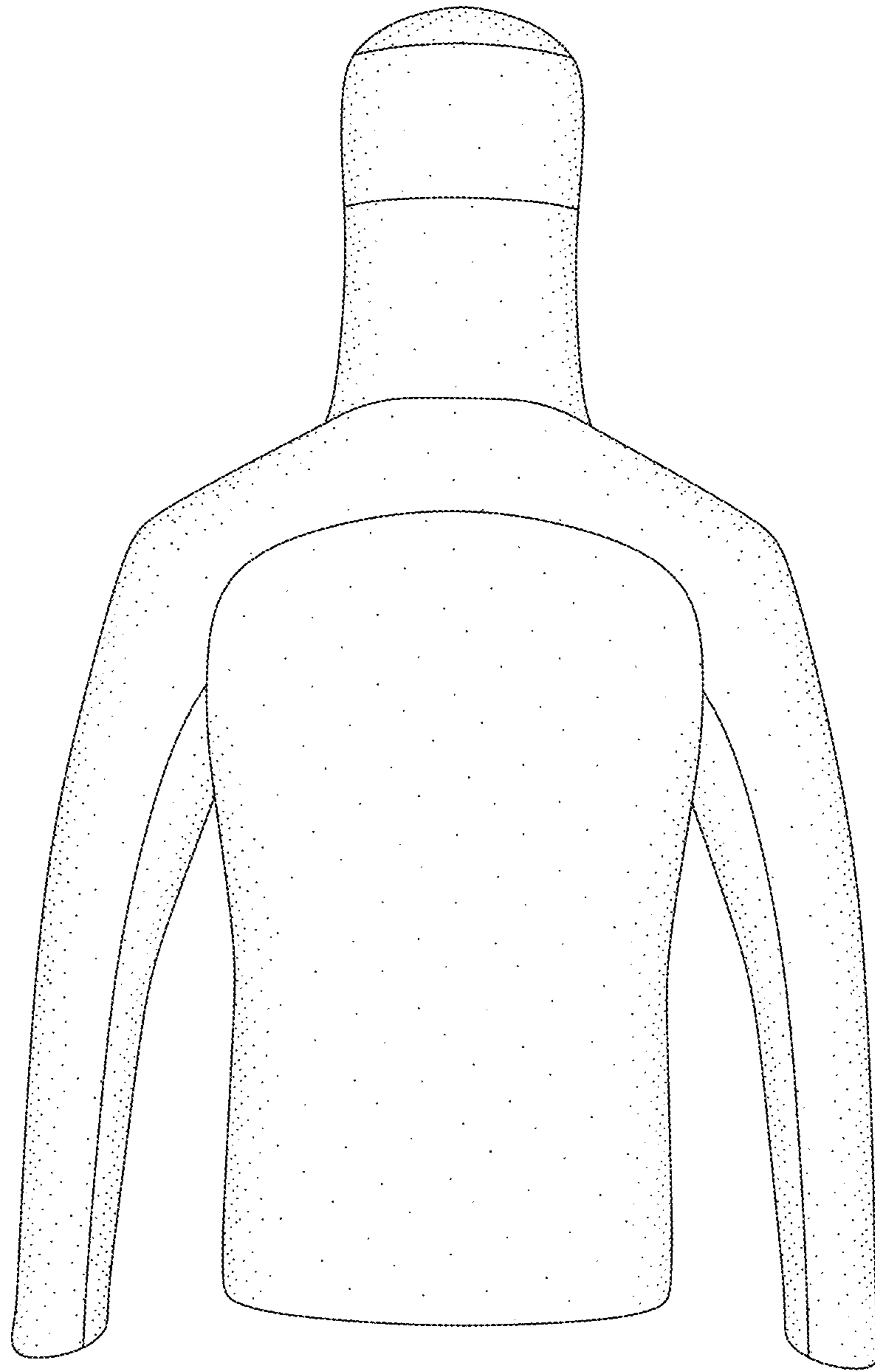
