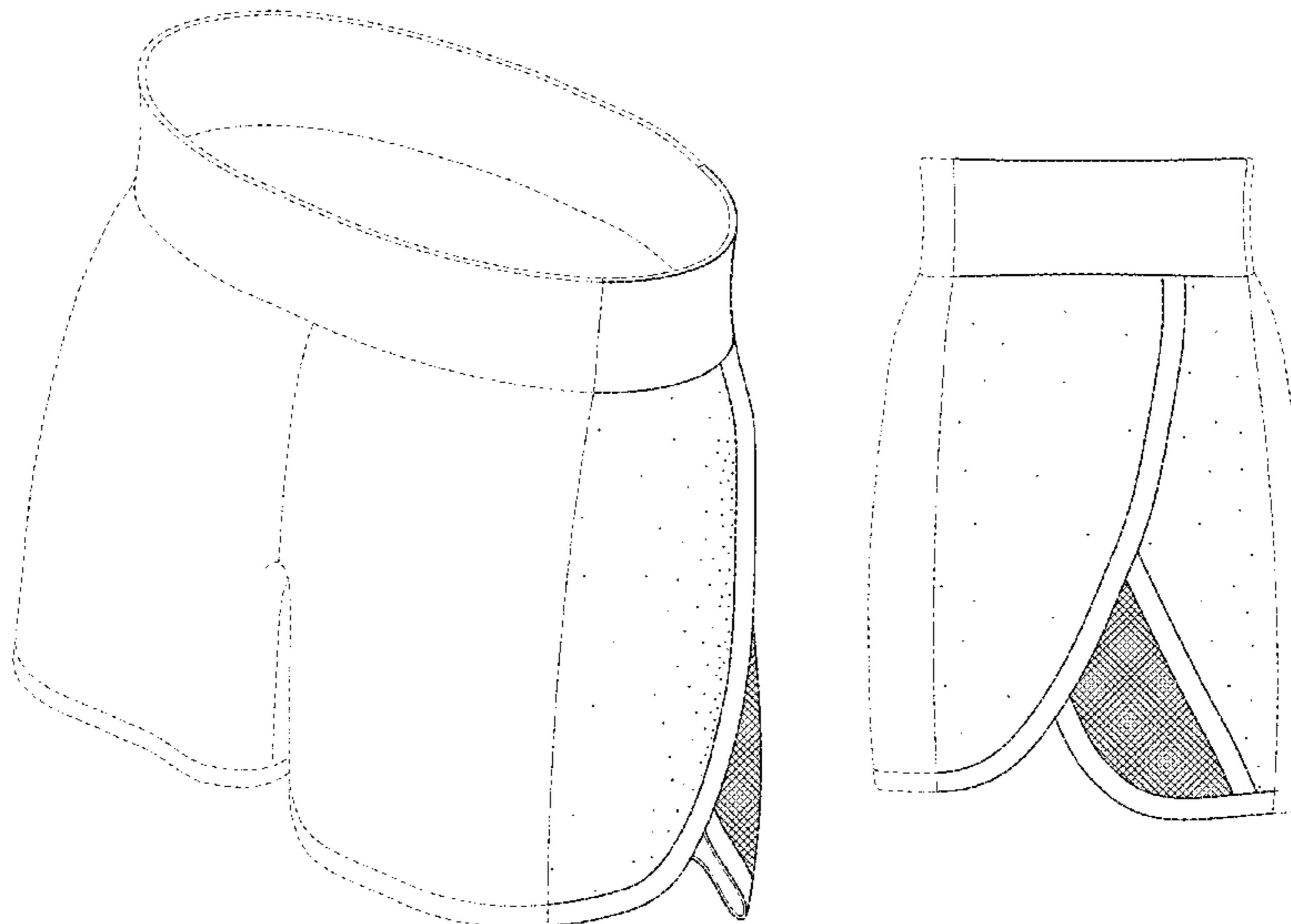
The ornamental design for shorts, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the shorts showing our new design in an in-use state; FIG. 2 is a rear view thereof; FIG. 3 is a side view thereof; and, FIG. 4 is a side view of the shorts of FIGS. 1-3 shown in a flat state.

The dash dot broken lines immediately adjacent to the shaded area represent boundaries of the claim and form no part thereof. The evenly dashed broken lines represent environmental subject matter that form no part of the claim.

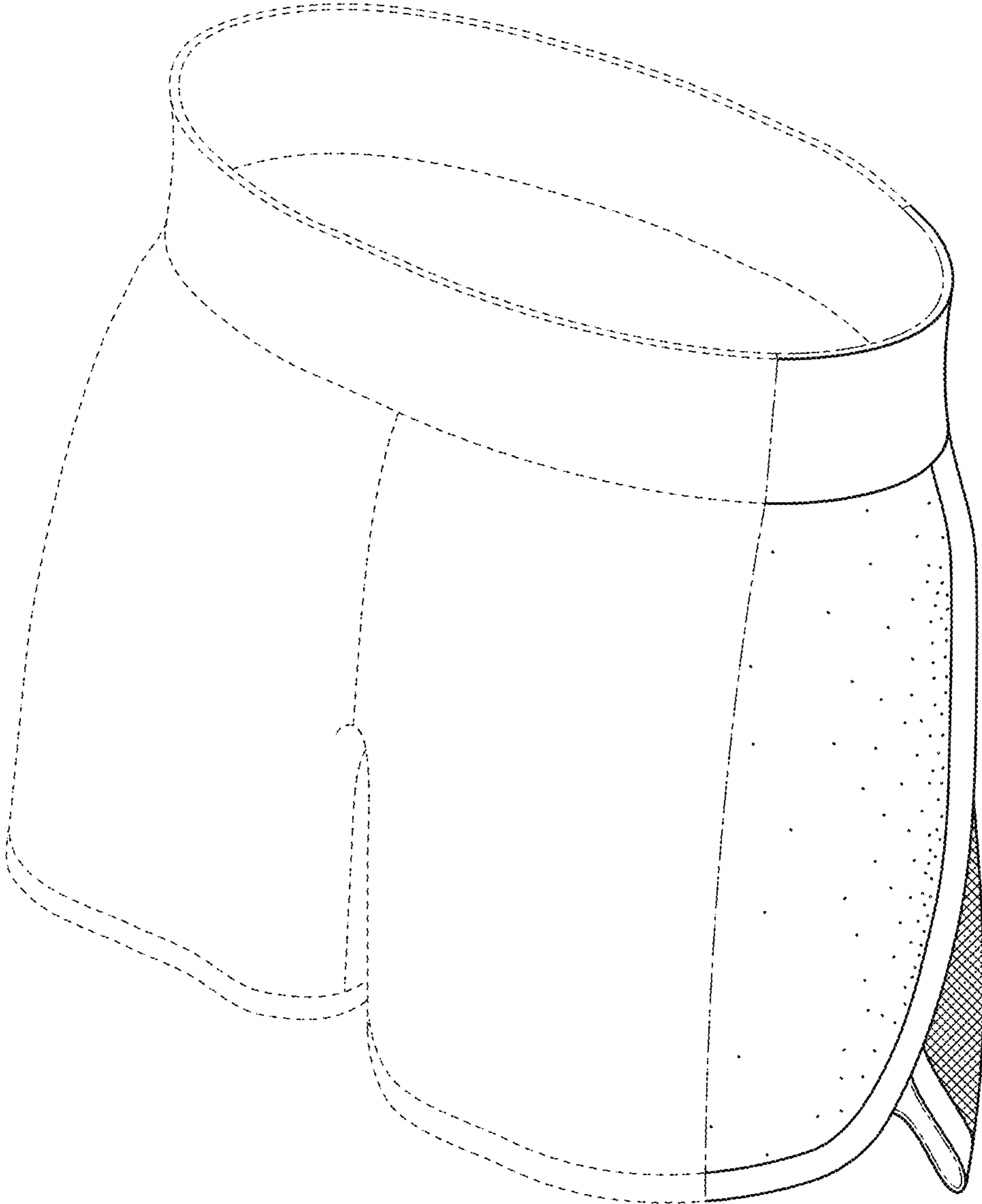

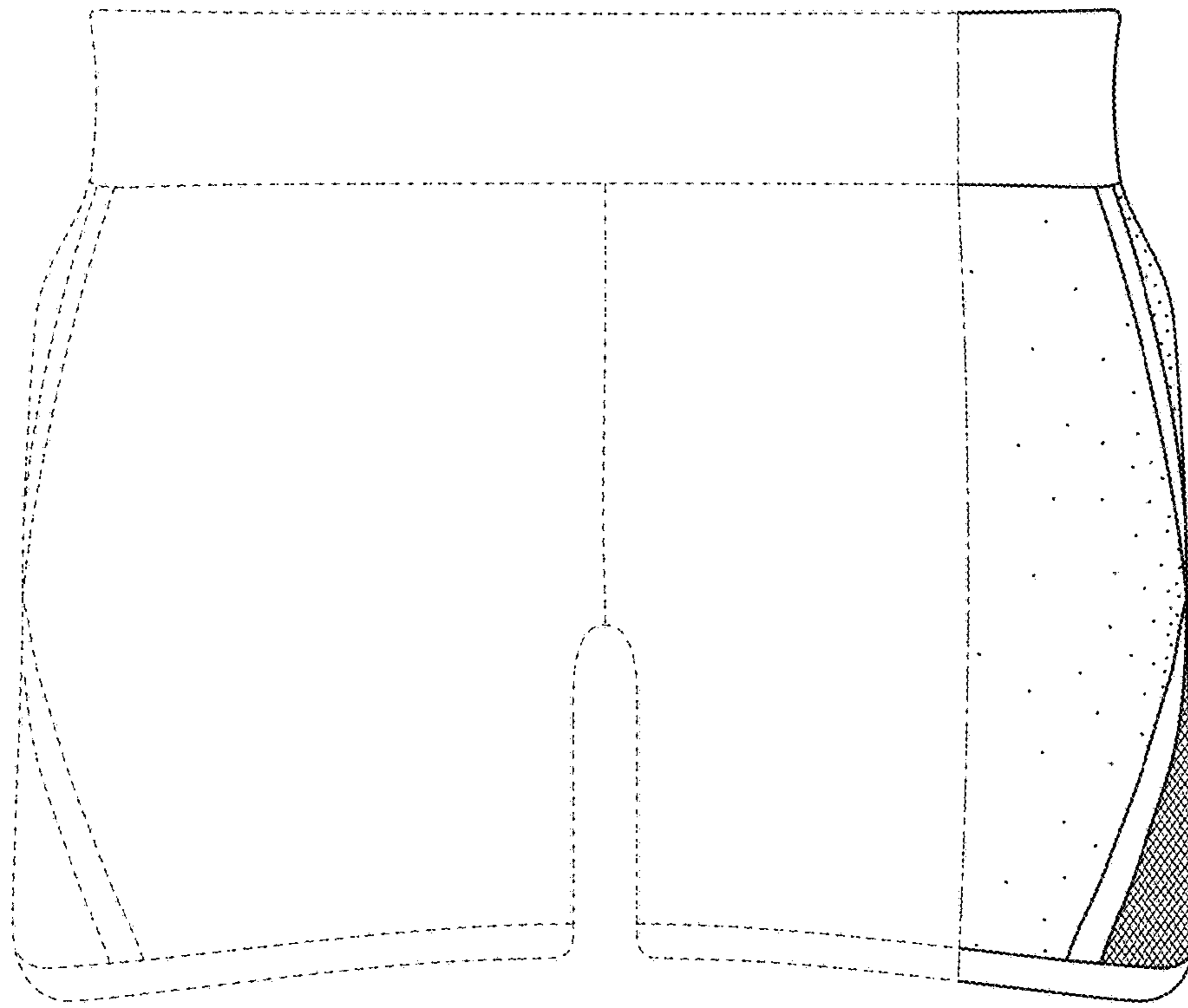

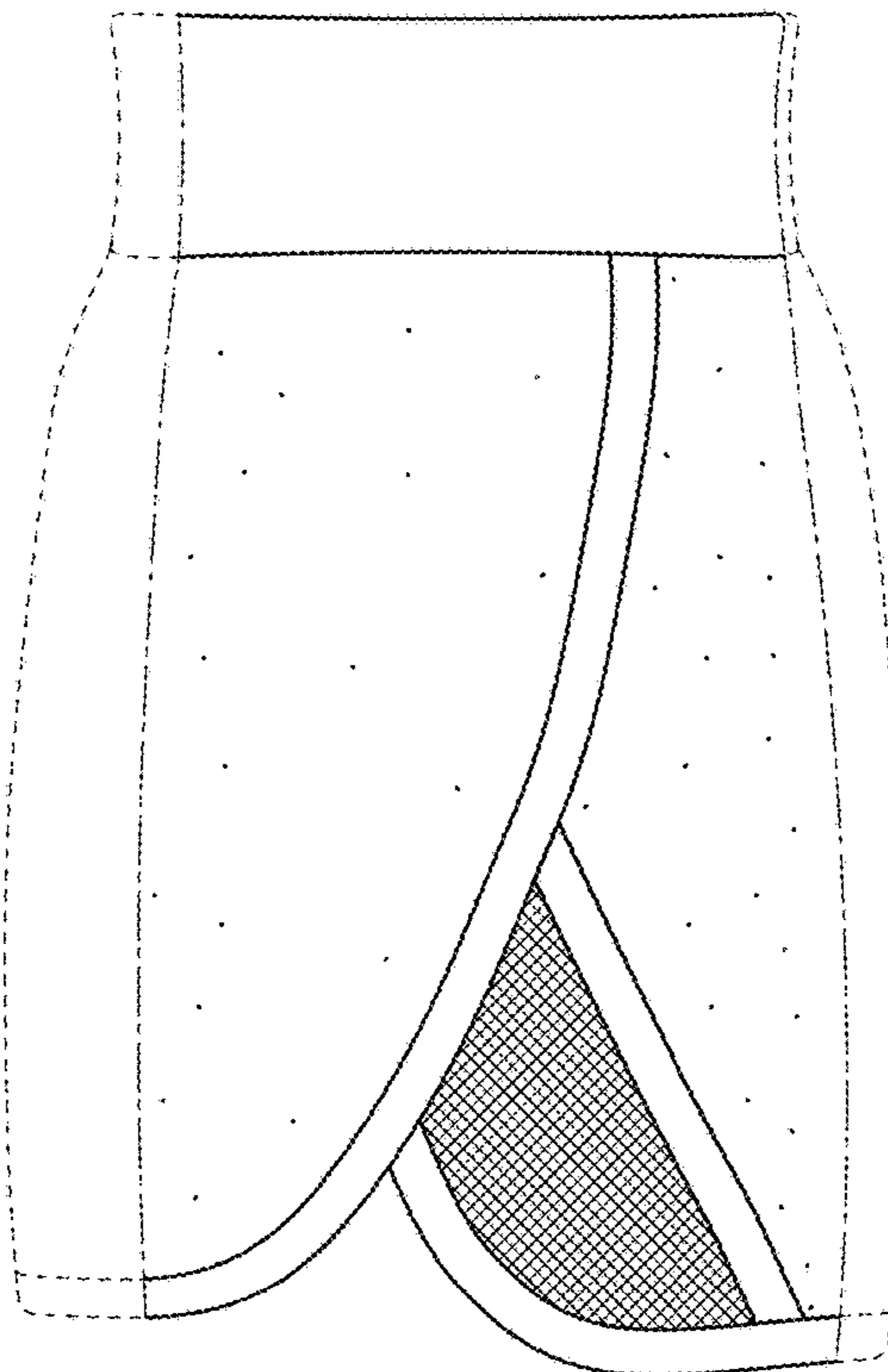

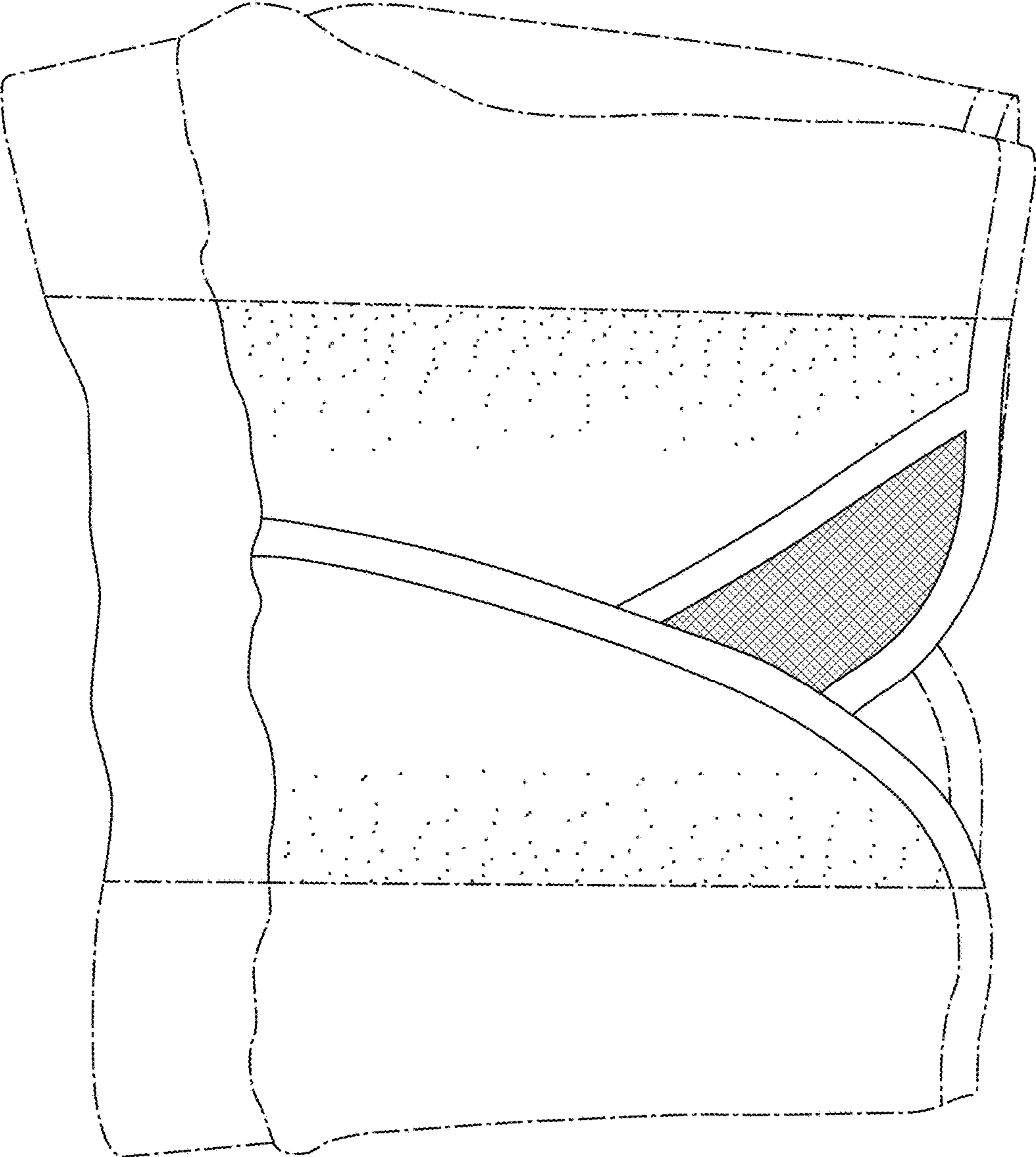
