DESCRIPTION

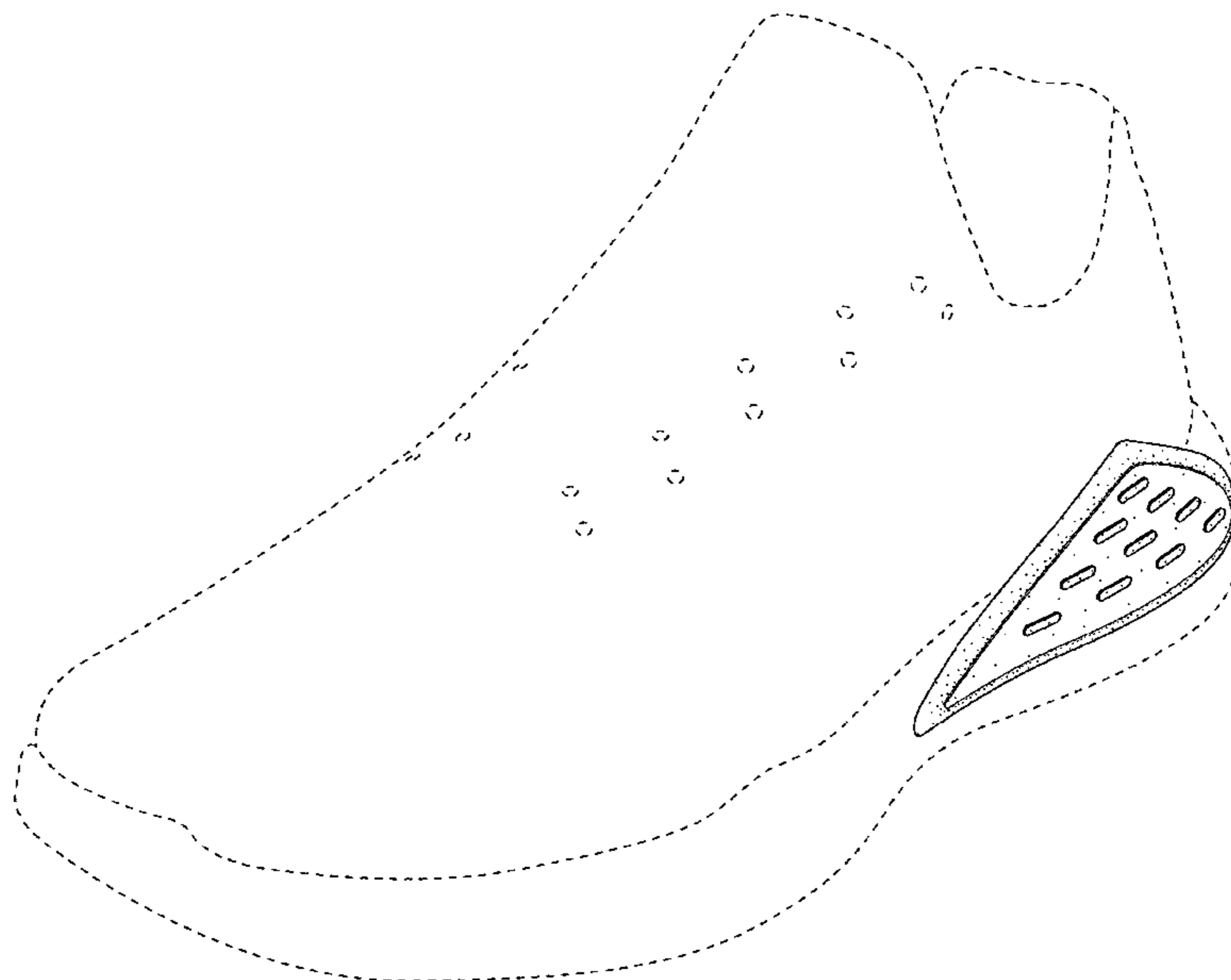
FIG. 1 is a front perspective view of a shoe showing my new design;

 The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

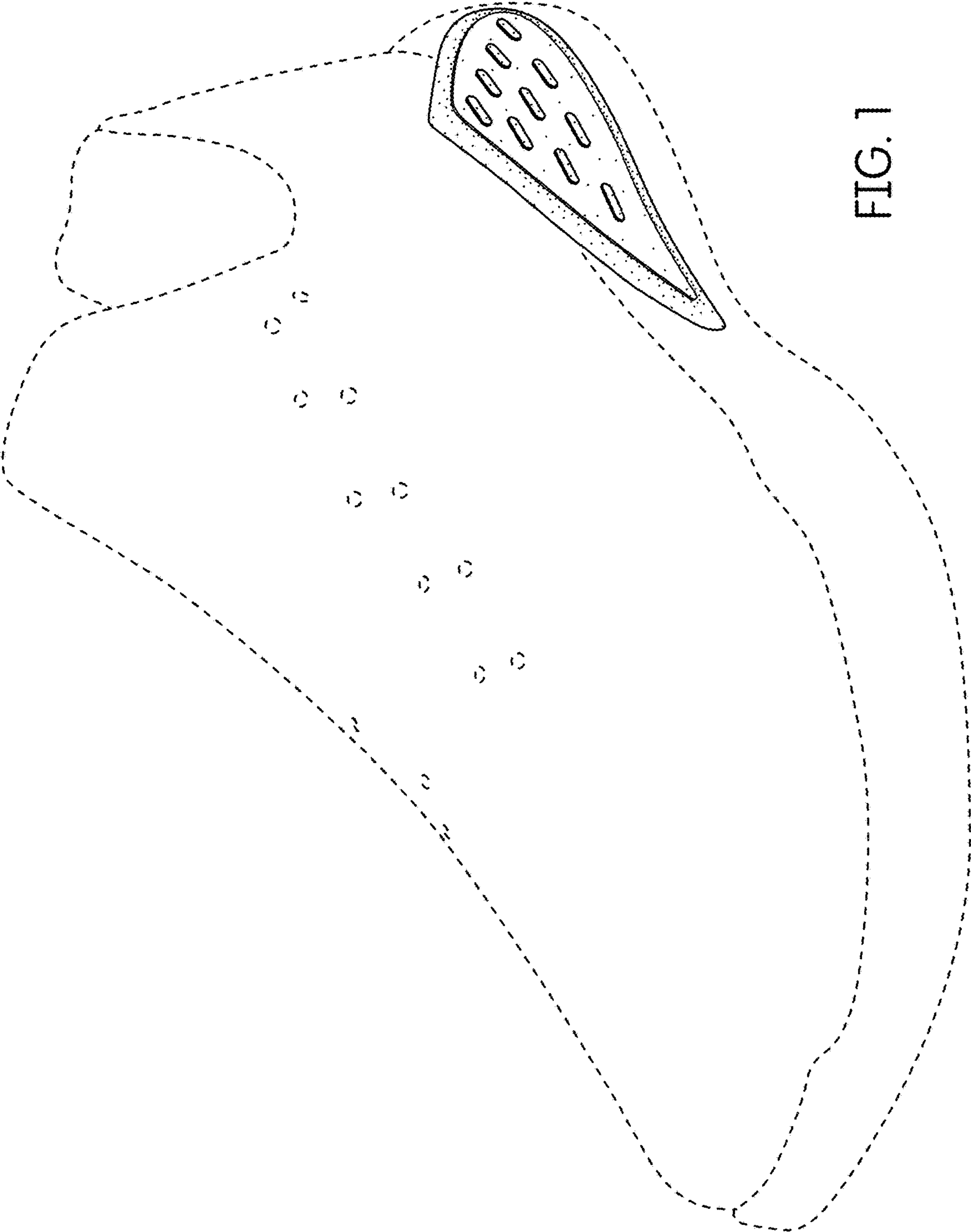

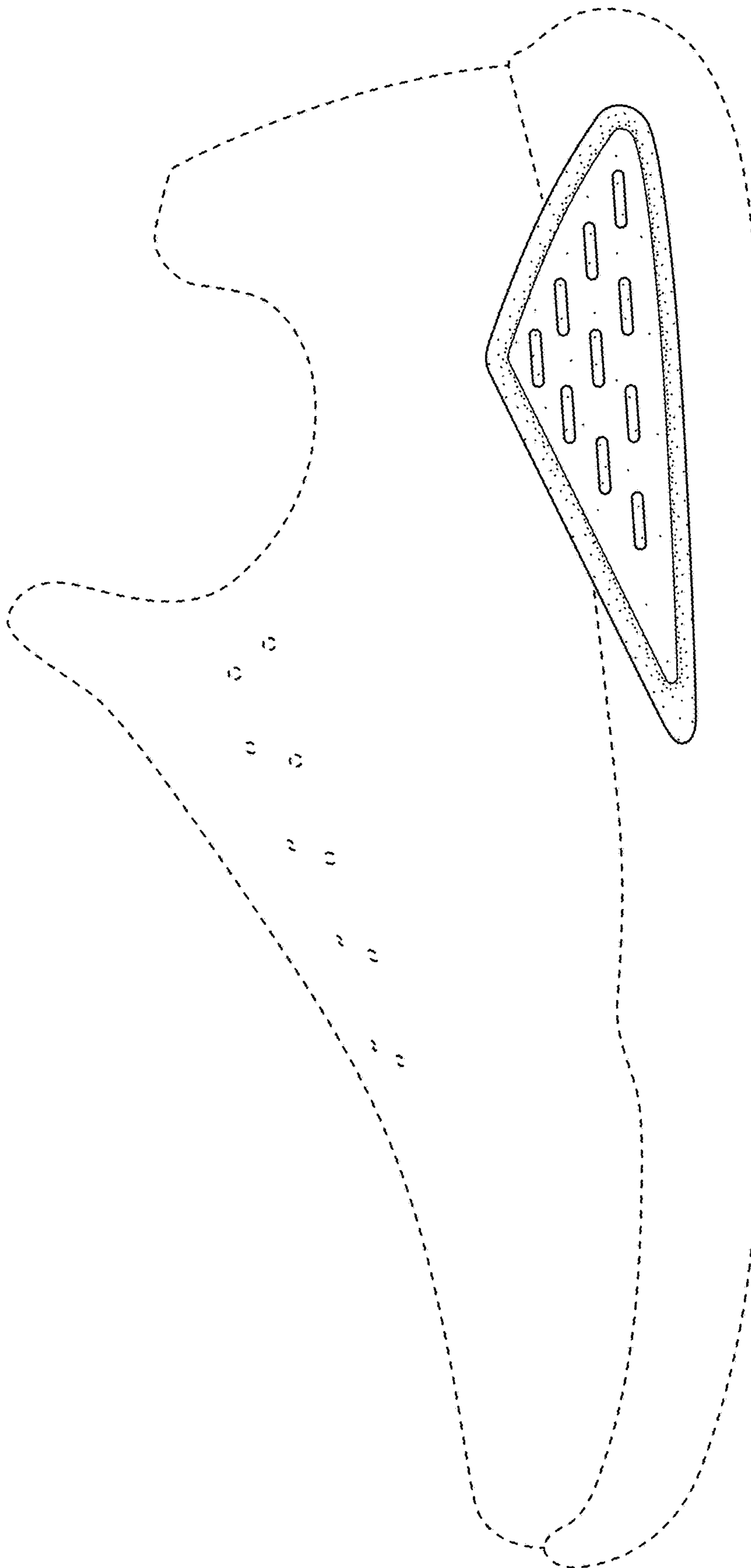

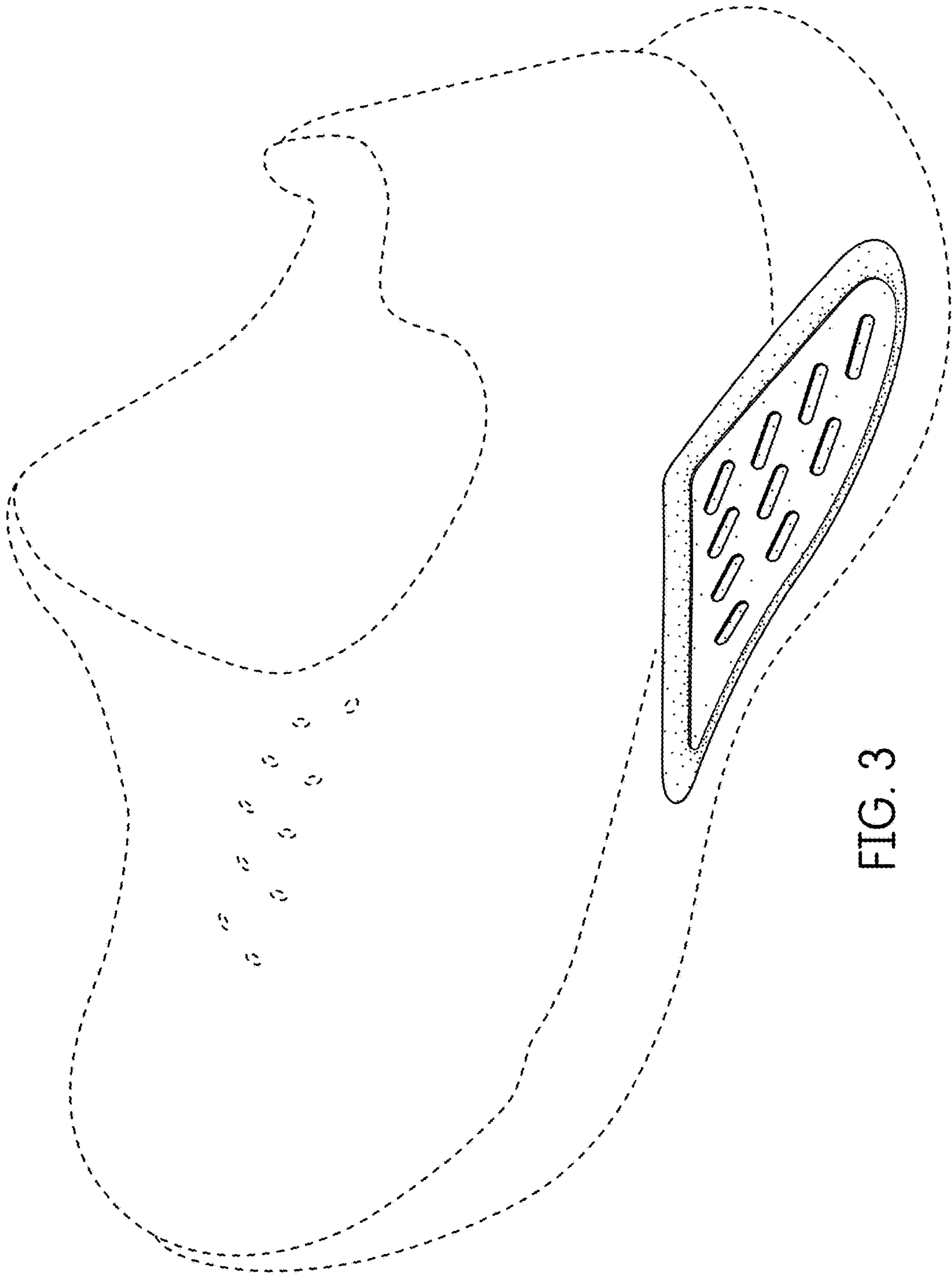
