
(57) **CLAIM**

The ornamental design for a storage container, as shown and described.

DESCRIPTION

FIG. 1 is a partially exploded perspective view of the storage container showing our new design; FIG. 2 is a fully collapsed front view thereof, where the rear view is a mirror image; FIG. 3 is a left-side view thereof, where the right-side view is a mirror image; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is another partially exploded perspective view thereof, where one of the bottom elements is shown in an open configuration and the remaining bottom elements are shown in a closed configuration.










