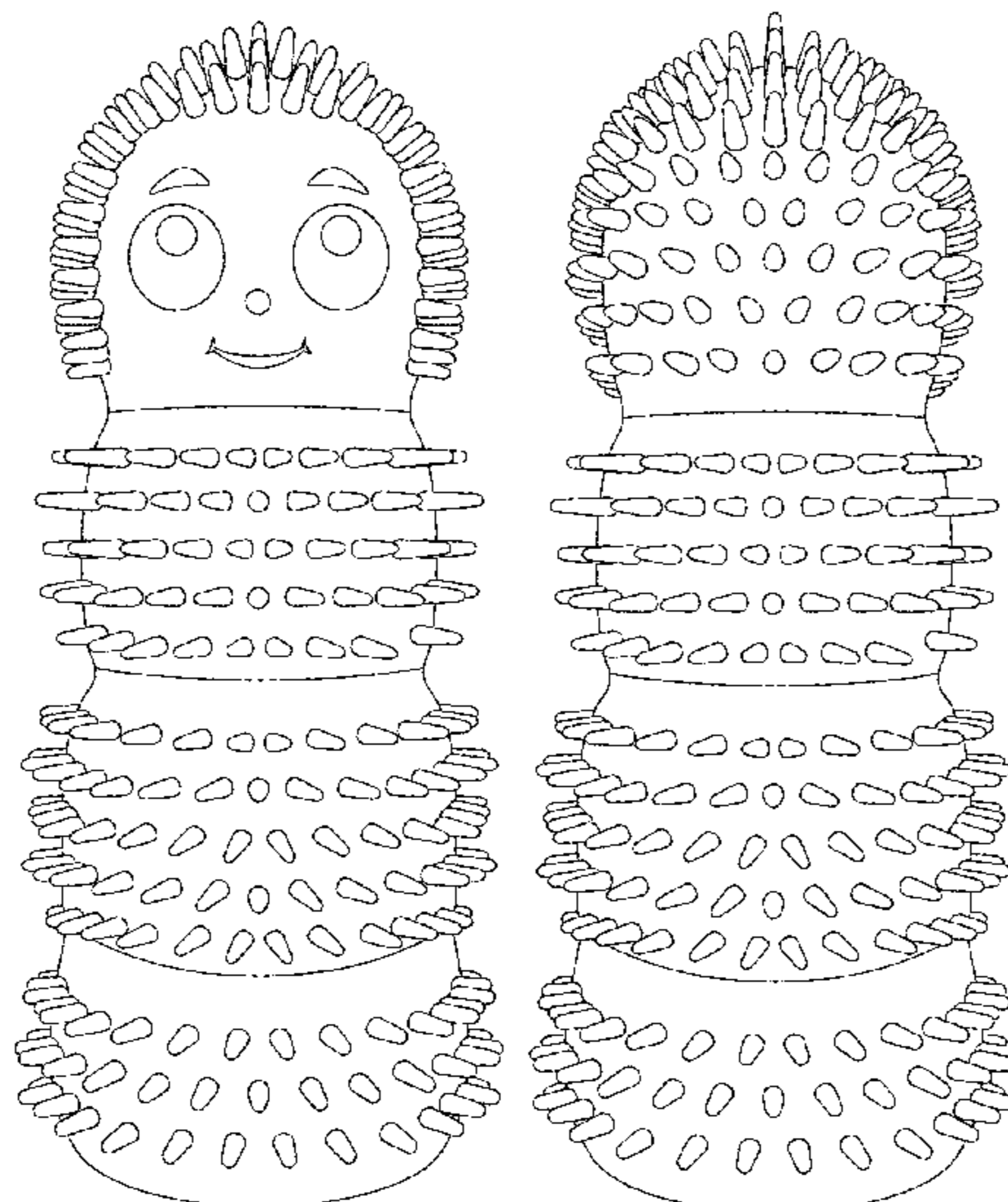
(57) **CLAIM**

We claim the ornamental design for a finger mounted
toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a finger mounted
toothbrush showing our new design;
FIG. 2 is a rear perspective view of the finger mounted
toothbrush of FIG. 1;
FIG. 3 is a right side perspective view of the finger mounted
toothbrush of FIG. 1;
FIG. 4 is a left side perspective view of the finger mounted
toothbrush of FIG. 1;
FIG. 5 is a top plan view of the finger mounted
toothbrush of FIG. 1;
FIG. 6 is a bottom plan view of the finger mounted tooth-
brush of FIG. 1;
FIG. 7 is a top/front perspective view of the finger mounted
toothbrush of FIG. 1;
FIG. 8 is a bottom/rear perspective view of the finger
mounted toothbrush of FIG. 1; and,
FIG. 9 is a view of the finger mounted toothbrush in use,
with environment (the unclaimed user's hand and the
unclaimed dog) depicted in broken lines.
The long-short dashed broken lines shown in FIGS. 6 and 8
illustrate the bounds of the claimed design and form no part
thereof.

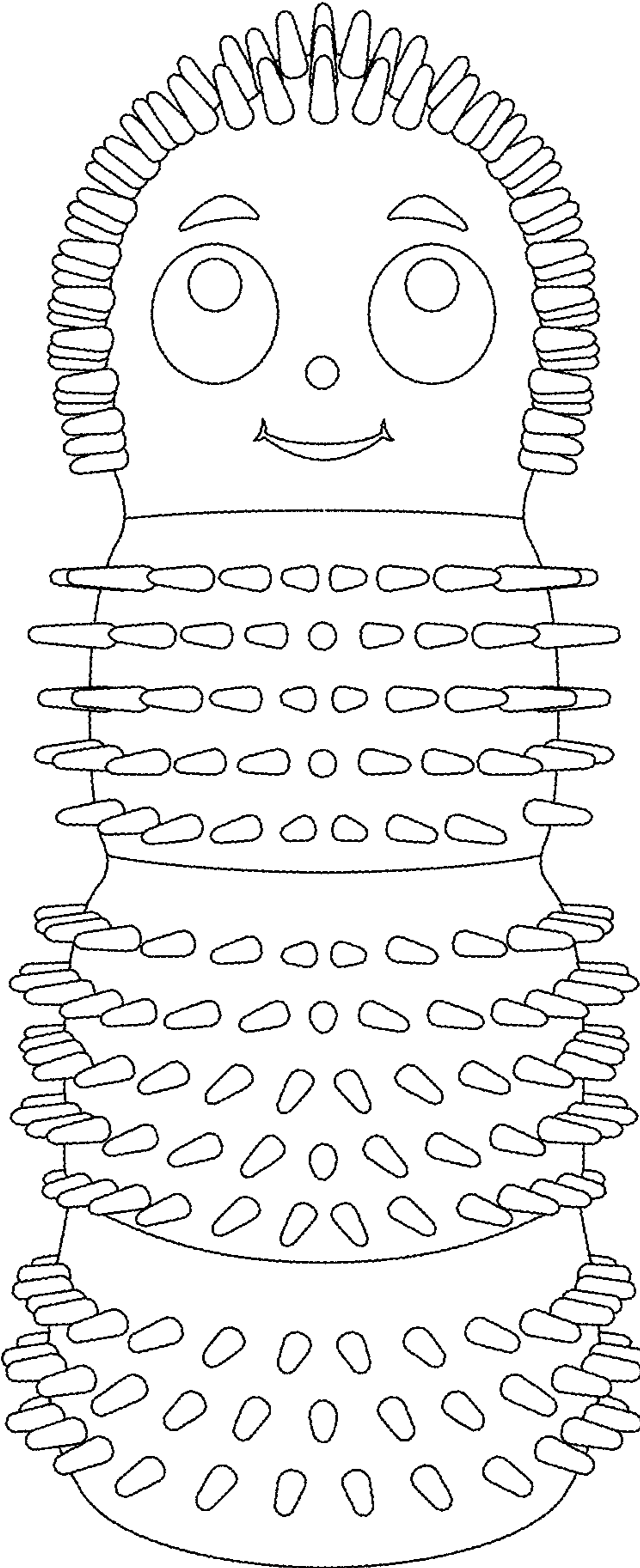

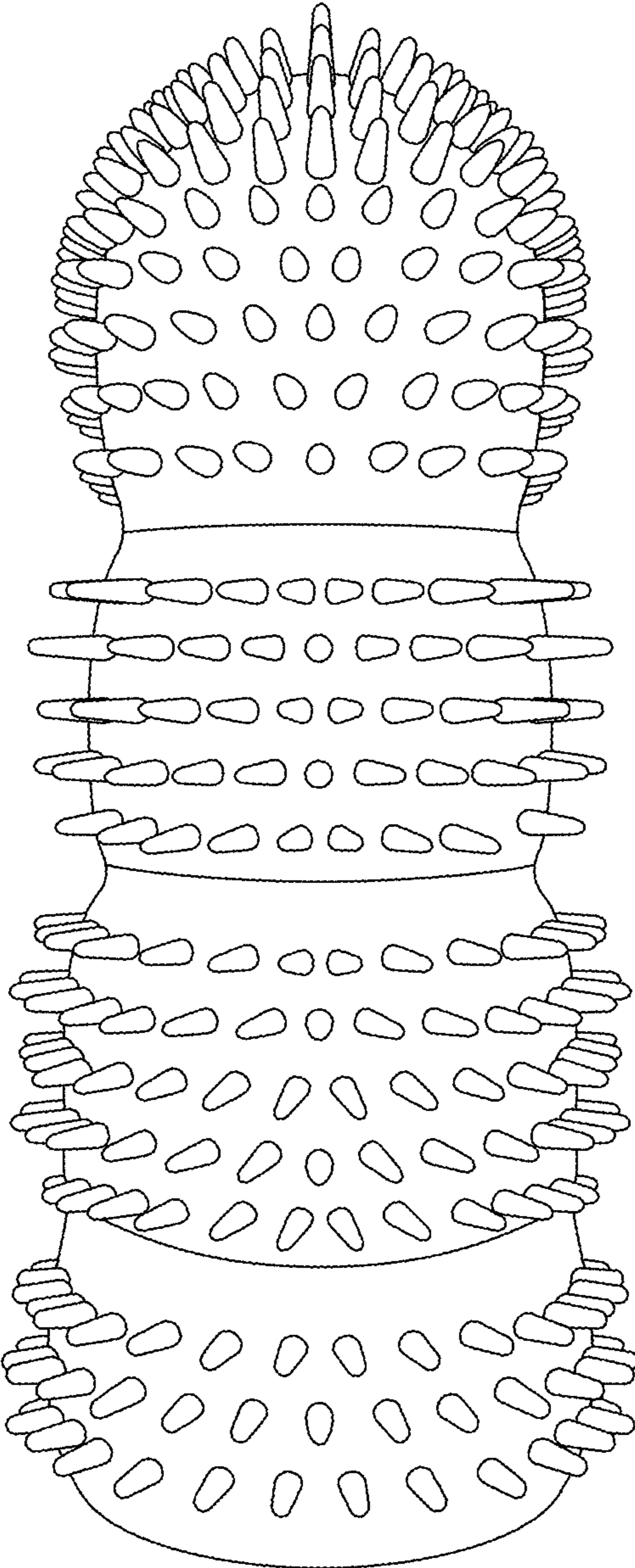

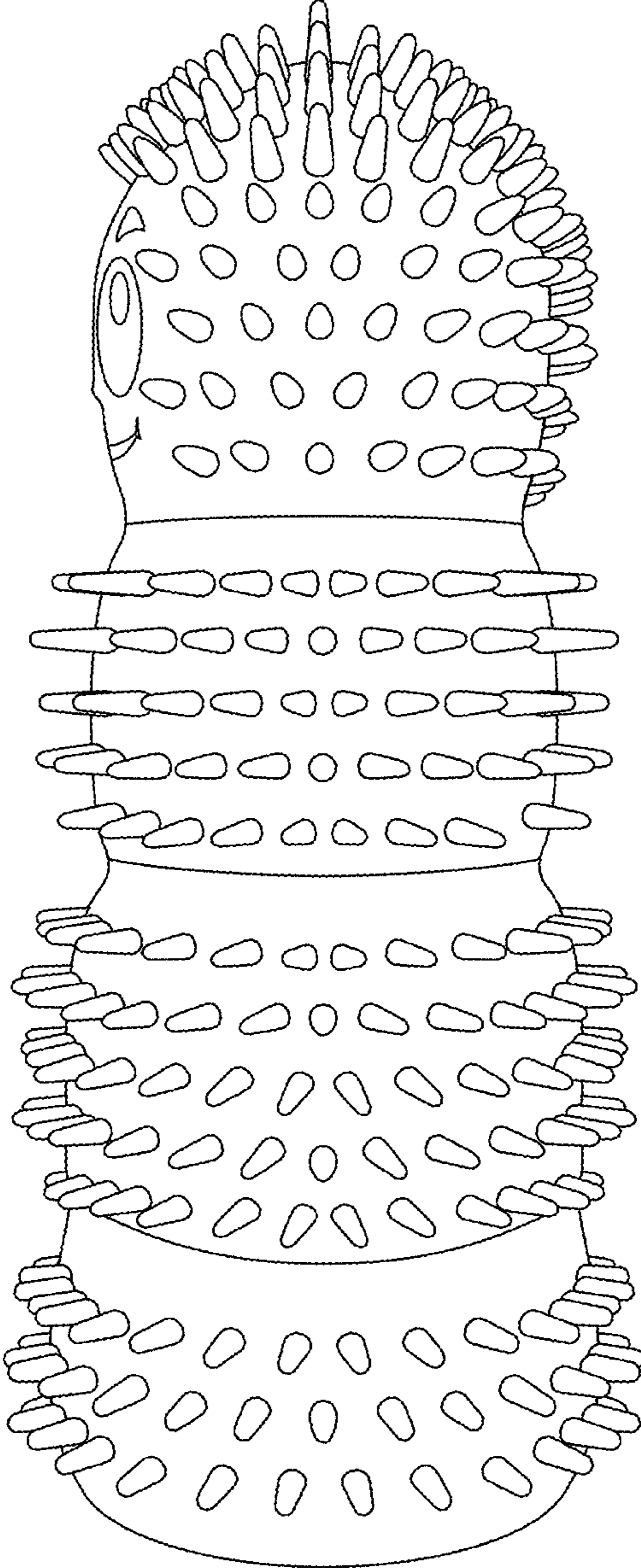

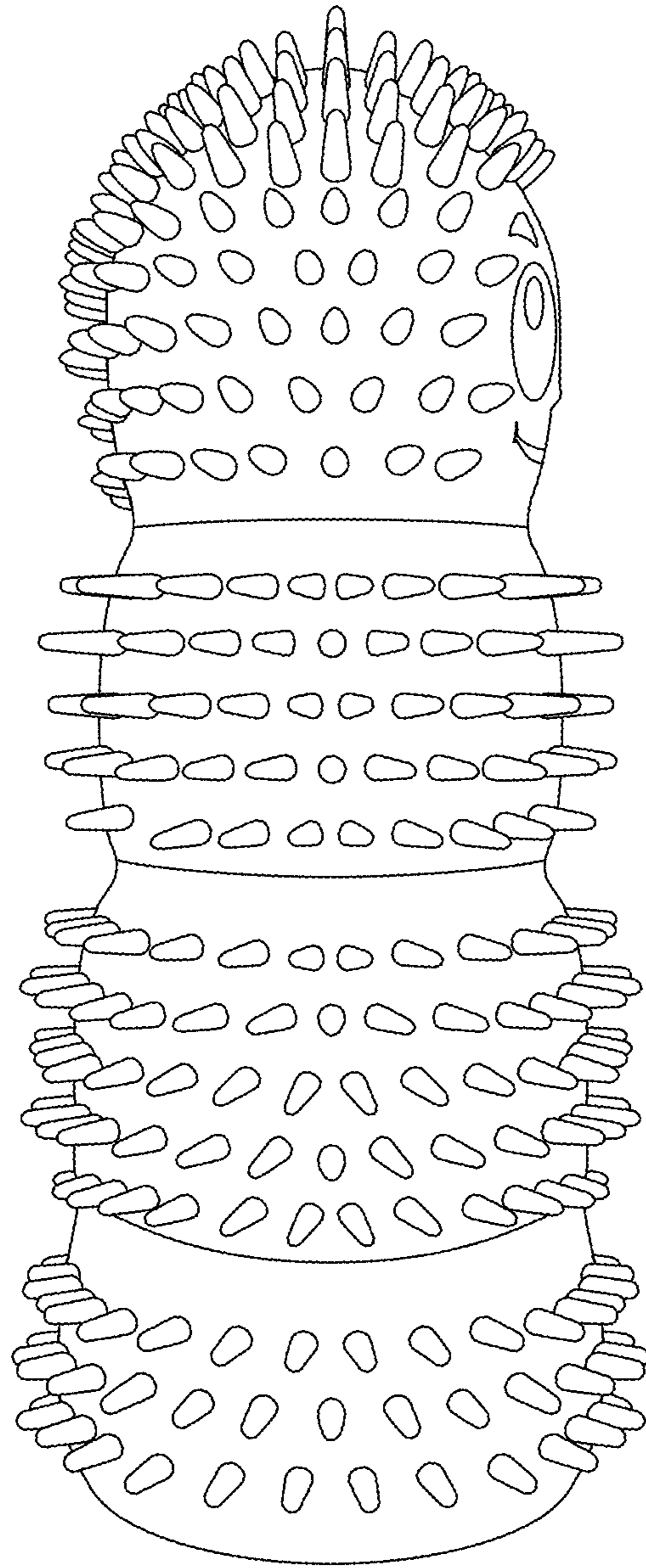

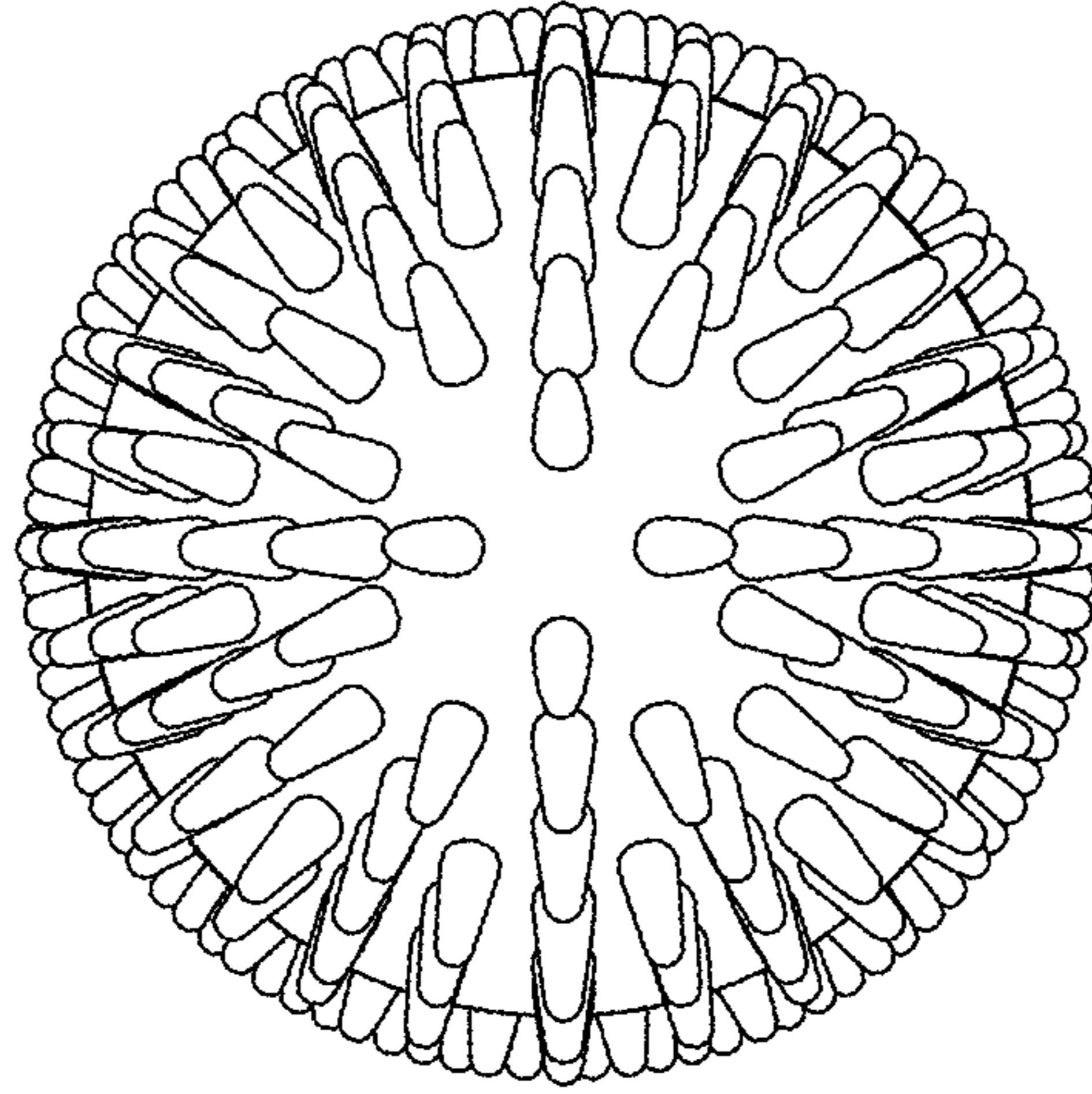

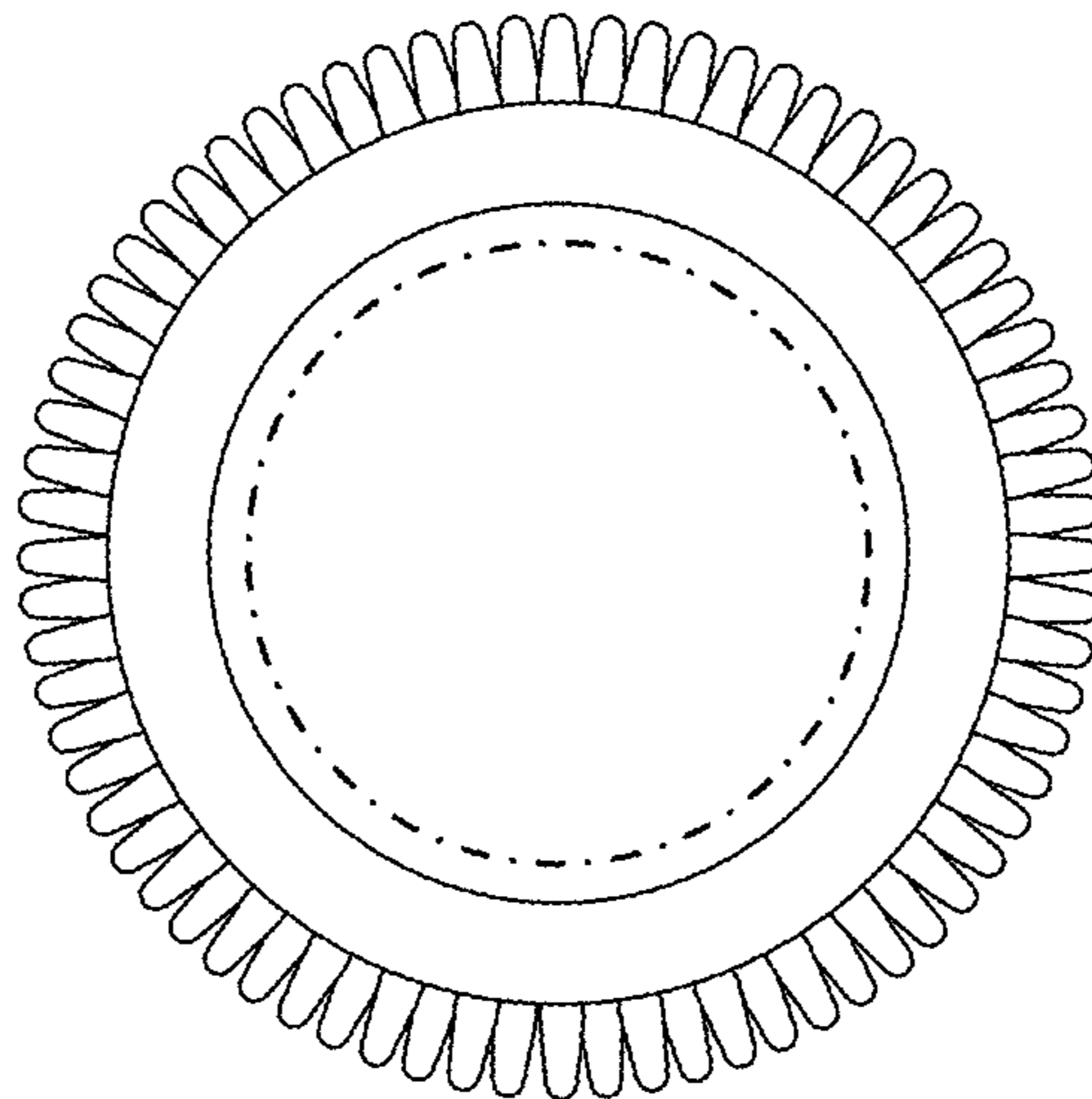

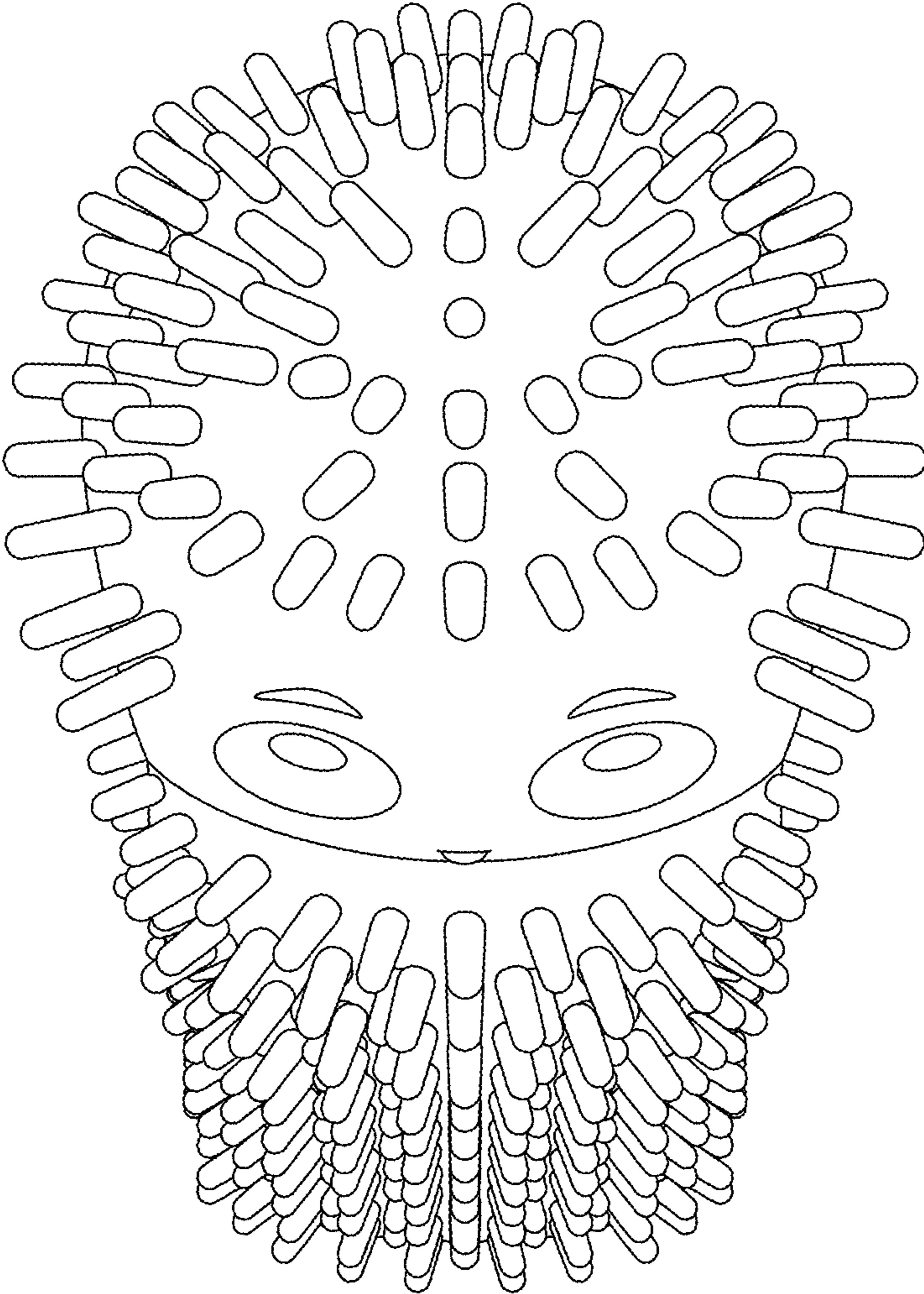

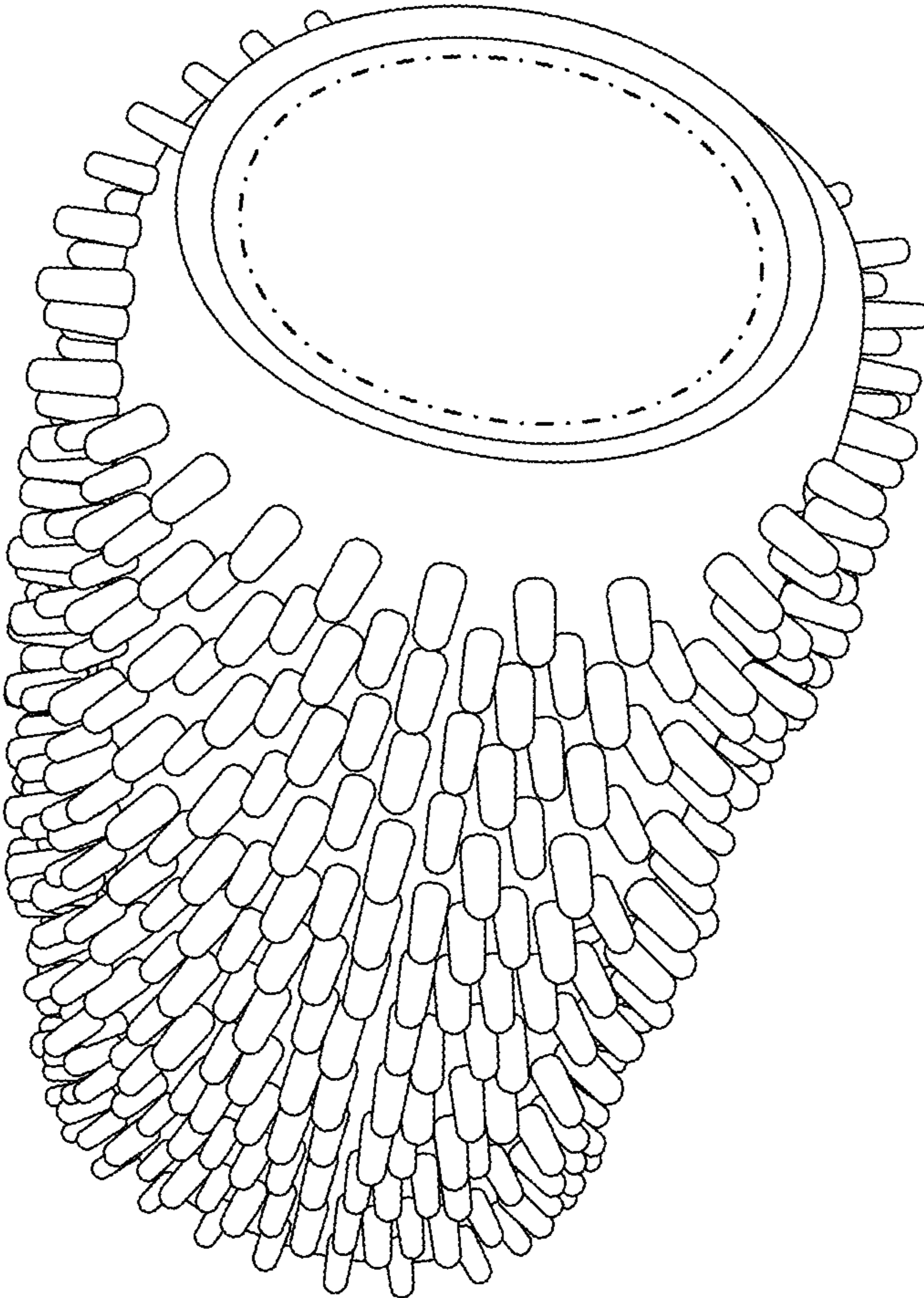

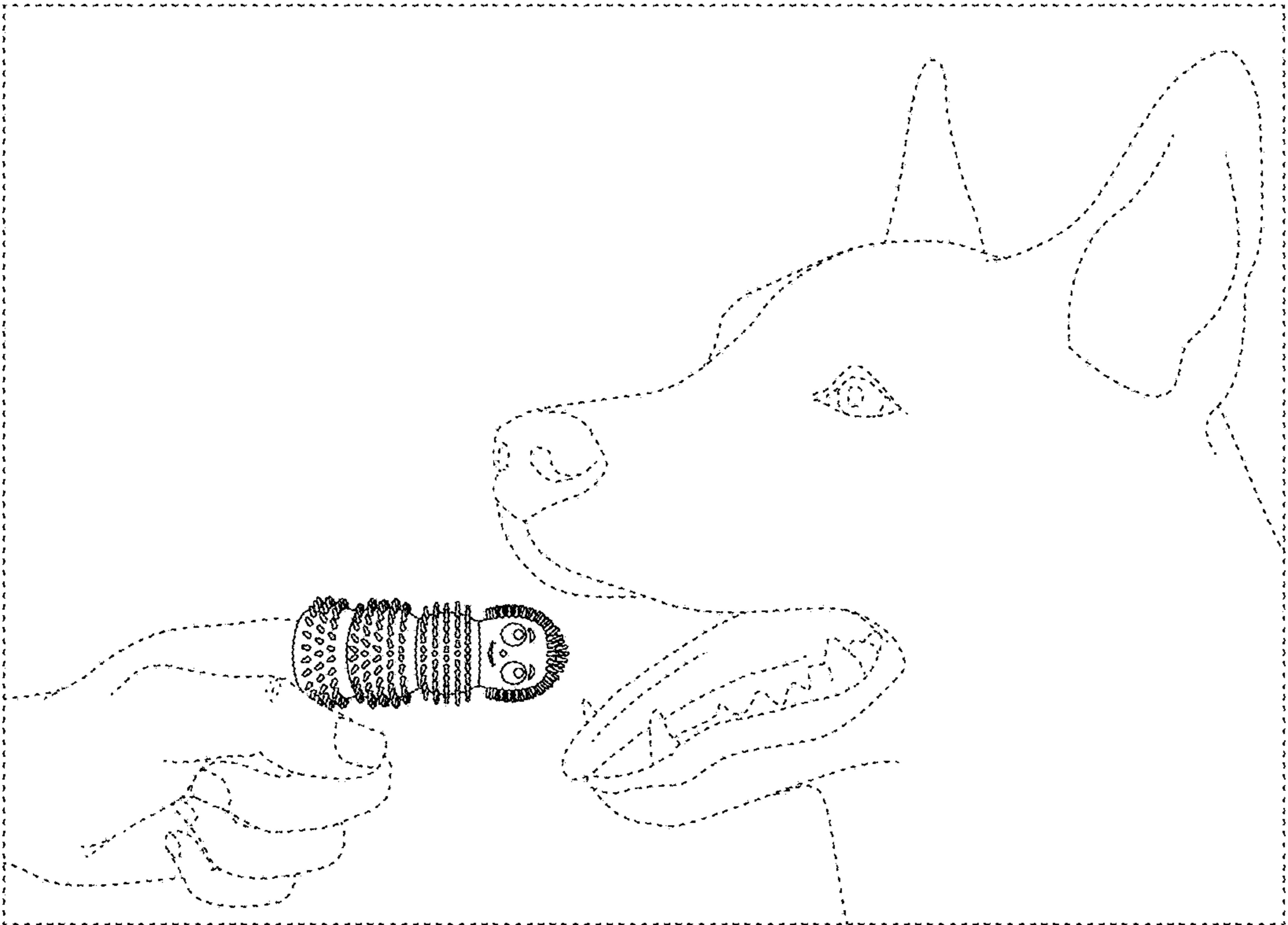
