DESCRIPTION

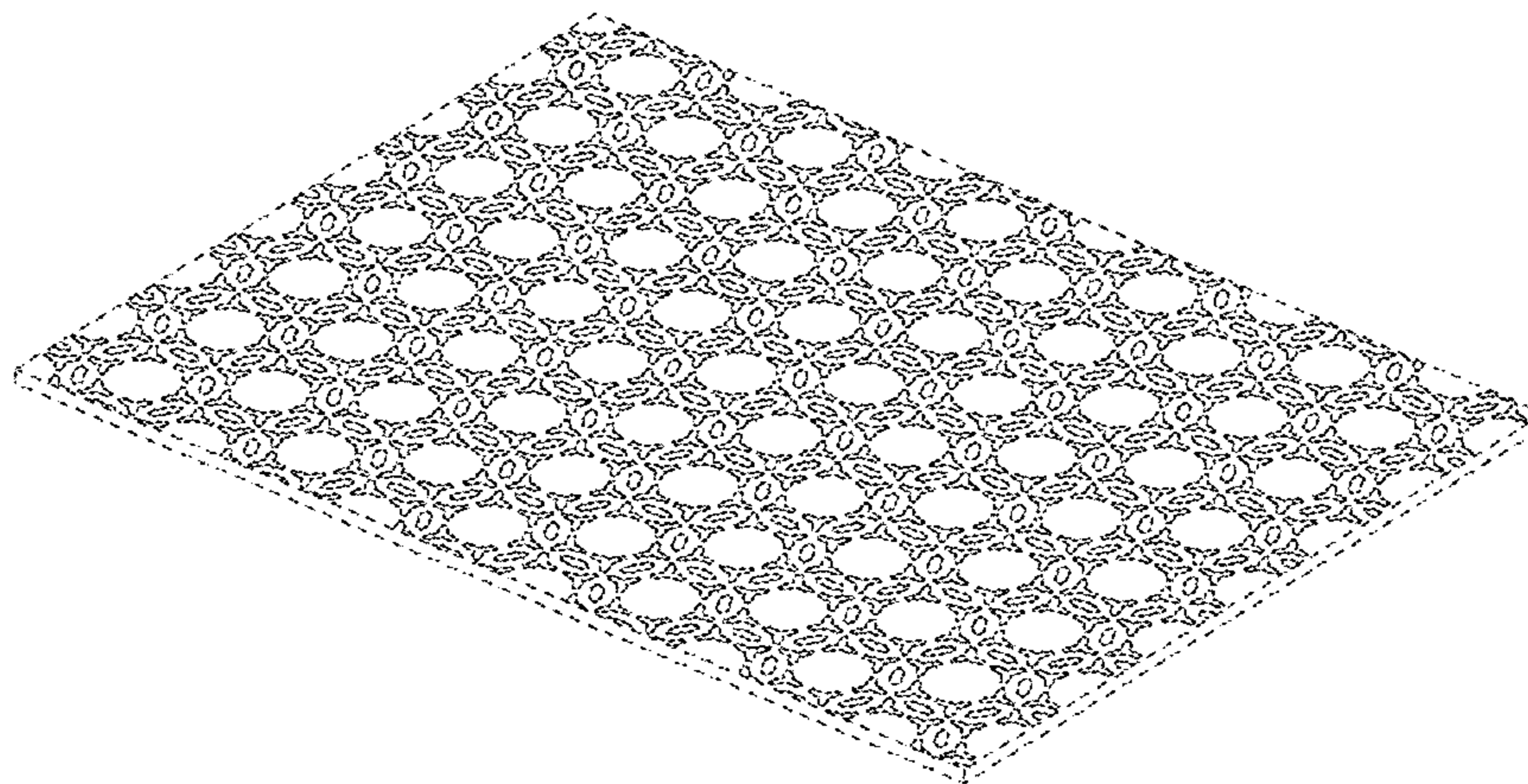
FIG. 1 is a front, bottom and left perspective view of a sheet material according to my new design; and, FIG. 2 is a front view thereof.

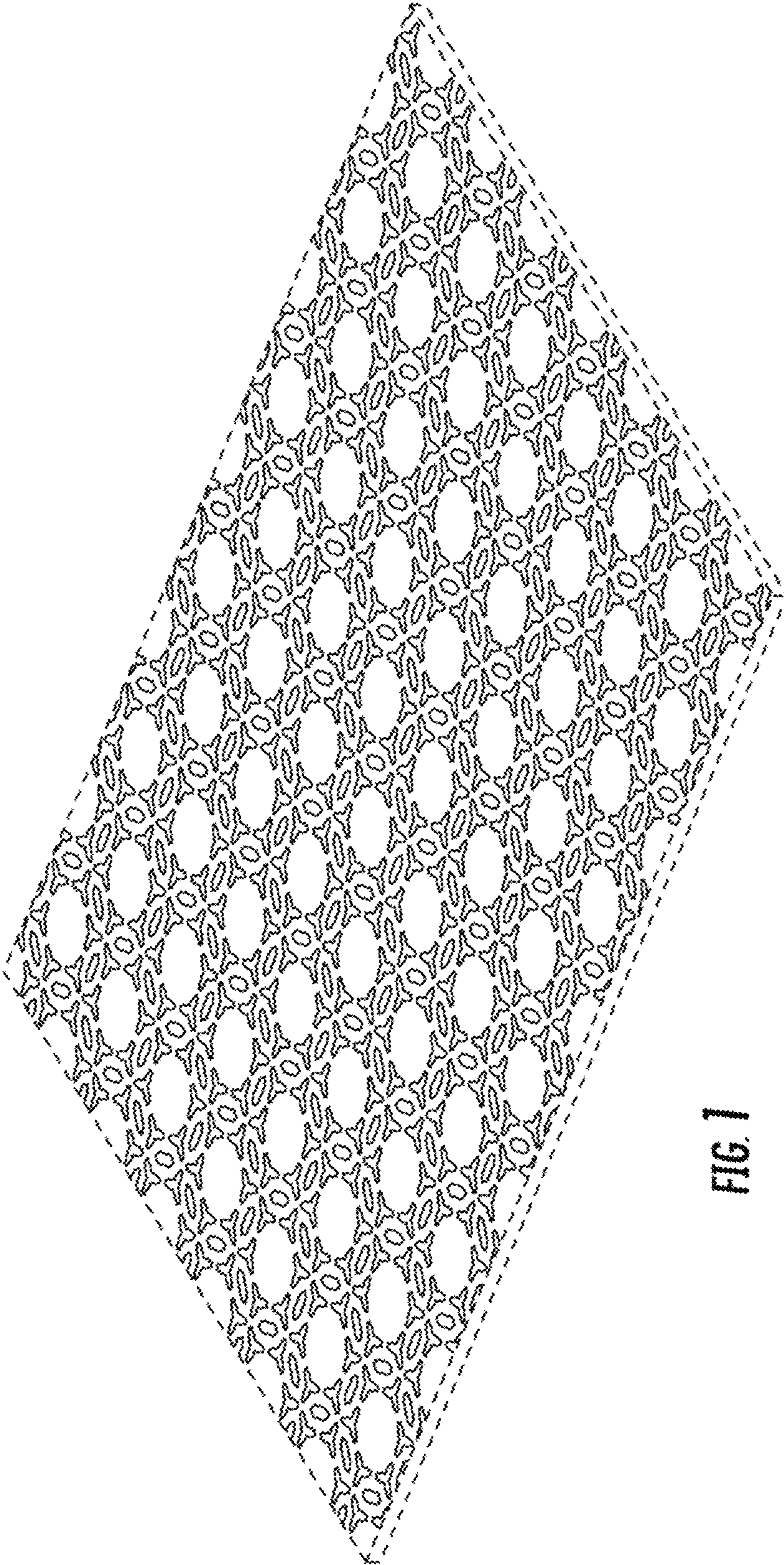

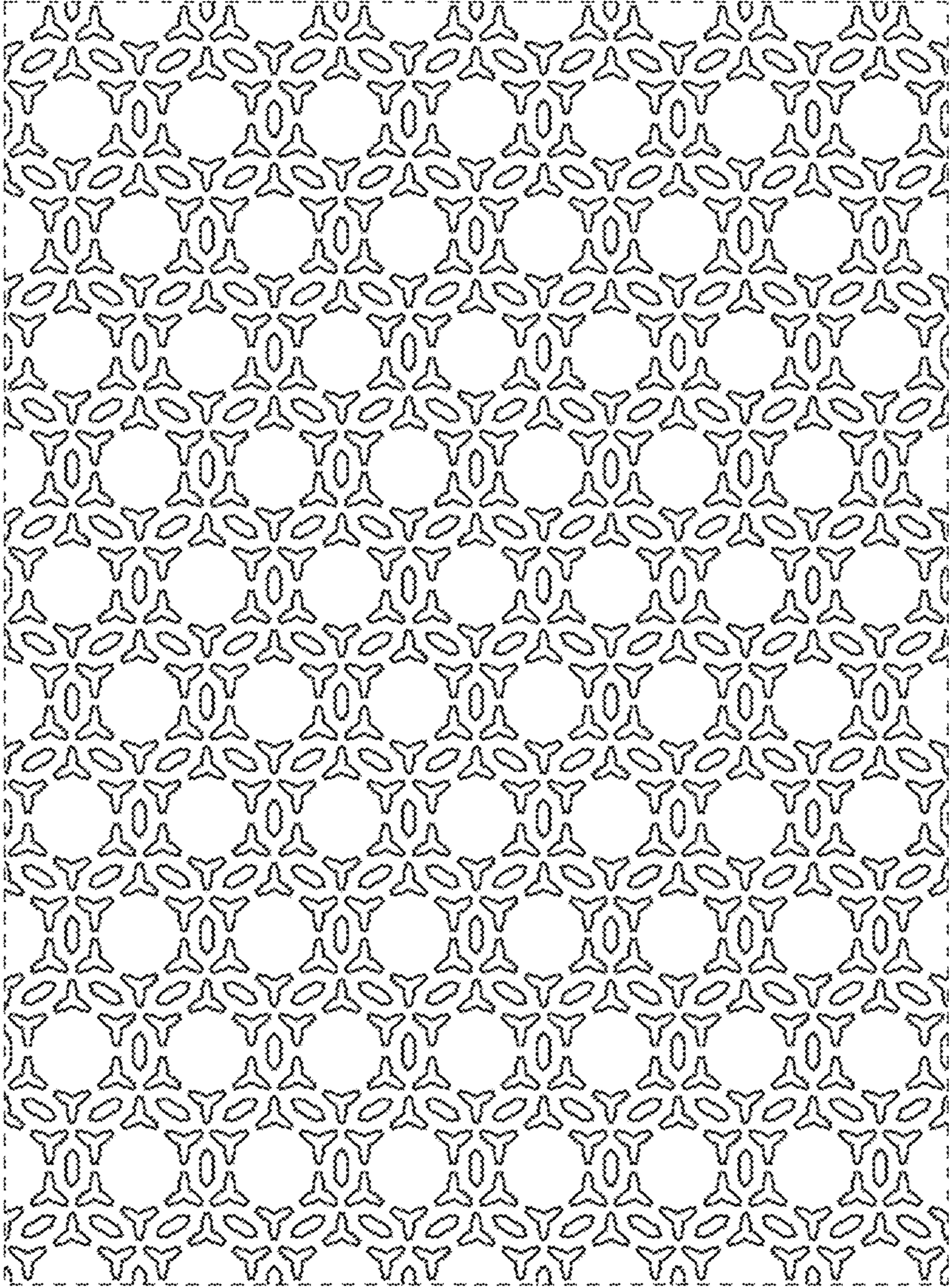
