(57) **CLAIM**

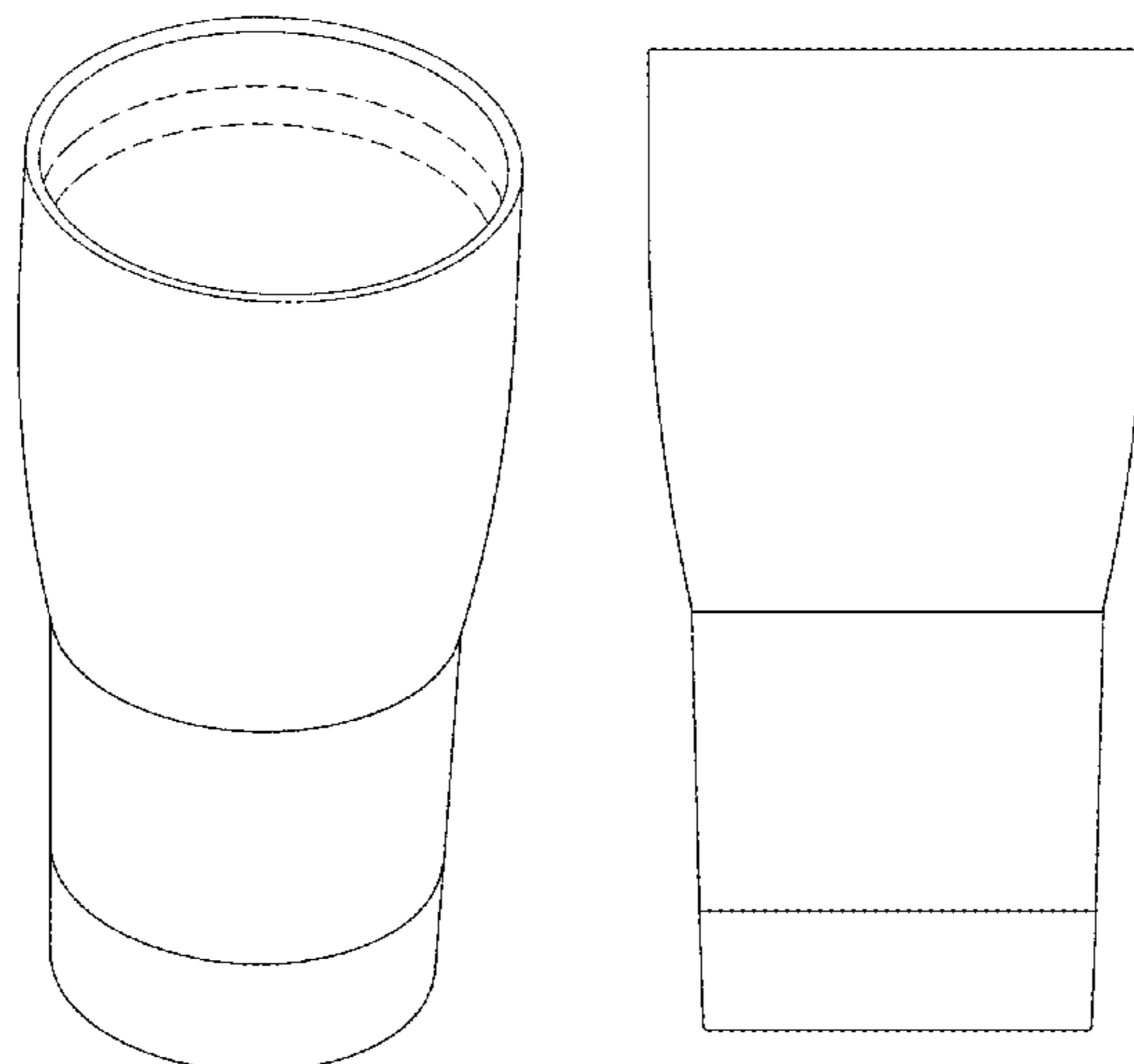
We claim the ornamental design for a tumbler, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a tumbler showing our new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a side view thereof, all side views being the same;  
FIG. 4 is a bottom view thereof; and,  
FIG. 5 is an enlarged sectional view thereof taken along the line 5-5 in FIG. 2.  
The broken lines in the drawings depict portions of the tumbler that form no part of the claimed design.

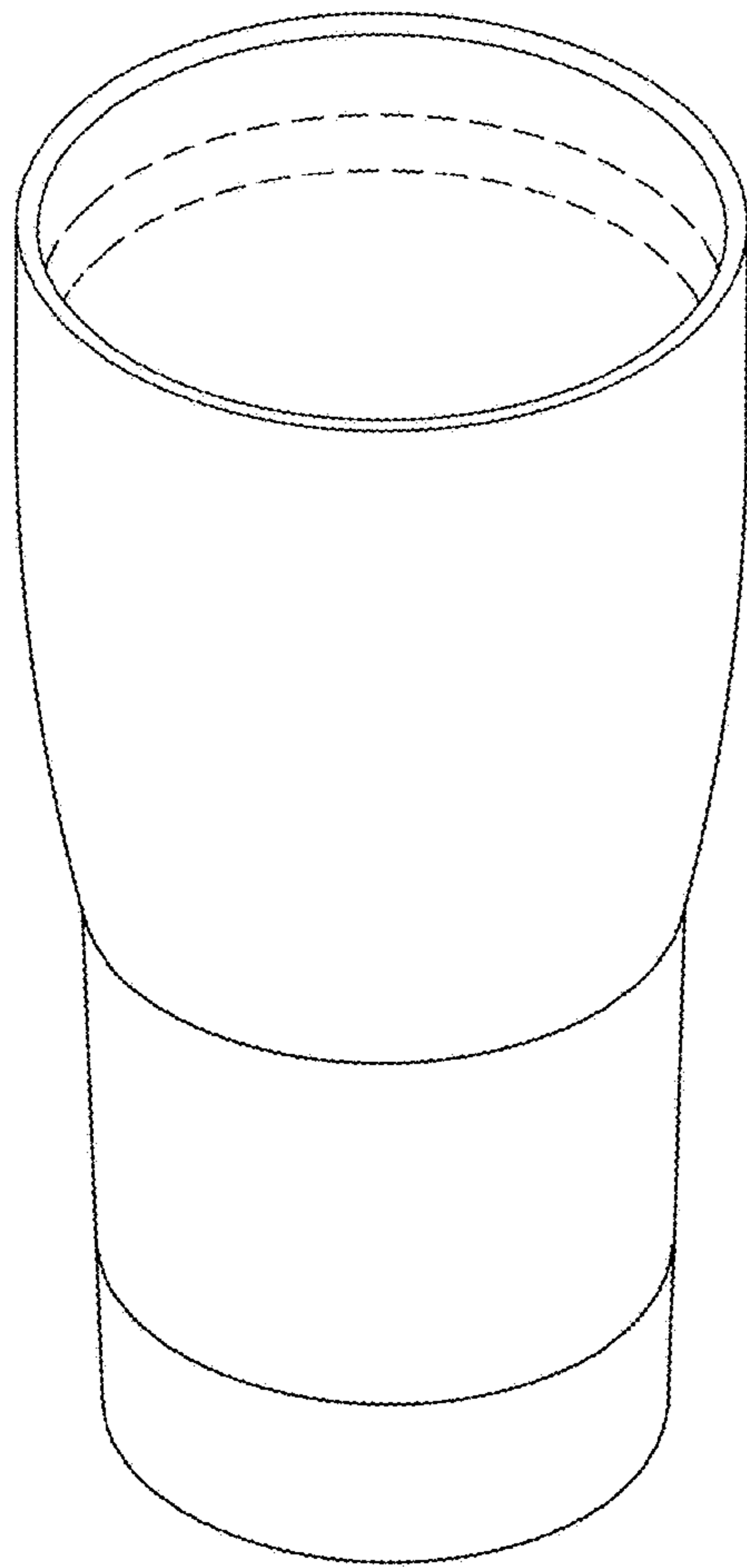

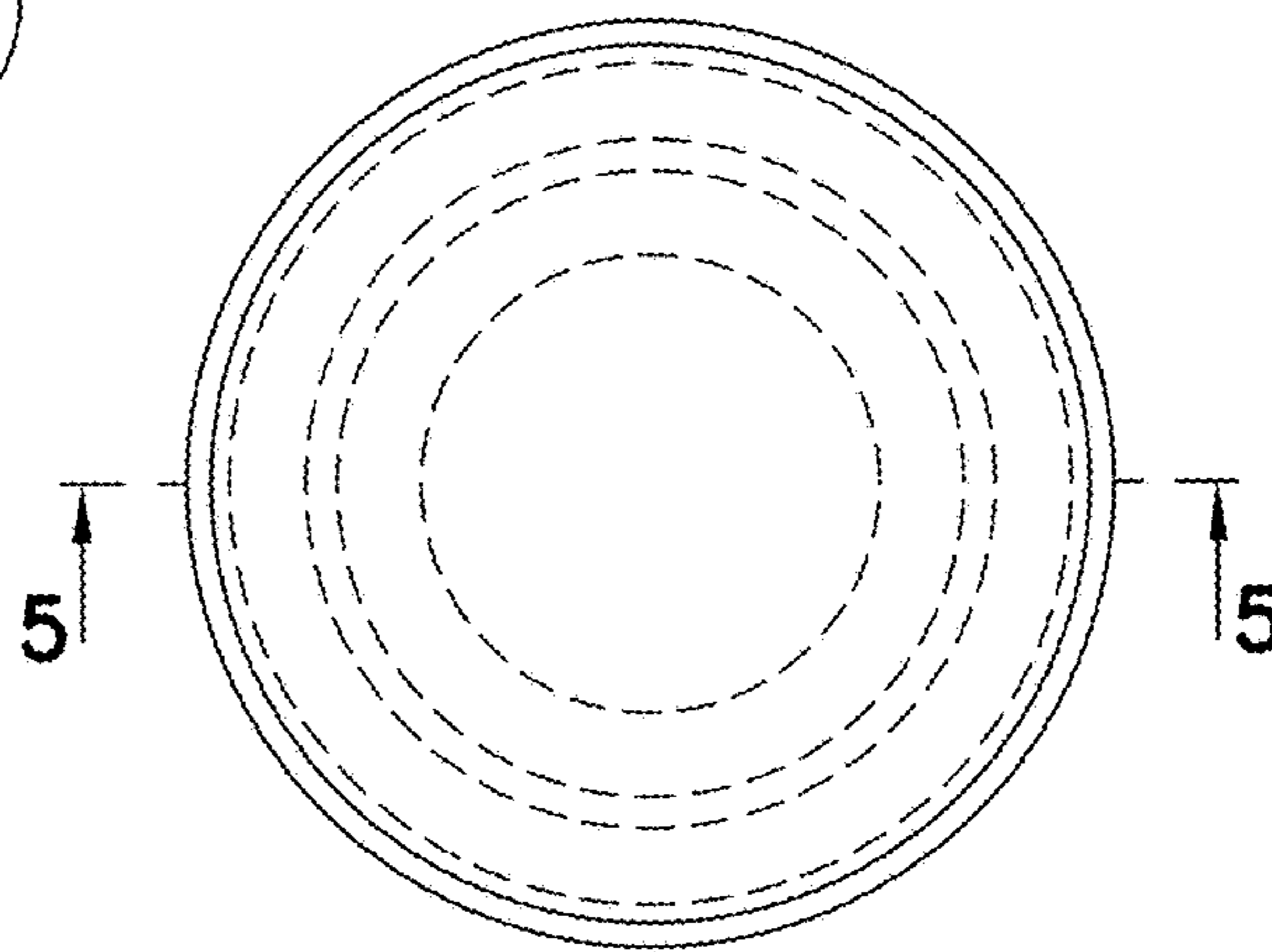

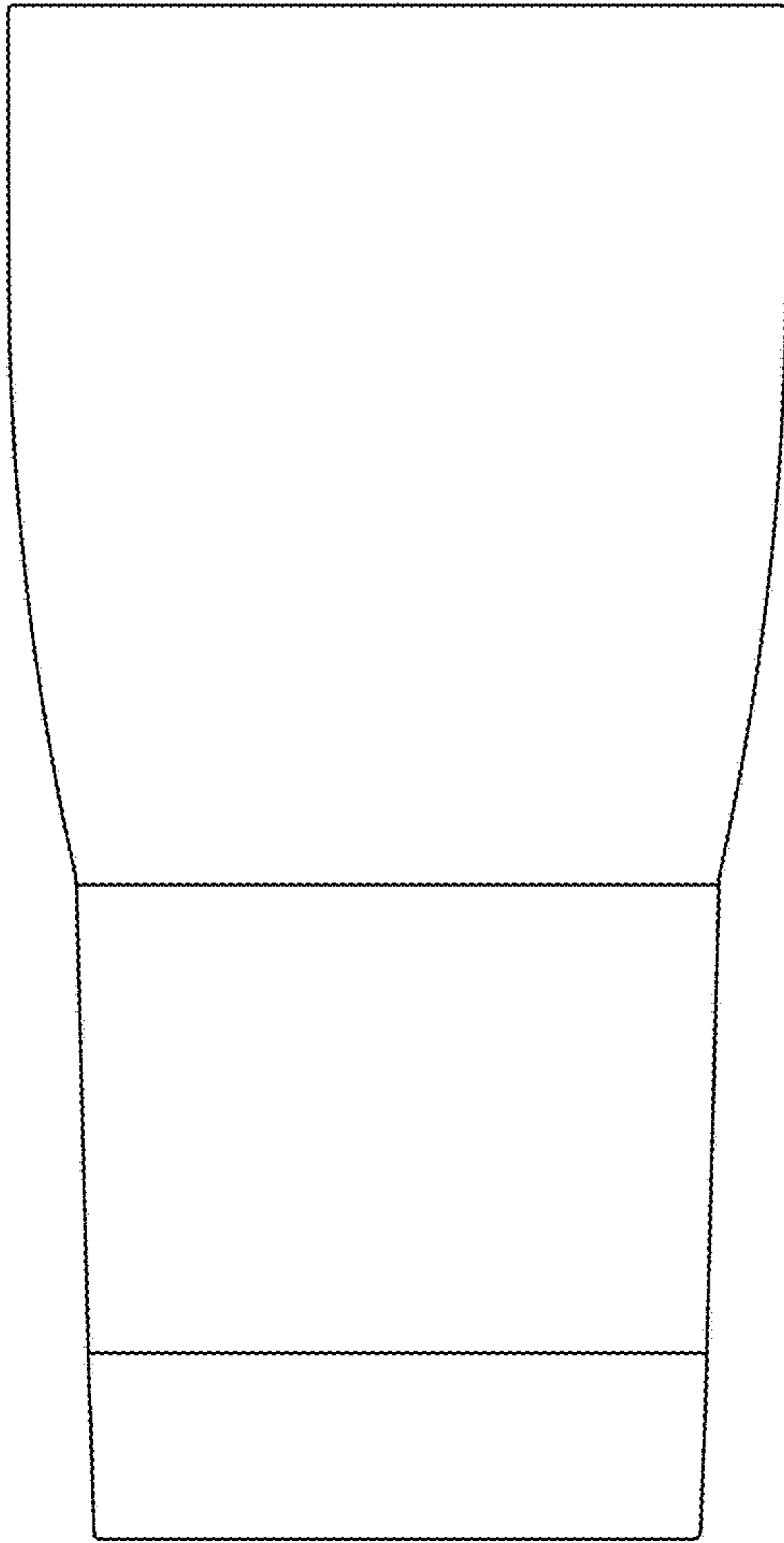

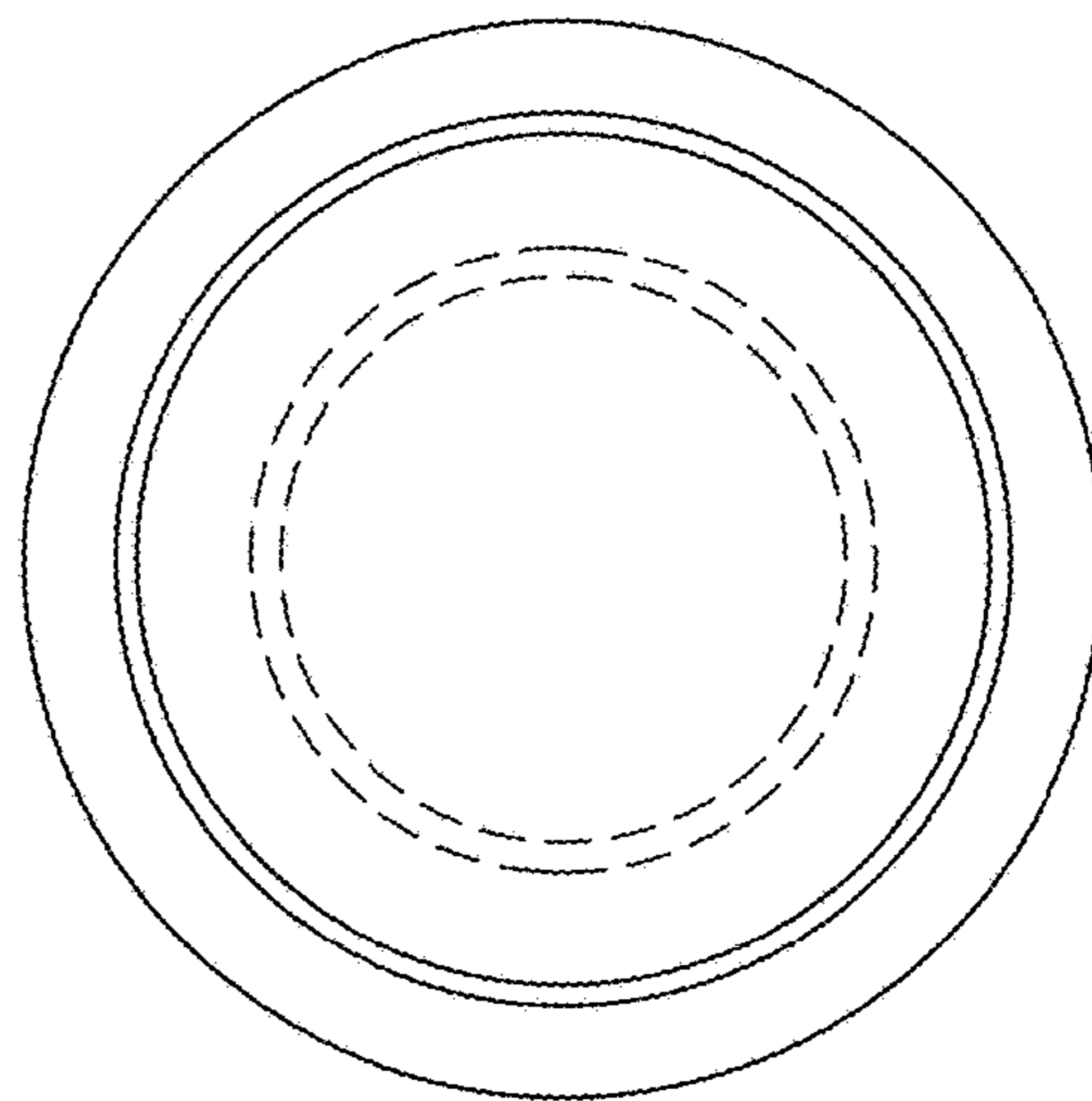

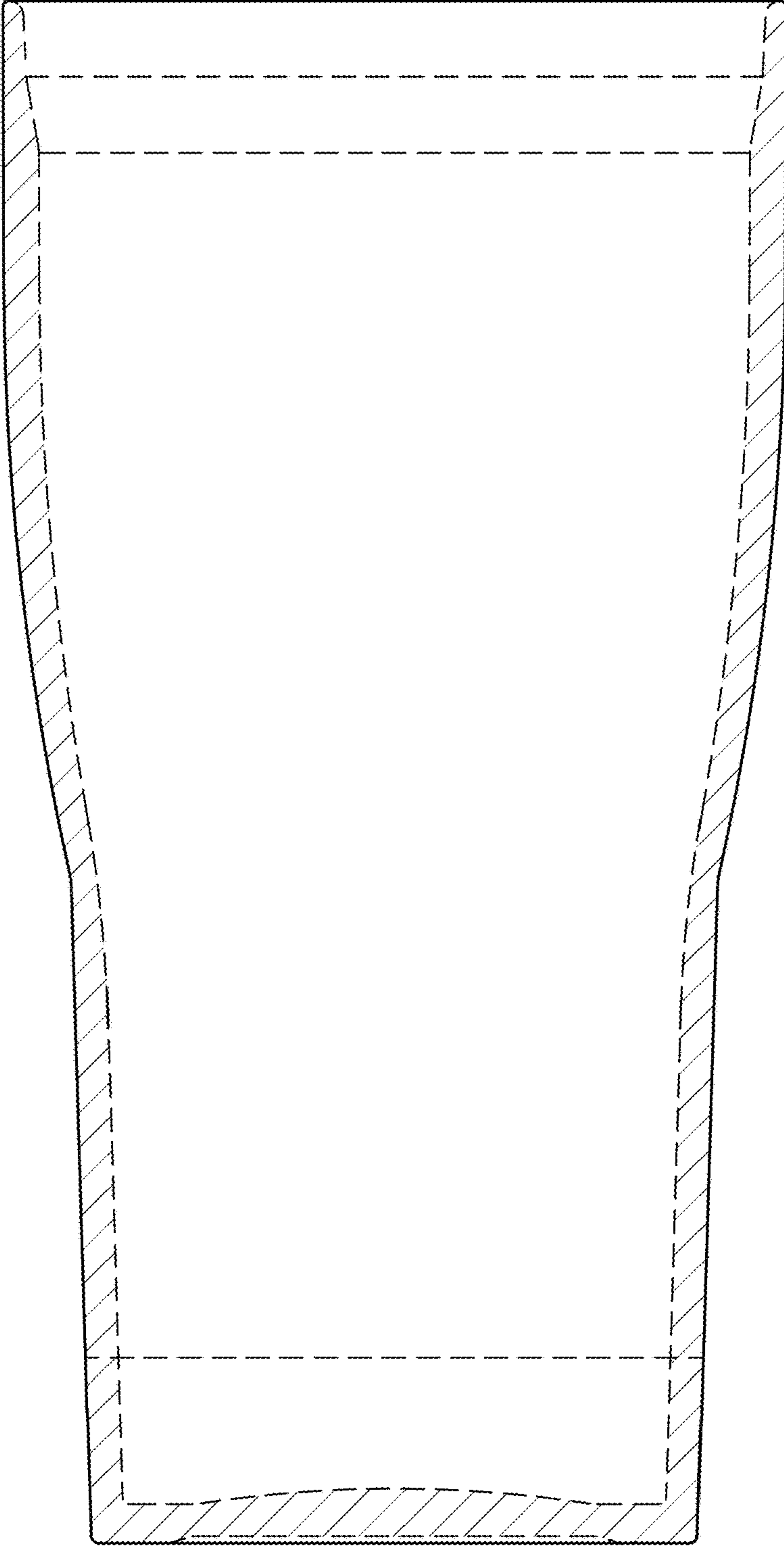
