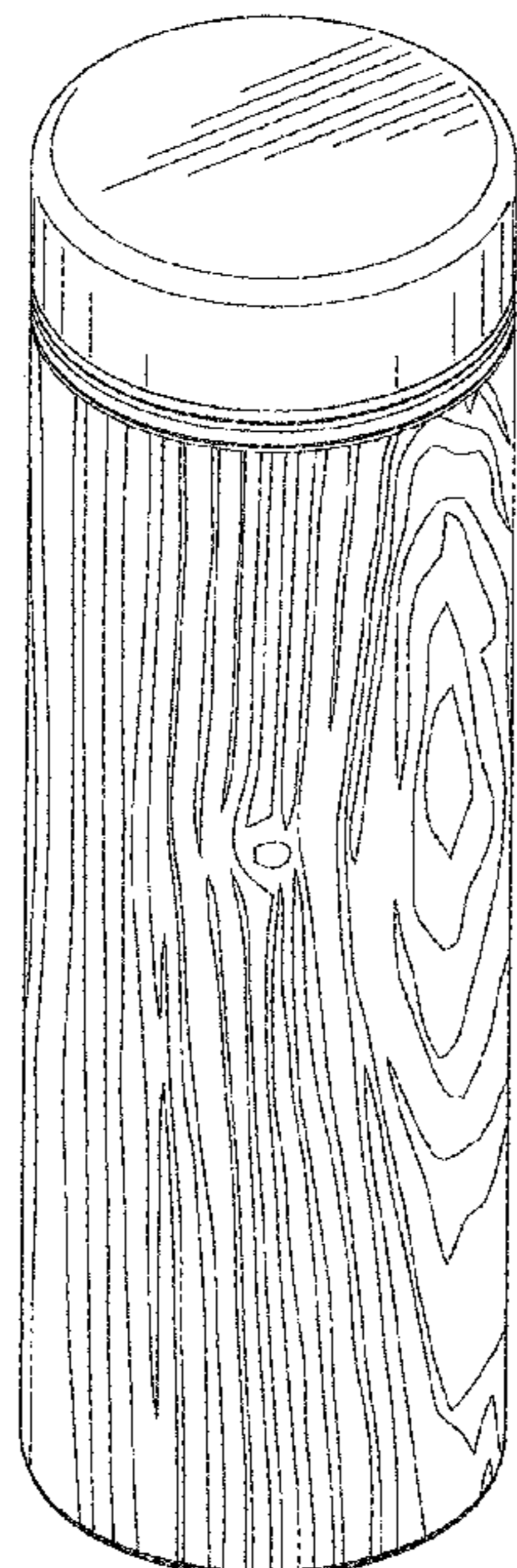
The ornamental design for a insulated water bottle, as shown and described.

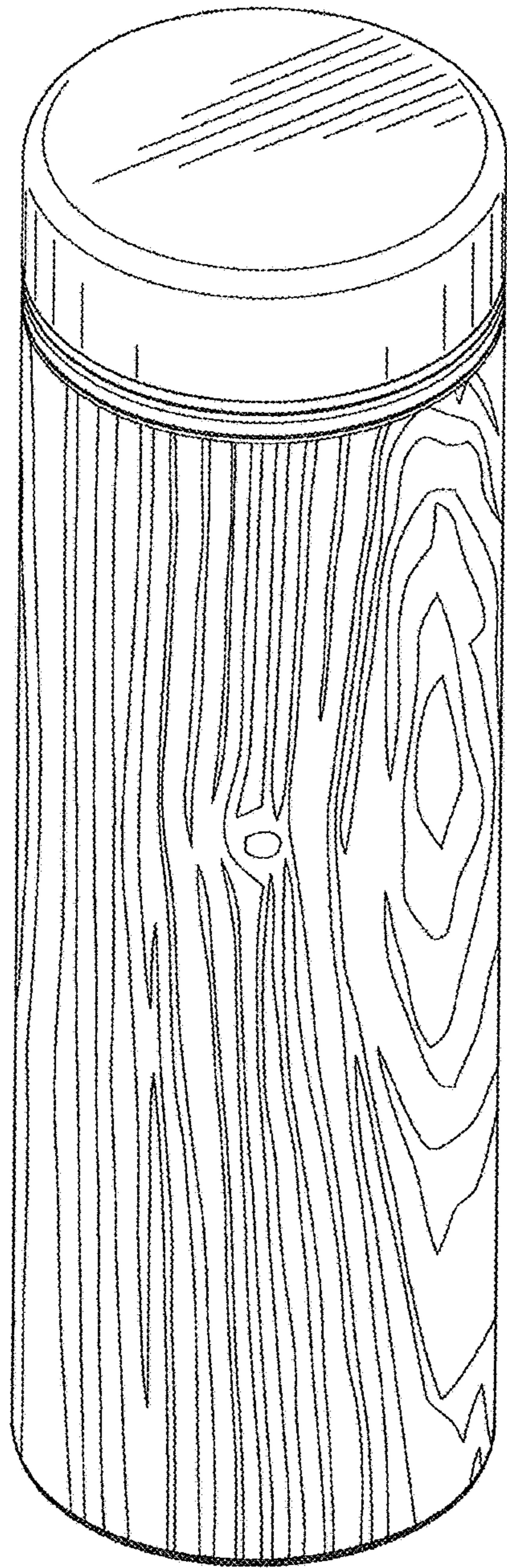

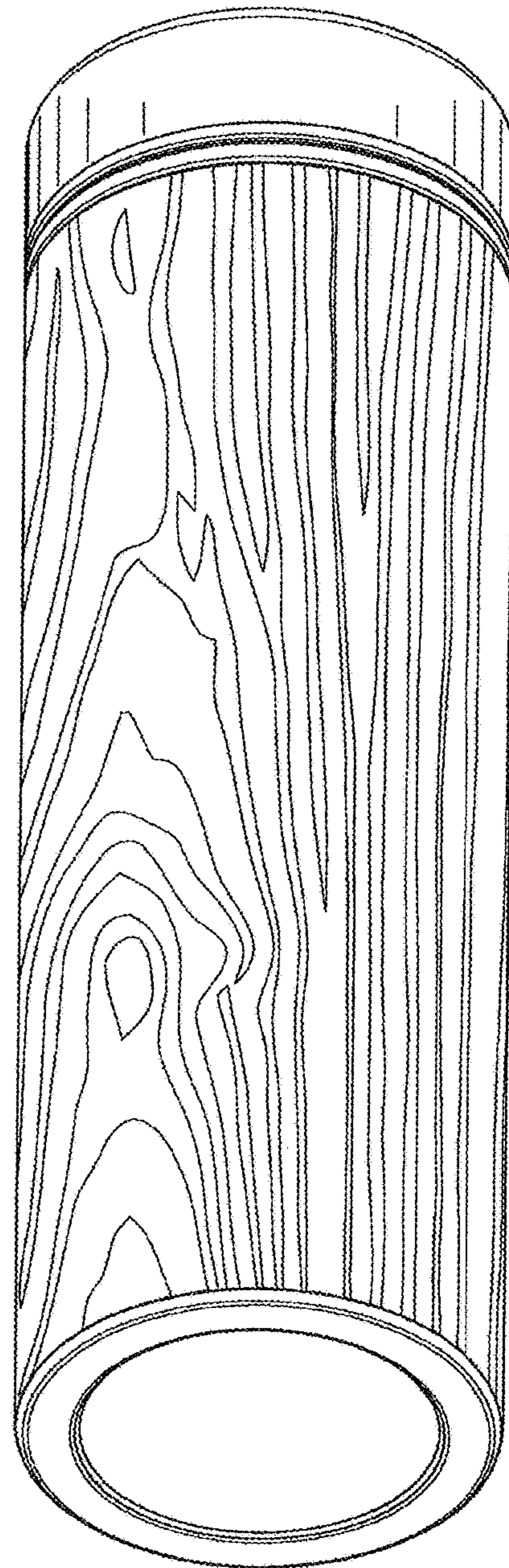

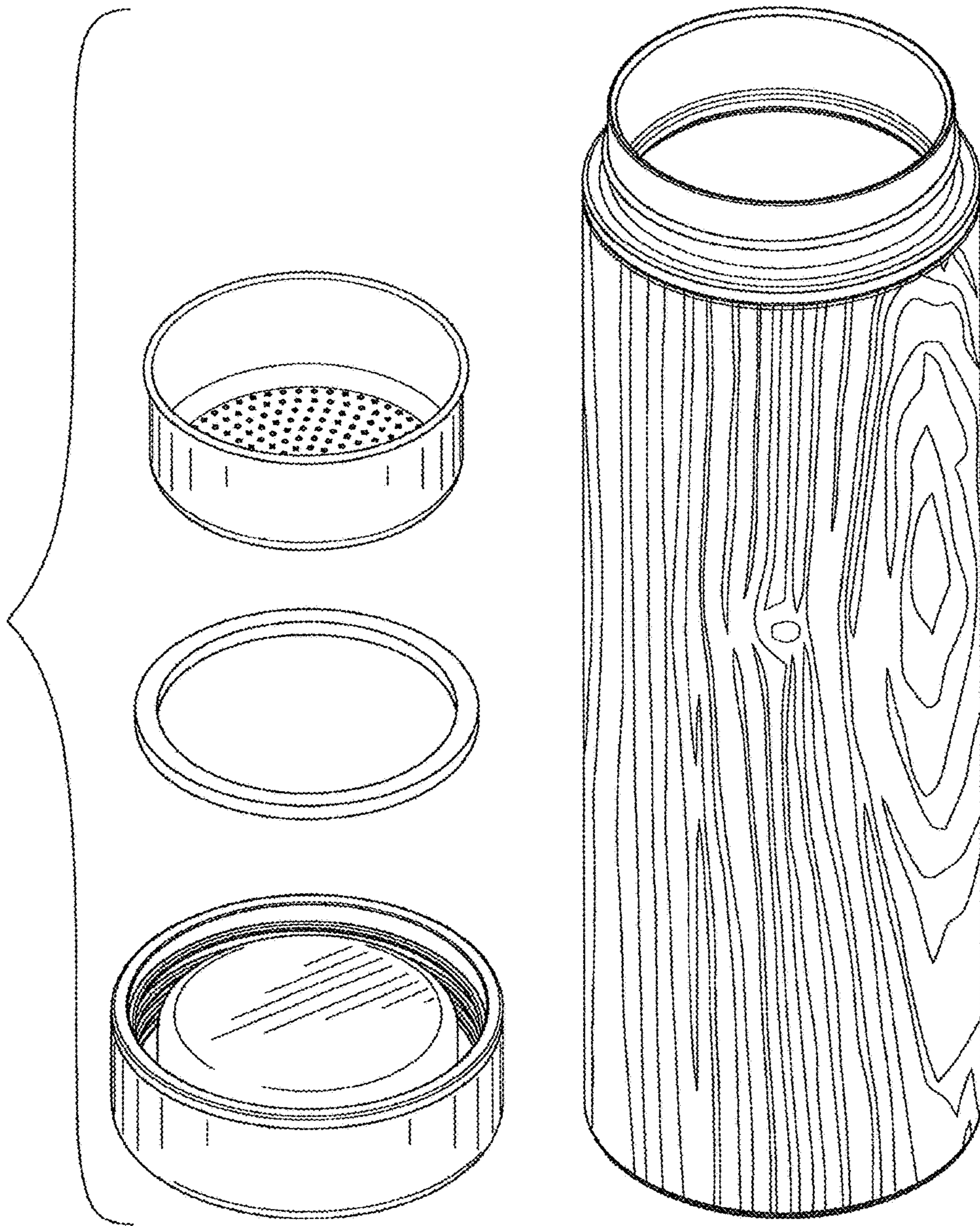

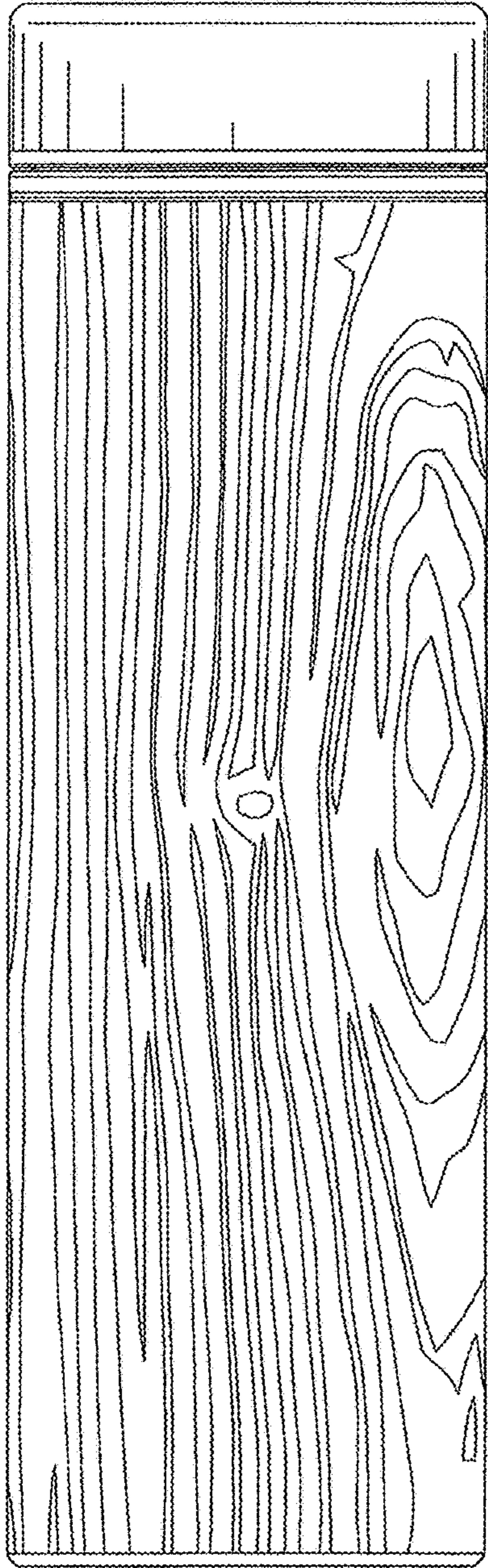

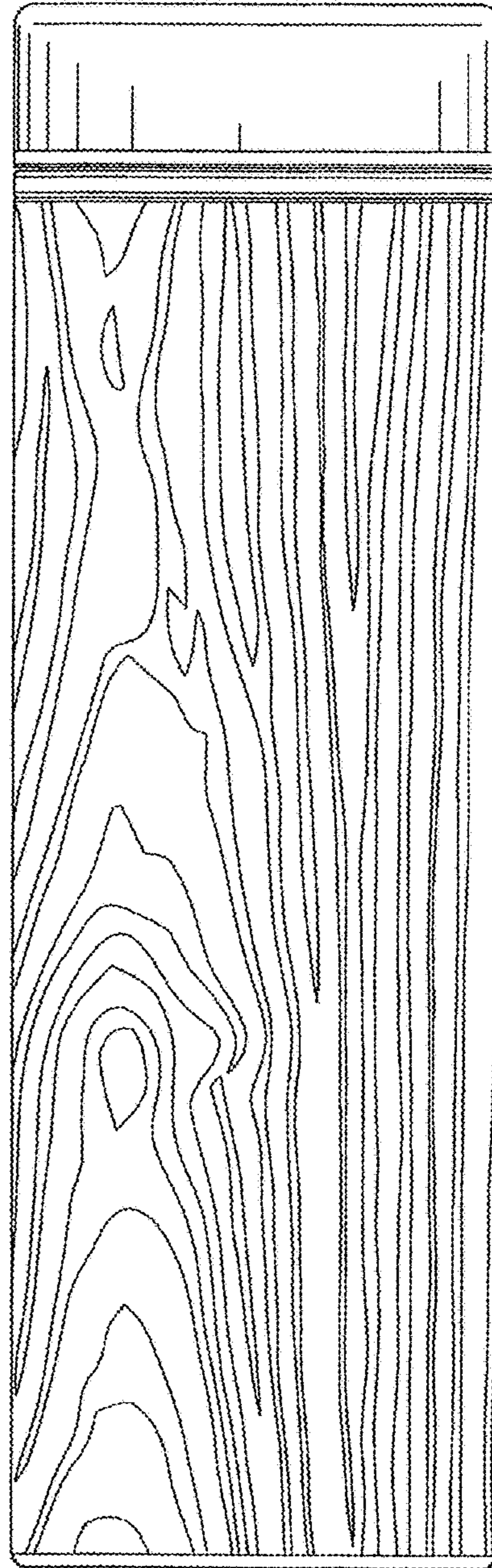

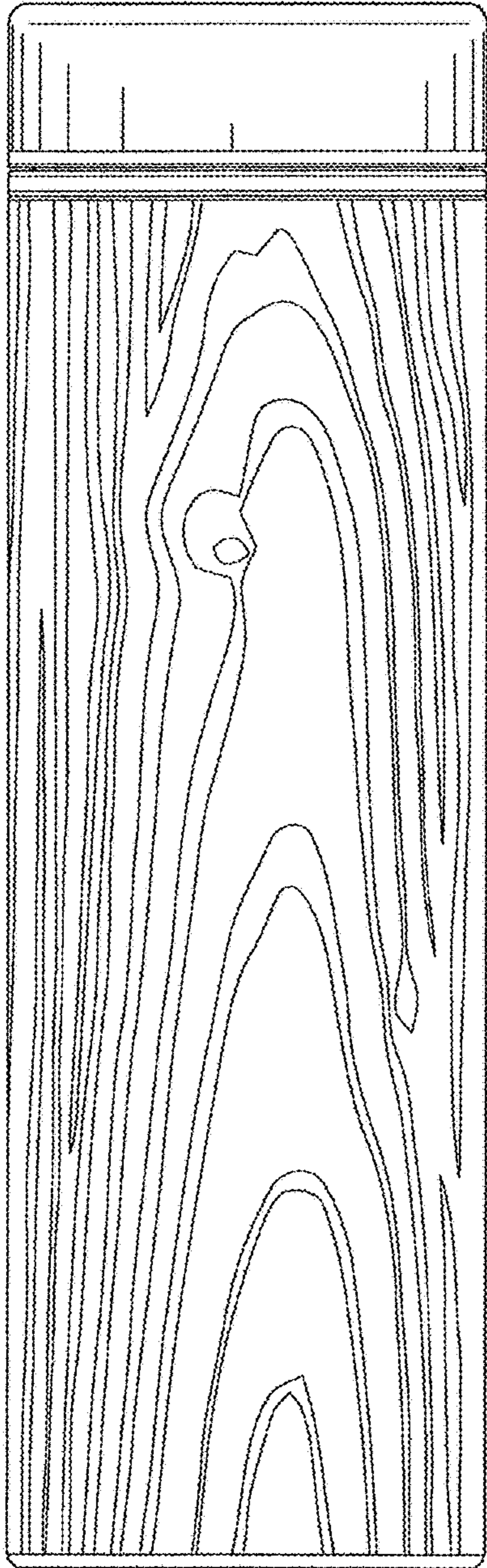

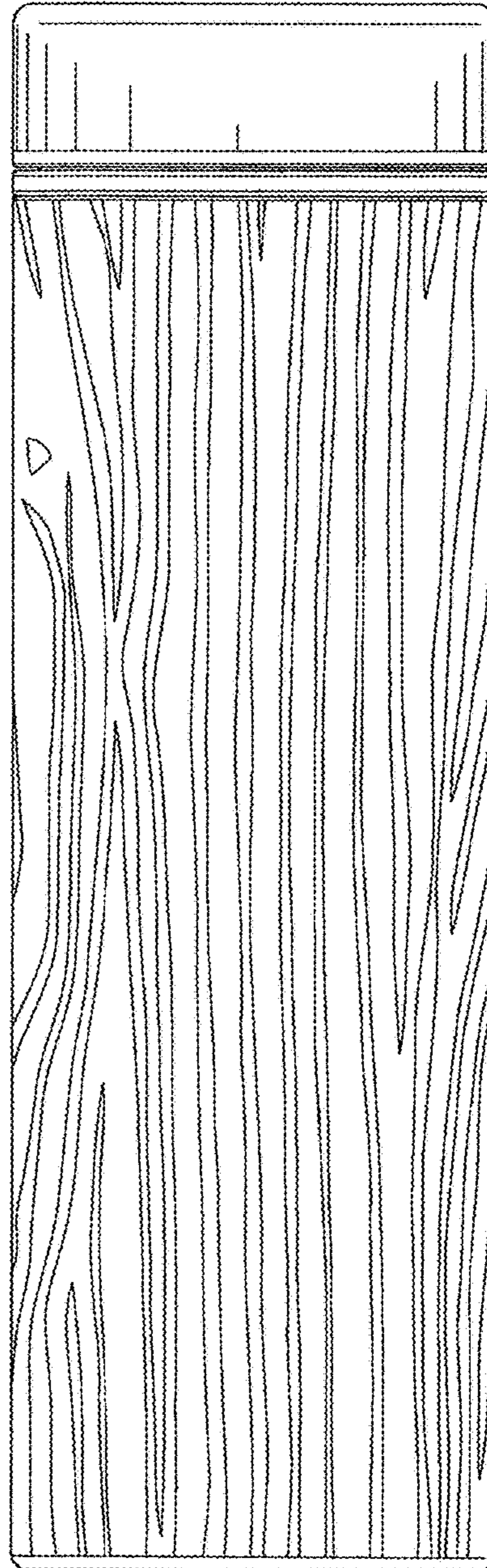

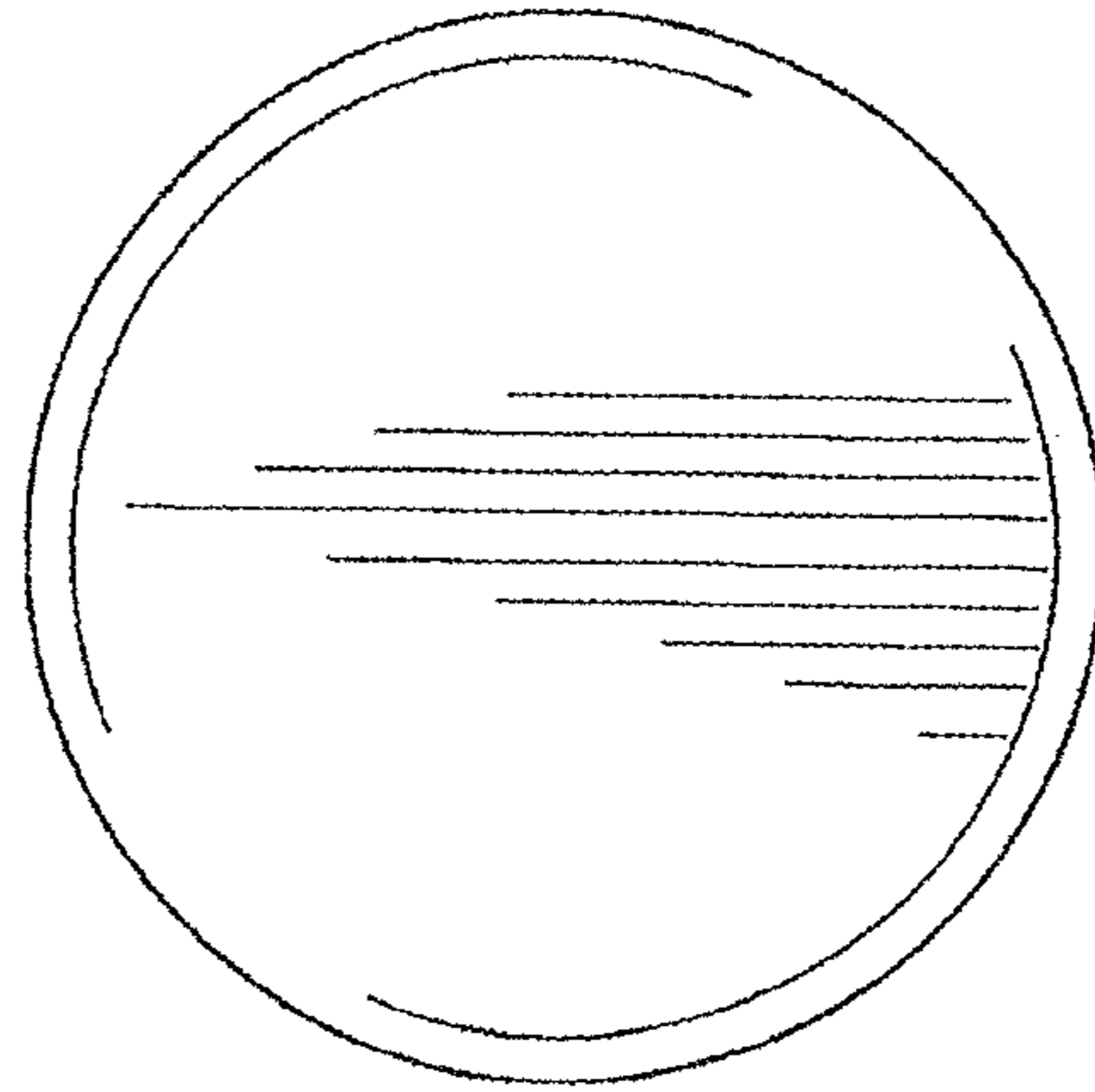

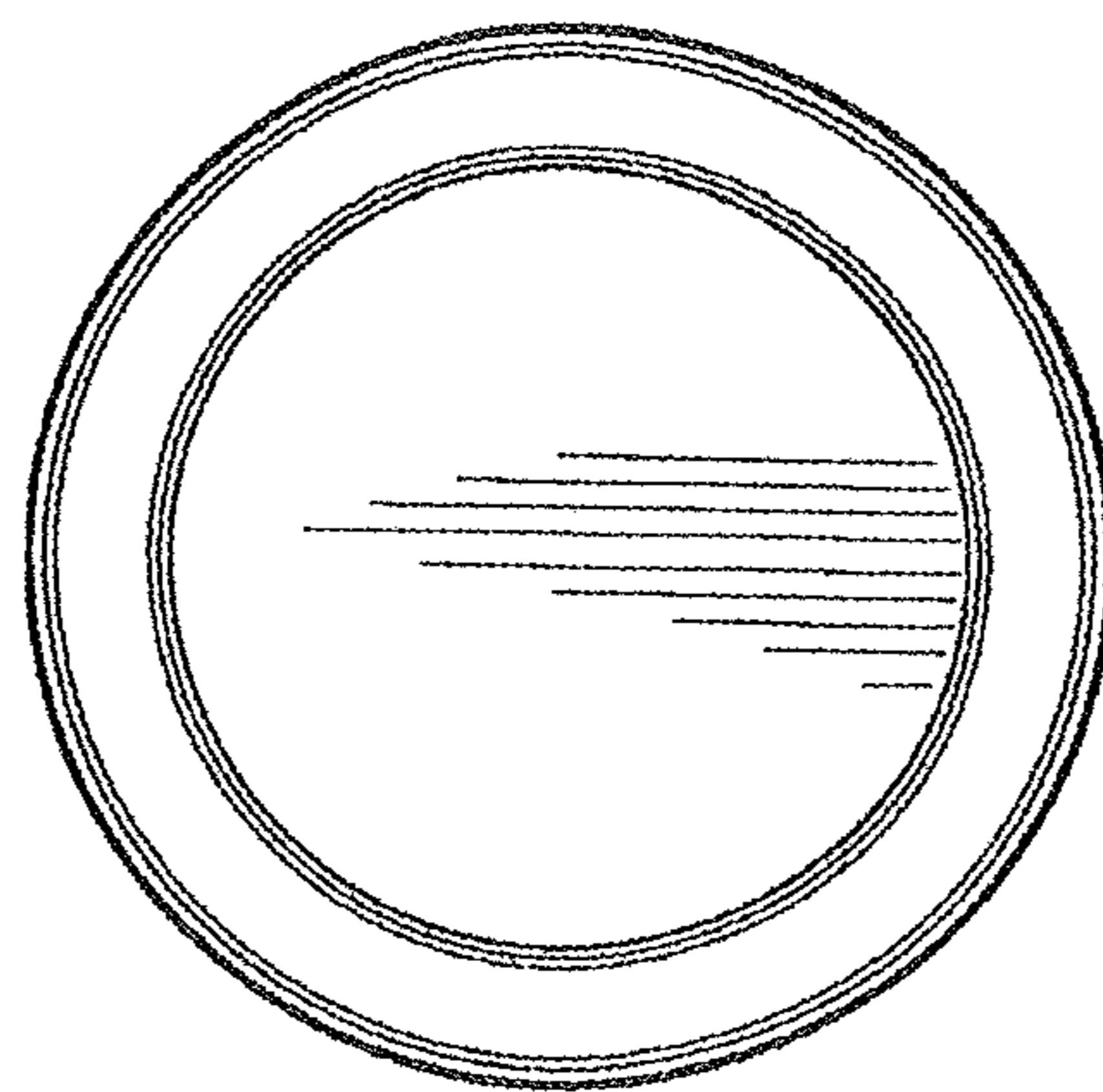
