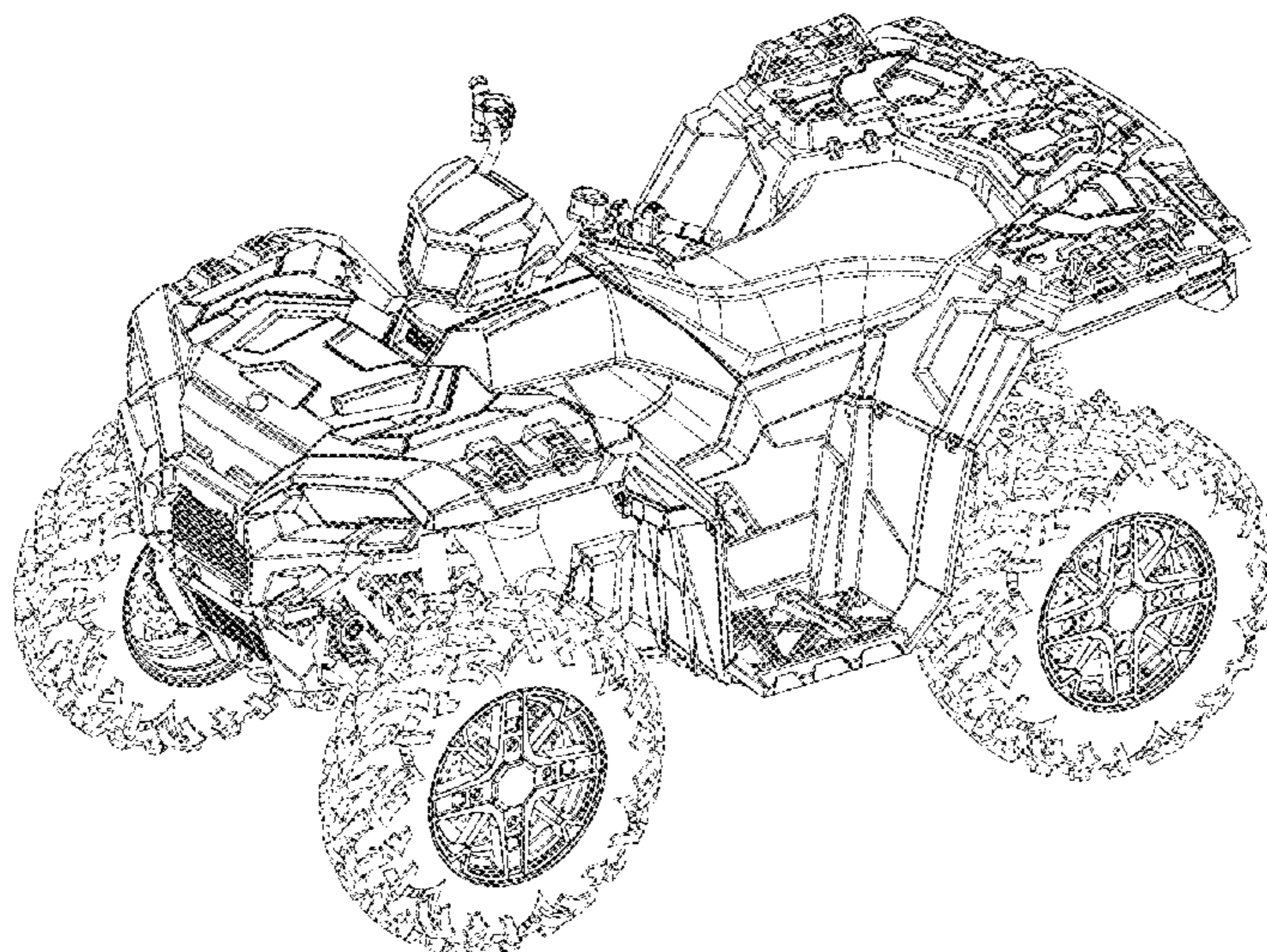
The ornamental design for an all-terrain vehicle, as shown and described.

DESCRIPTION

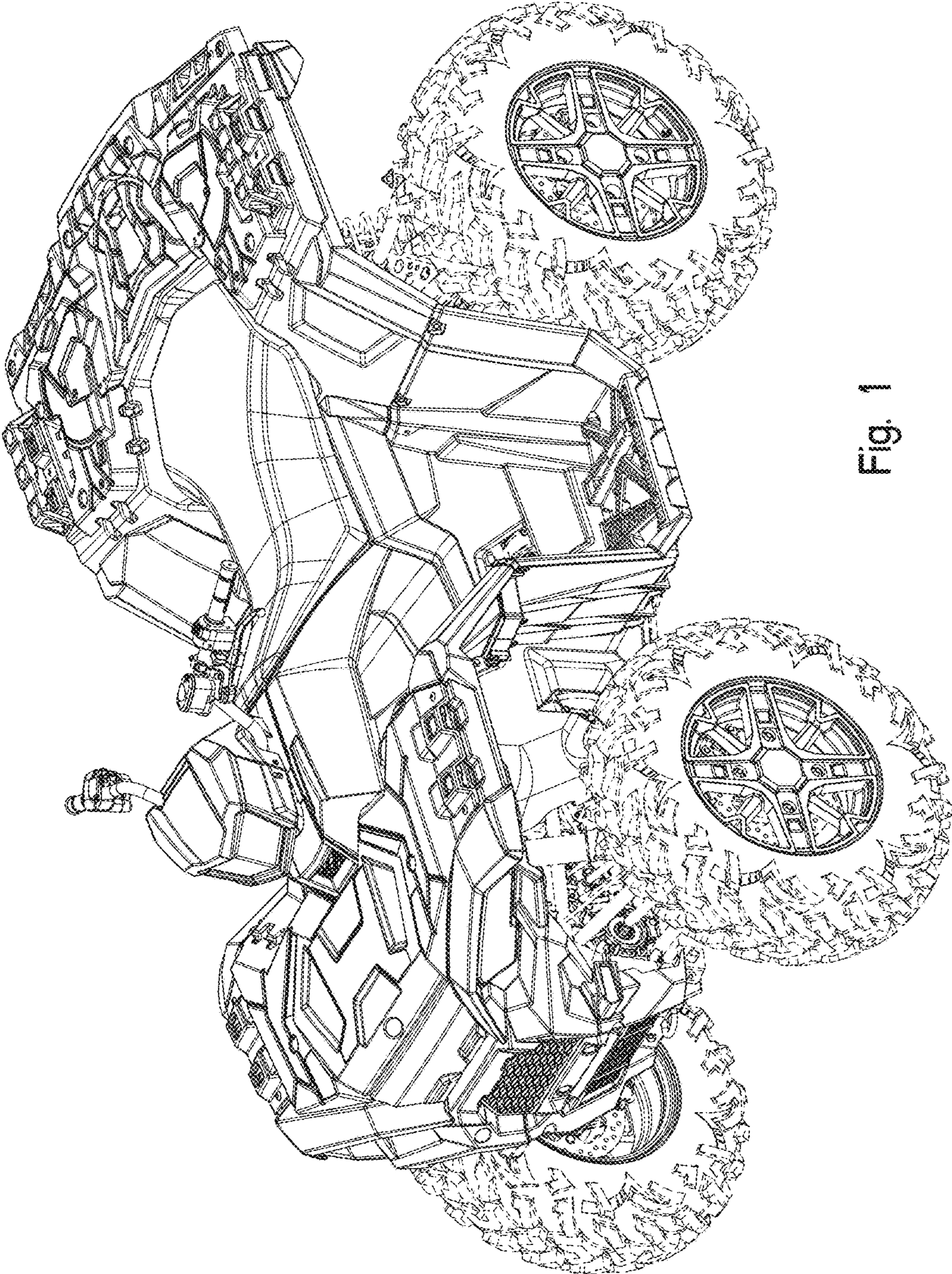

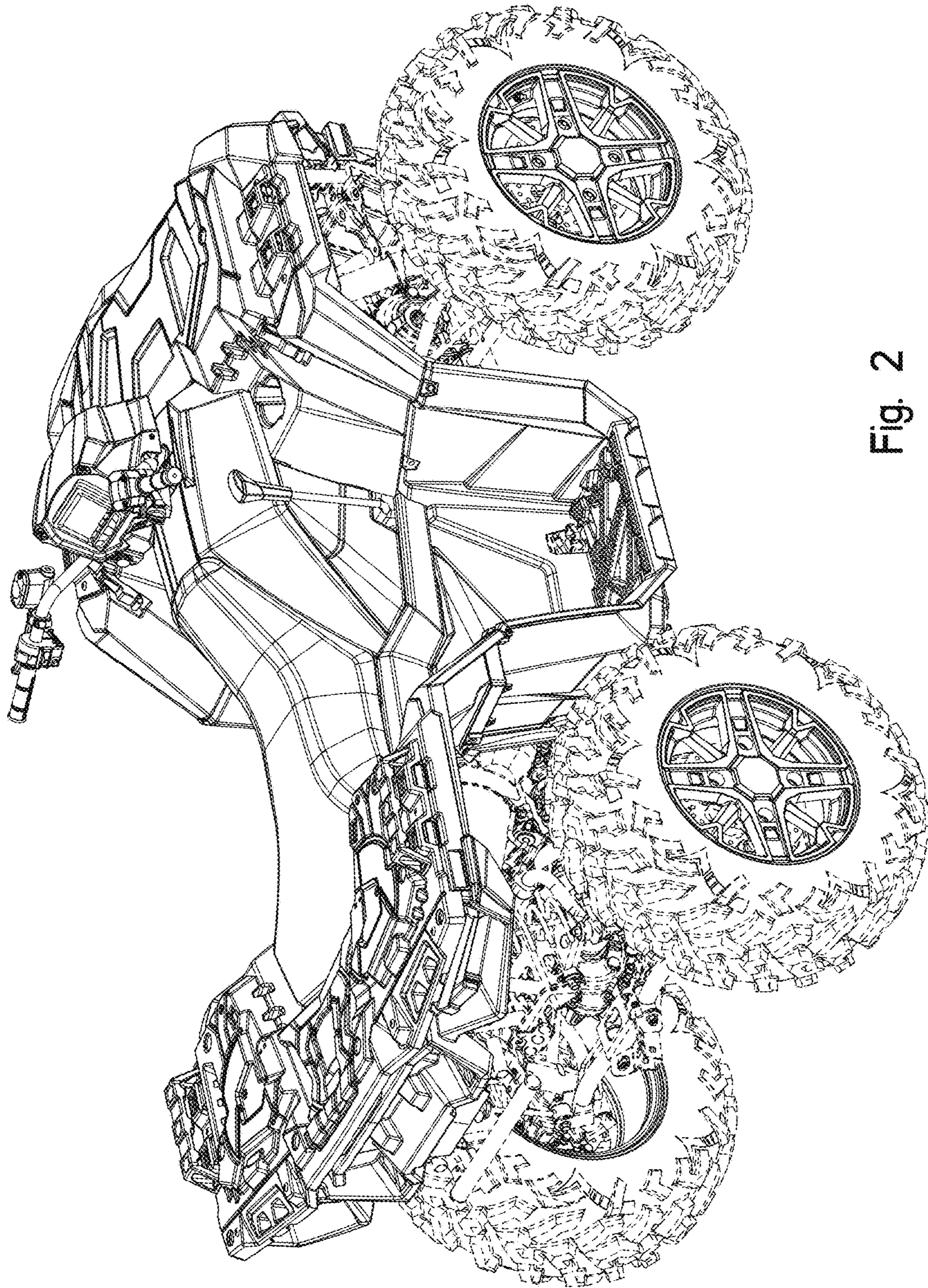

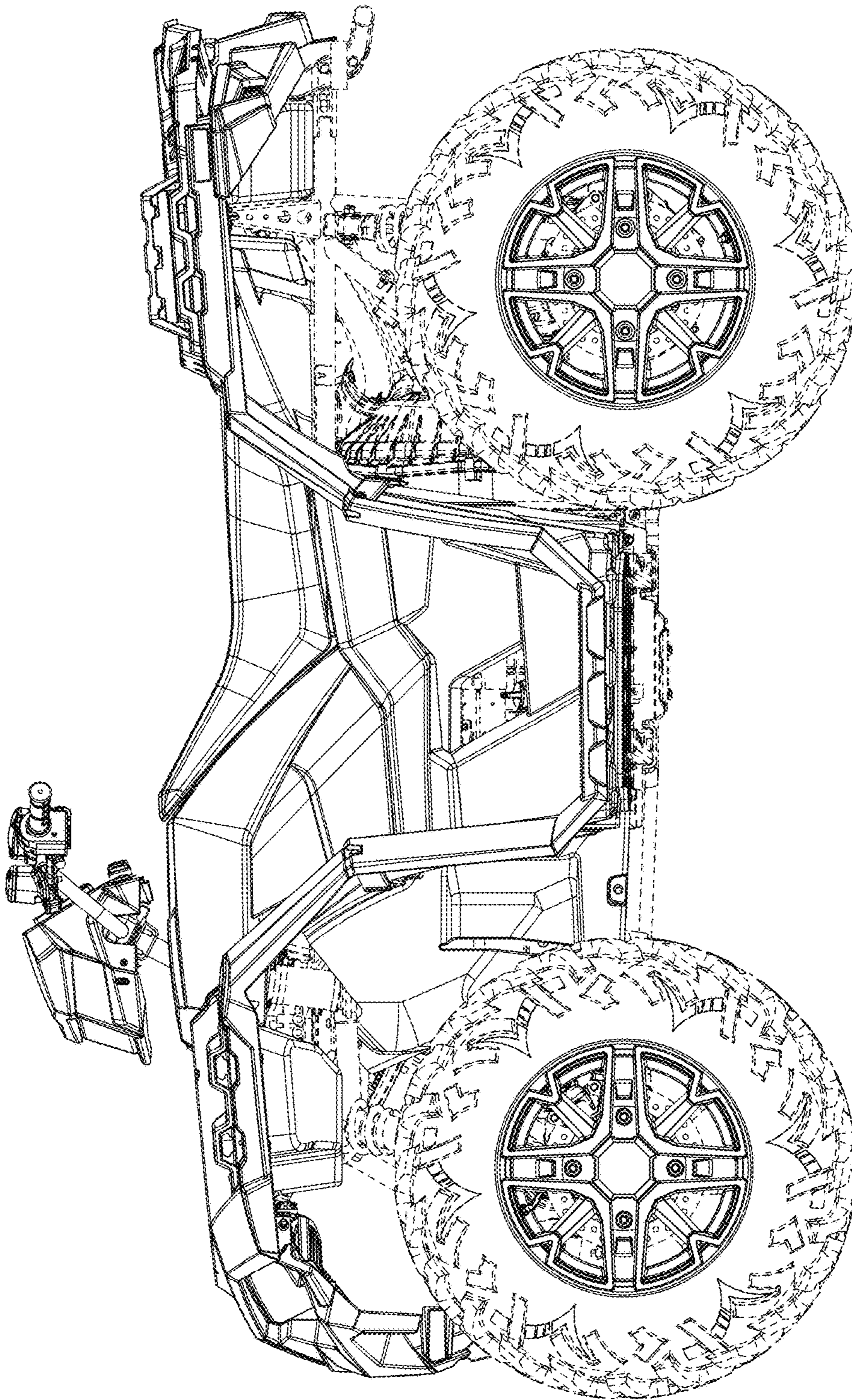

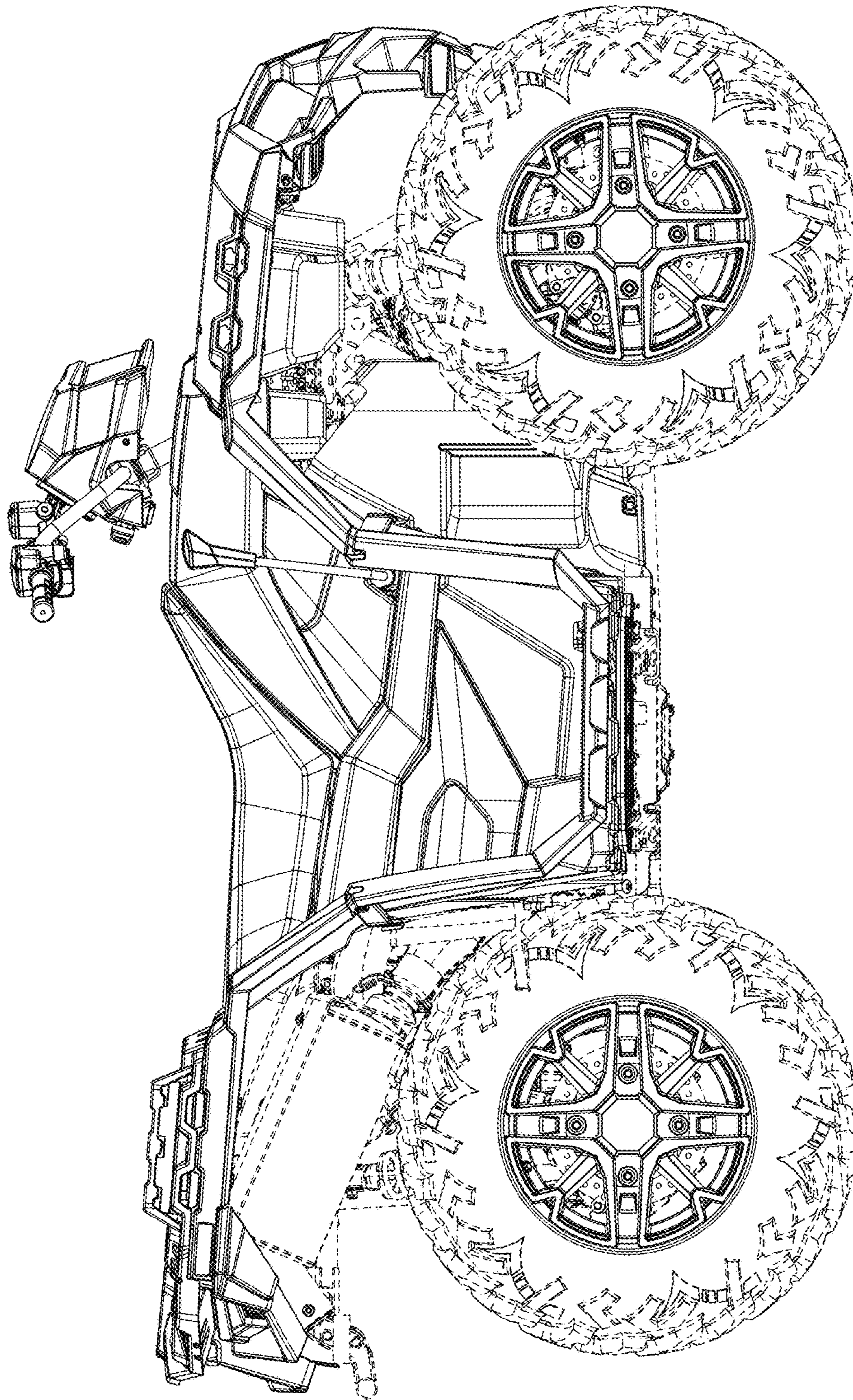

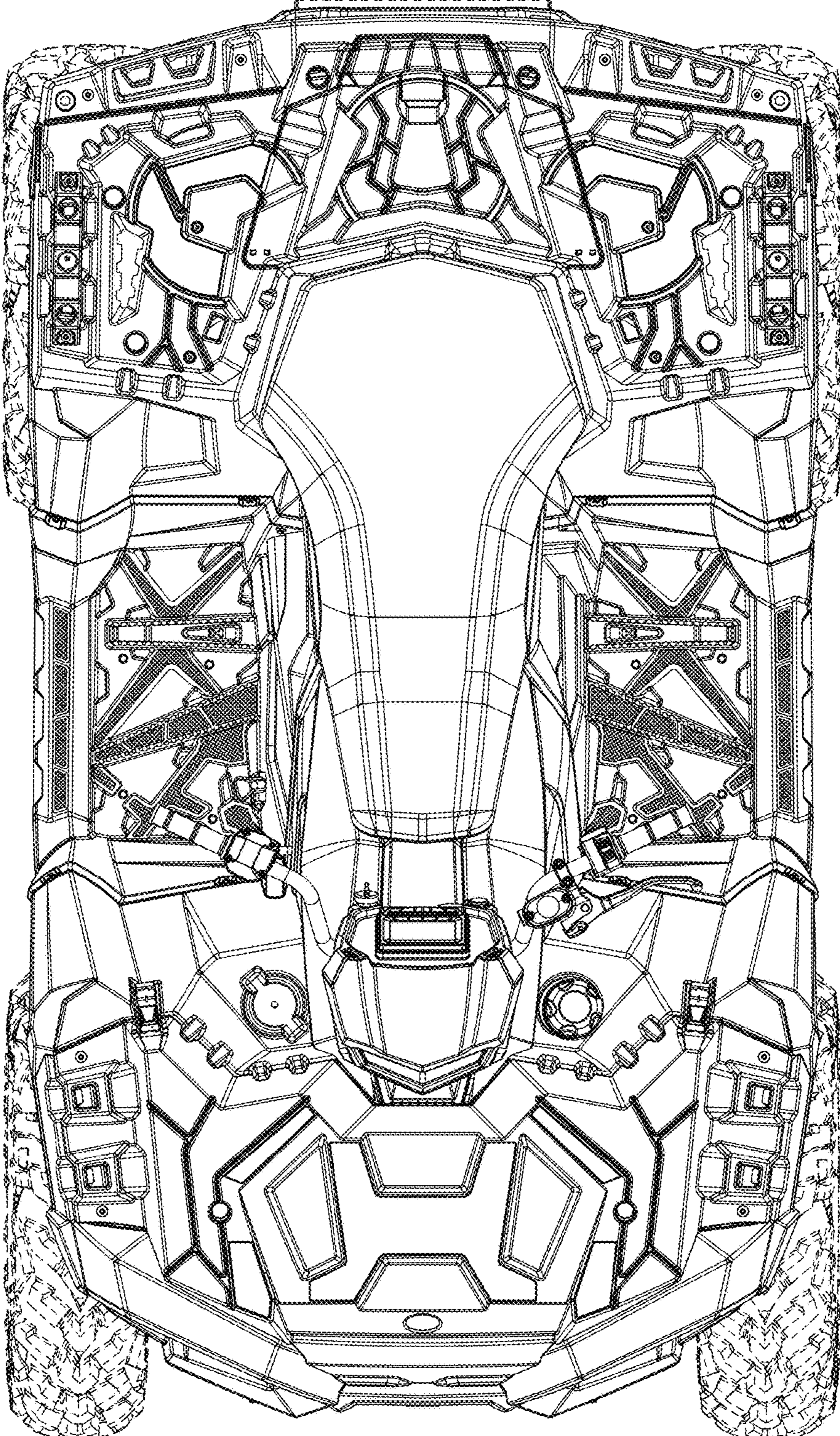

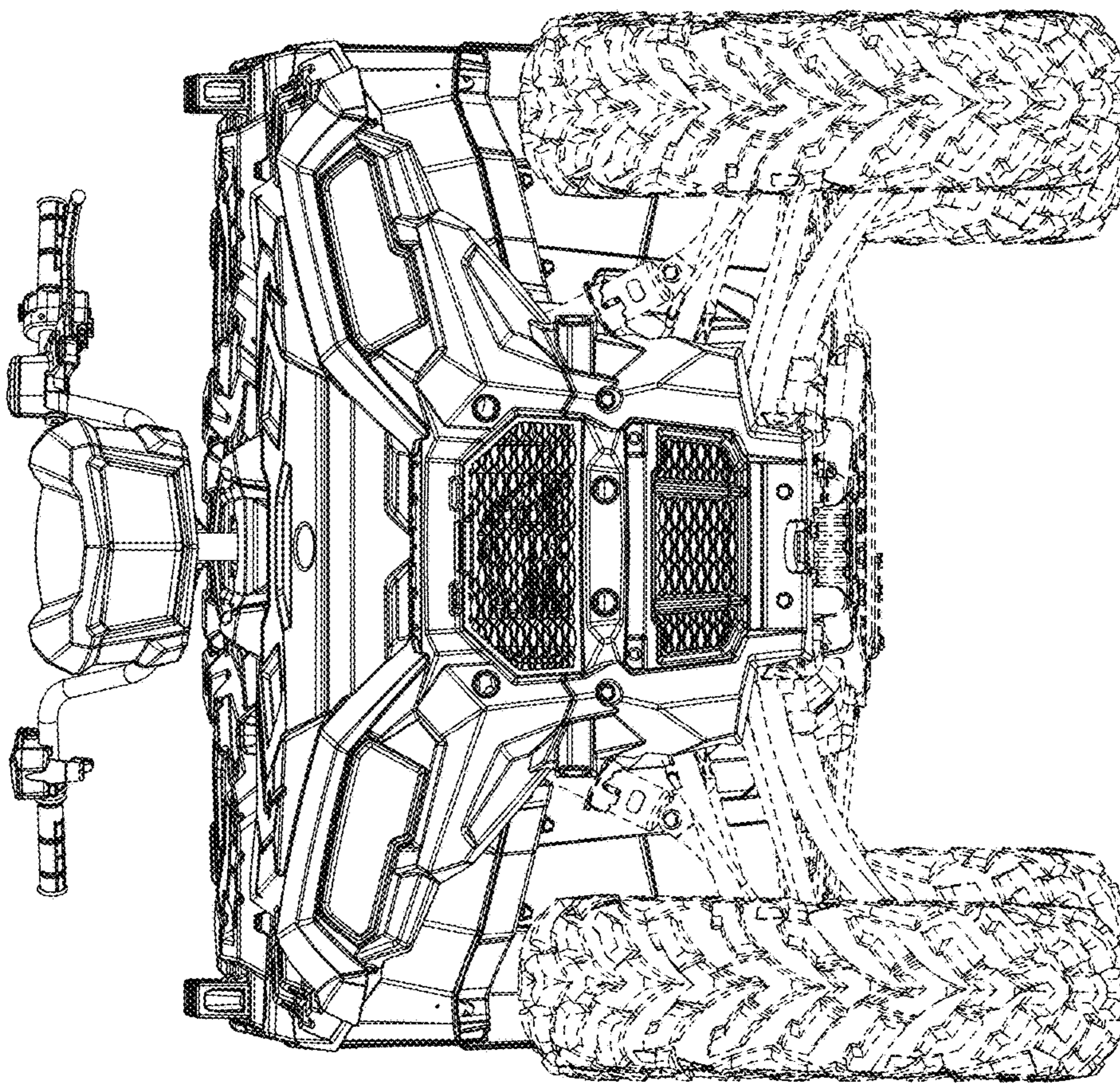

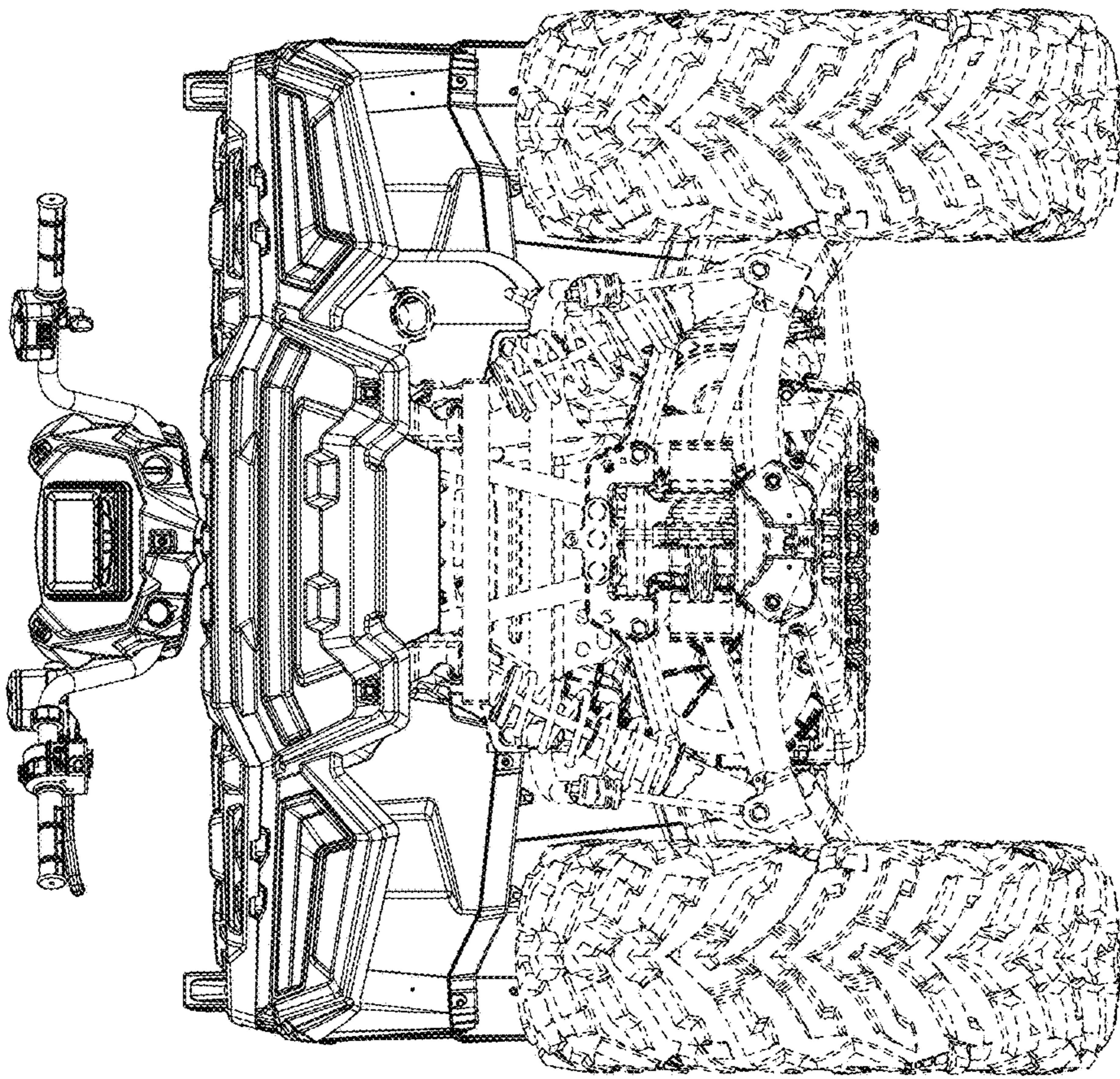

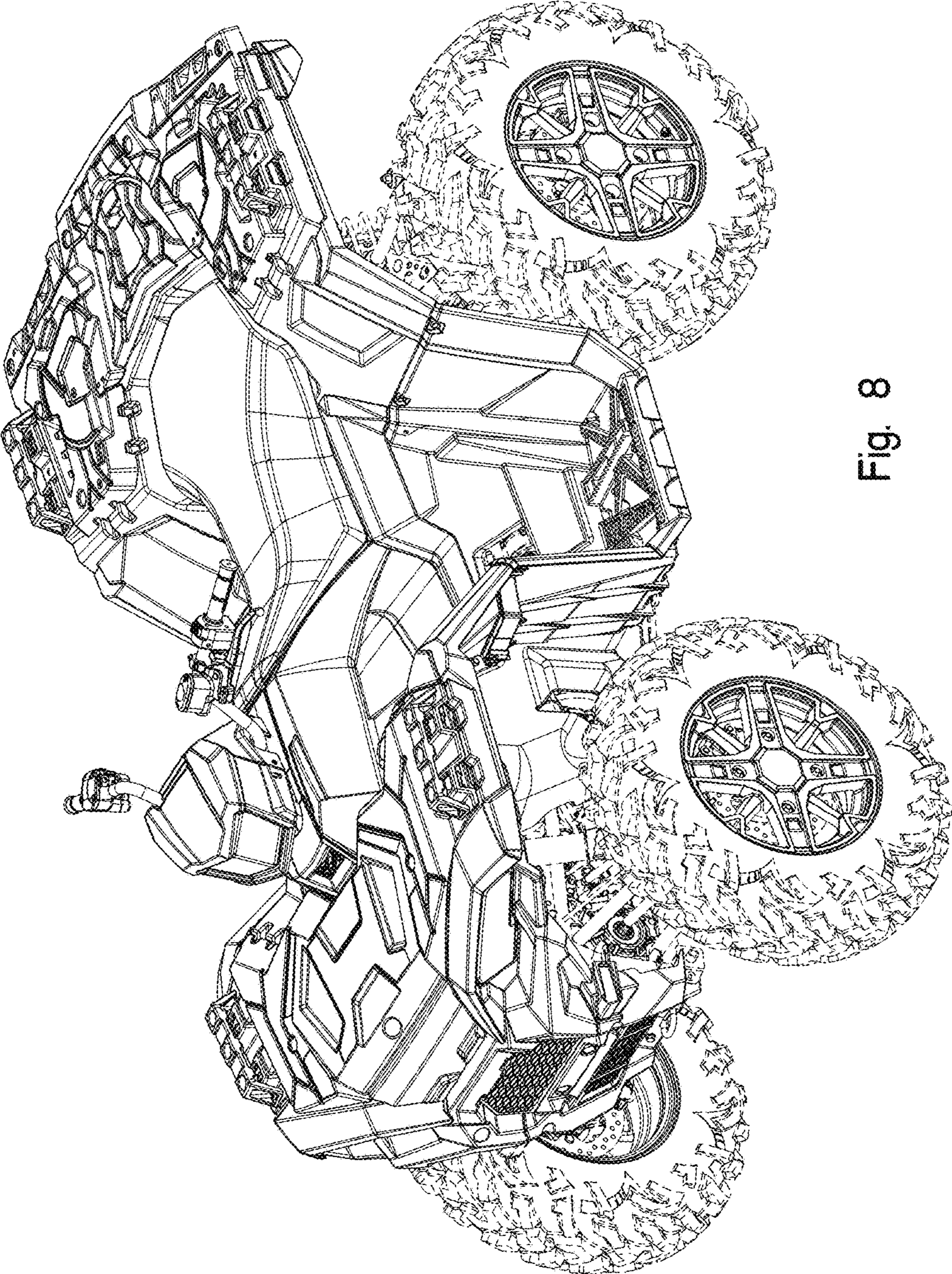

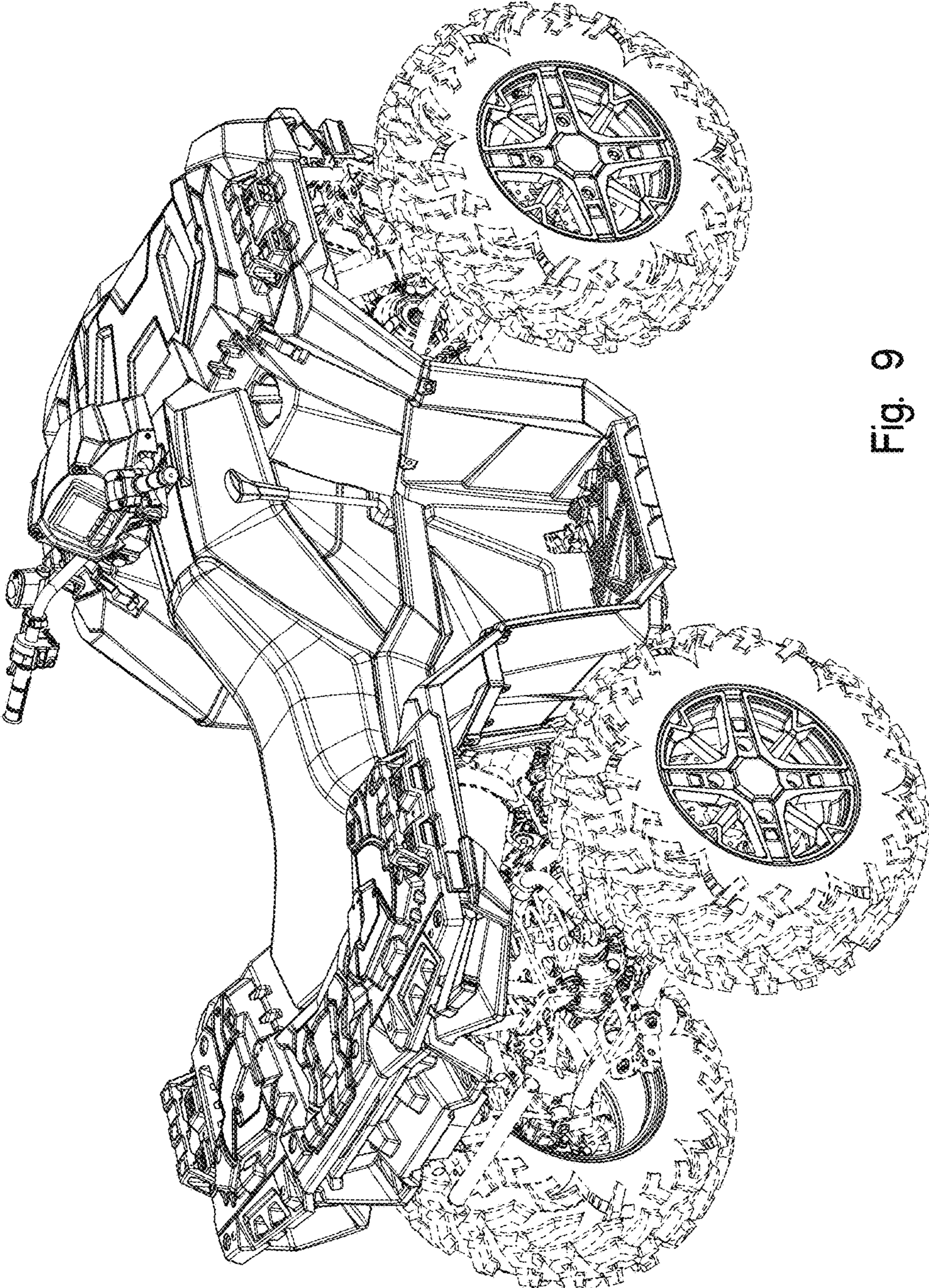

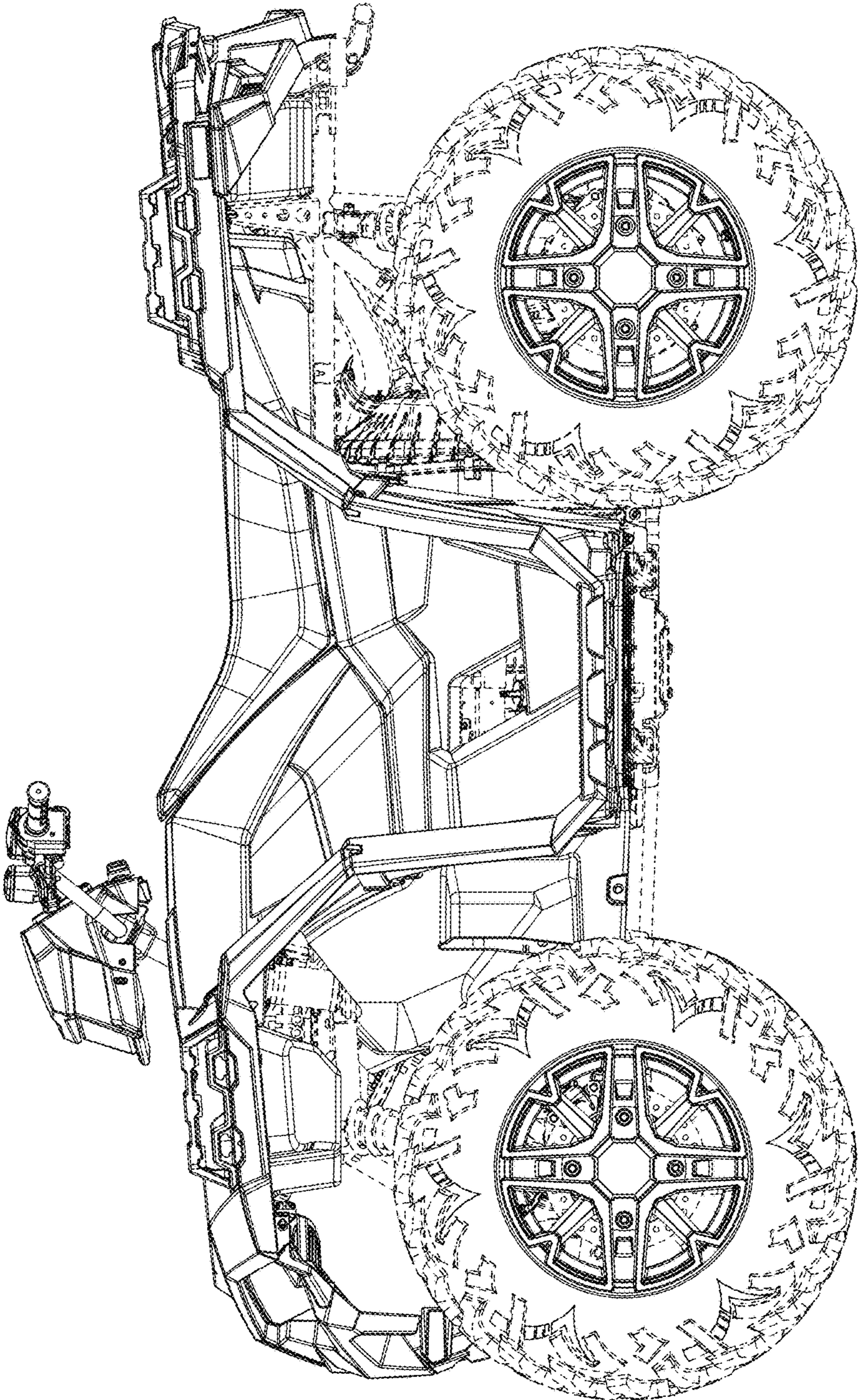

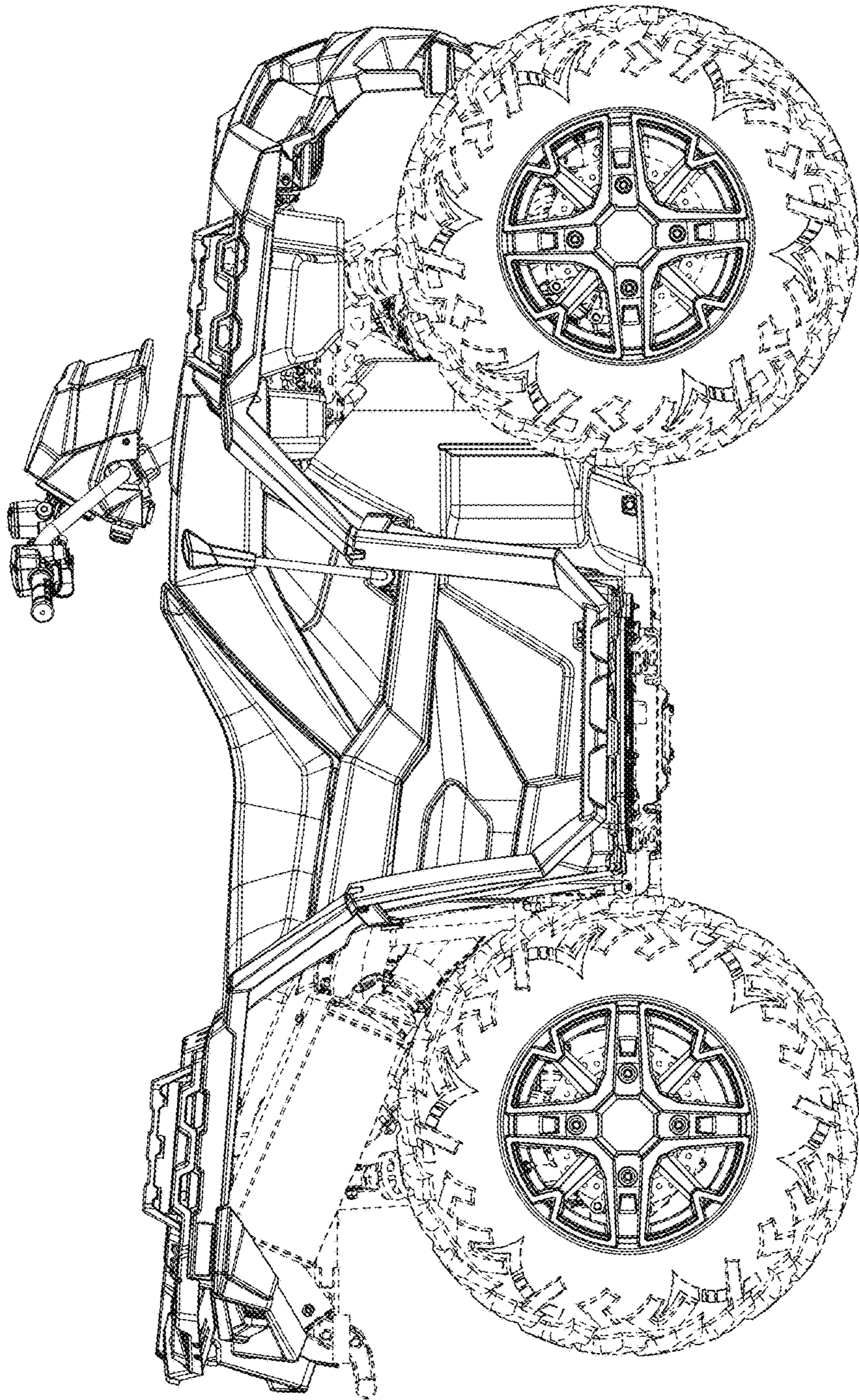

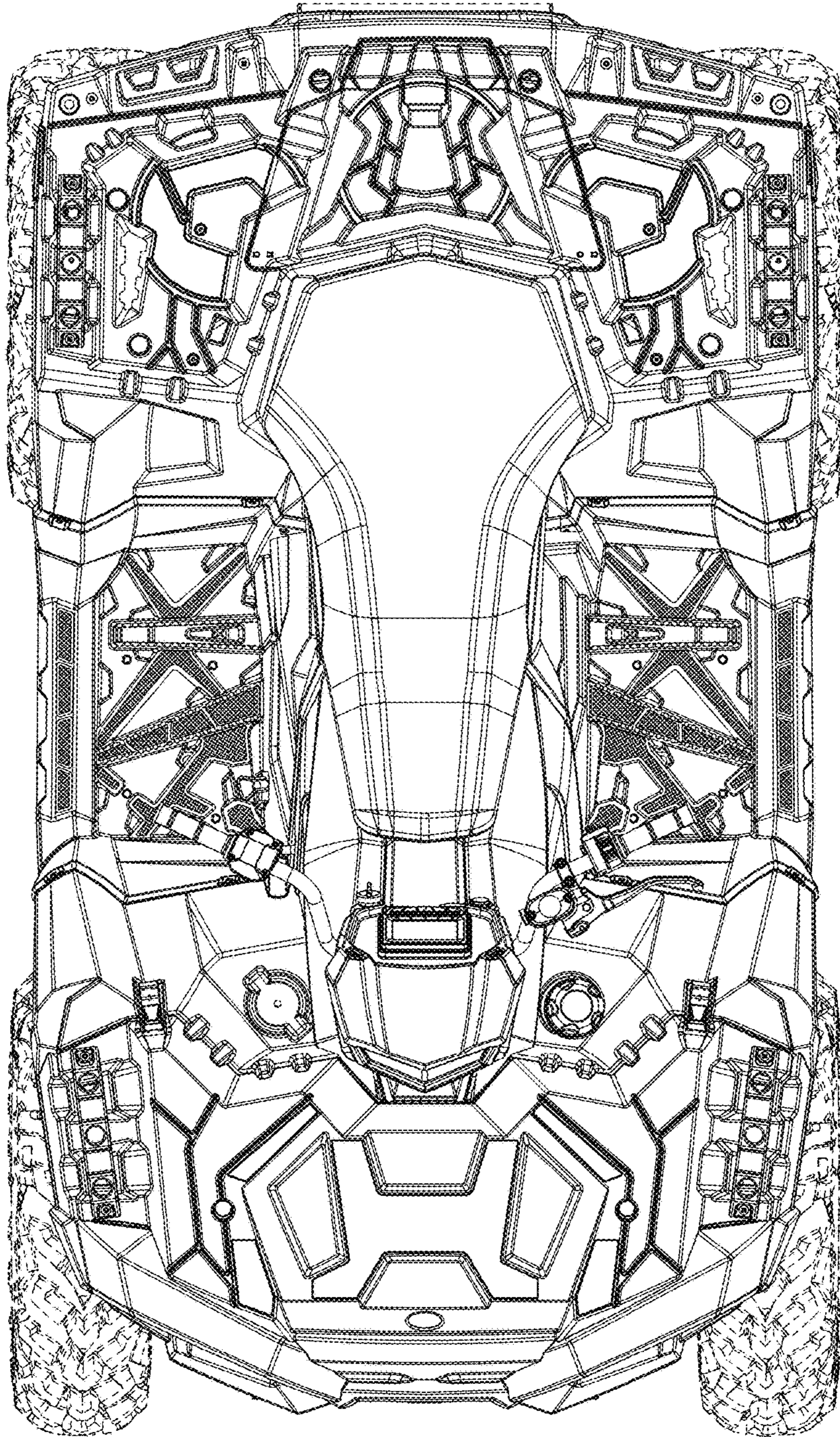

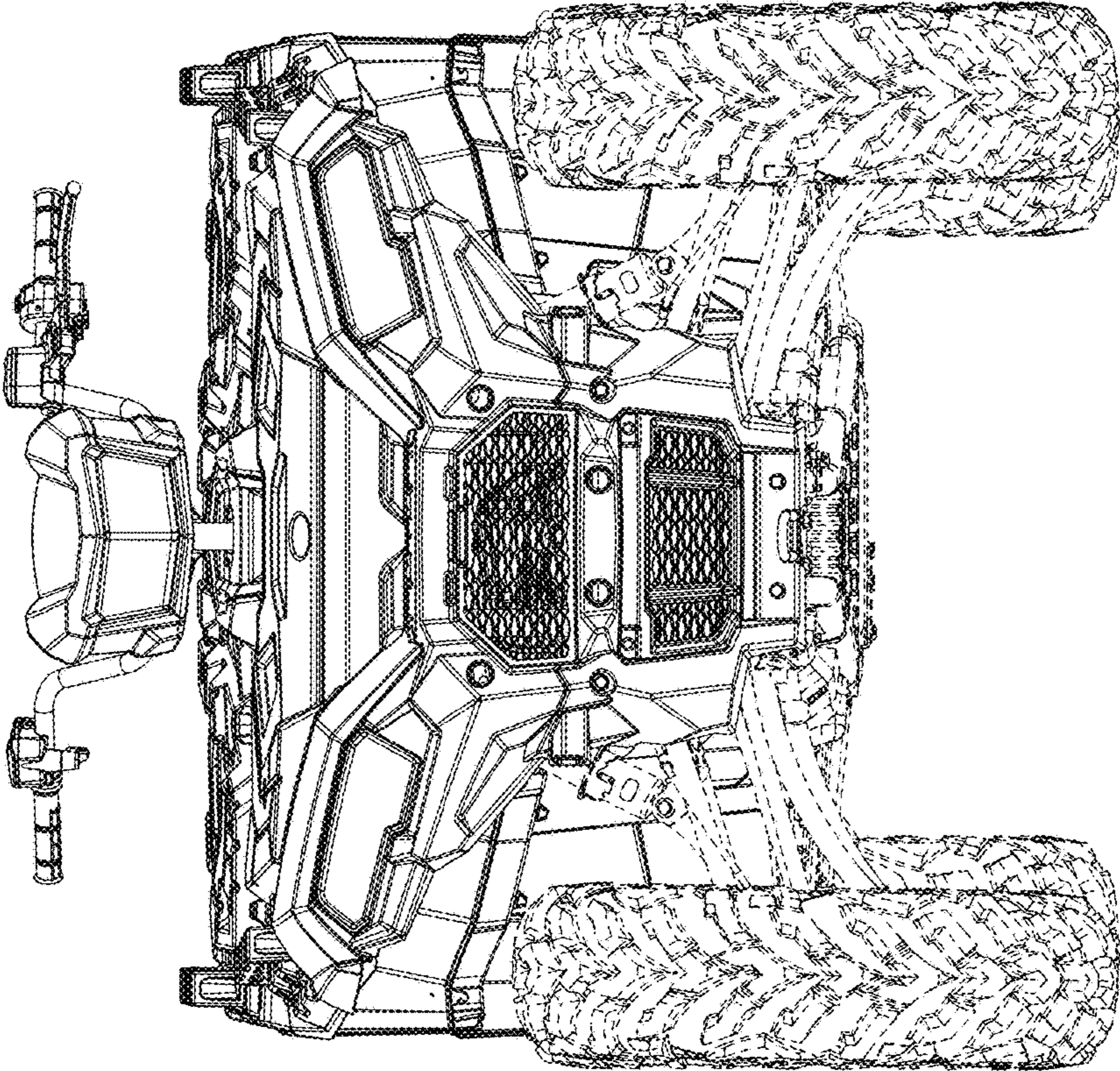

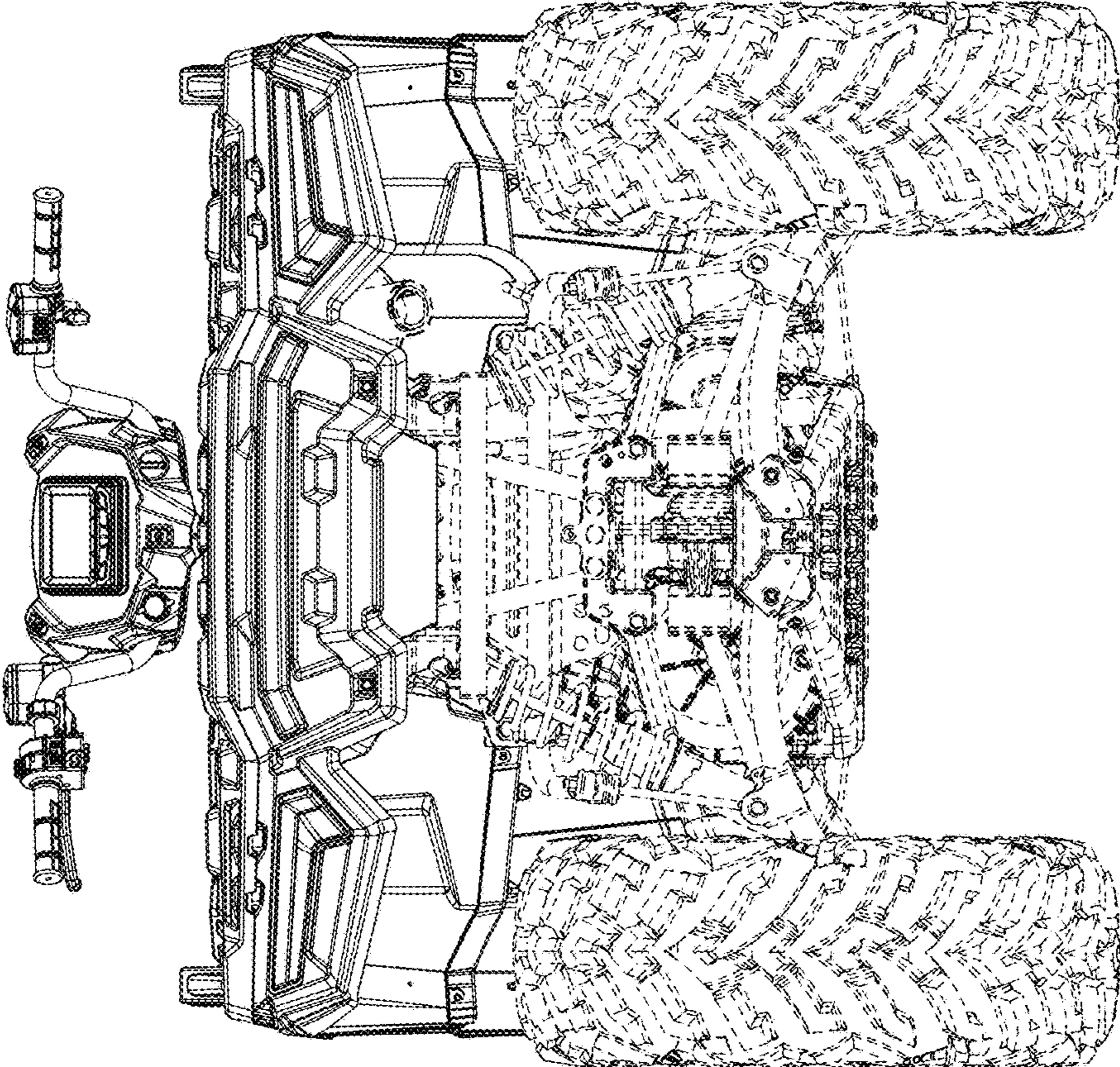

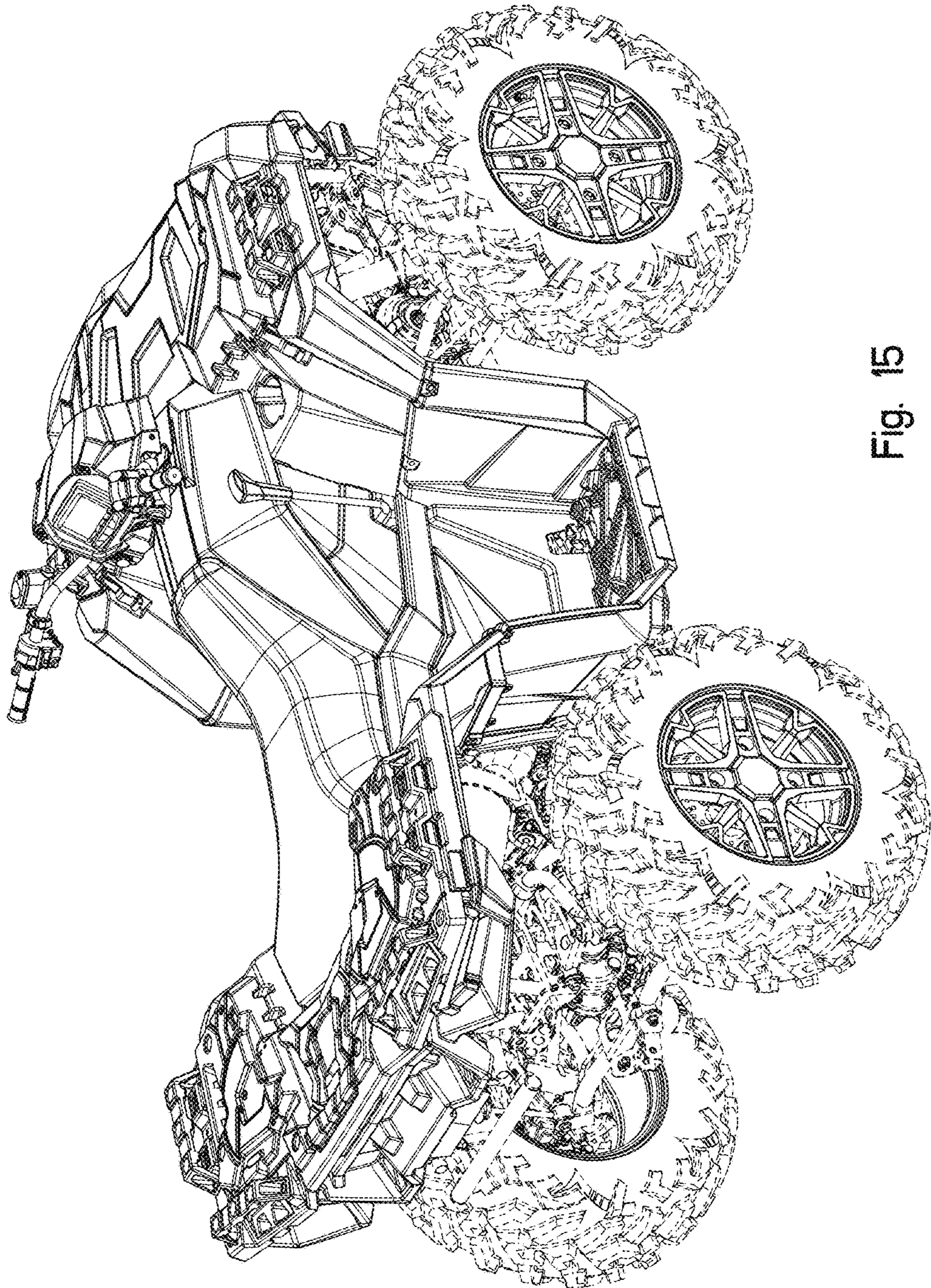

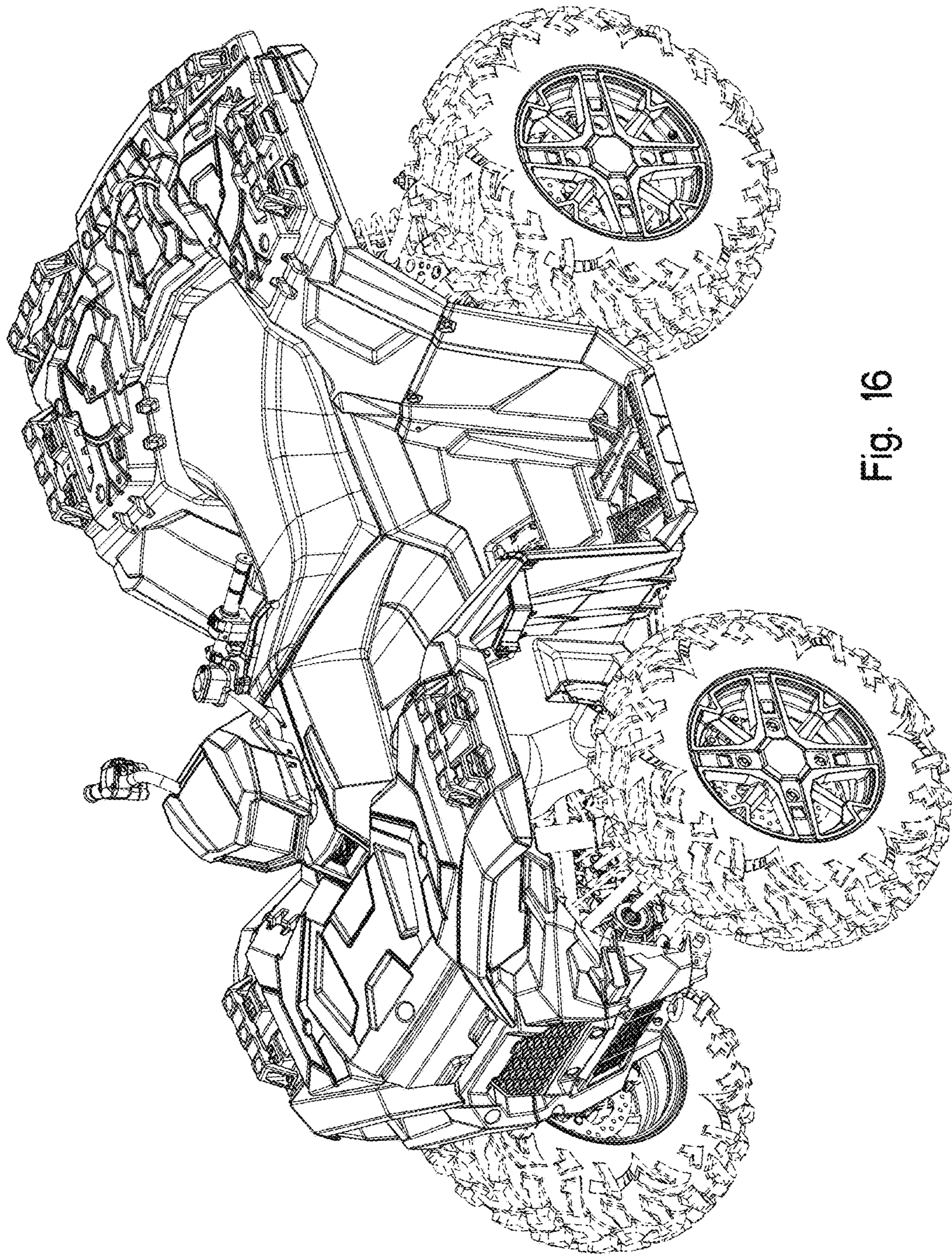

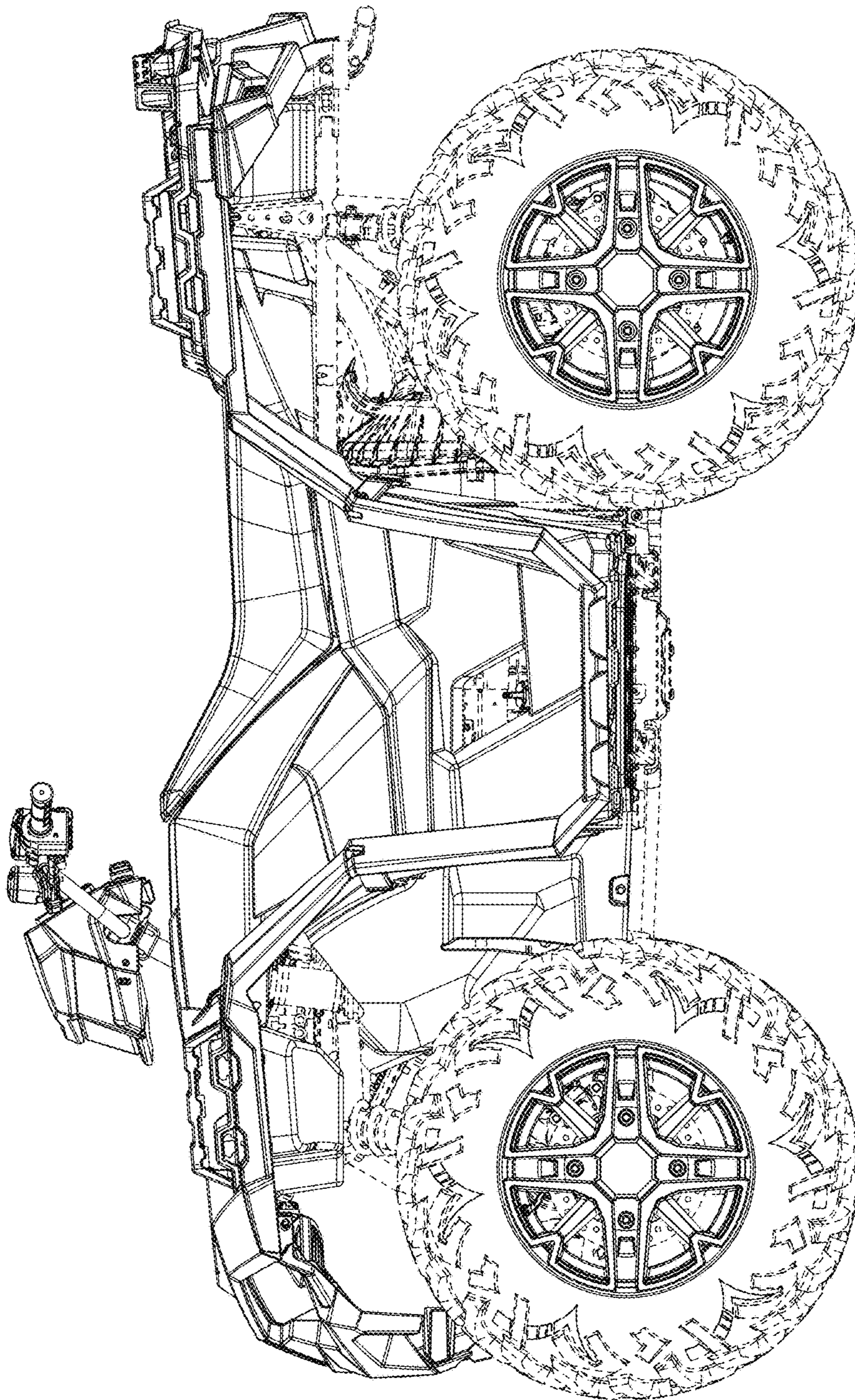

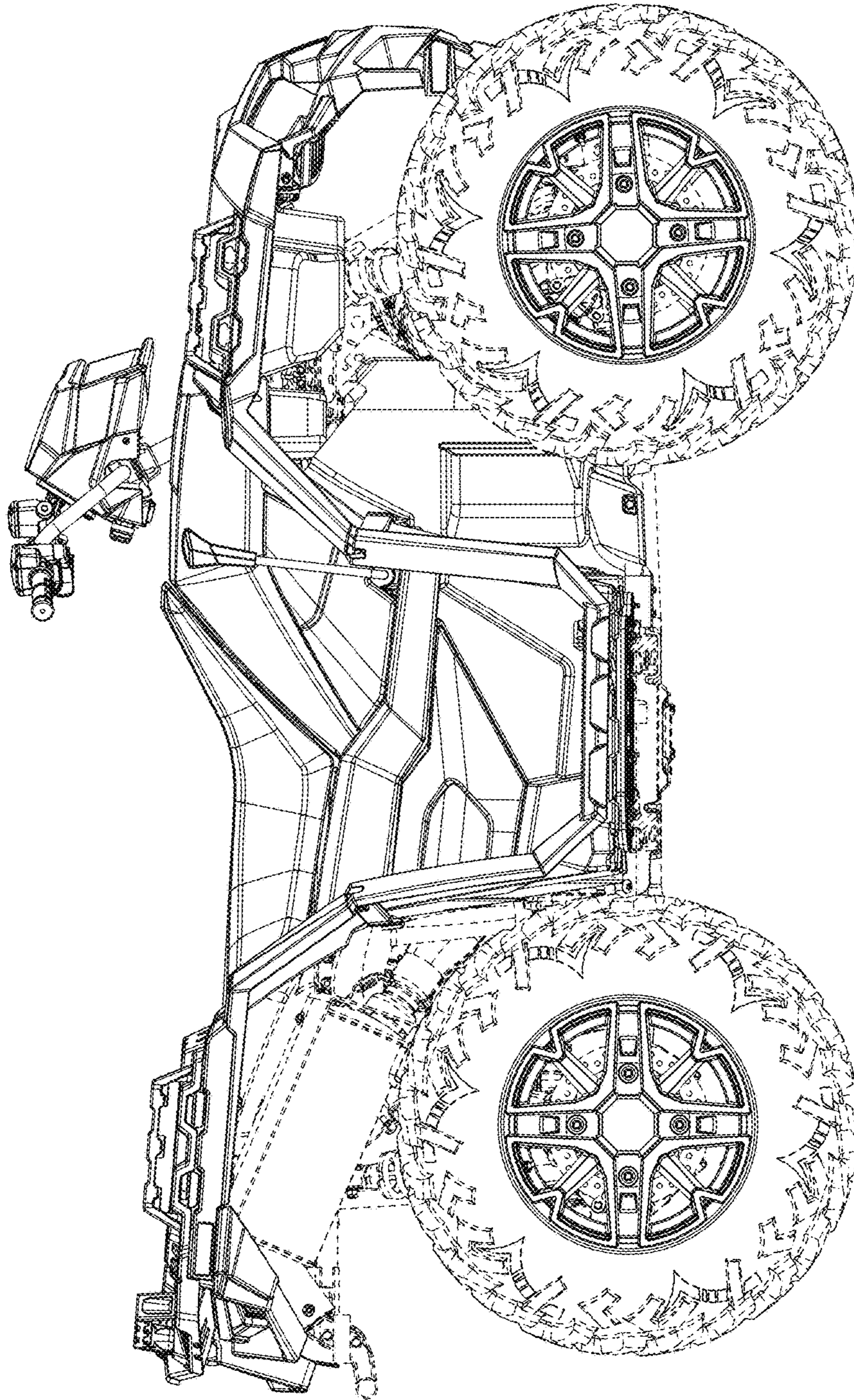

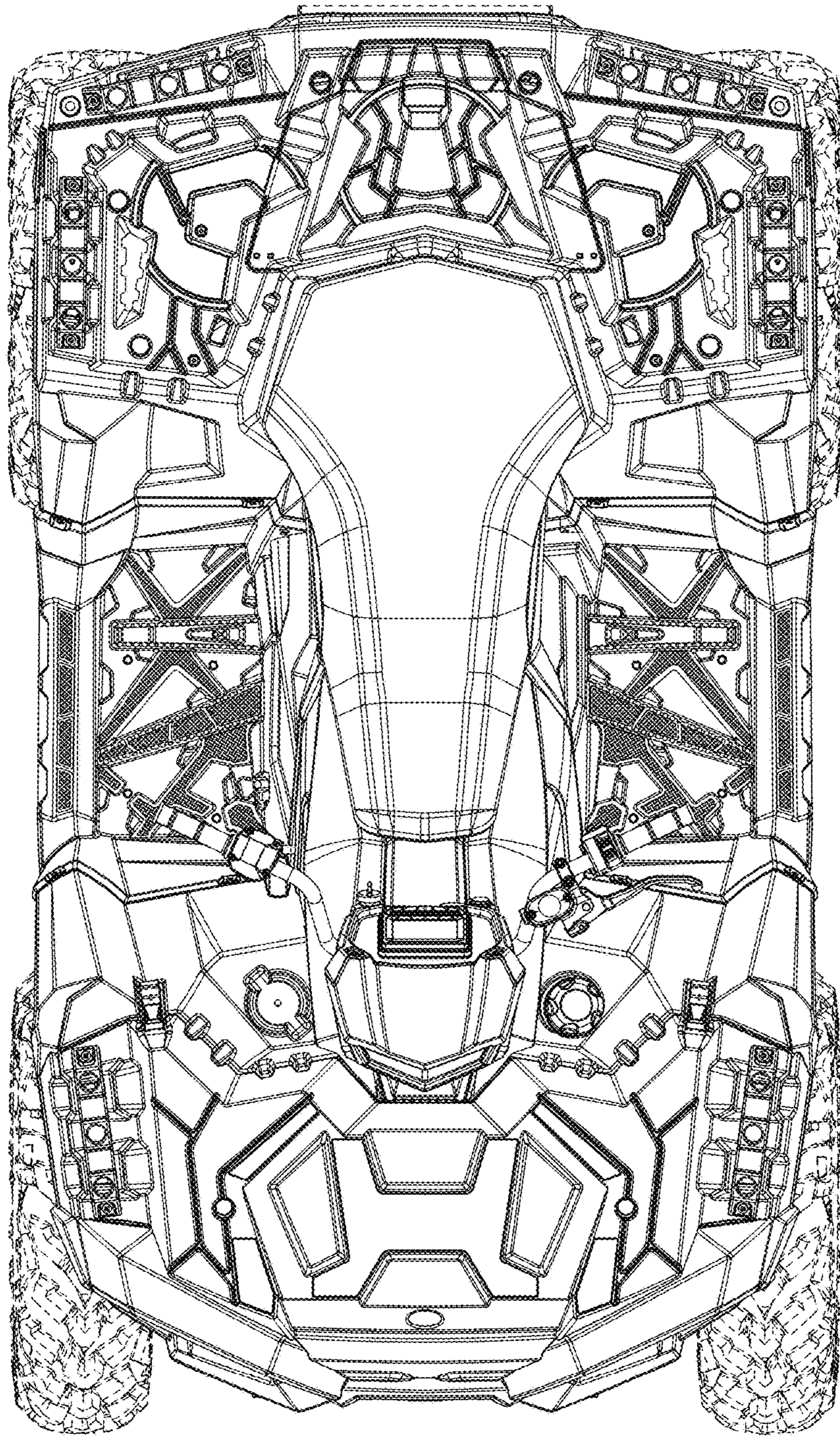

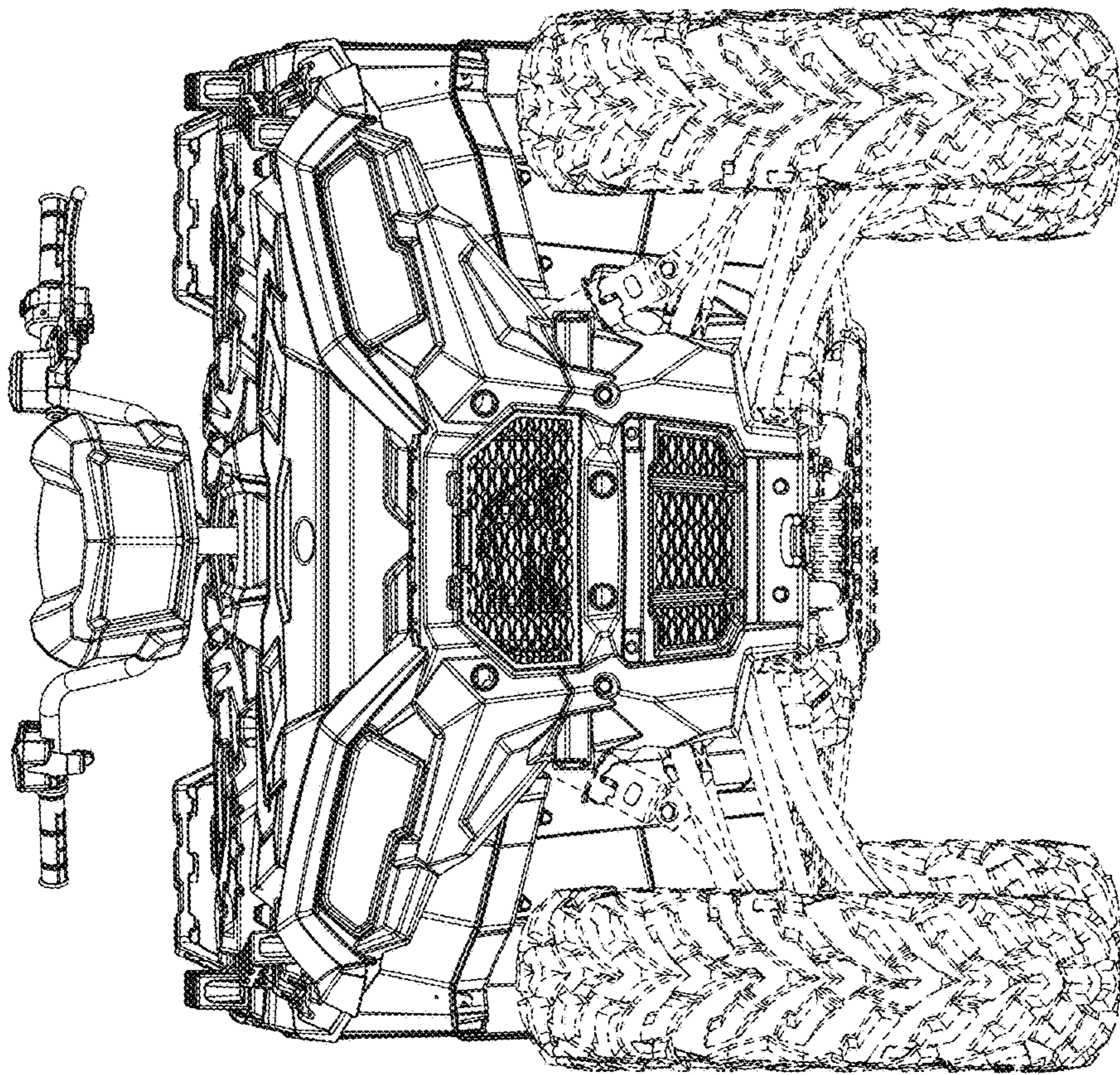

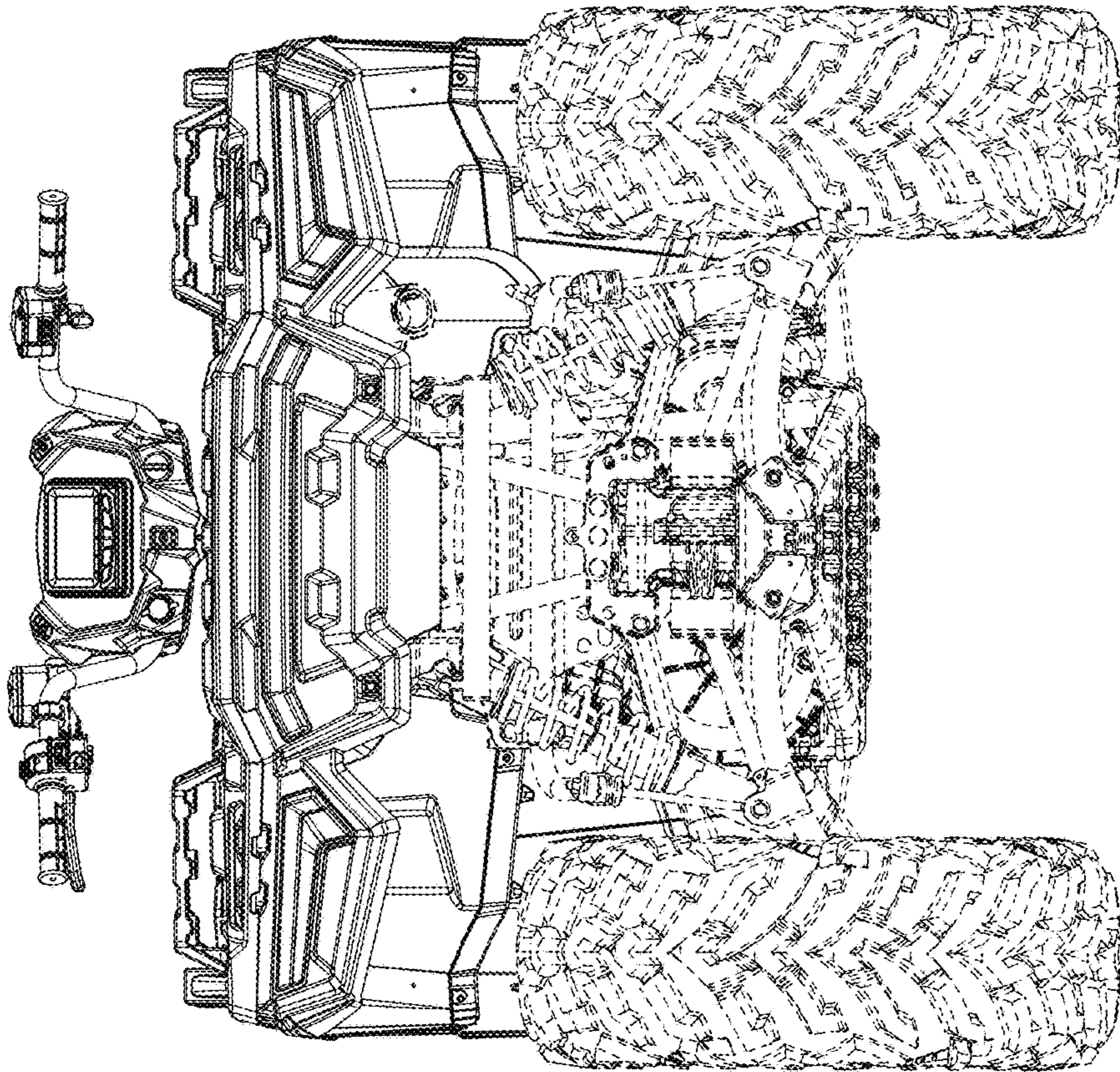
