FIG. 3 is a back view of the gear shift knob of FIG. 1.

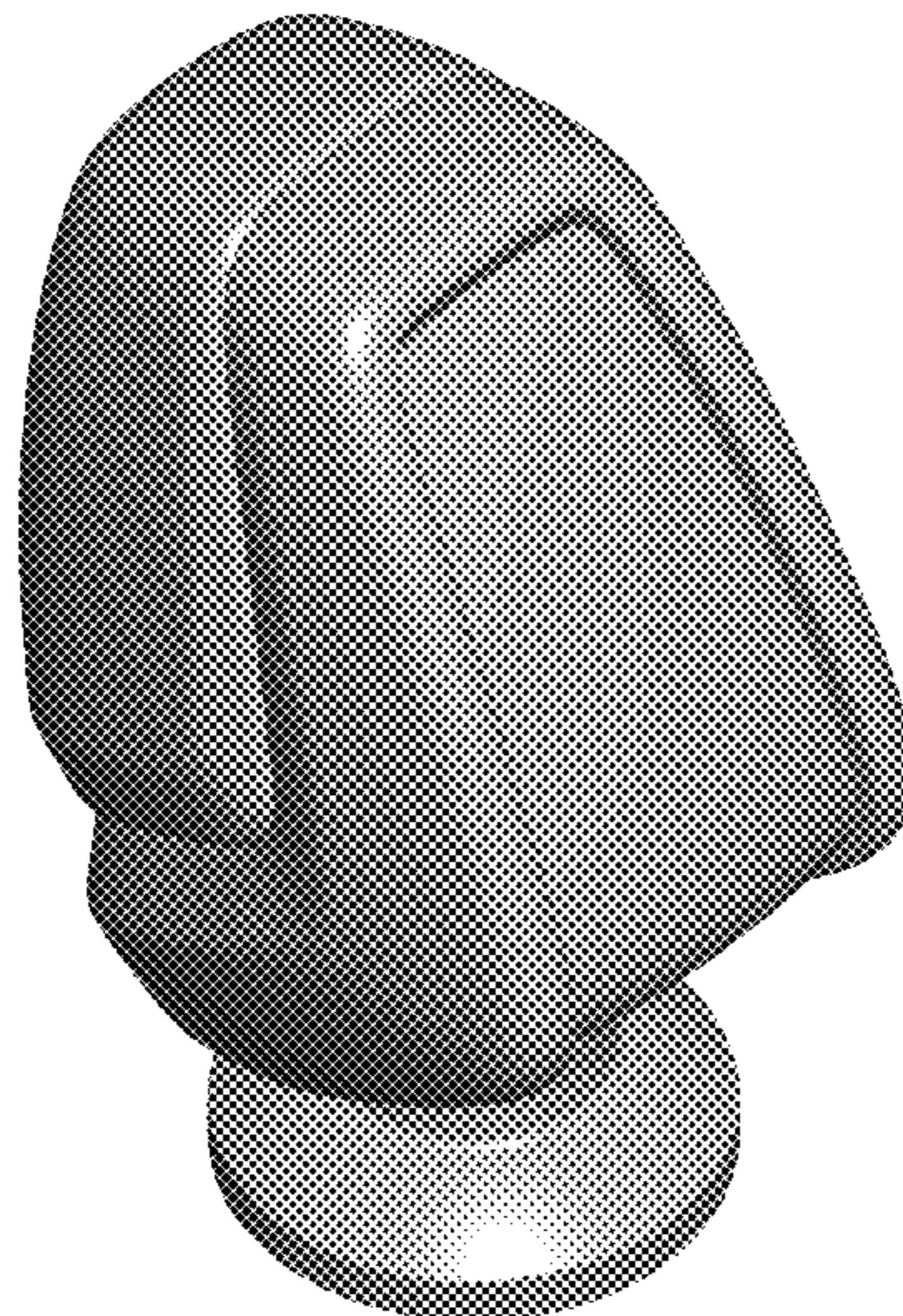
FIG. 4 is a left-side view of the gear shift knob of FIG. 1.

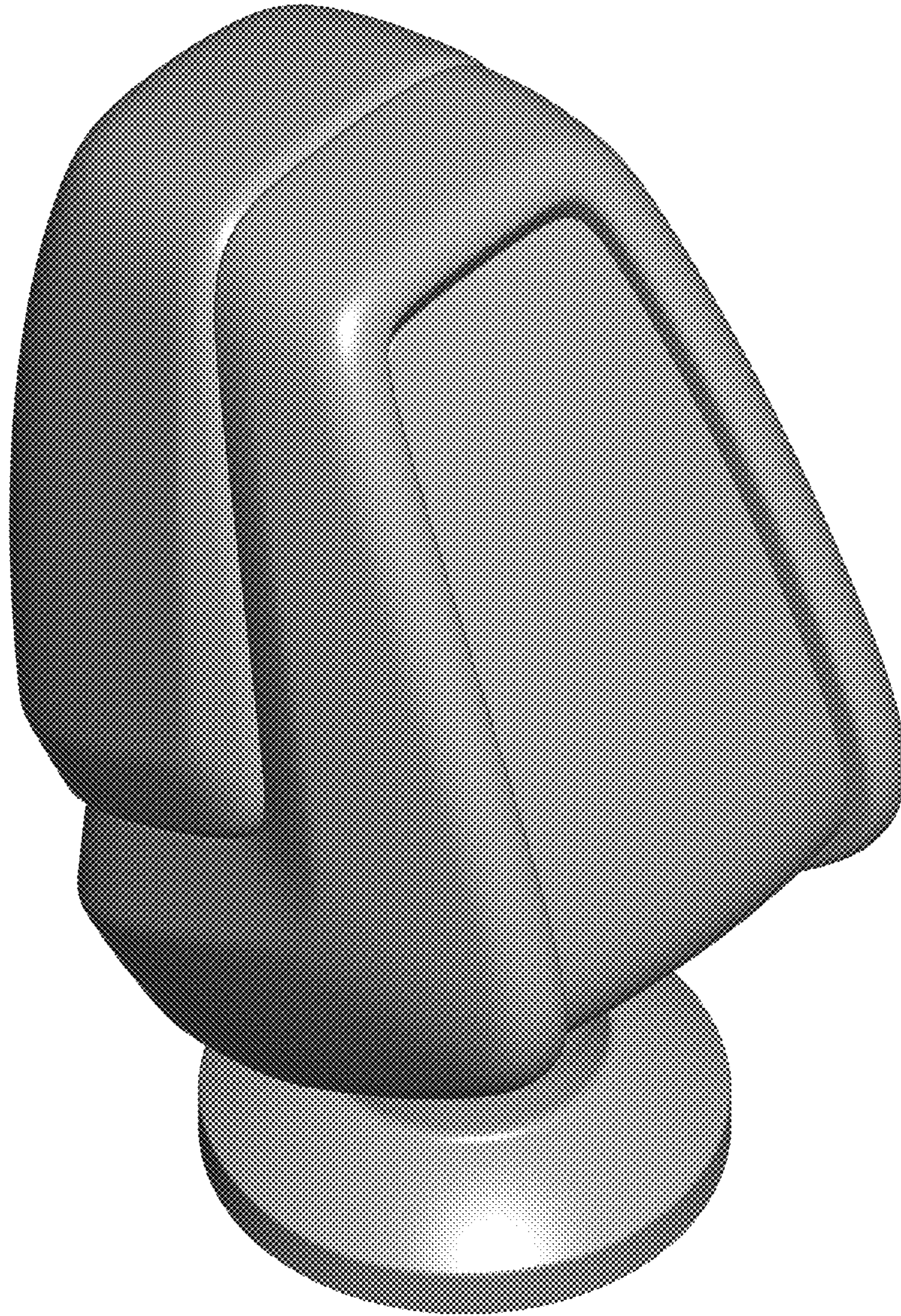

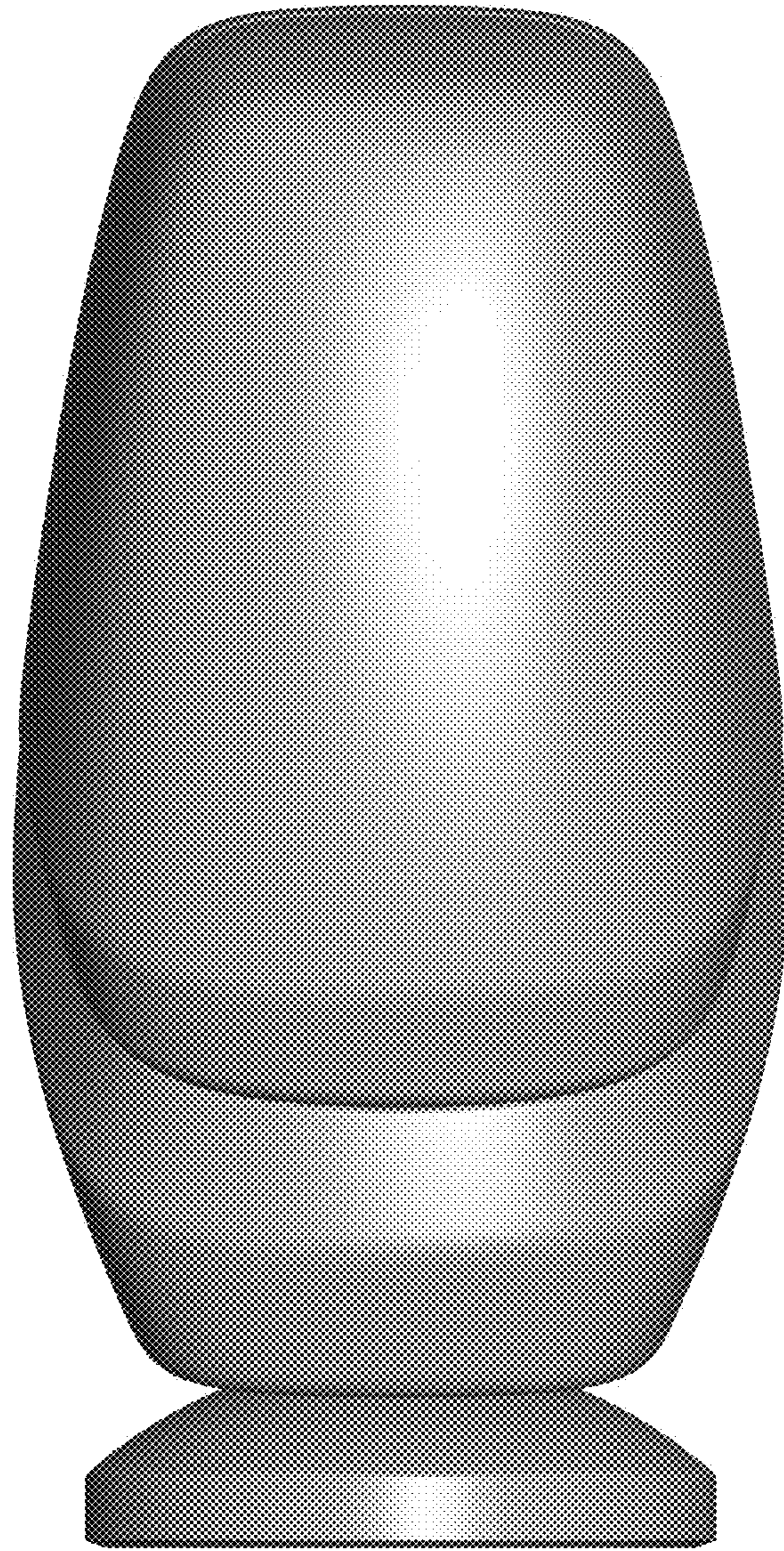

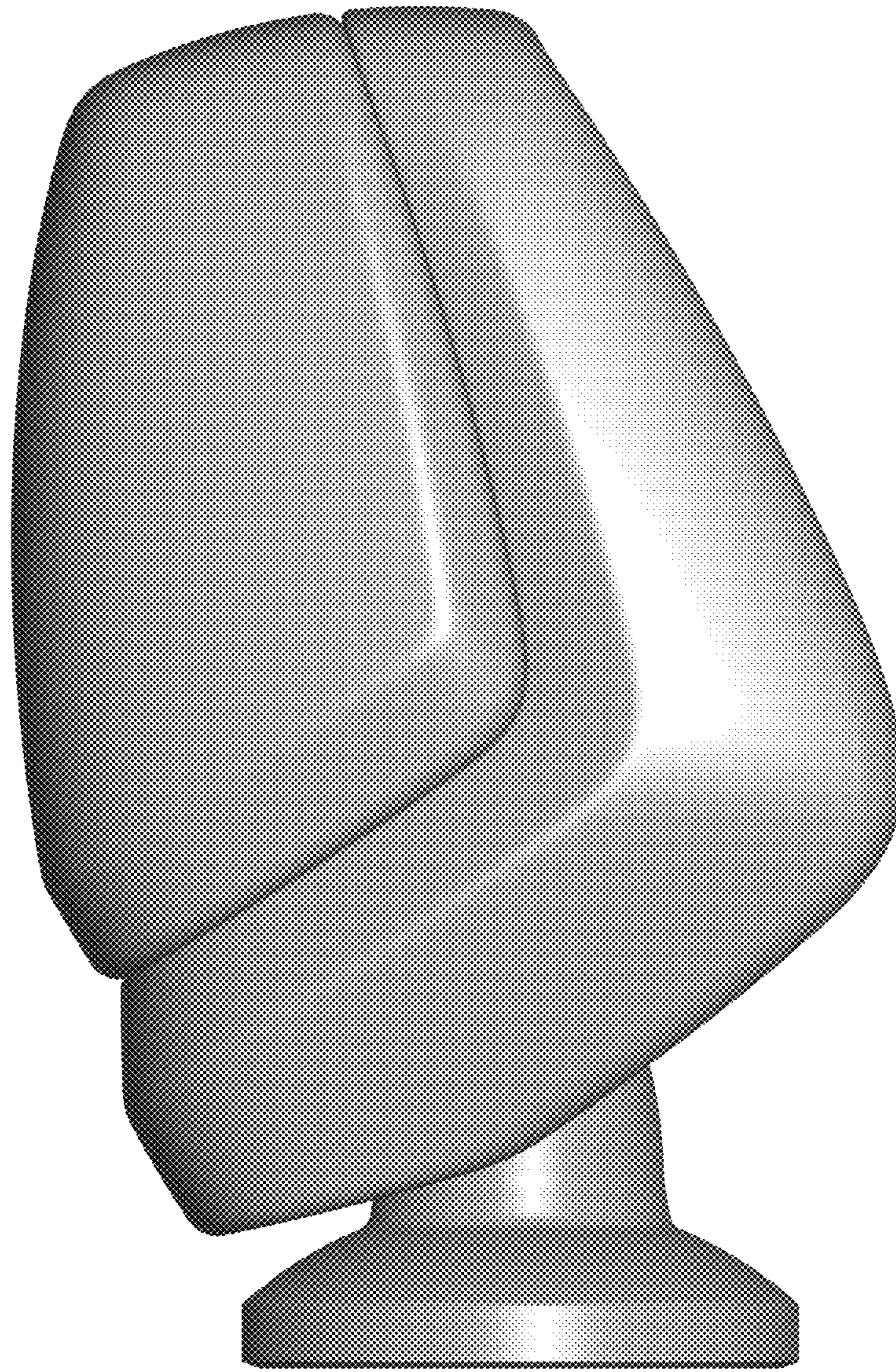

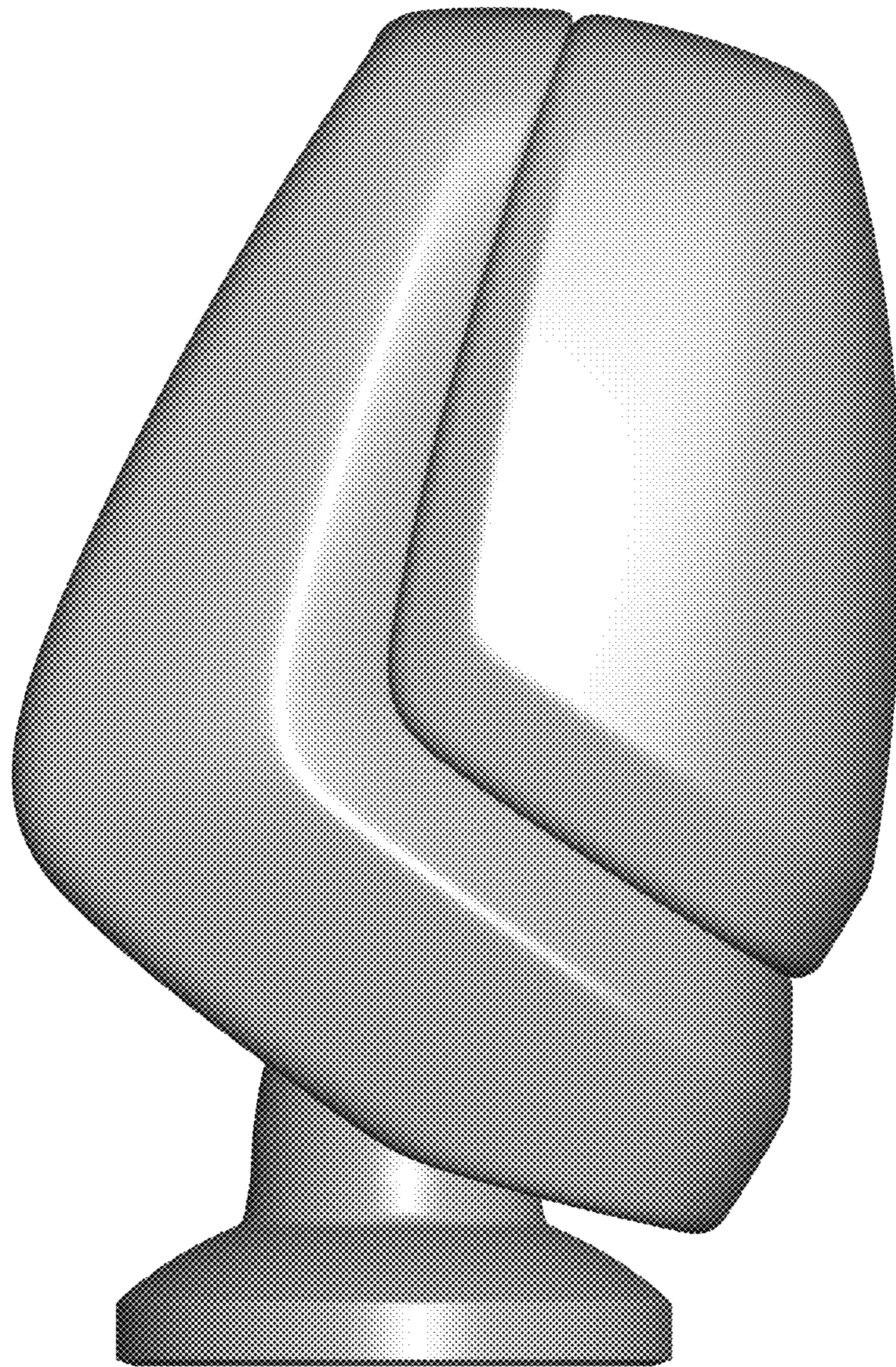

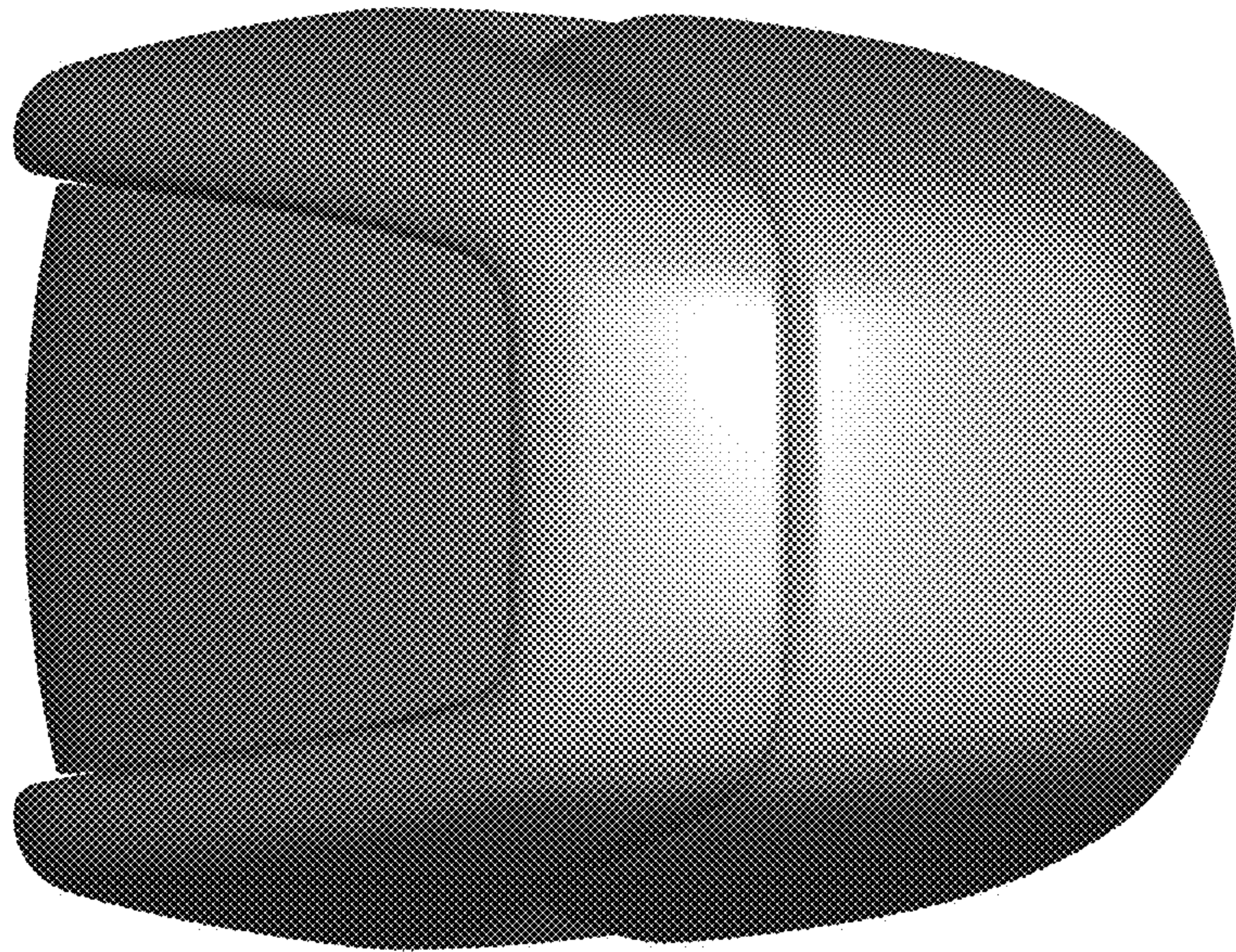

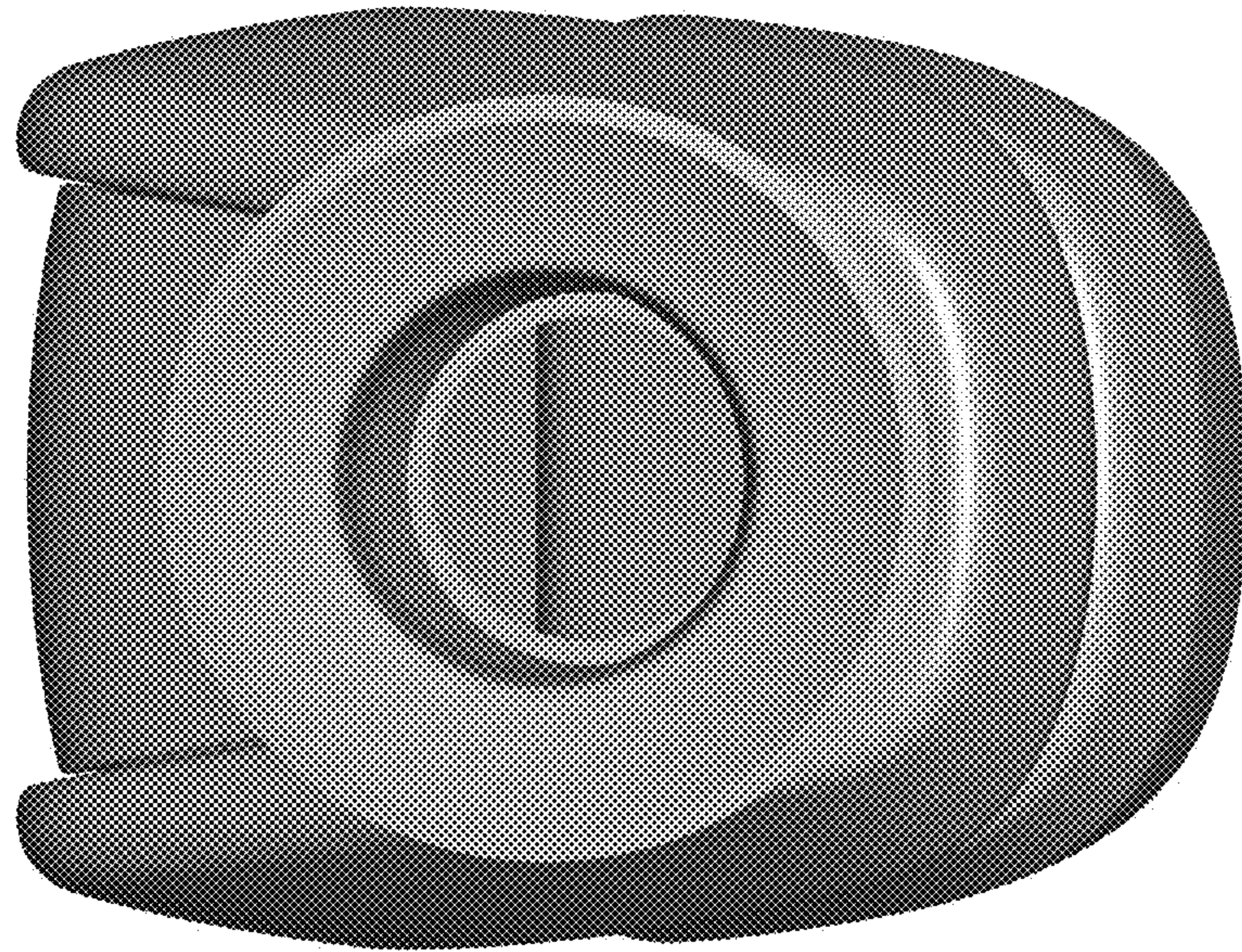
