(57) **CLAIM**

The ornamental design for a spoiler, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a spoiler for a vehicle according to the present invention.
 FIG. 2 is a right side view thereof.
 FIG. 3 is a top view thereof.
 FIG. 4 is a rear view thereof.
 FIG. 5 is a front view thereof.
 FIG. 6 is a rear right perspective view thereof.
 FIG. 7 is a front left perspective view thereof.
 FIG. 8 is a rear left perspective view thereof.
 FIG. 9 is a left side view thereof from below; and,
 FIG. 10 is a front right perspective view of the spoiler shown in FIGS. 1-9, with the spoiler mounted on a vehicle shown in de-emphasized and half-tone portions so as to illustrate environmental structures for the vehicle rear. These portions form no part of the claimed invention. More particularly, in FIG. 10, the spoiler of the present invention is shown within the broken line, and any elements shown outside of the broken line form no part of the claimed invention, but are instead included to show environmental aspects of the claimed invention.

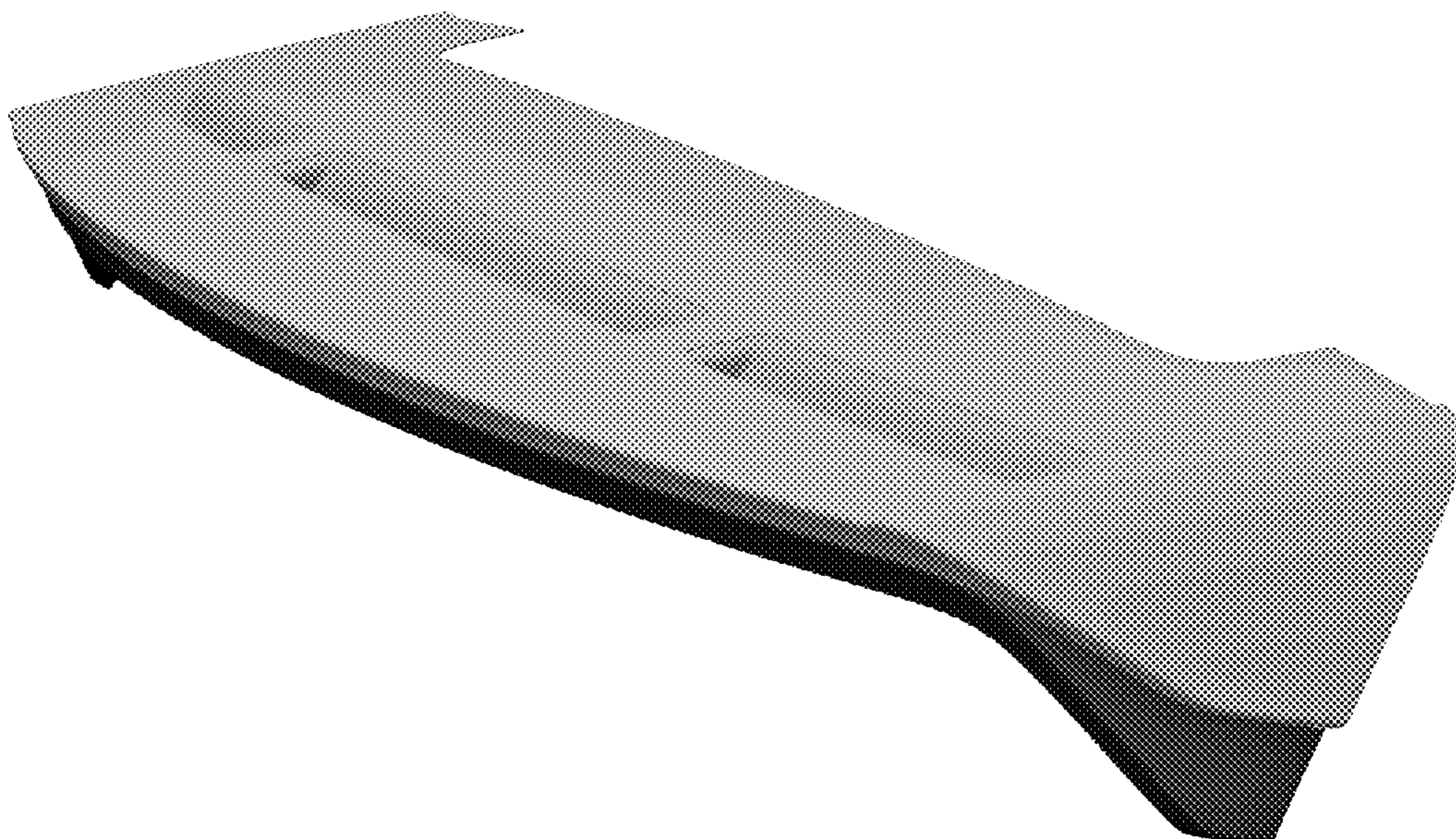

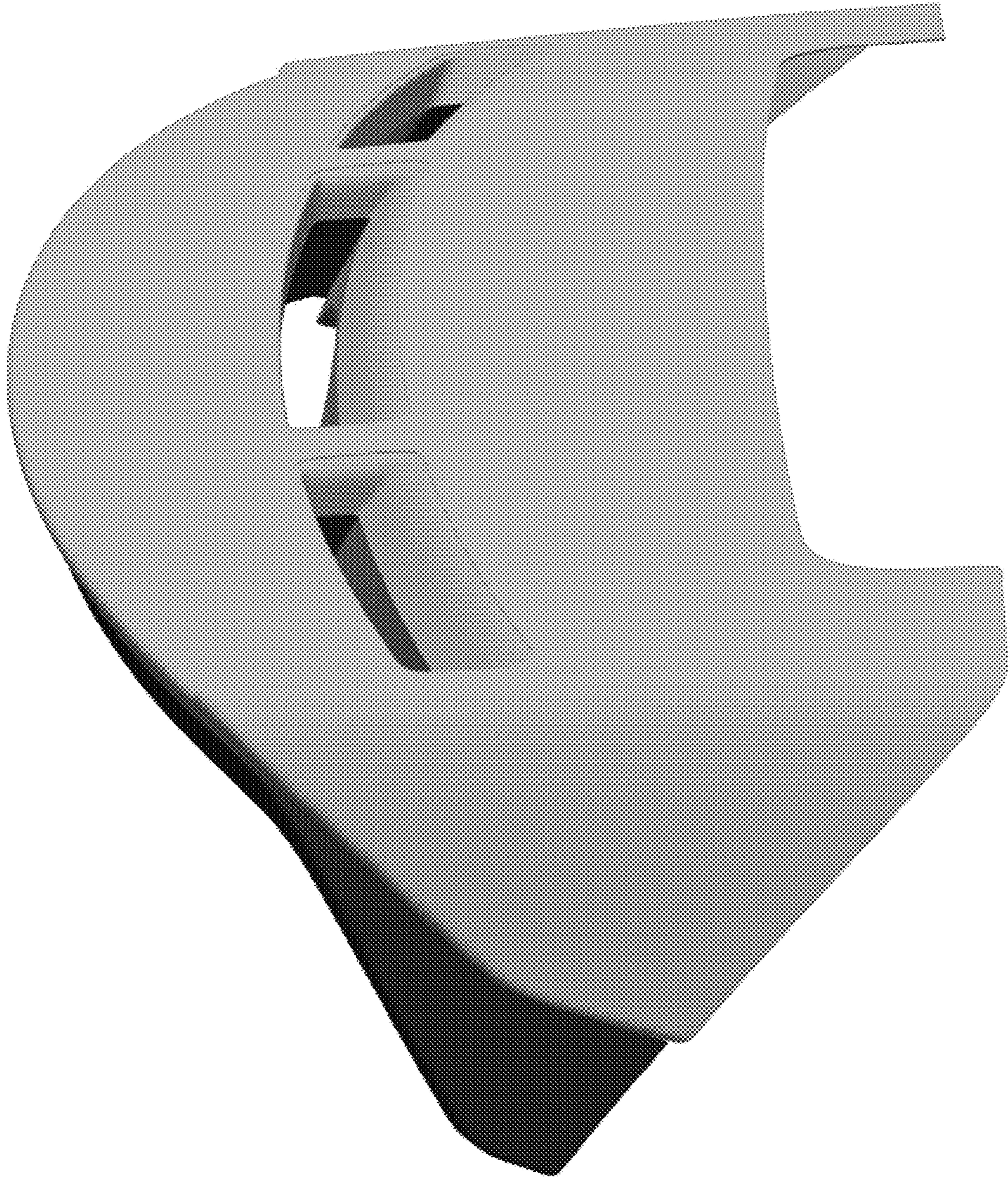

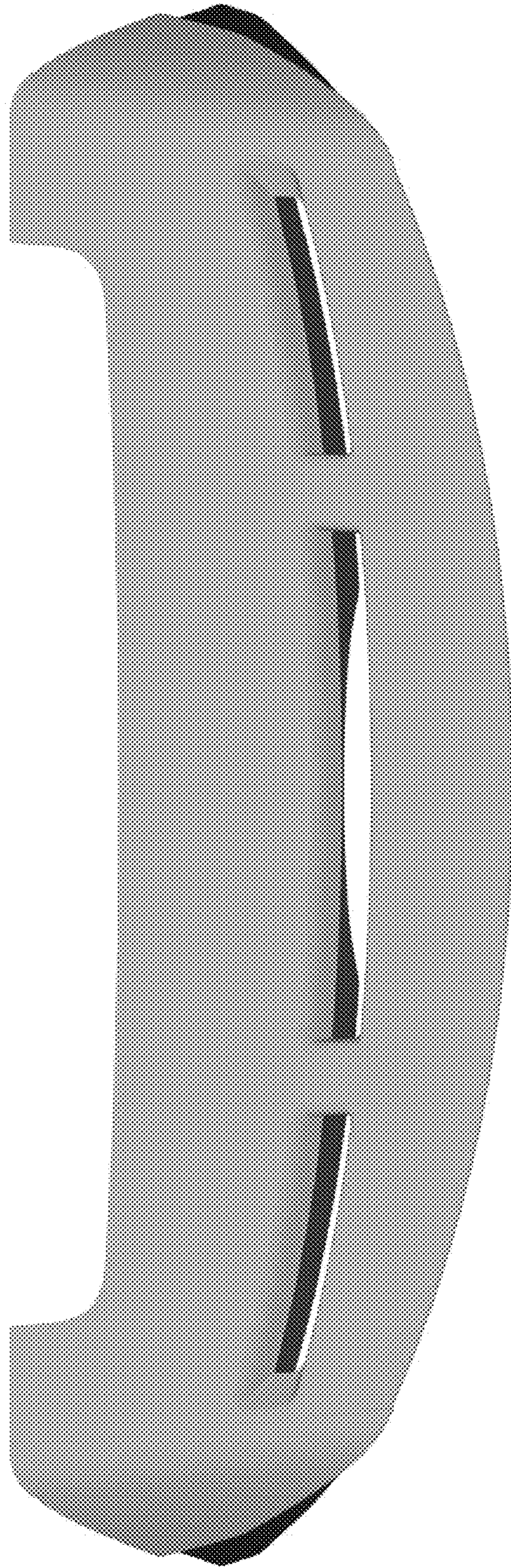

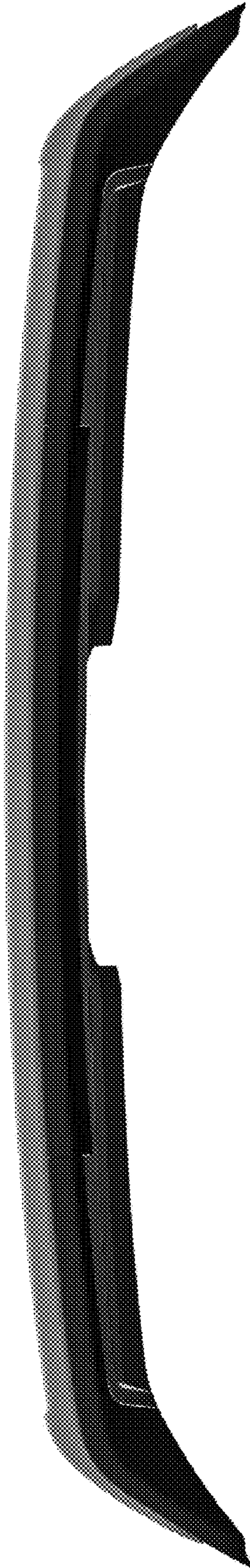

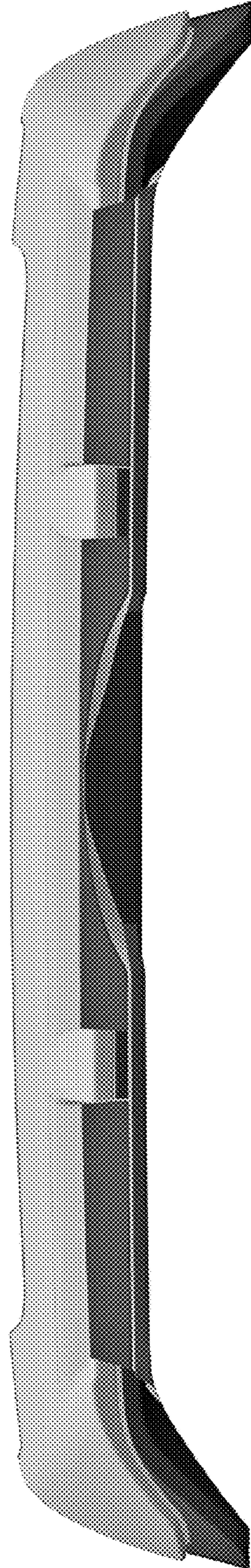

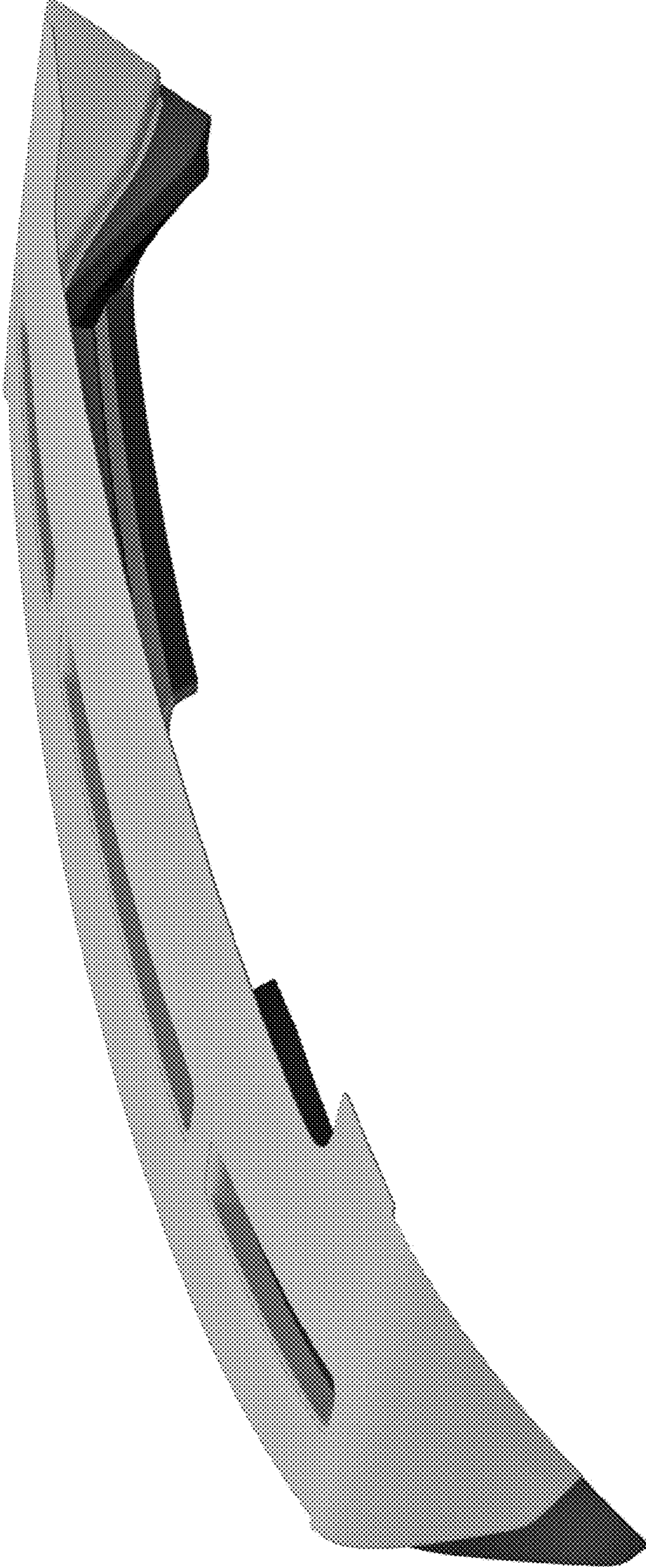

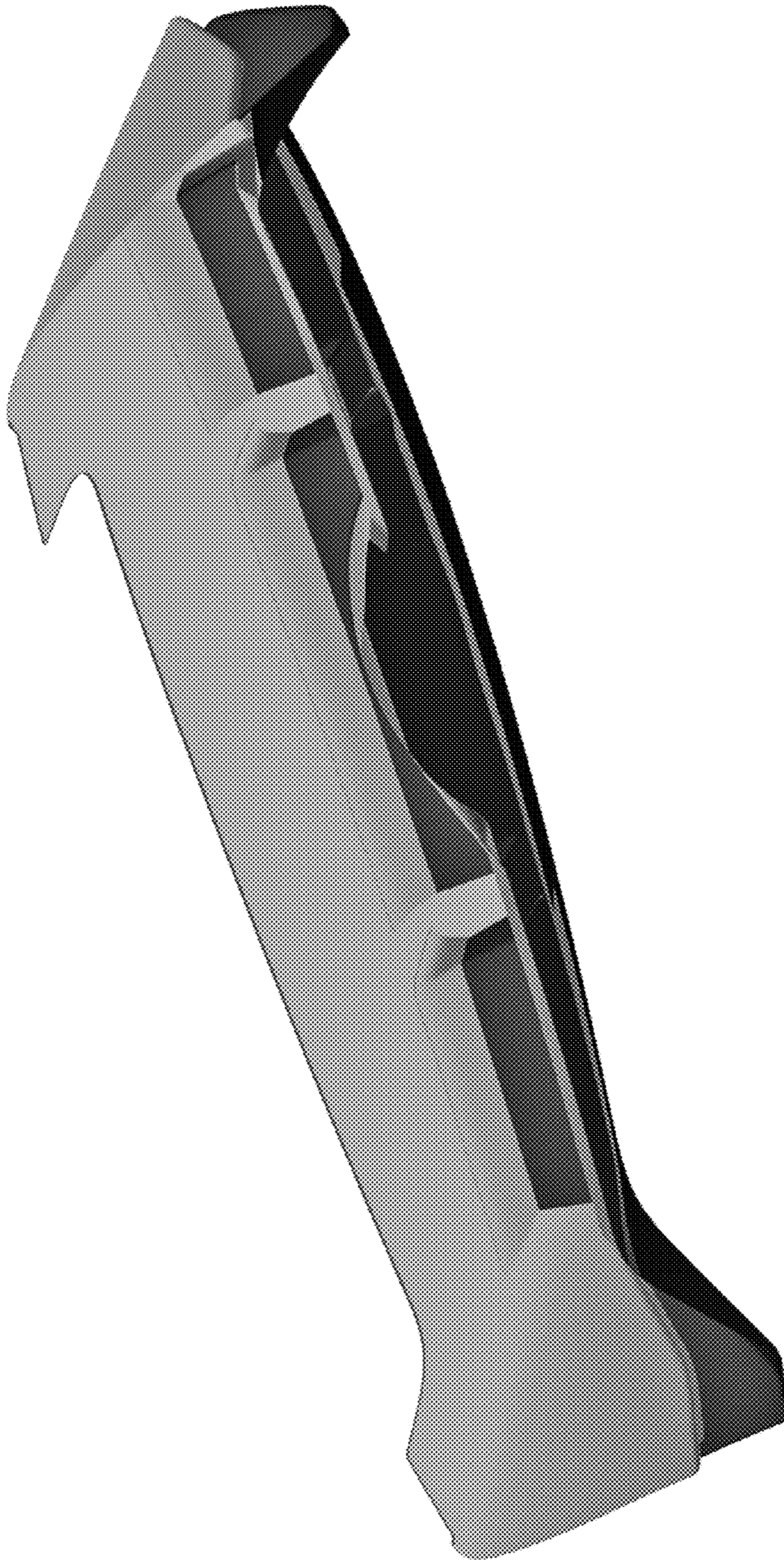

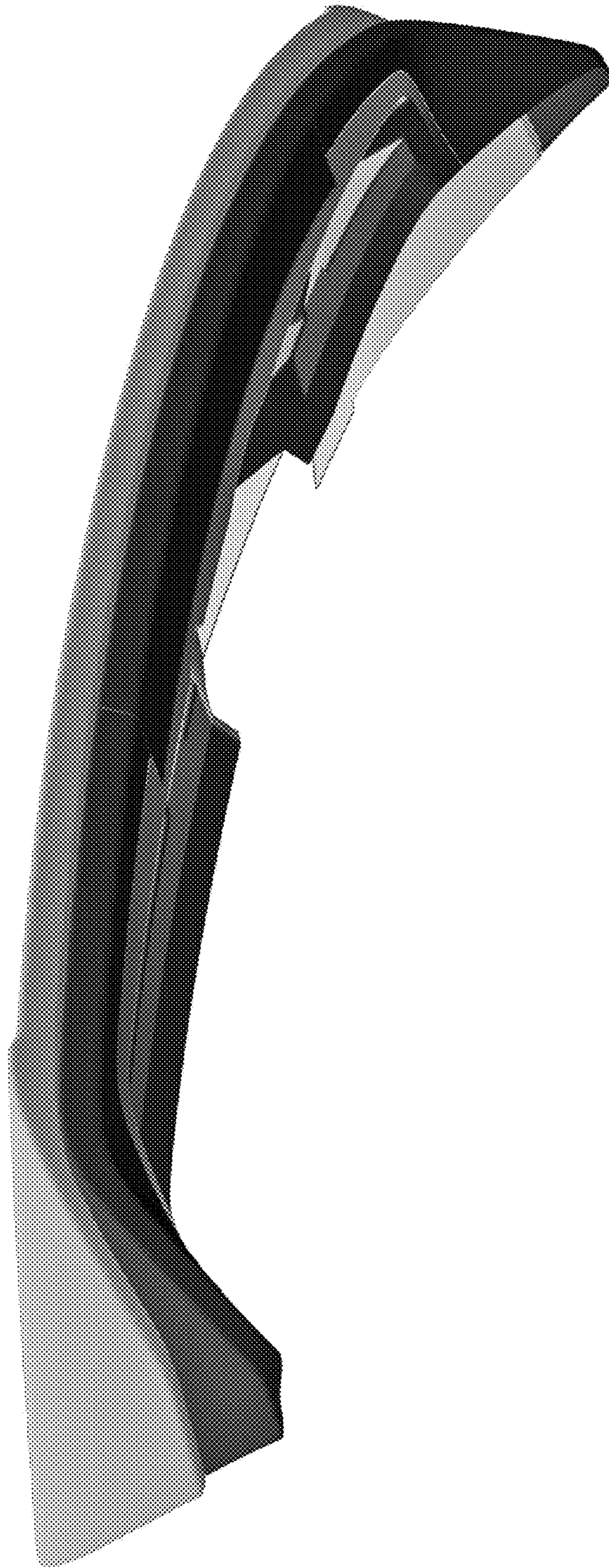

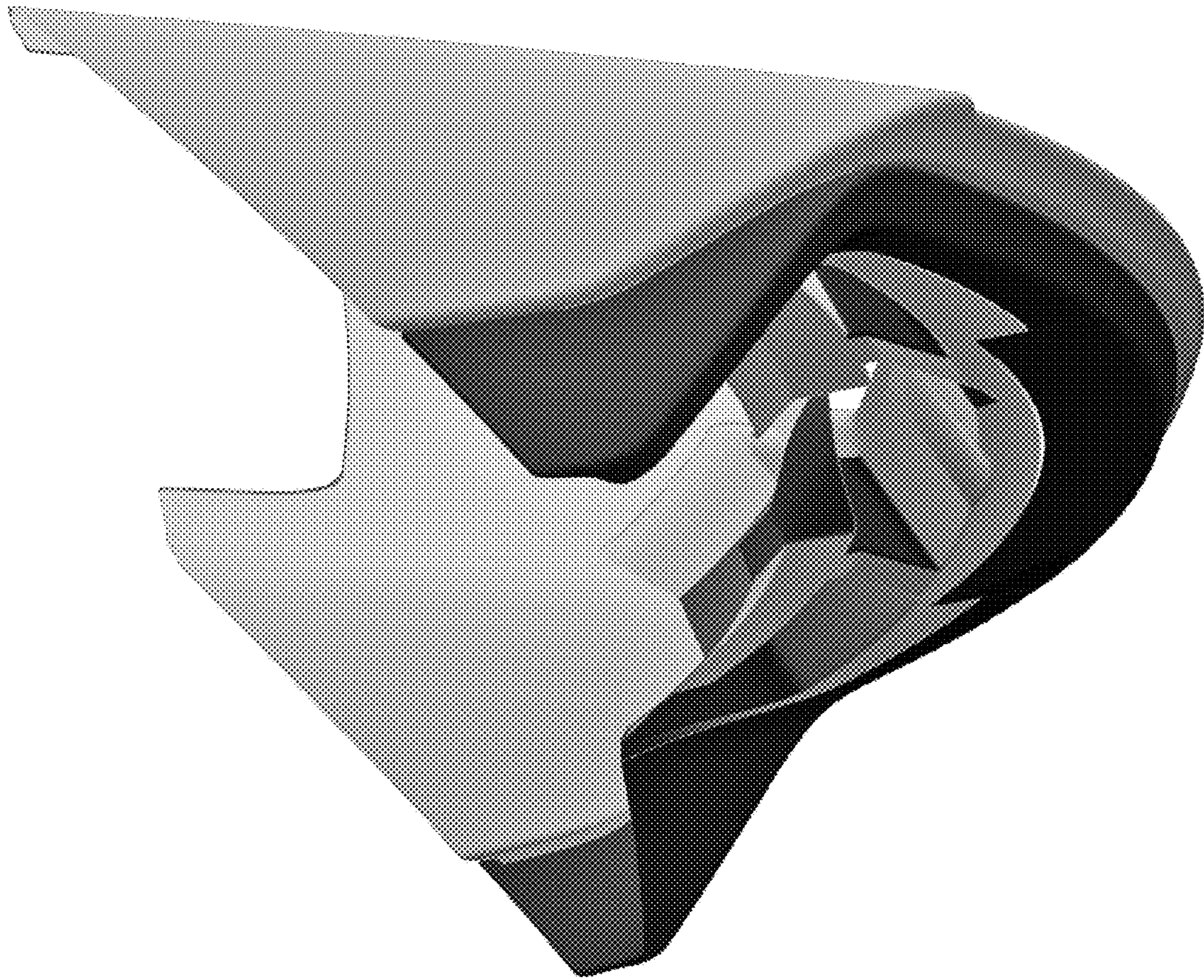

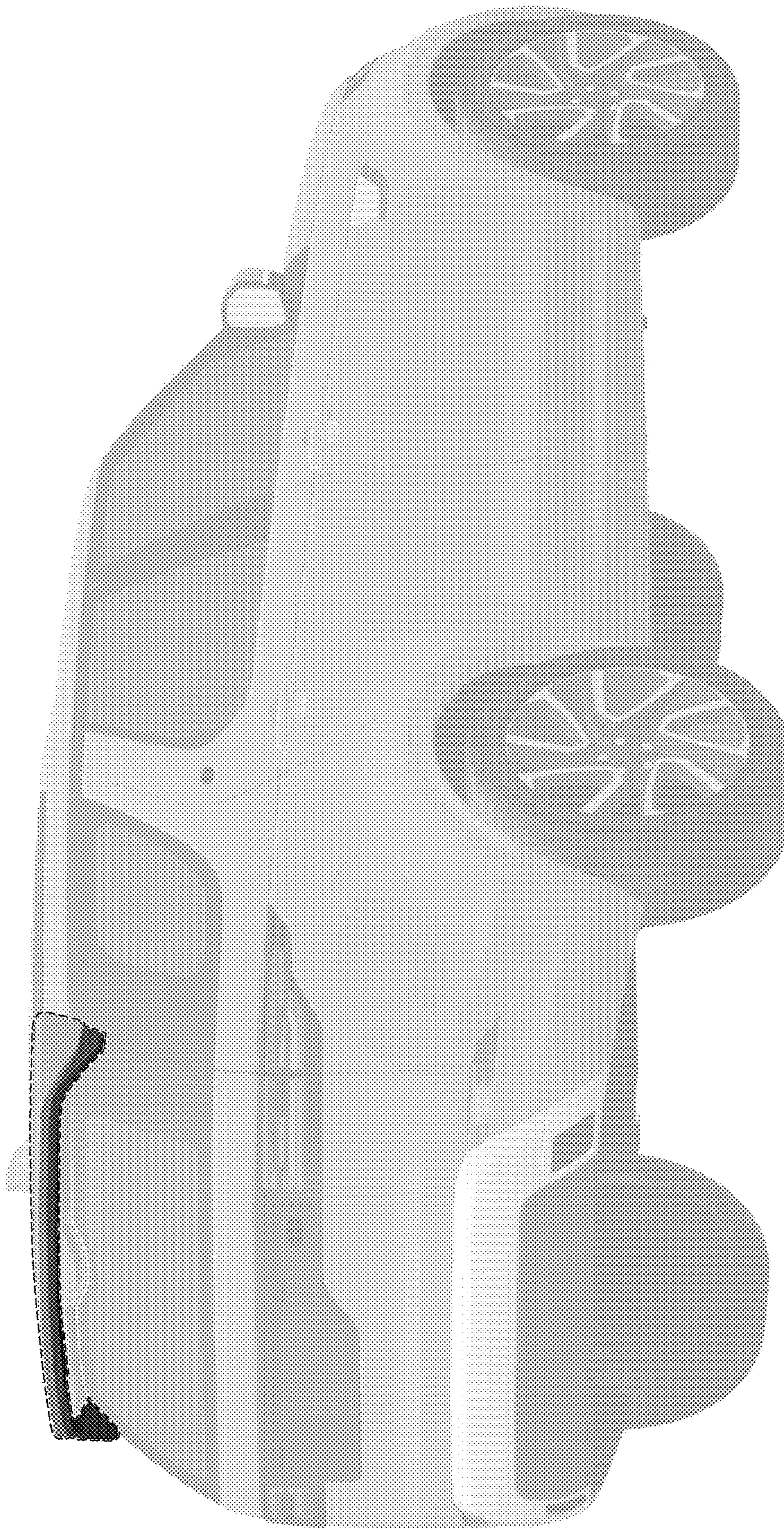
