(57) **CLAIM**

The ornamental design for a tire for motorcycle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tire for motorcycle showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a top view thereof;
FIG. 8 is a partial enlarged view of FIG. 2; illustrating the repeating pattern of the tread grooves;
FIG. 9 is a partial cross-section along the line 9-9 in FIG. 2, illustrating the depth of the grooves in the repeating pattern; and,
FIG. 10 is a partial cross-section along the line 10-10 in FIG. 2, illustrating the depth of the grooves in the repeating pattern.

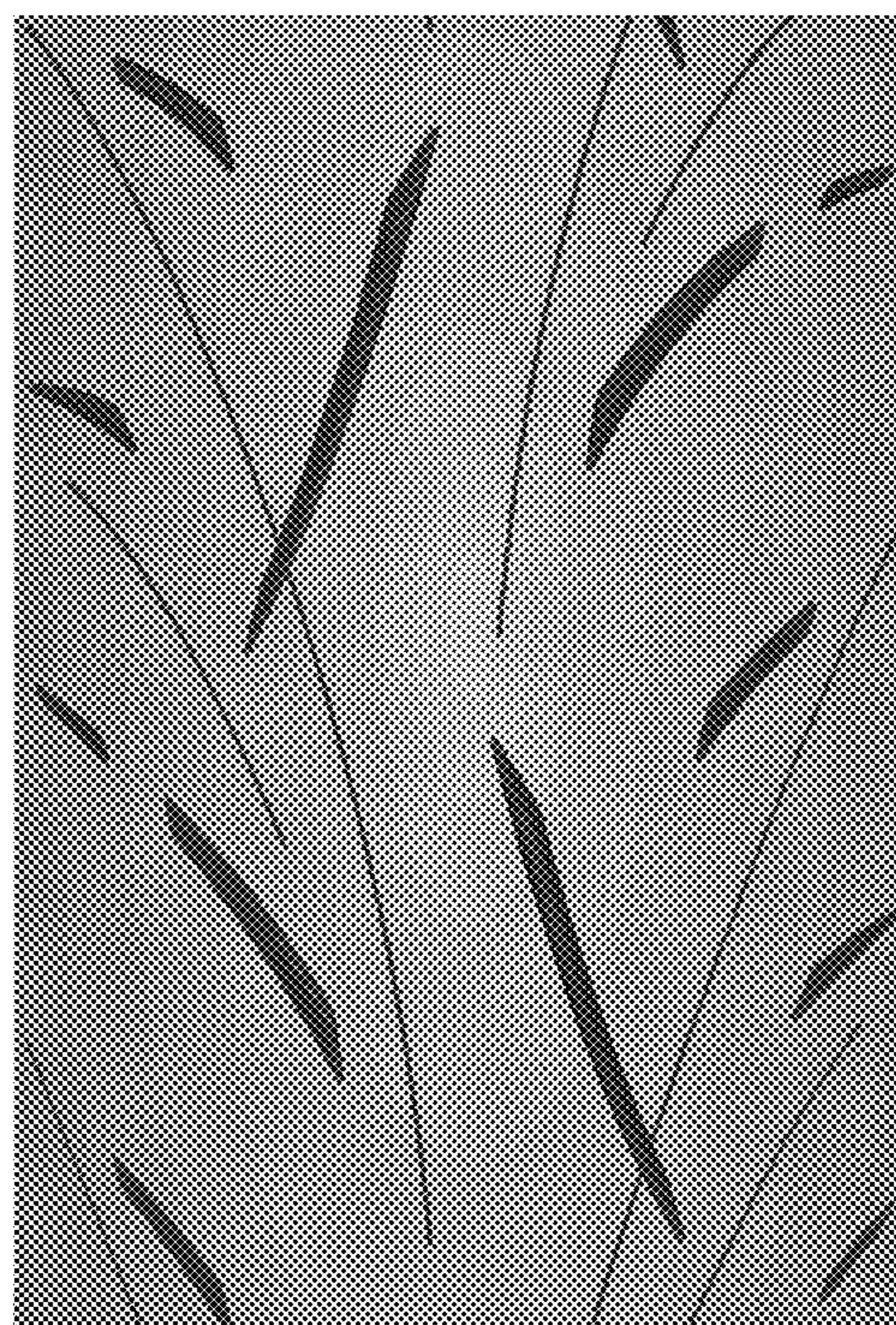

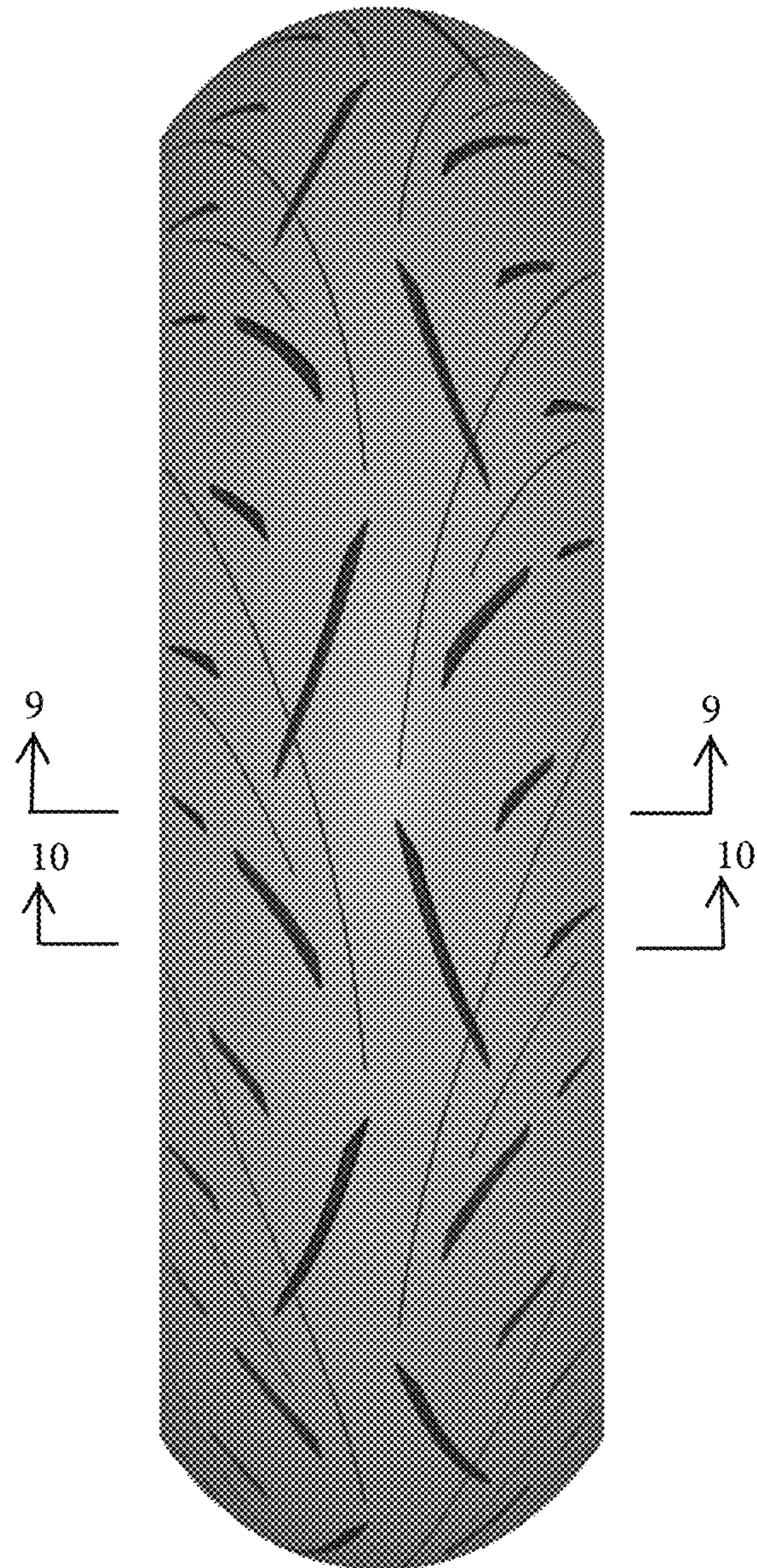

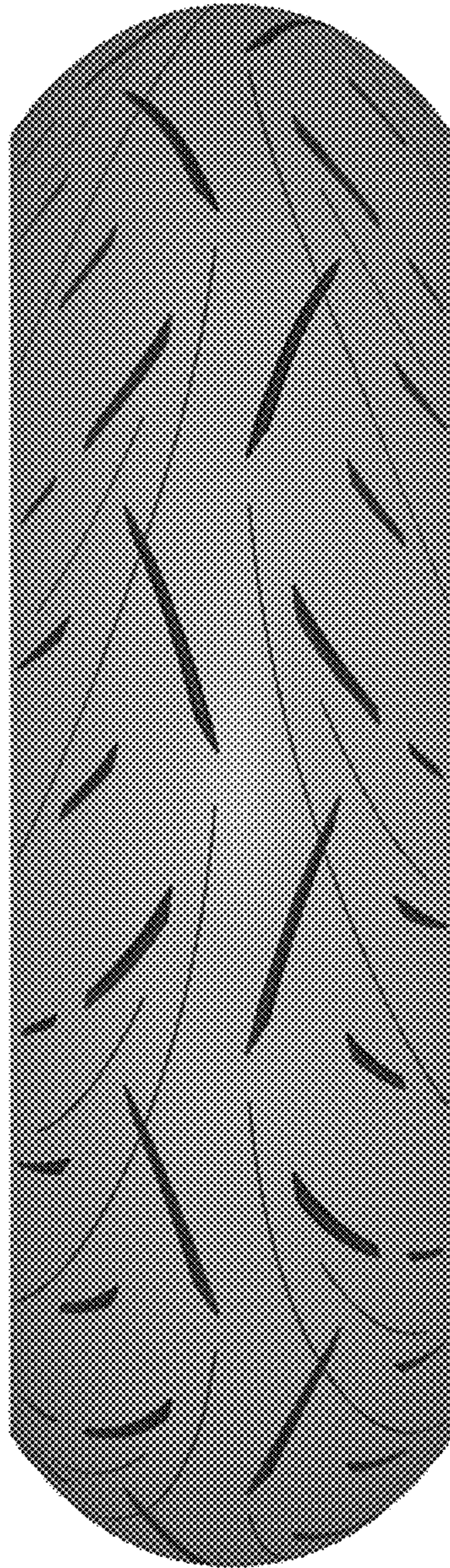

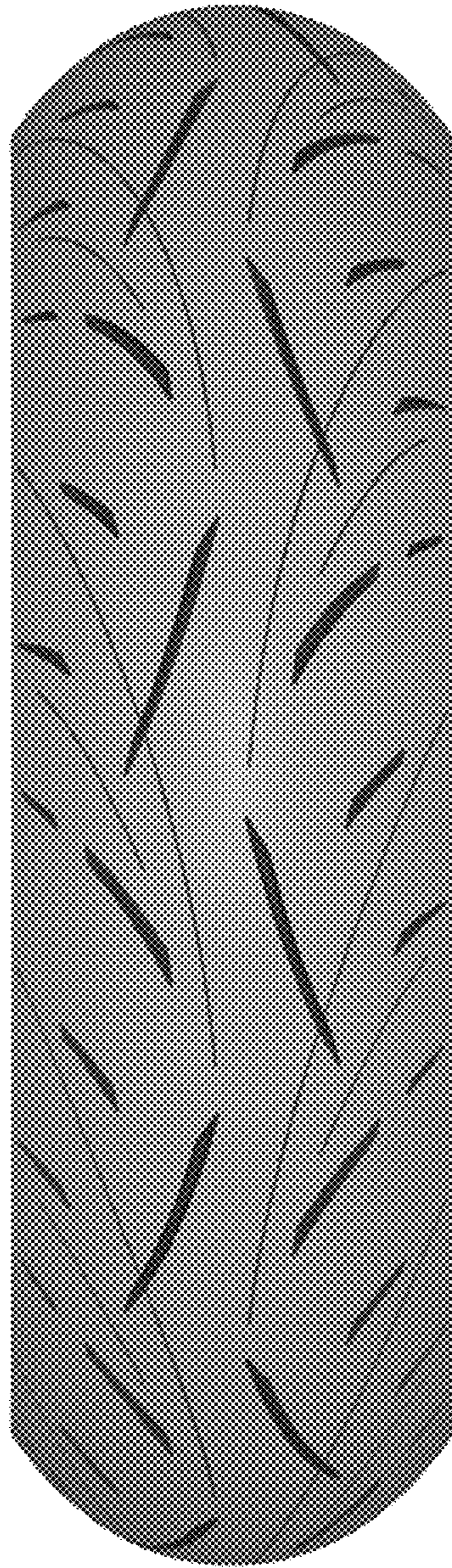

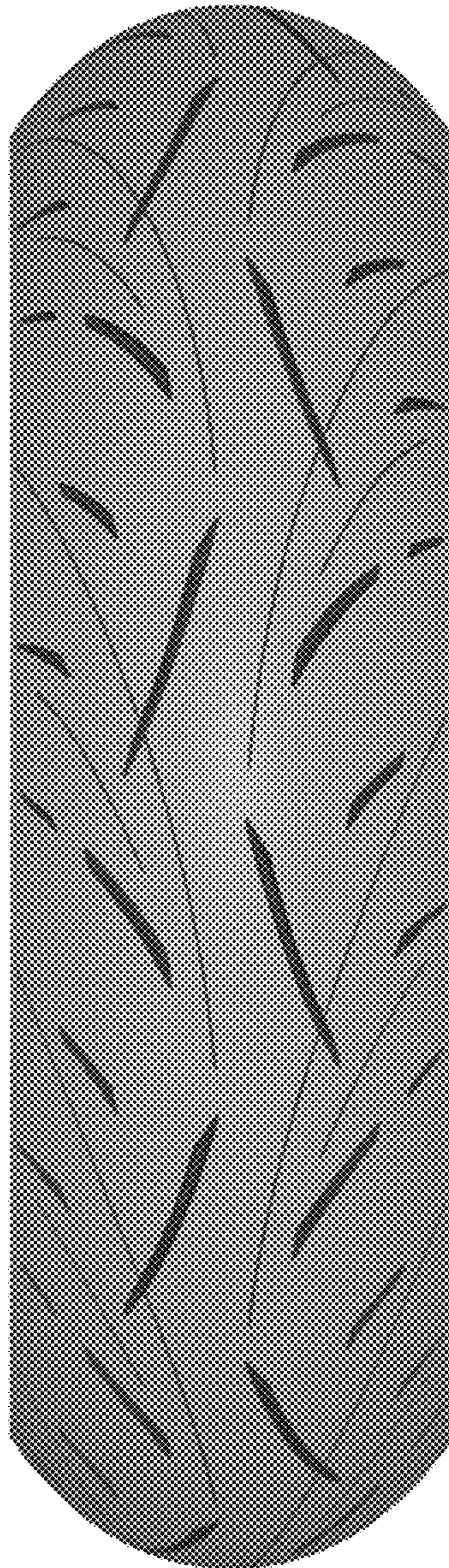

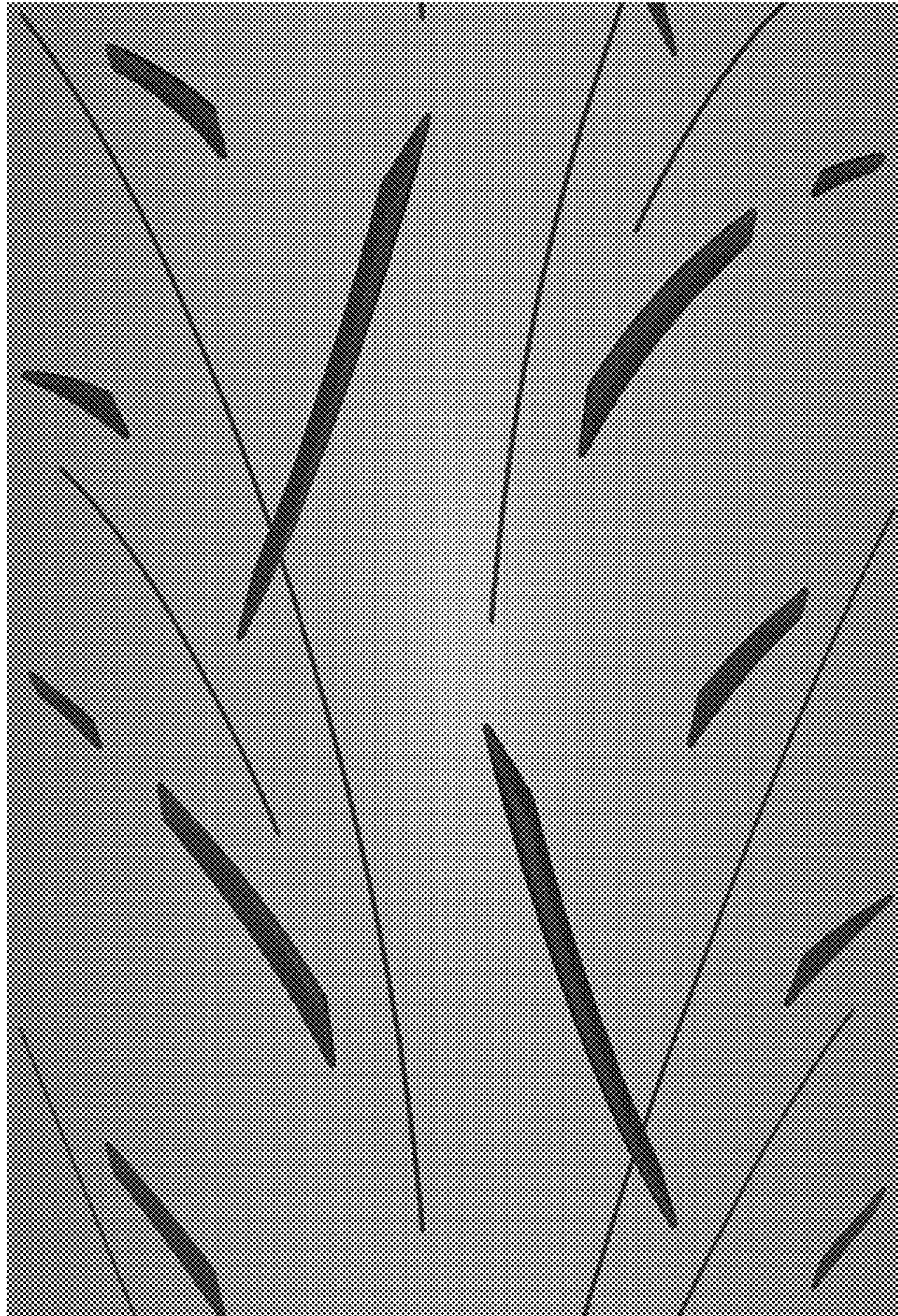

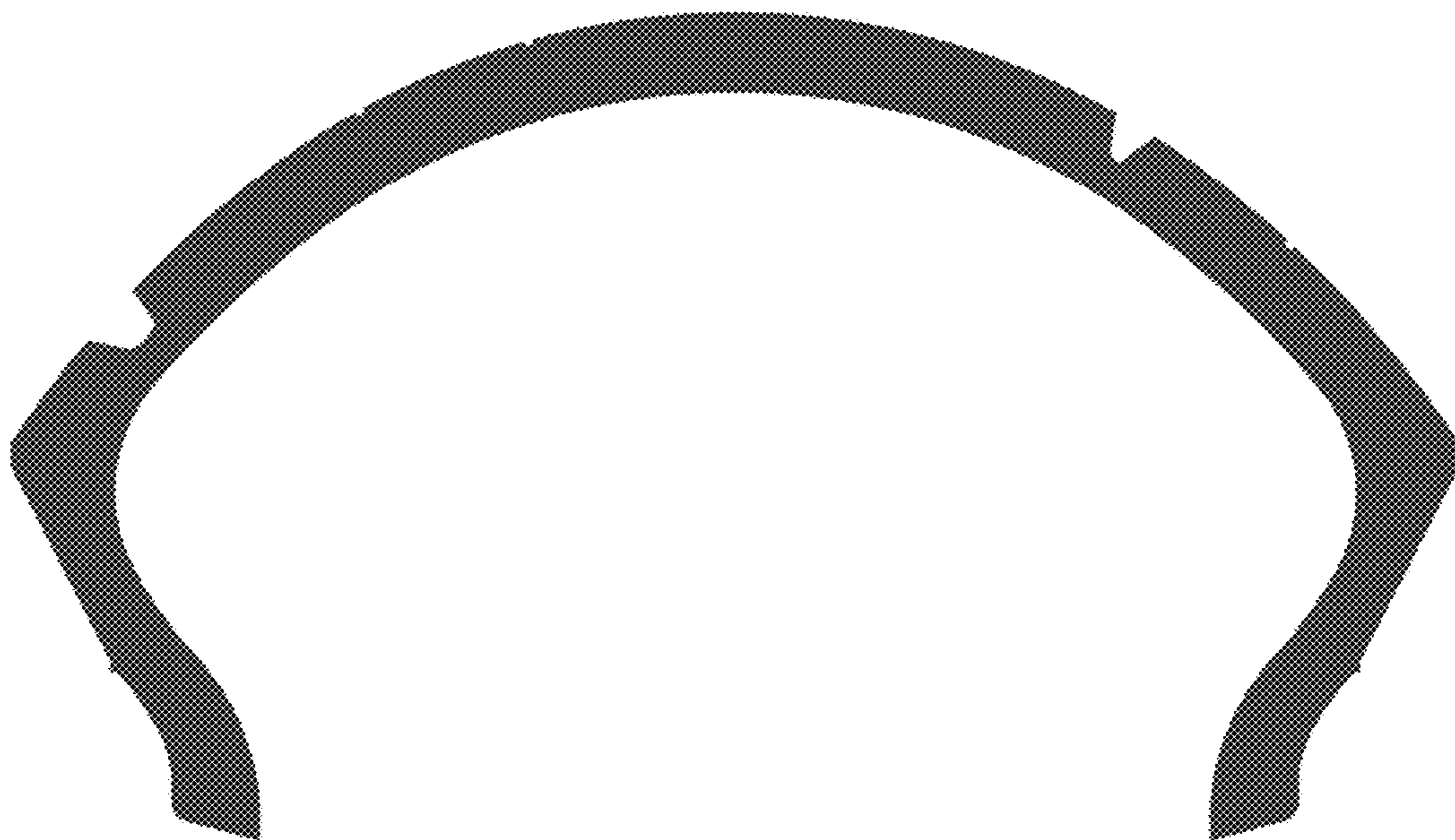

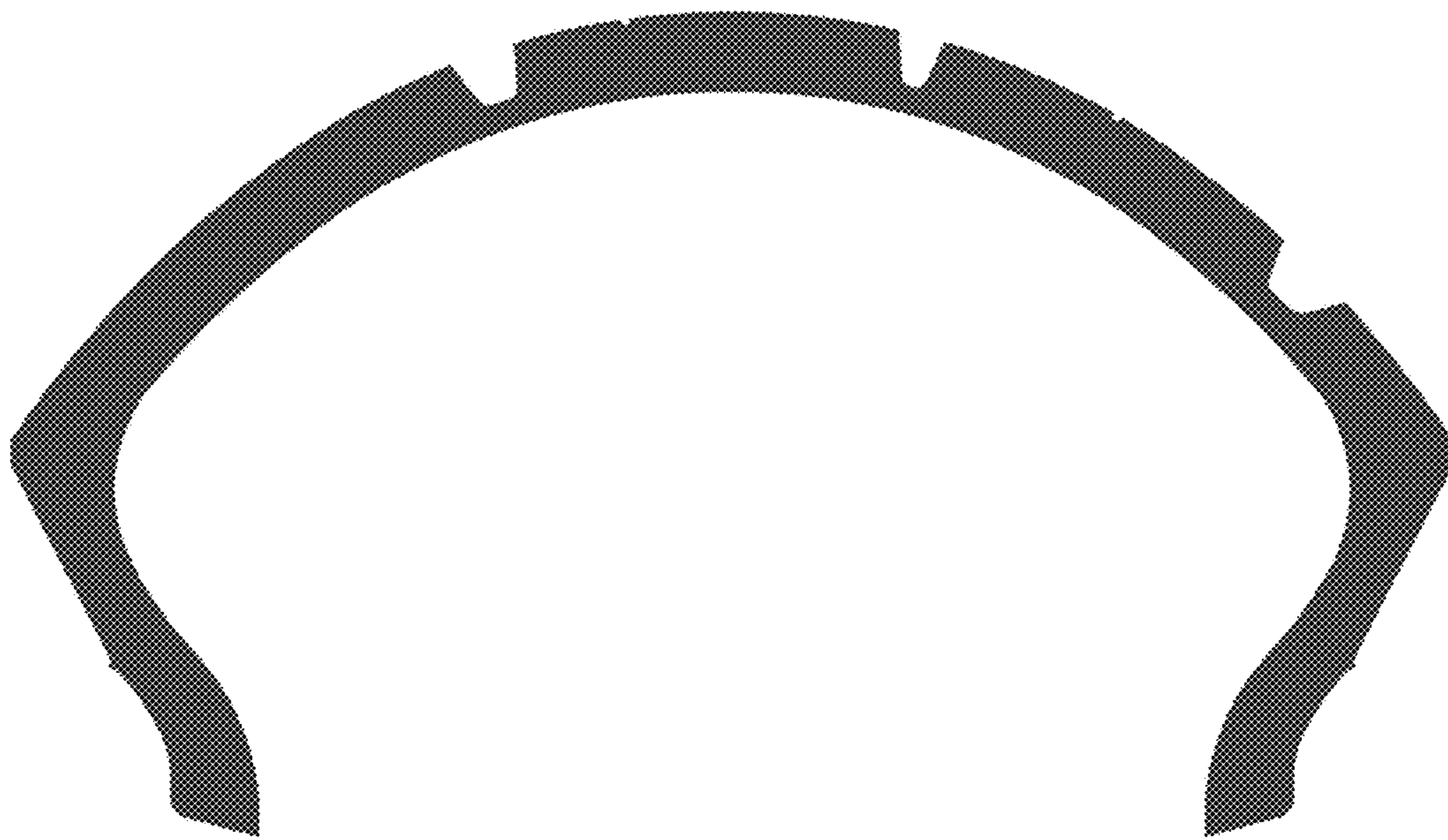
