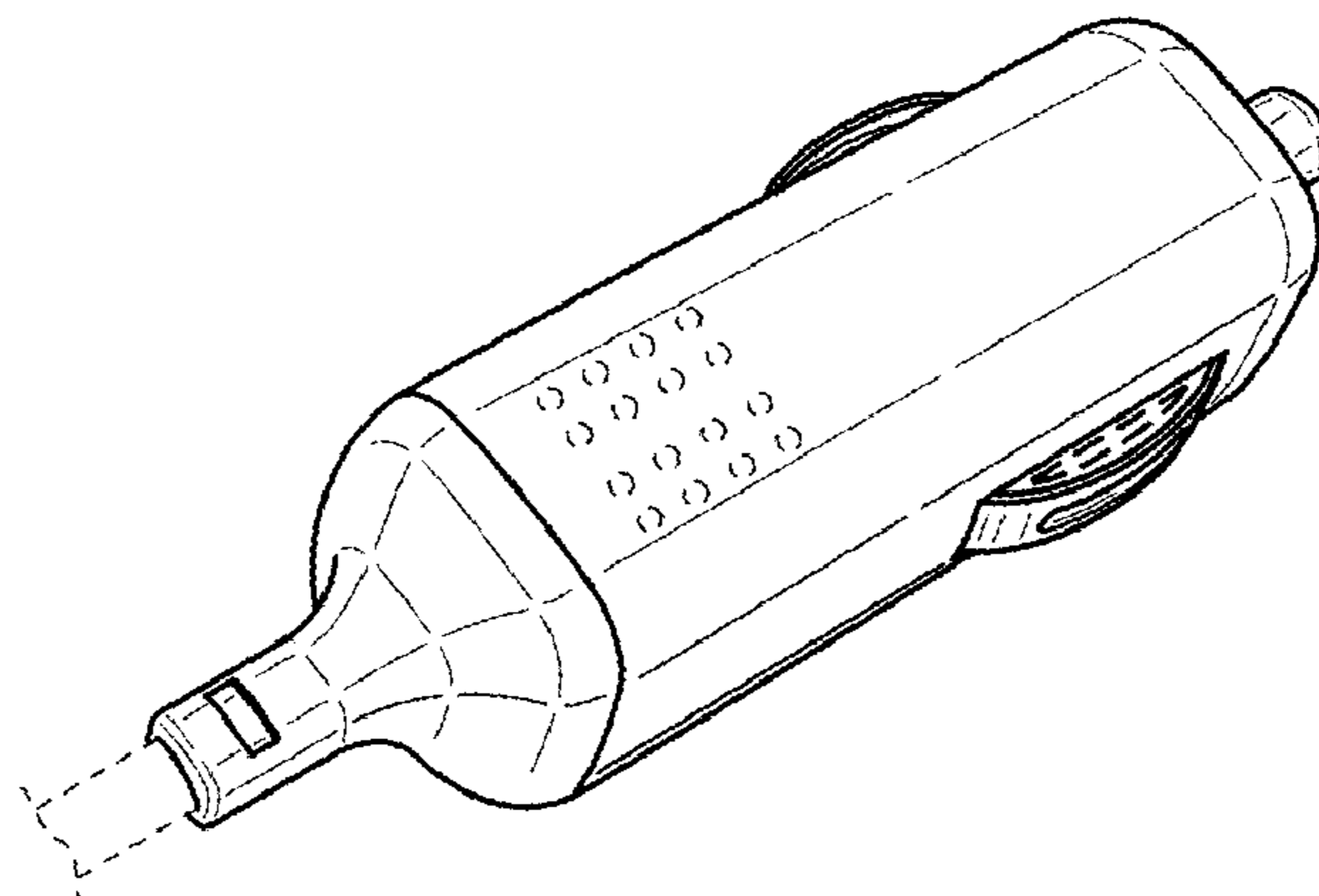
(57) **CLAIM**

I claim the ornamental design for a car charger, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a car charger showing my new design;
FIG. 2 is a front side view thereof, the rear side view being a mirror image thereof;
FIG. 3 is a right side view thereof, the left side view being a mirror image thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is a front side view thereof, shown in an environment of use.
The broken lines in the figures represent portions of the article which form no part of the claimed design.

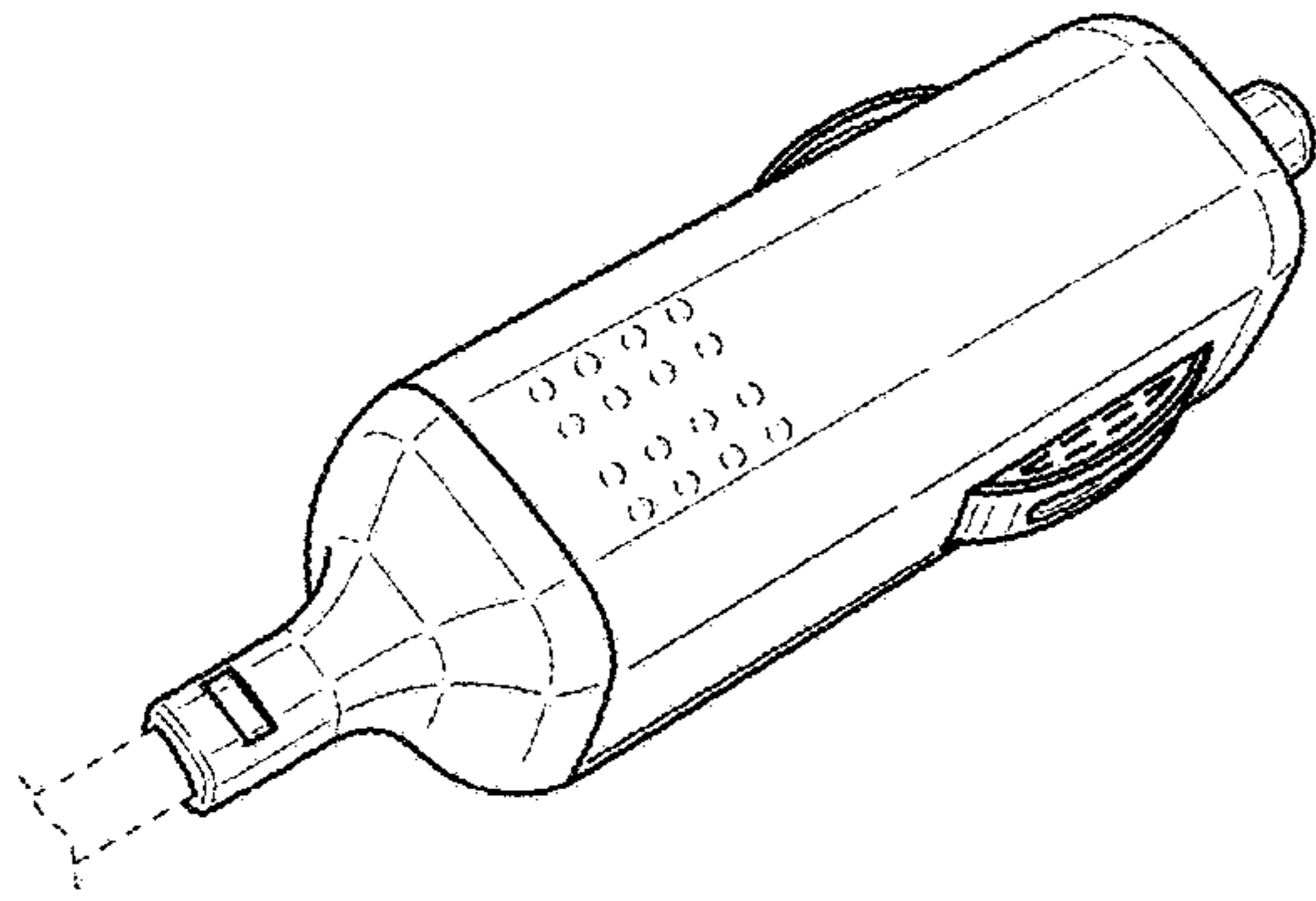

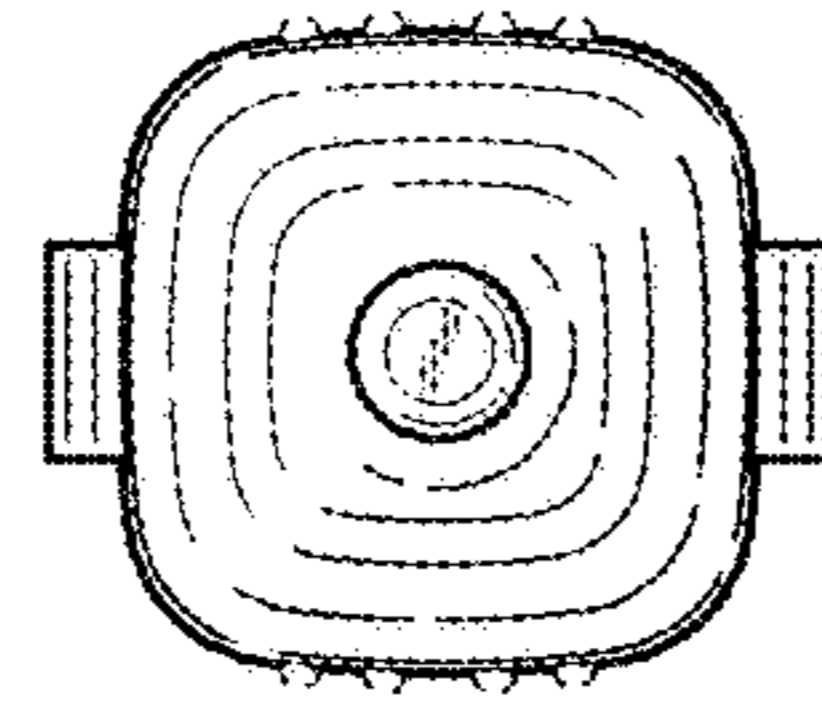

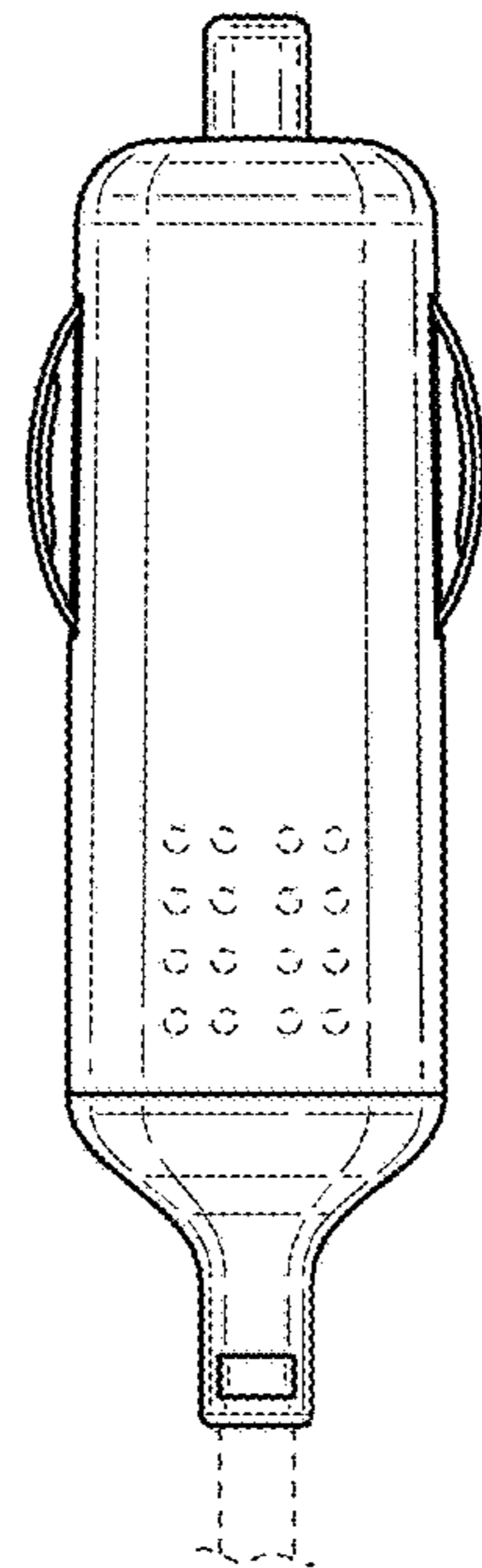

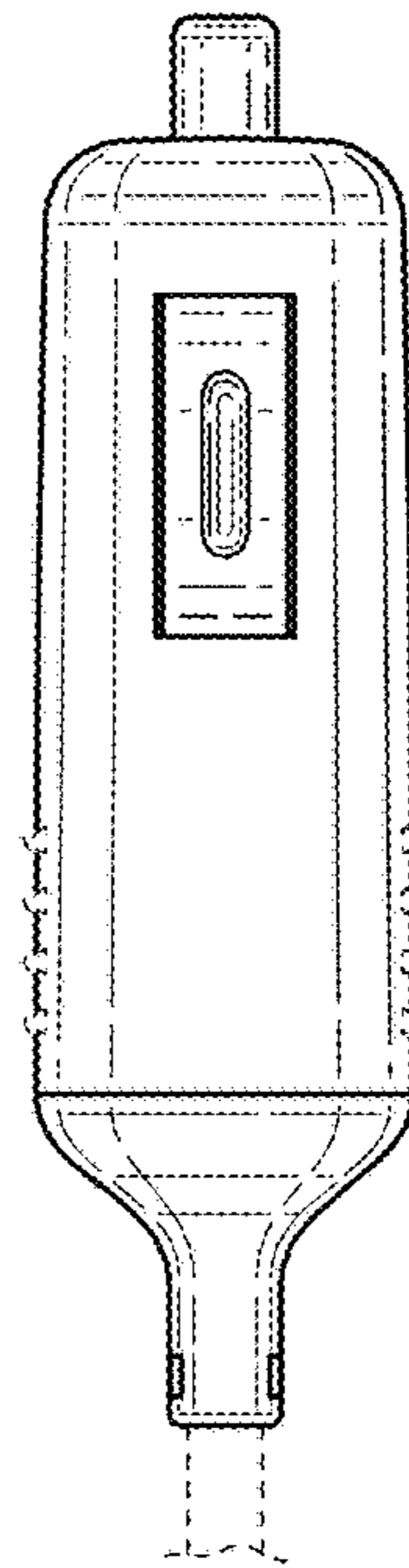

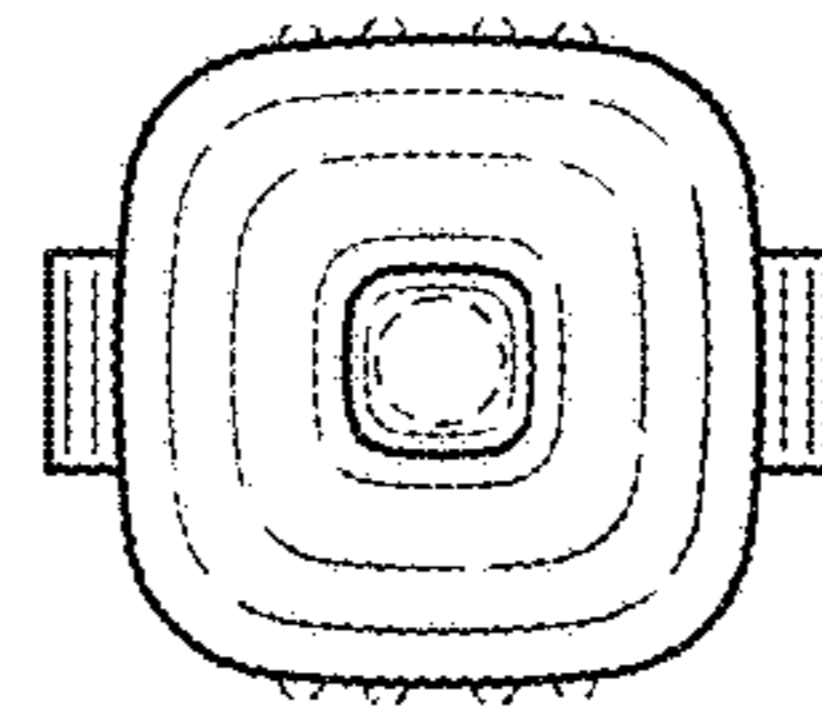

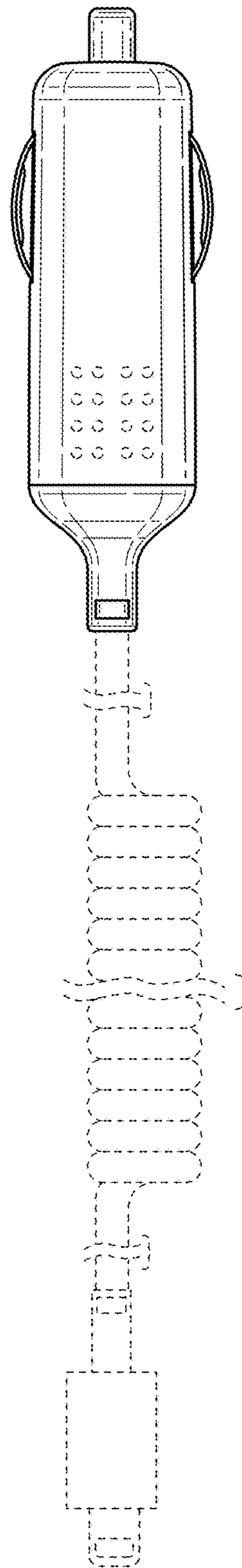
