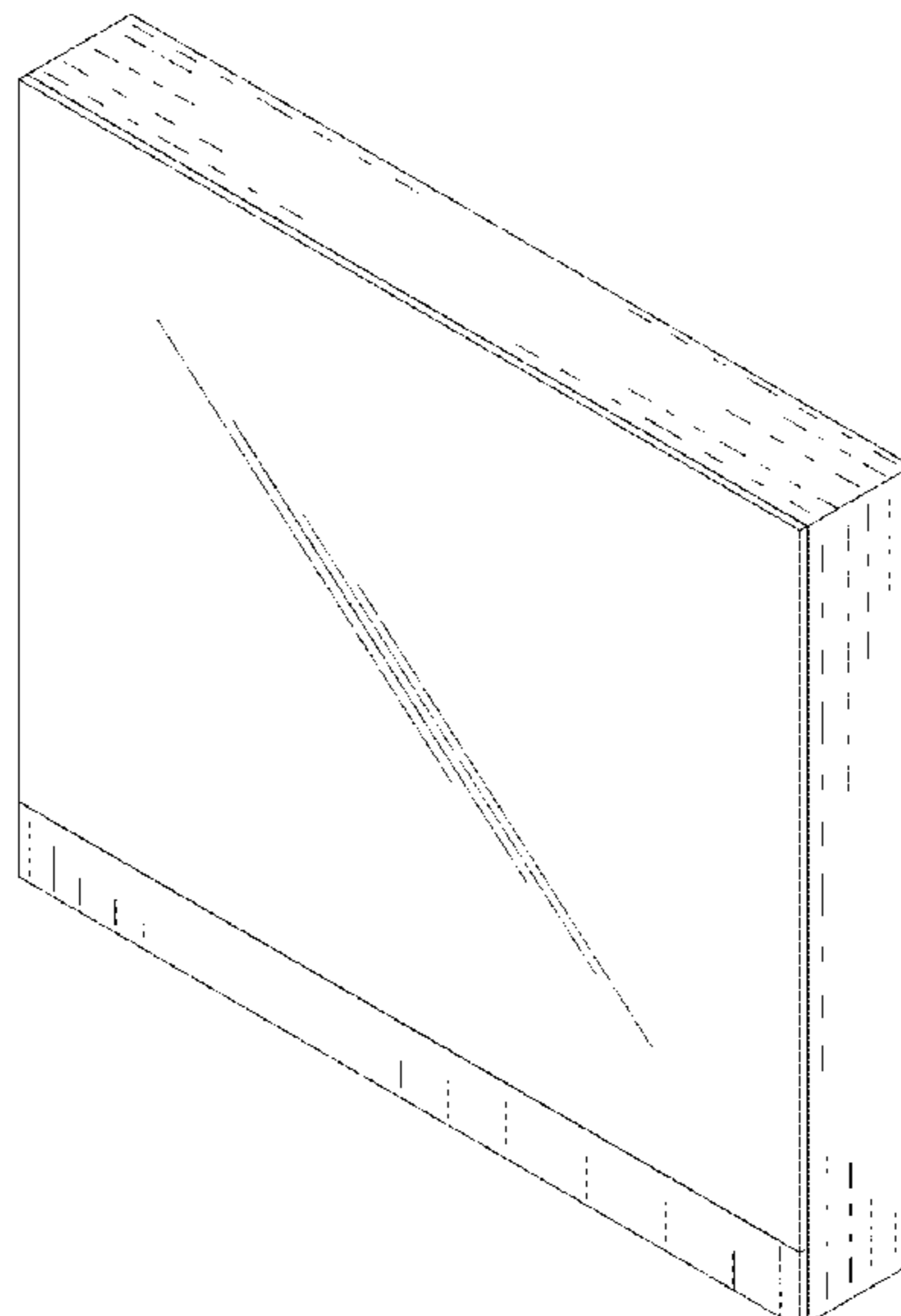
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top right perspective view of a bathroom television showing my new design;

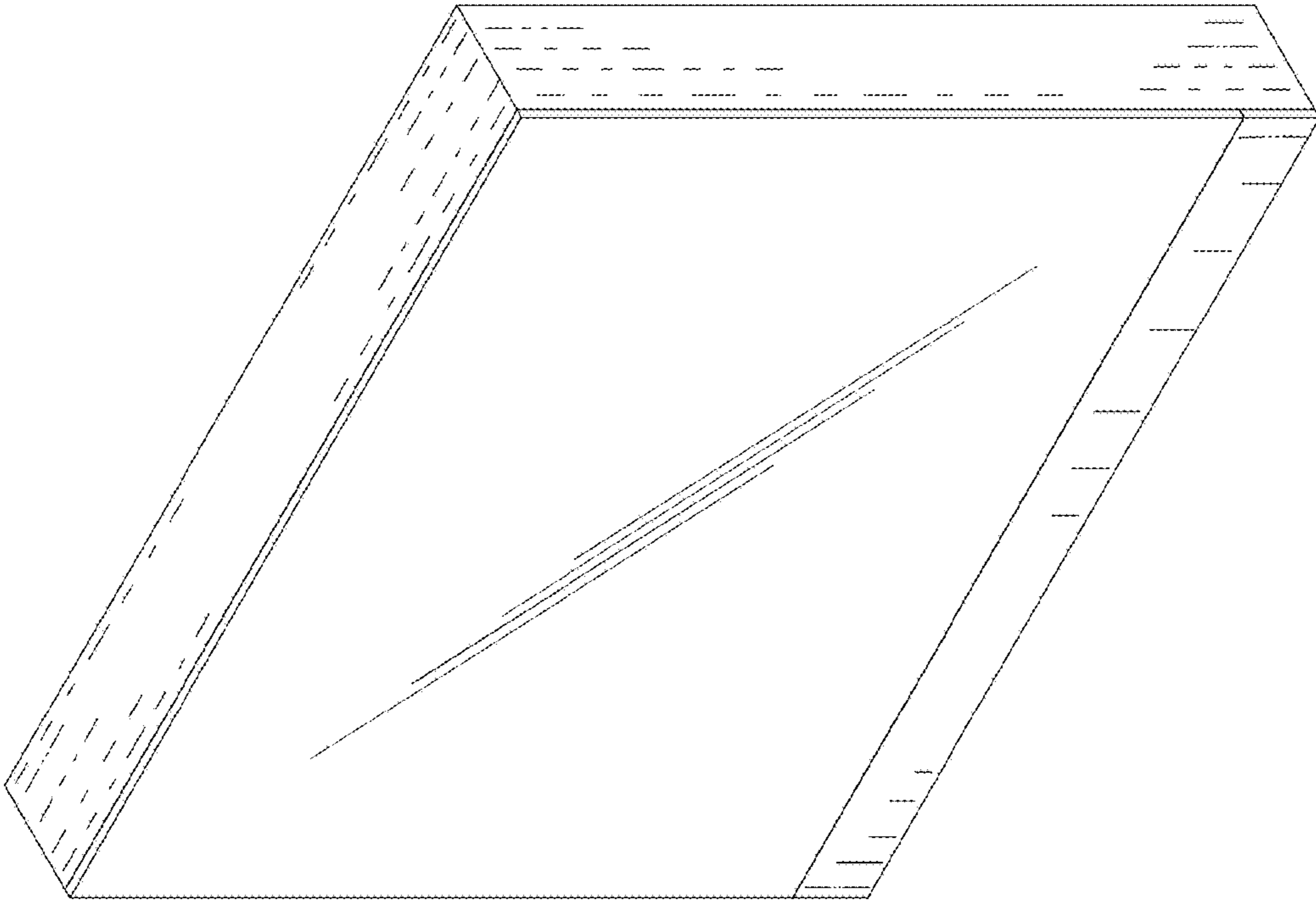

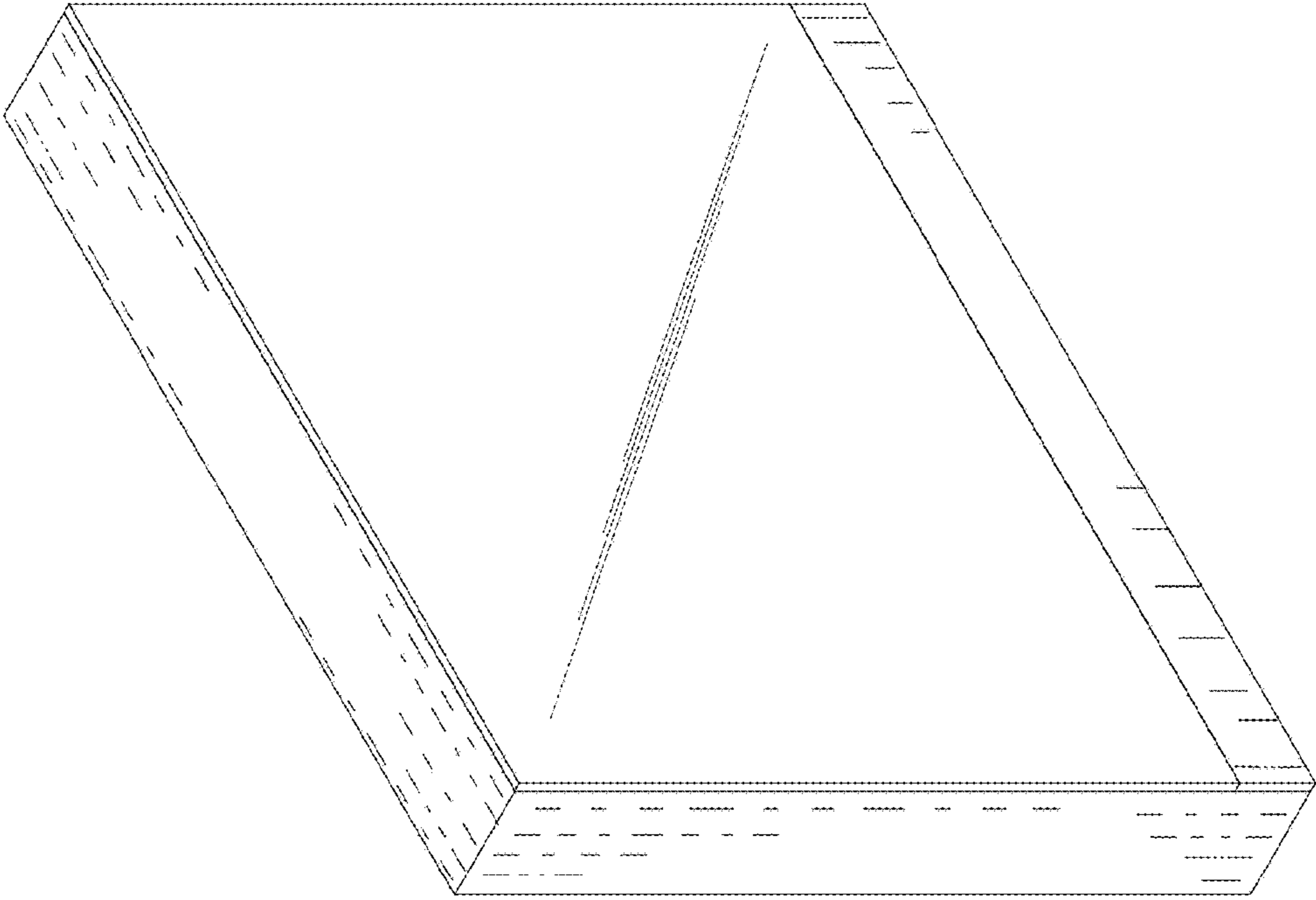

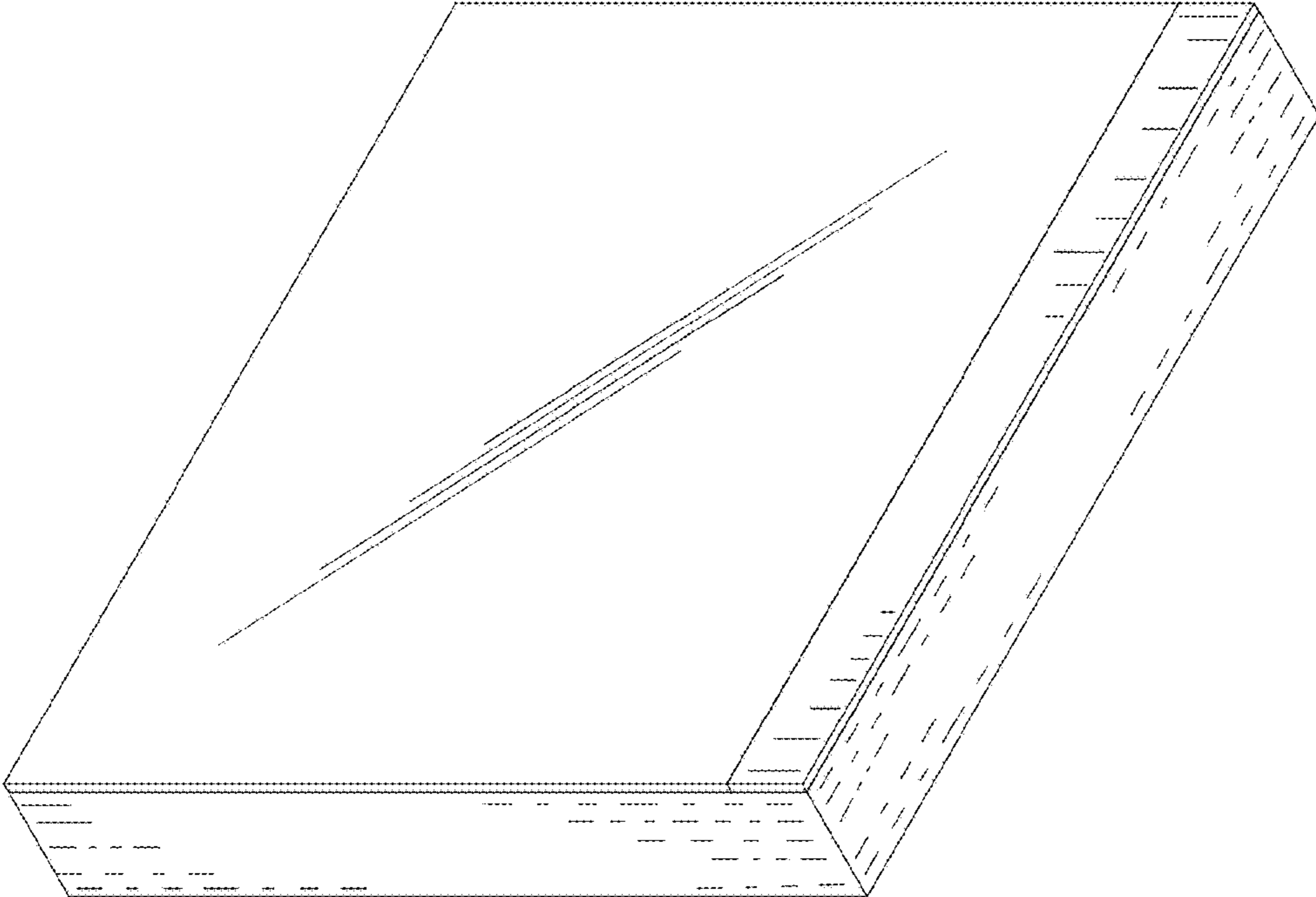

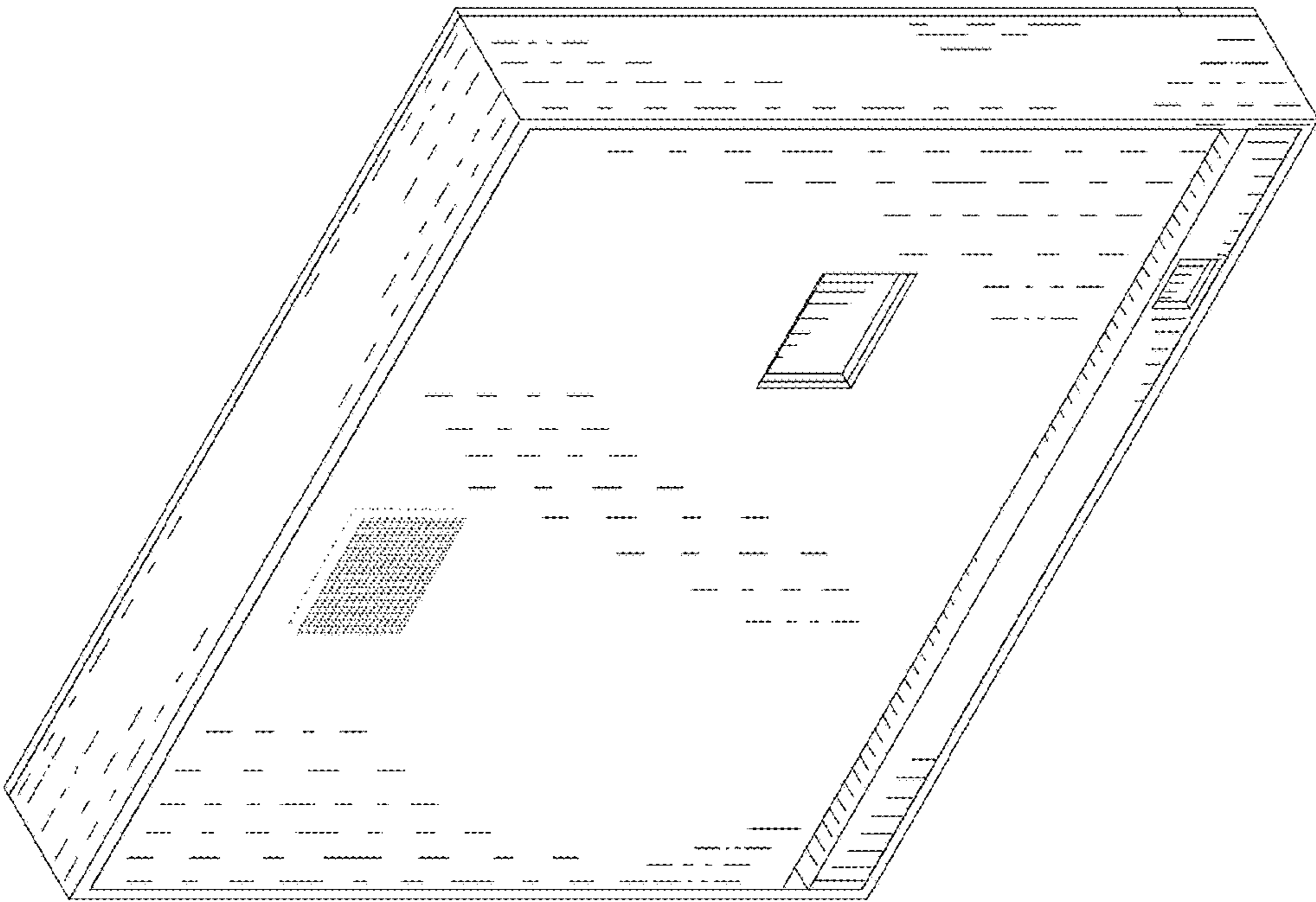

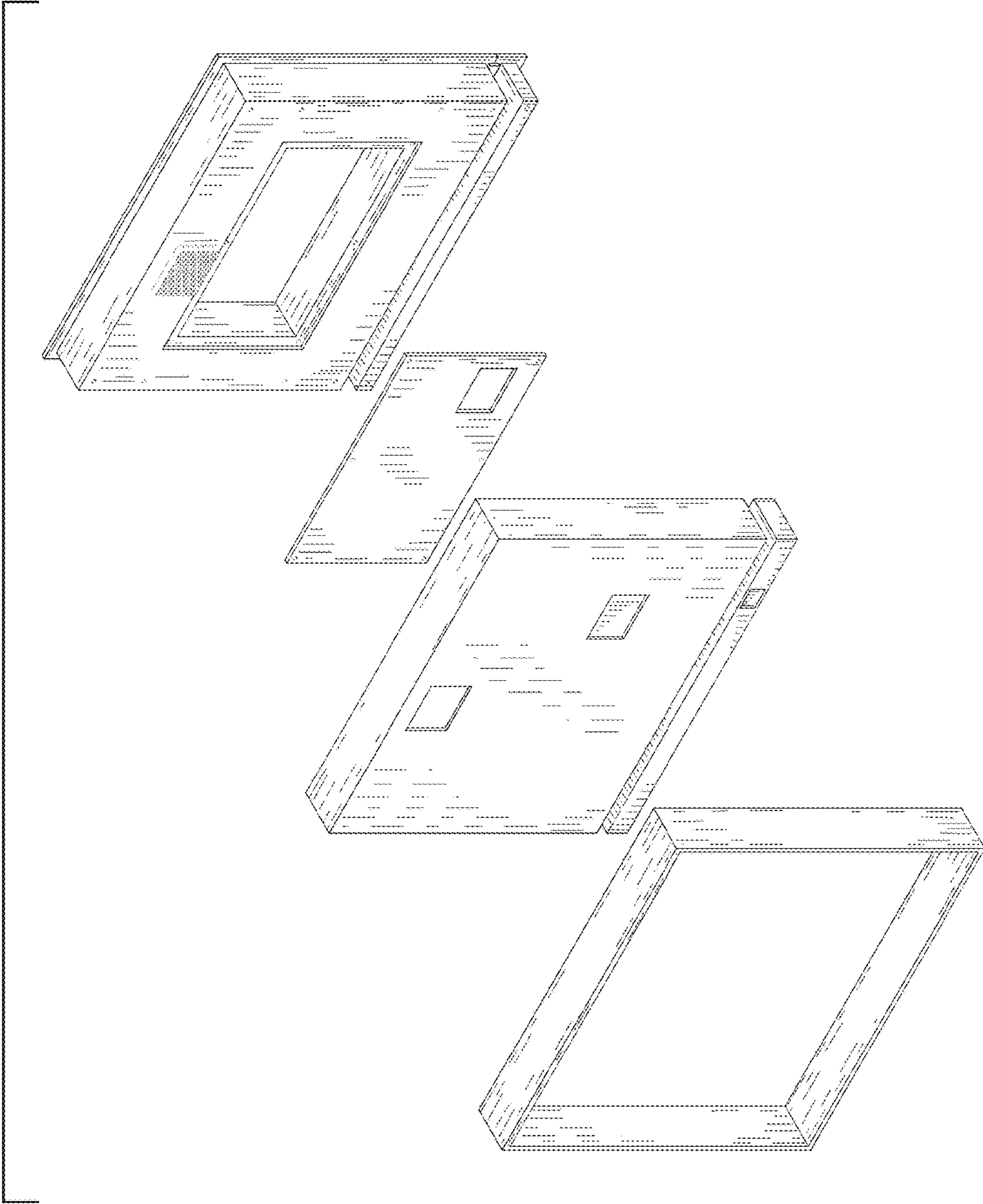

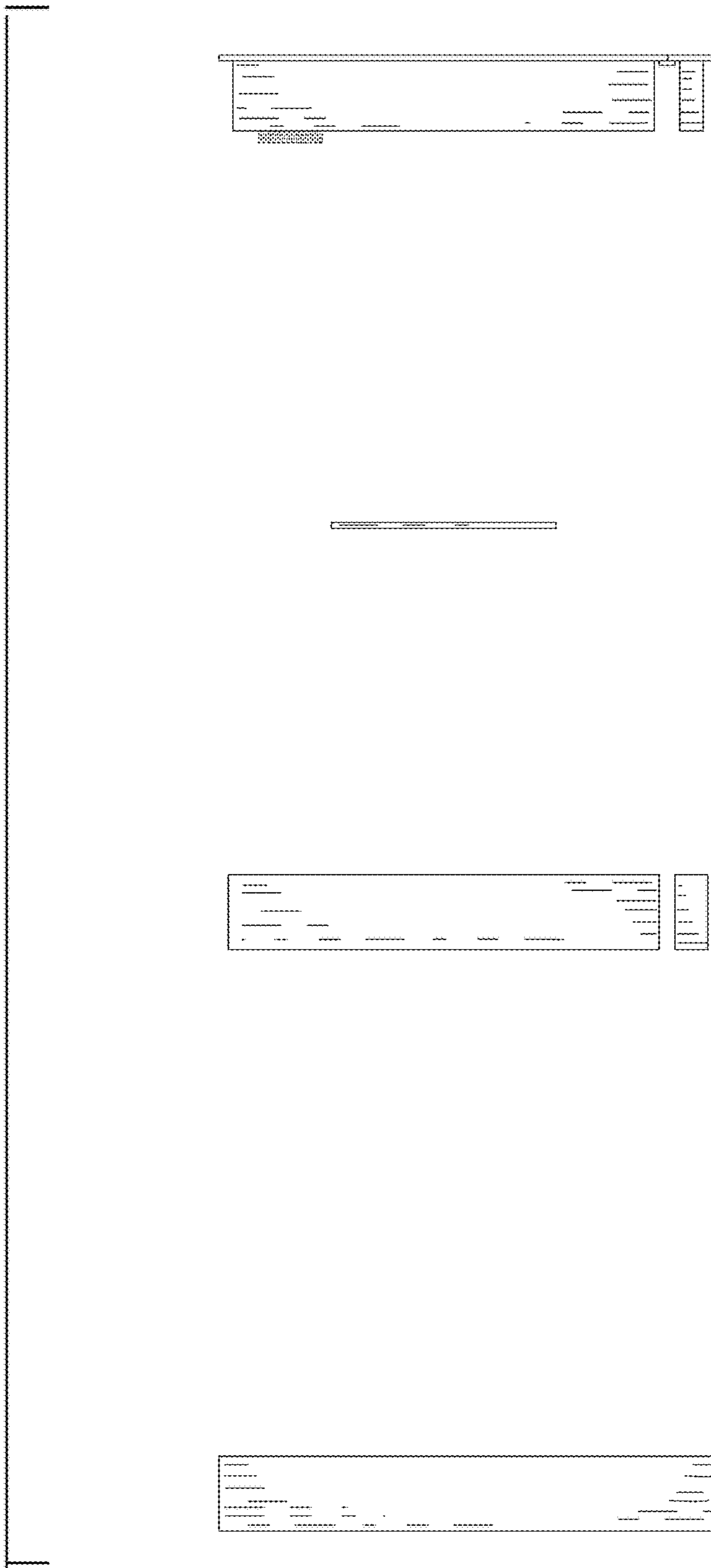

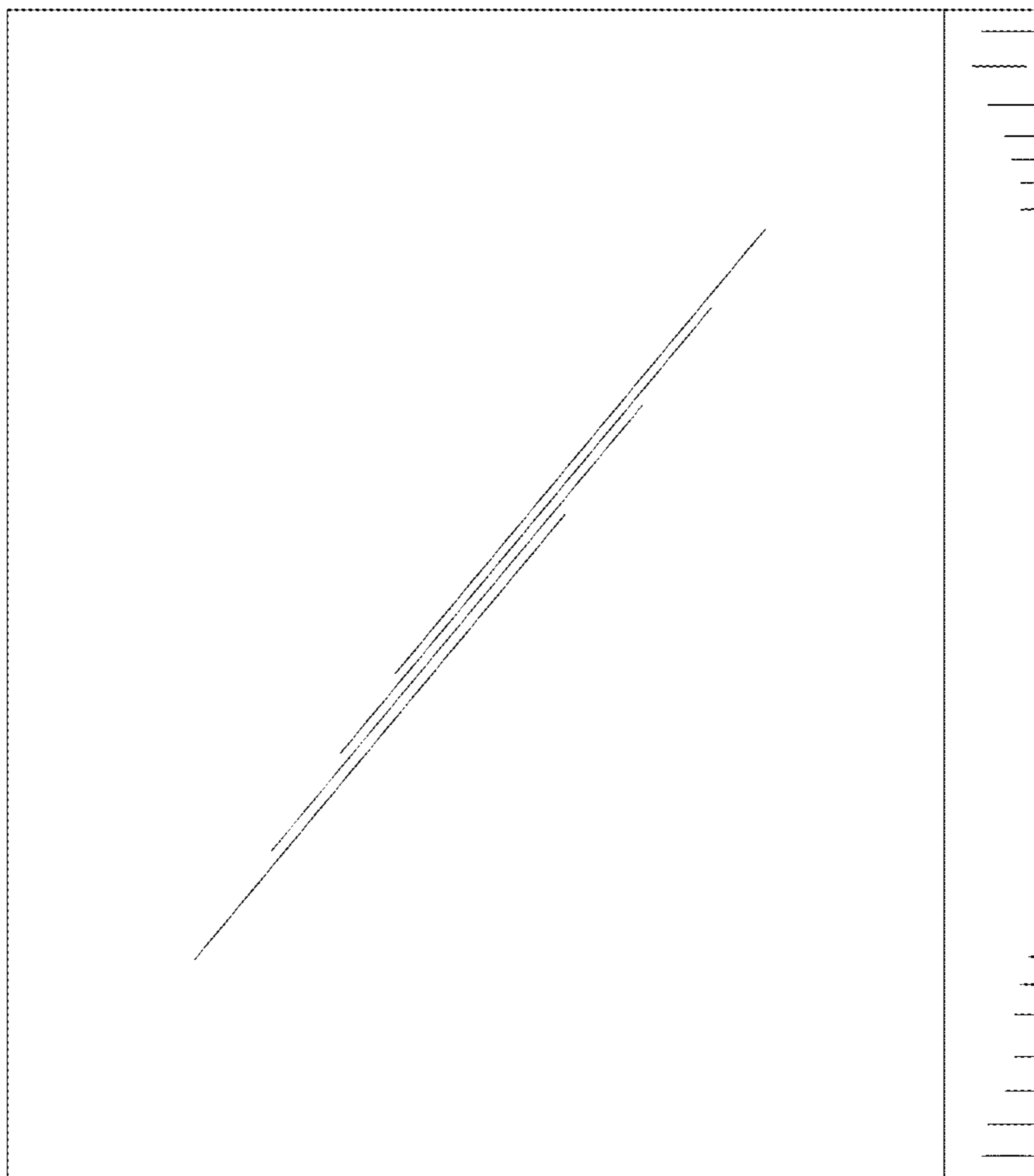

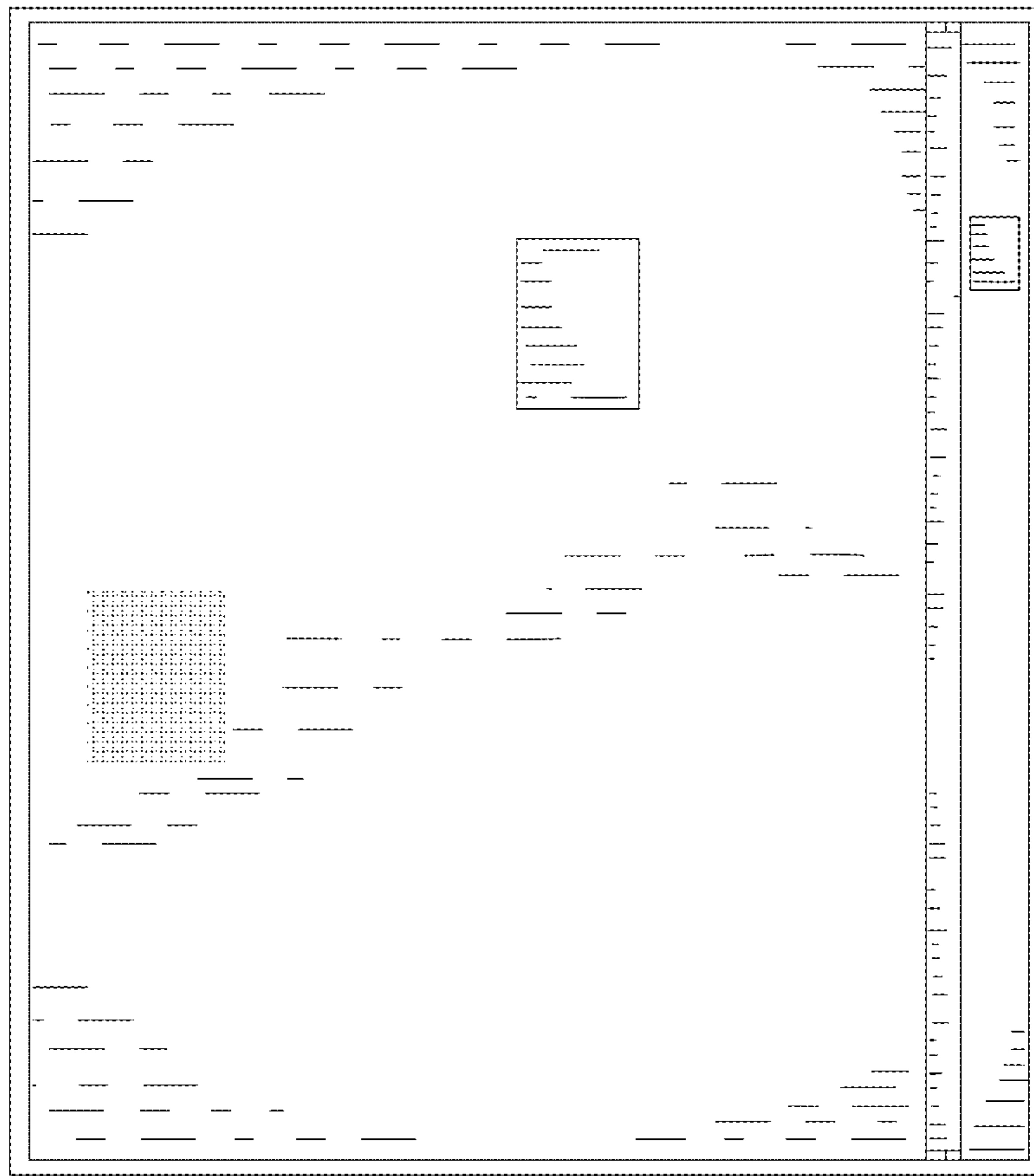

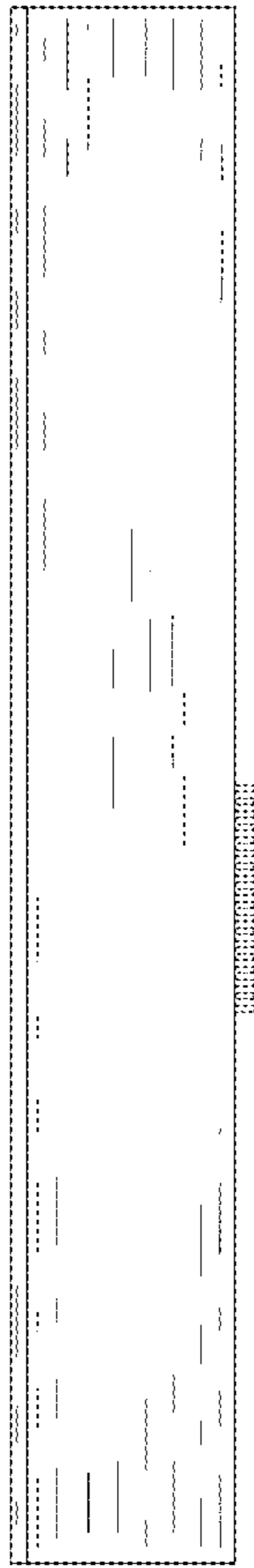

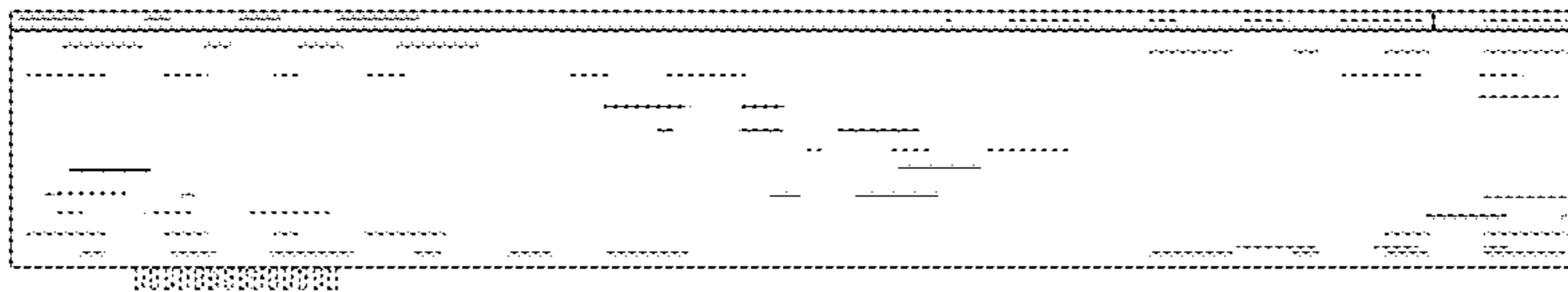

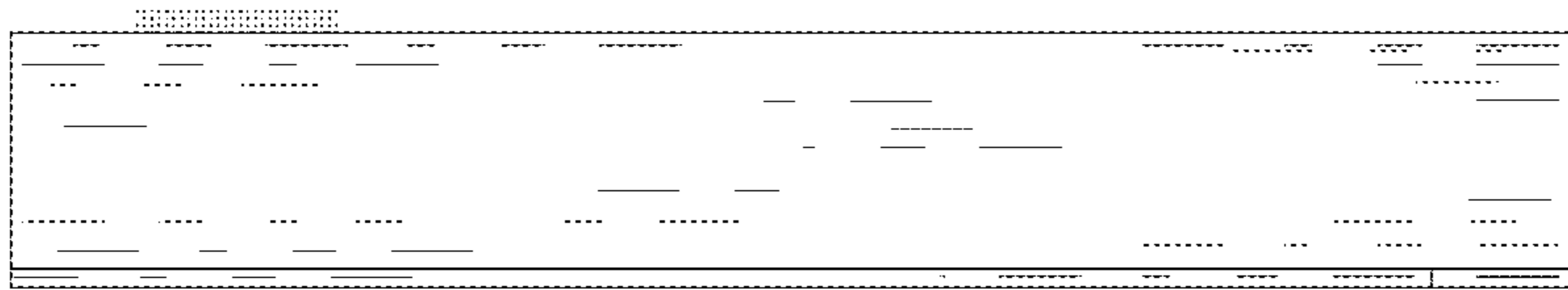
