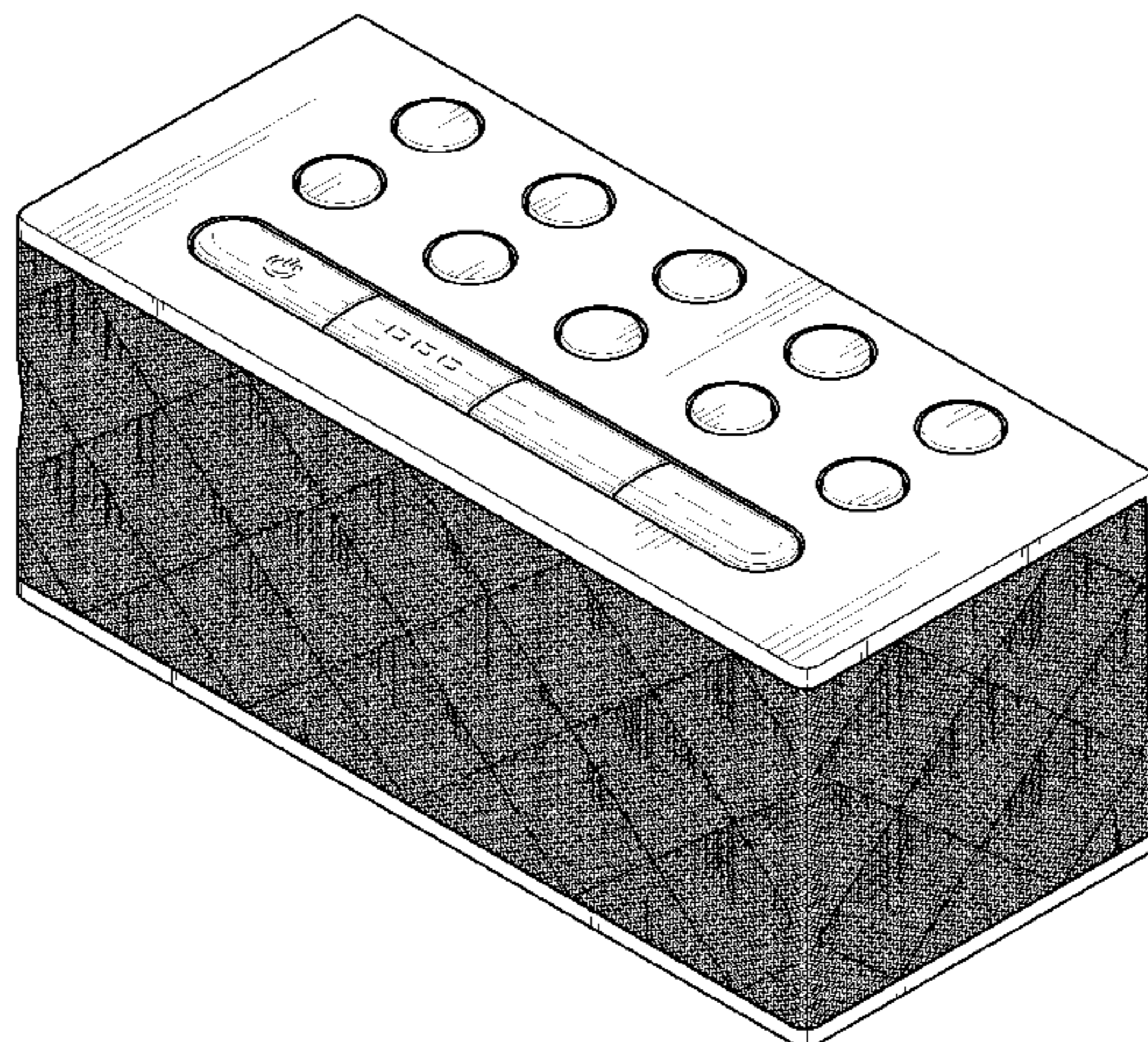
(57) **CLAIM**

The ornamental design for a sound machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sound machine showing my design, as viewed from the top and front.
FIG. 2 is a front elevational view thereof.
FIG. 3 is a back elevational view thereof.
FIG. 4 is a first side elevational view thereof.
FIG. 5 is a second side elevational view thereof.
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

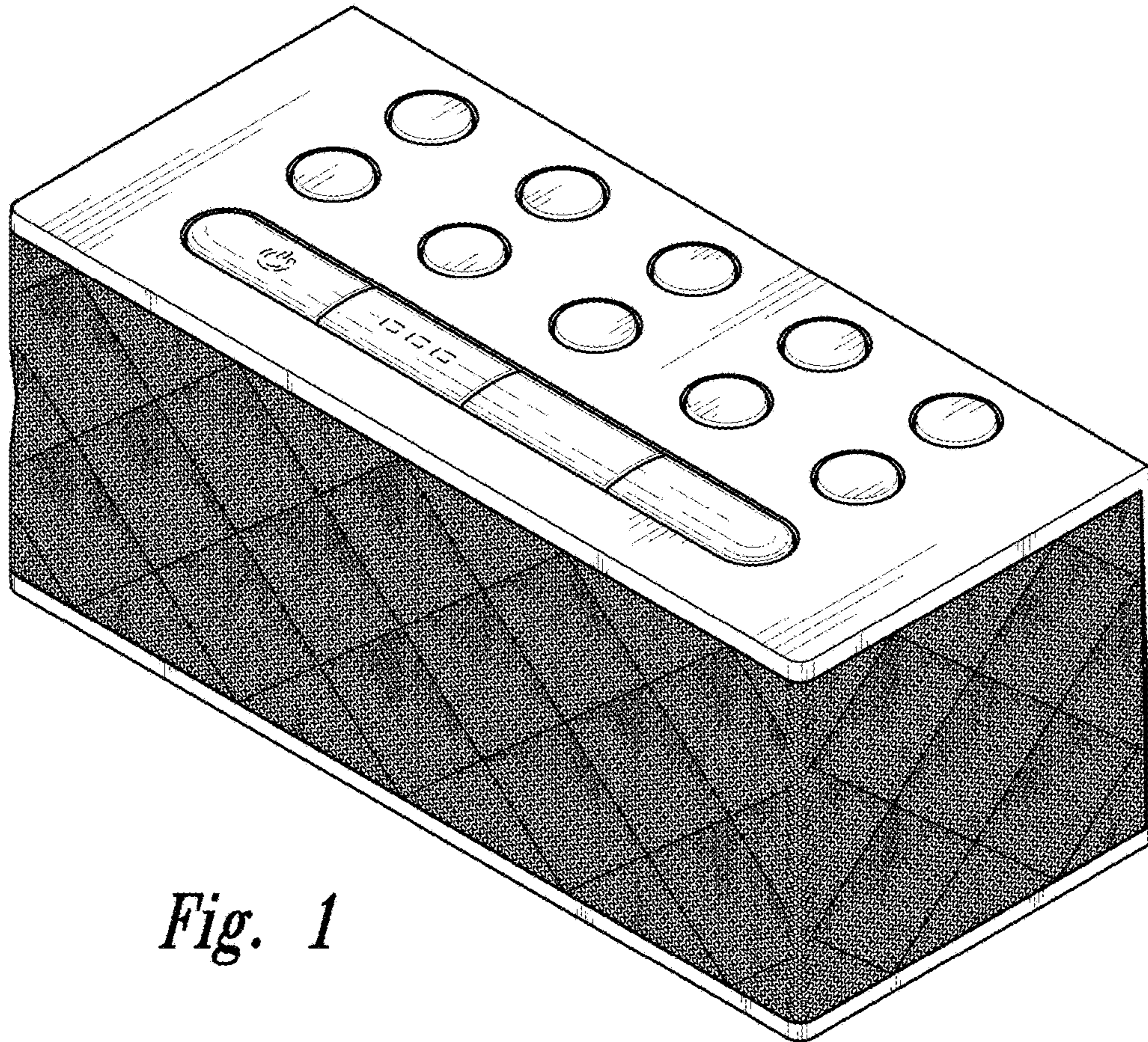

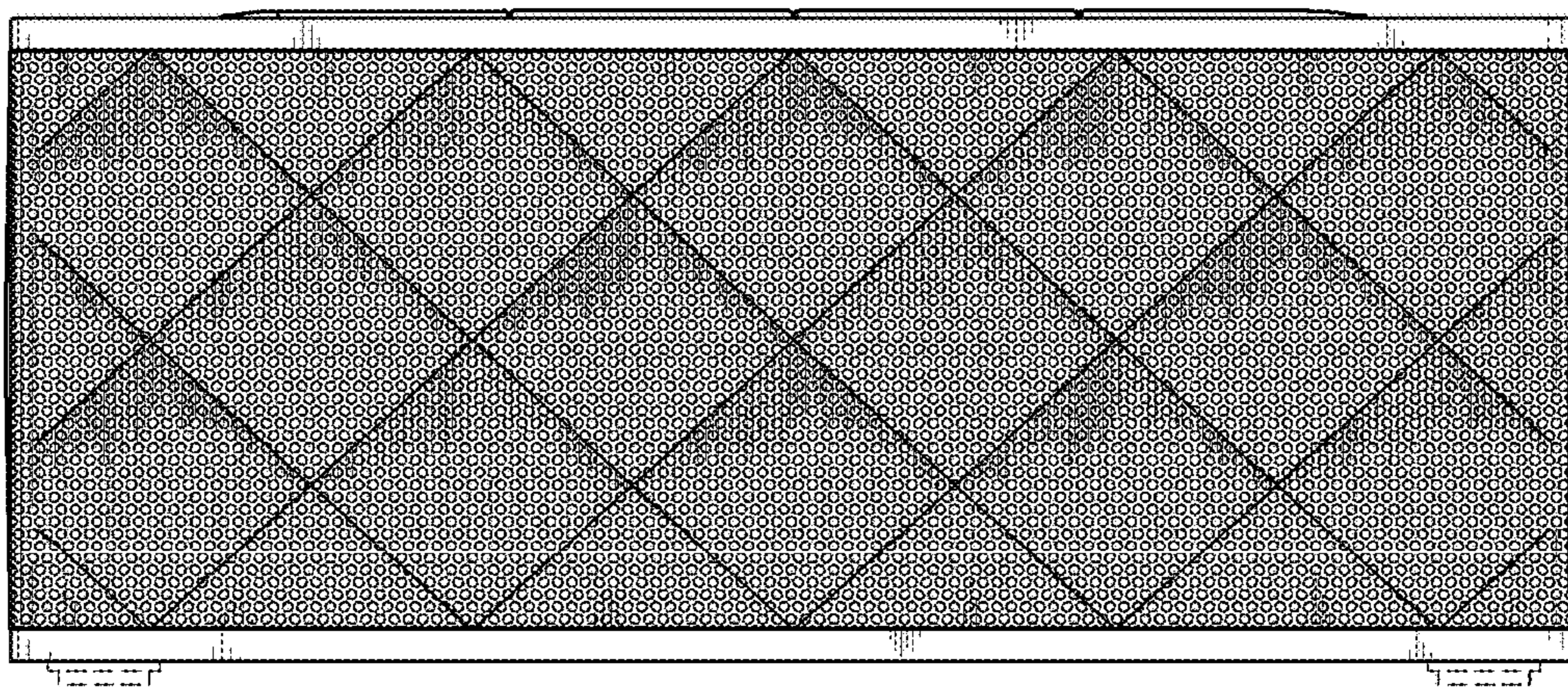

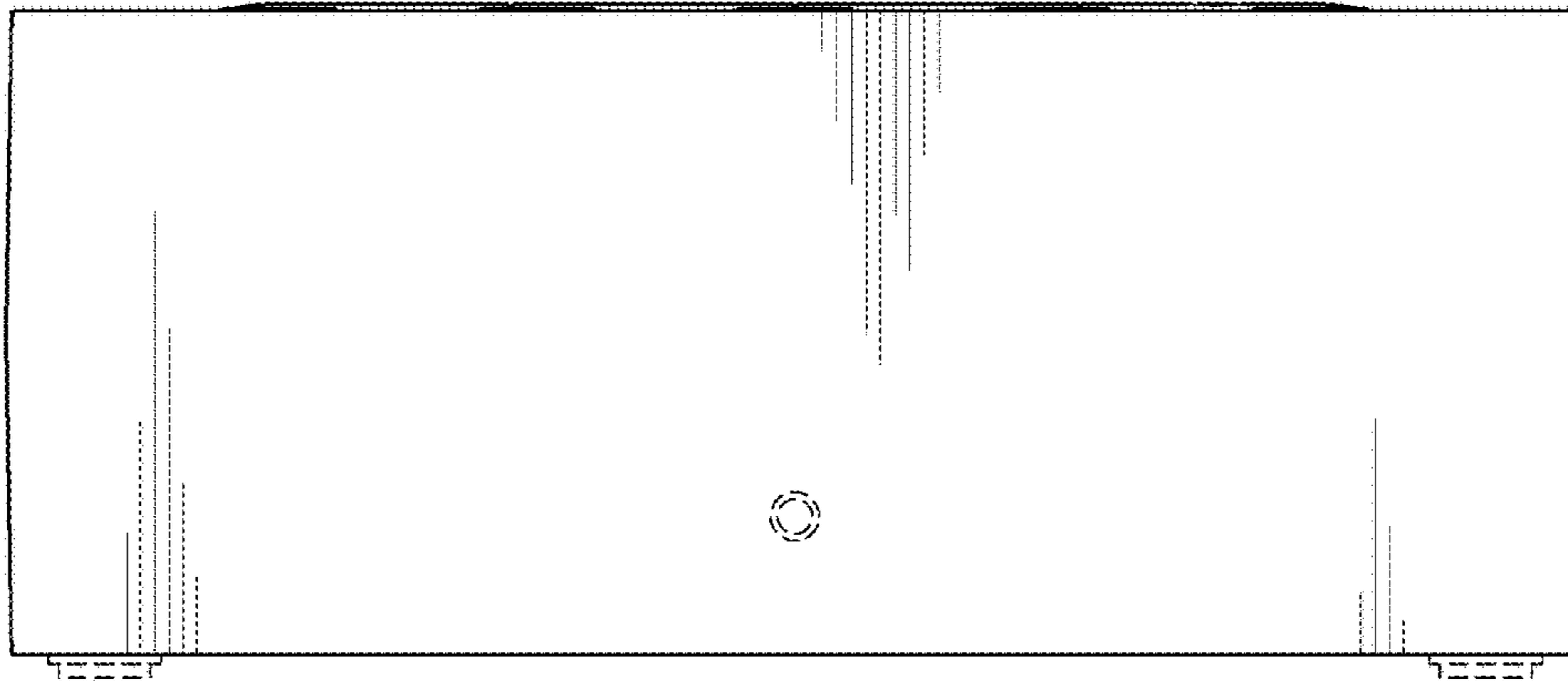

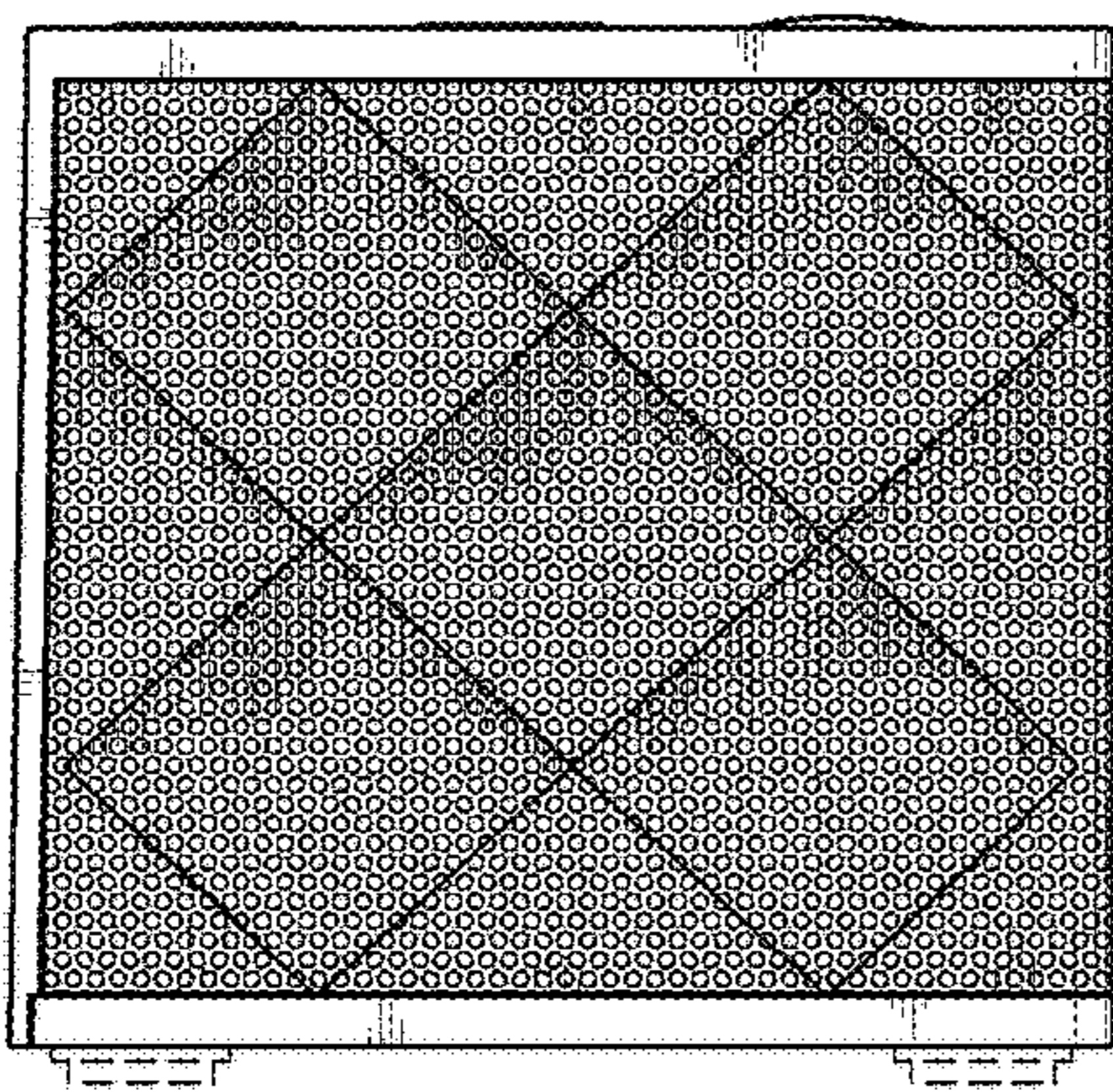

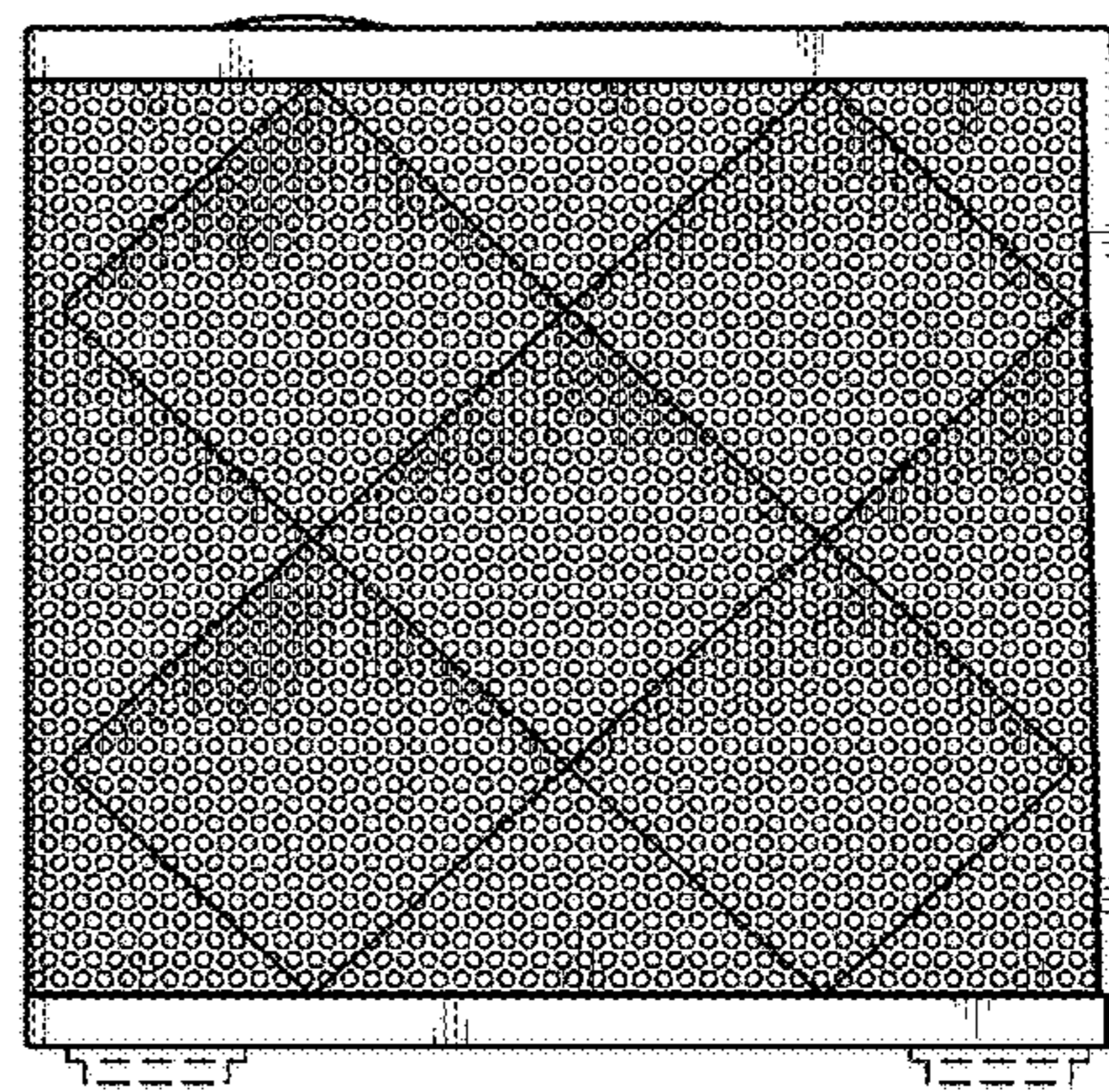

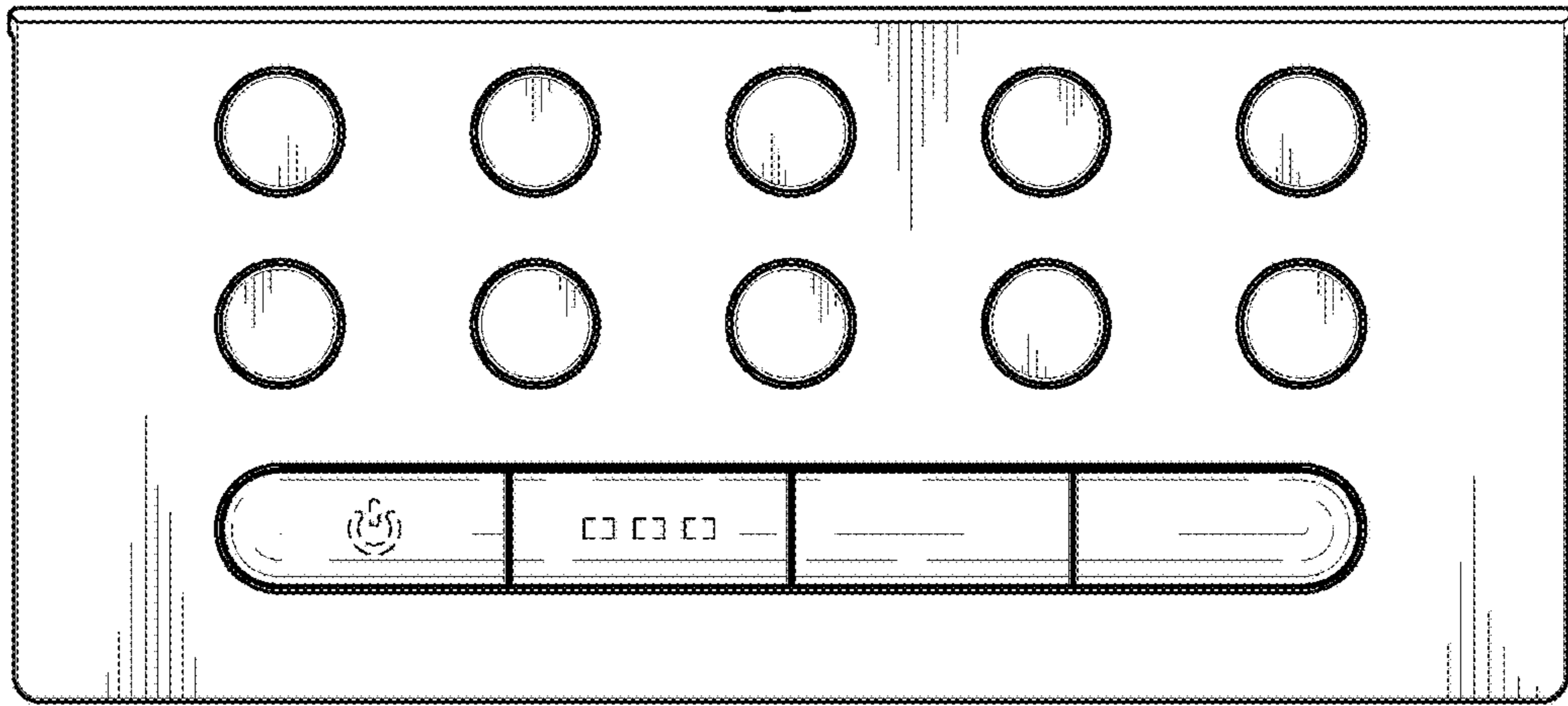

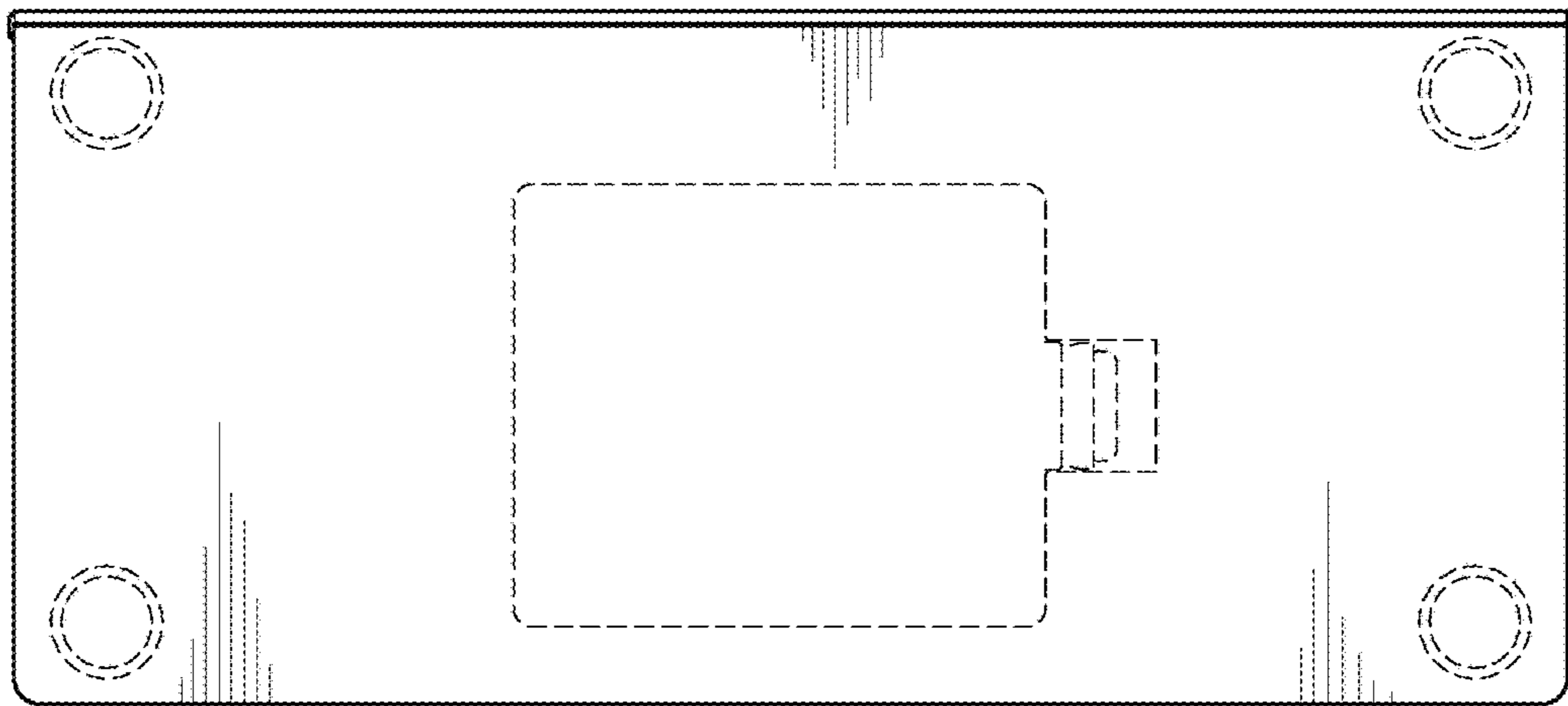
