**DESCRIPTION**

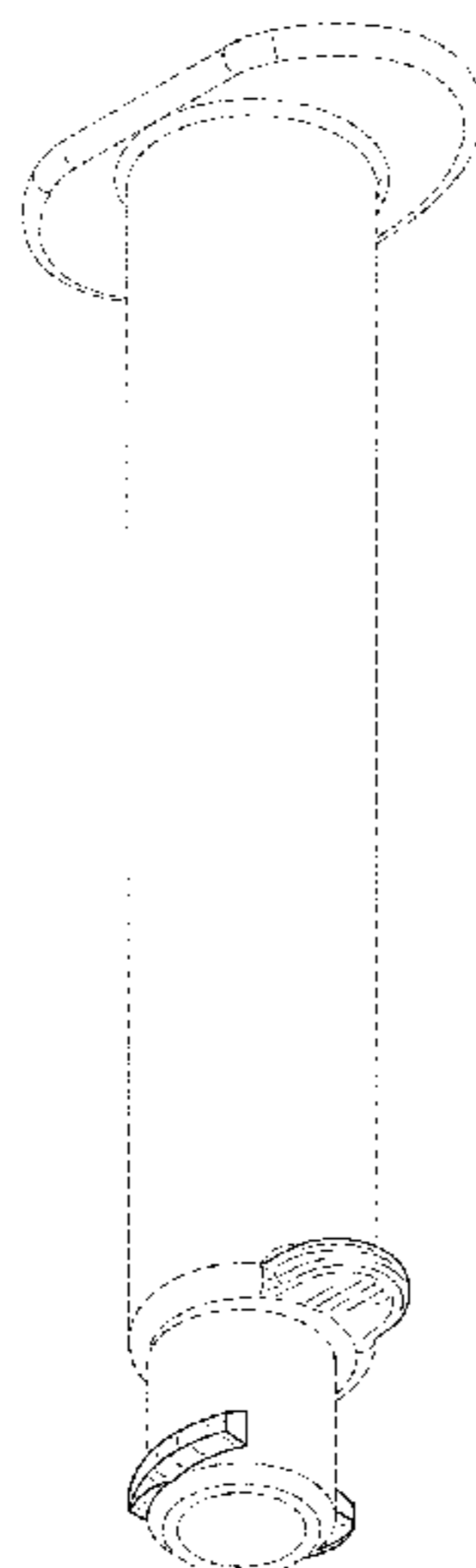
FIG. 1 is a perspective view of an enteral syringe showing our new design.

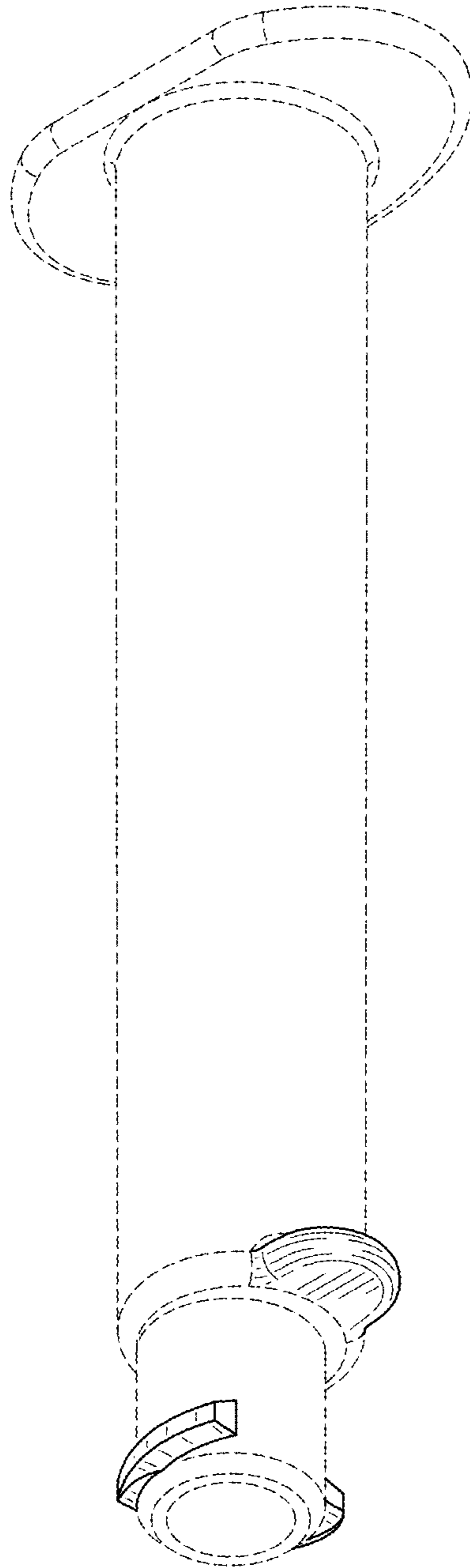

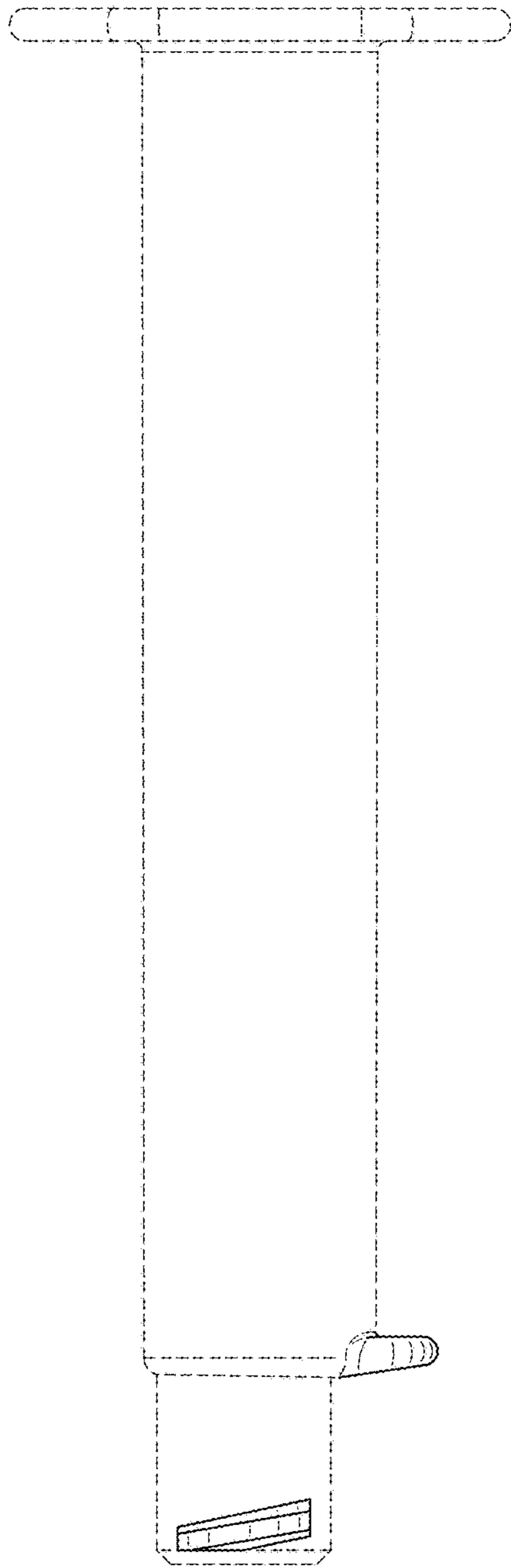

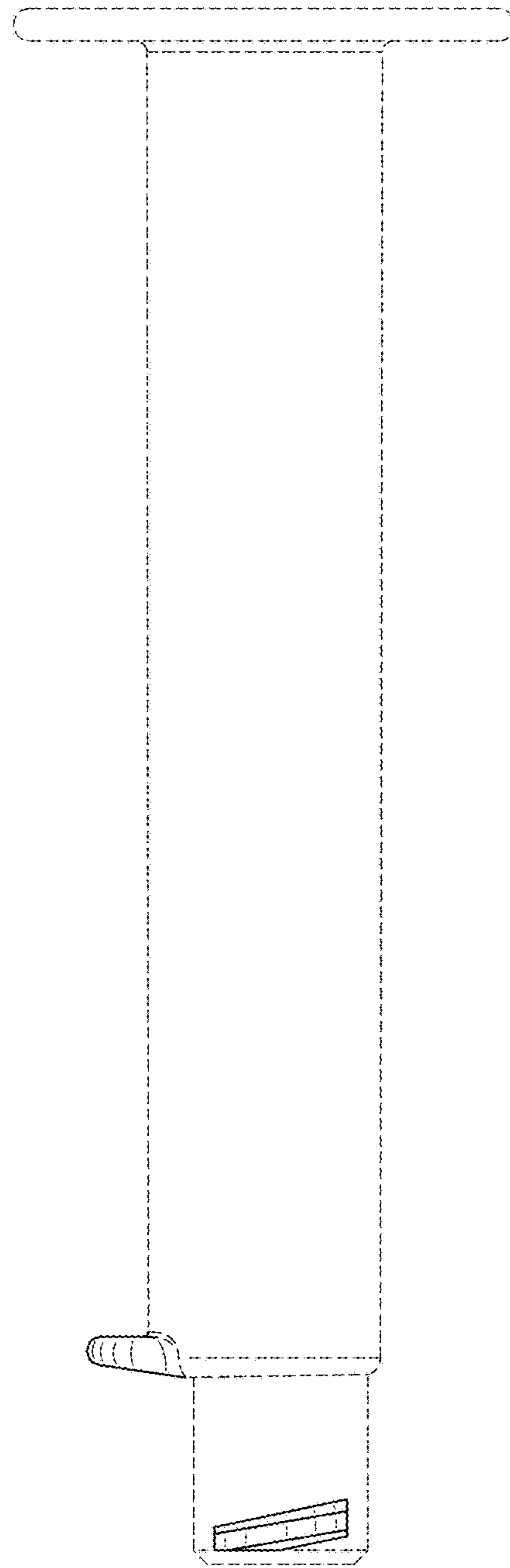

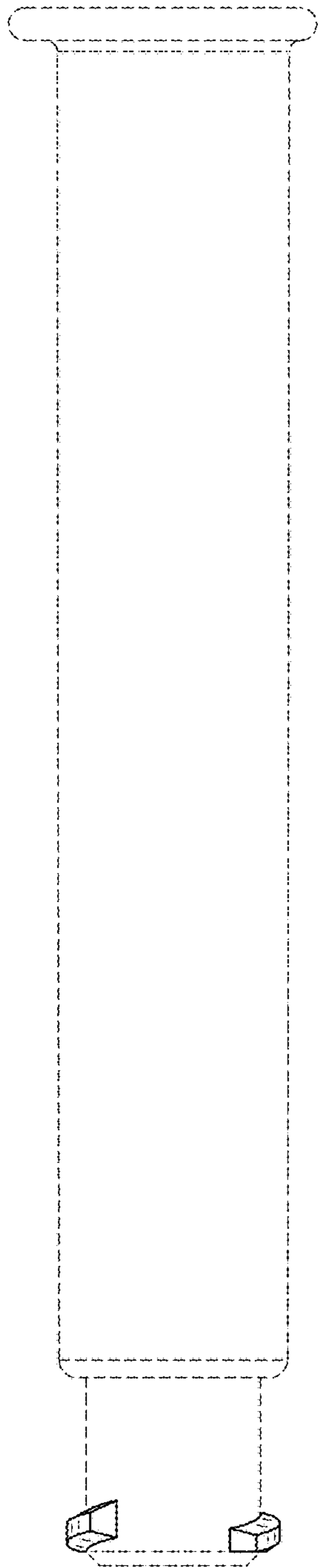

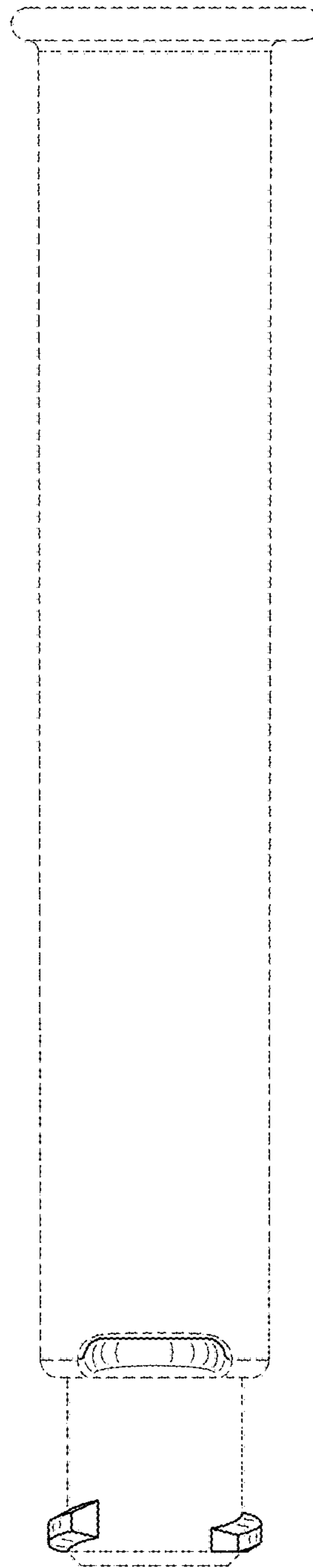

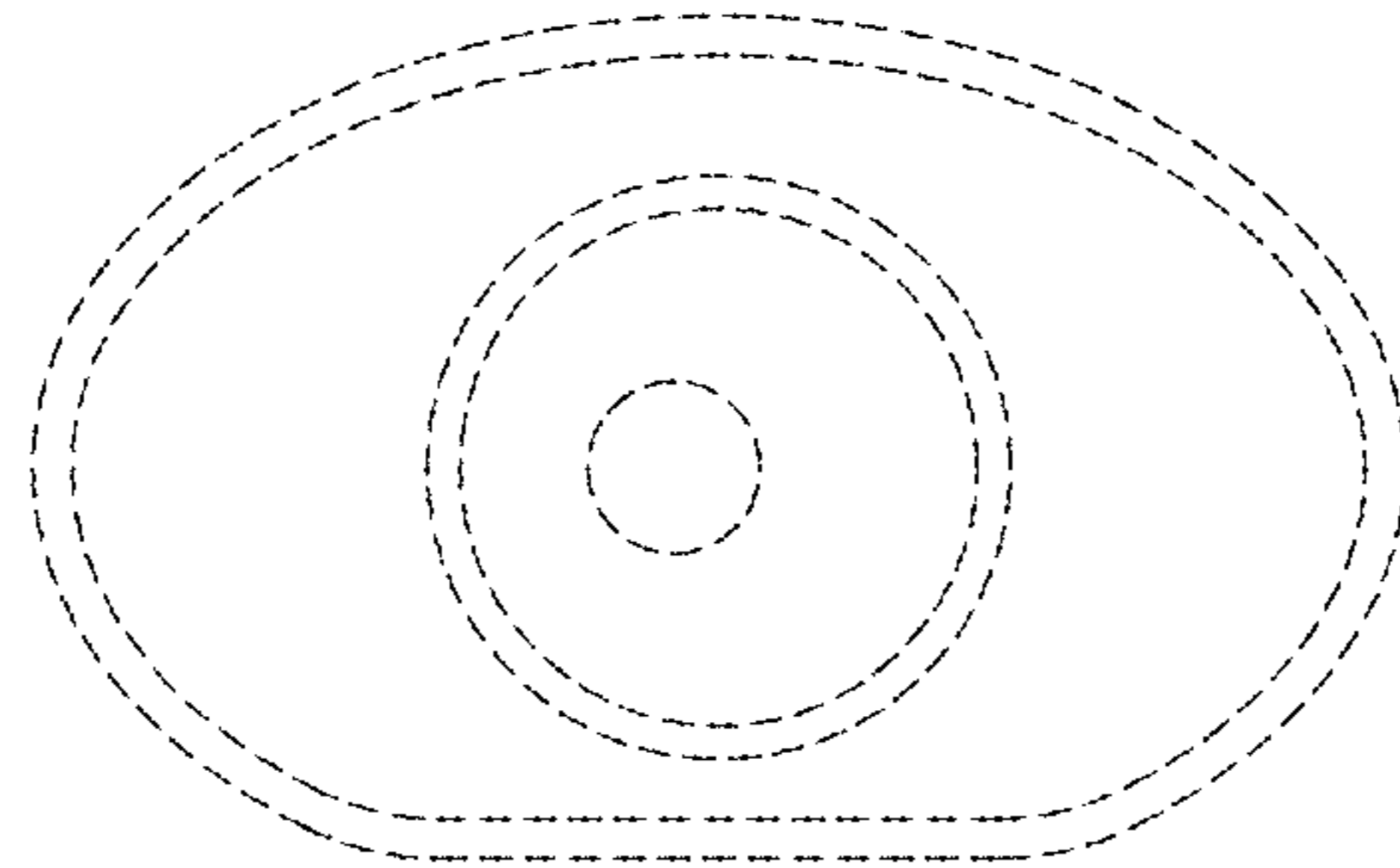

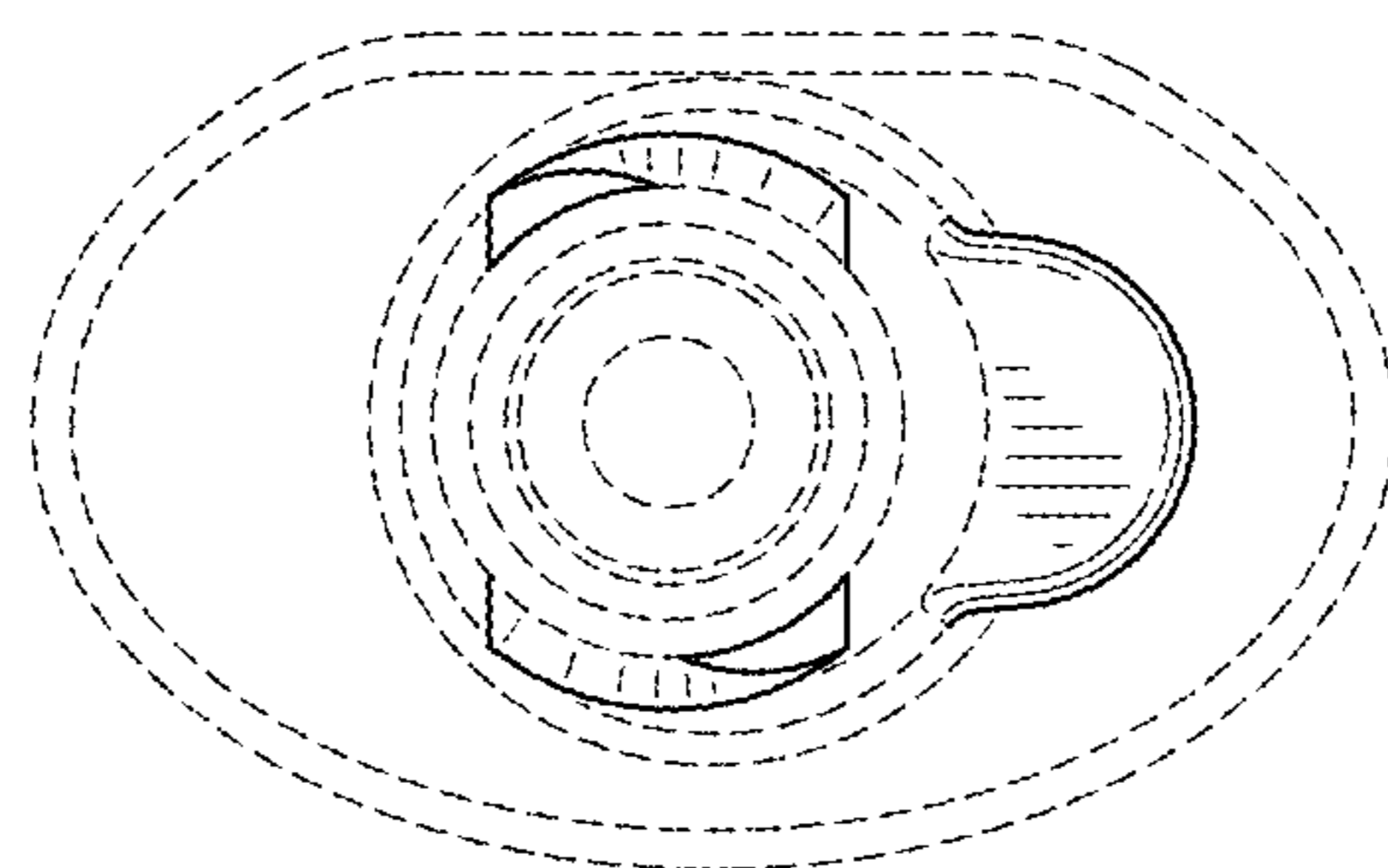
