(57) **CLAIM**

An ornamental design for a paver and landscape edging, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of a paver and landscape edging showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is right side elevation view thereof; FIG. 7 is a left side elevation view thereof; and, FIG. 8 is a top plan view thereof.

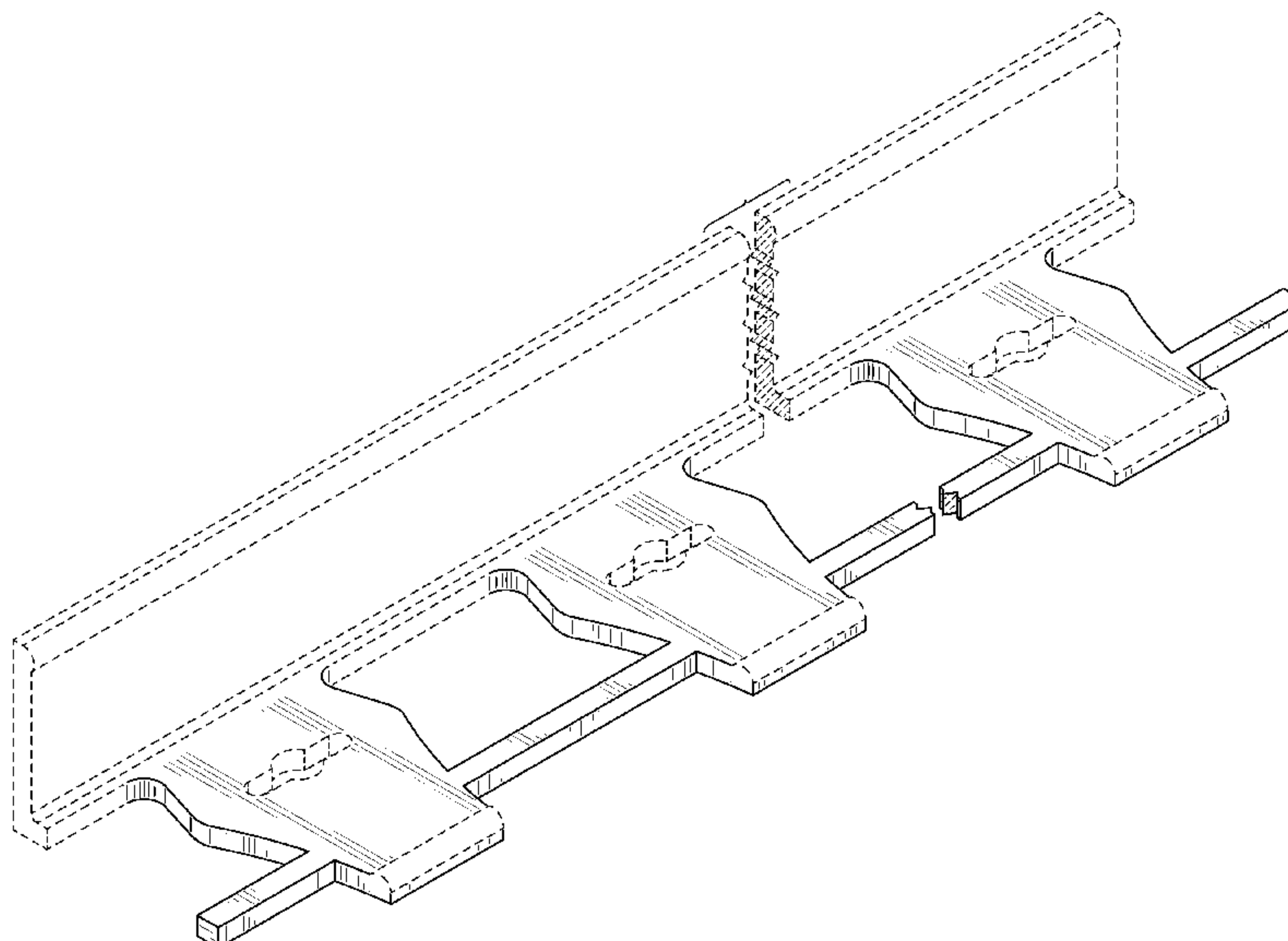

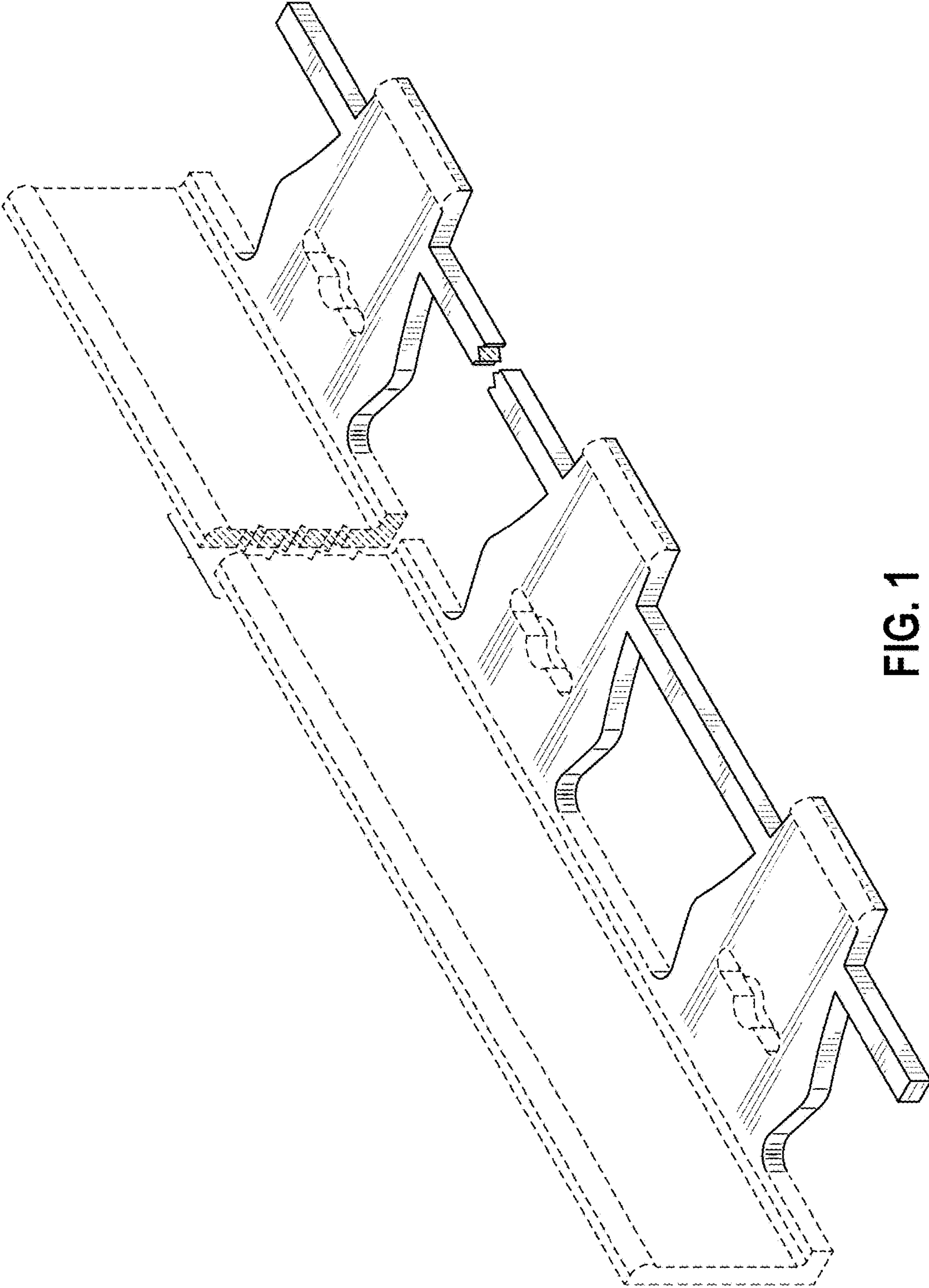

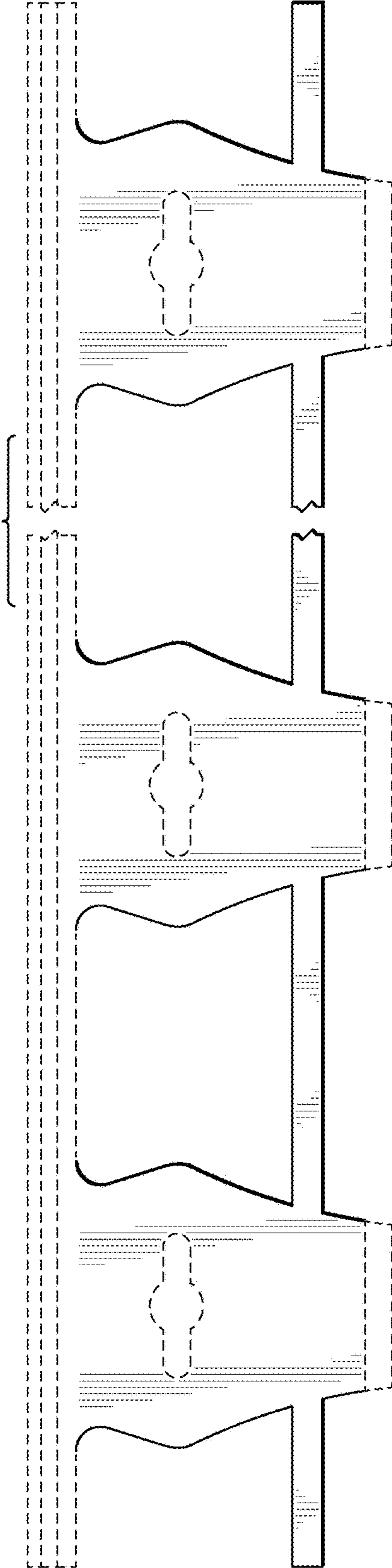

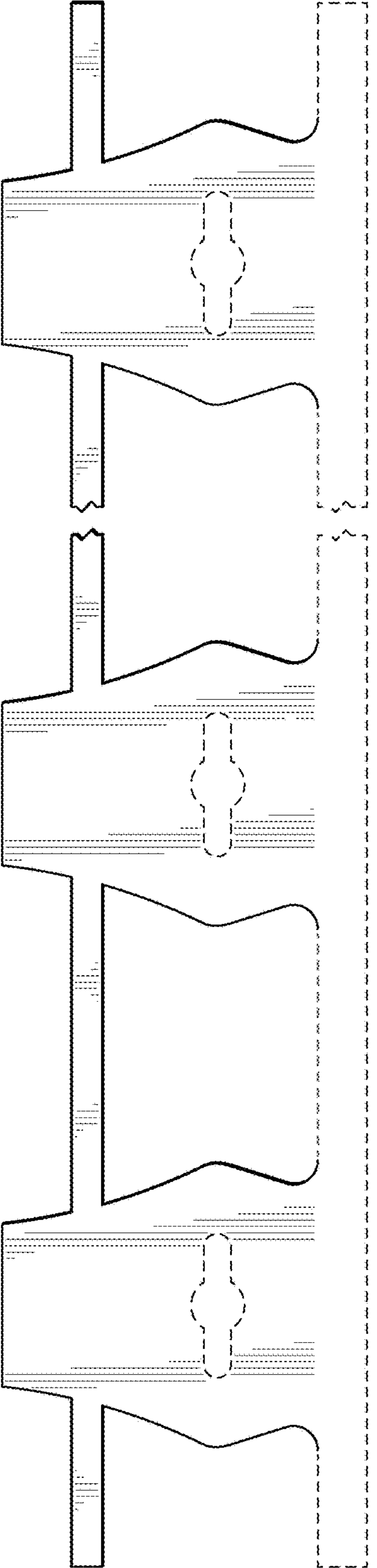
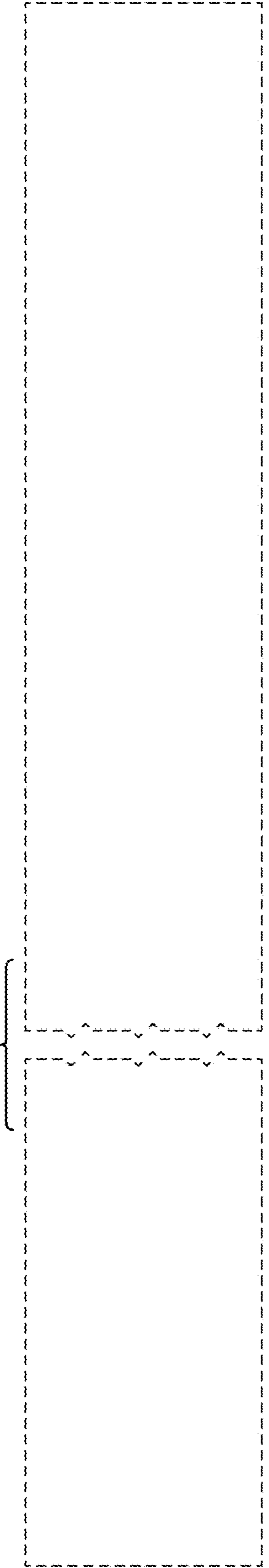
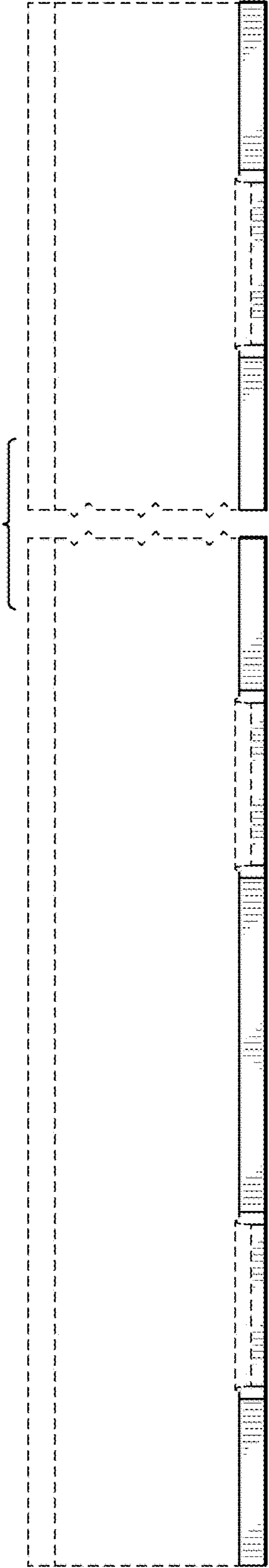

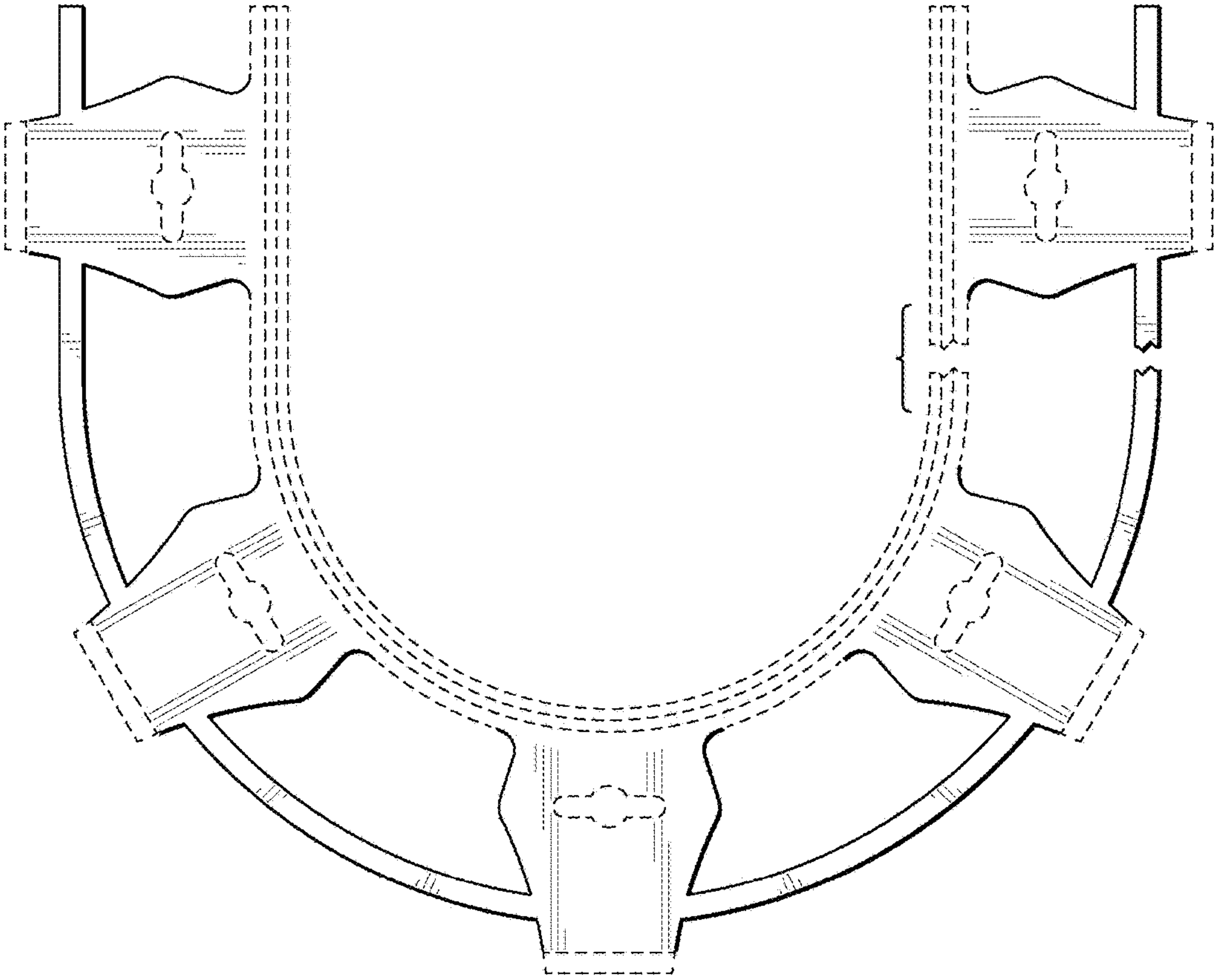
