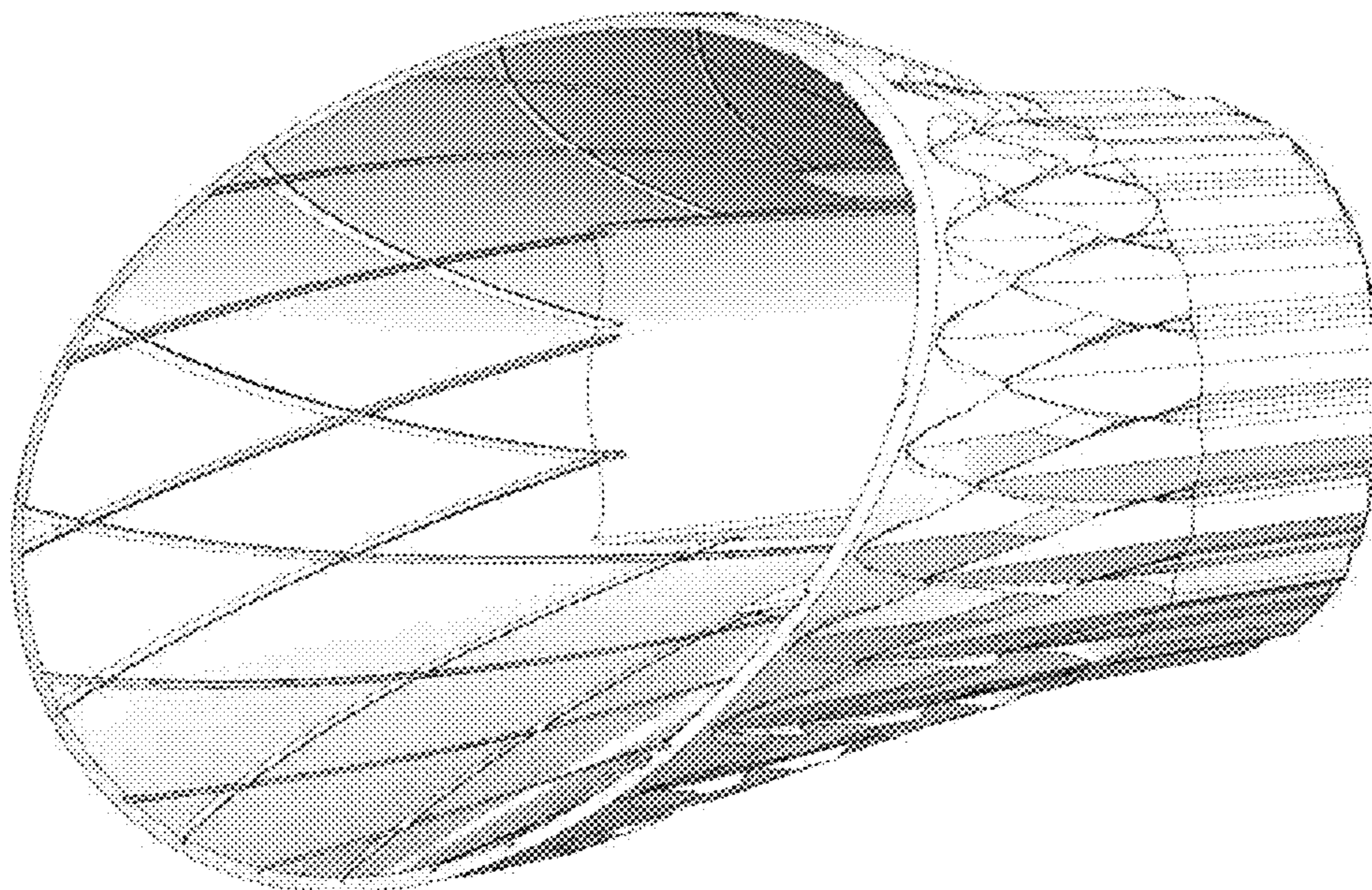
(57) **CLAIM**

The ornamental design for light guide for a vehicle headlight, as shown and described.

DESCRIPTION

FIG. 1 is a rear view of a light guide for a vehicle headlight; FIG. 2 is a front view; FIG. 3 is a bottom view thereof; FIG. 4 is a perspective view thereof; FIG. 5 is another perspective view thereof; FIG. 6 is yet another perspective view thereof; and FIG. 7 is a top view thereof; FIG. 8 is a front view of an exemplary embodiment of the light guide for a vehicle headlight, where the light is illustrated as not illuminated; and, FIG. 9 is another front view thereof, illustrating the light being illuminated.

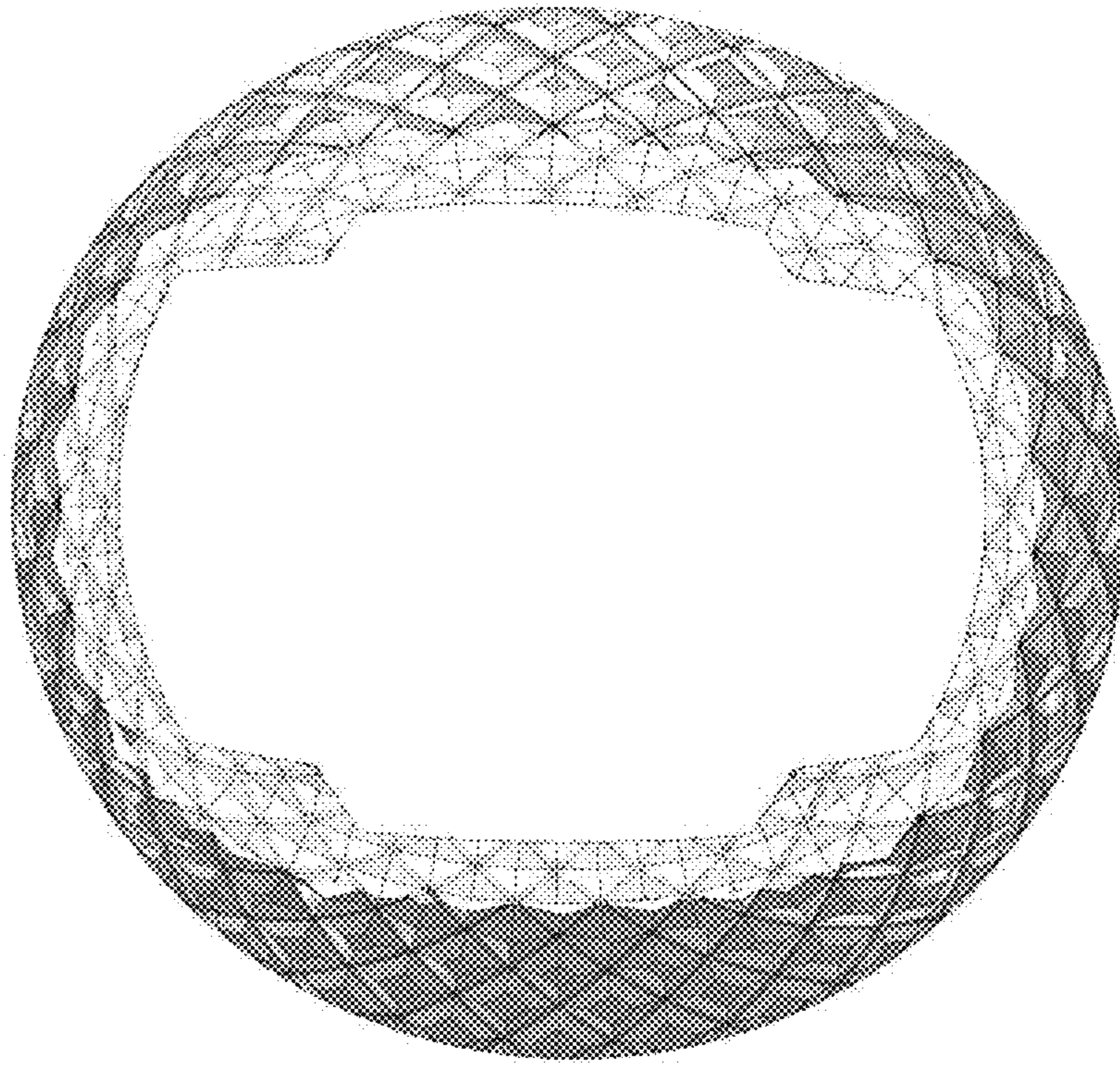

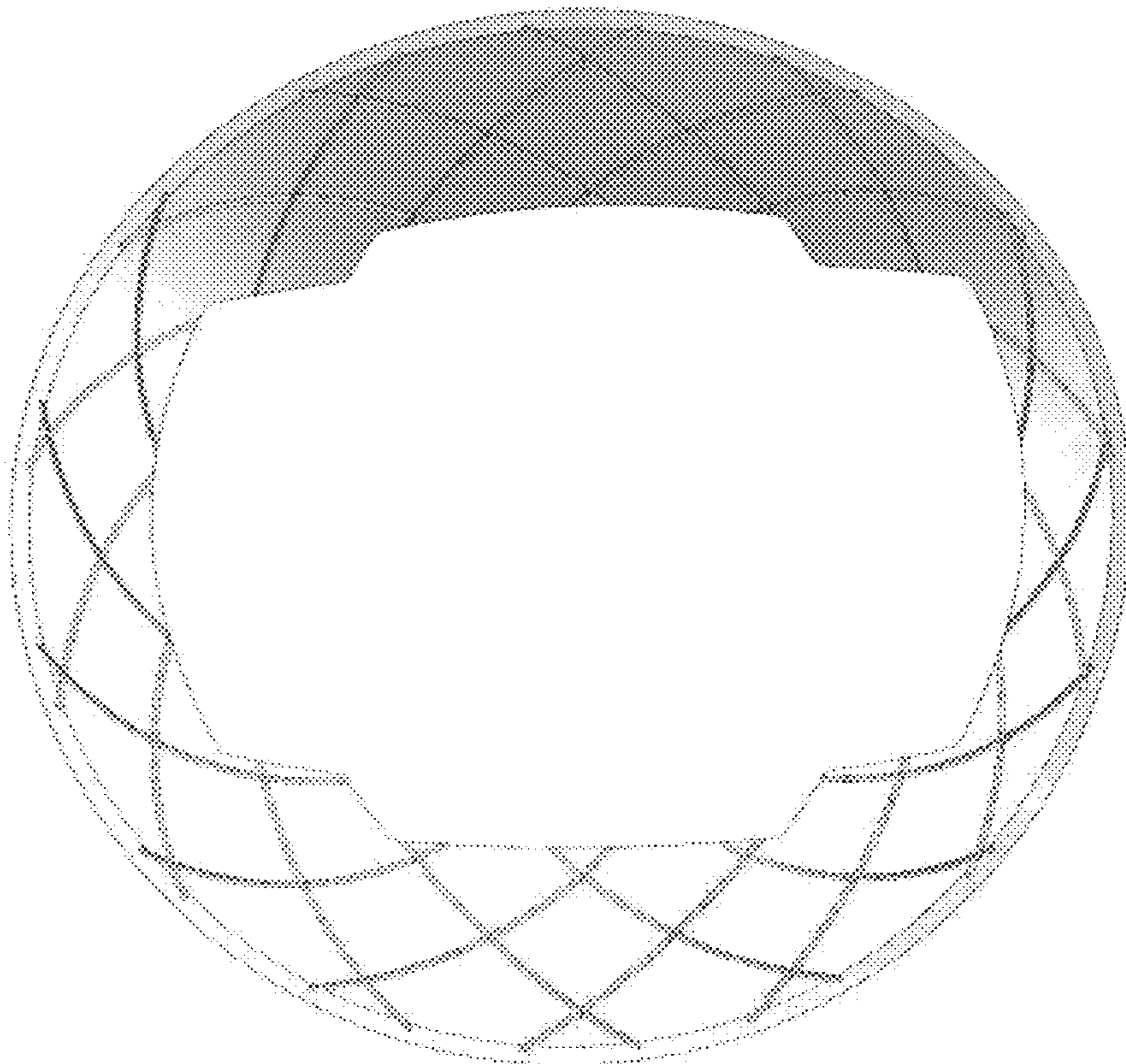

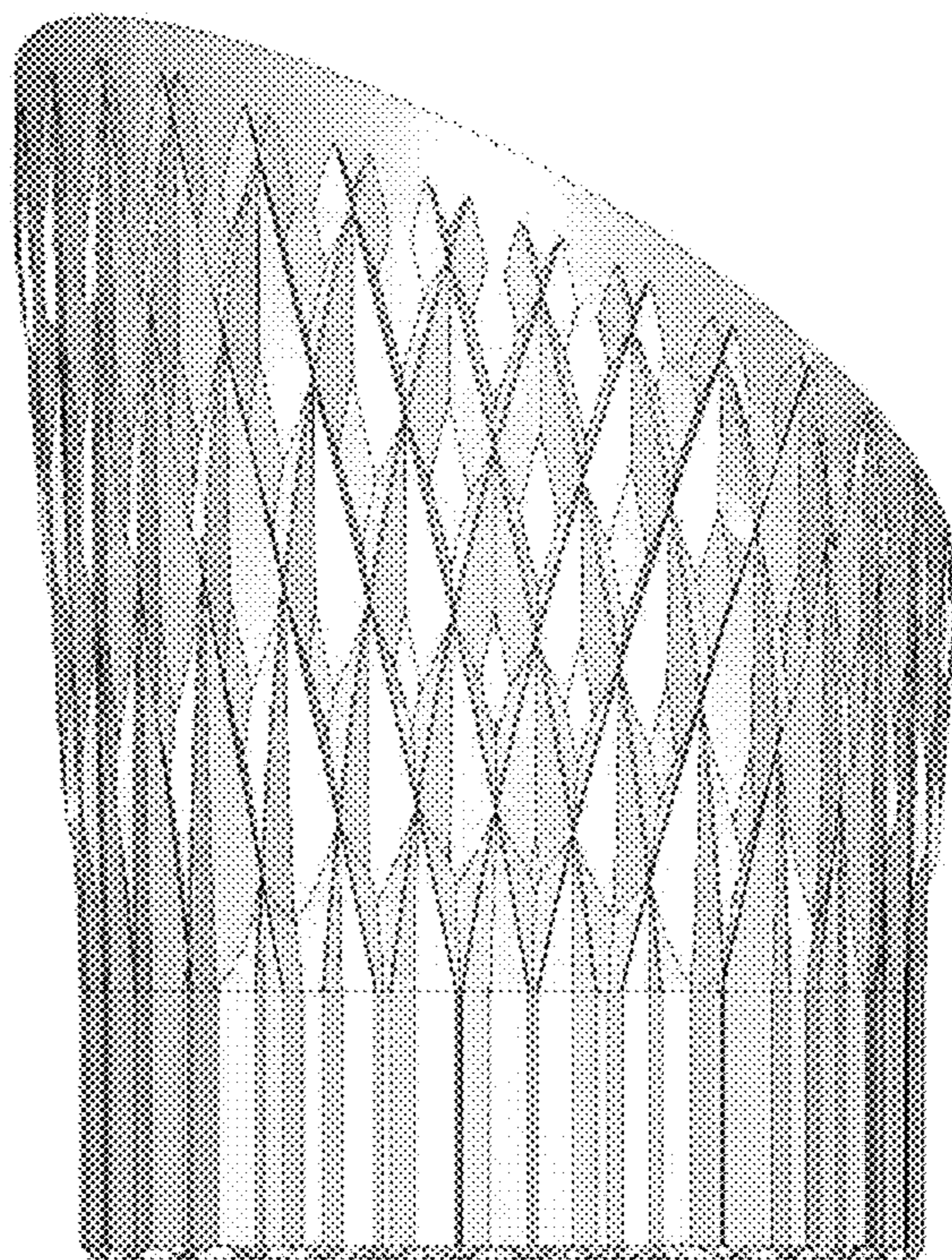

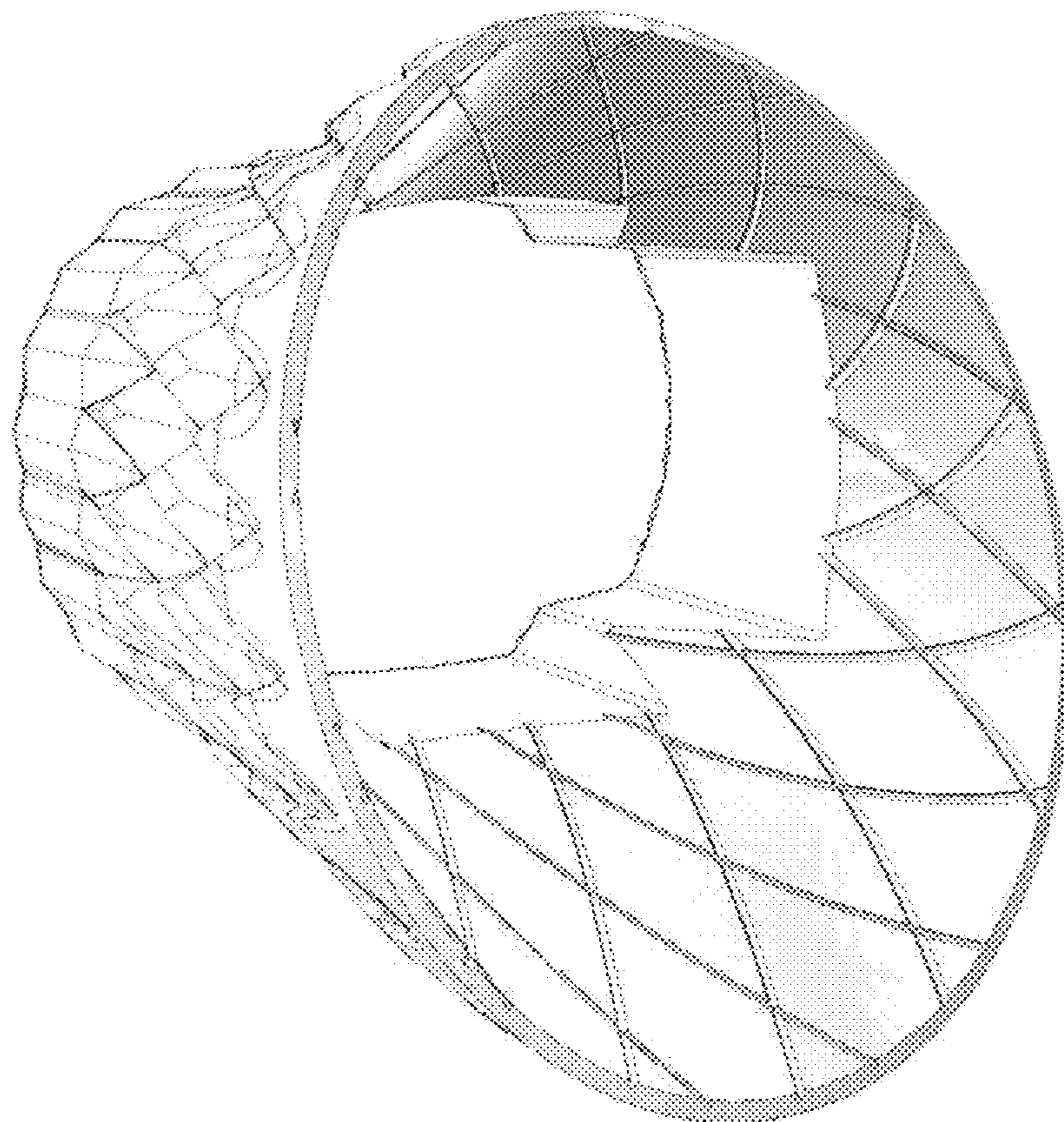

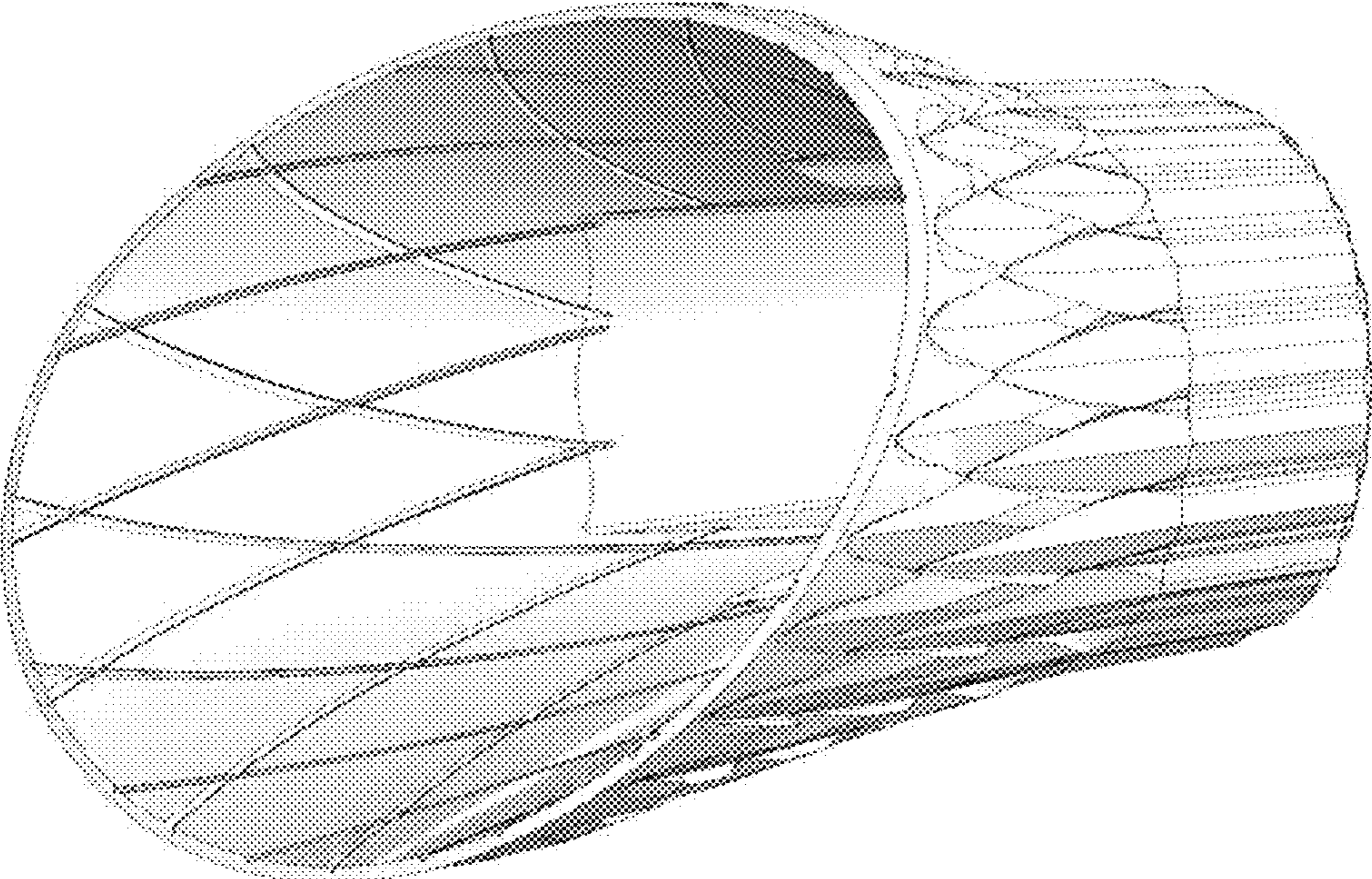

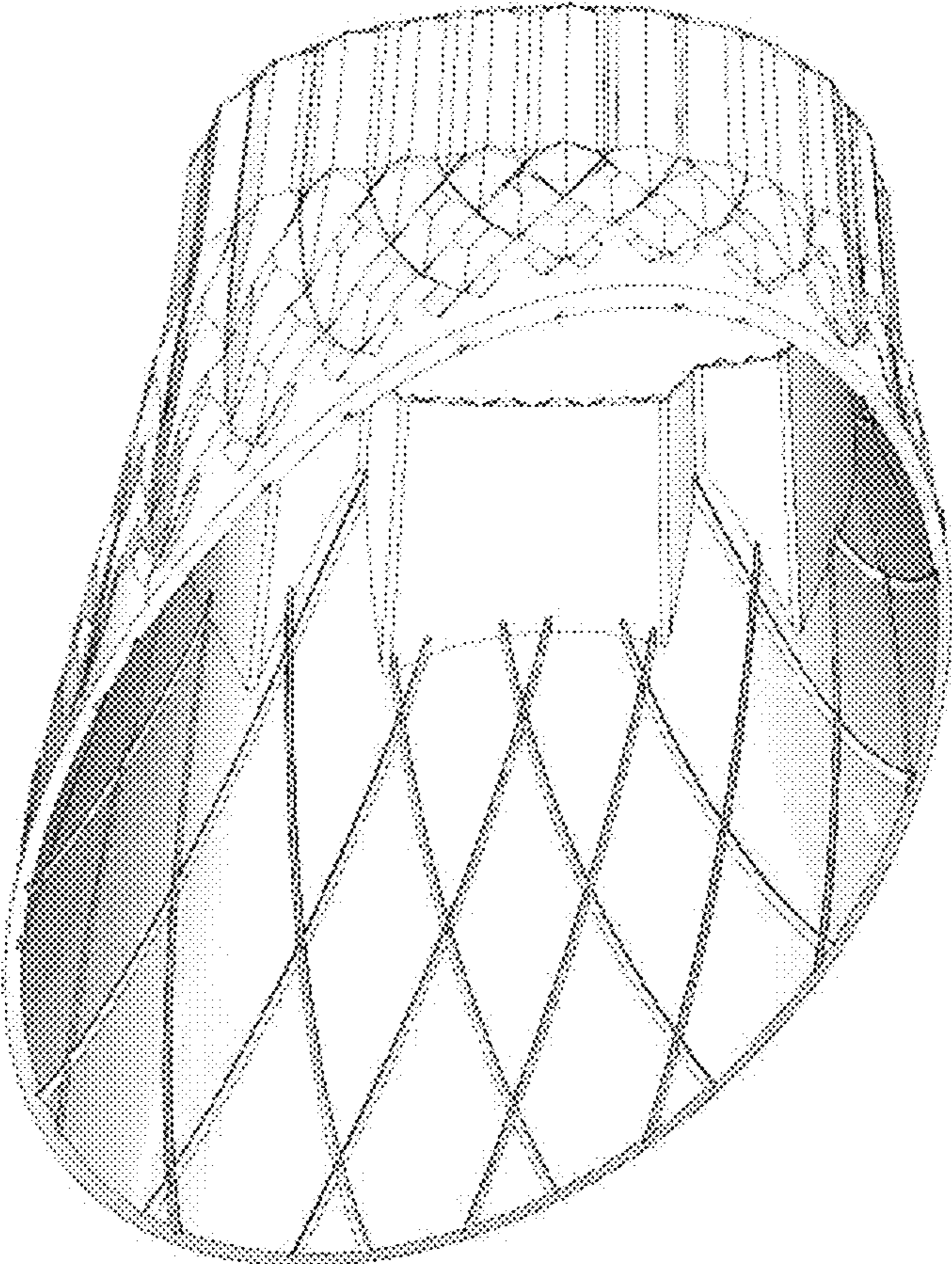

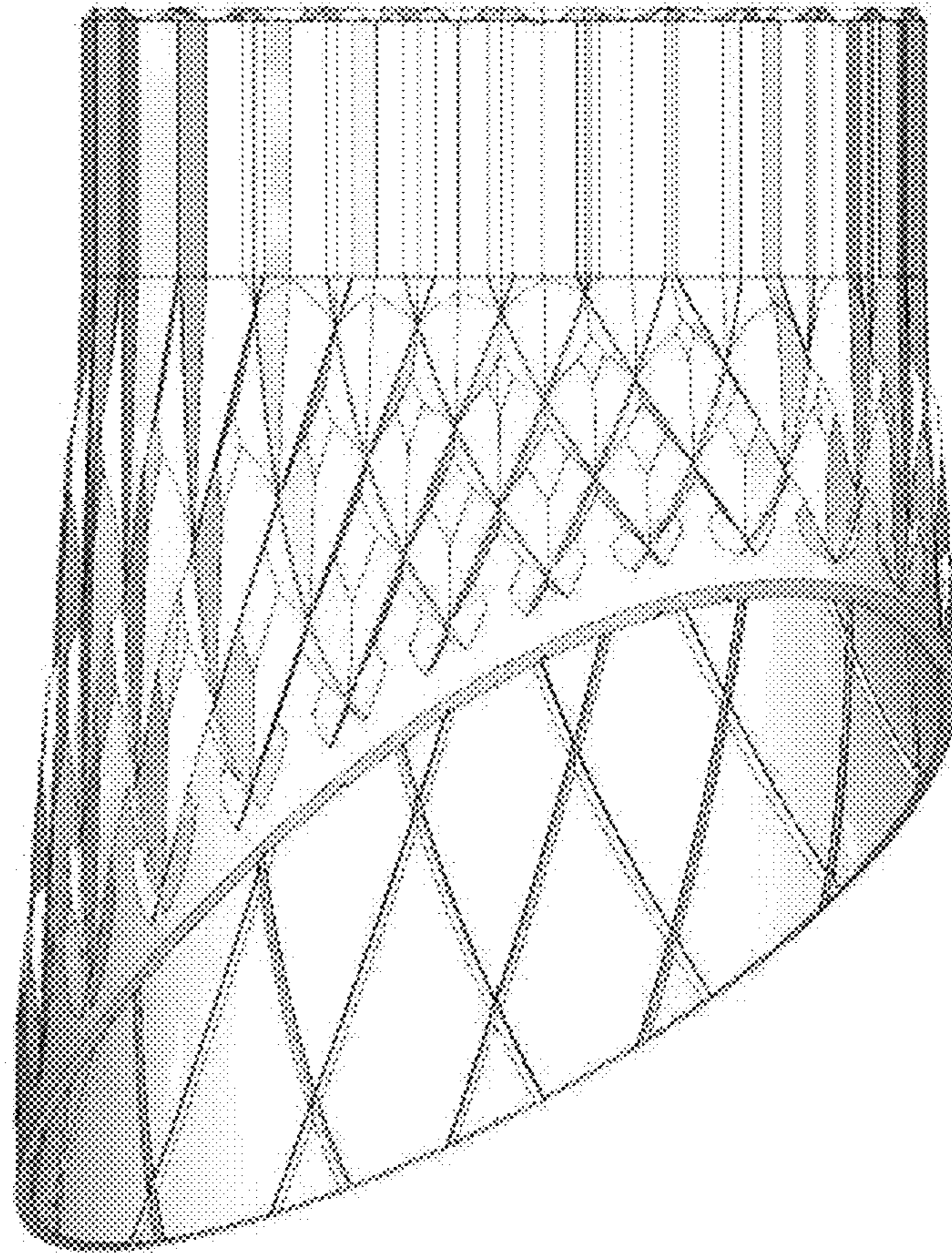

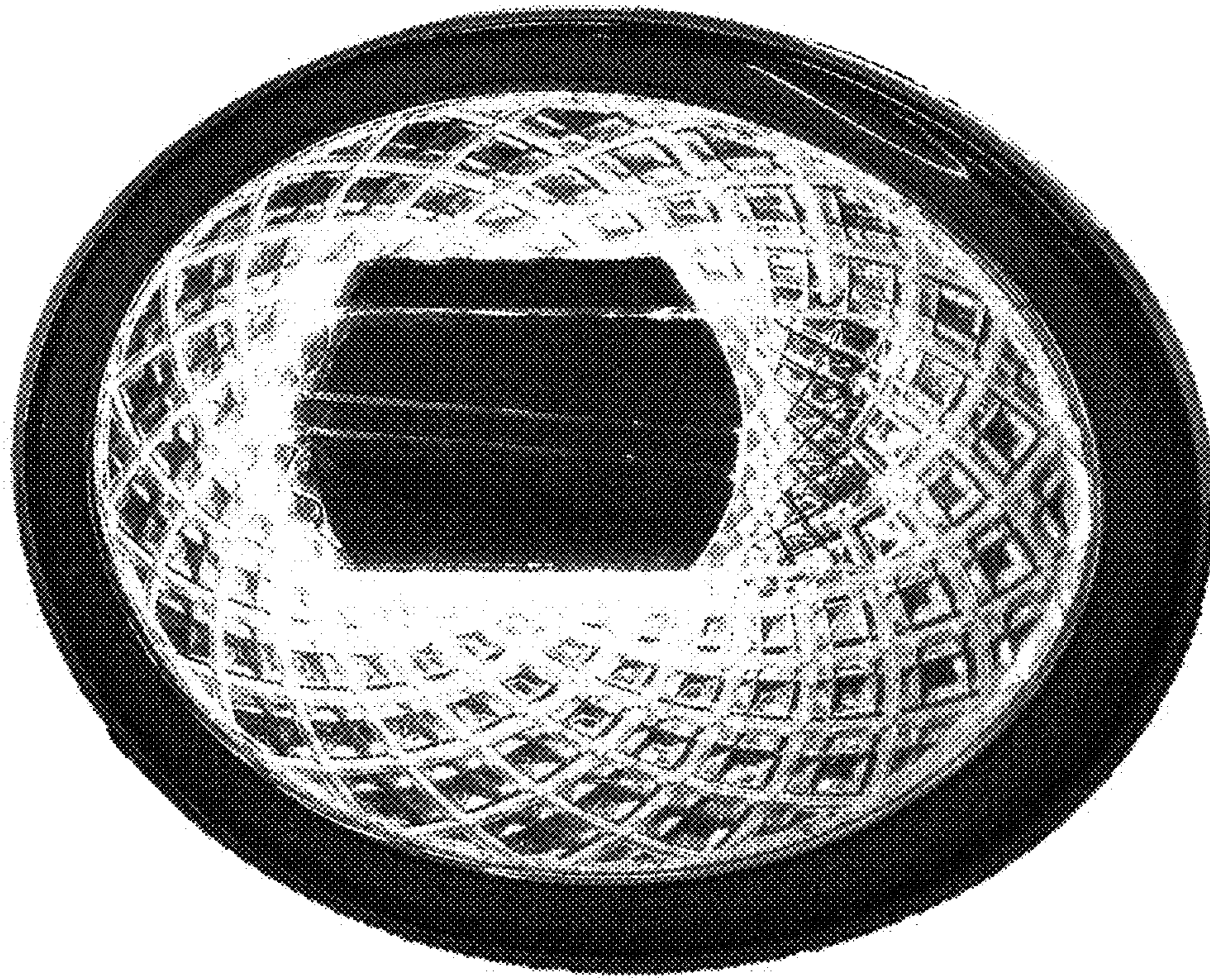

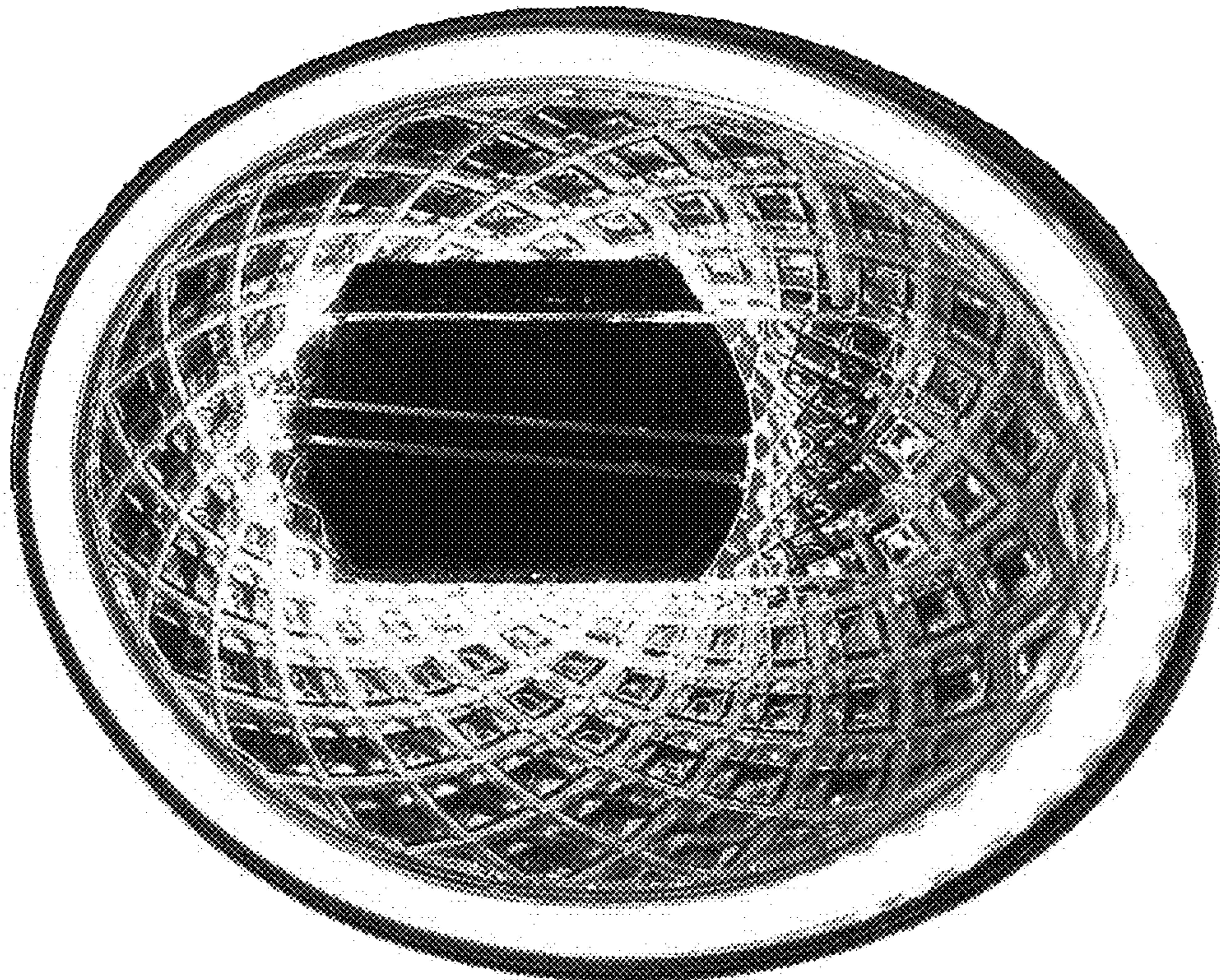
