Figure 1.3 is a bottom plan view thereof;

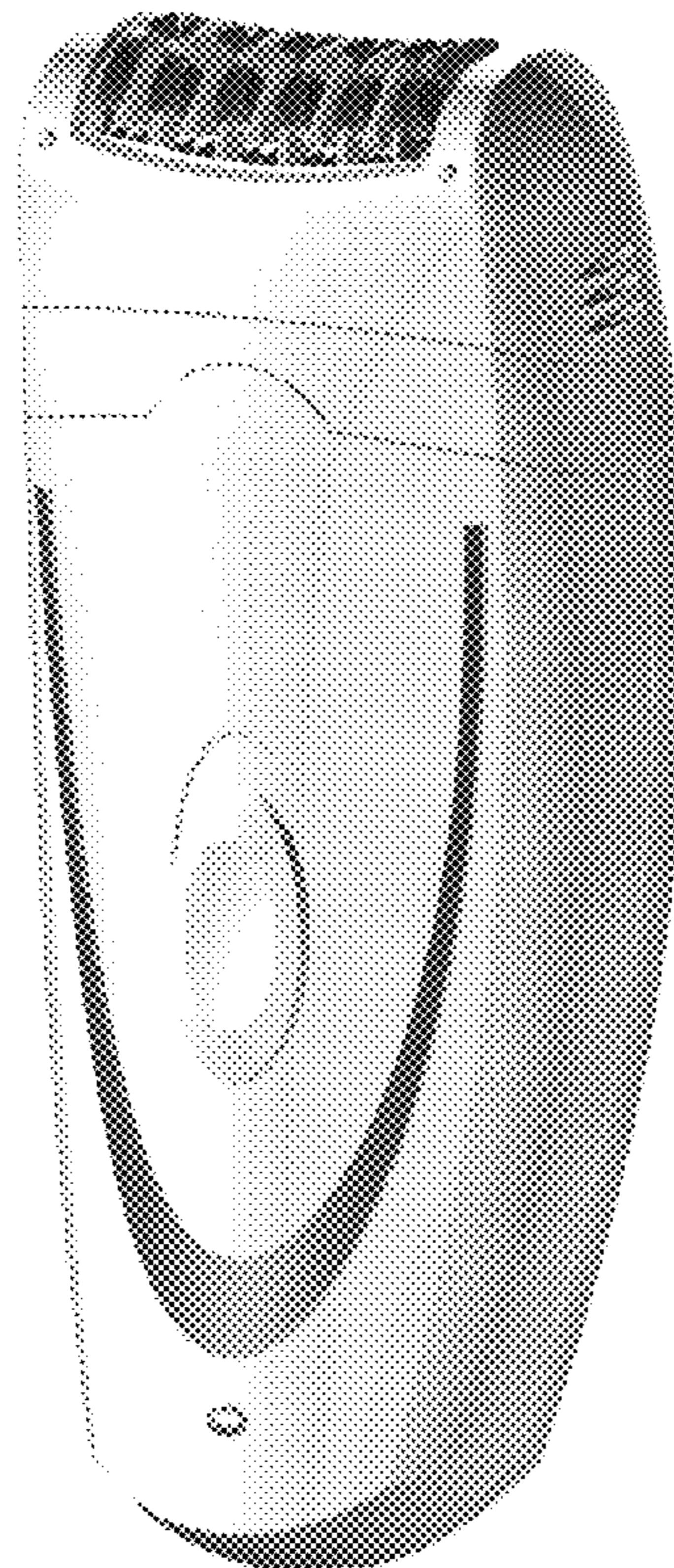
Figure 1.4 is a front elevational view thereof;

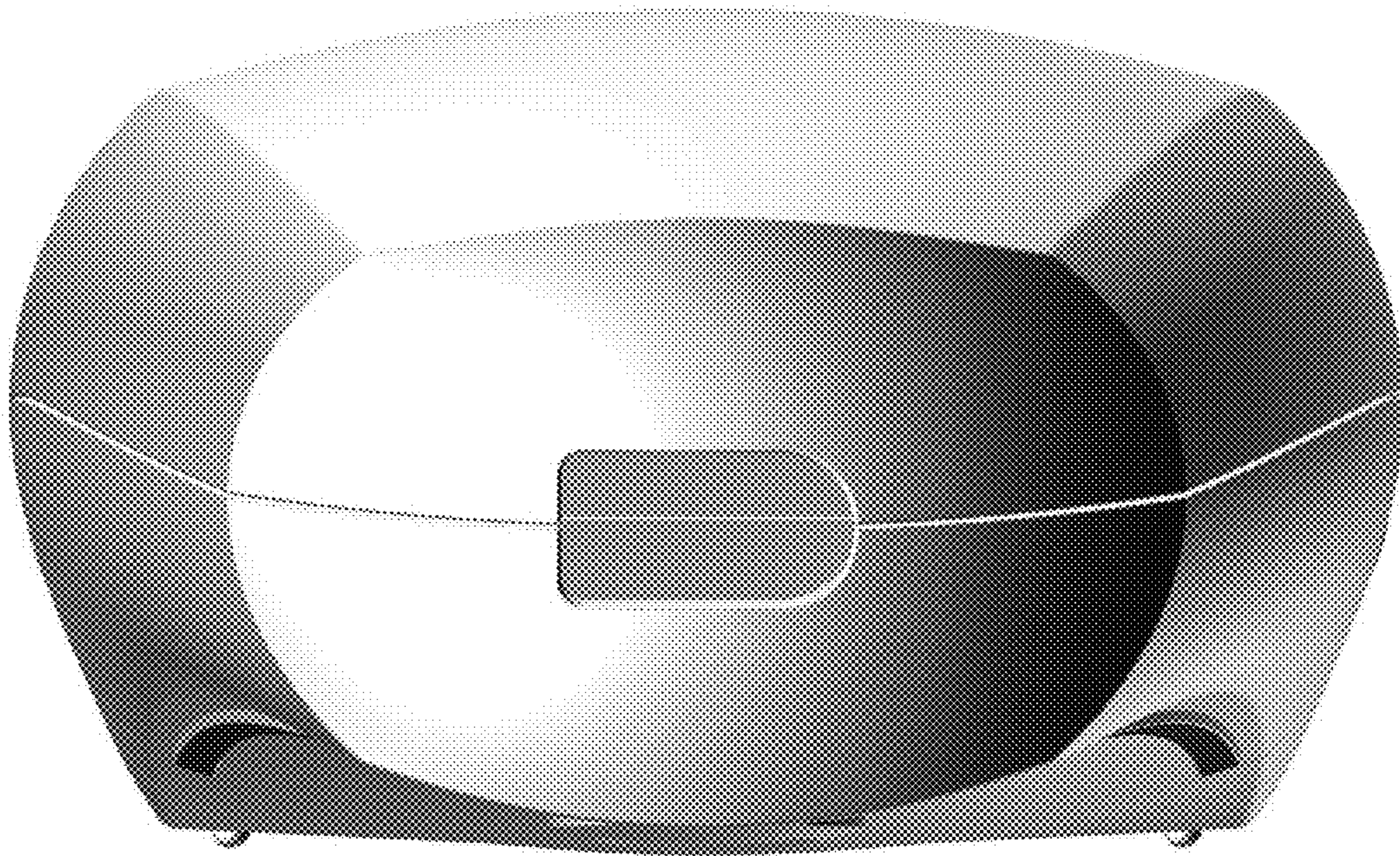

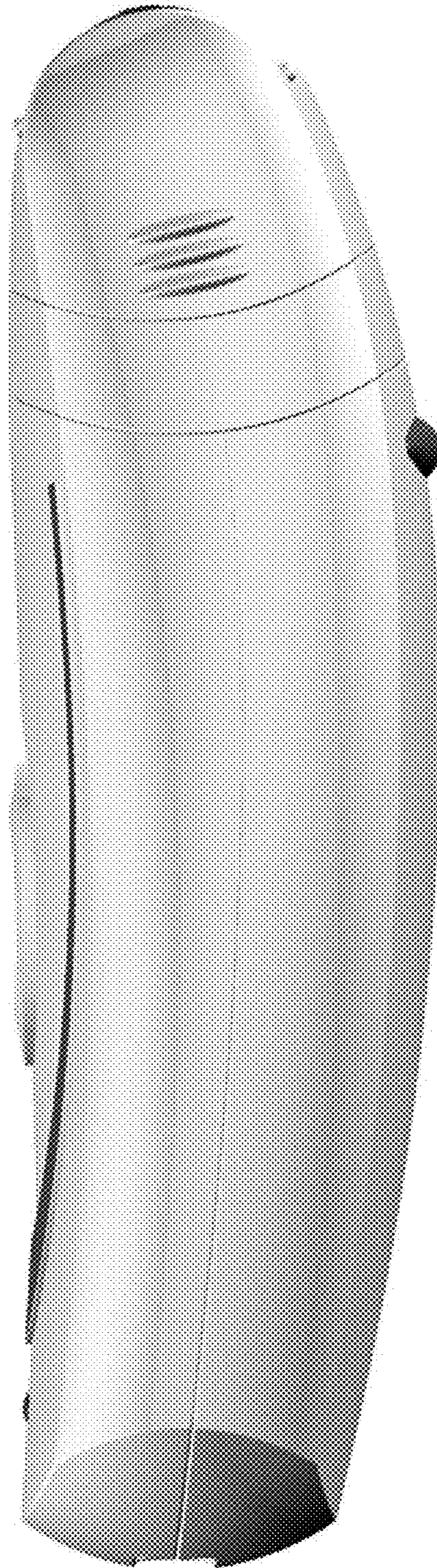

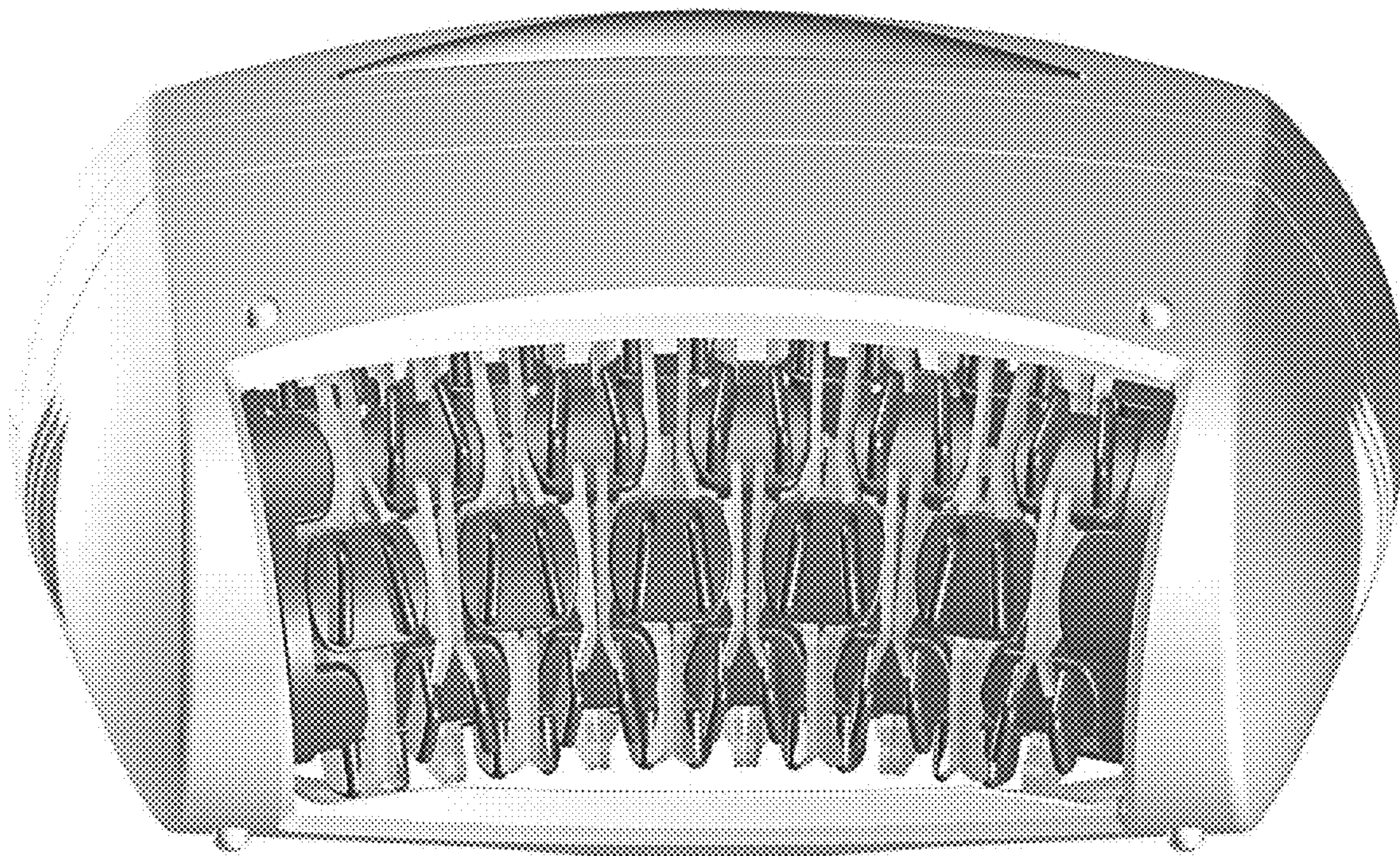
