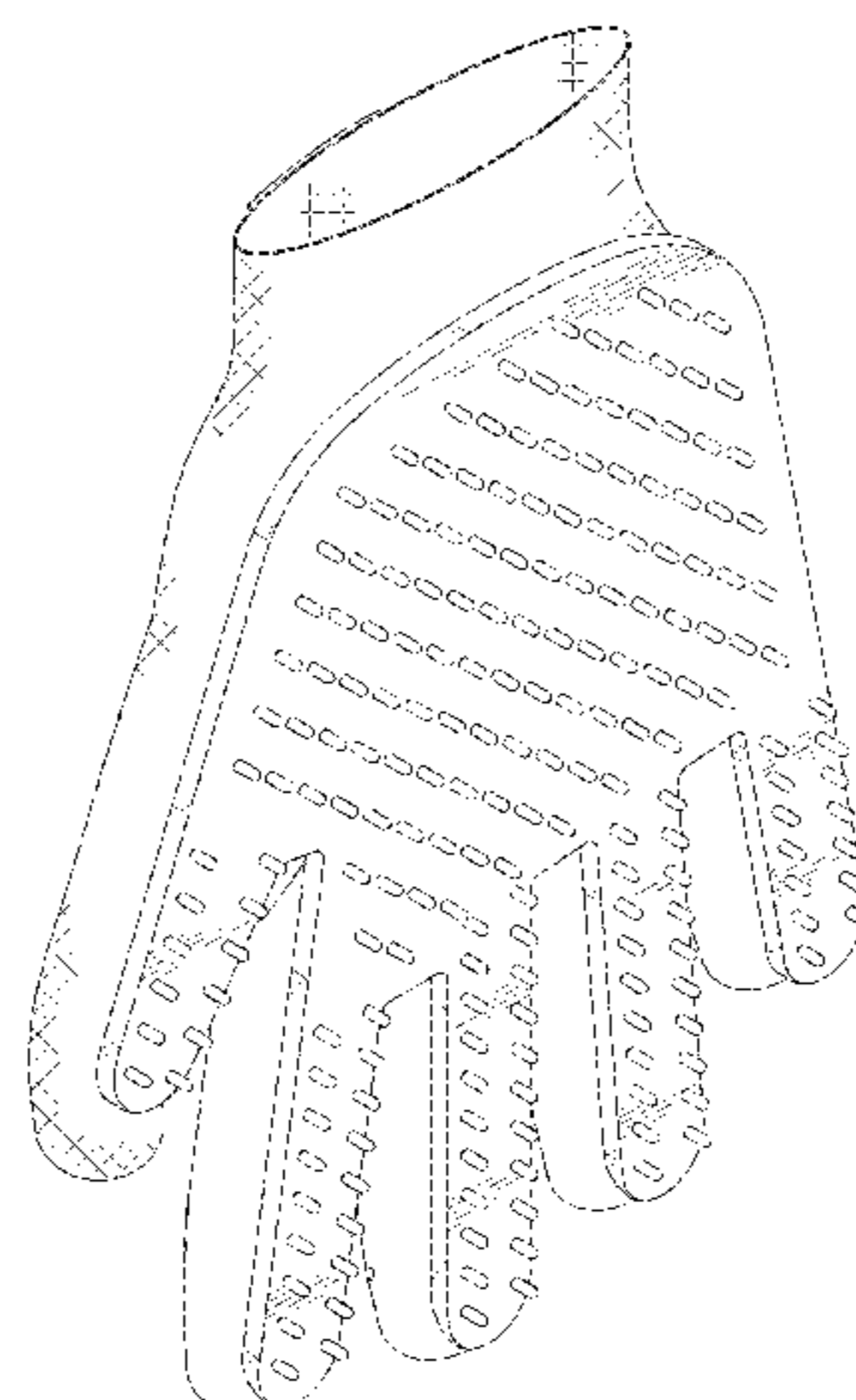
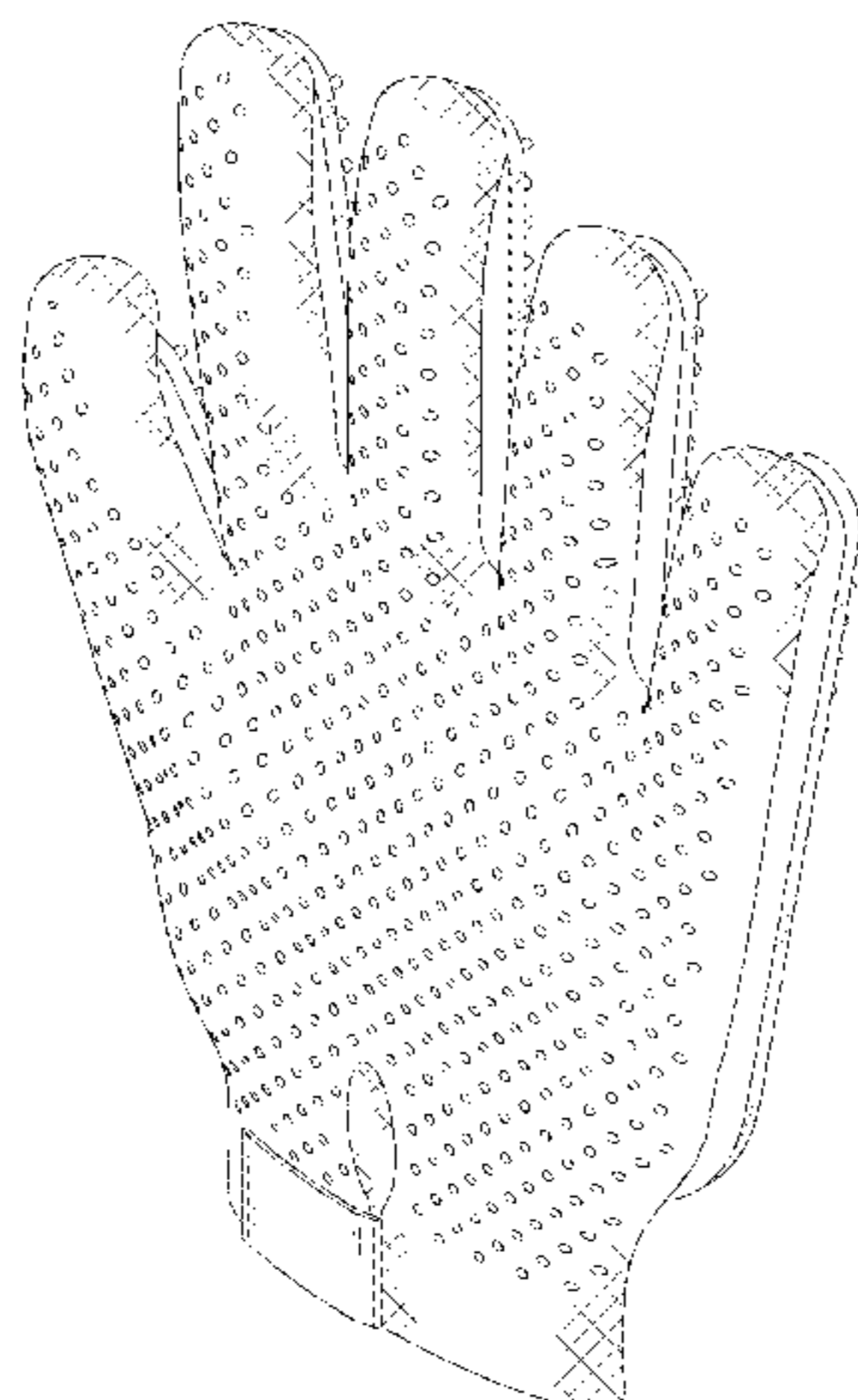


FIG. 8 is a bottom view of an ornamental design for the pet grooming glove according to our invention.

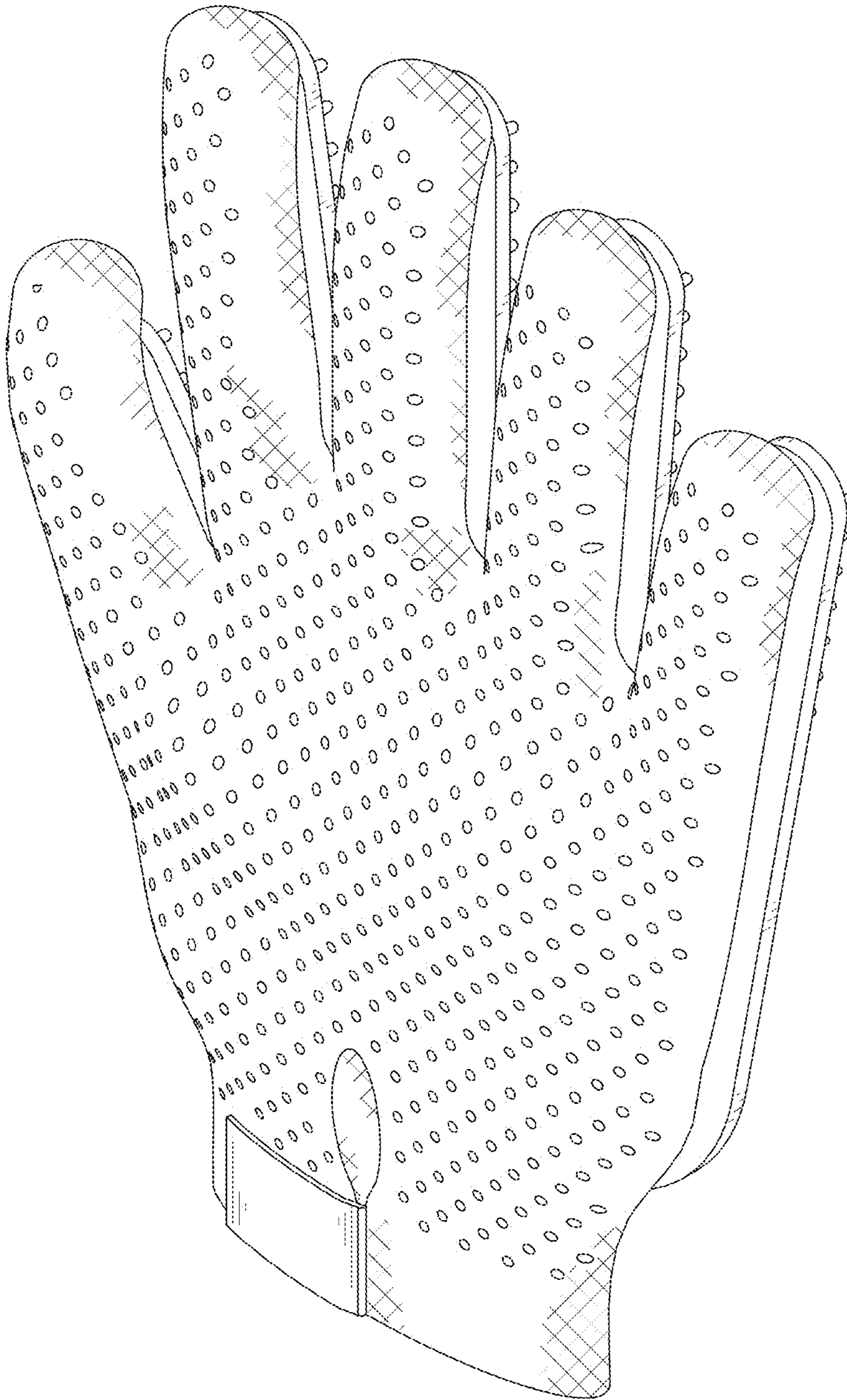

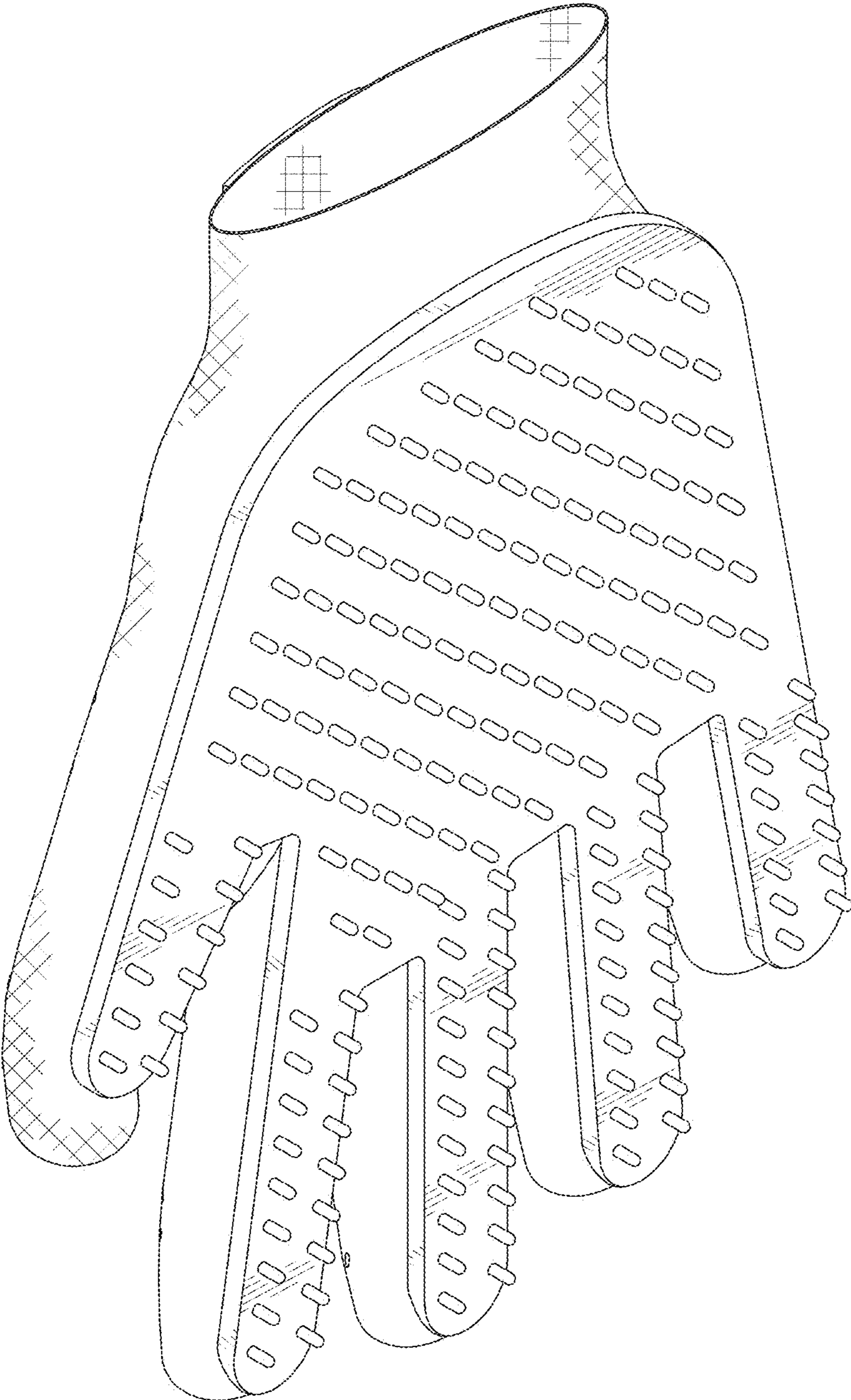

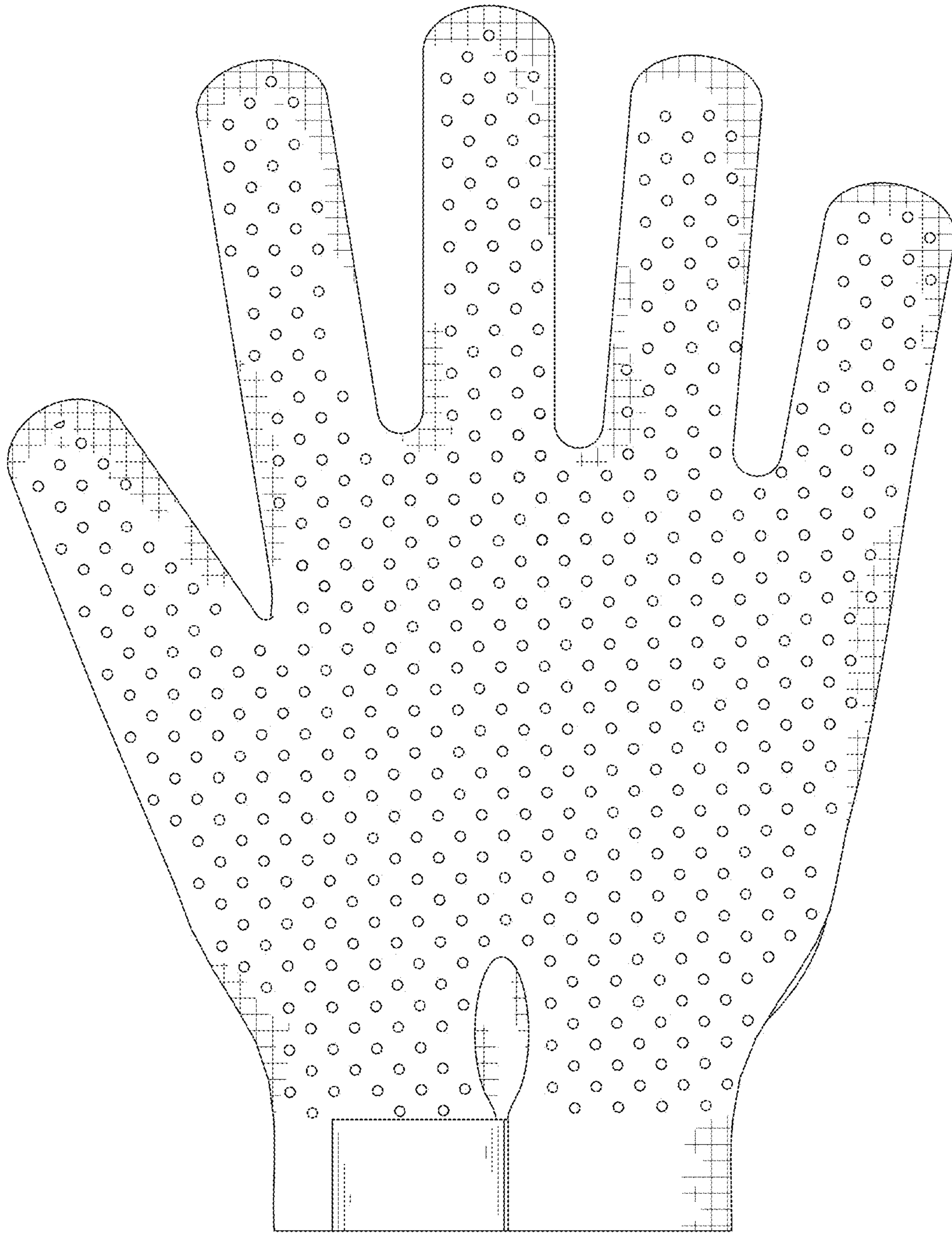

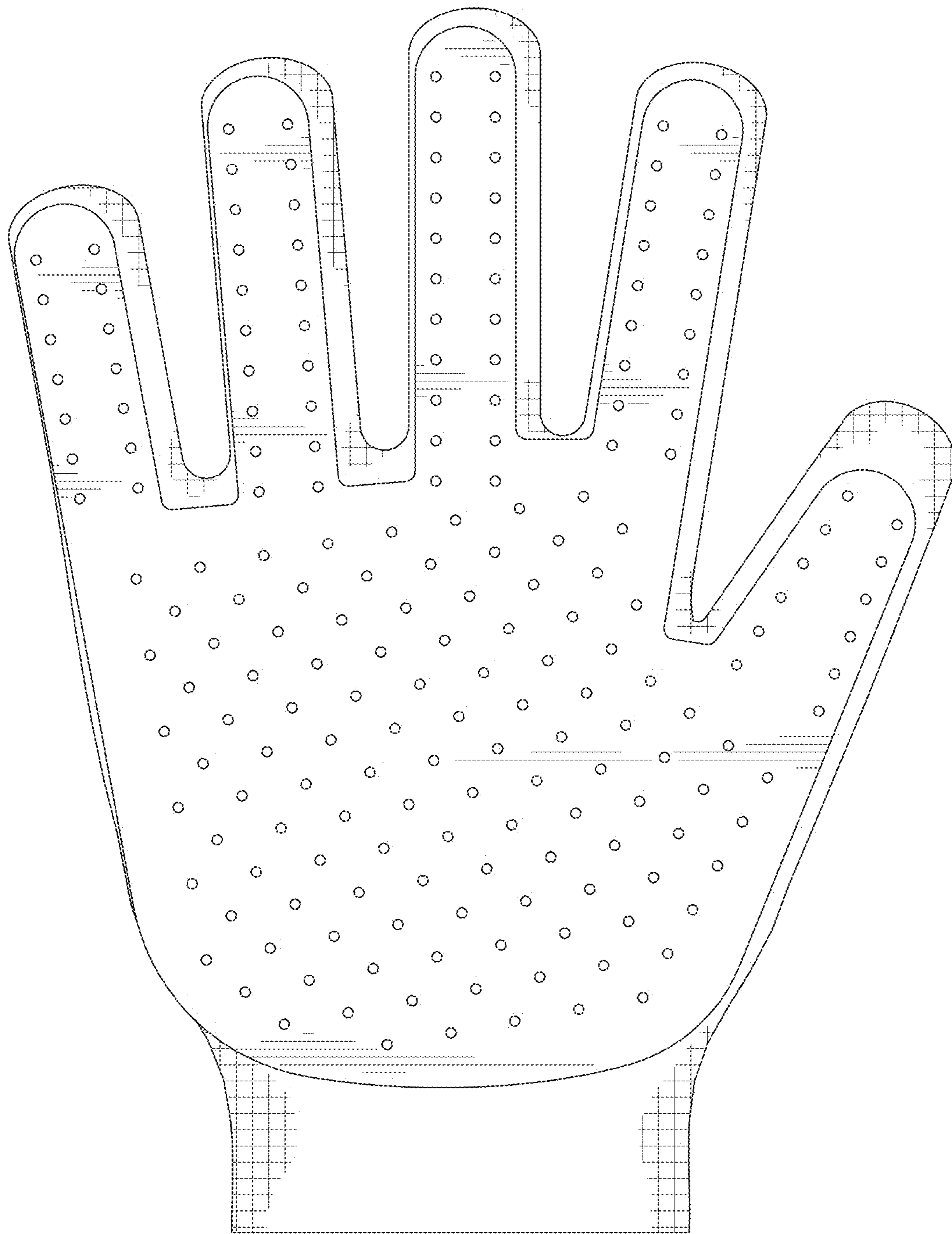

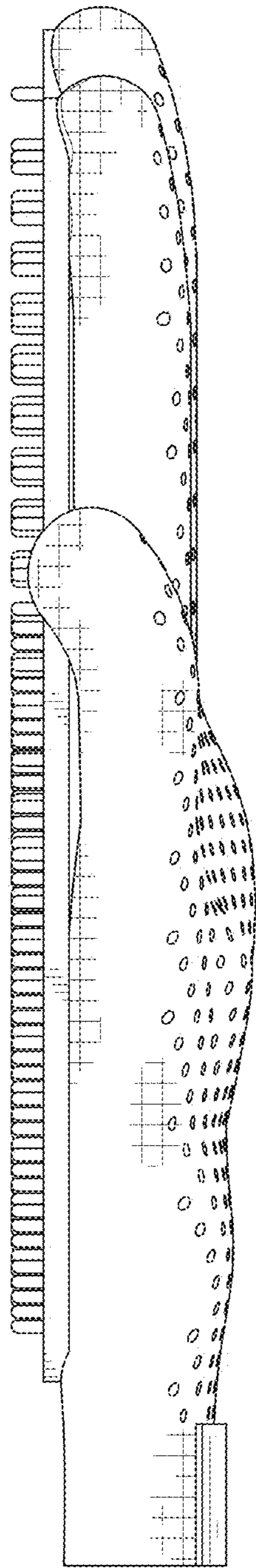

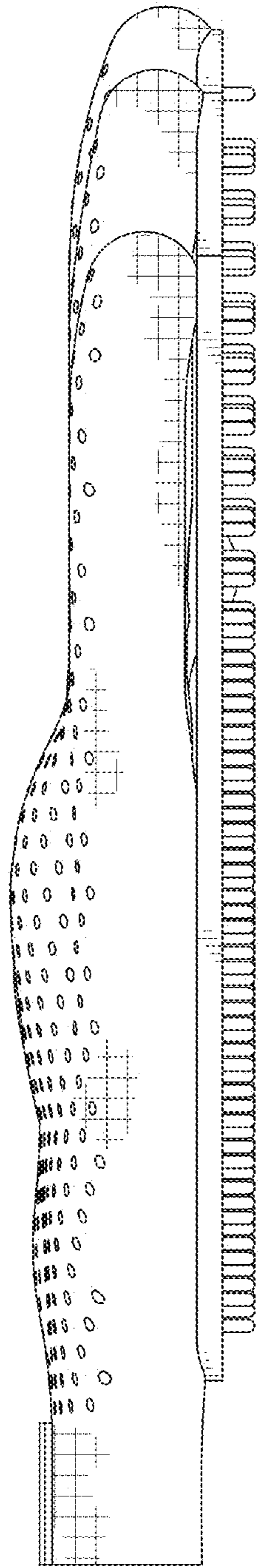

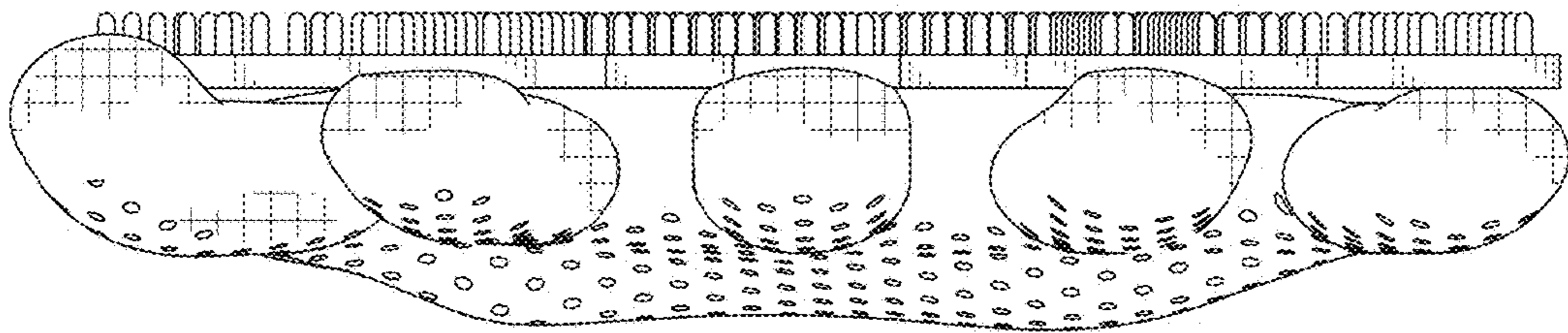

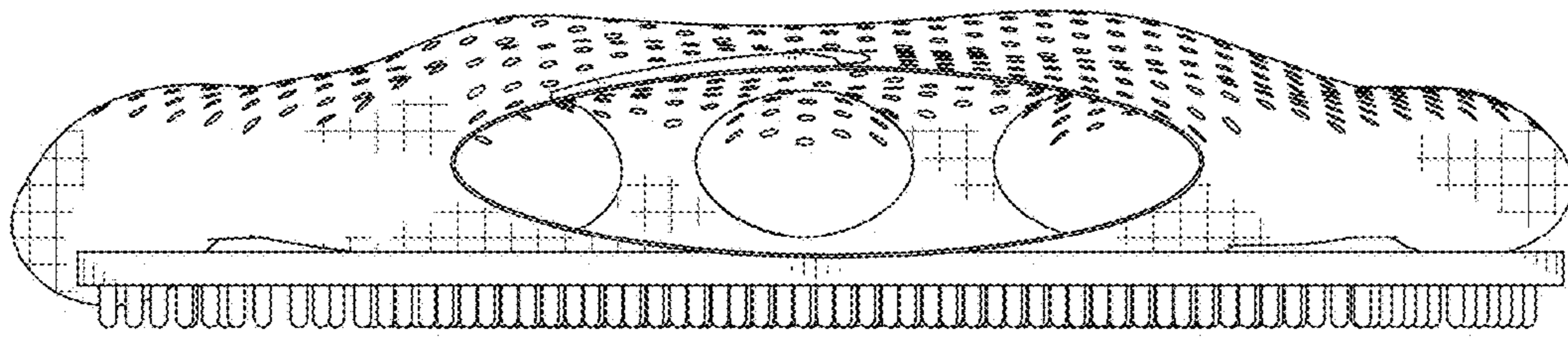
