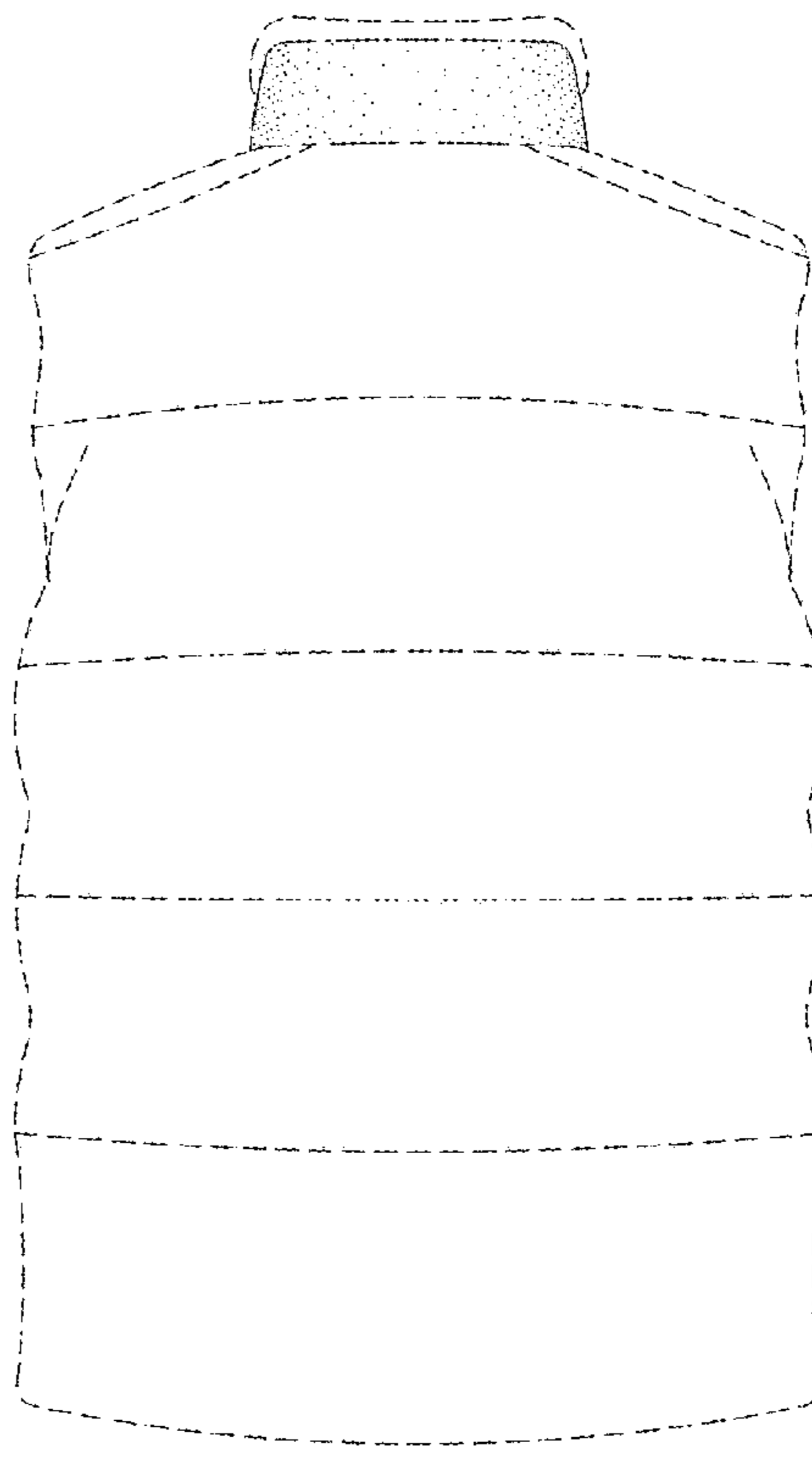
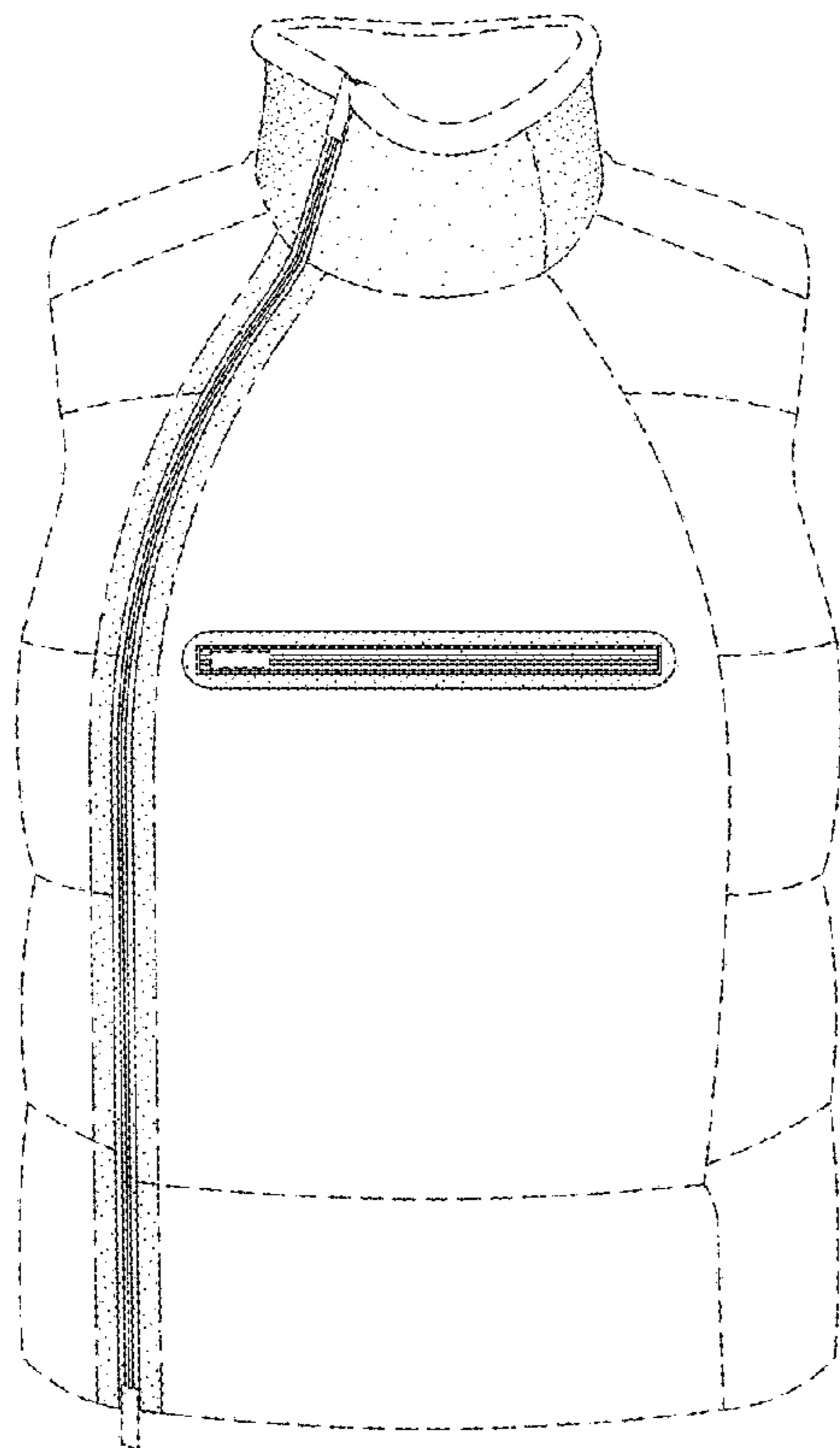
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a garment showing our design;
FIG. 2 is a rear view thereof;
FIG. 3 is a first side view thereof;

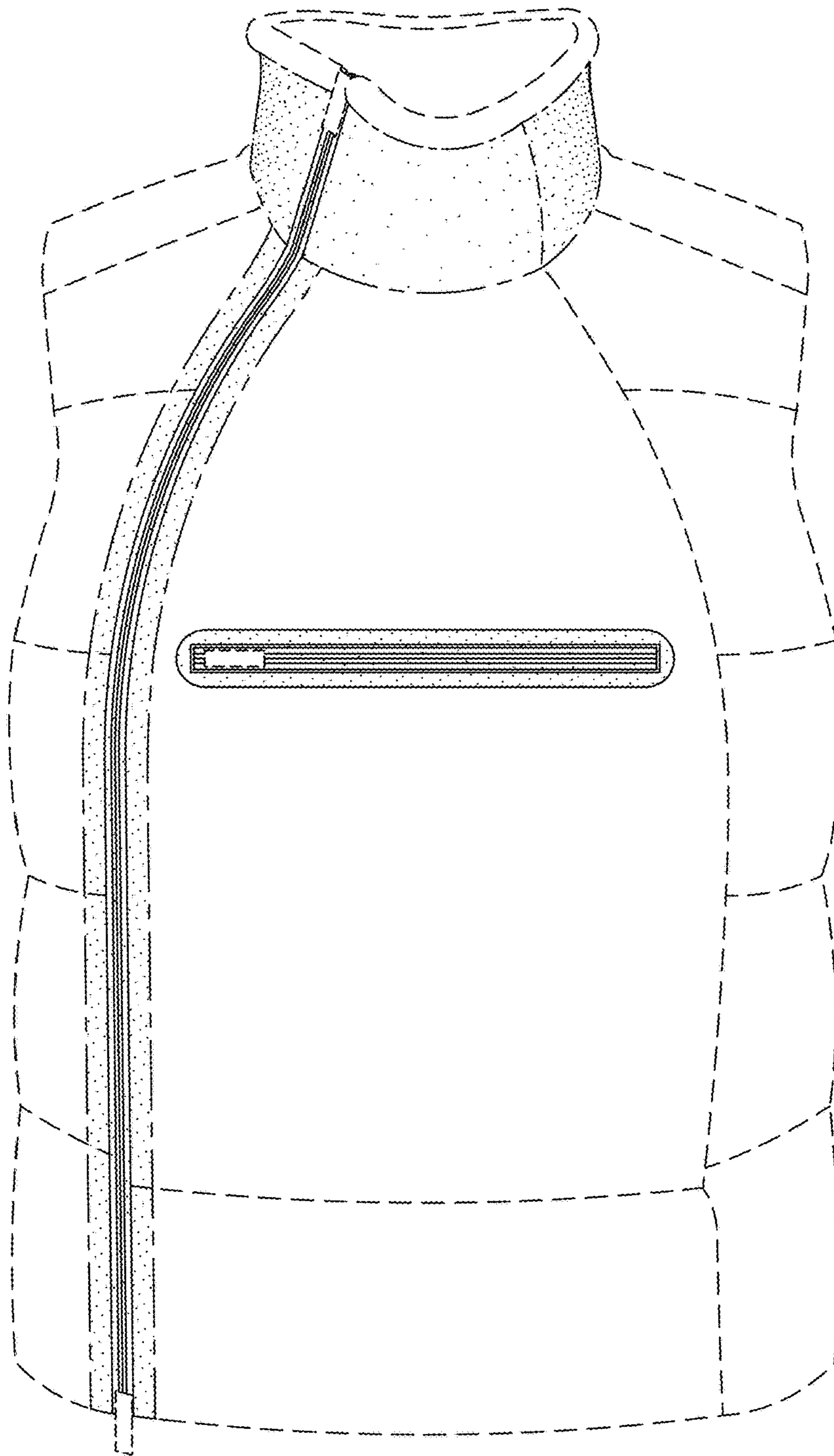

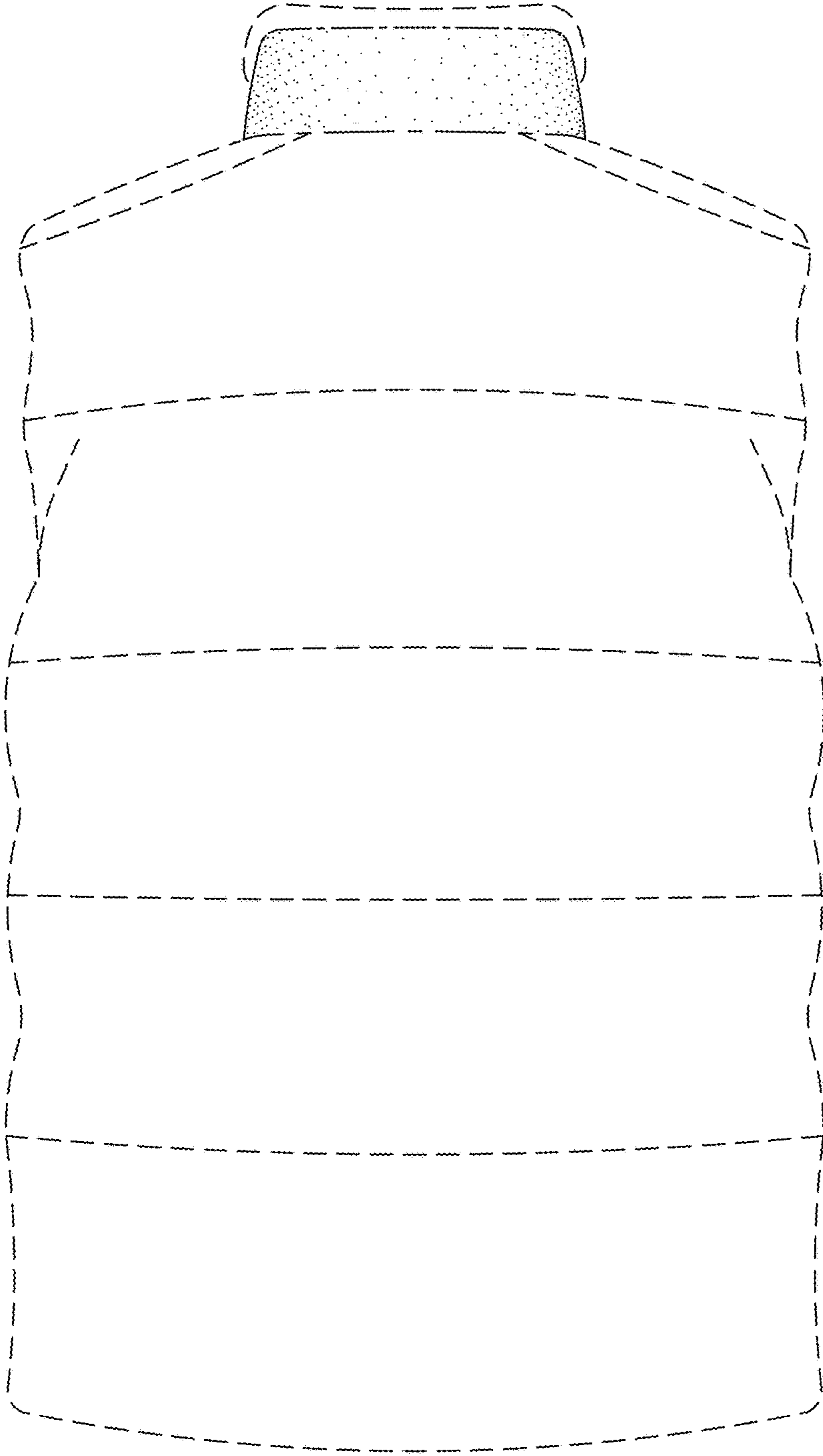

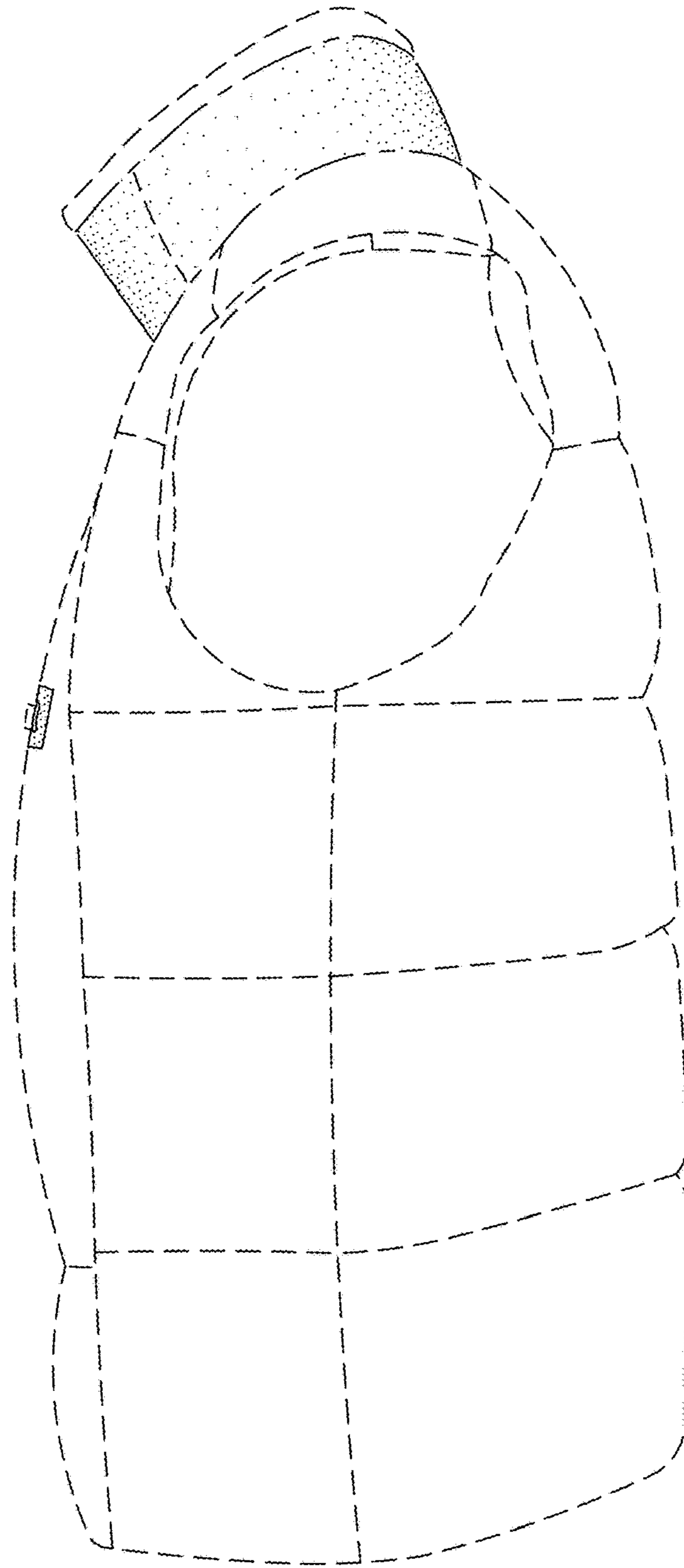

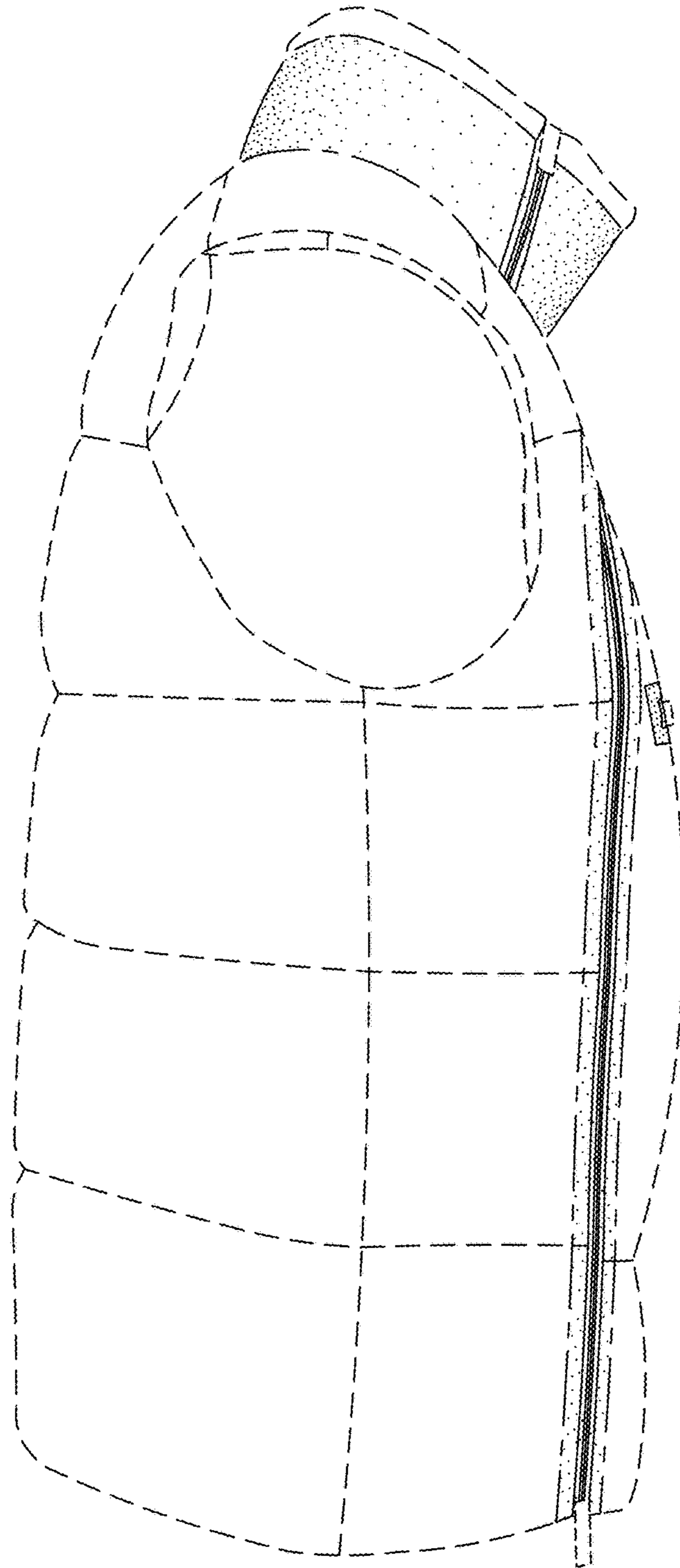

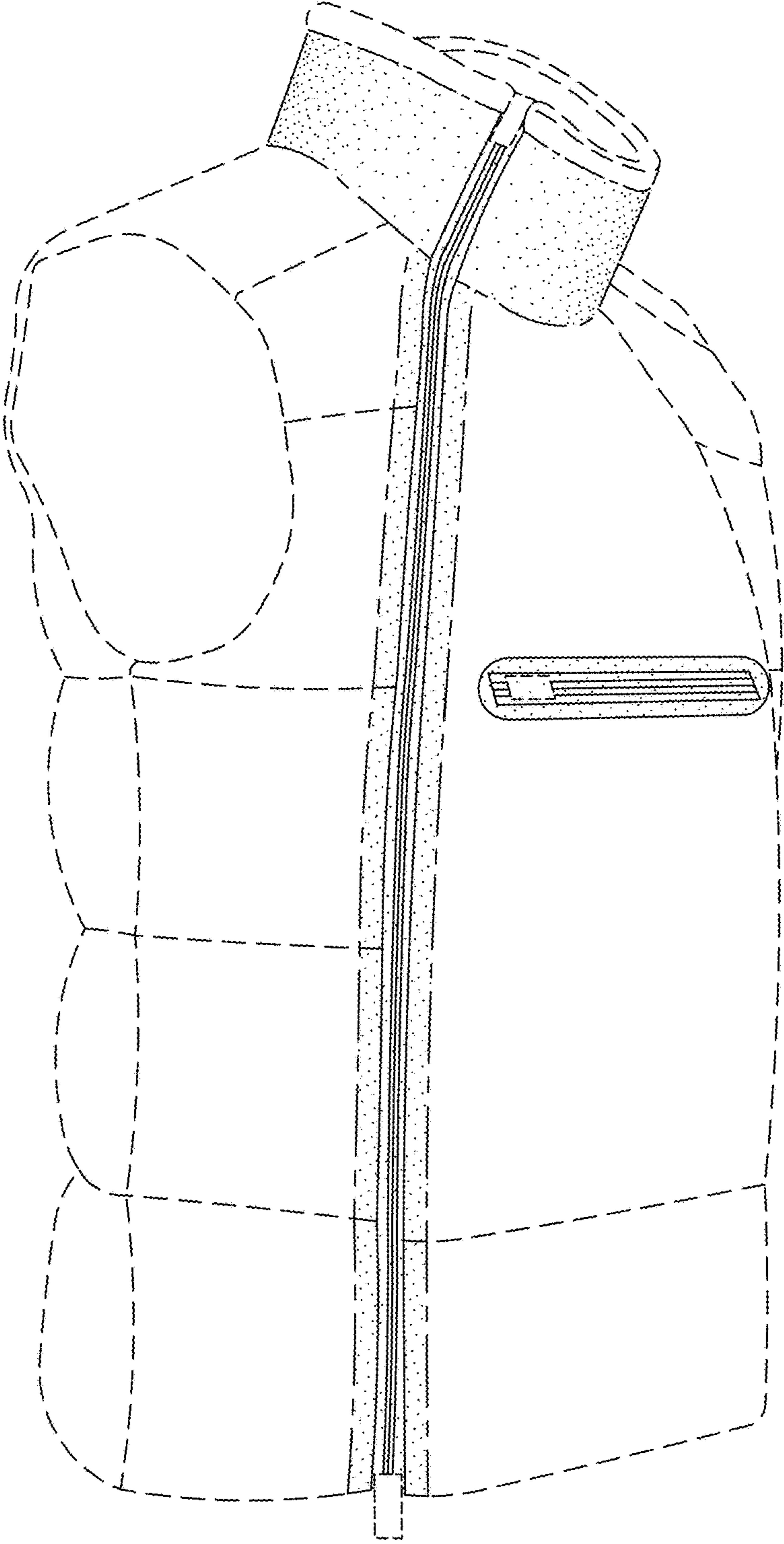
