(57) **CLAIM**

We claim the ornamental design for a coat extension, as shown and described.

DESCRIPTION

FIG. 1 is a Front Perspective view of the first variant of a coat extension showing our new design.

FIG. 2 is a Rear Perspective view of the coat extension shown in FIG. 1.

FIG. 3 is a Close-up view of a portion of the coat extension shown in FIG. 1 and FIG. 10.

FIG. 4 is a Left side view of the coat extension shown in FIG. 1.

FIG. 5 is a Front view of the coat extension shown in FIG. 1.

FIG. 6 is a Right side view of the coat extension shown in FIG. 1.

FIG. 7 is a Rear view of the coat extension shown in FIG. 1.

FIG. 14 is a Right side view of the coat extension shown in FIG. 10.

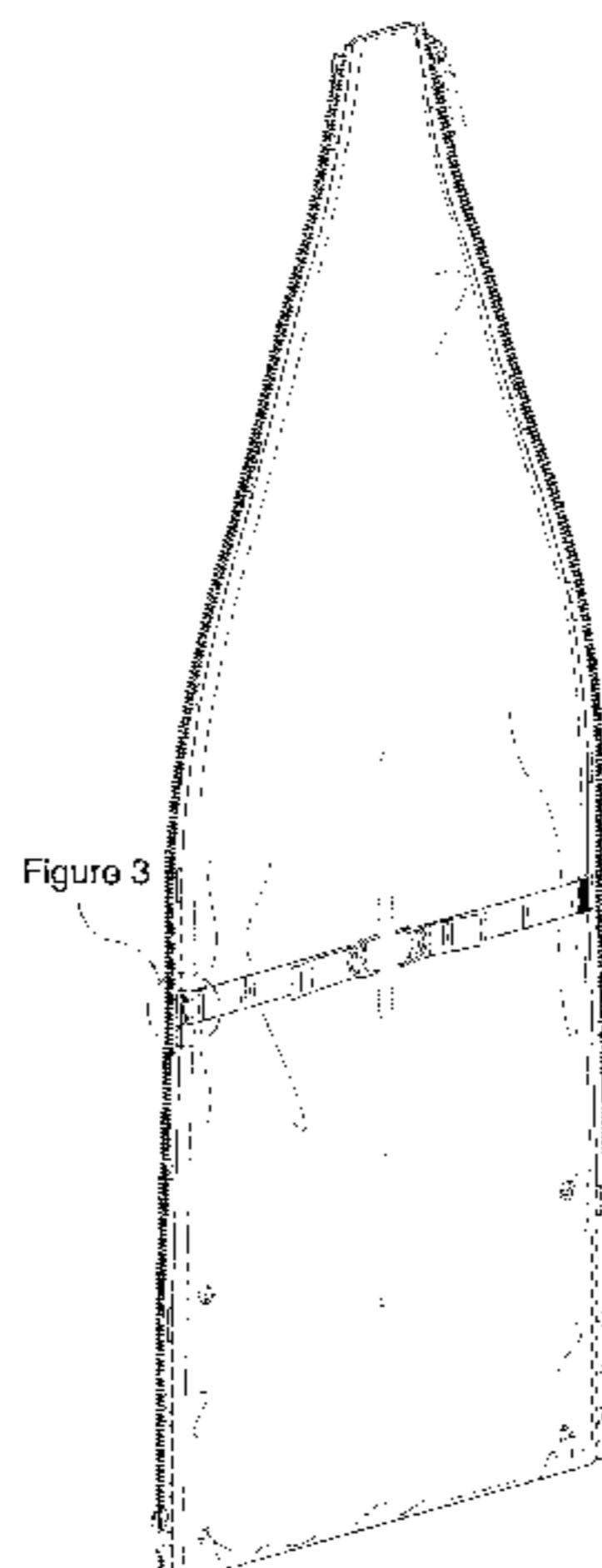
FIG. 15 is a Rear view of the coat extension shown in FIG. 10.

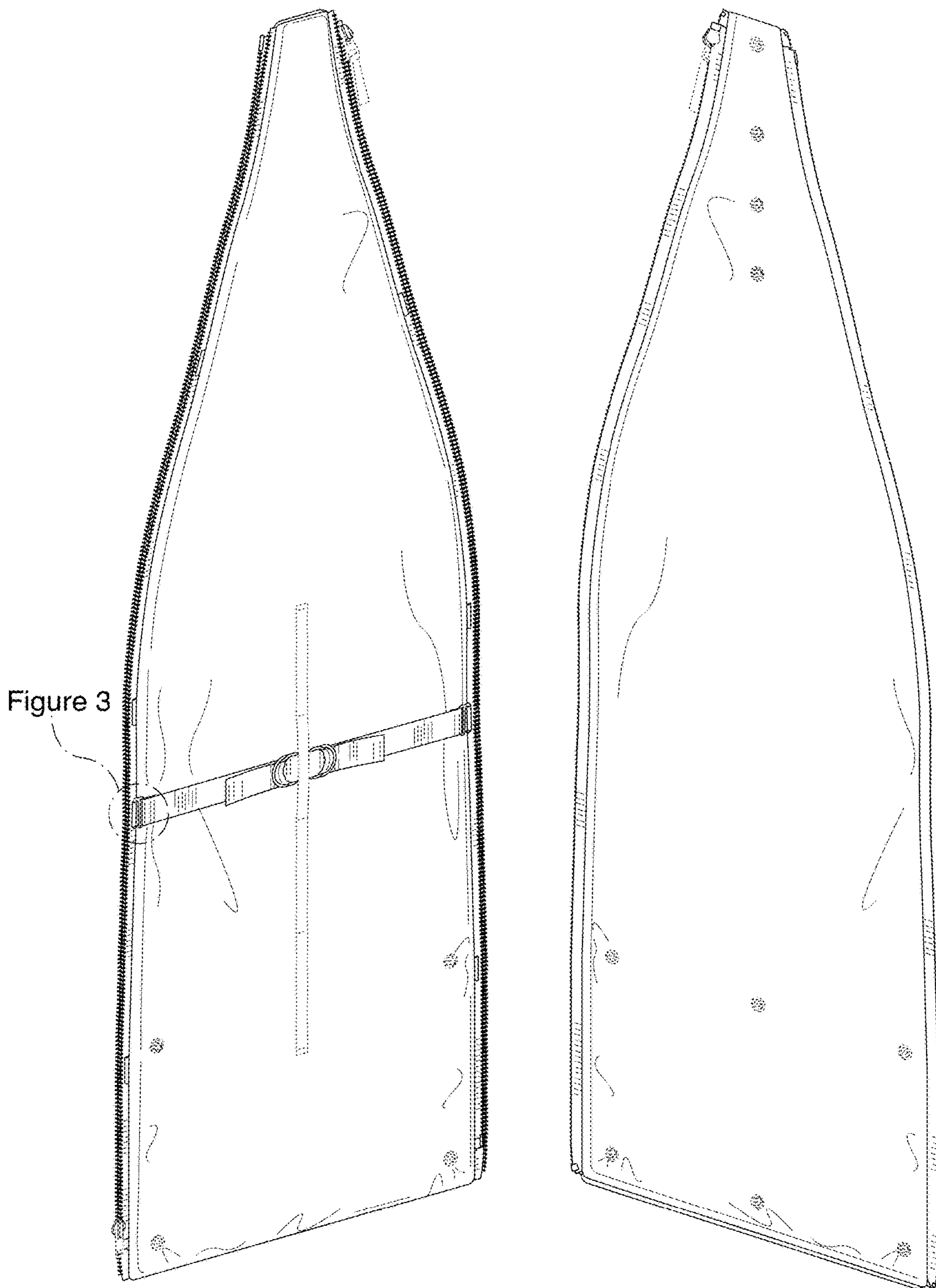

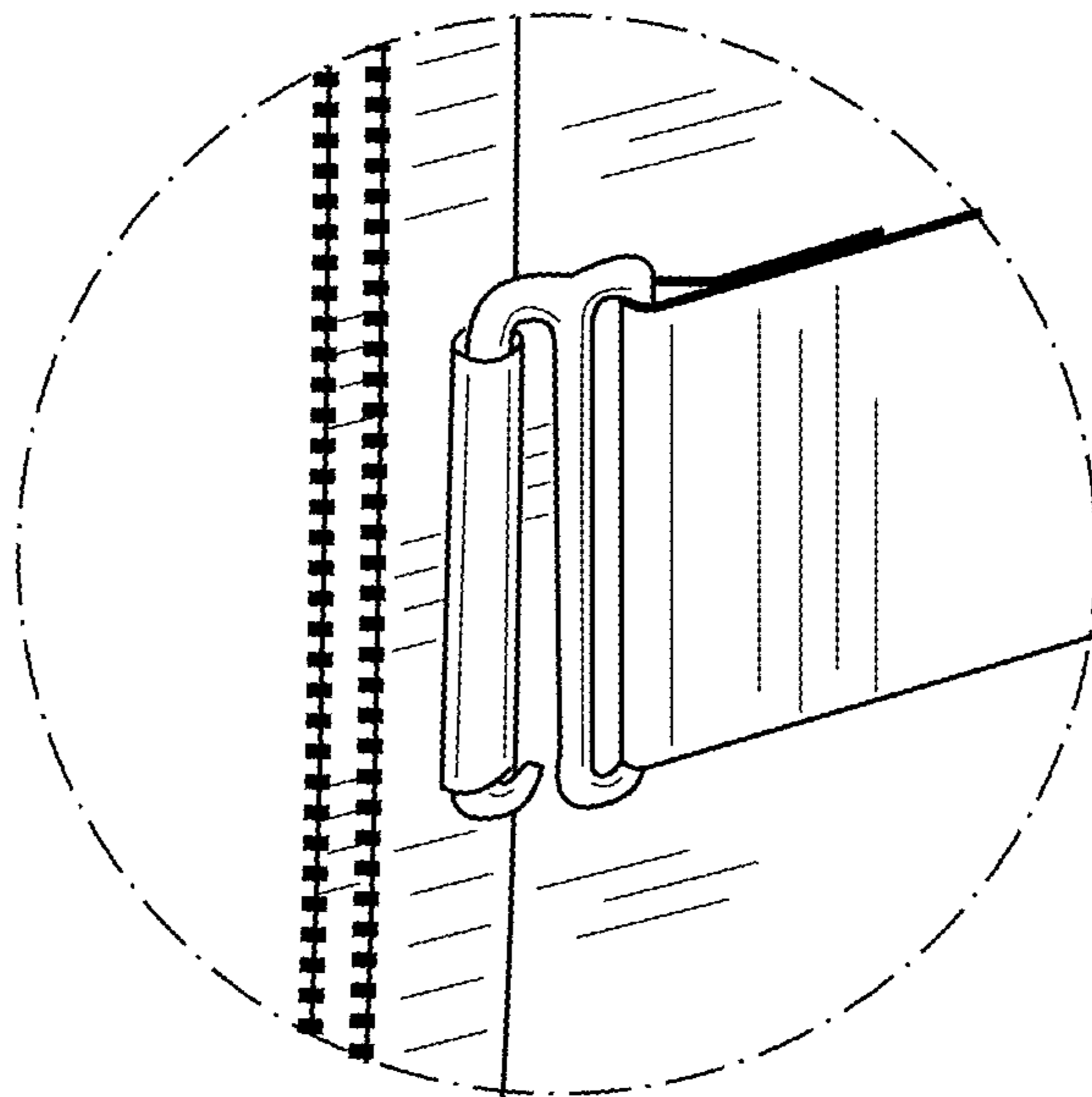

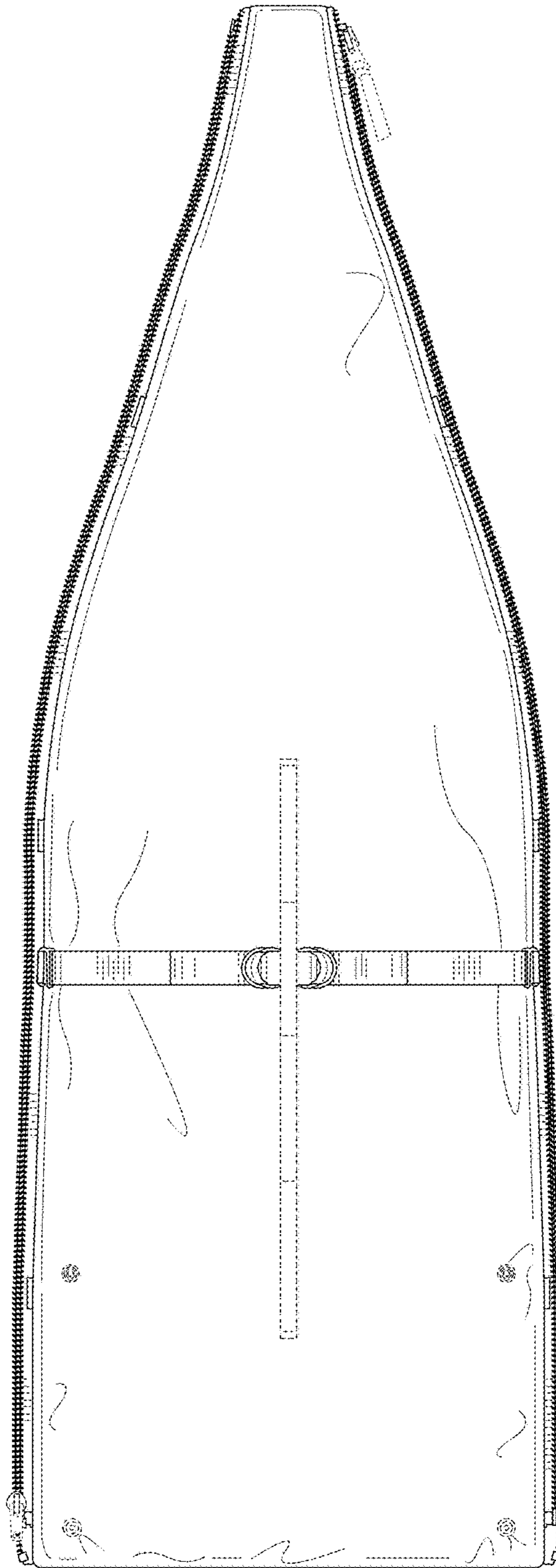

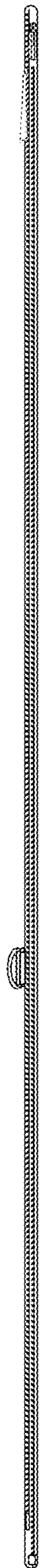

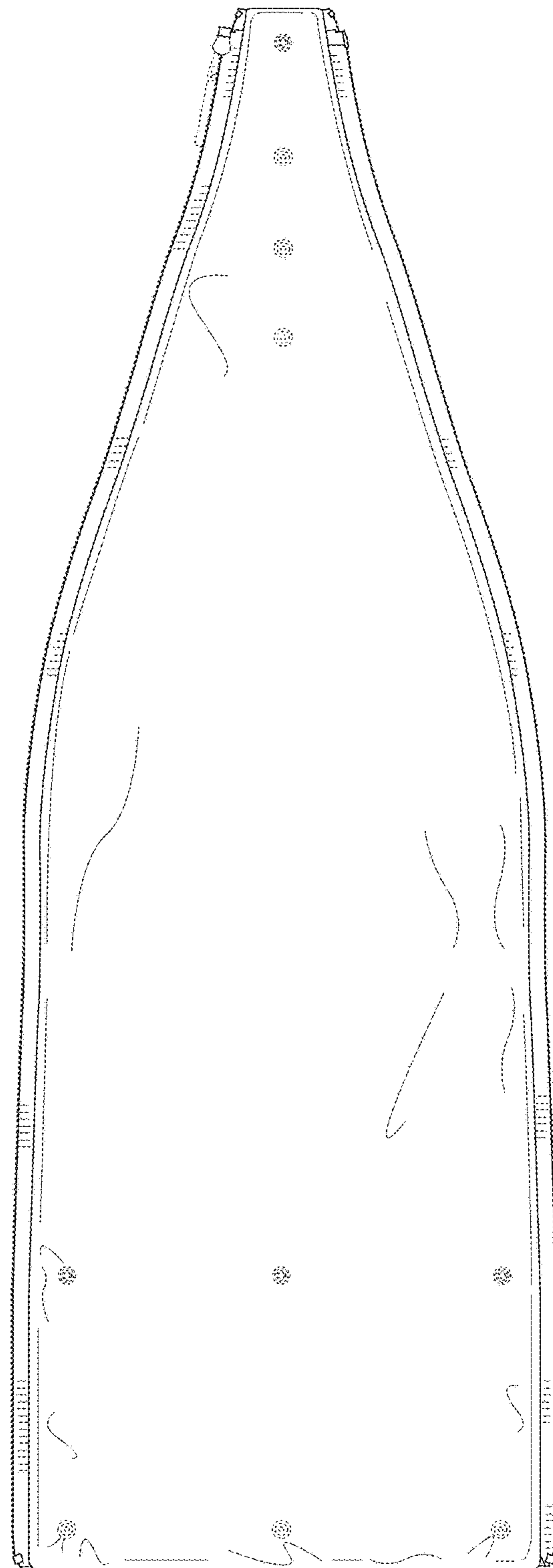

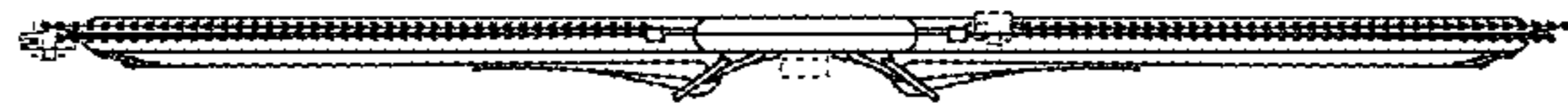

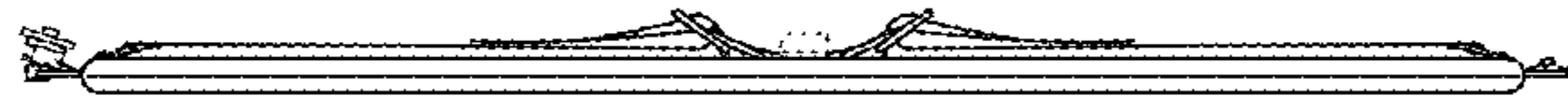

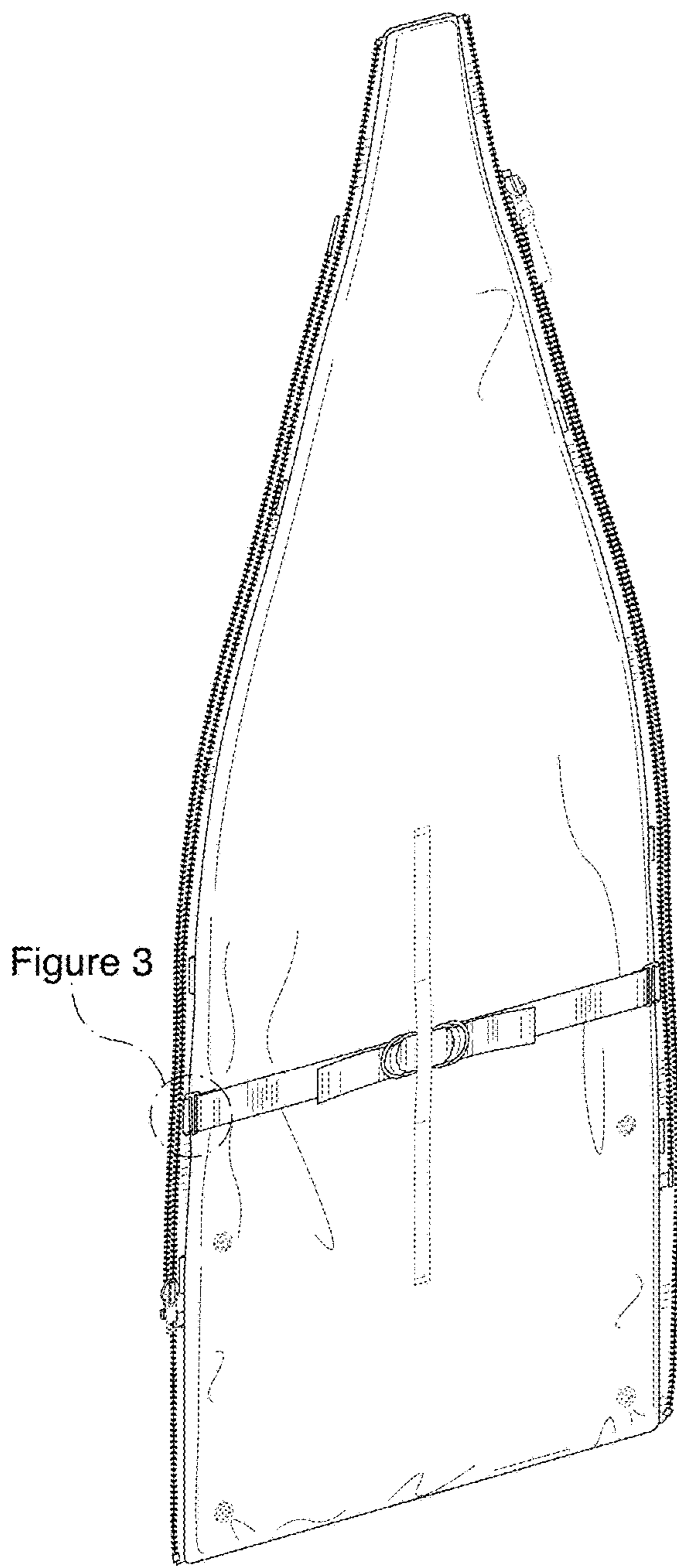

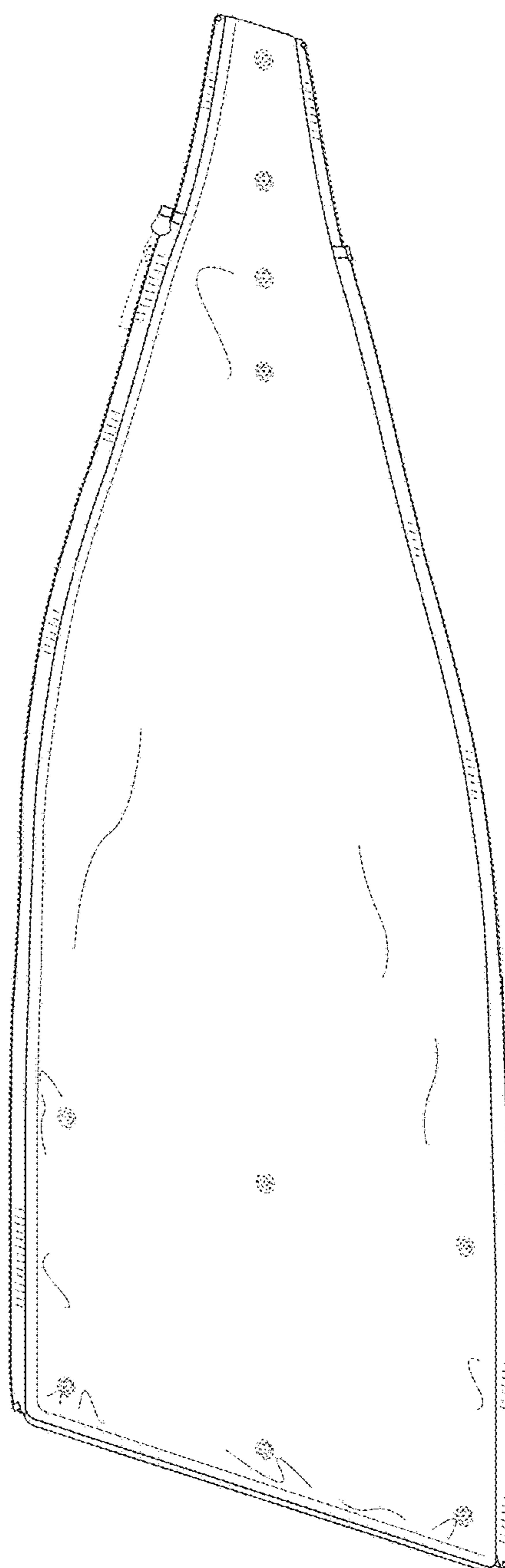

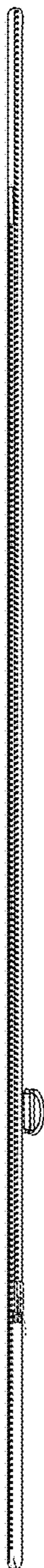

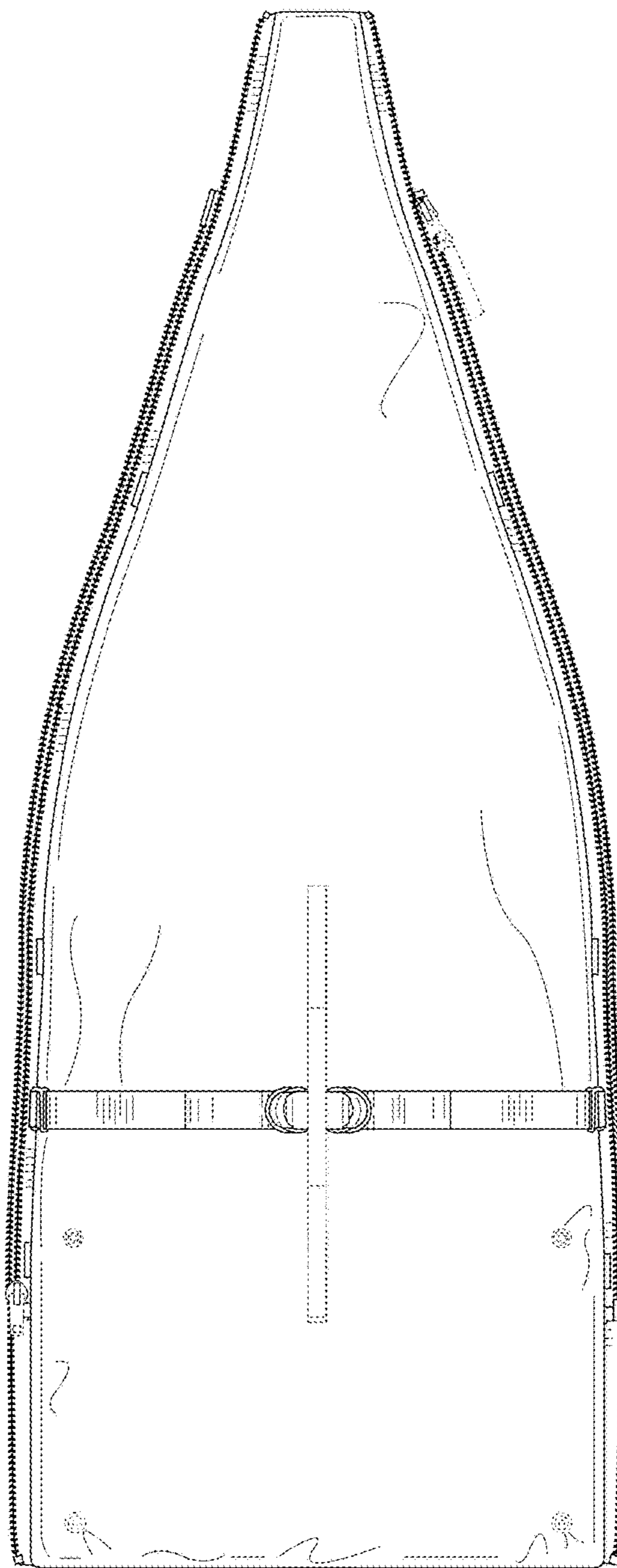

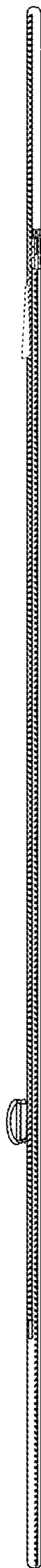

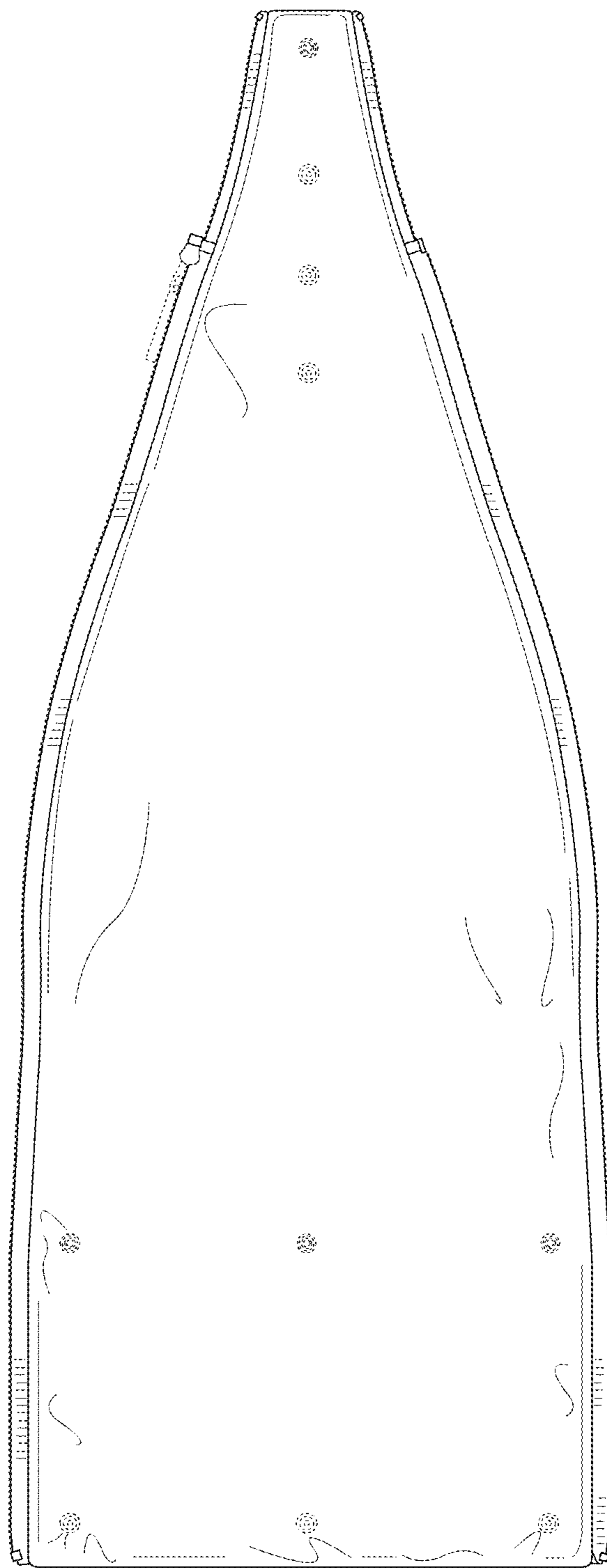

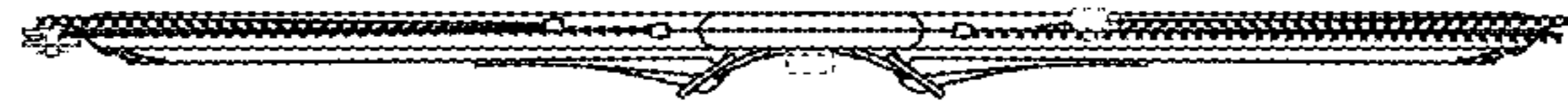

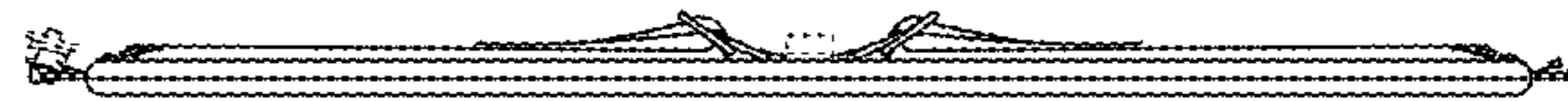
