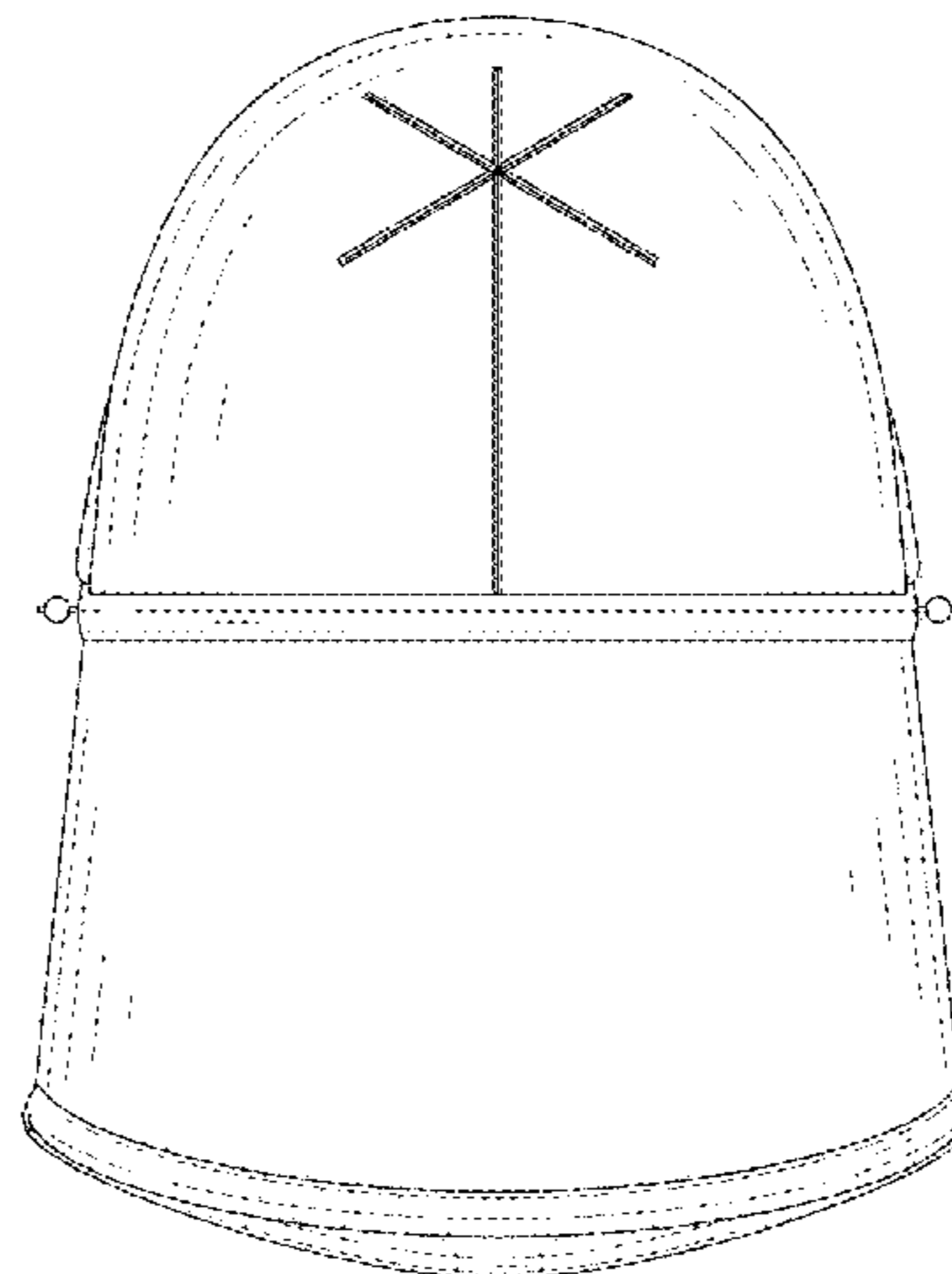
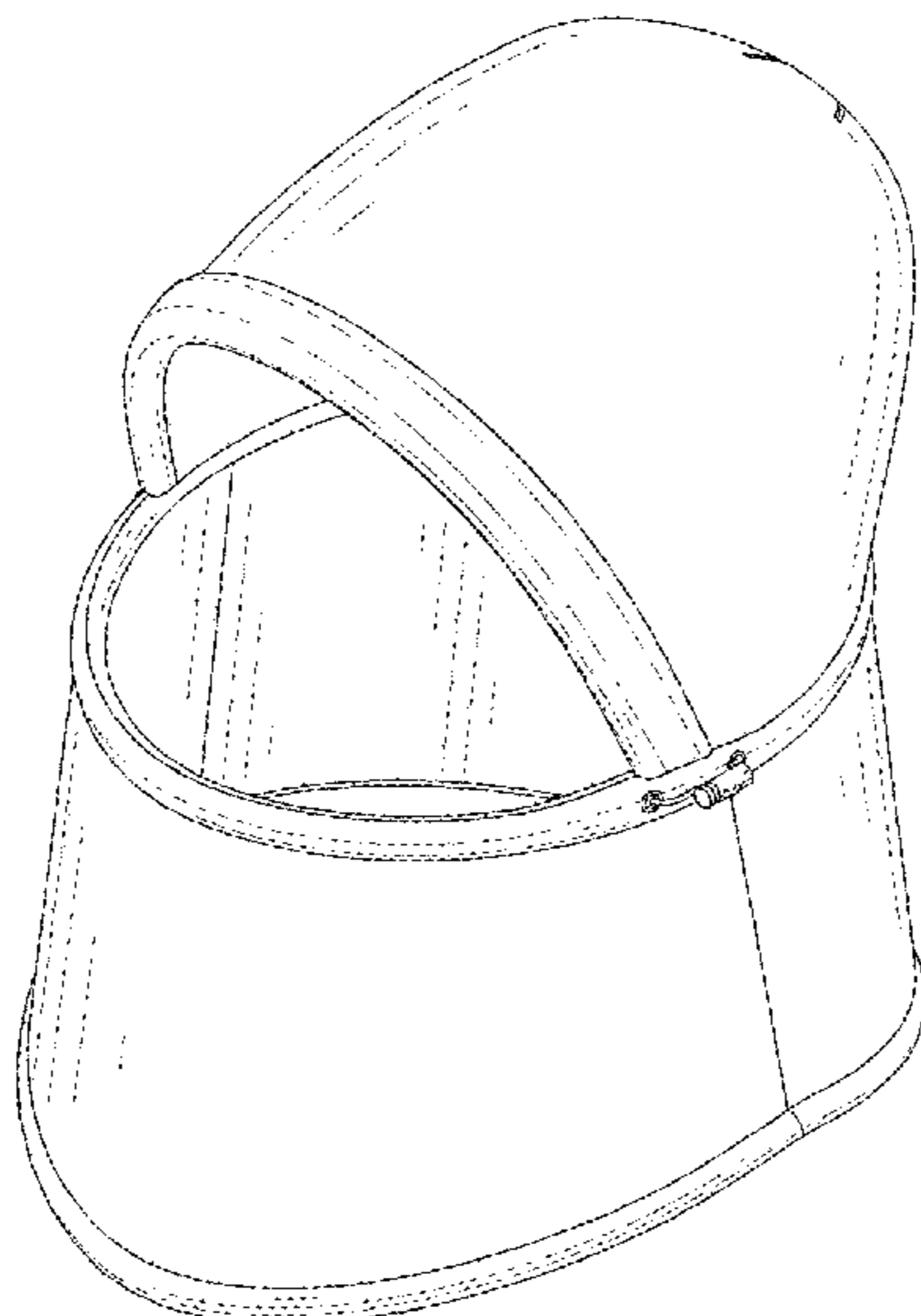
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a first perspective view of an embodiment of a balaclava showing the claimed new design;

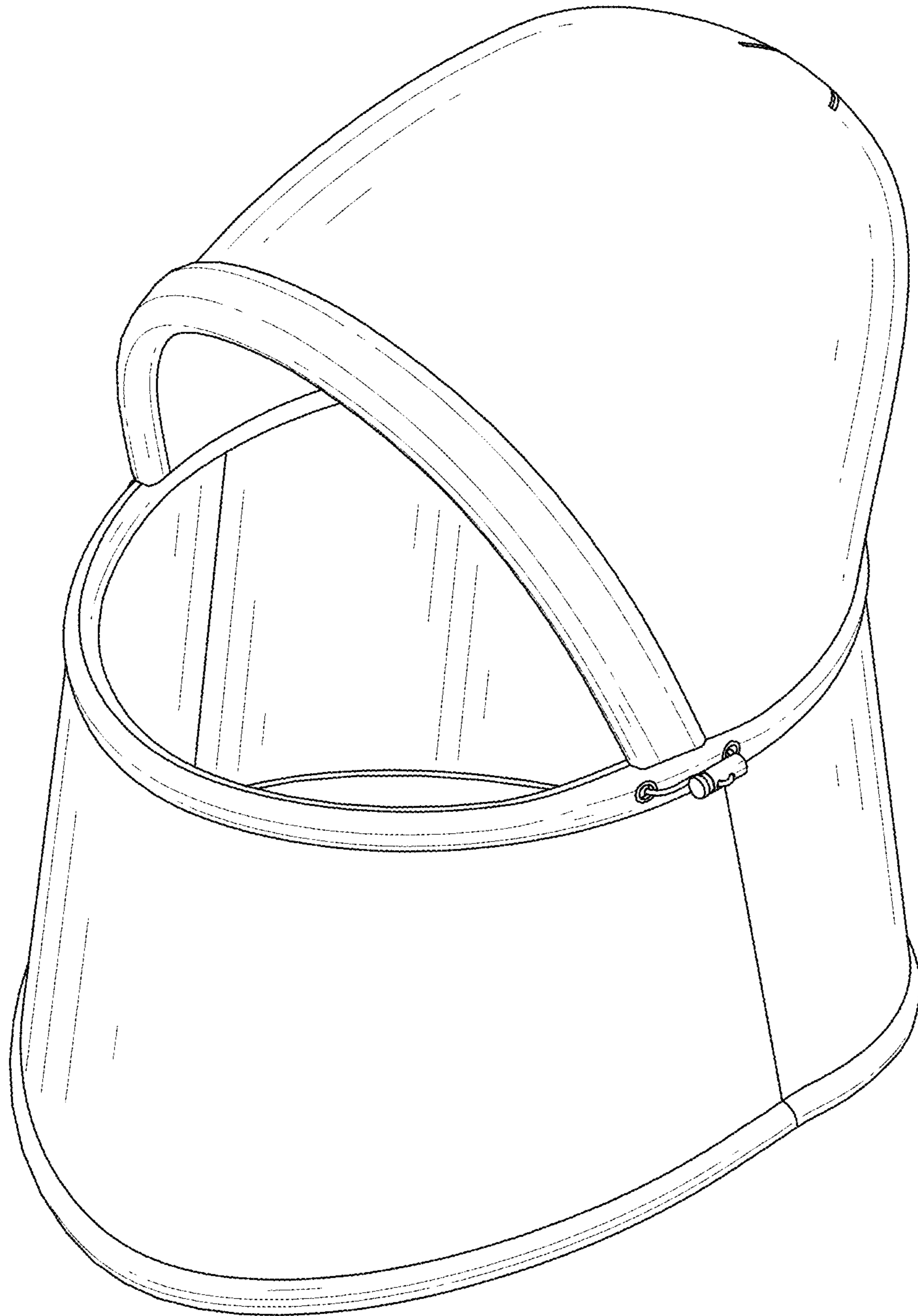

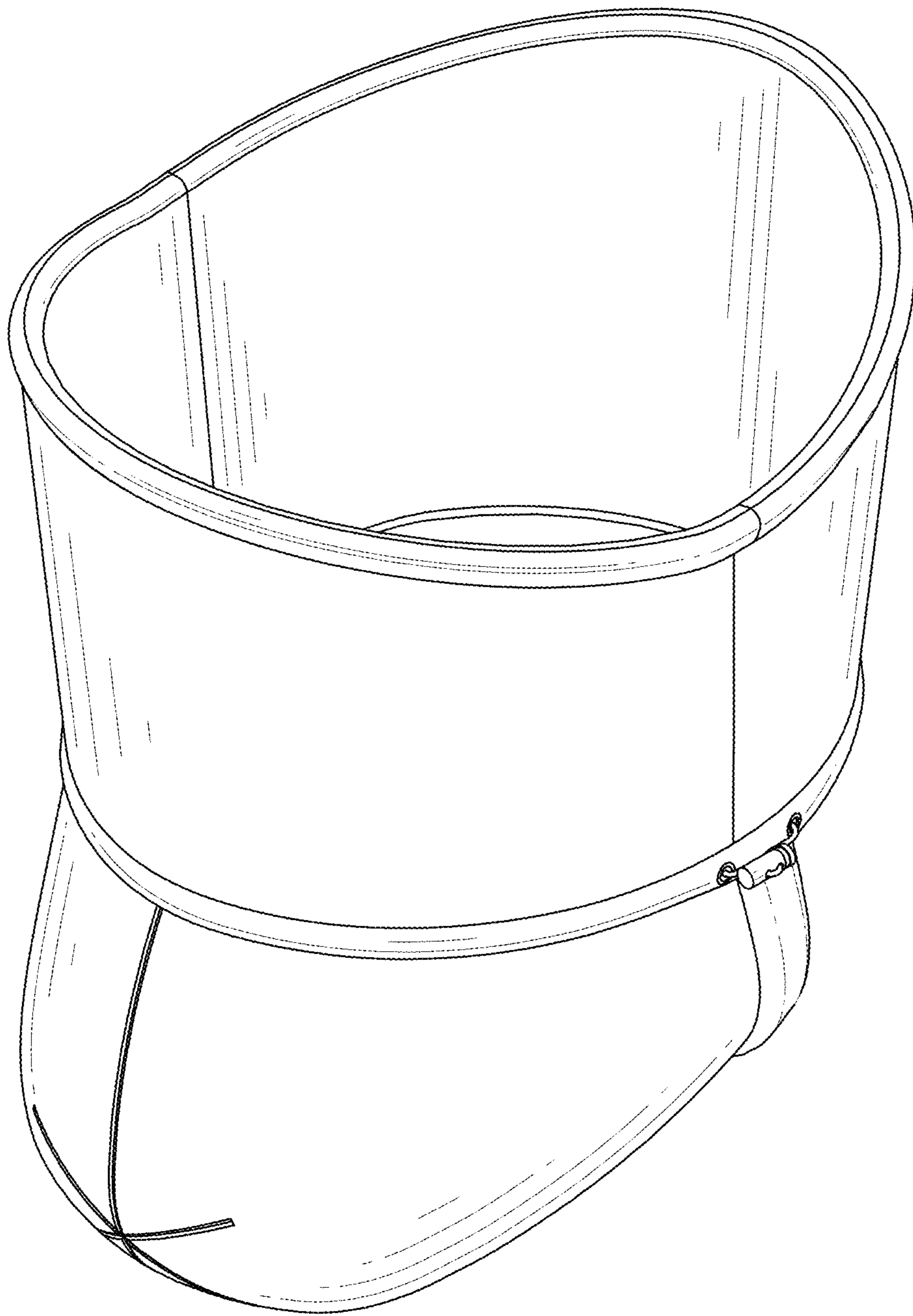

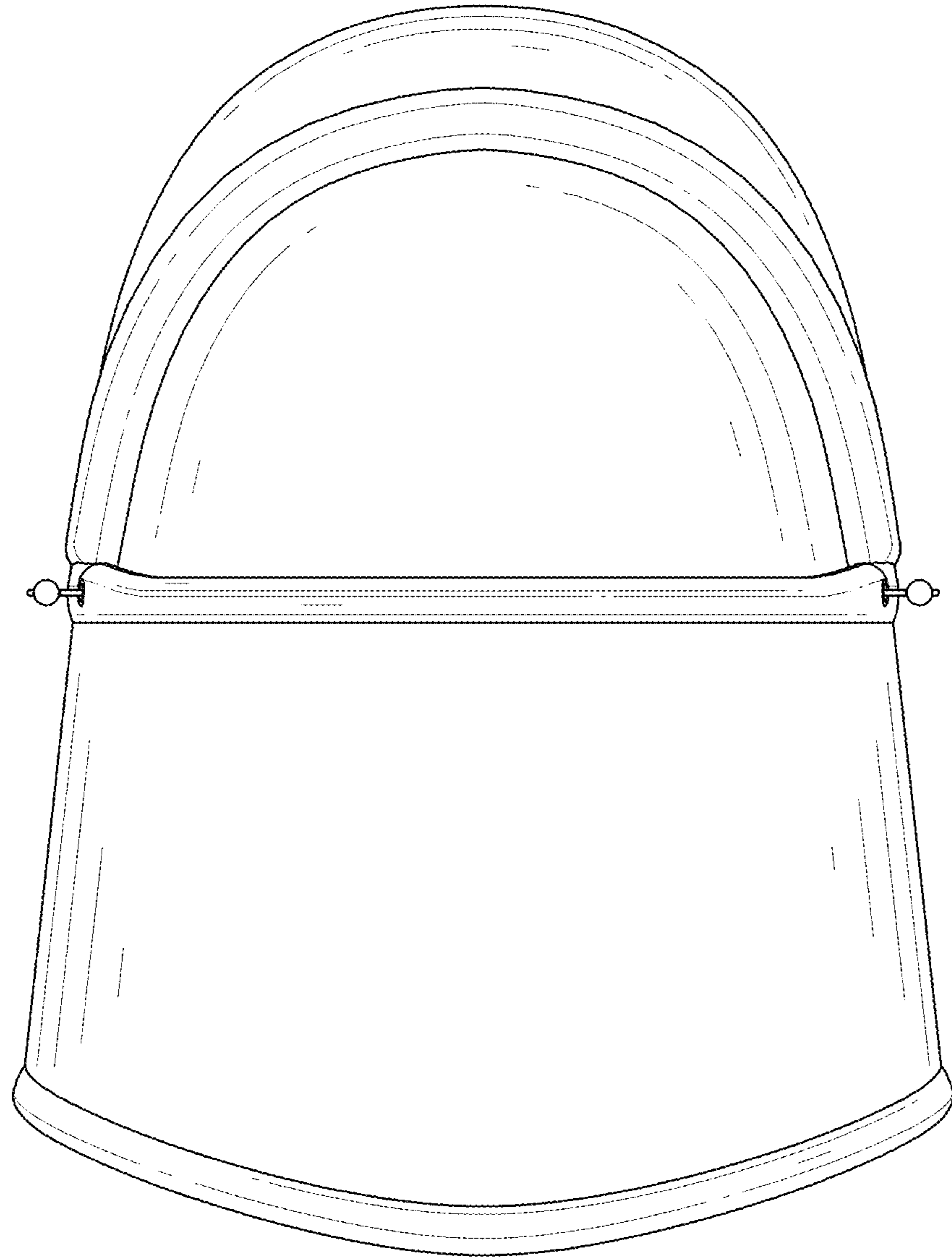

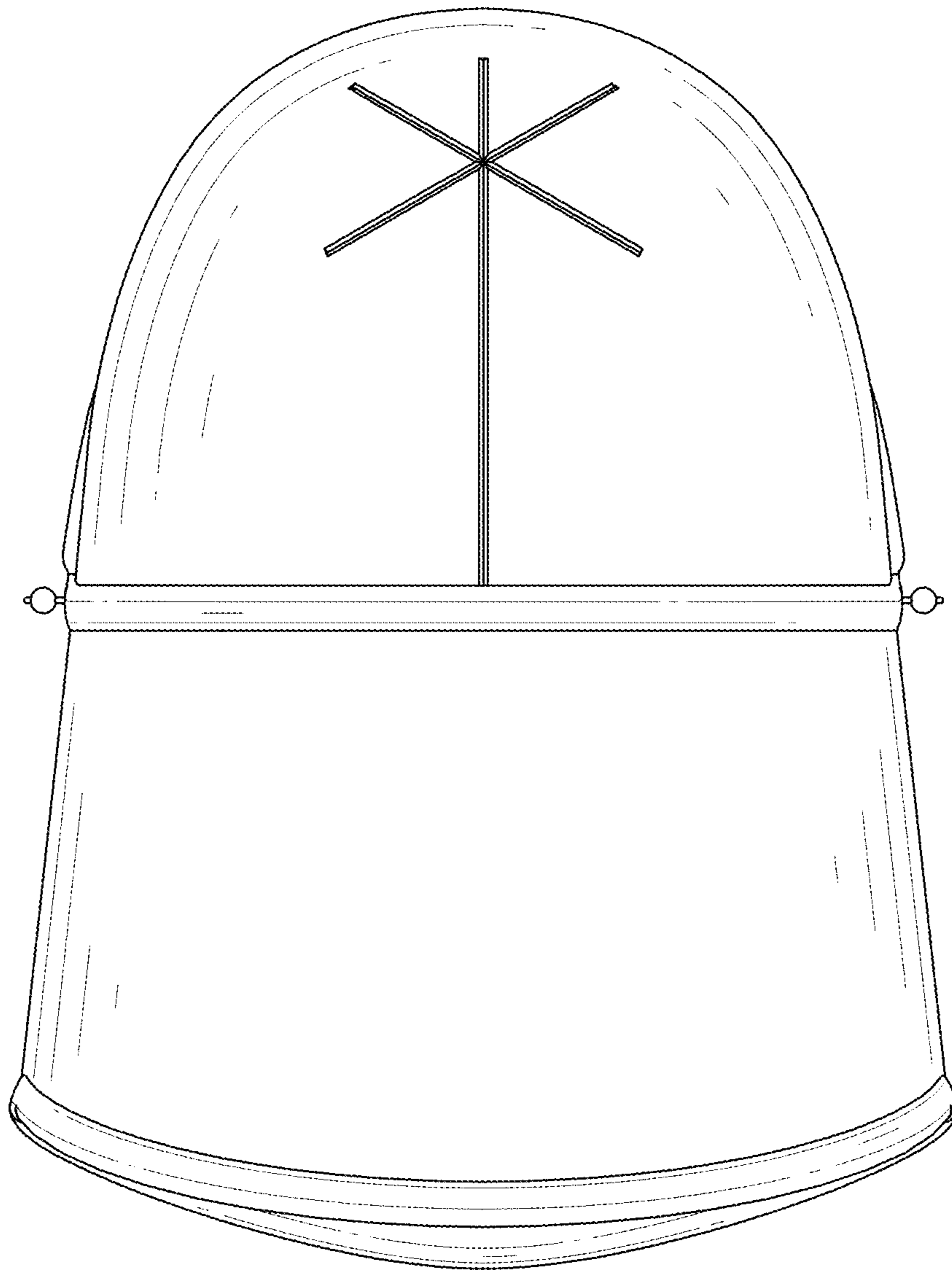

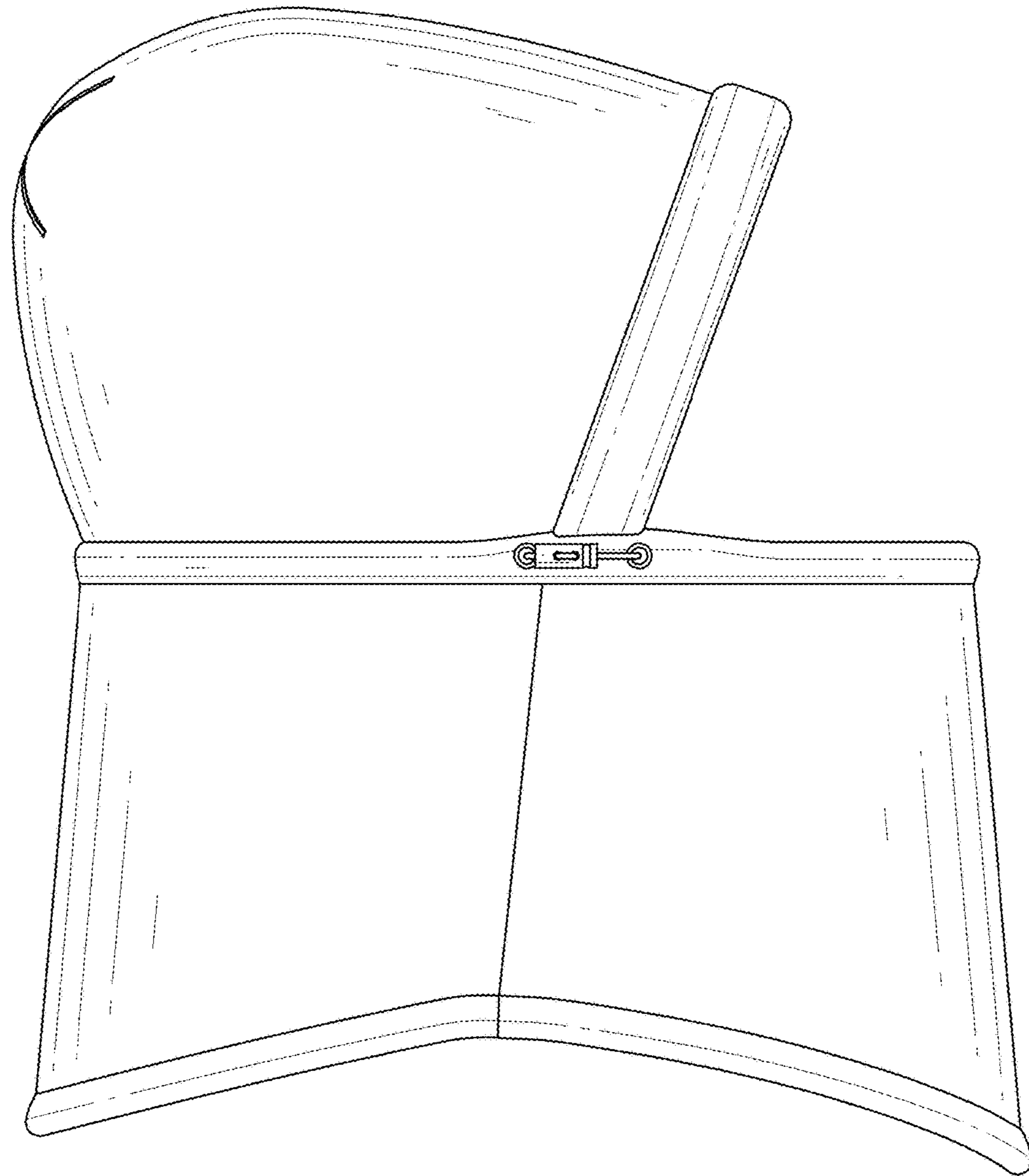

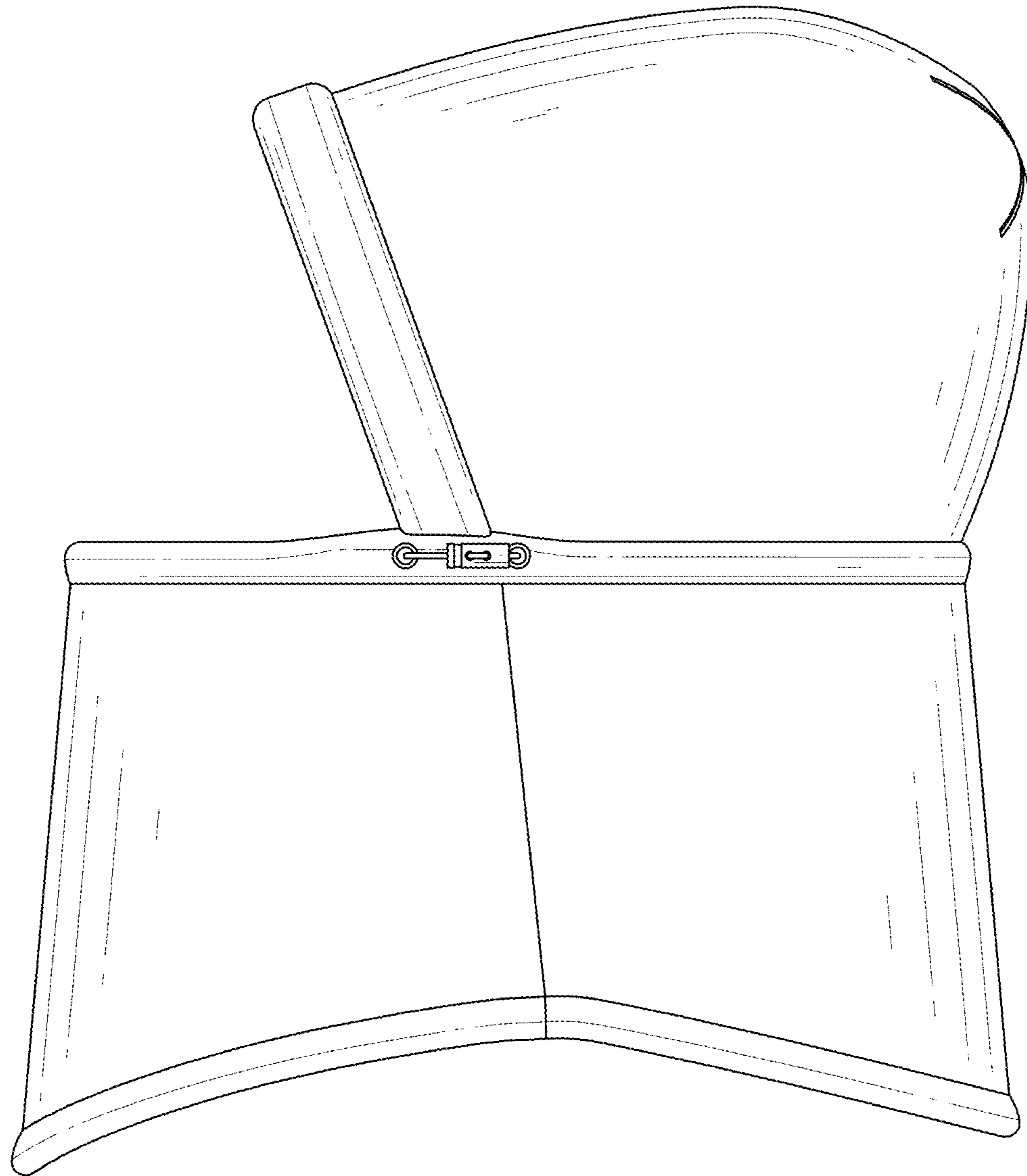

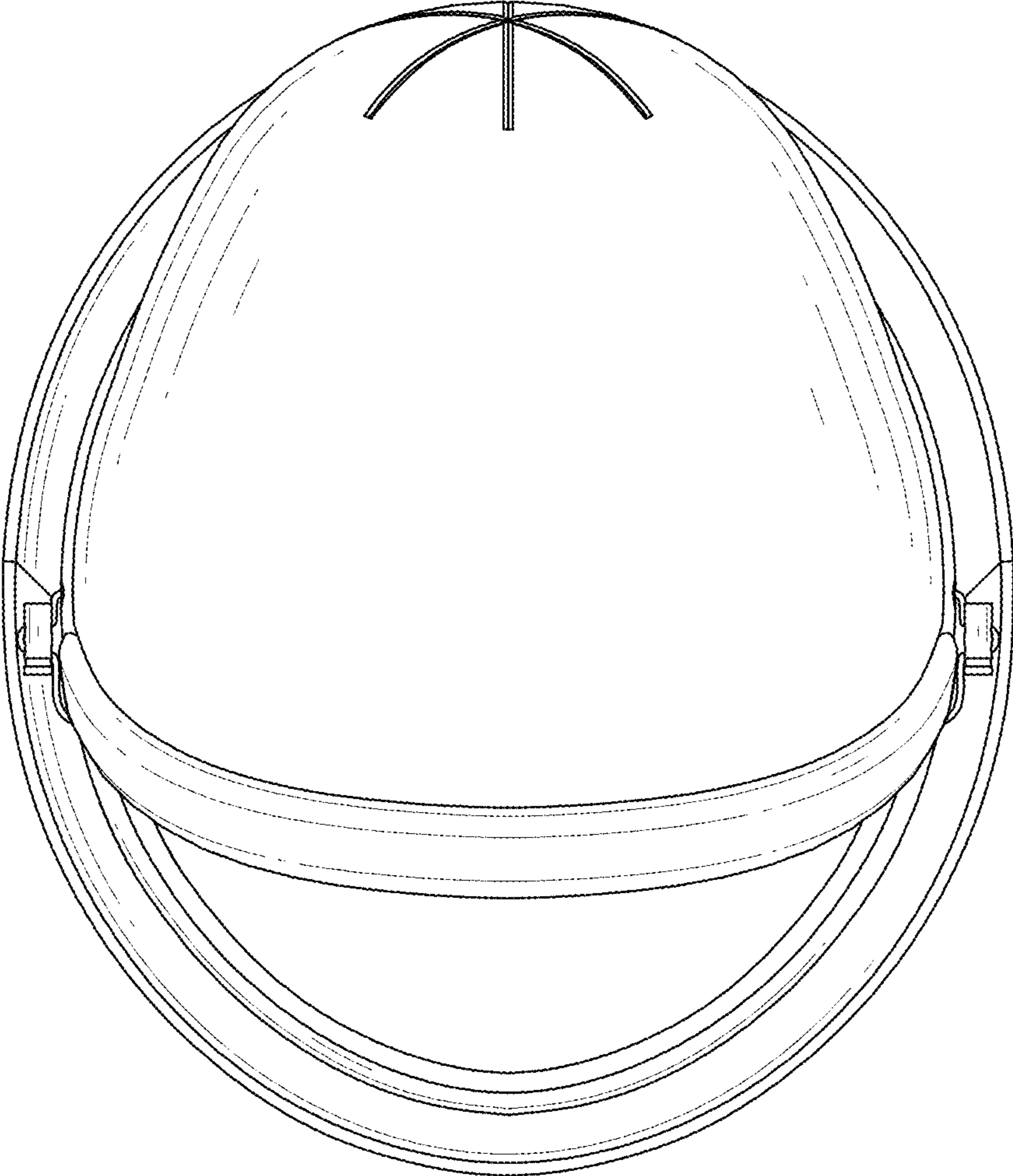

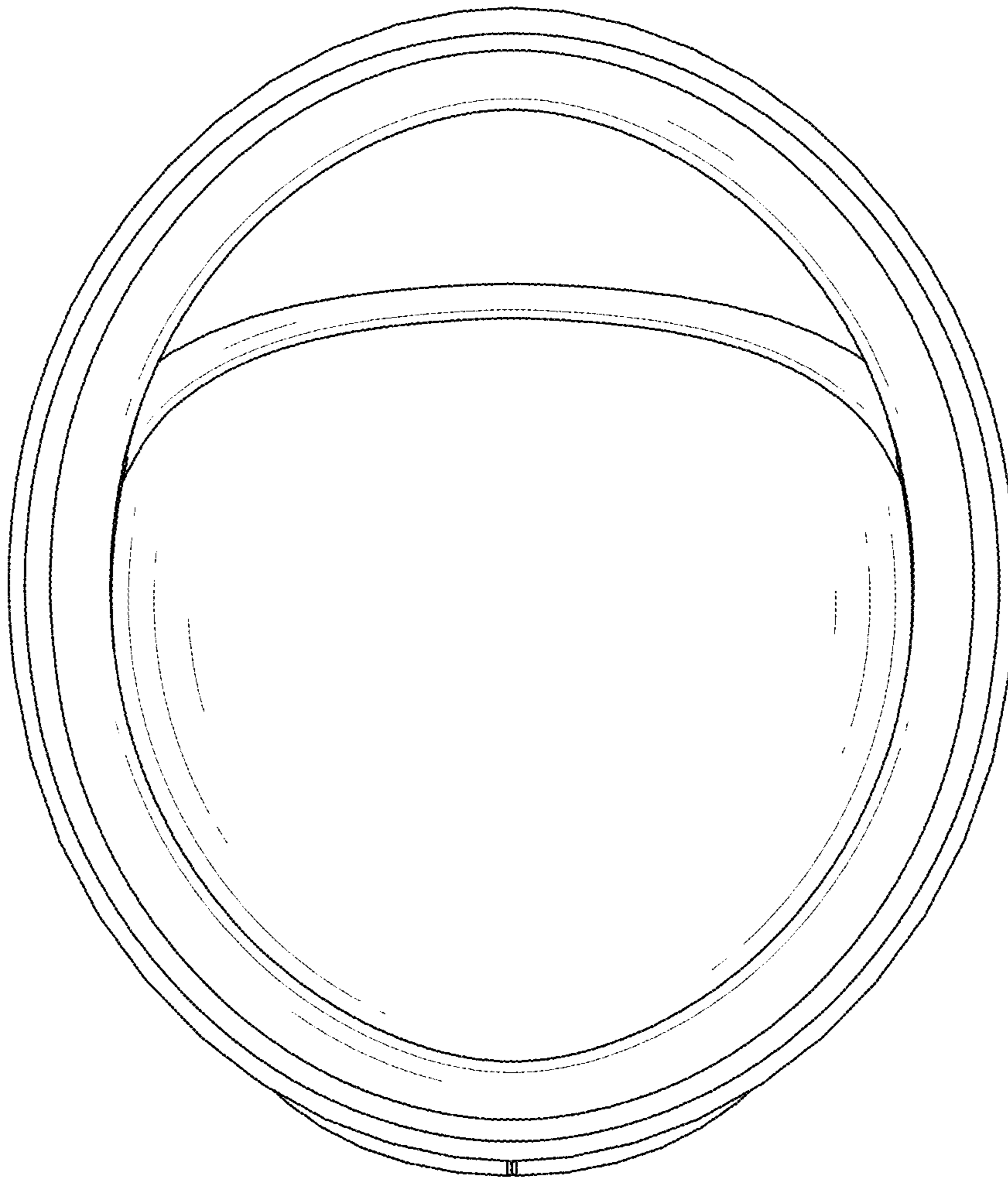

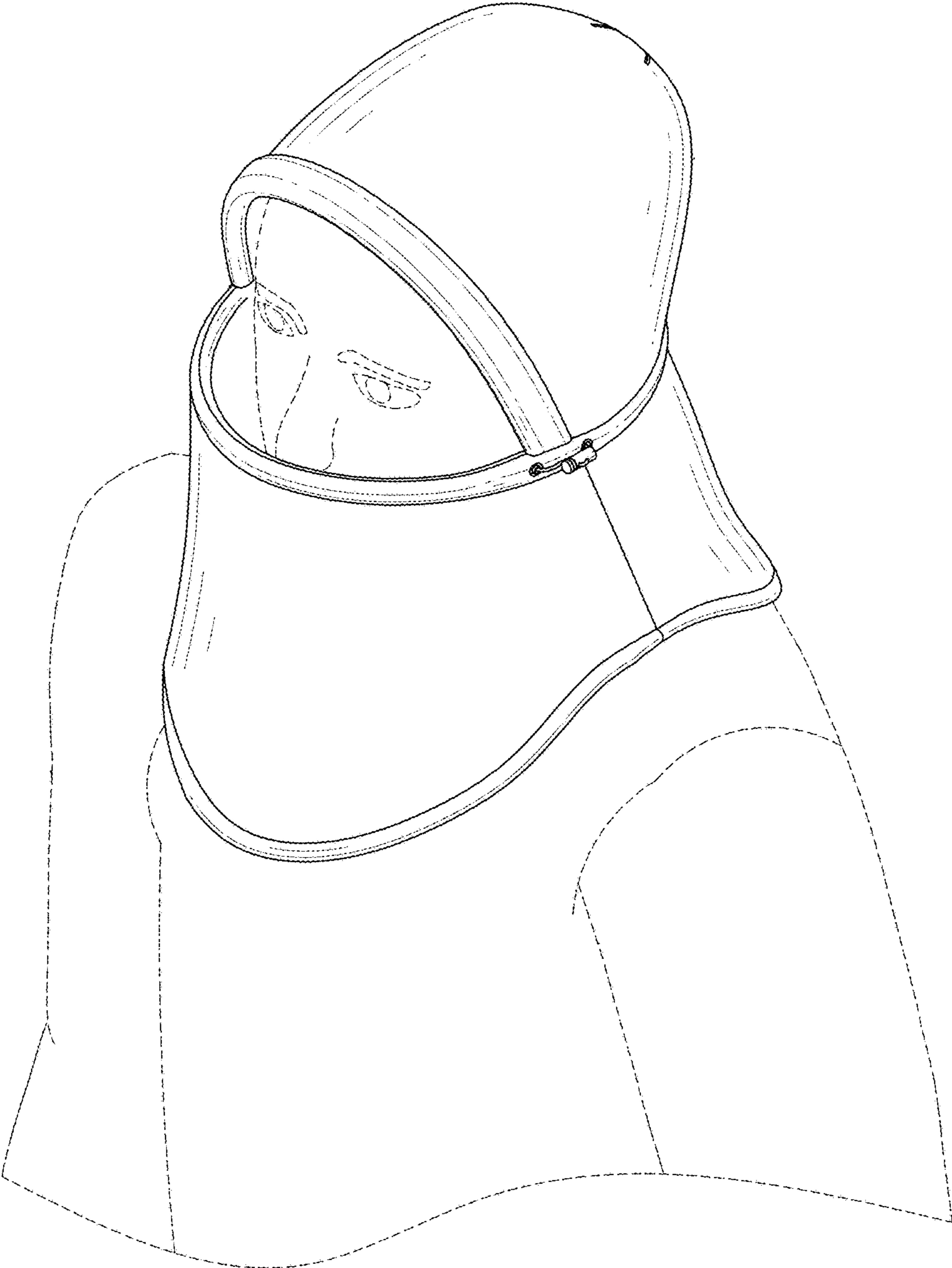
