DESCRIPTION

FIG. 1 is a back perspective view of an umbrella handle showing my new design;

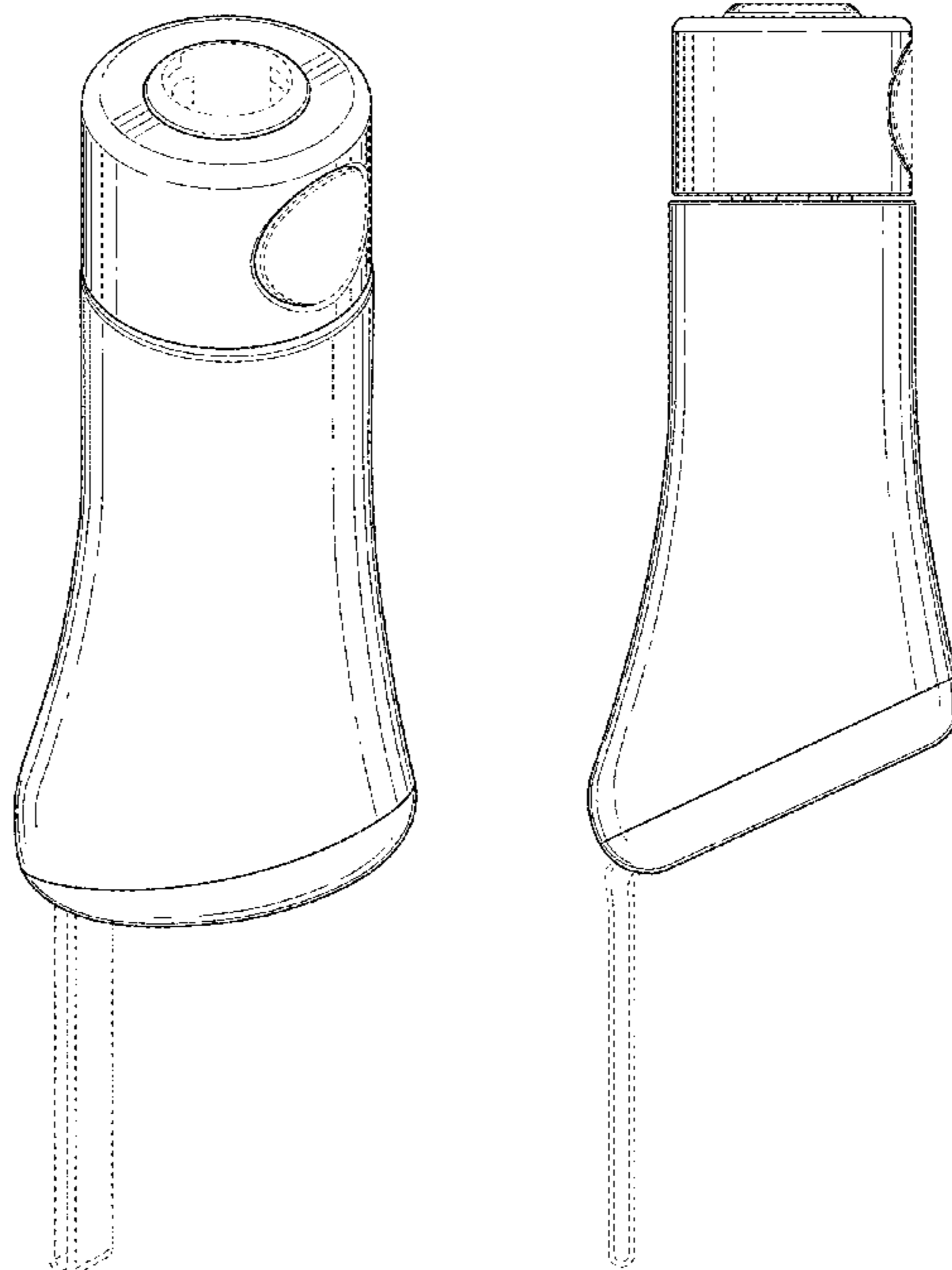

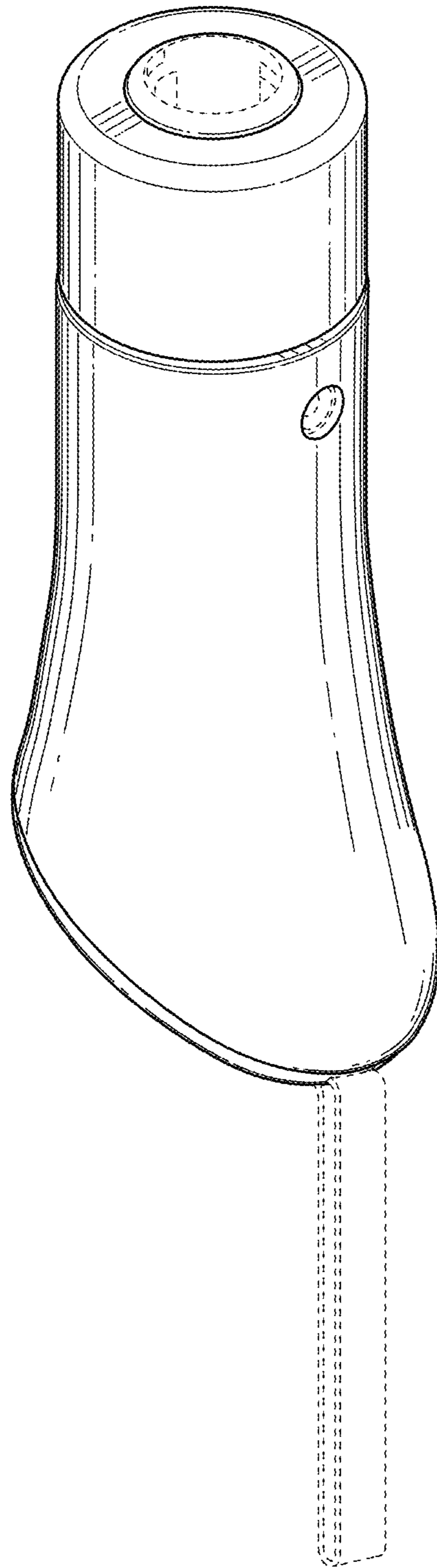

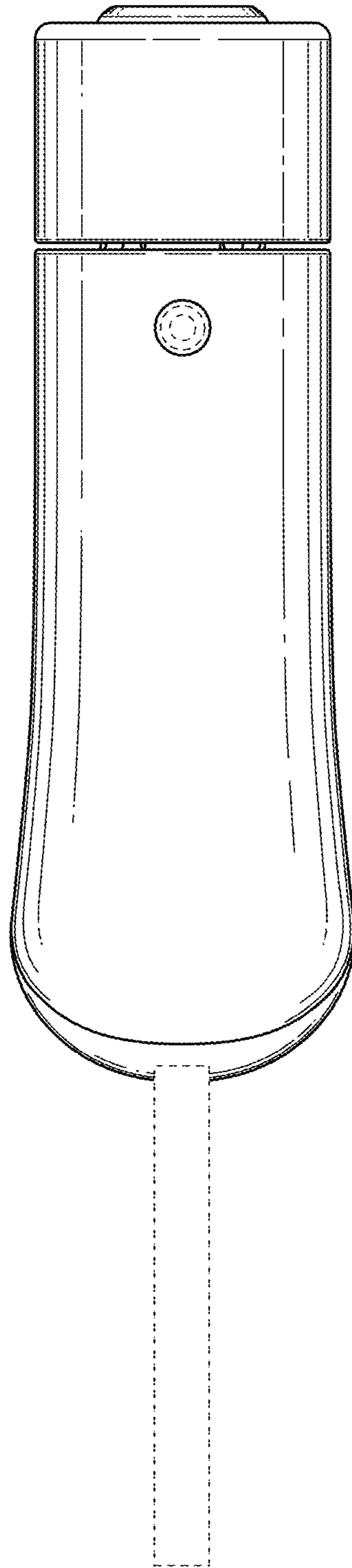

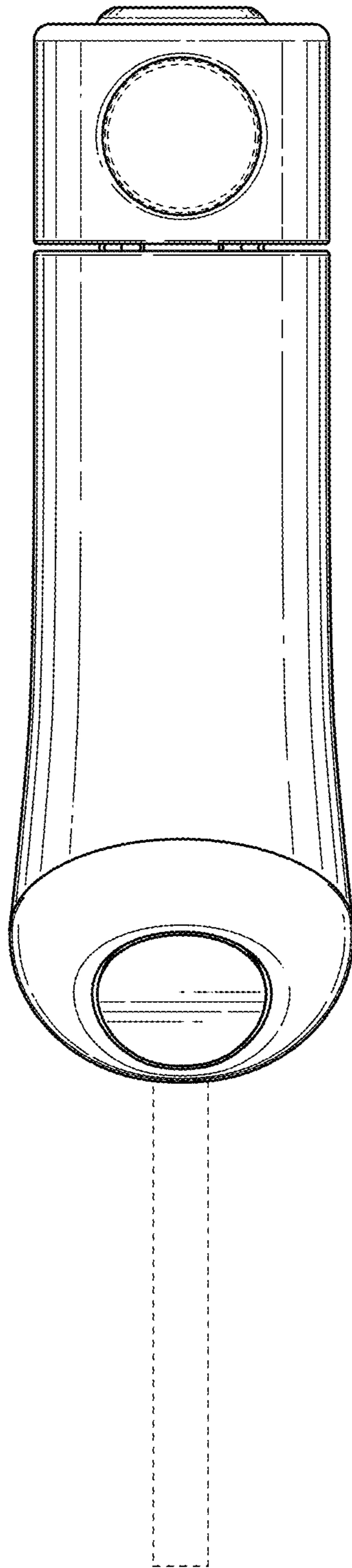

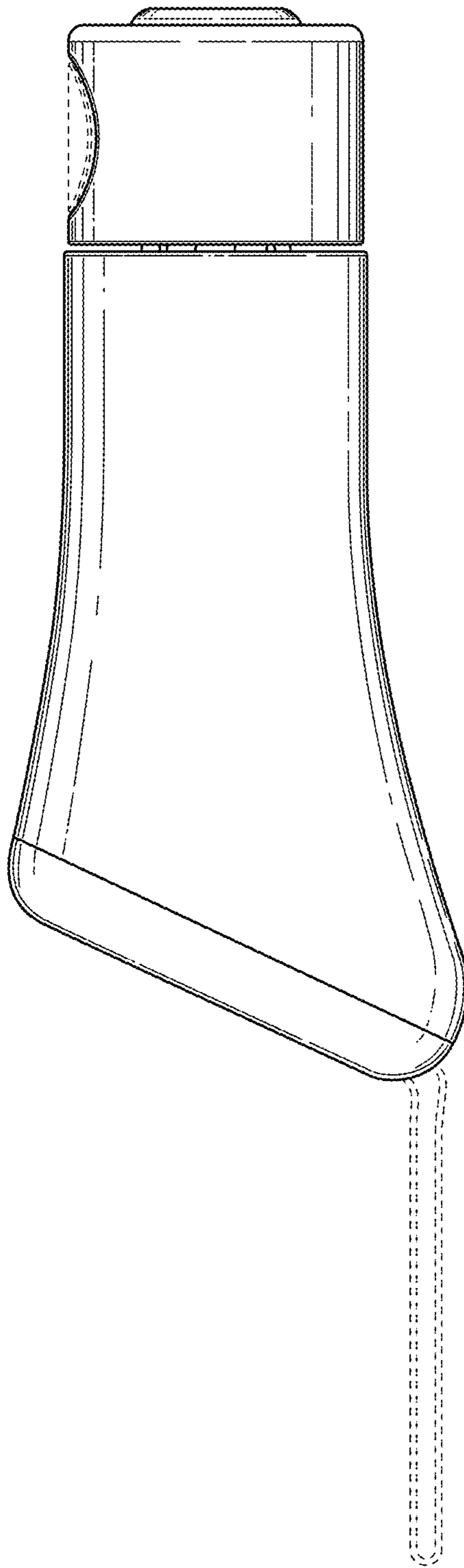

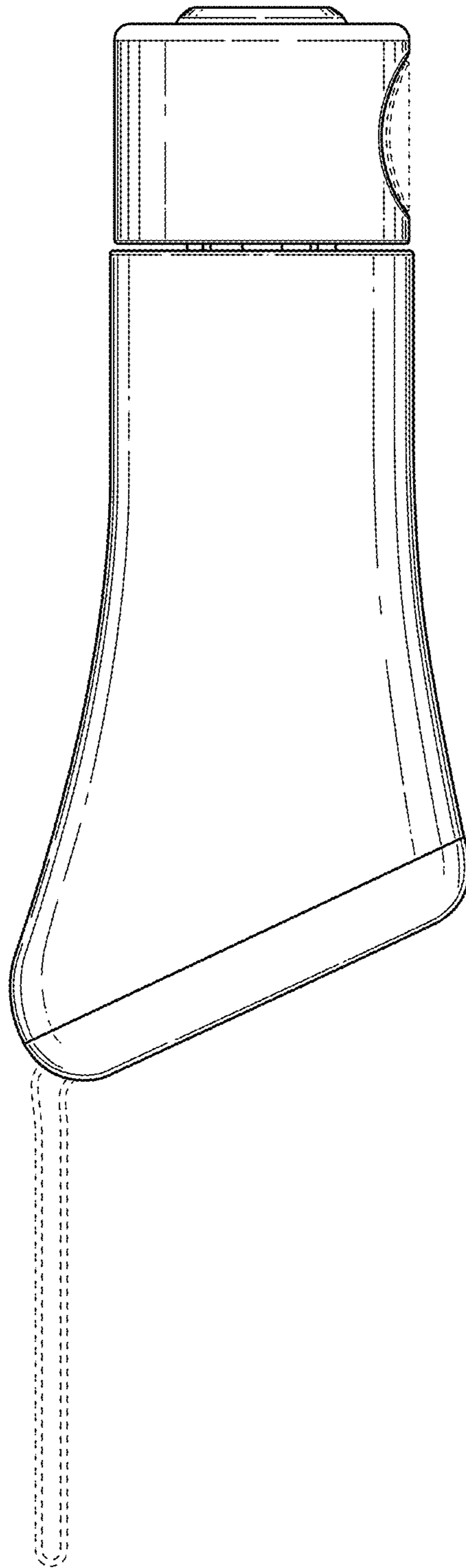

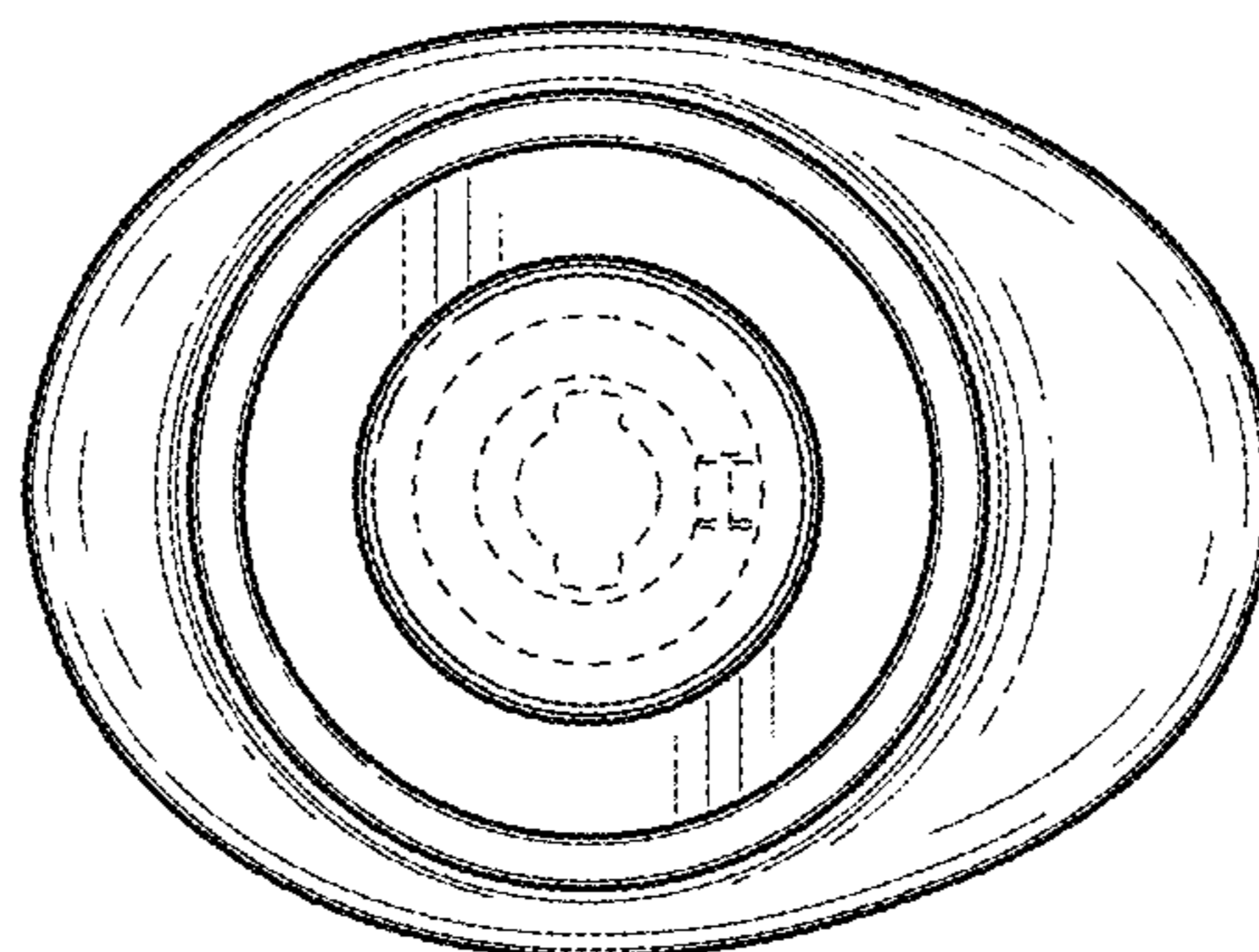

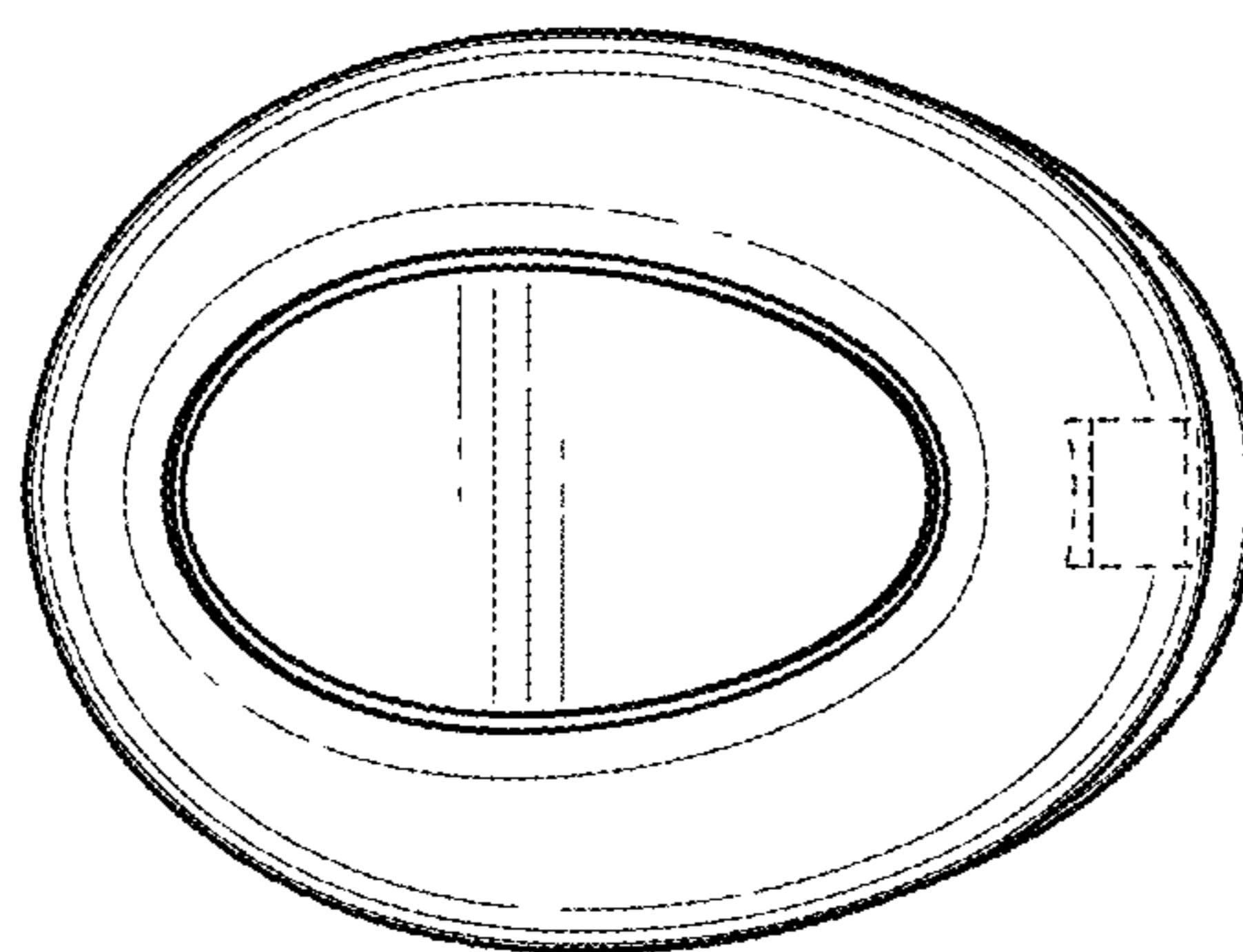
