DESCRIPTION

FIG. 1 is a top, front, left perspective view of a handbag showing my new design;

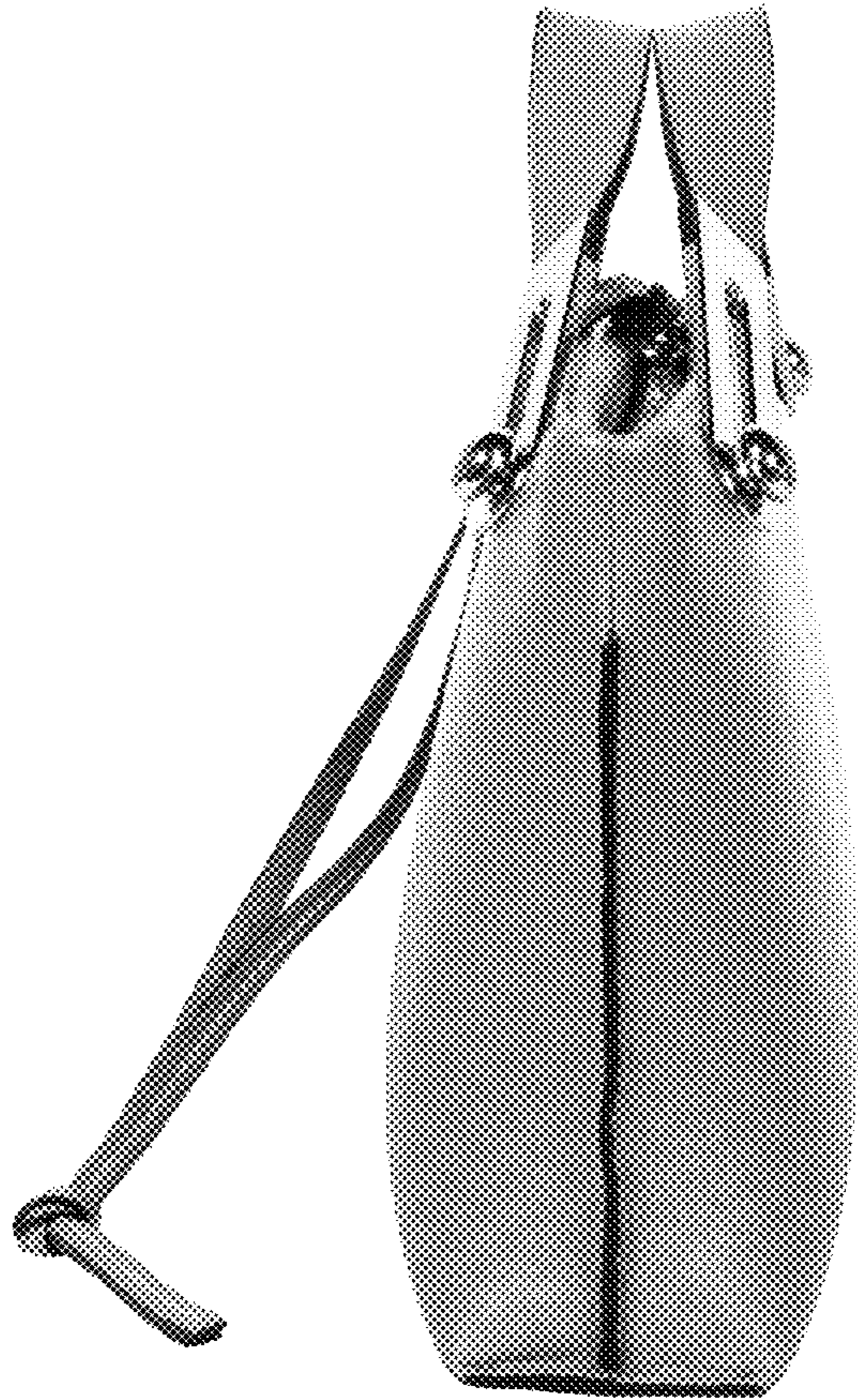

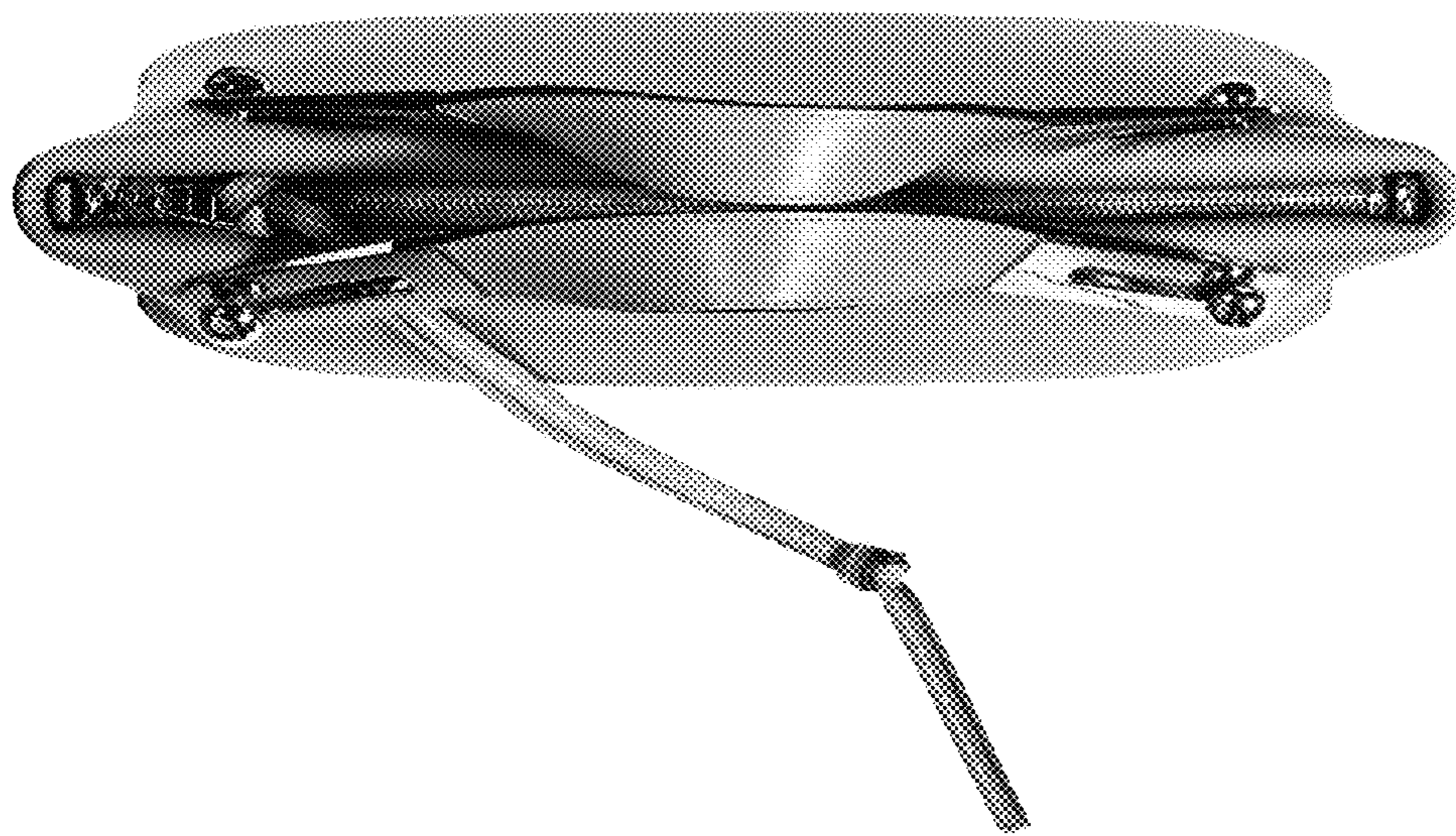

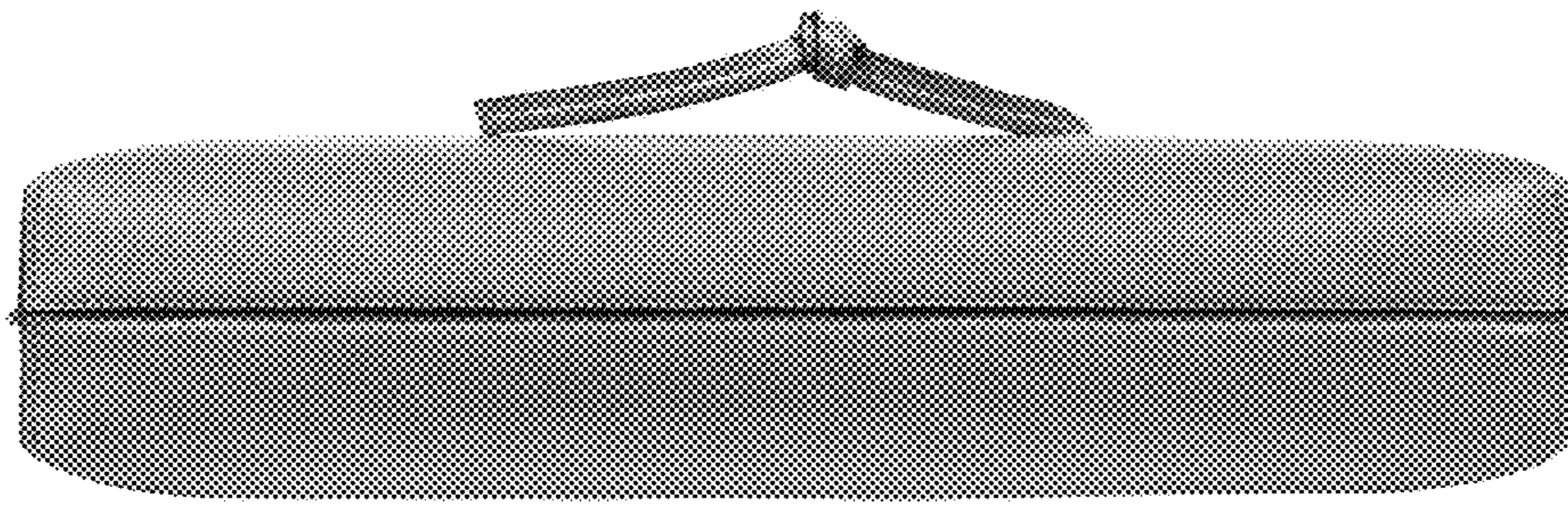
