DESCRIPTION

FIG. 1 is a top front oblique view of a bag showing my new design;

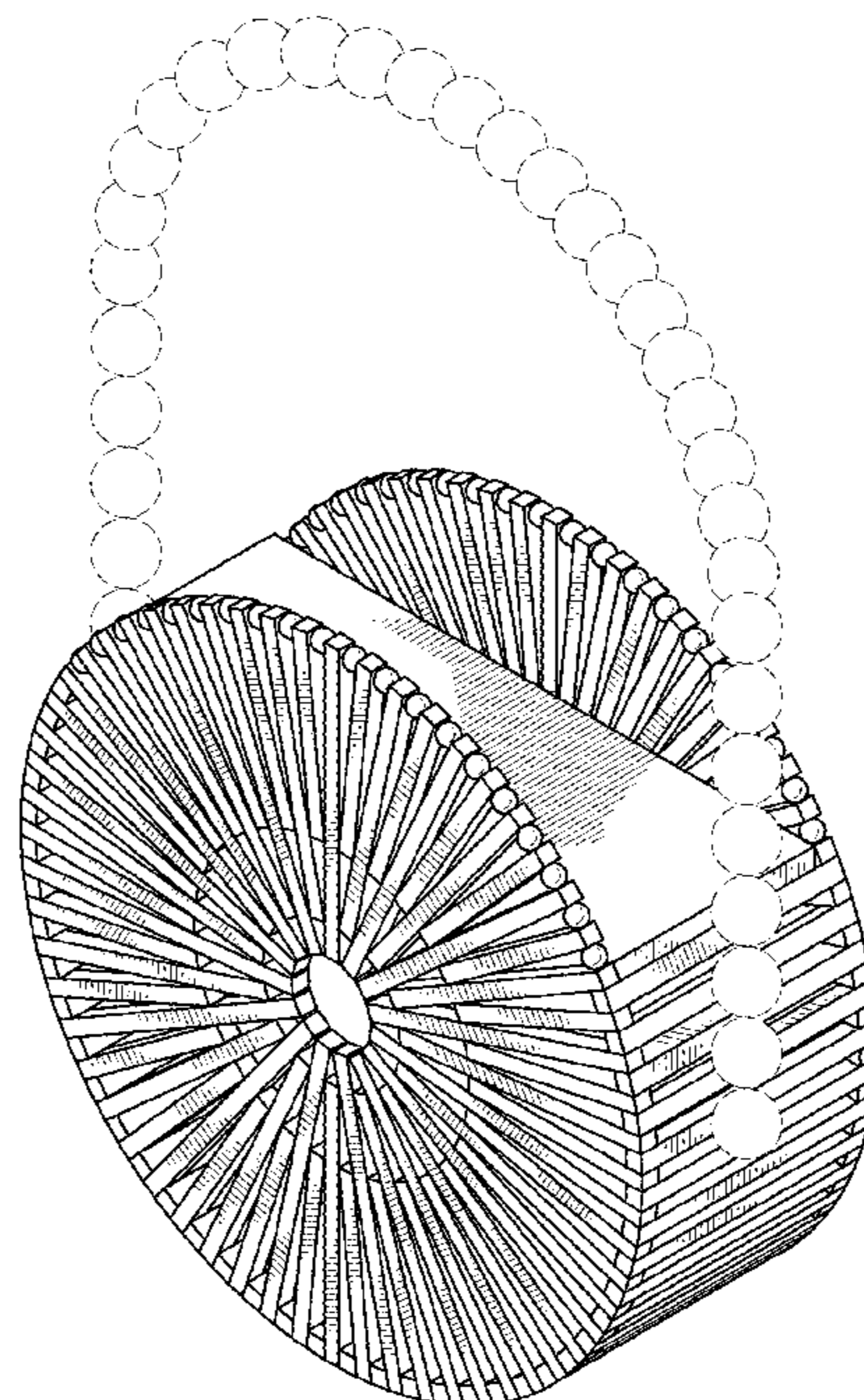

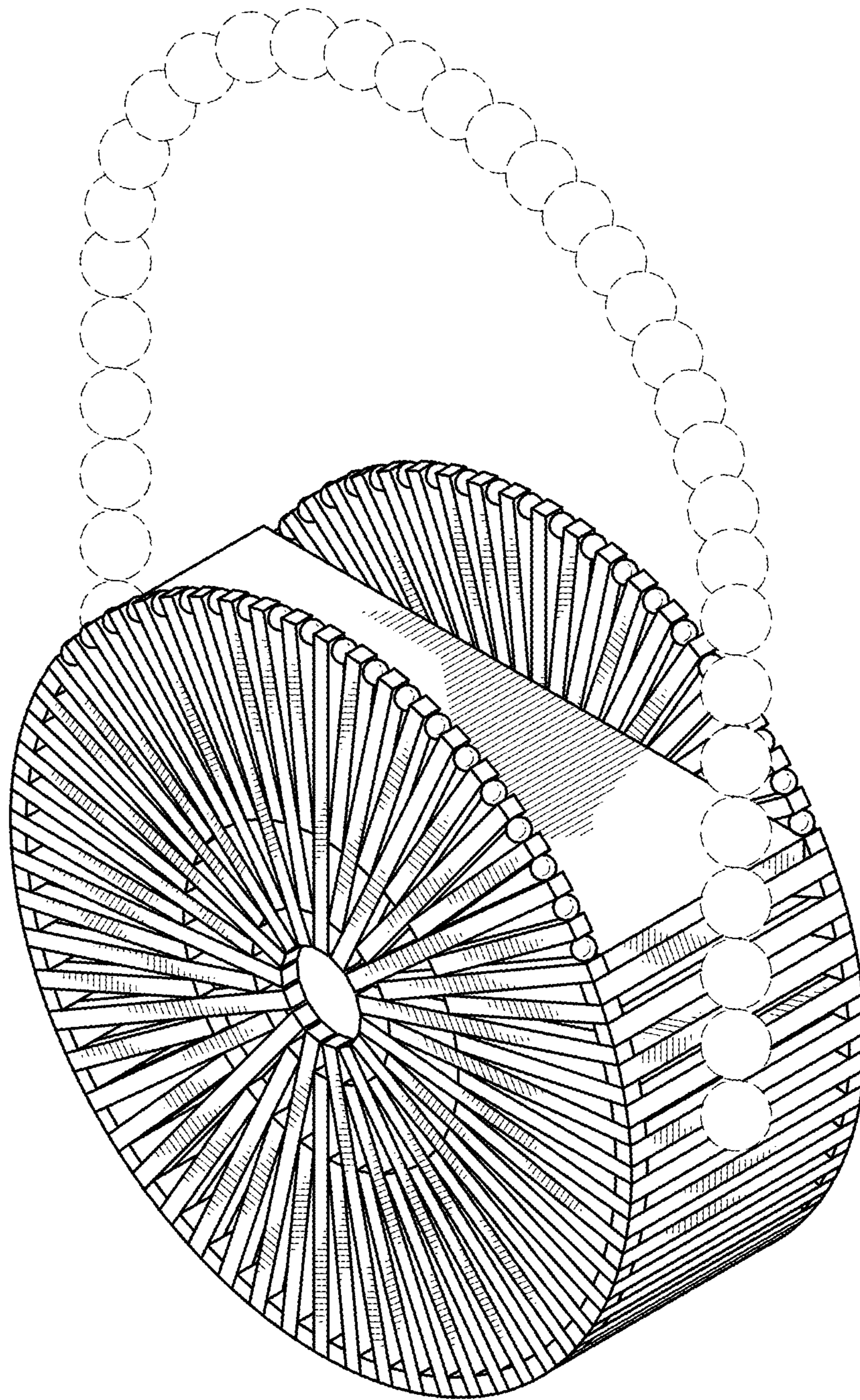

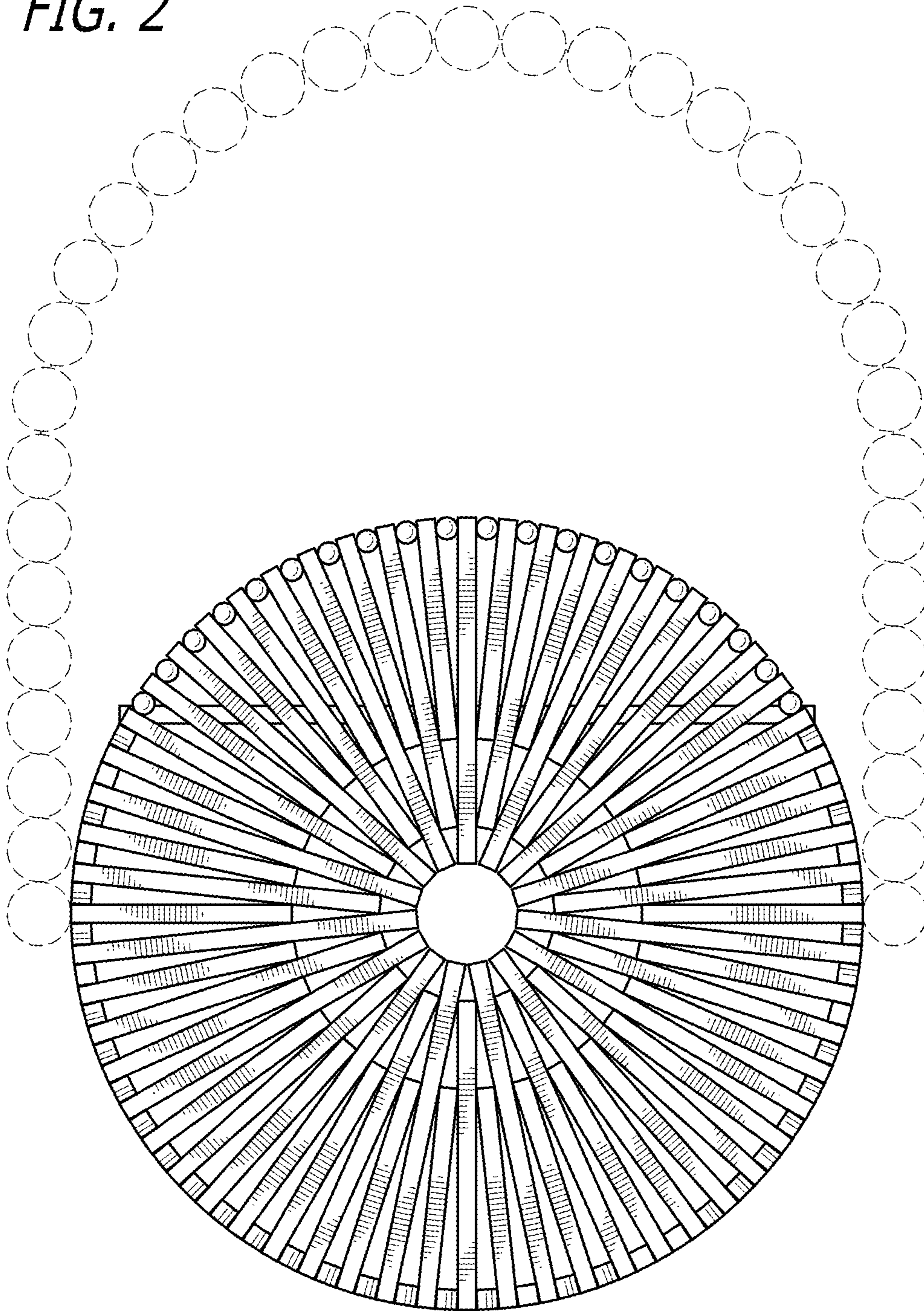
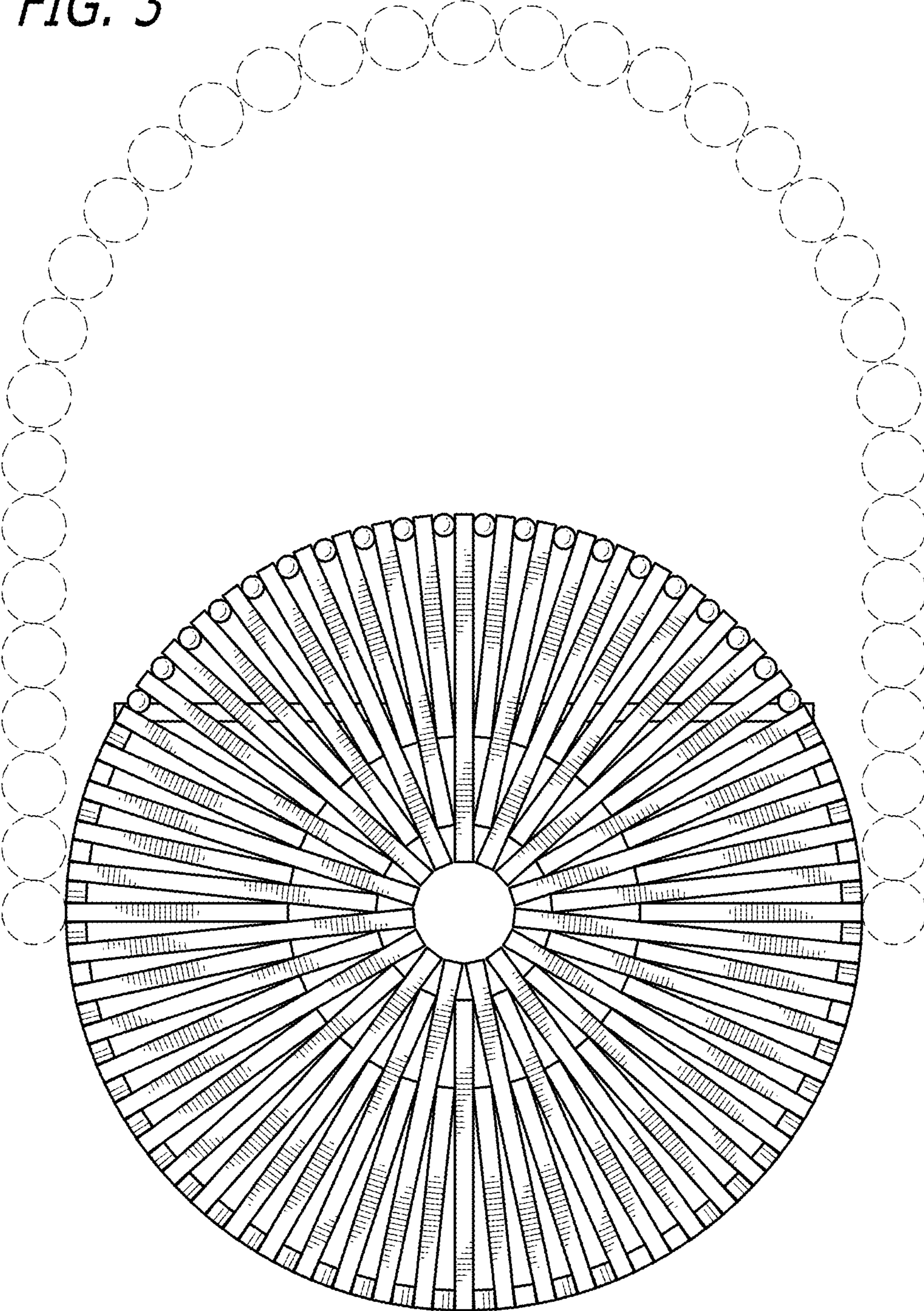

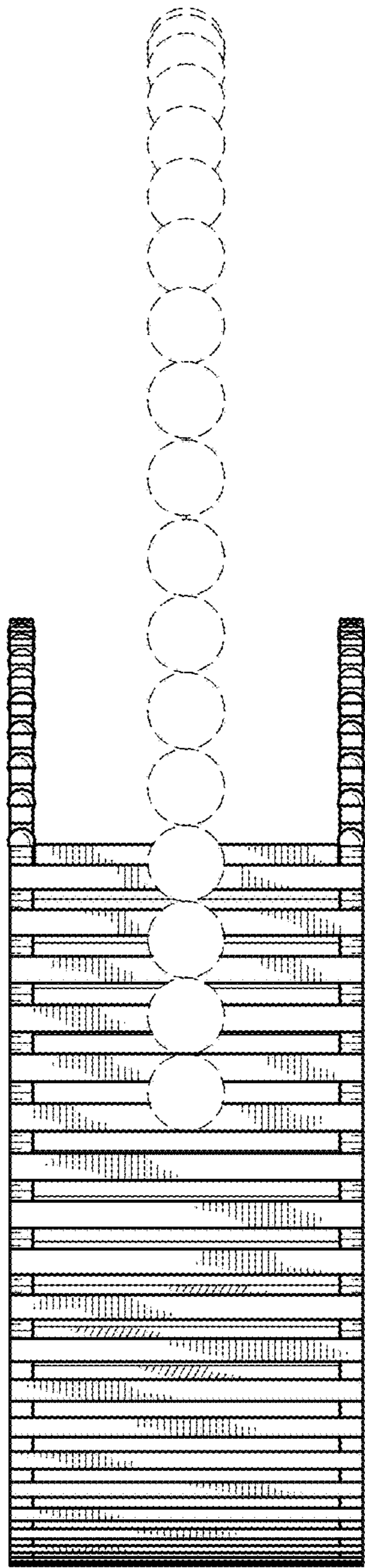

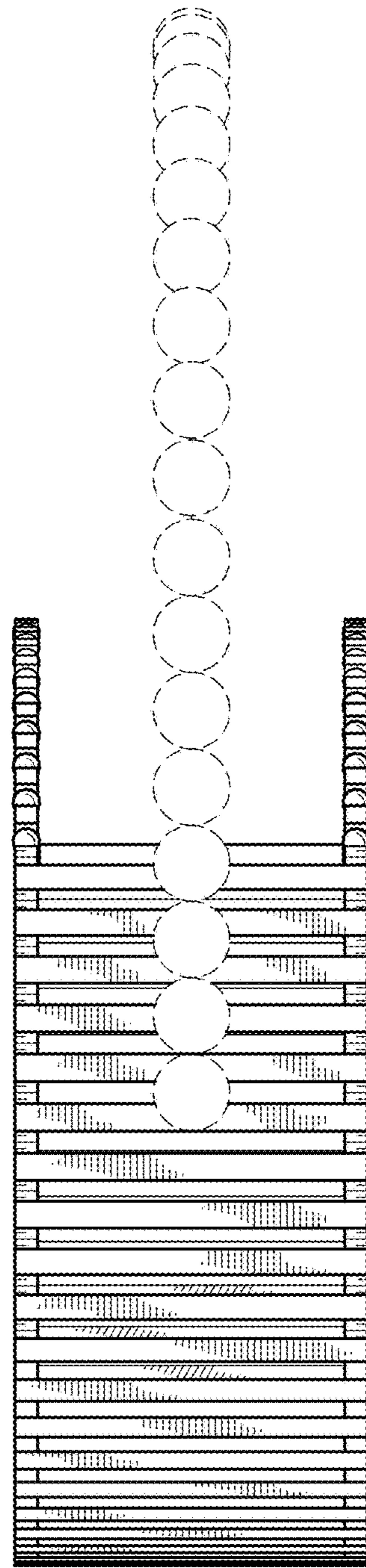

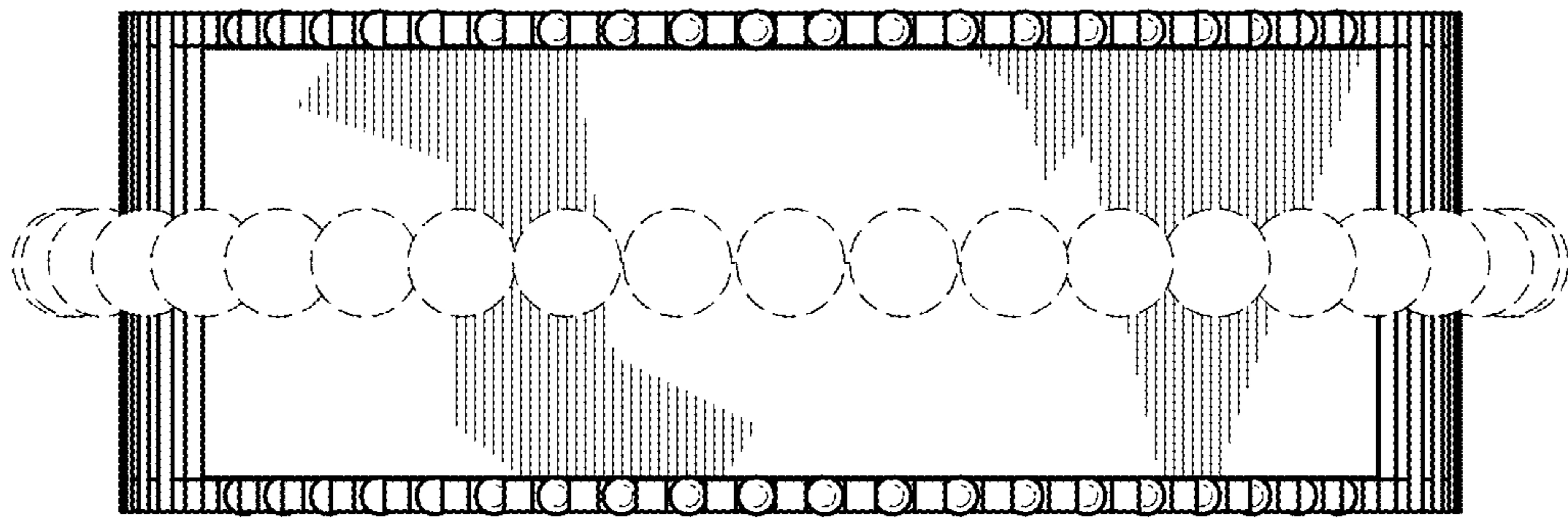

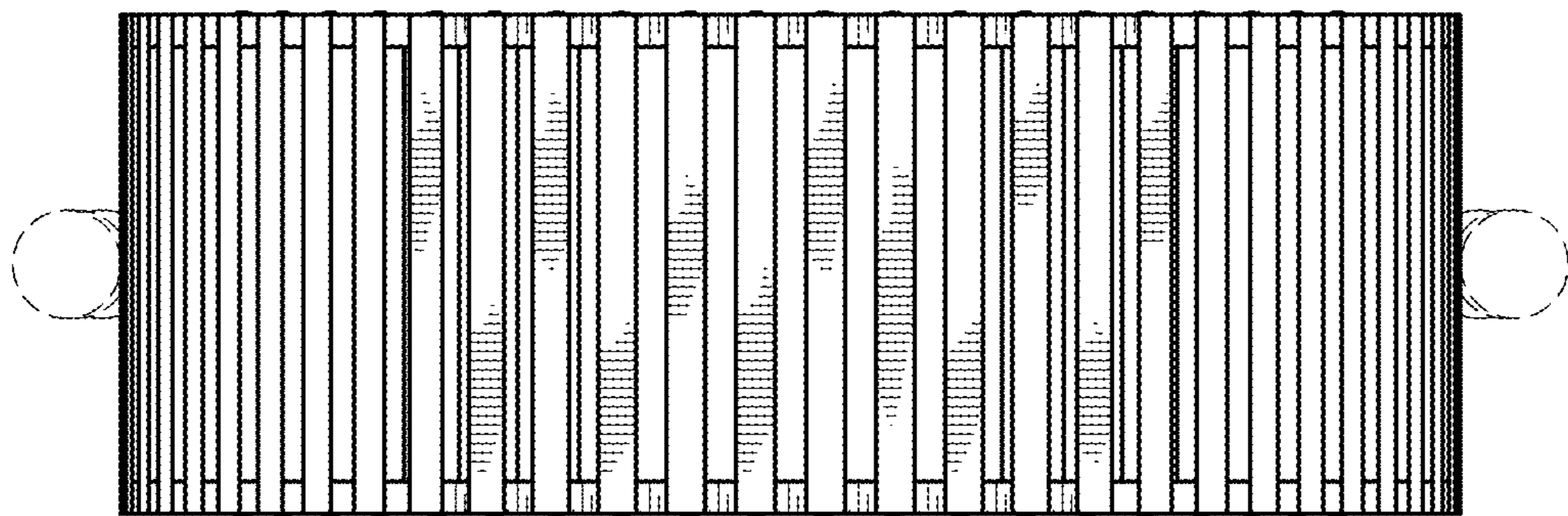
