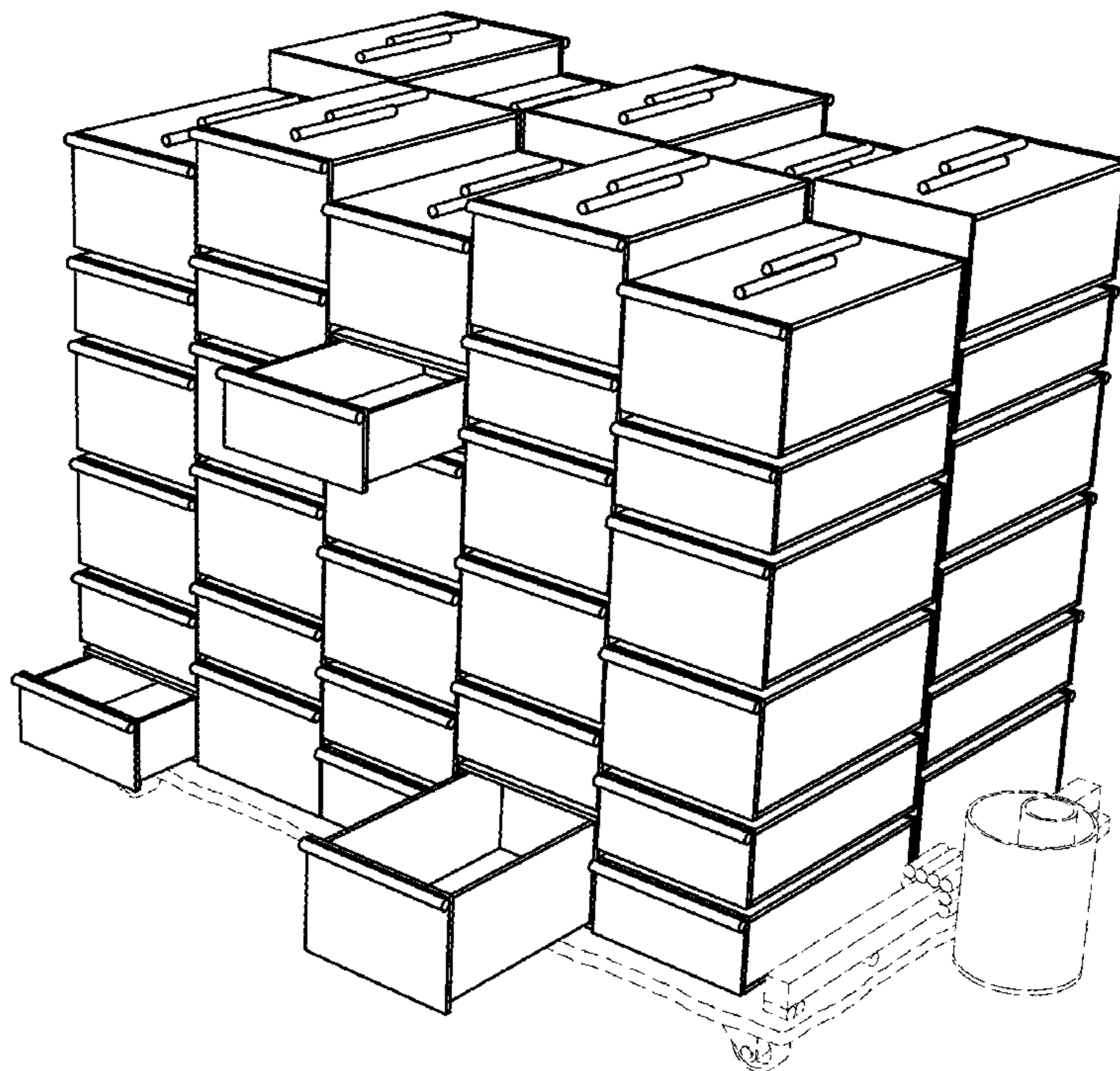
(57) **CLAIM**

The ornamental design for a makeup storage cabinet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the makeup storage cabinet showing my new design;  
FIG. 2 is another front perspective view showing the drawer tray opened;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a left elevation side view thereof; and,  
FIG. 5 is a top plan view thereof.

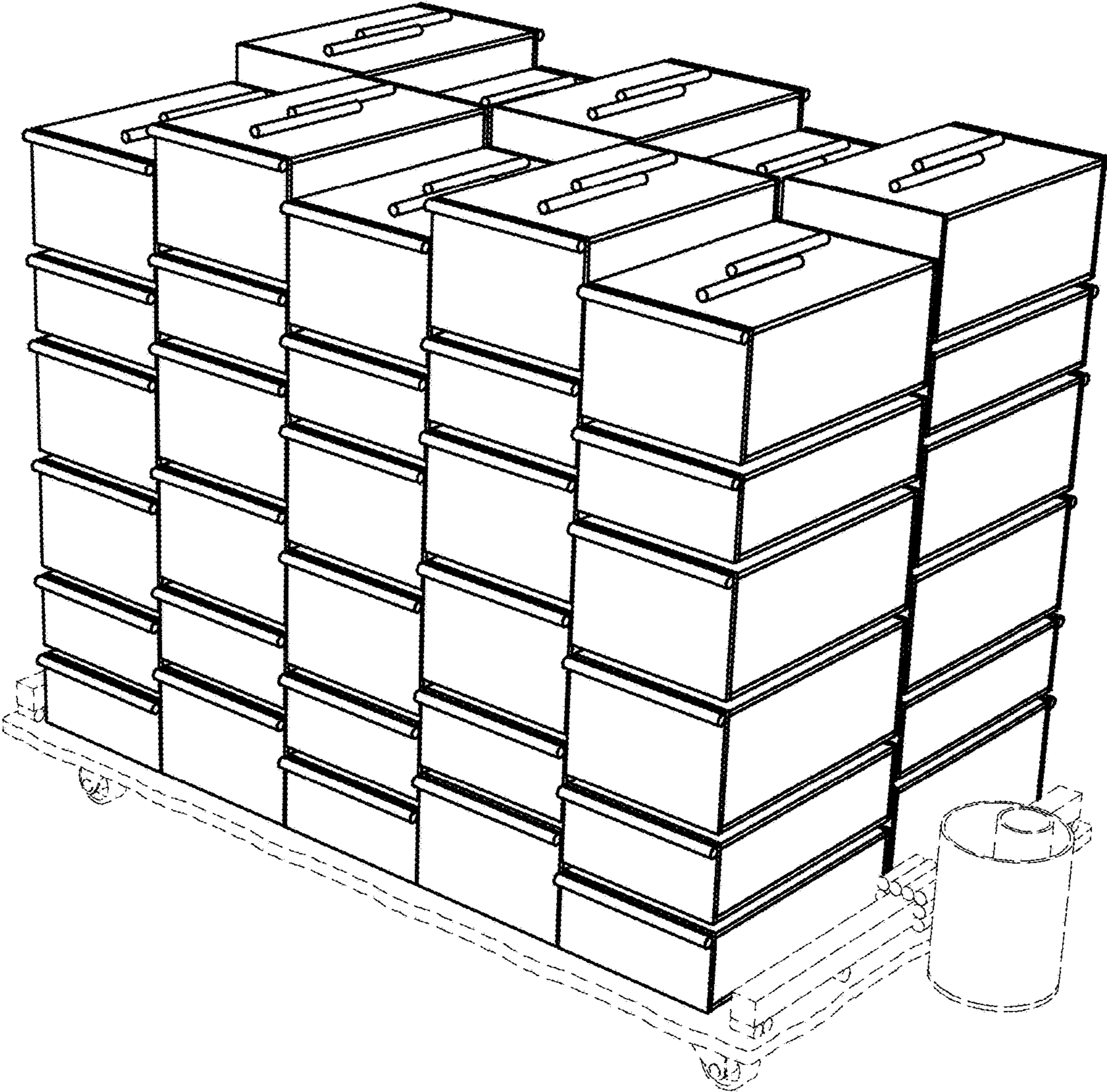

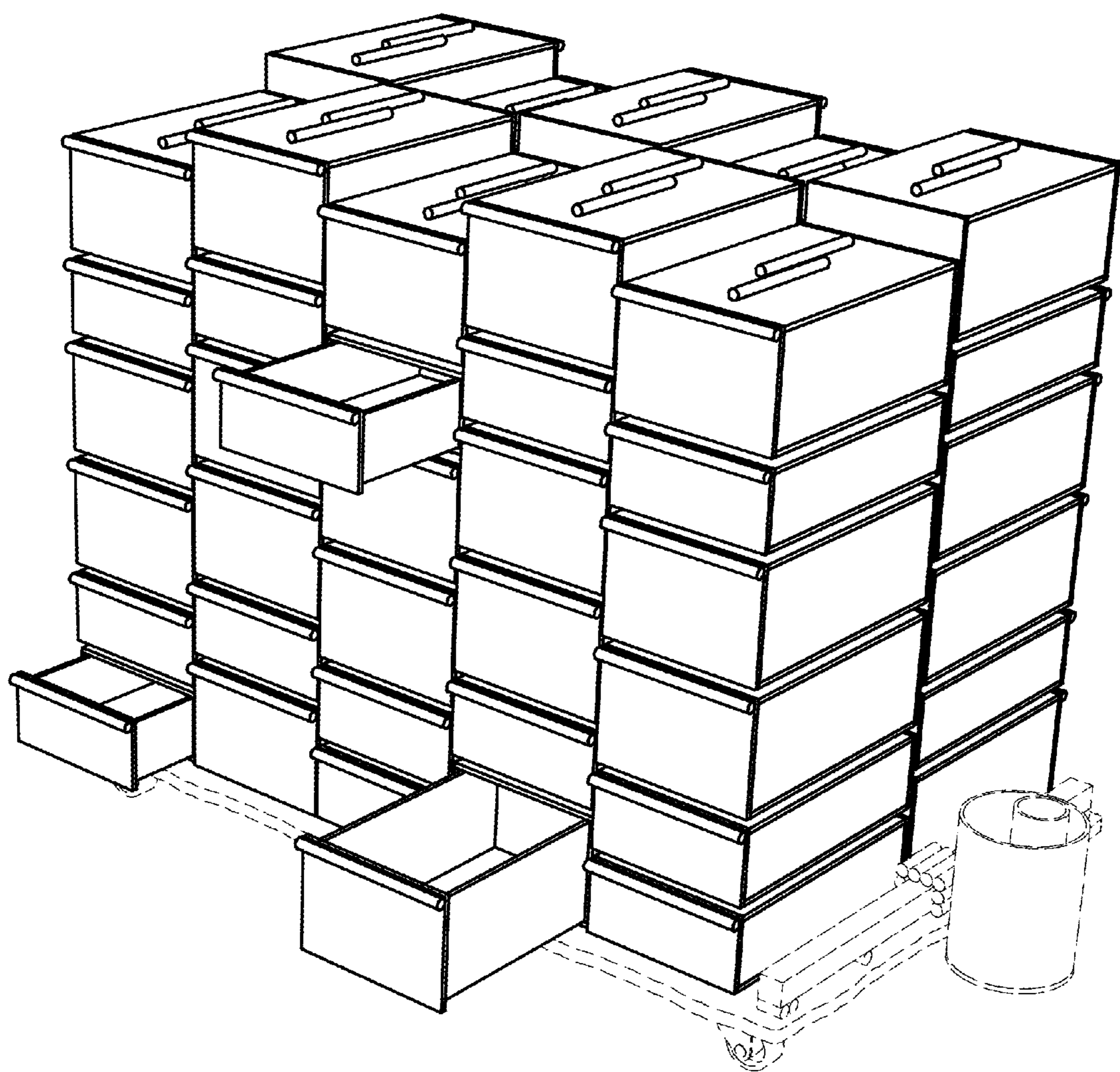

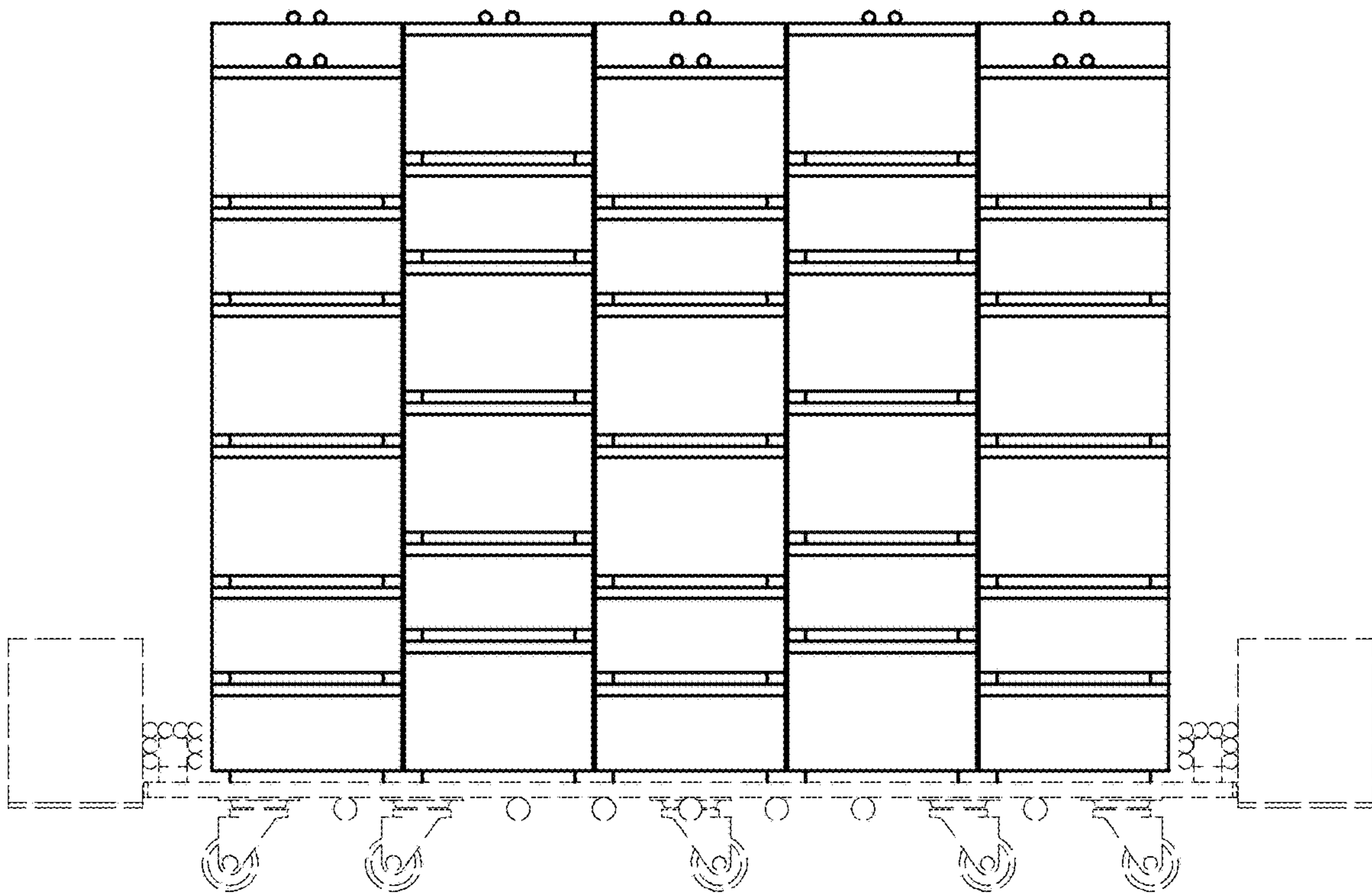

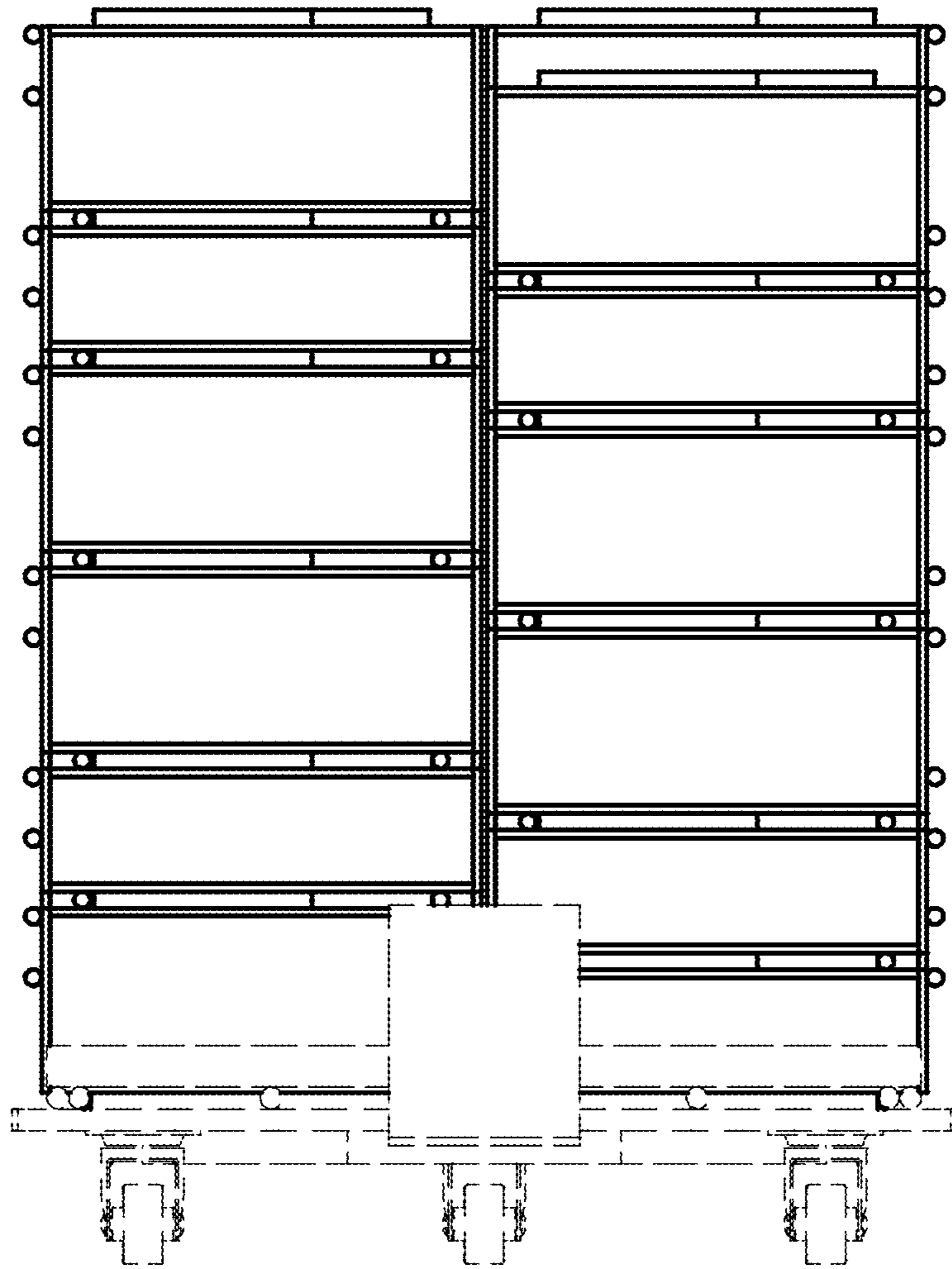

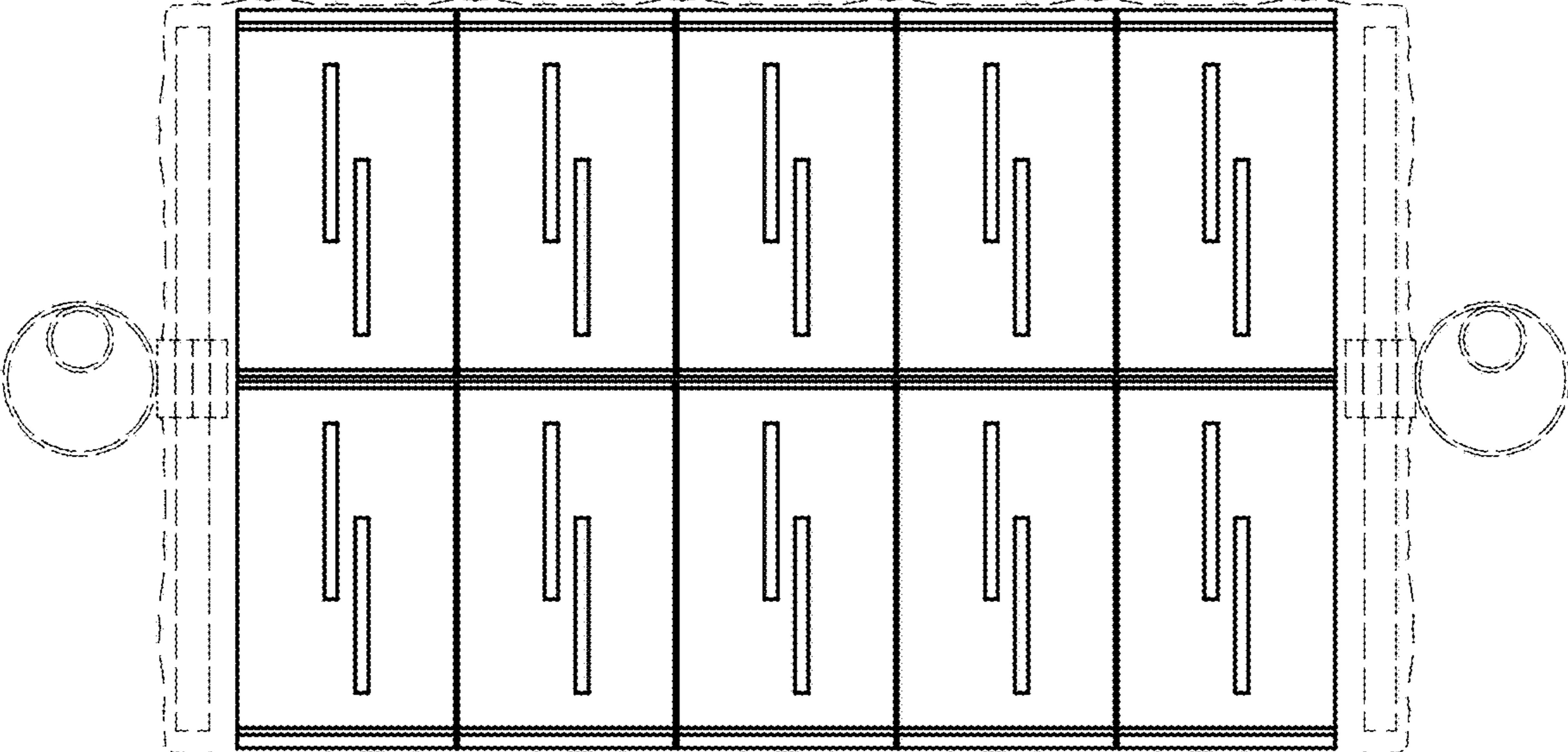
