(57) **CLAIM**

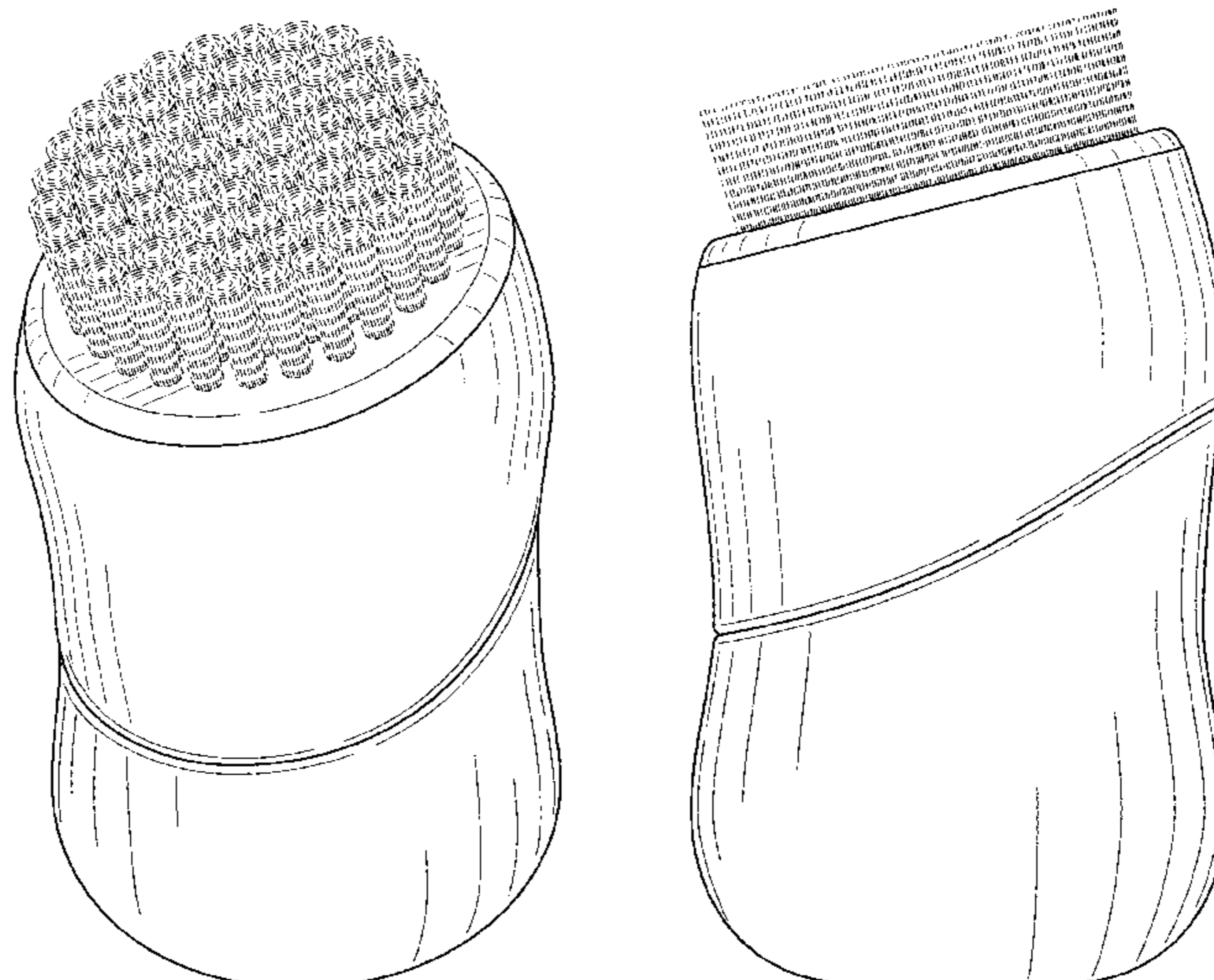
The ornamental design for a brush, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a front, top, and right side of an ornamental design for a brush;

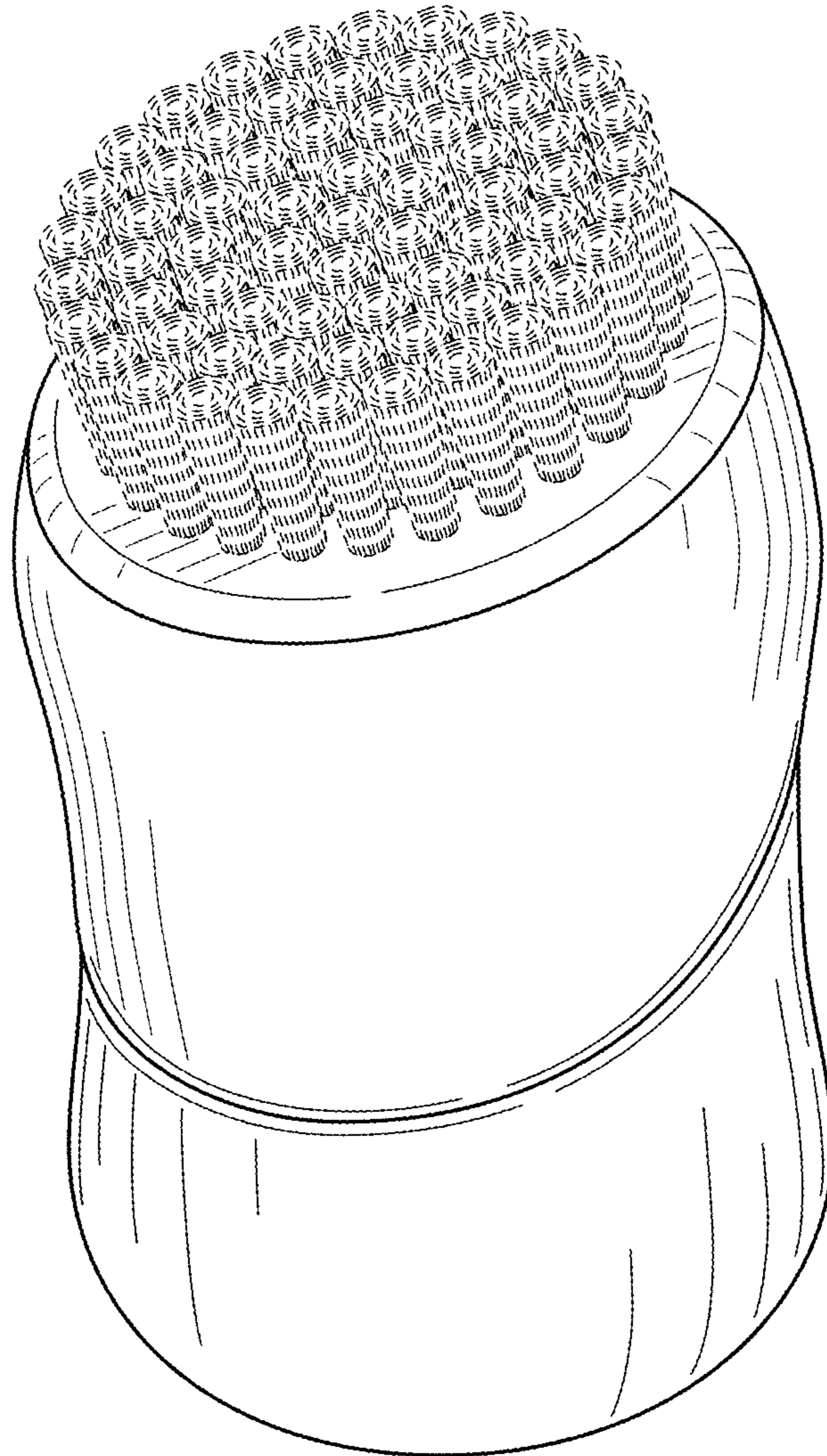

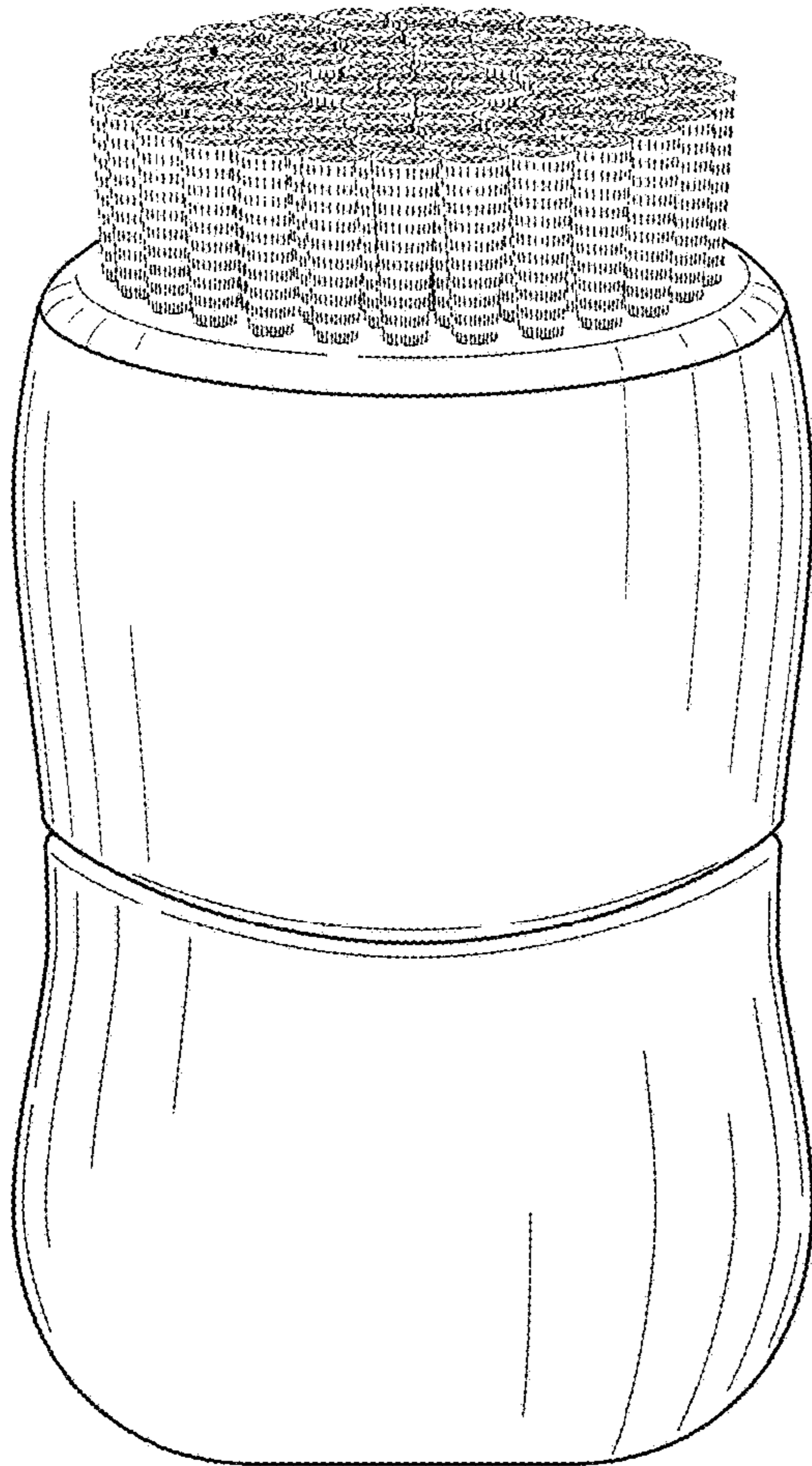

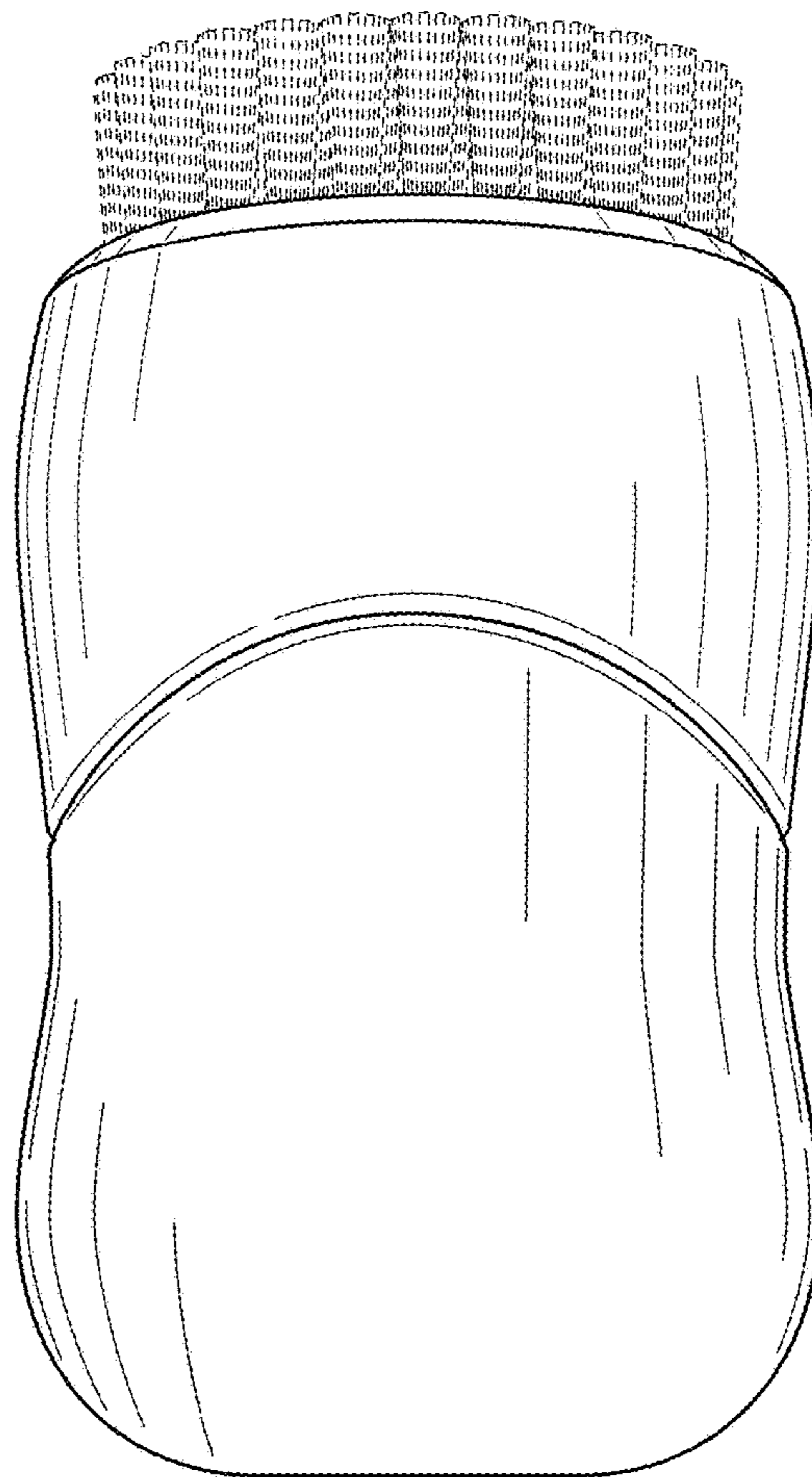

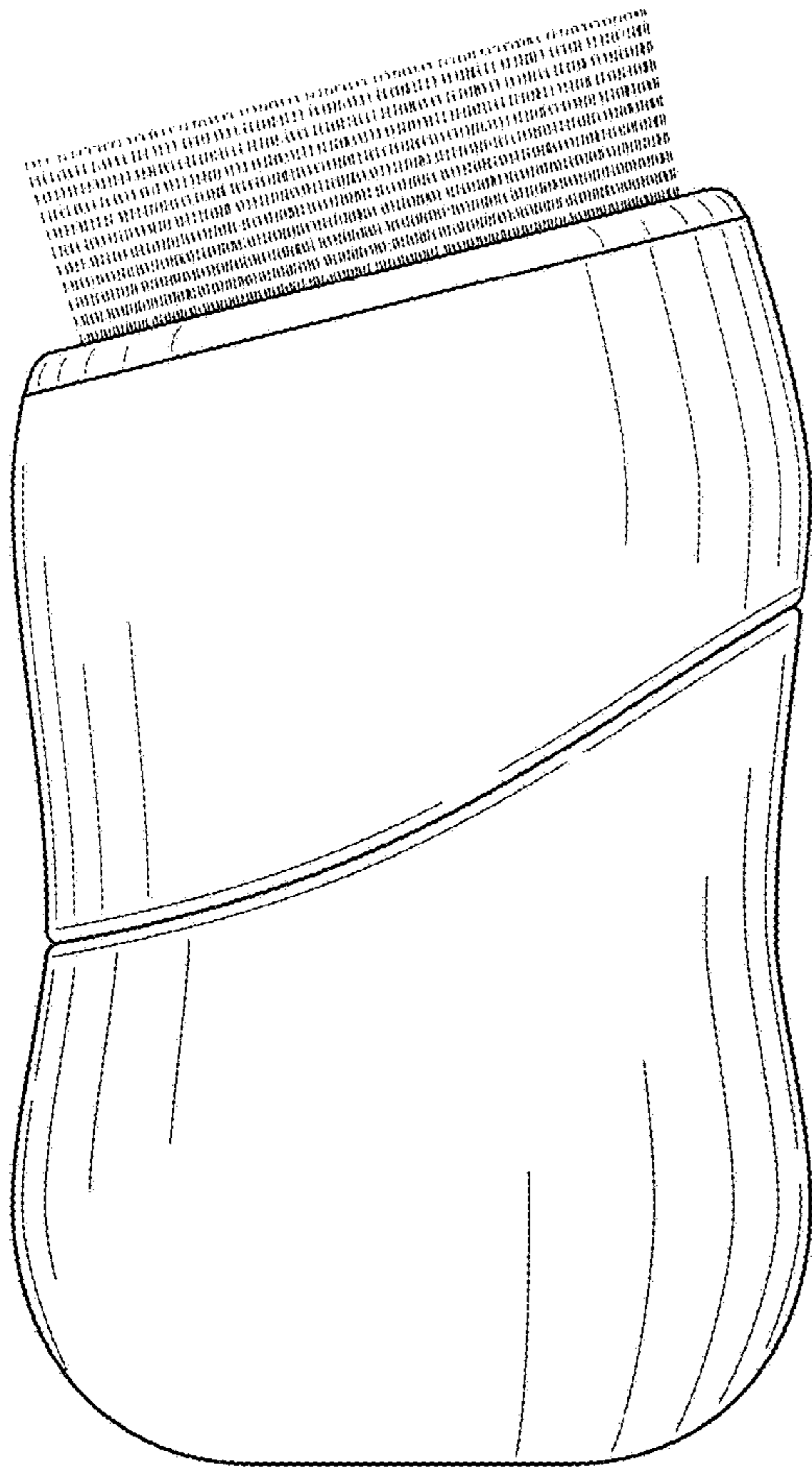

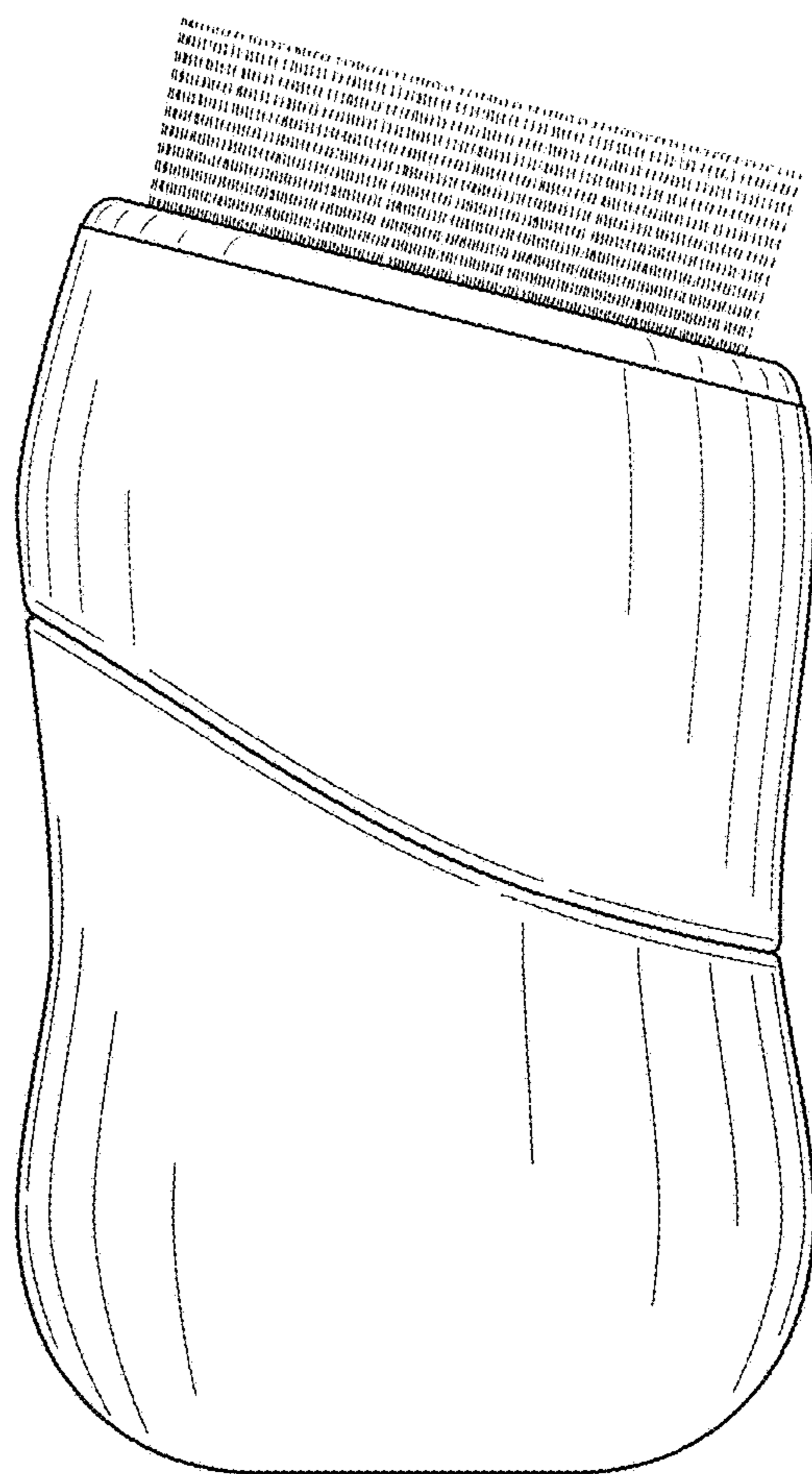
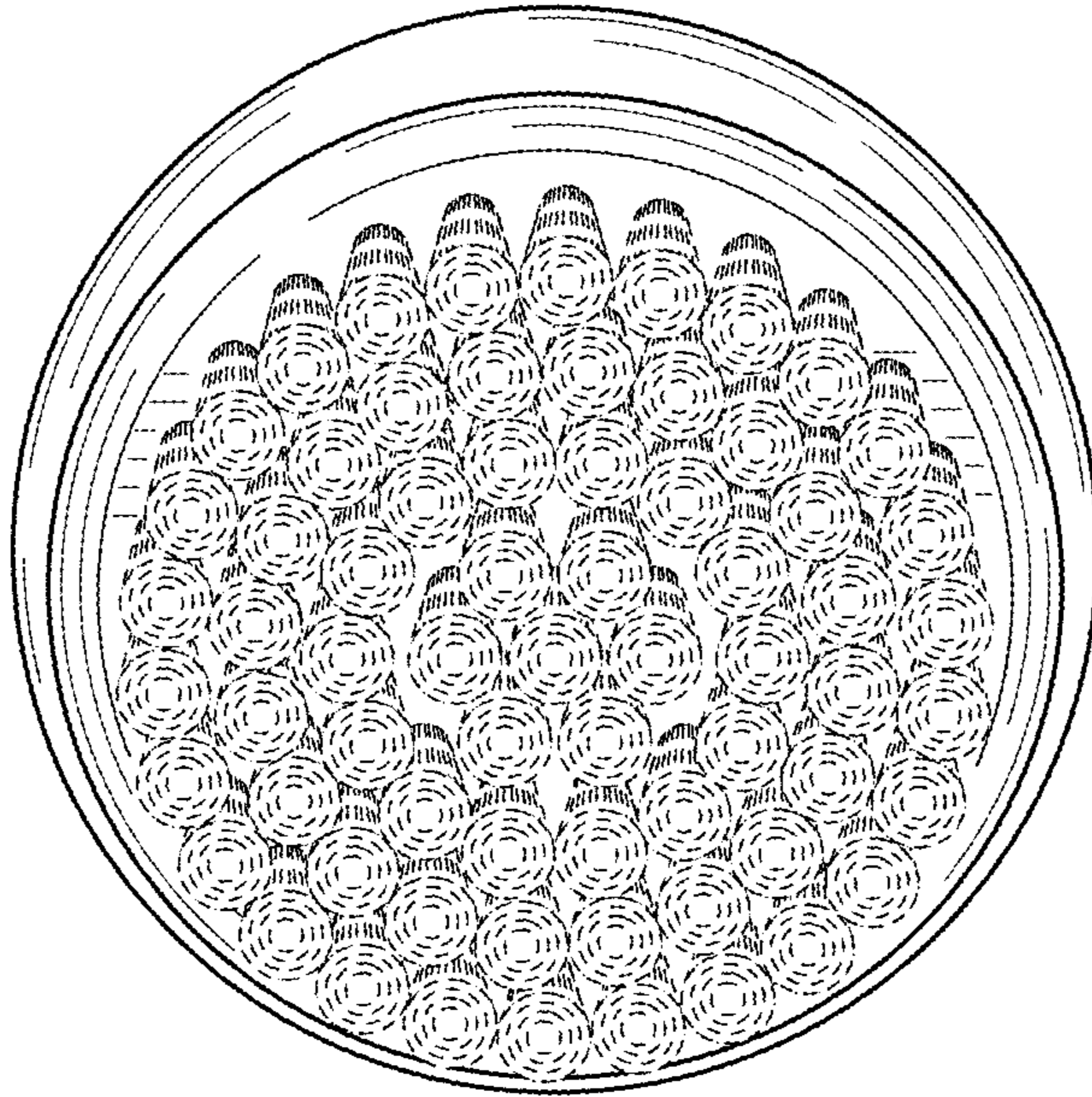
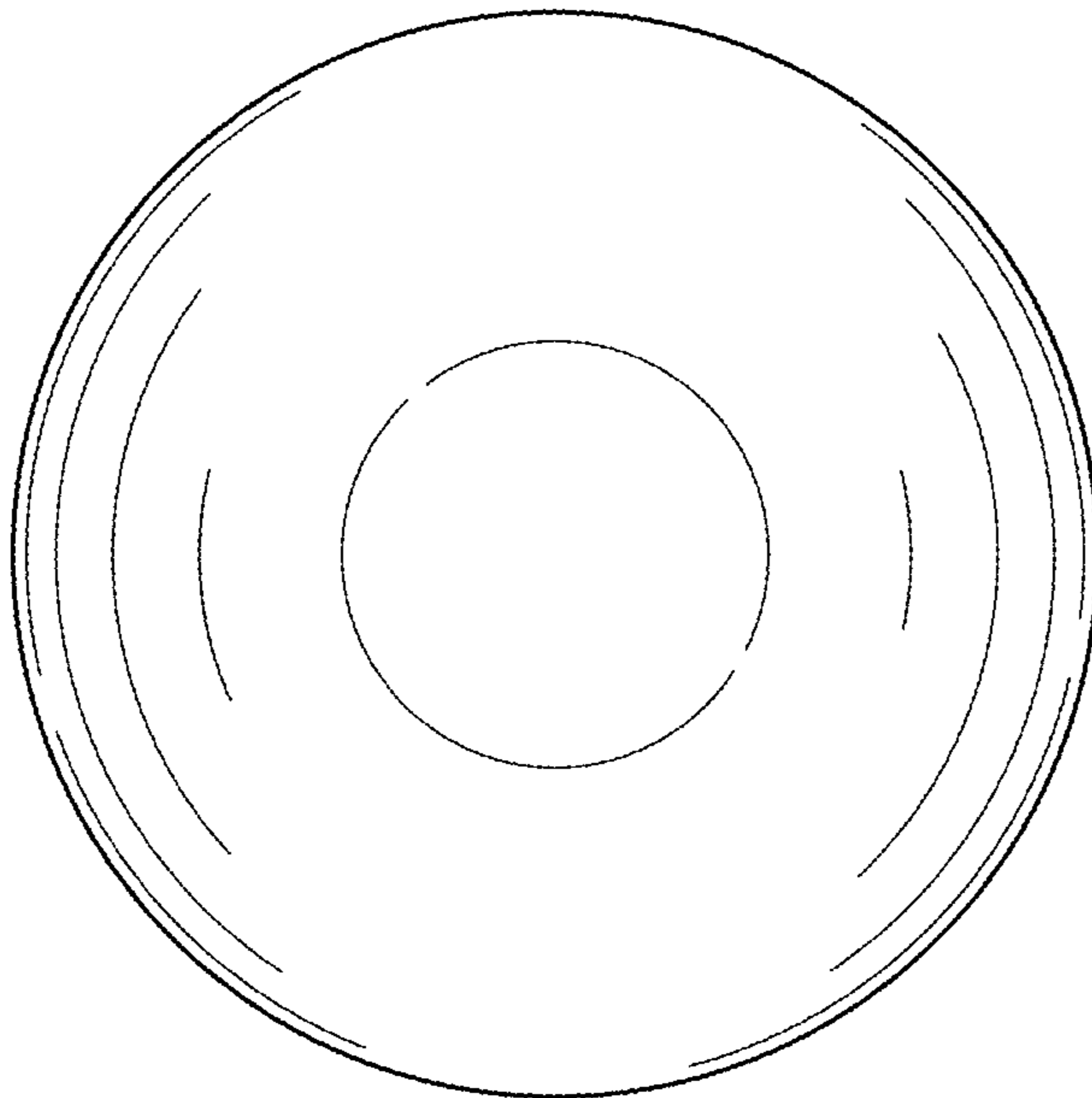

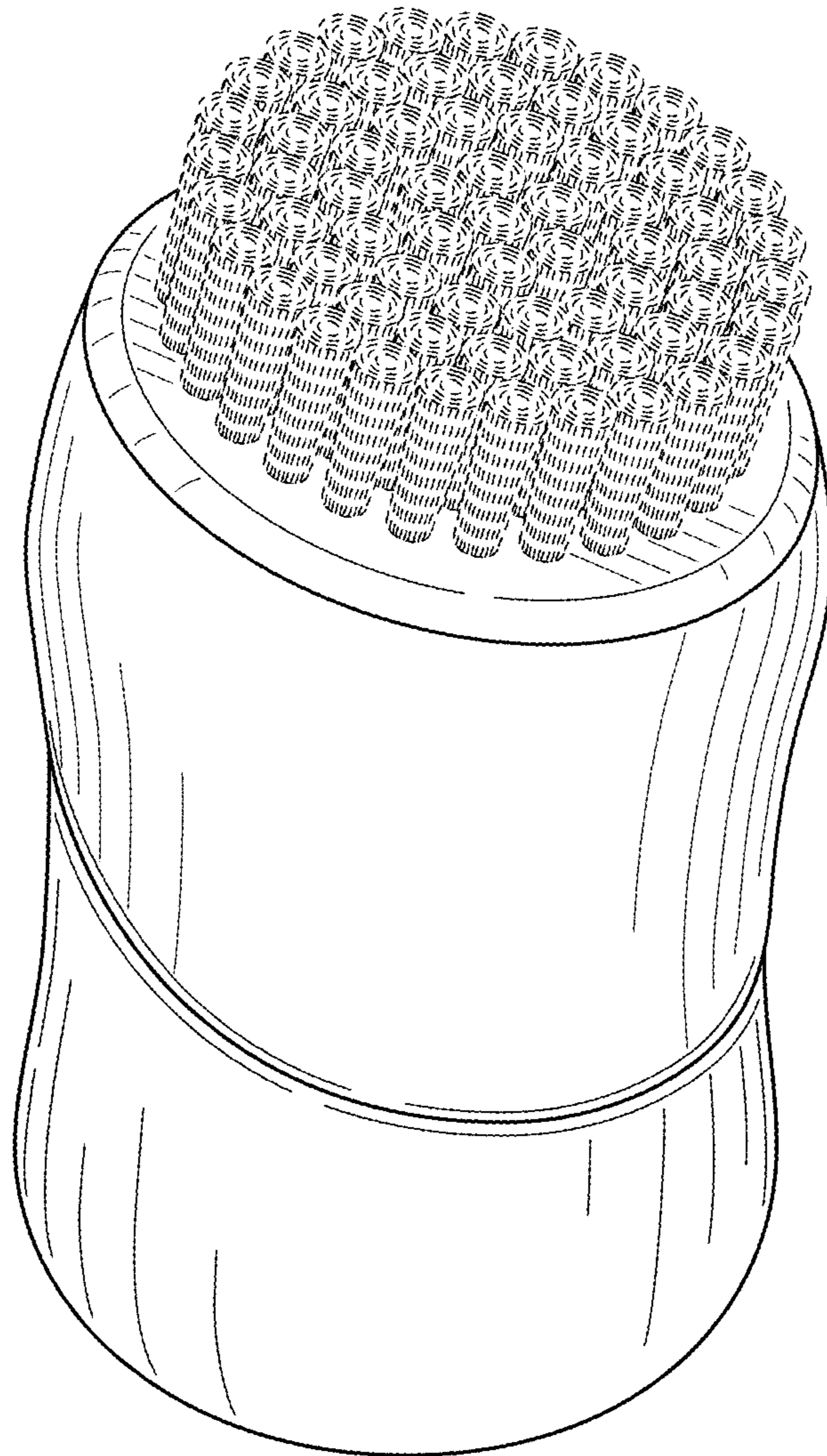

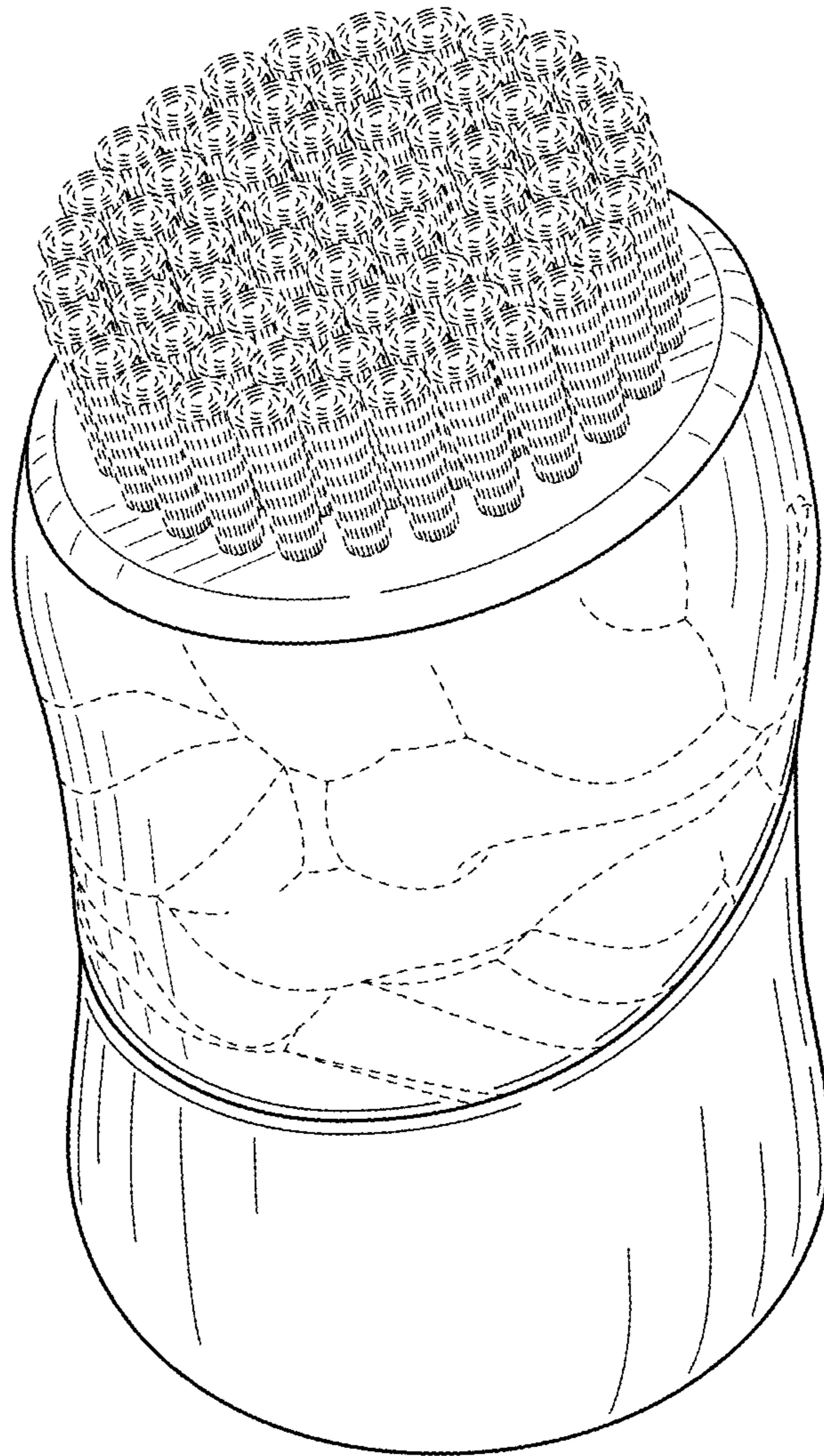

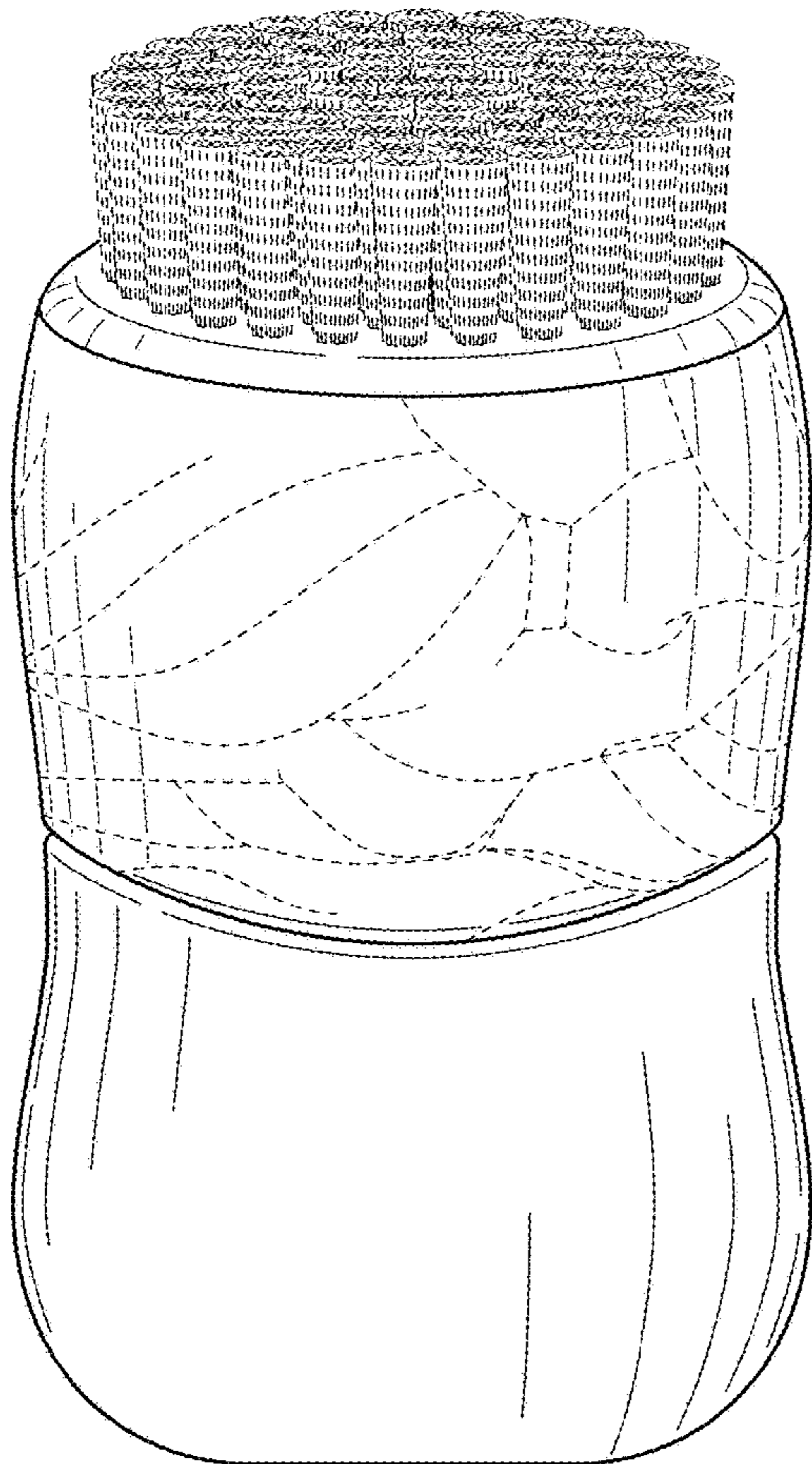

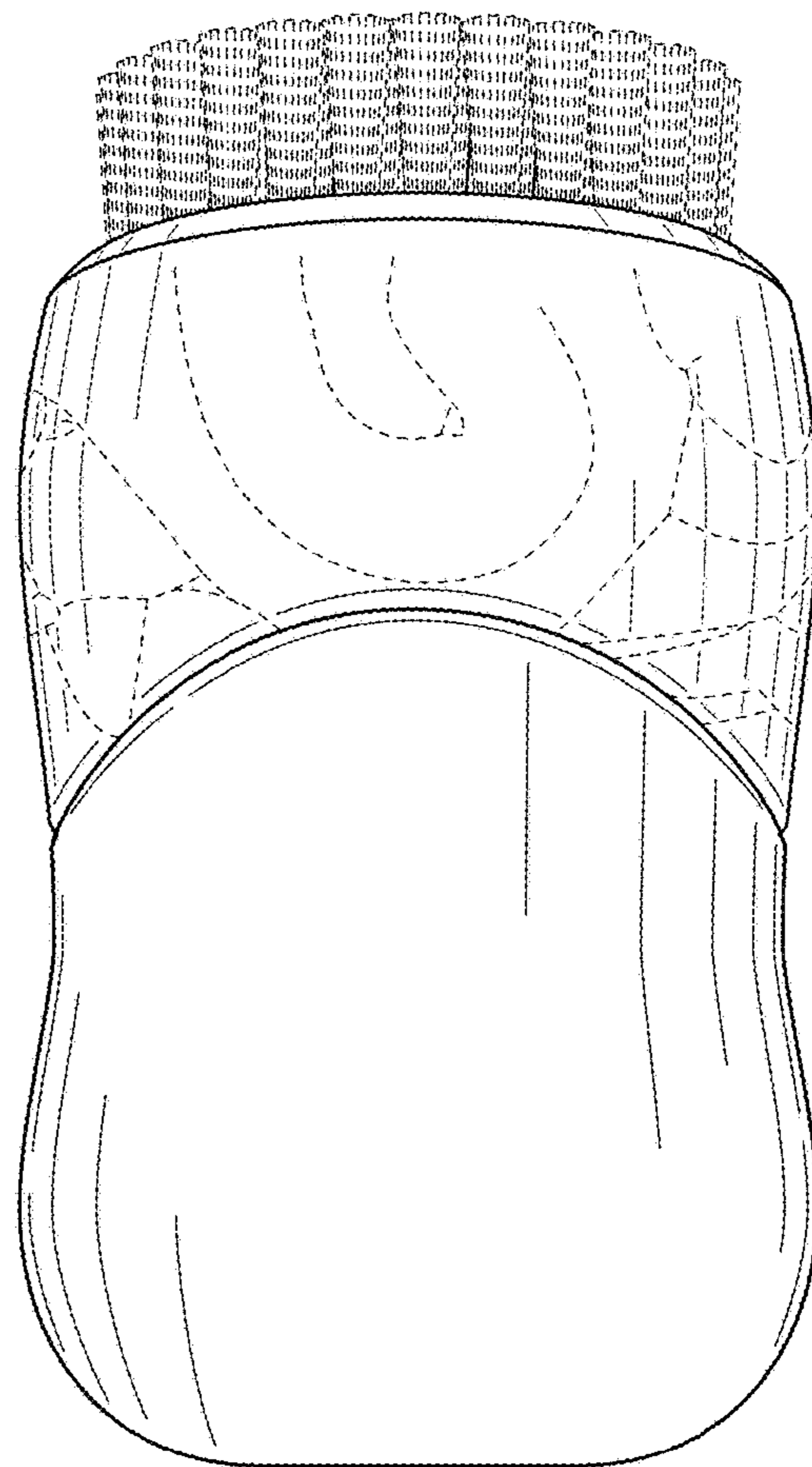

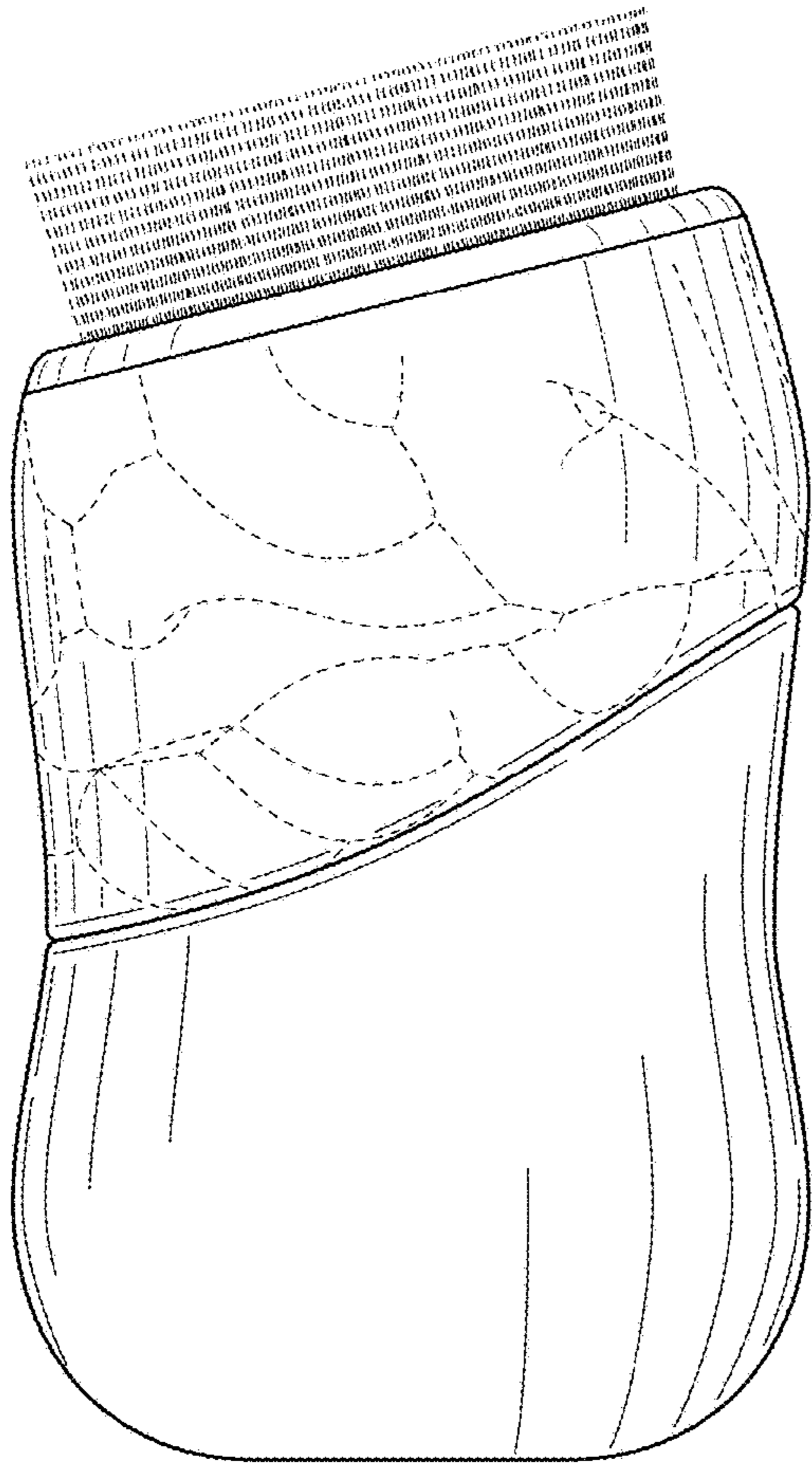

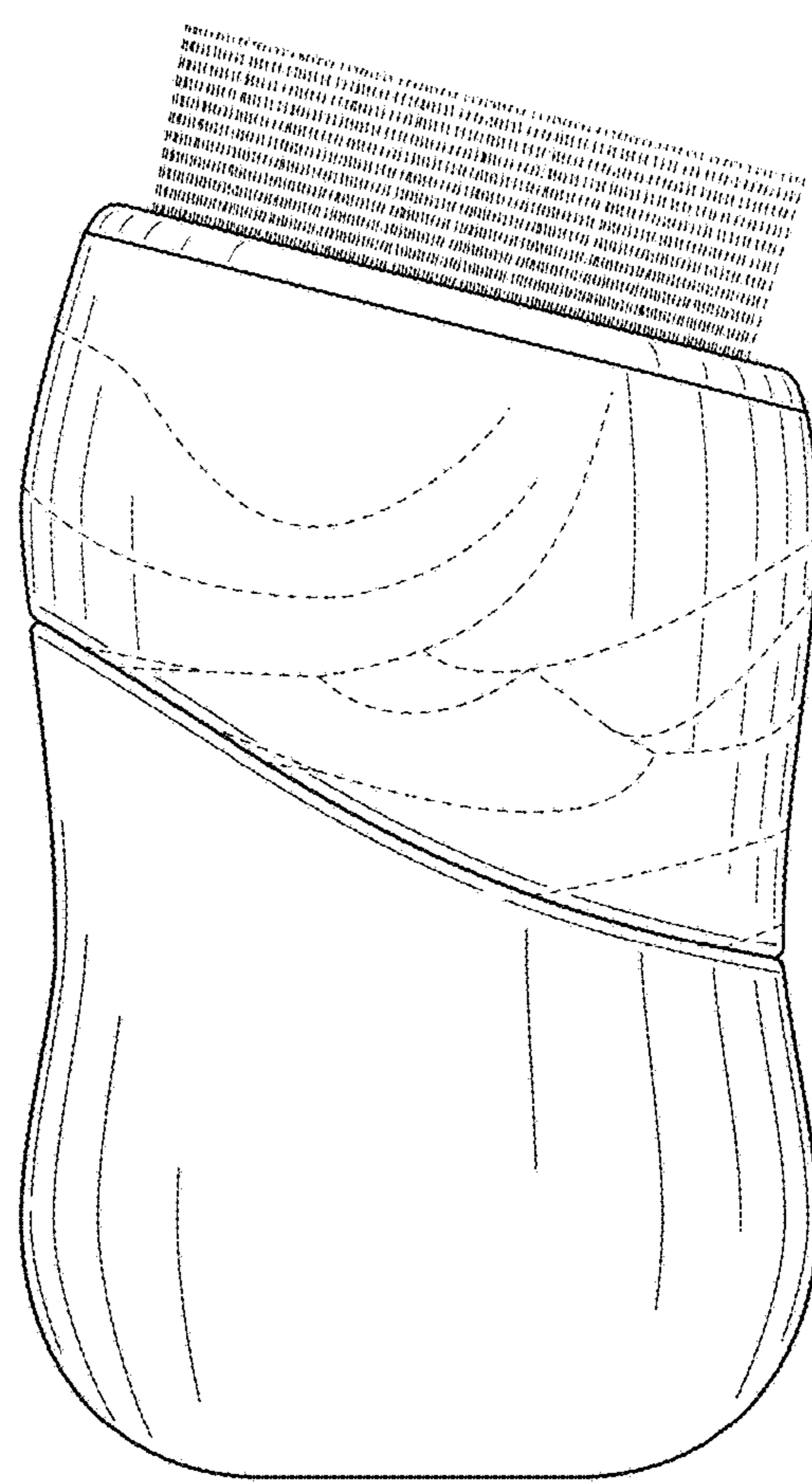

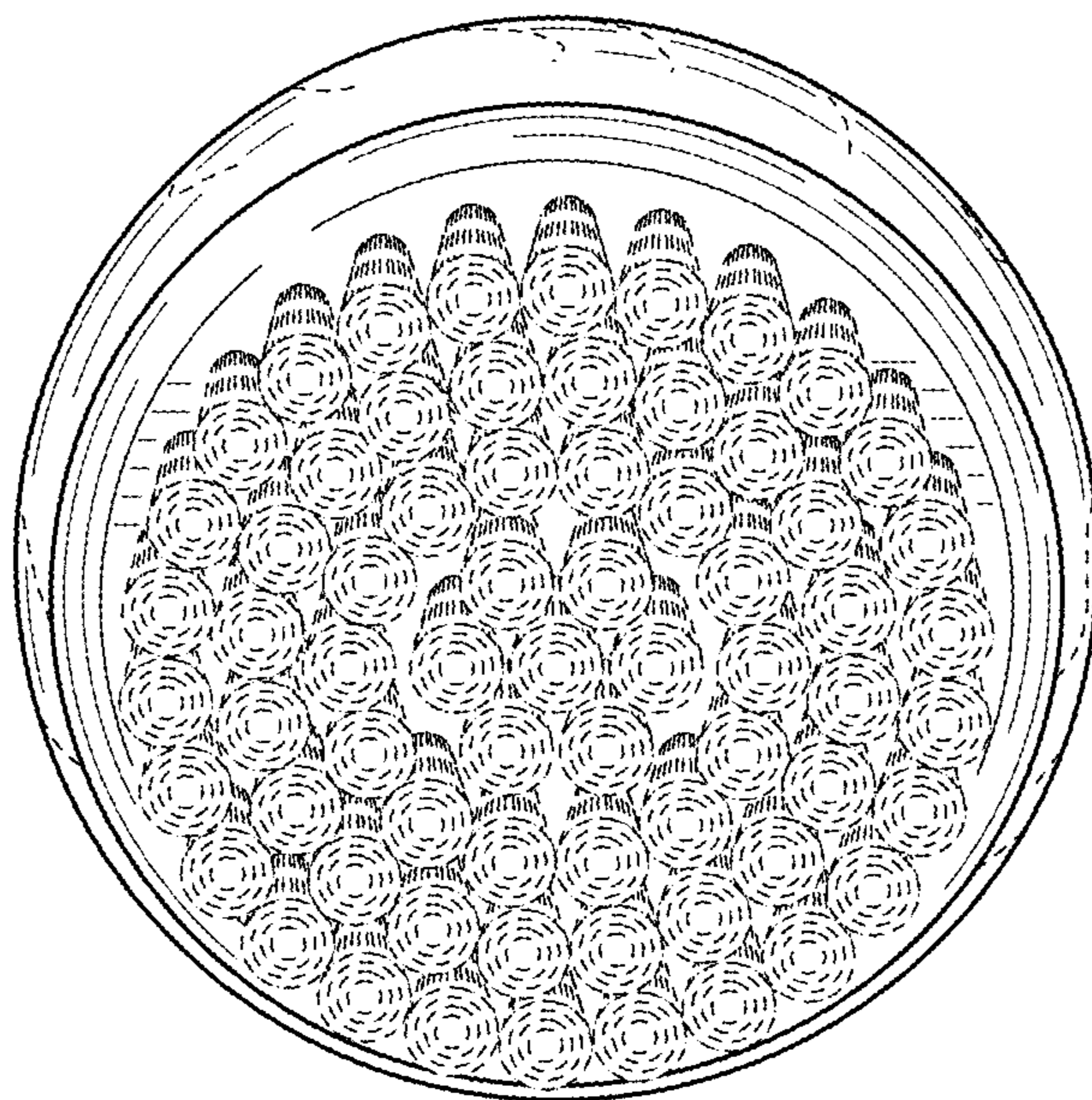

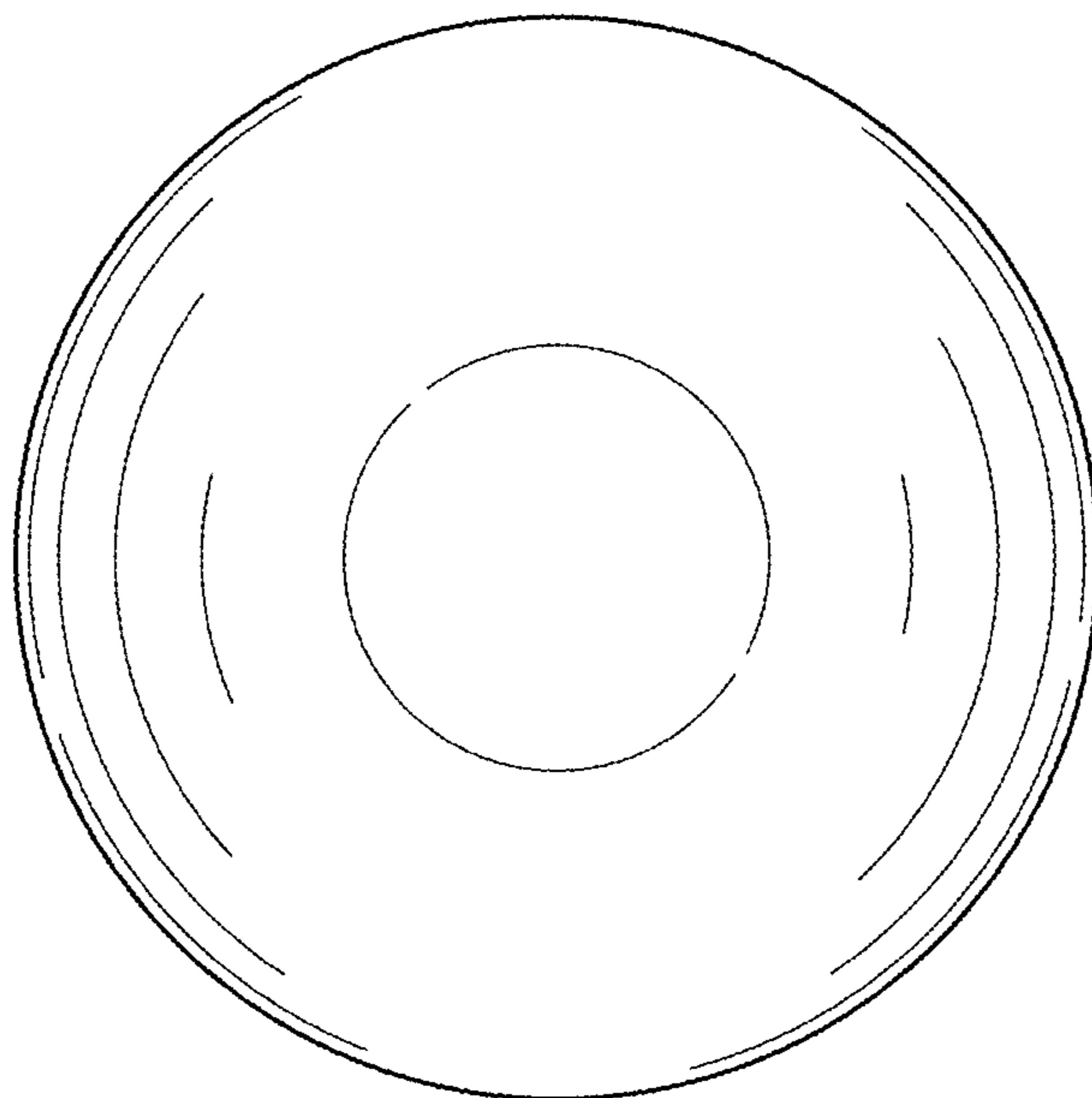

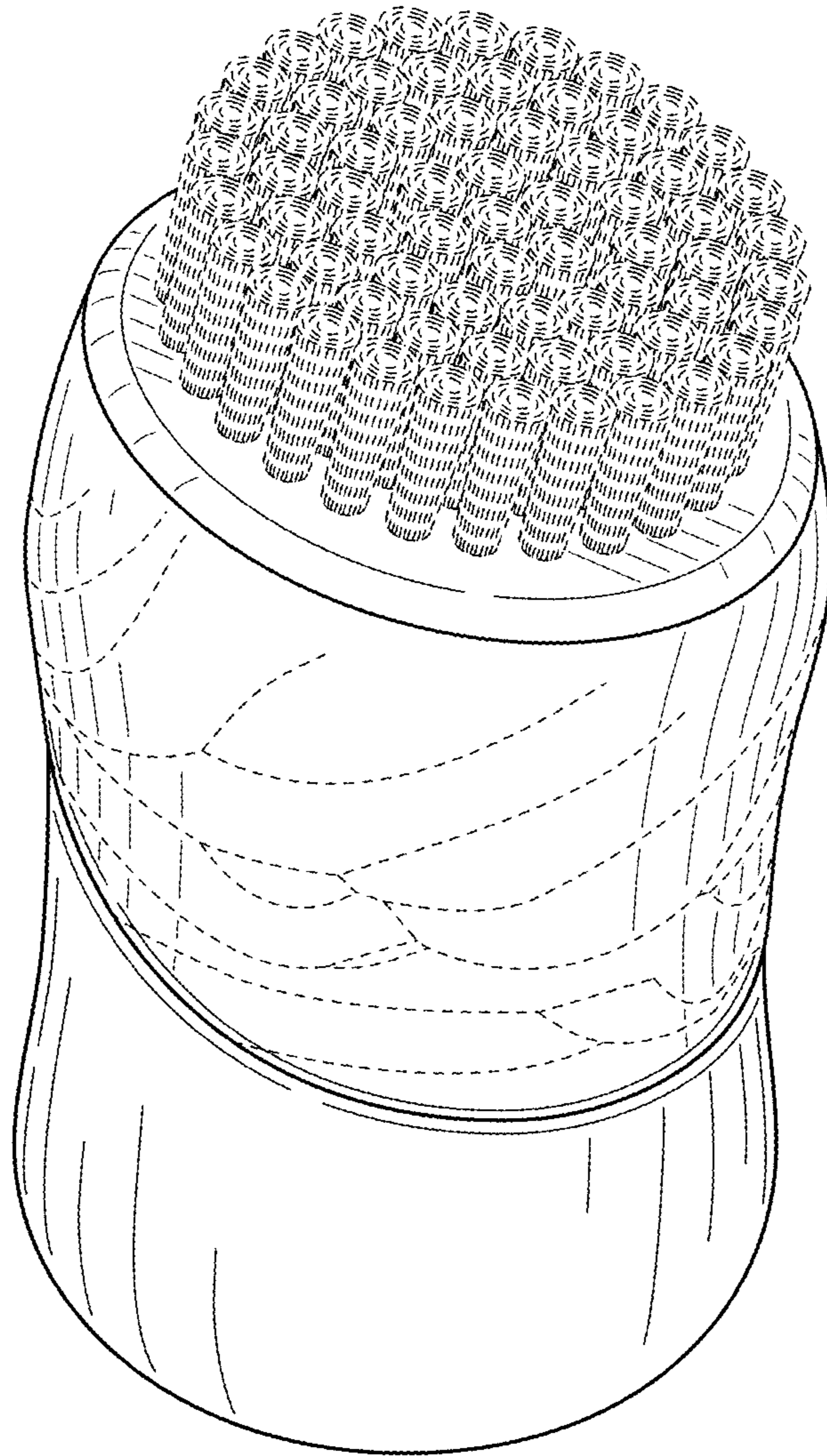
