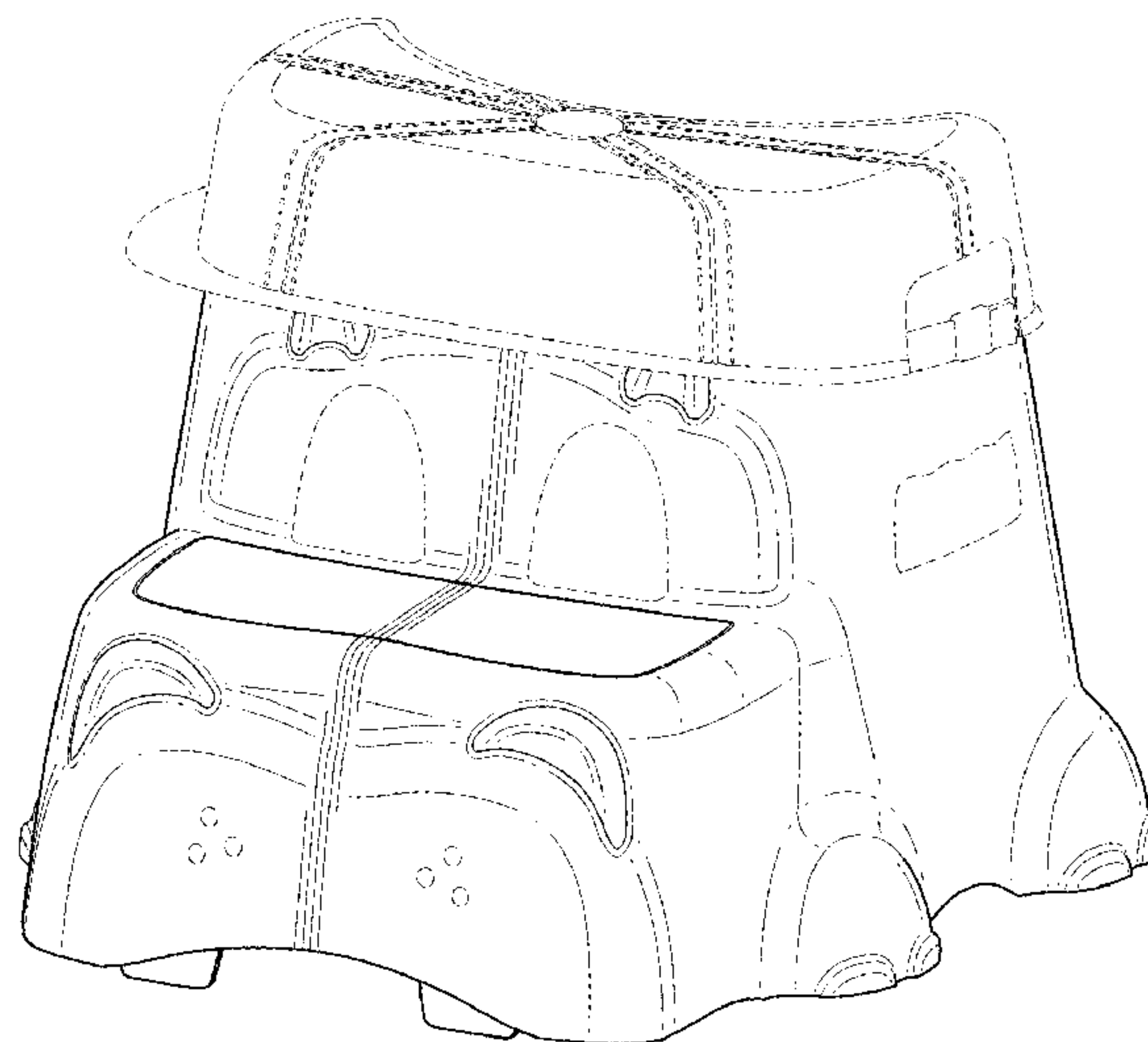
The ornamental design for a toilet footrest for children, as

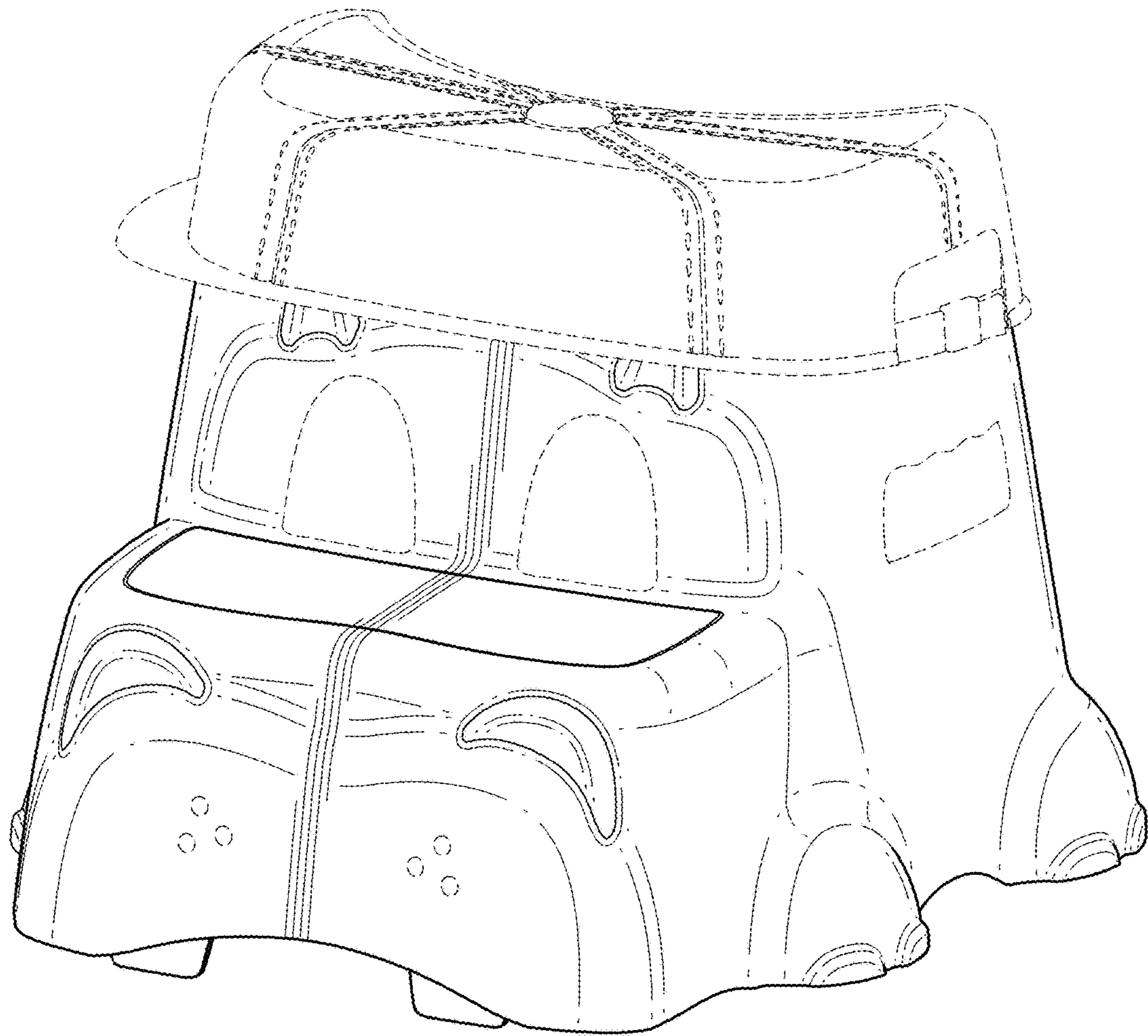

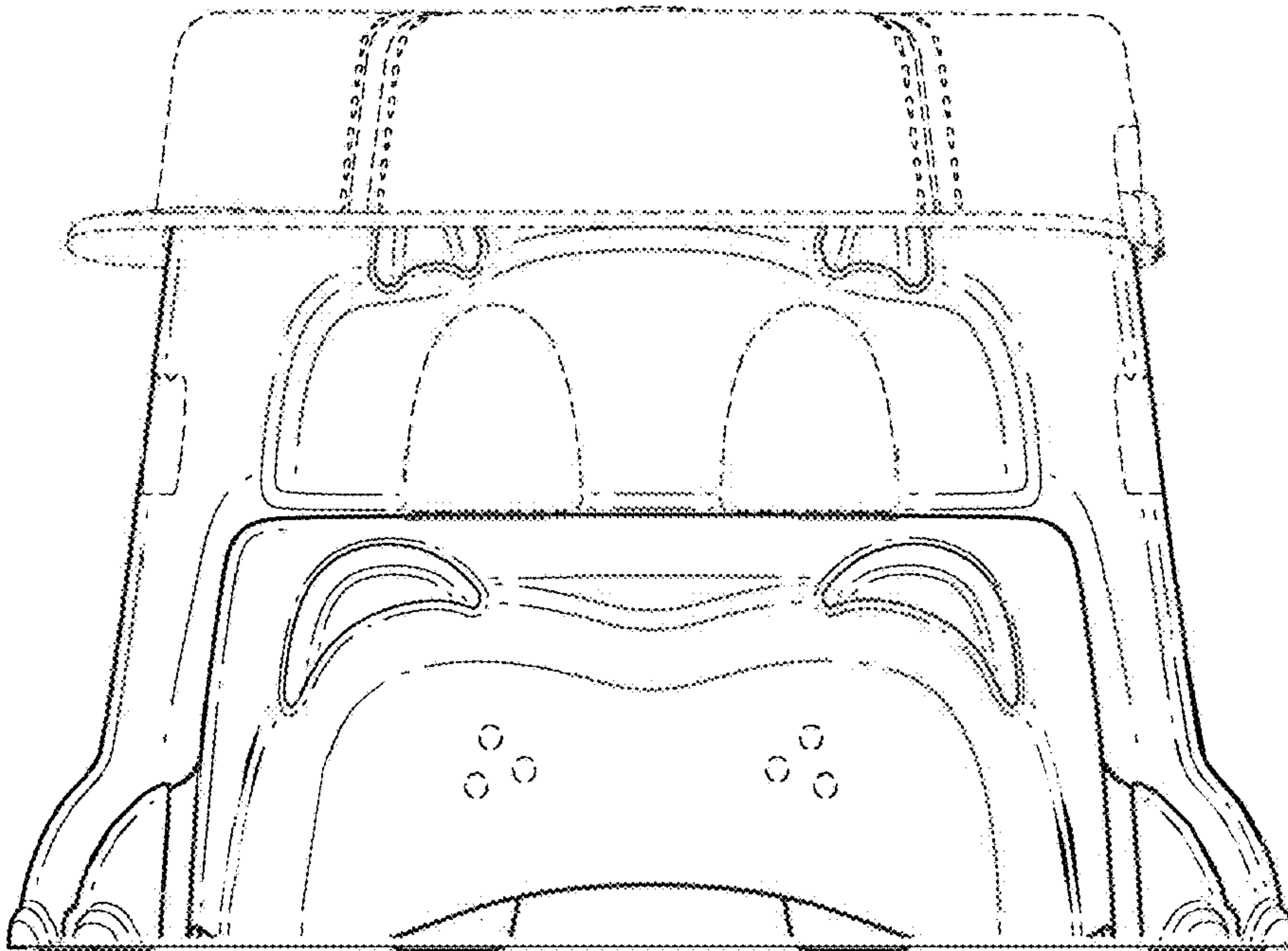

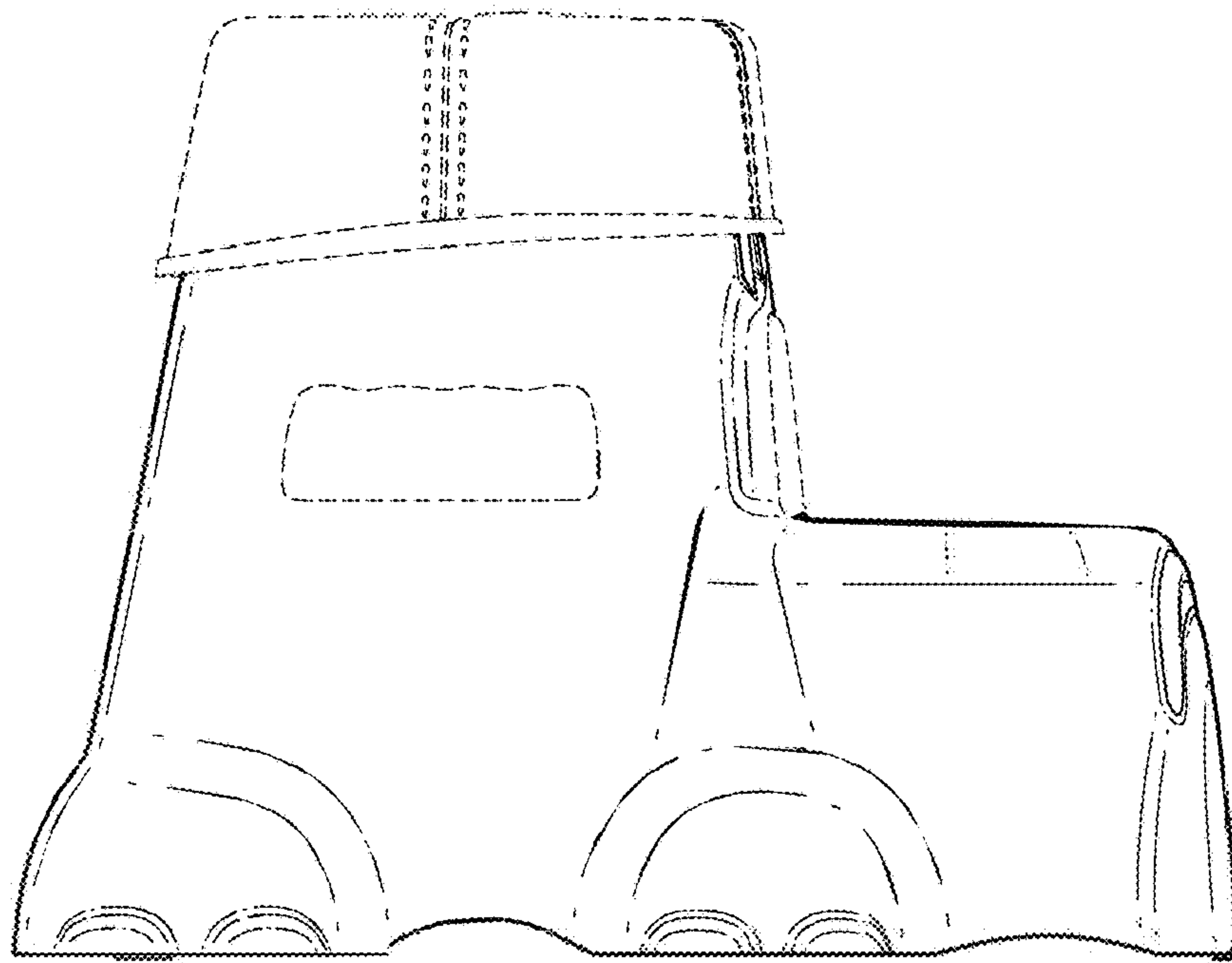

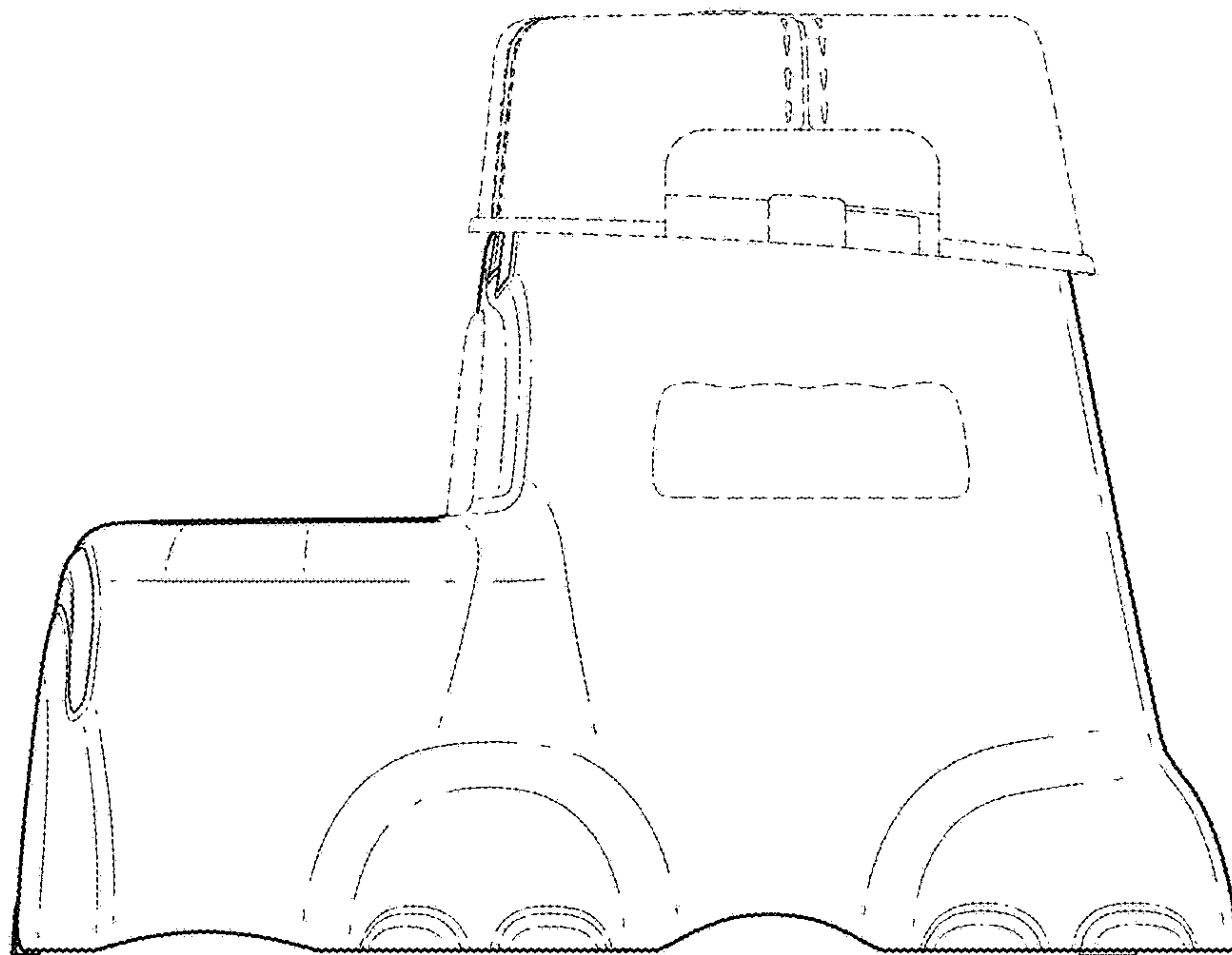

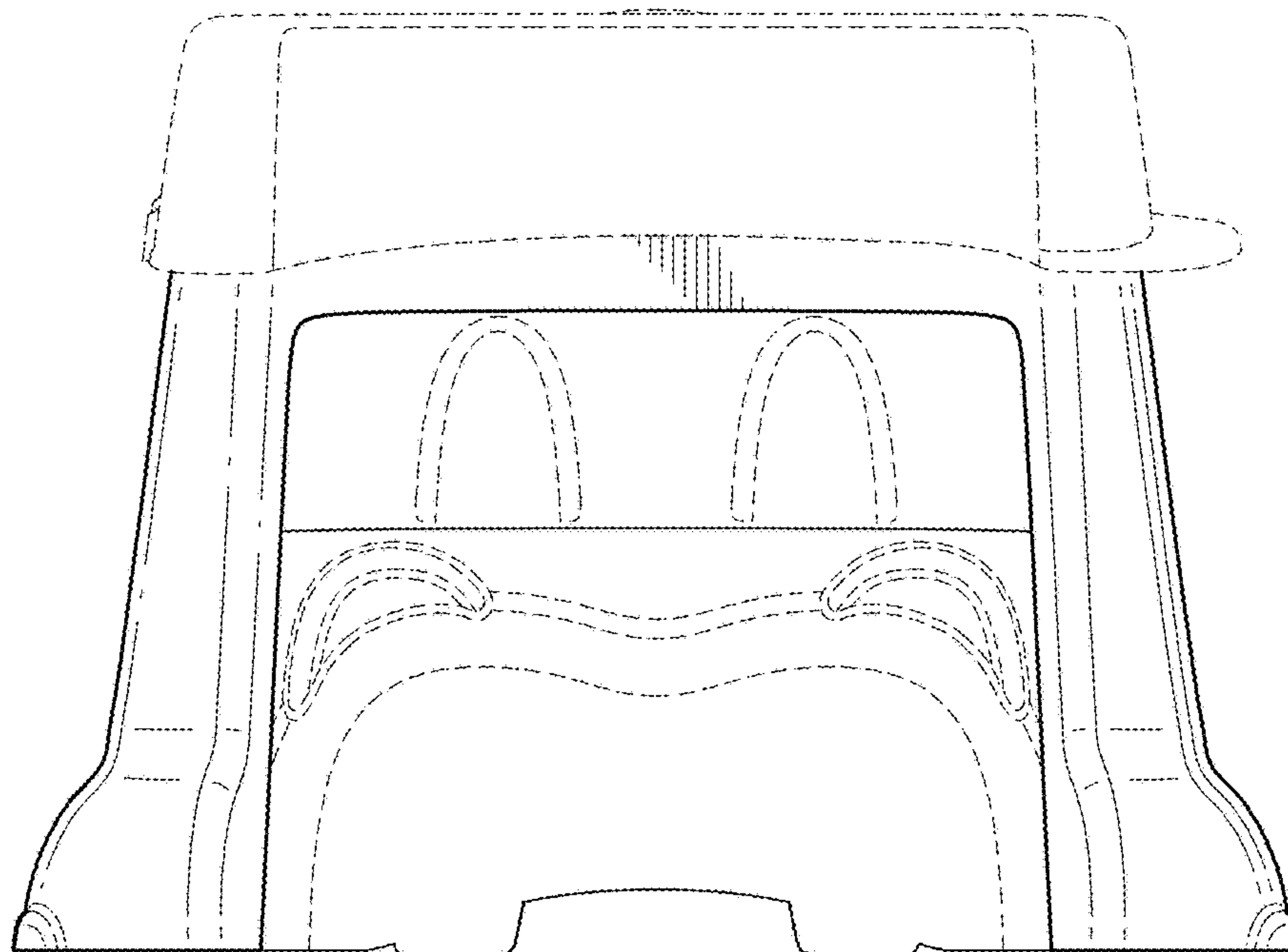

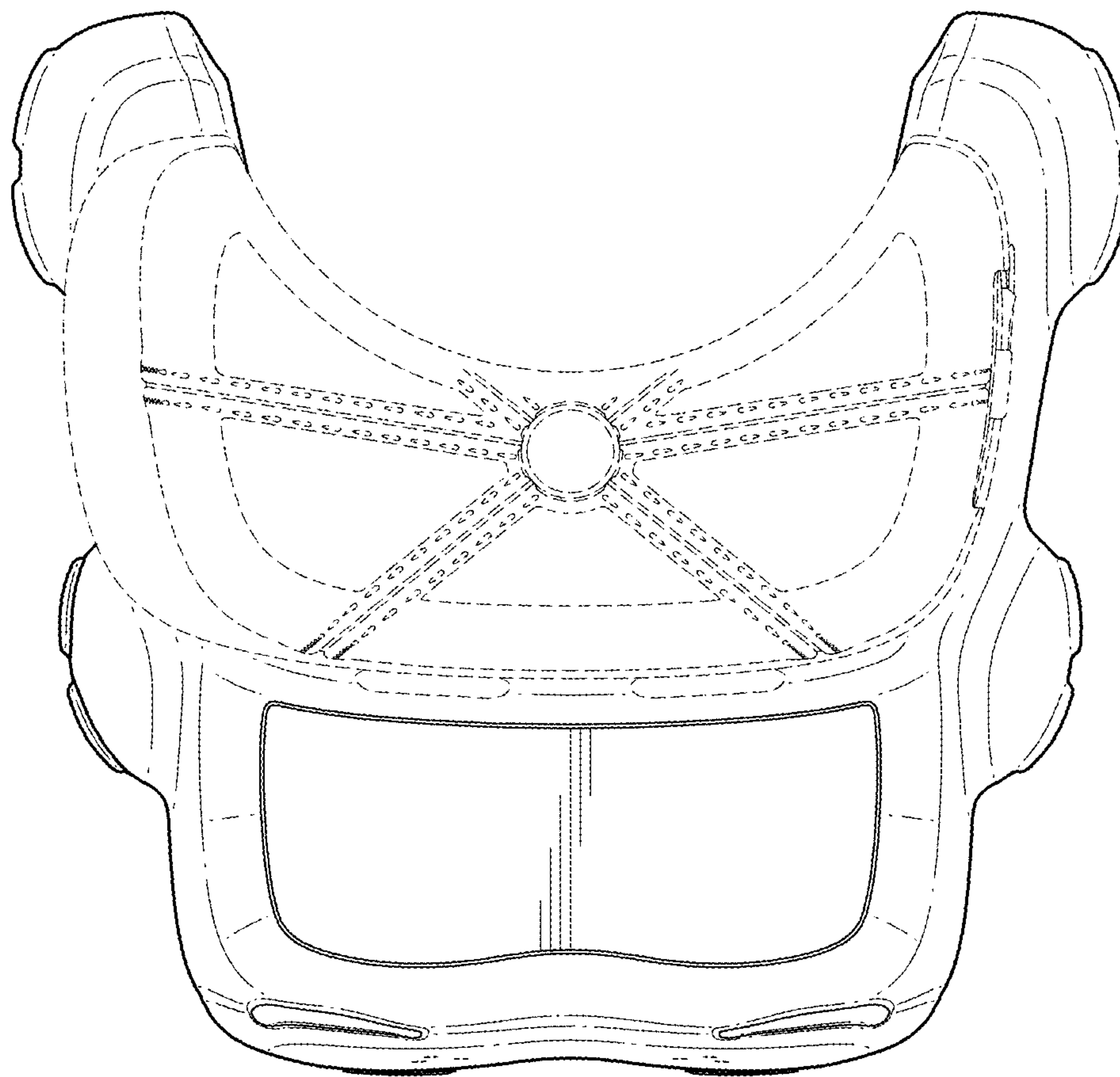




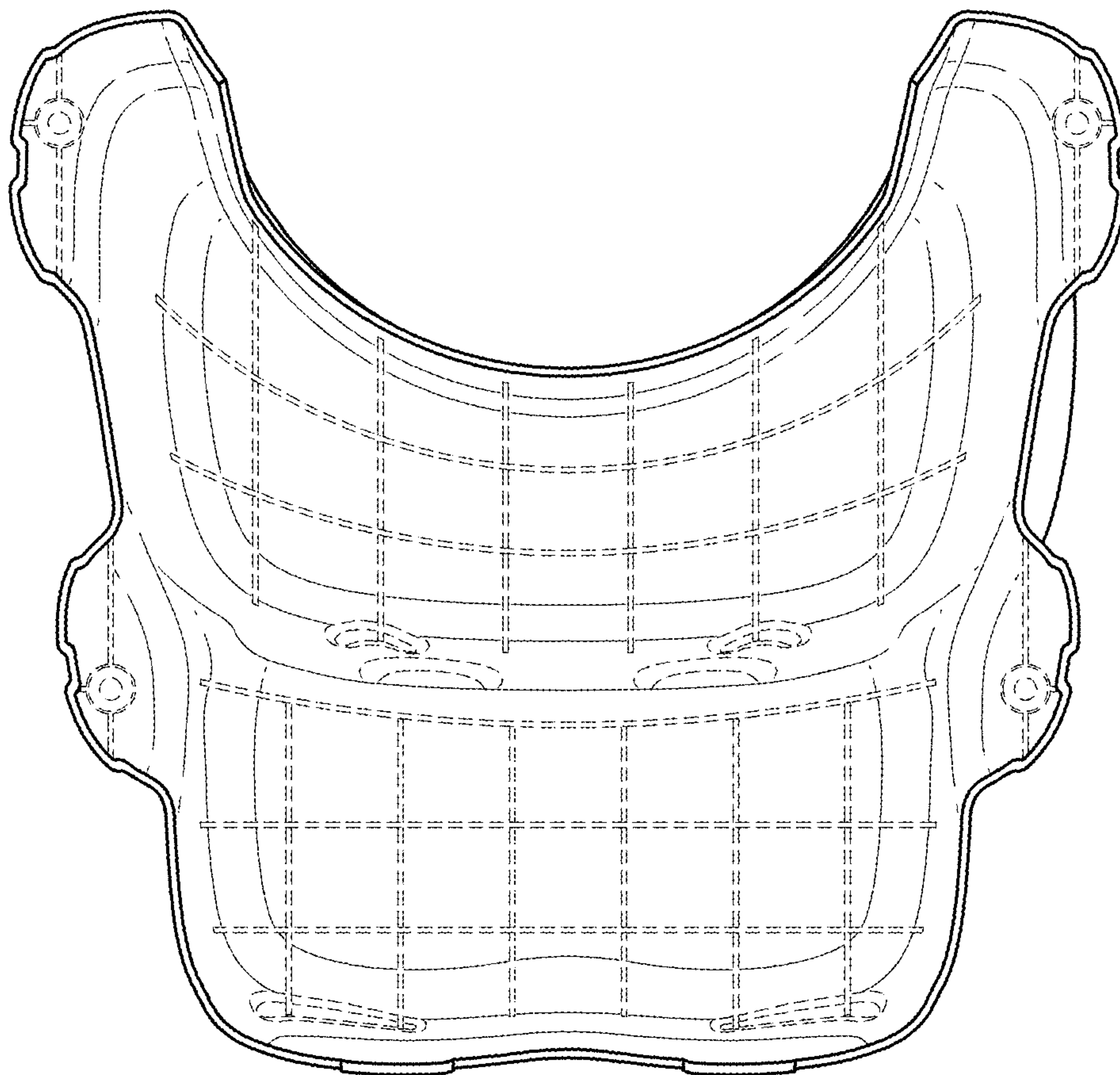
