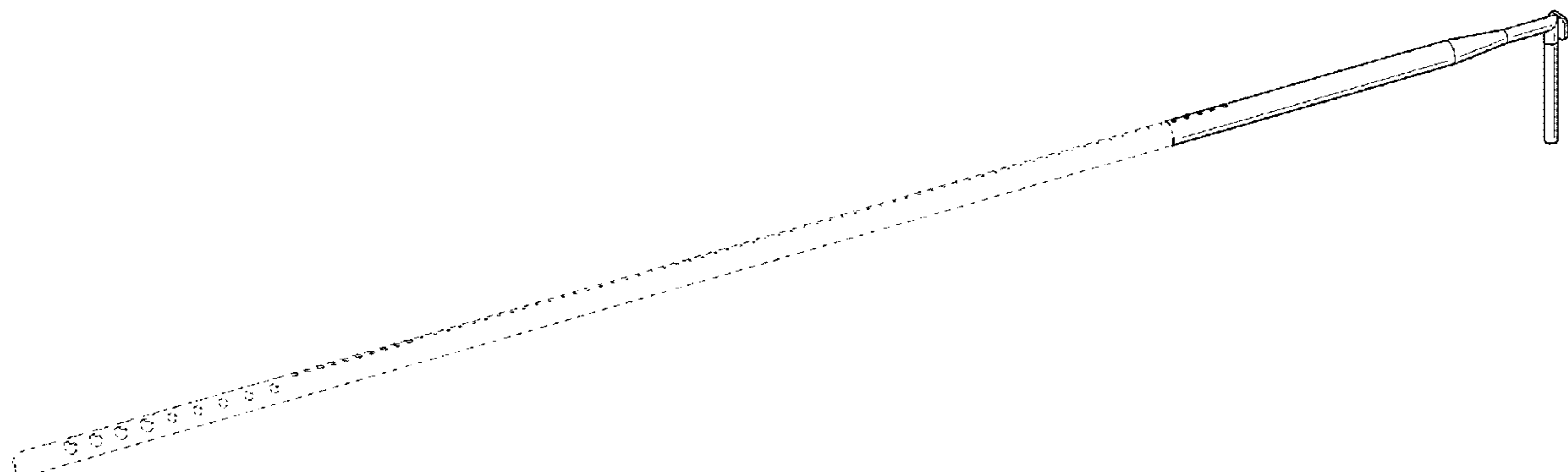
(57) **CLAIM**

We claim the ornamental design for a gas supply nozzle, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and left side perspective view of a gas supply nozzle showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and
FIG. 7 is a bottom plan view thereof.
FIG. 8 is an enlarged right side elevational view of FIG. 5 thereof;
FIG. 9 is an enlarged portion view take long line 9-9 in FIG. 2 thereof;
FIG. 10 is an enlarged portion view take long line 10-10 in FIG. 2 thereof; and,
FIG. 11 is a cross-sectional view taken along lines 11-11 in FIG. 10.
The dashed-dot-dashed lines represent the boundary lines of the claimed design.
The broken lines shown in the drawings represent portions of the gas supply nozzle that form no part of the claimed design.

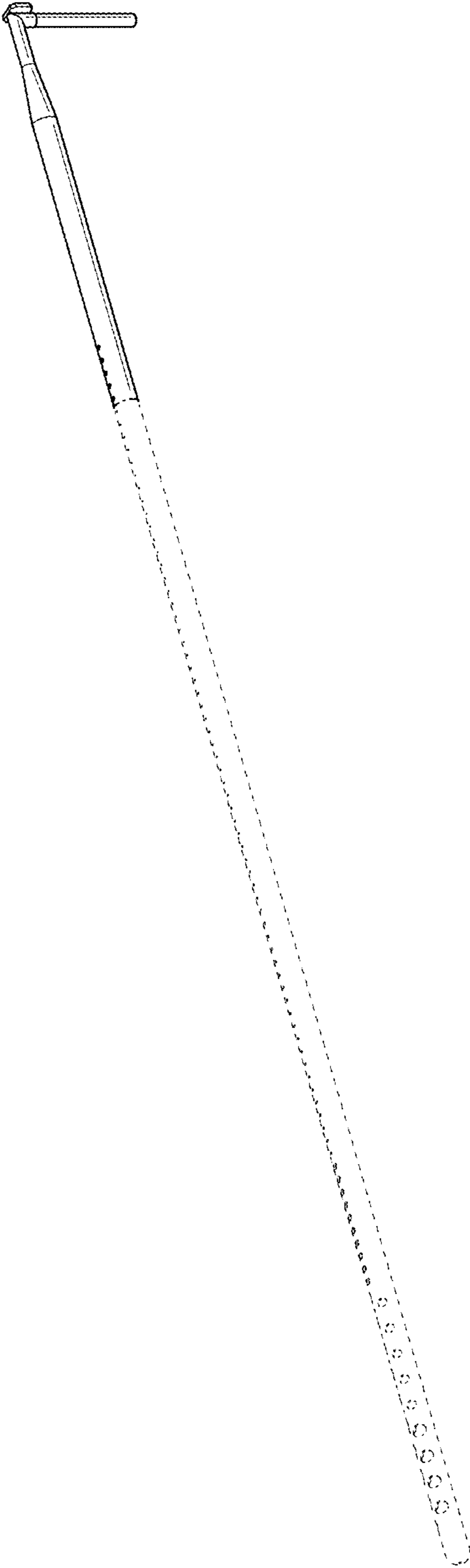

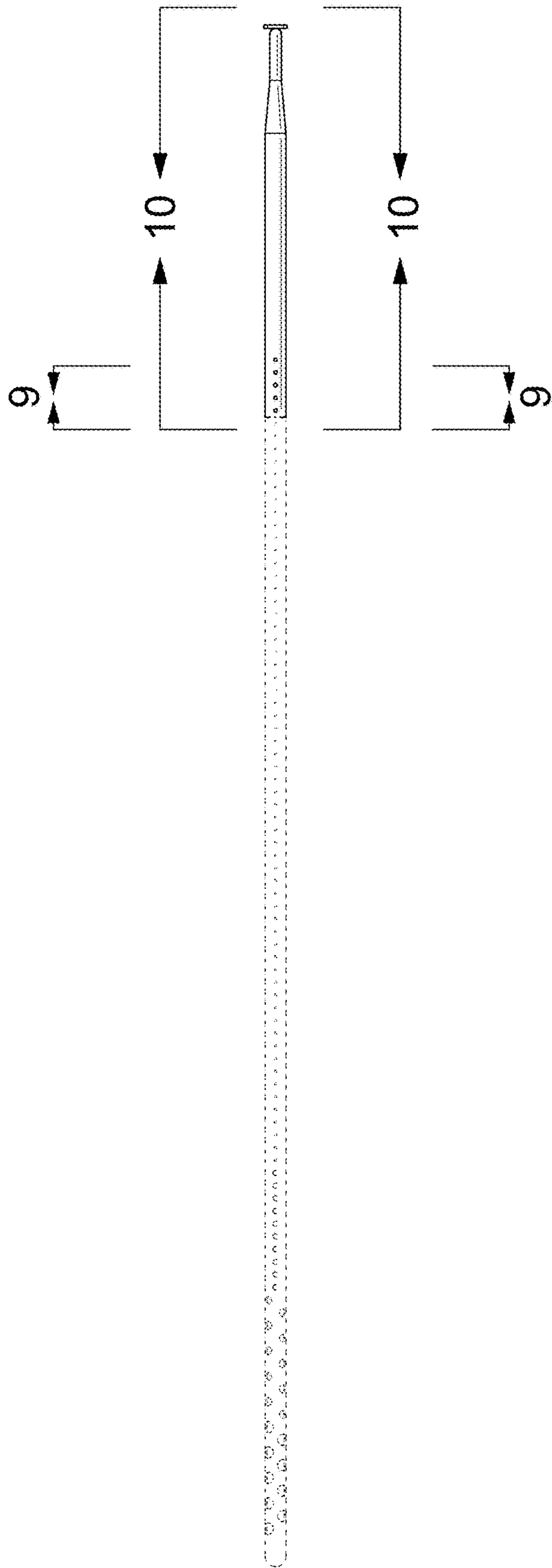

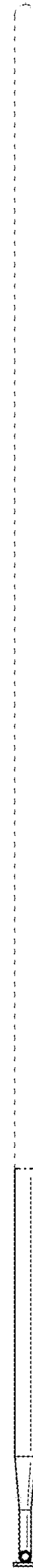

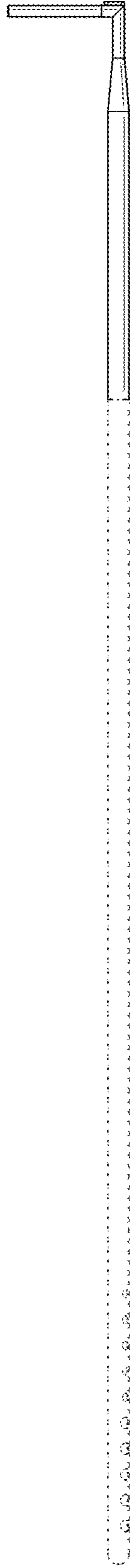

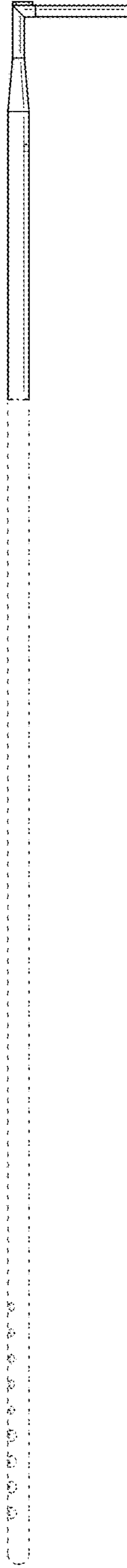

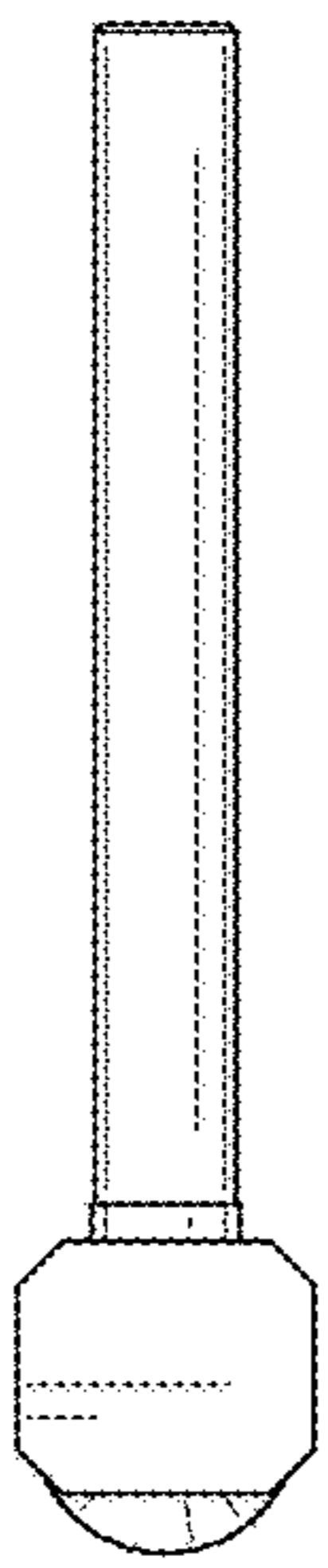

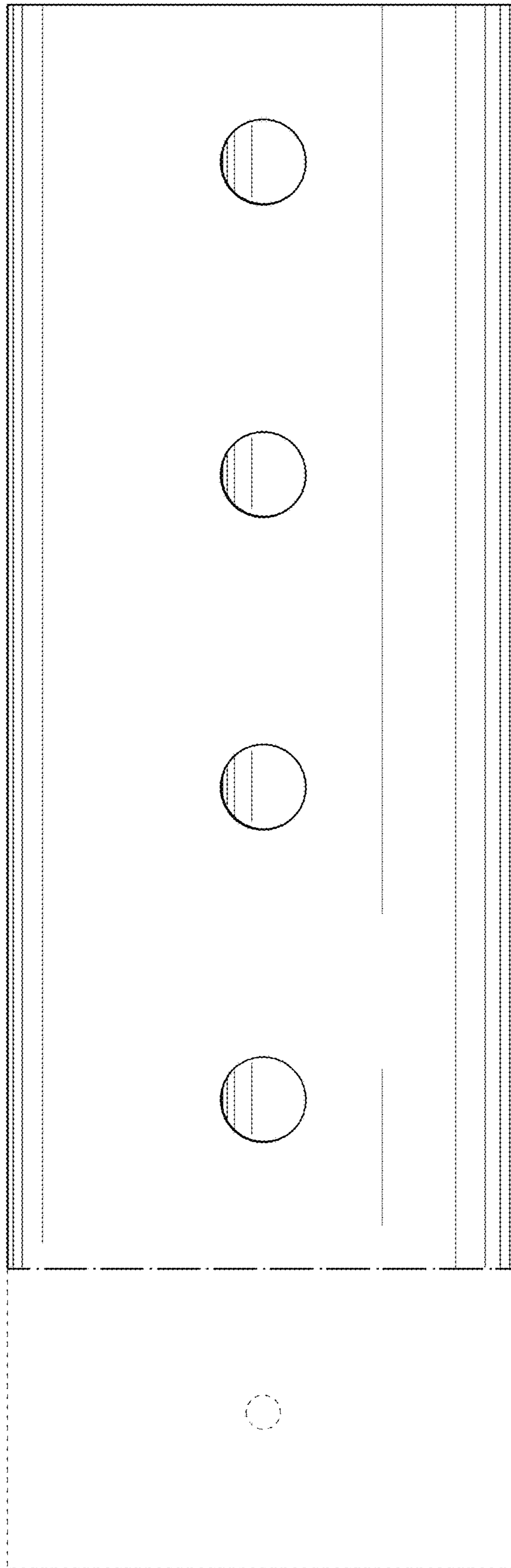

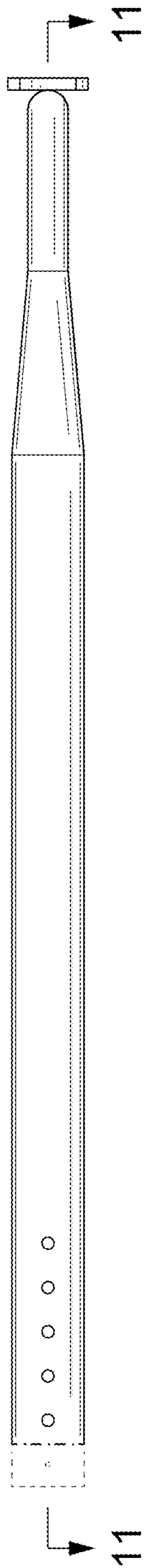

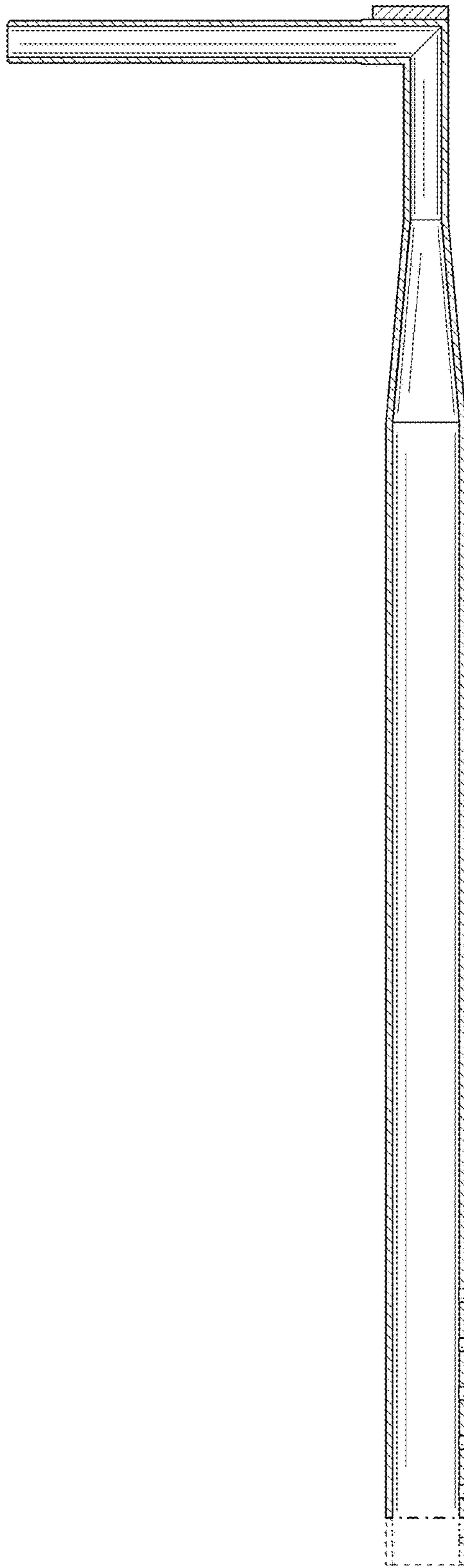
