(57) **CLAIM**
The ornamental design for a bowl, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top view from a side of a first embodiment of the bowl of our new design, showing a portion of an edge of the bowl being disclaimed in dashed lines;

FIG. 2 is a top view of the bowl as shown in FIG. 1, showing the portion of the edge of the bowl being disclaimed in dashed lines;

FIG. 3 is a bottom view of the bowl as shown in FIG. 1, showing the portion of the edge of the bowl and a ridge provided on a base of the bowl being disclaimed in dashed lines;

FIG. 4 is a side view from the left of the bowl as shown in FIG. 1, showing the portion of the edge of the bowl and the ridge provided on the base of the bowl being disclaimed in dashed lines;

FIG. 5 is a side view from the right of the bowl as shown in FIG. 1, showing the portion of the edge of the bowl and the ridge provided on the base of the Bowl being disclaimed in dashed lines;

FIG. 6 is a front view of the bowl as shown in FIG. 1, showing the portion of the edge of the Bowl and the ridge provided on the base of the bowl being disclaimed in dashed lines;

FIG. 7 is a rear view of the bowl as shown in FIG. 1, showing the portion of the edge of the bowl and the ridge provided on the base of the bowl being disclaimed in dashed lines;

FIG. 8 is a perspective top view from a side of a second embodiment of the bowl of our new design;

FIG. 9 is a top view of the bowl as shown in FIG. 8;

FIG. 10 is a bottom view of the bowl as shown in FIG. 8, showing a ridge provided on a base of the bowl being disclaimed in dashed lines;

FIG. 11 is a side view from the left of the bowl as shown in FIG. 8, showing the ridge provided on the base of the bowl being disclaimed in dashed lines;

FIG. 12 is a side view from the right of the bowl as shown in FIG. 8, showing the ridge provided on the base of the bowl being disclaimed in dashed lines;

FIG. 13 is a front view of the bowl as shown in FIG. 8, showing the ridge provided on the base of the bowl being disclaimed in dashed lines; and,

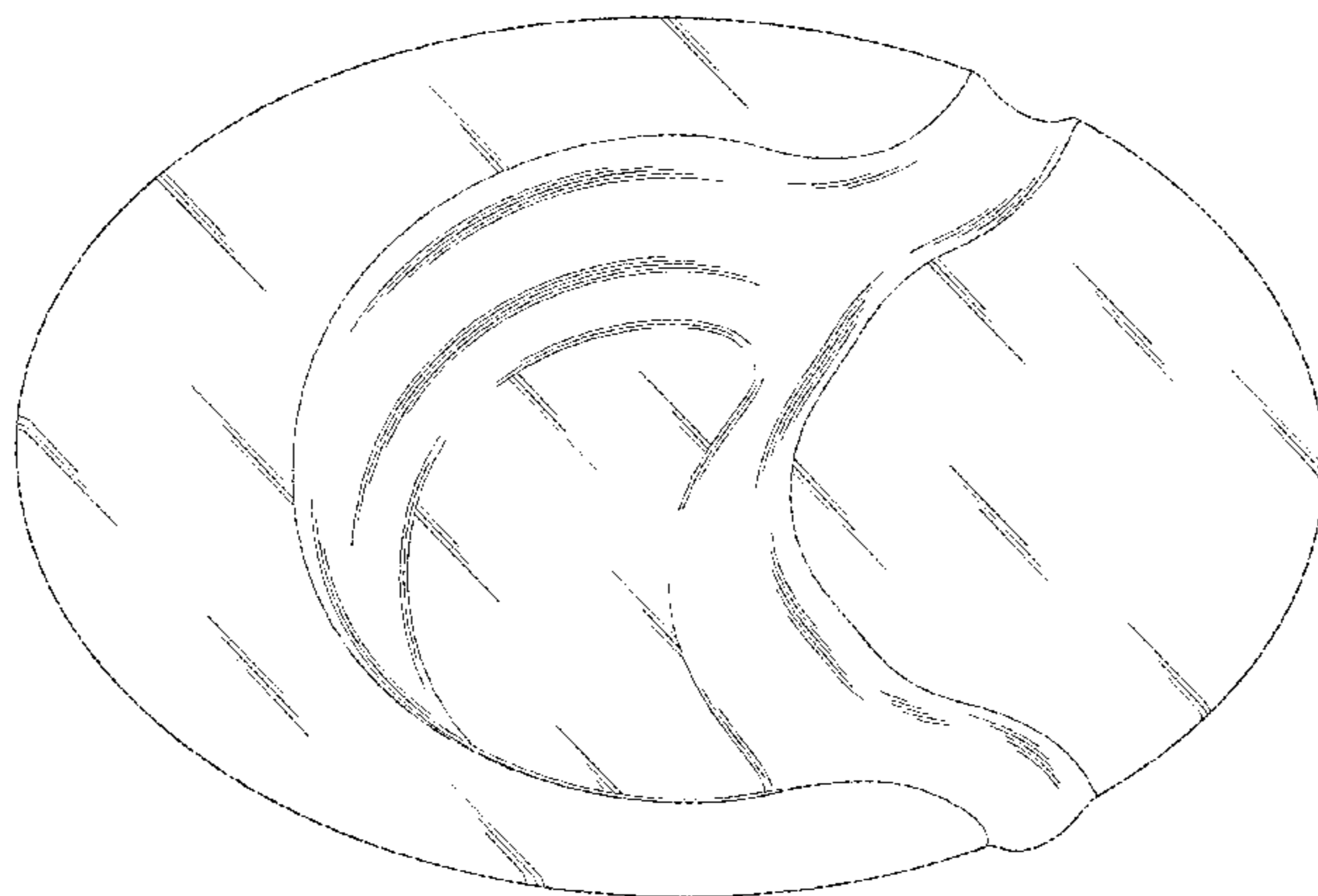


FIG. 14 is a rear view of the bowl as shown in FIG. 8, showing the base of the bowl being disclaimed in dashed lines;

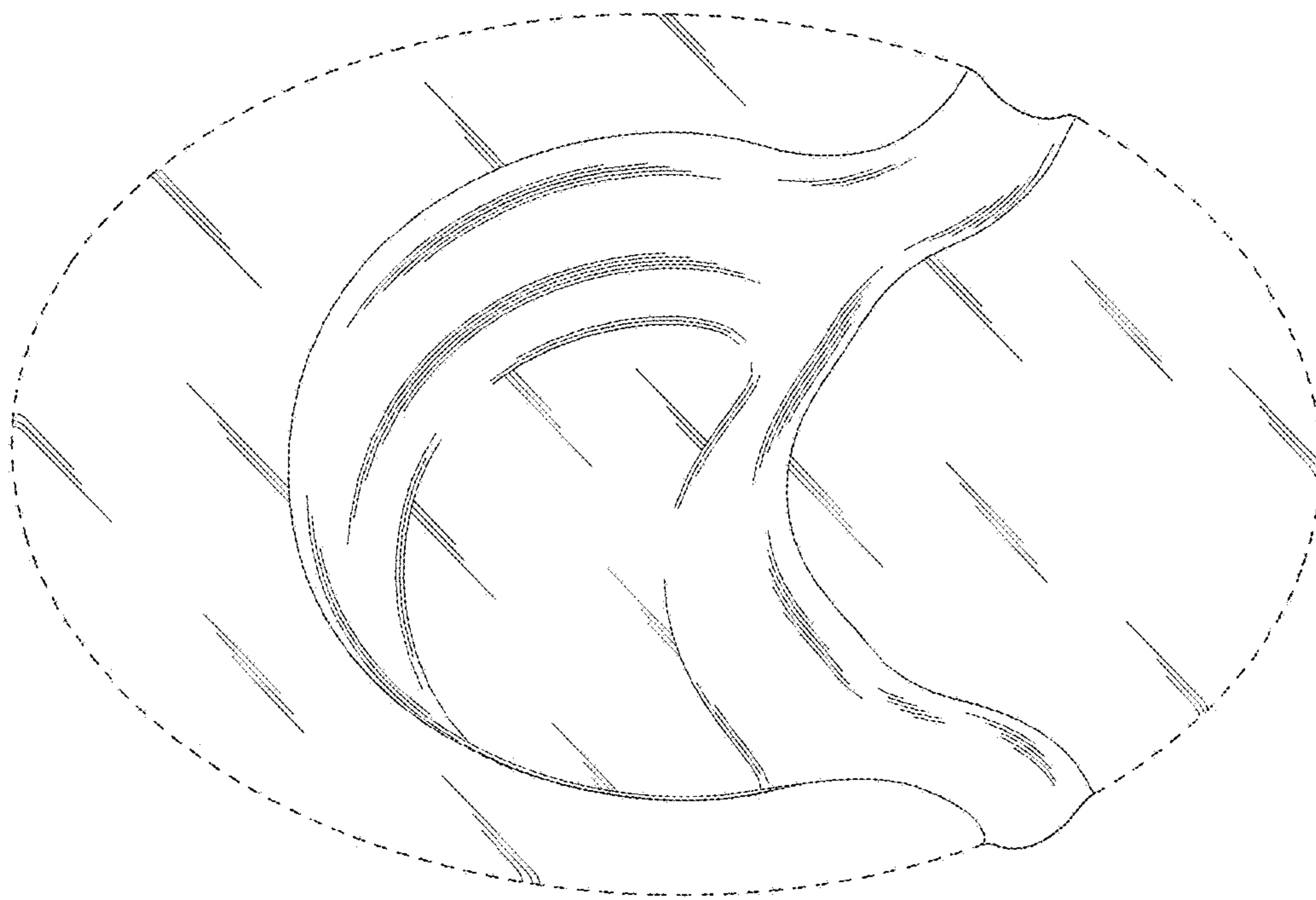

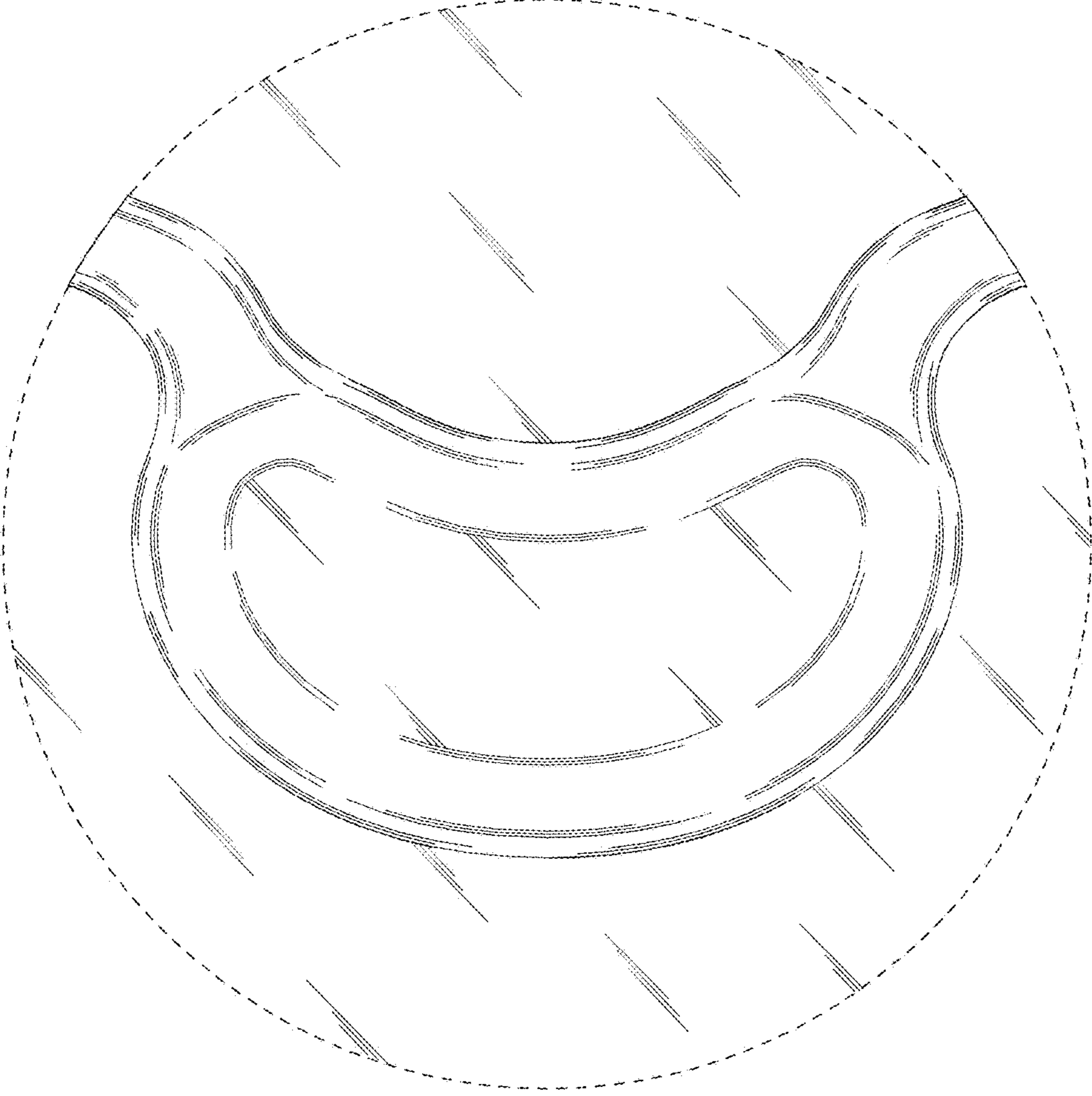

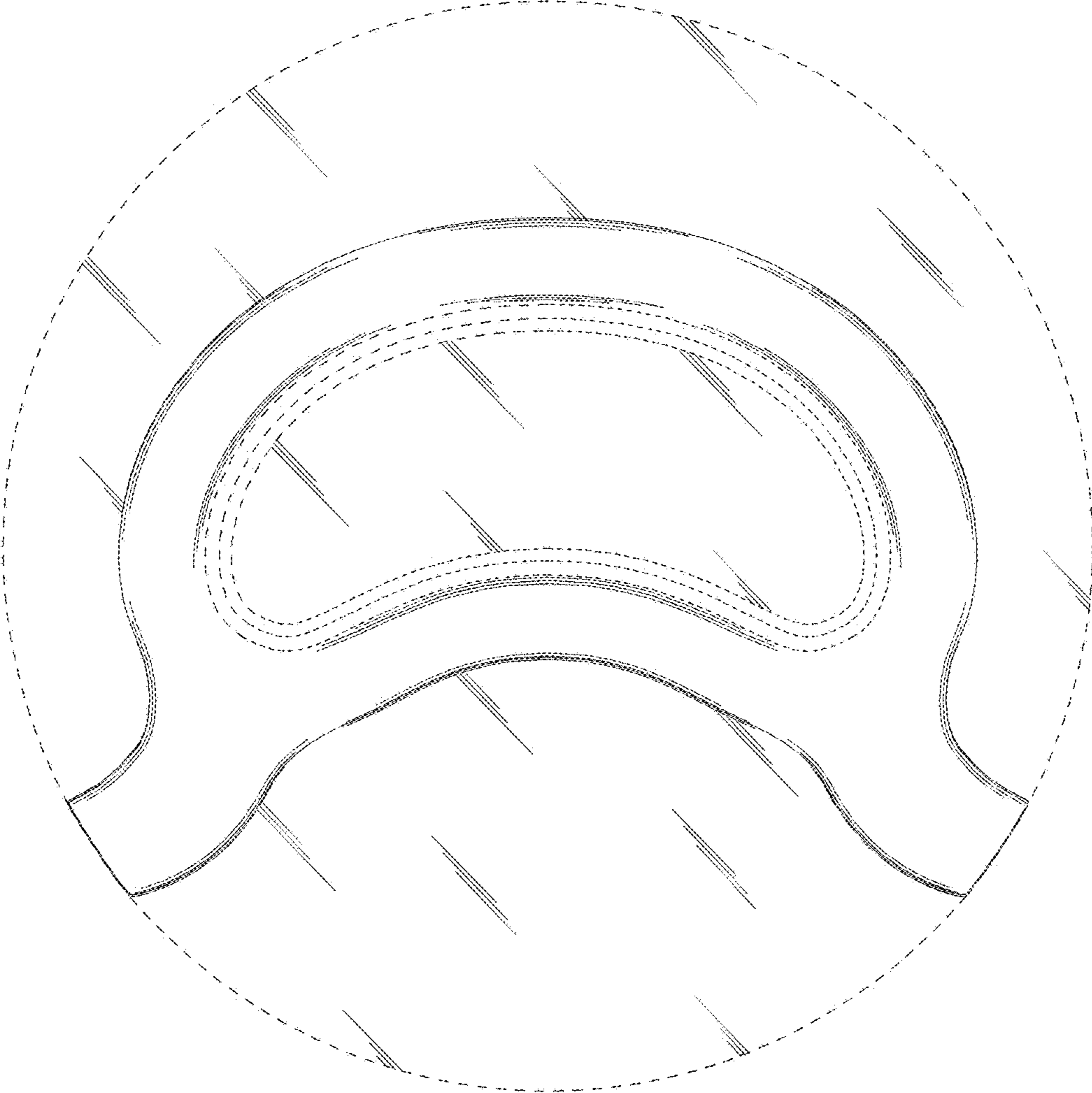

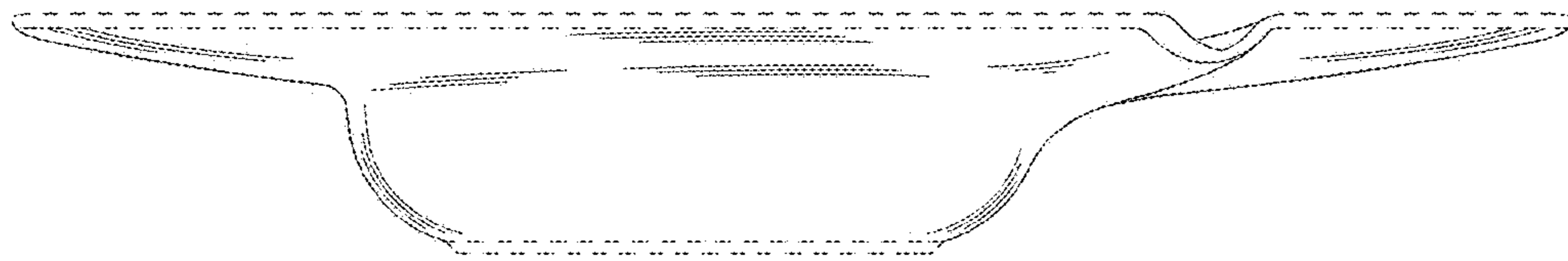

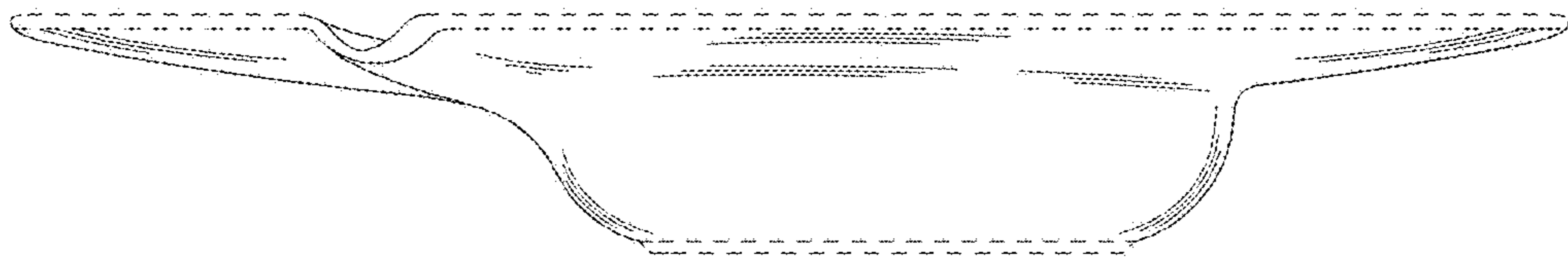

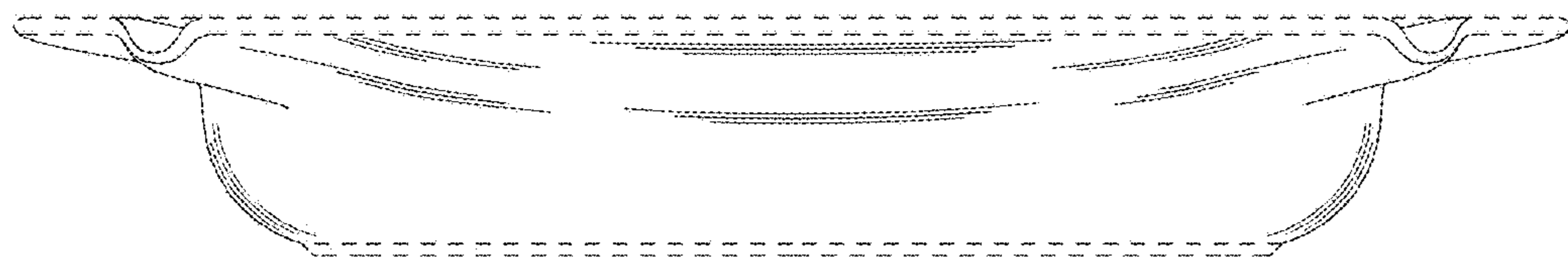

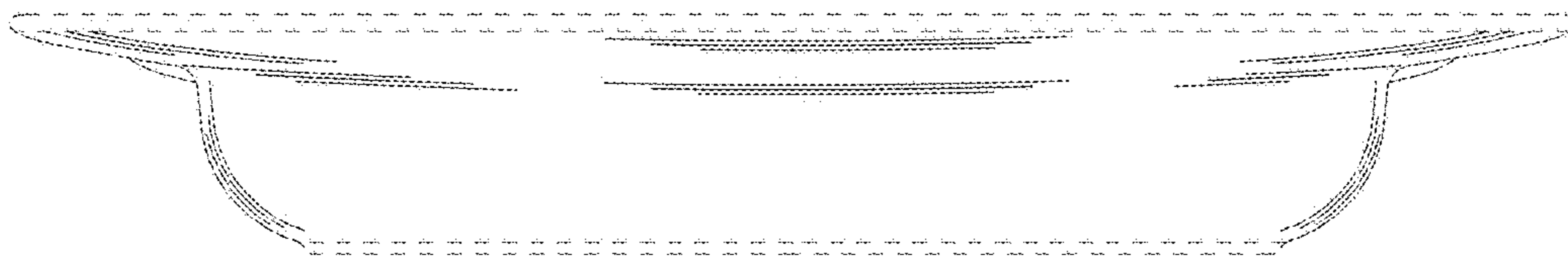

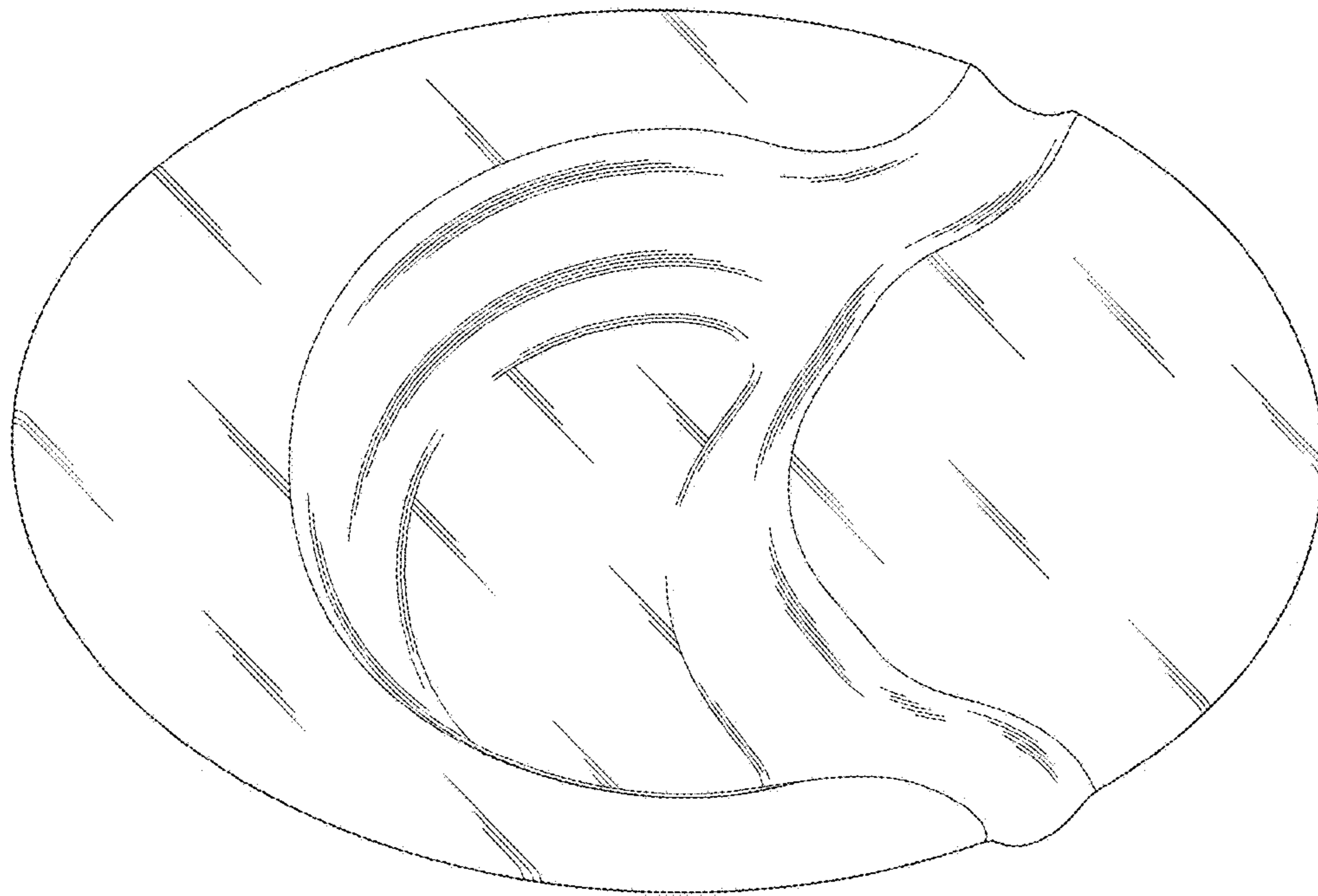

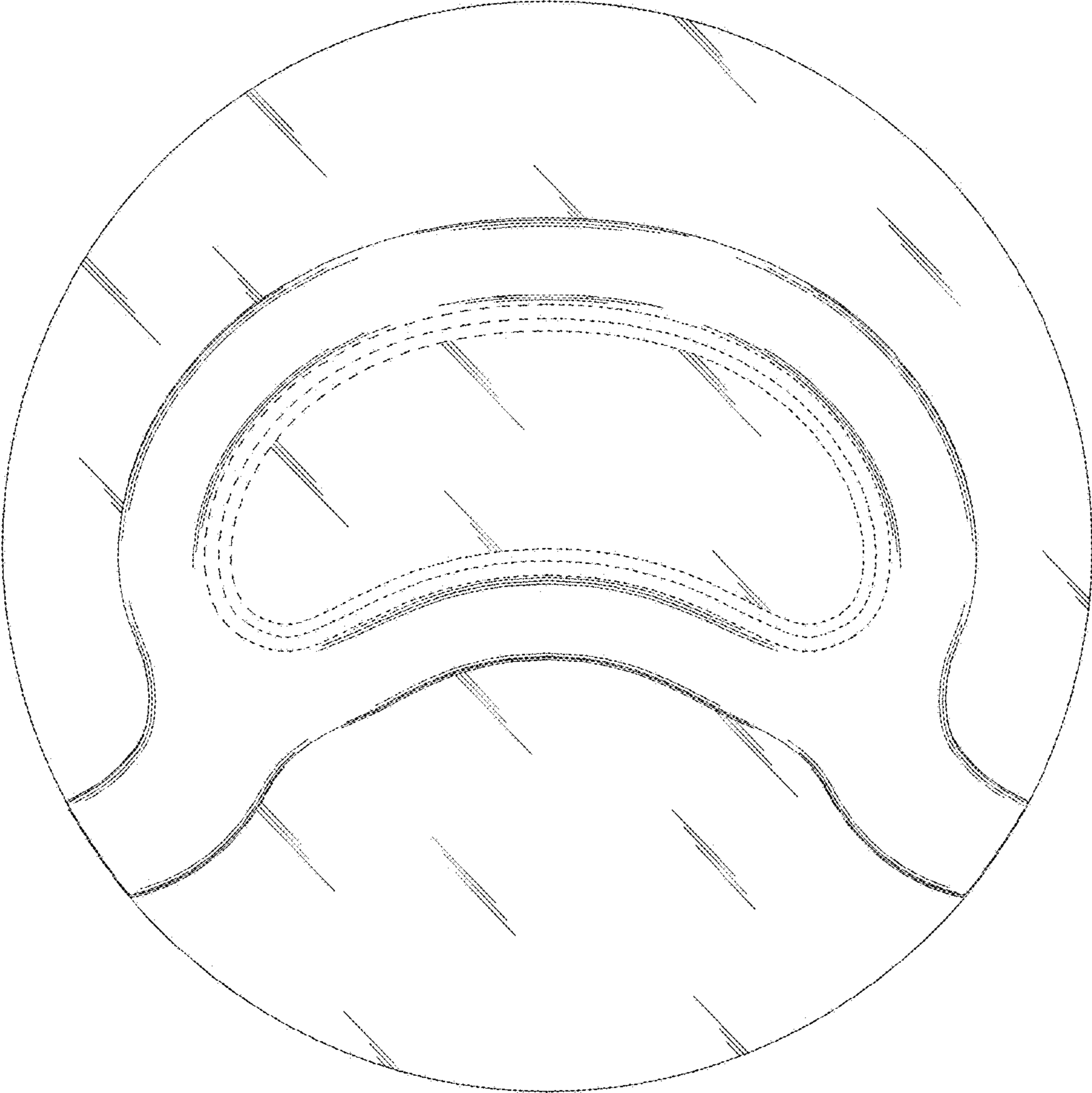

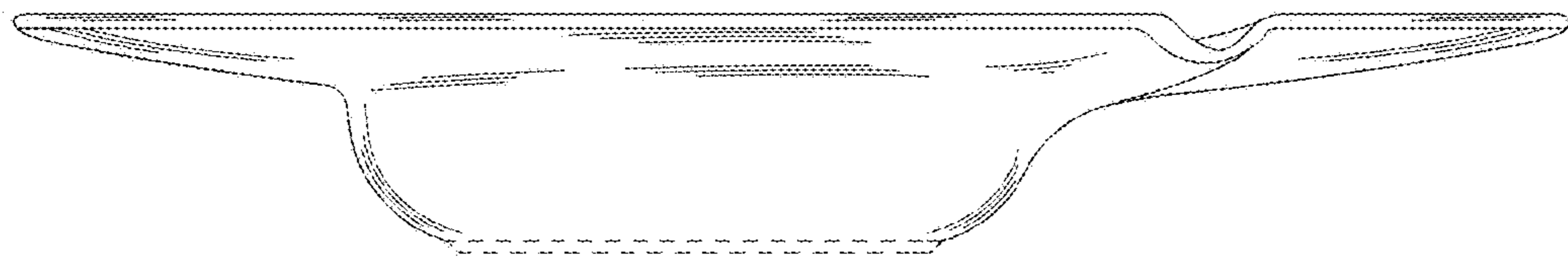

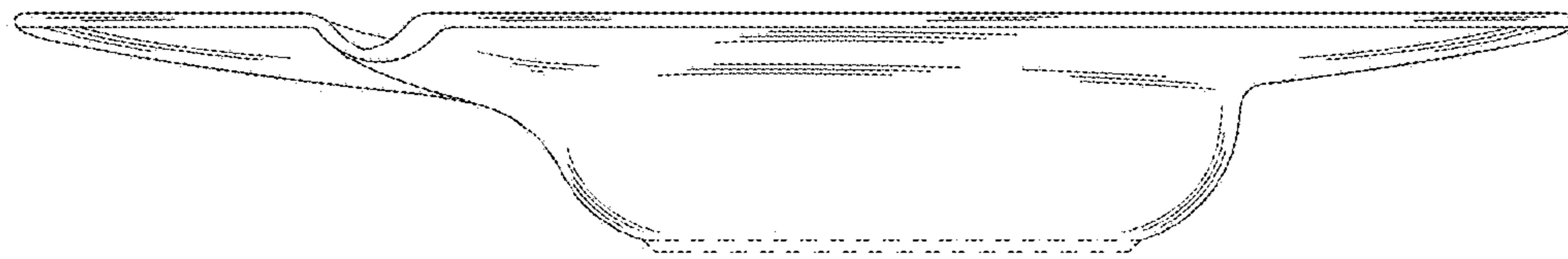

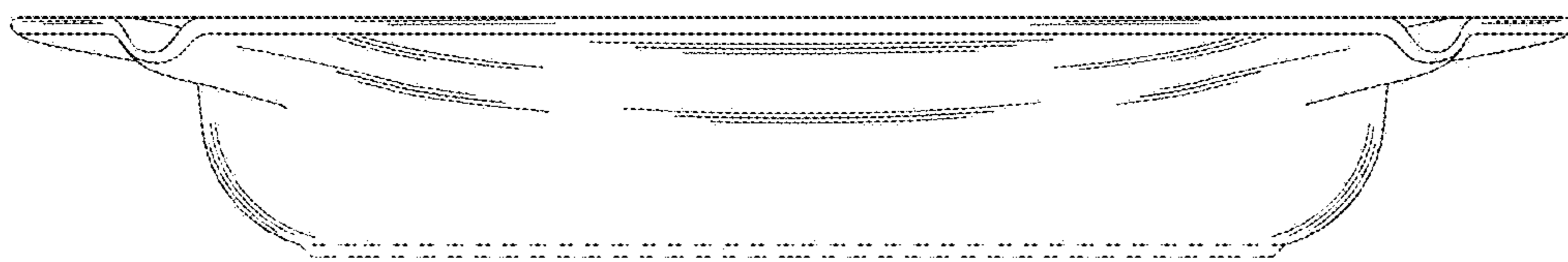

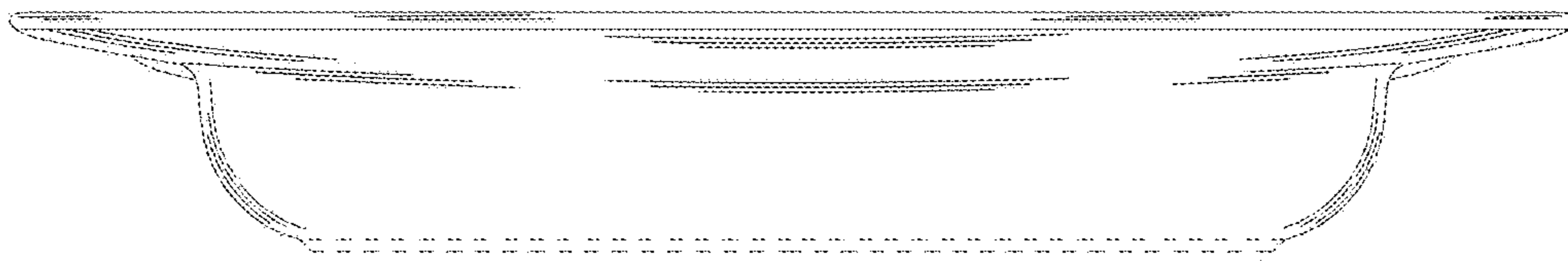
