The ornamental design for a food container with two compartments, as shown and described.

**DESCRIPTION**

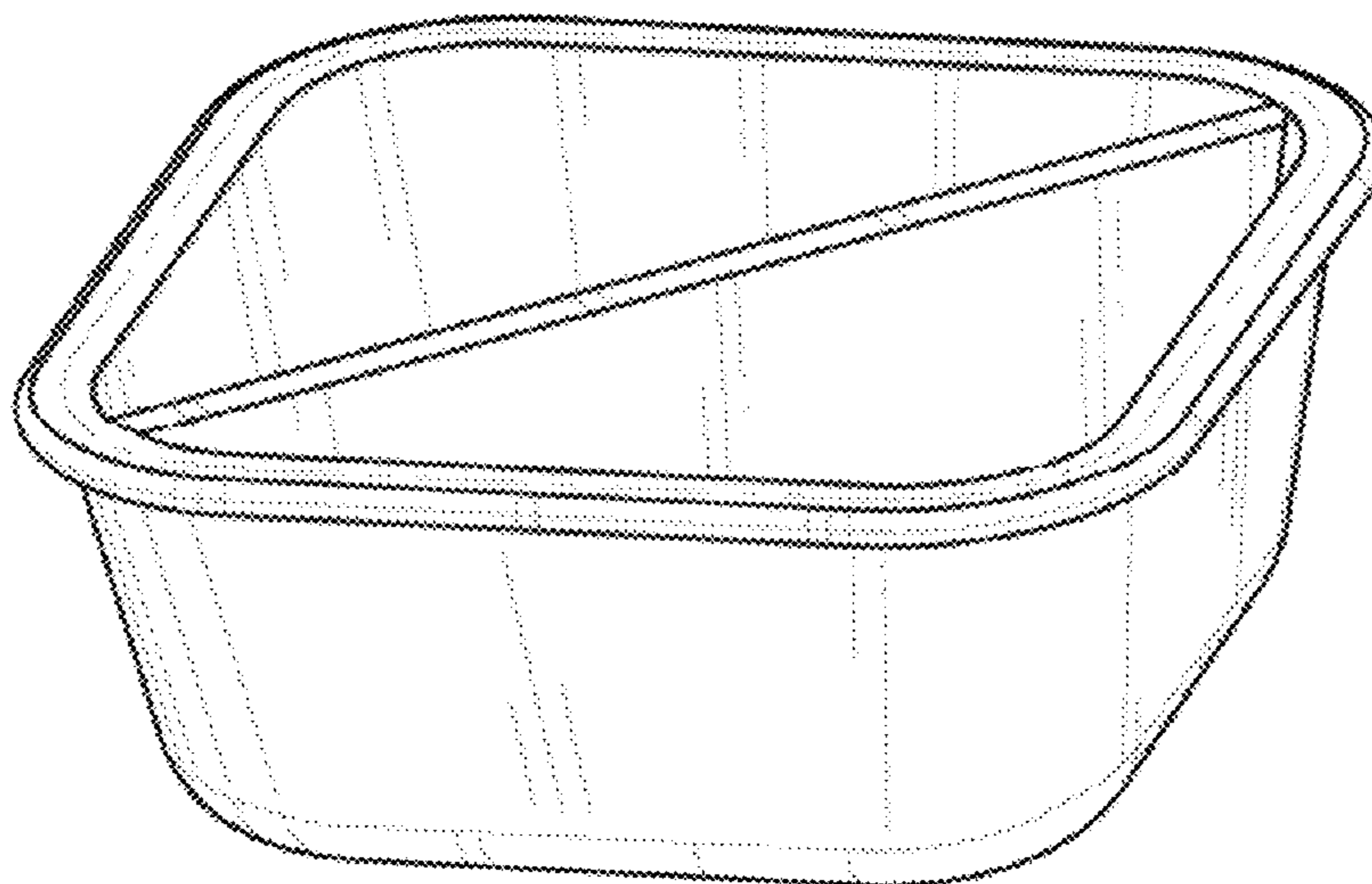
FIG. 1 is a top plan view of a food container with two components showing my new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a left side elevation view thereof;  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a front elevation view thereof;  
FIG. 6 is a rear elevation view thereof; and,  
FIG. 7 is a top, front perspective view thereof.  
The narrow rectangles bound by three broken lines and a solid line in FIG. 2 are features of the food container with two compartments that form no part of the claimed design.

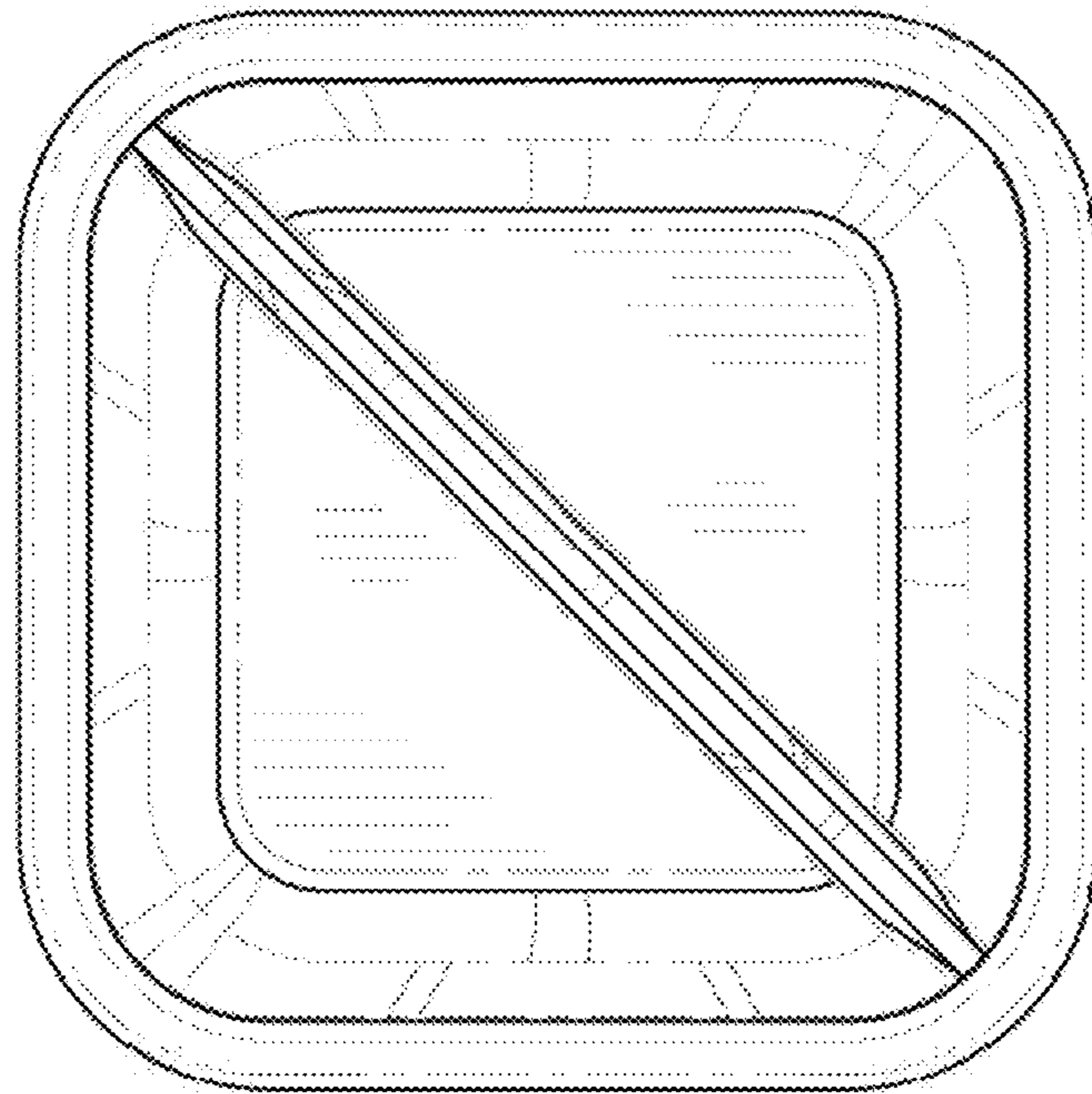

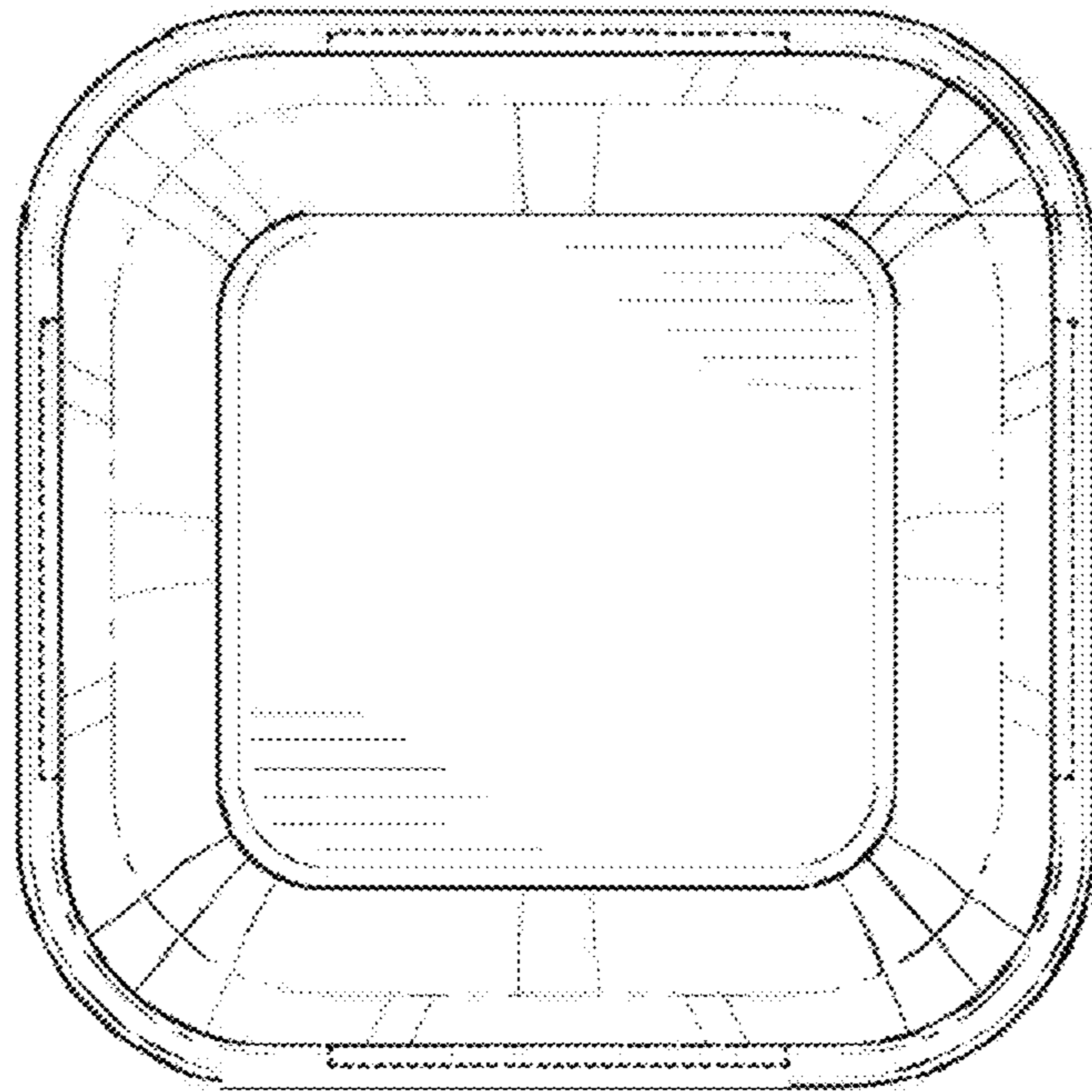

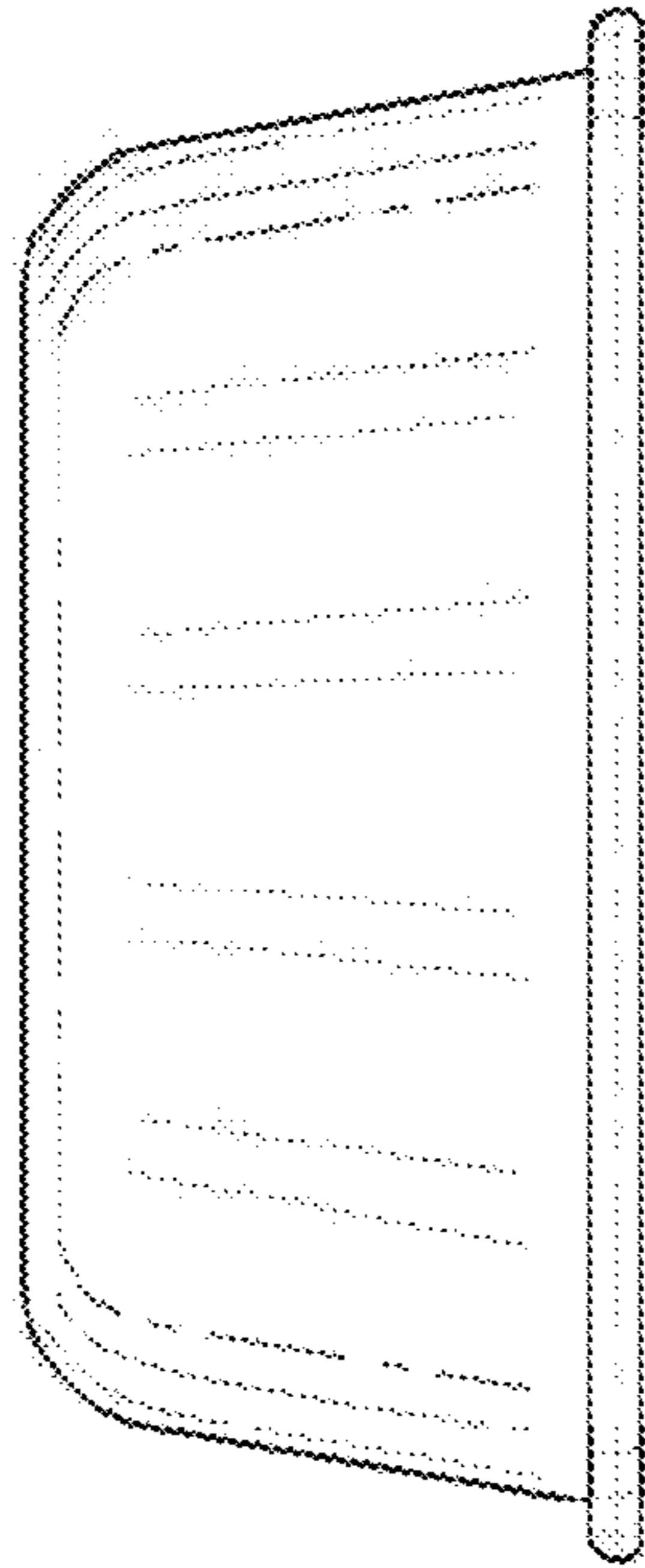

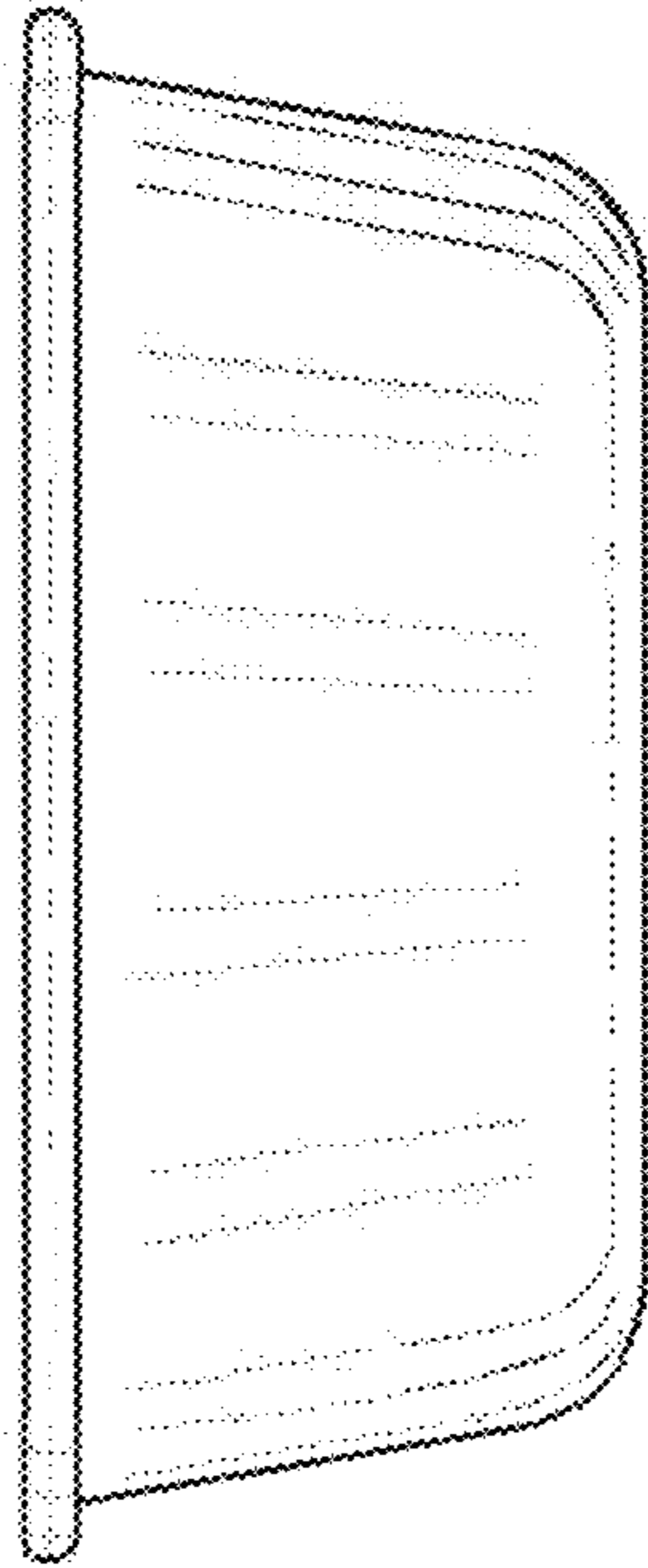

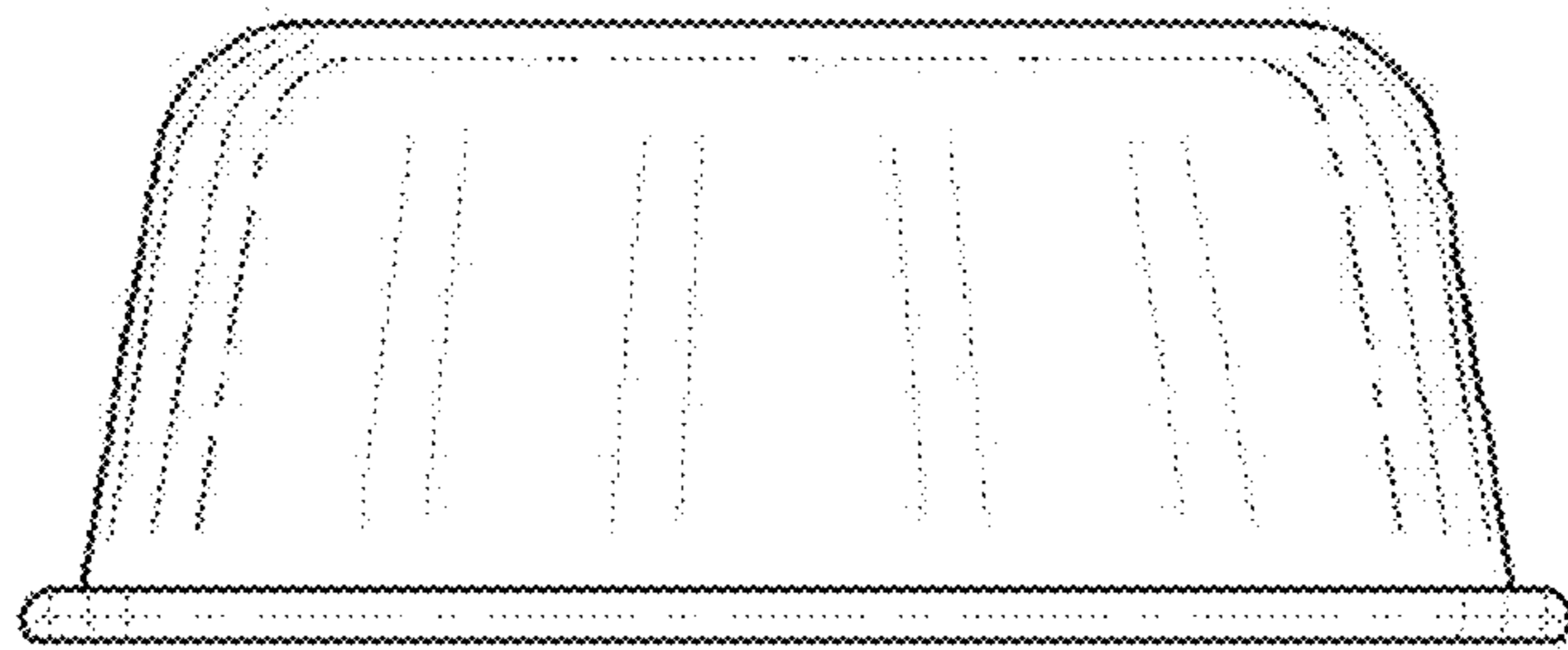

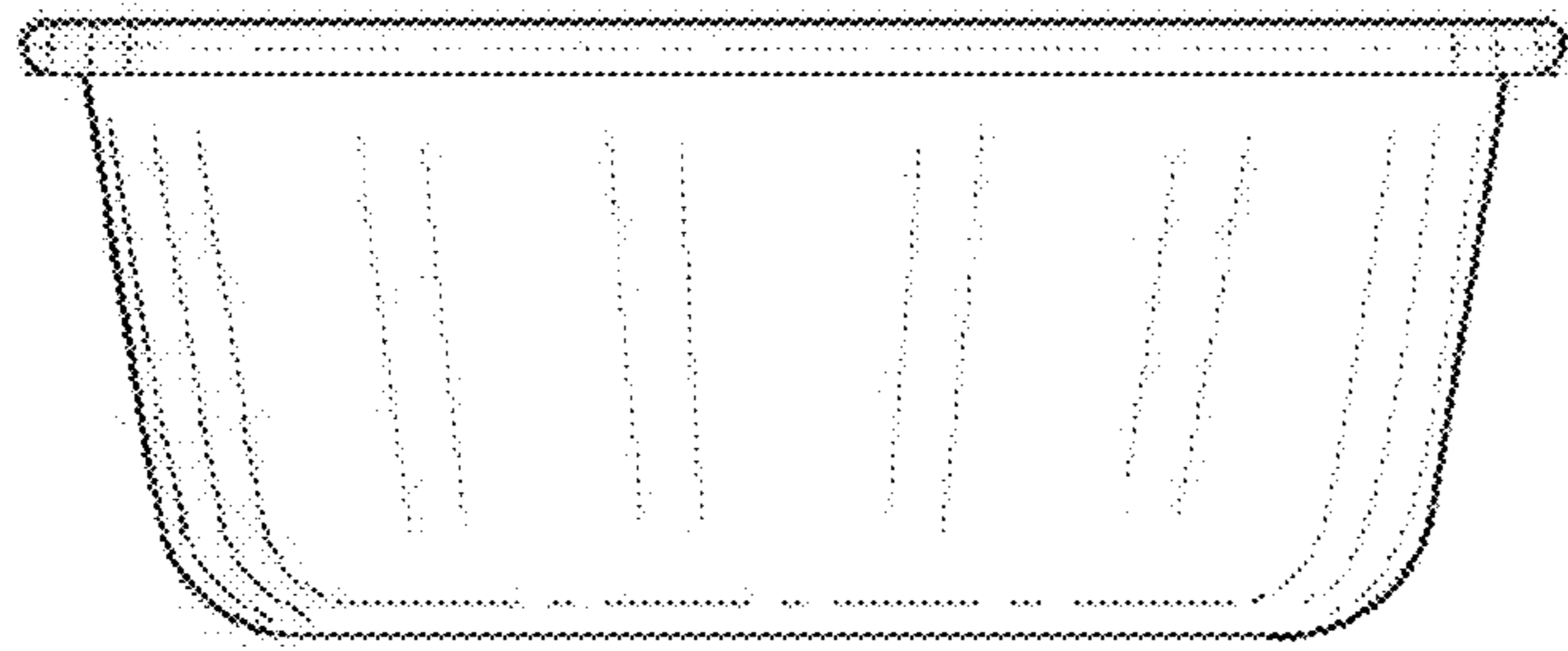

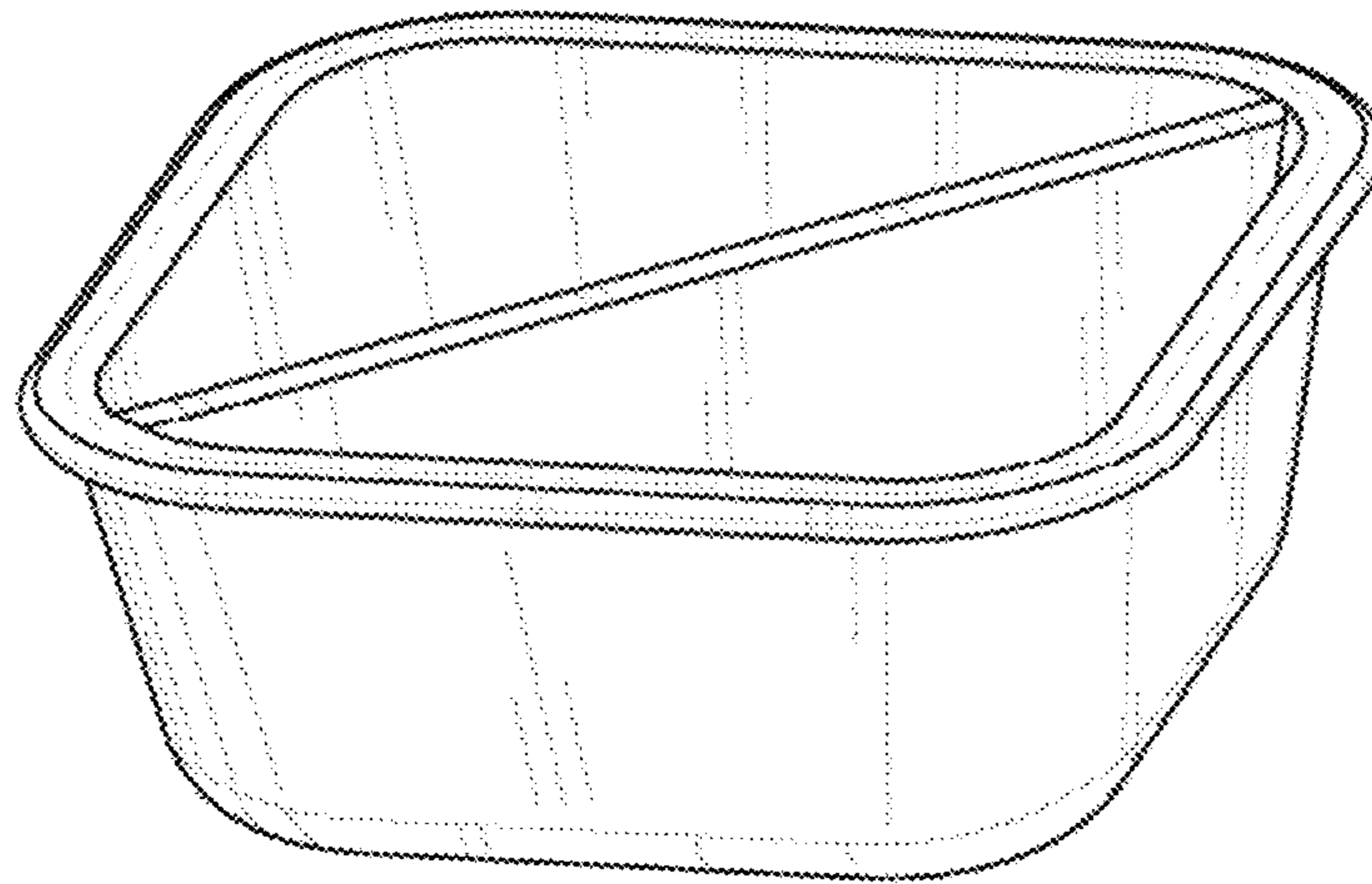
