DESCRIPTION

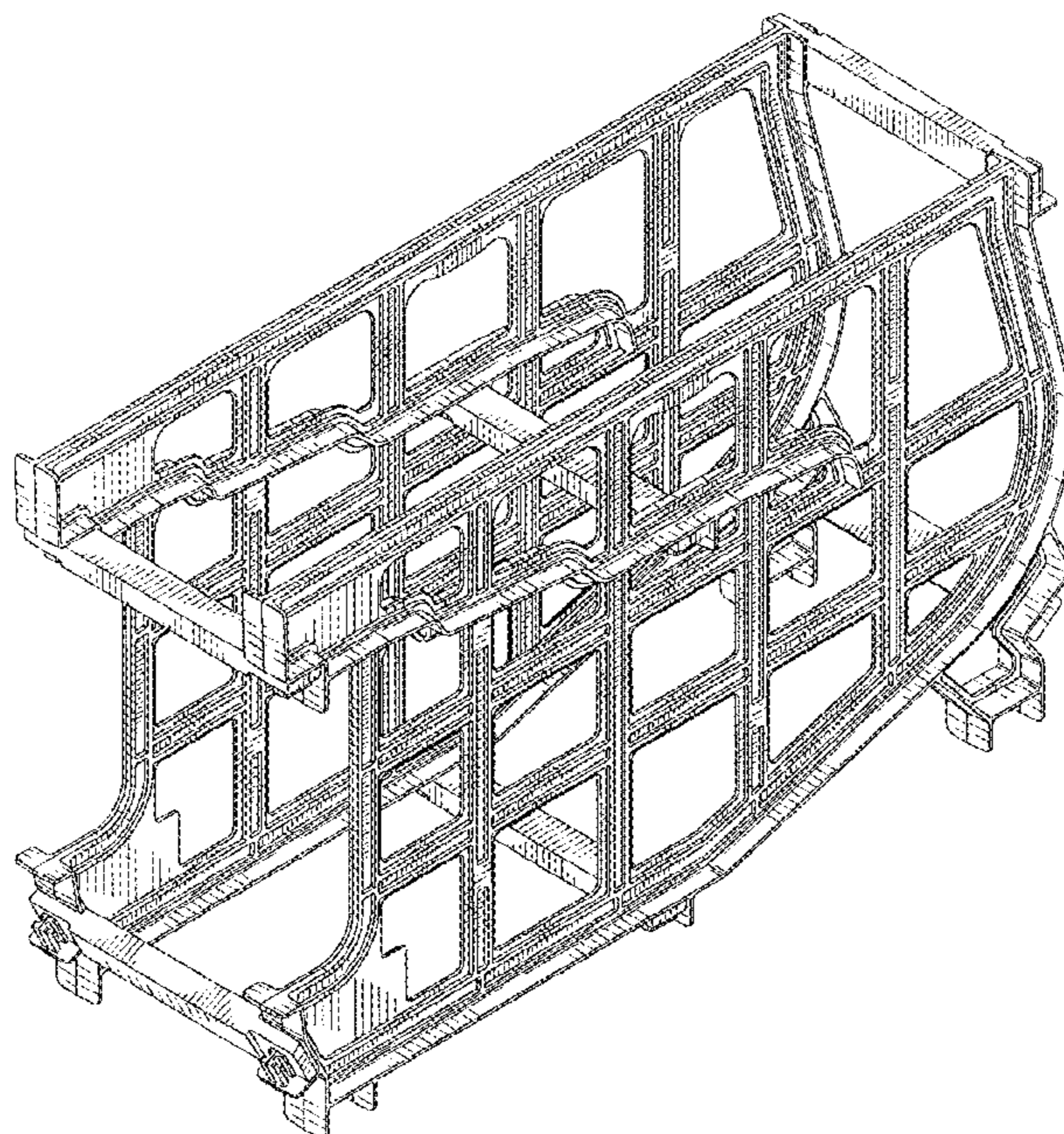

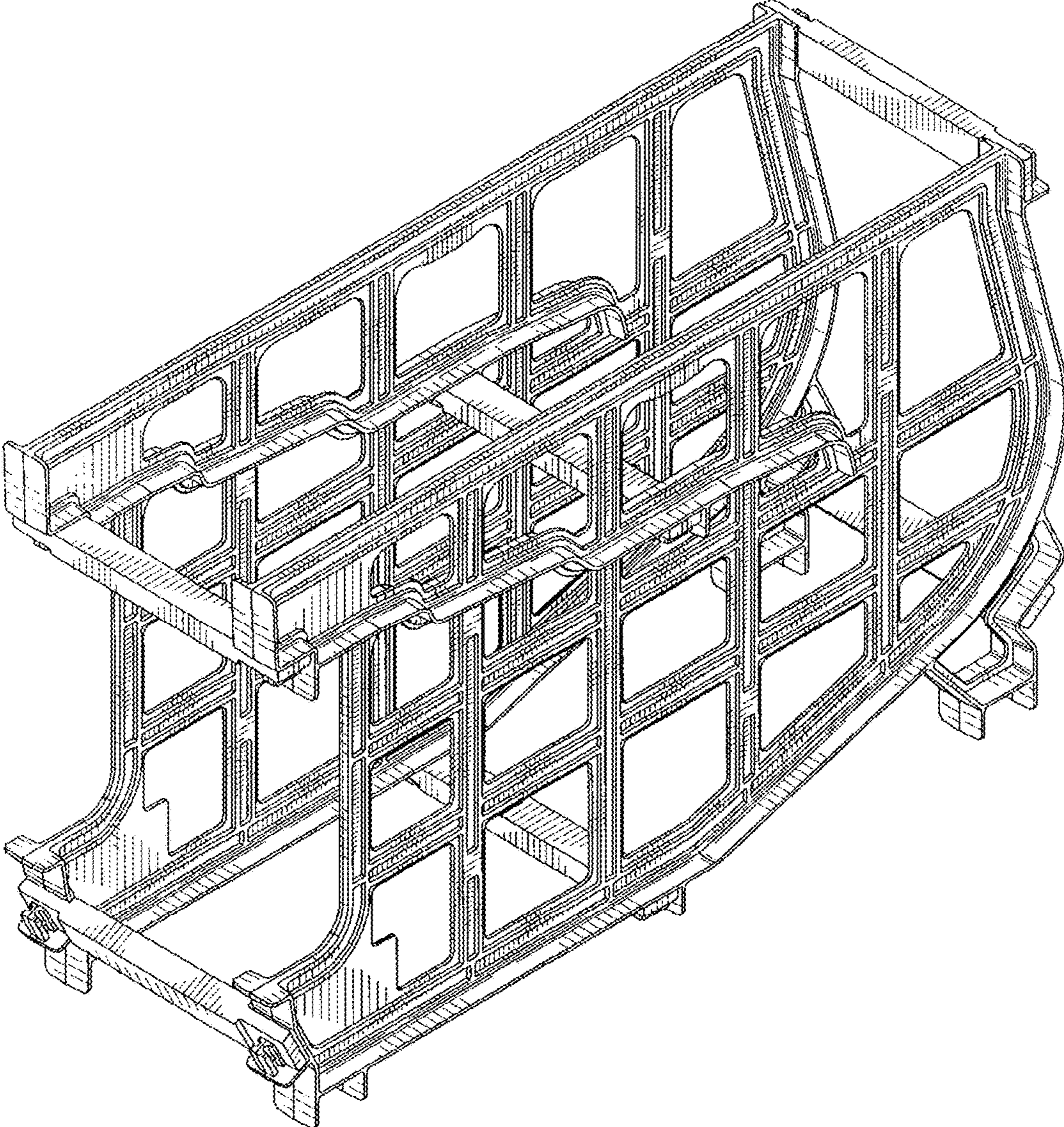

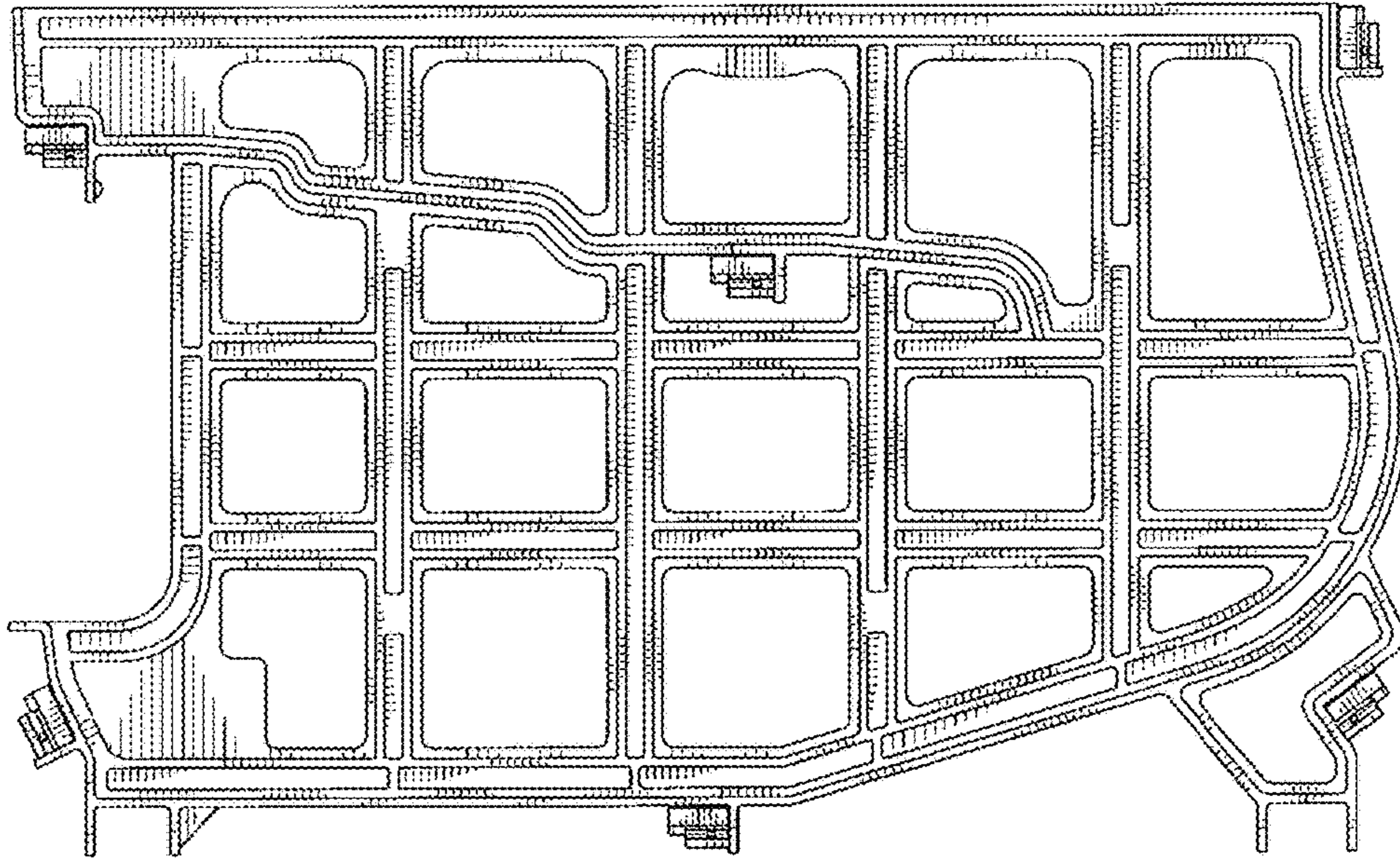

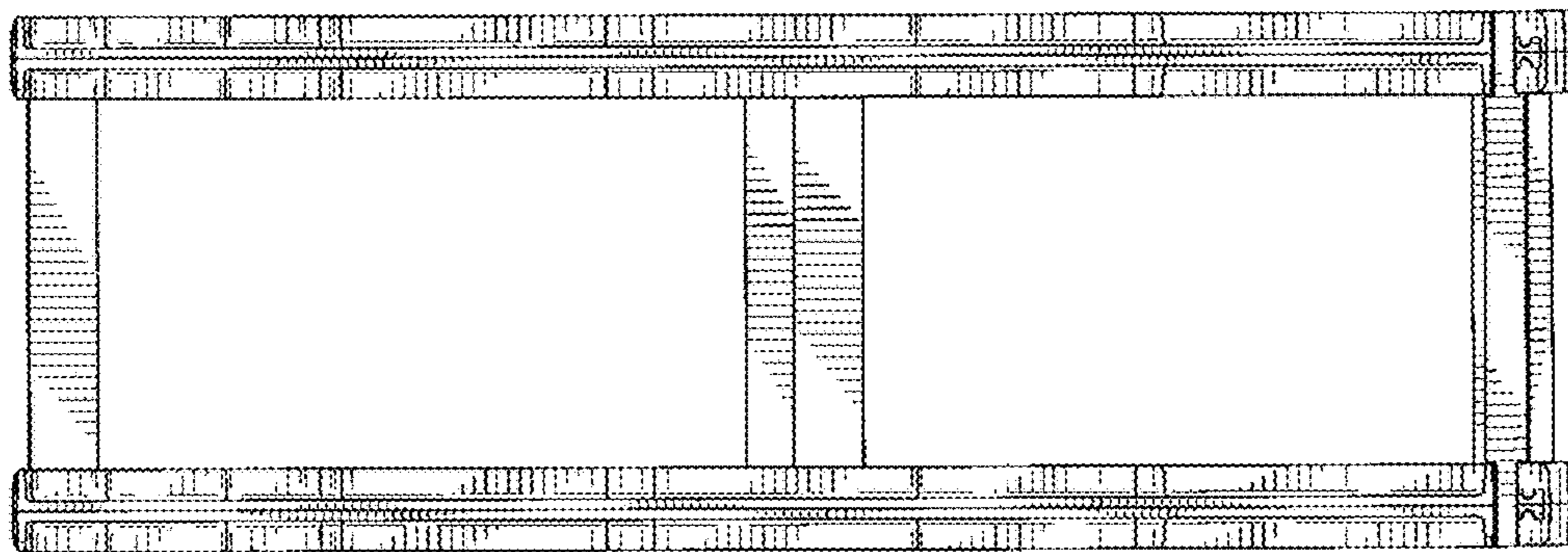

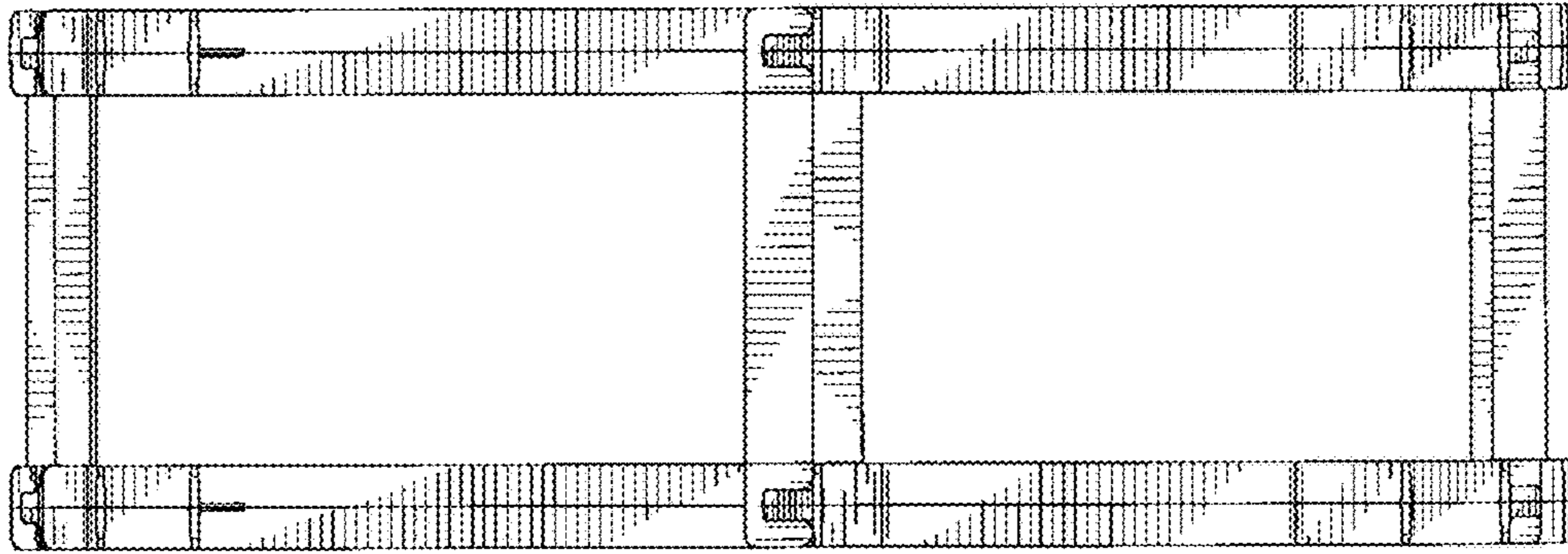

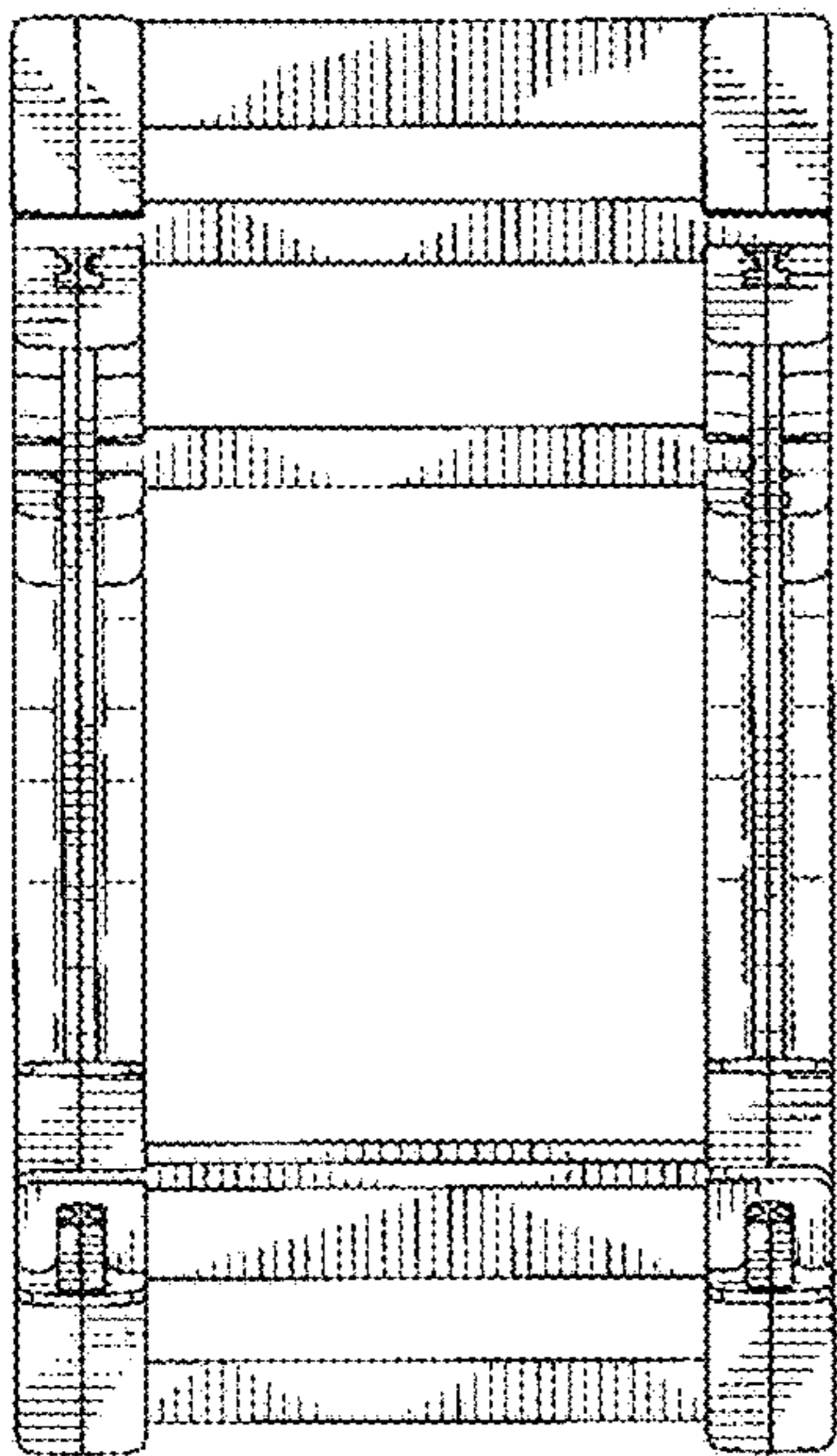

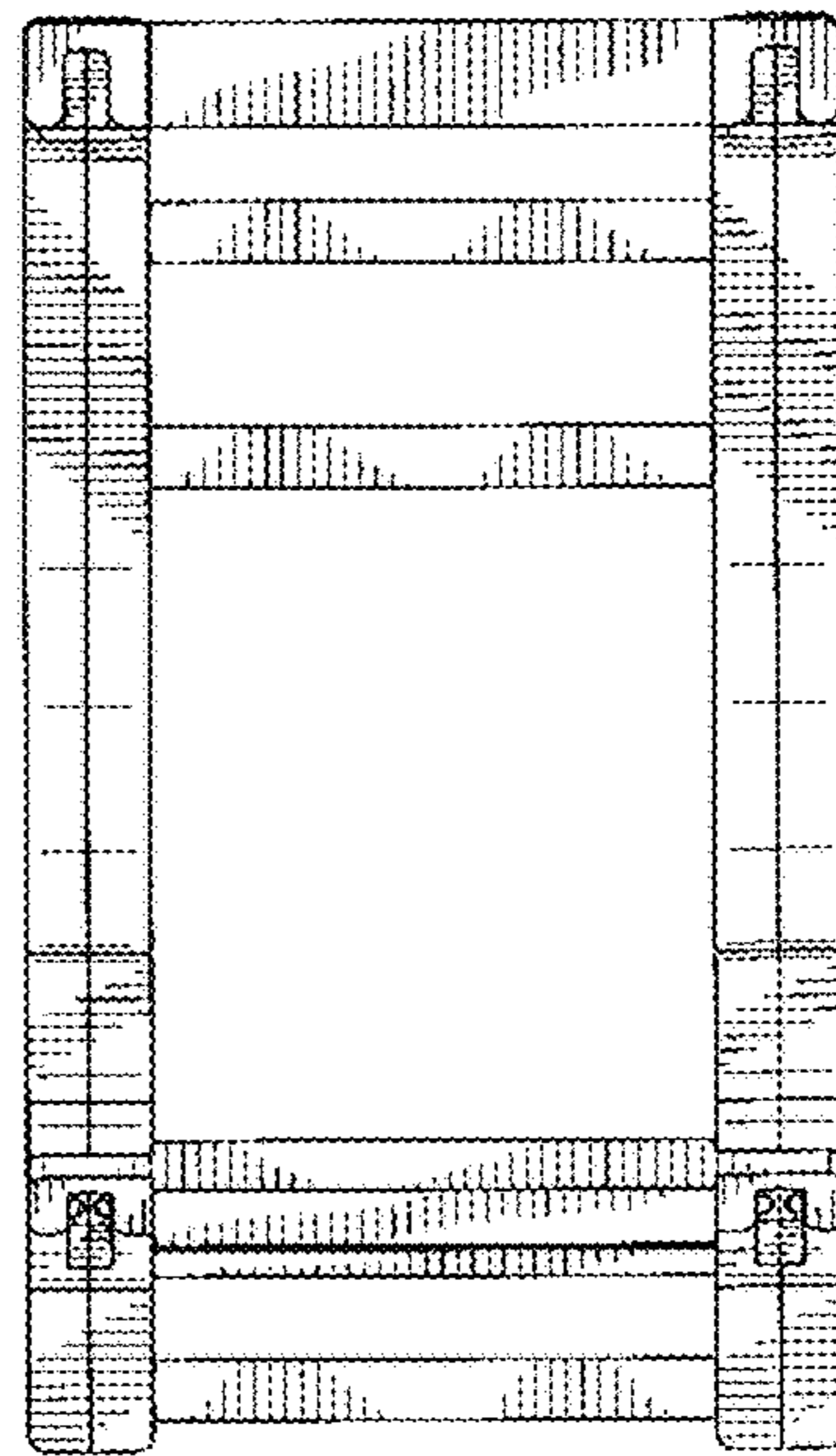

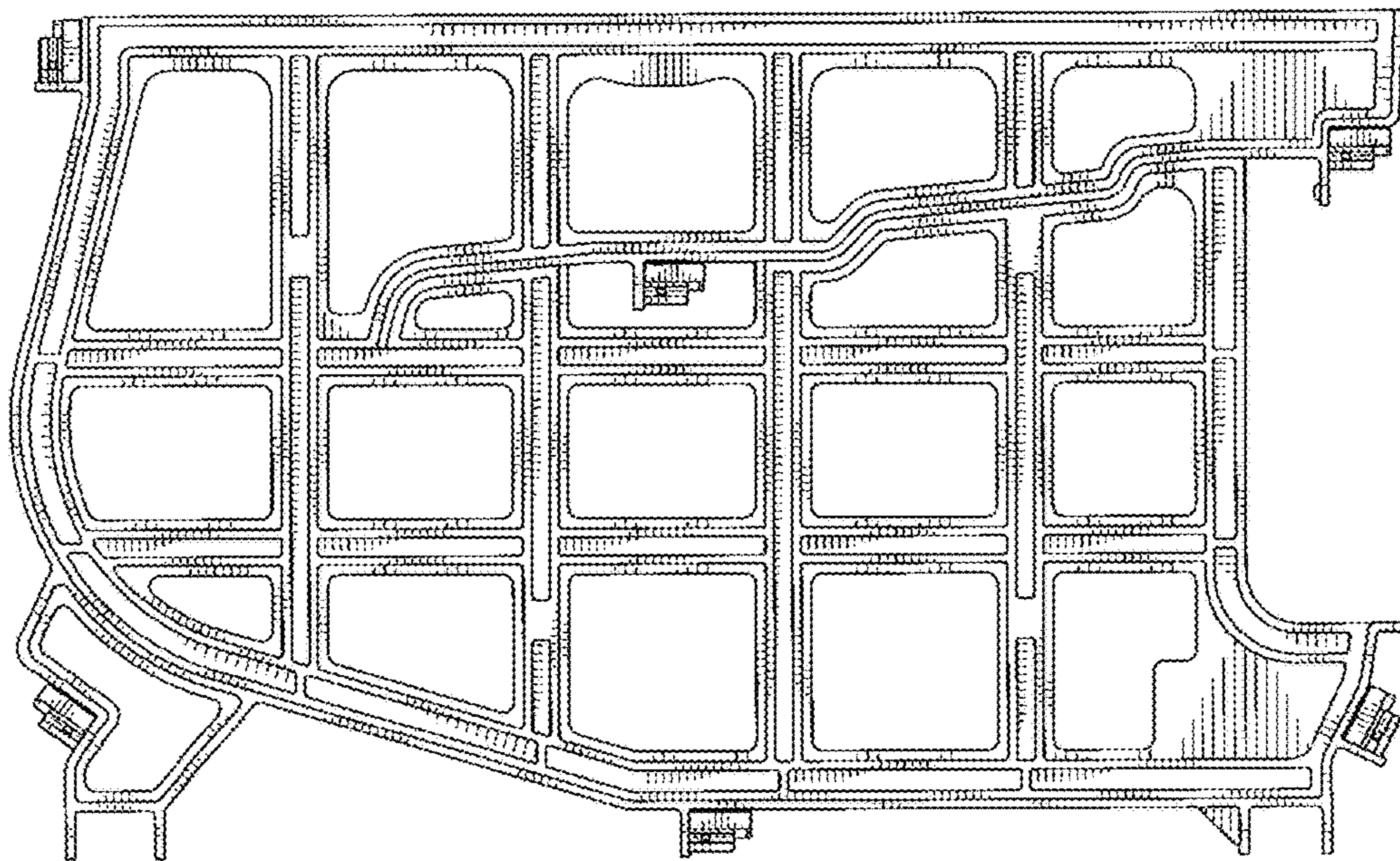

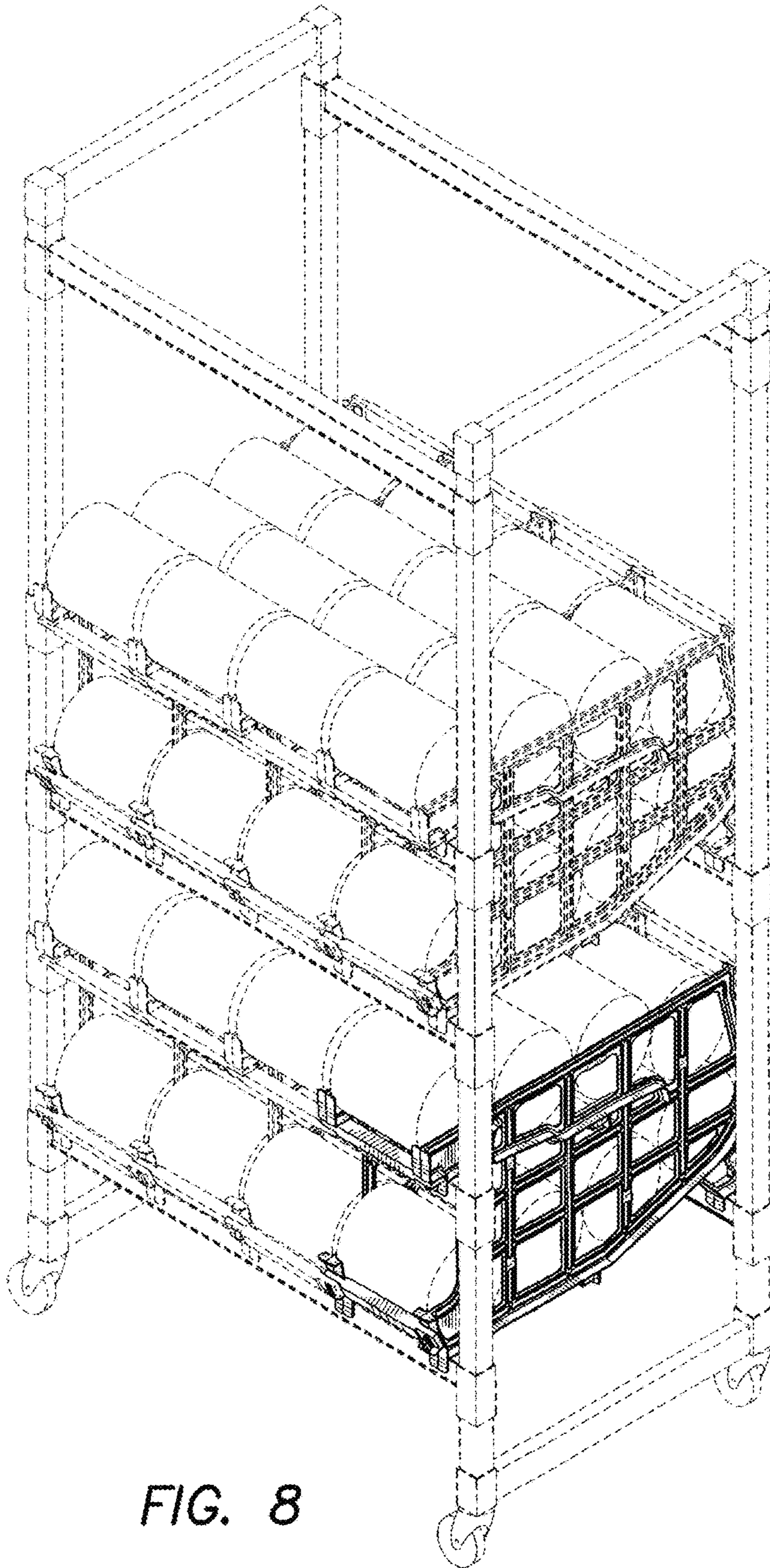
