FIG. 1 is a front perspective view of a bracelet showing my new design.

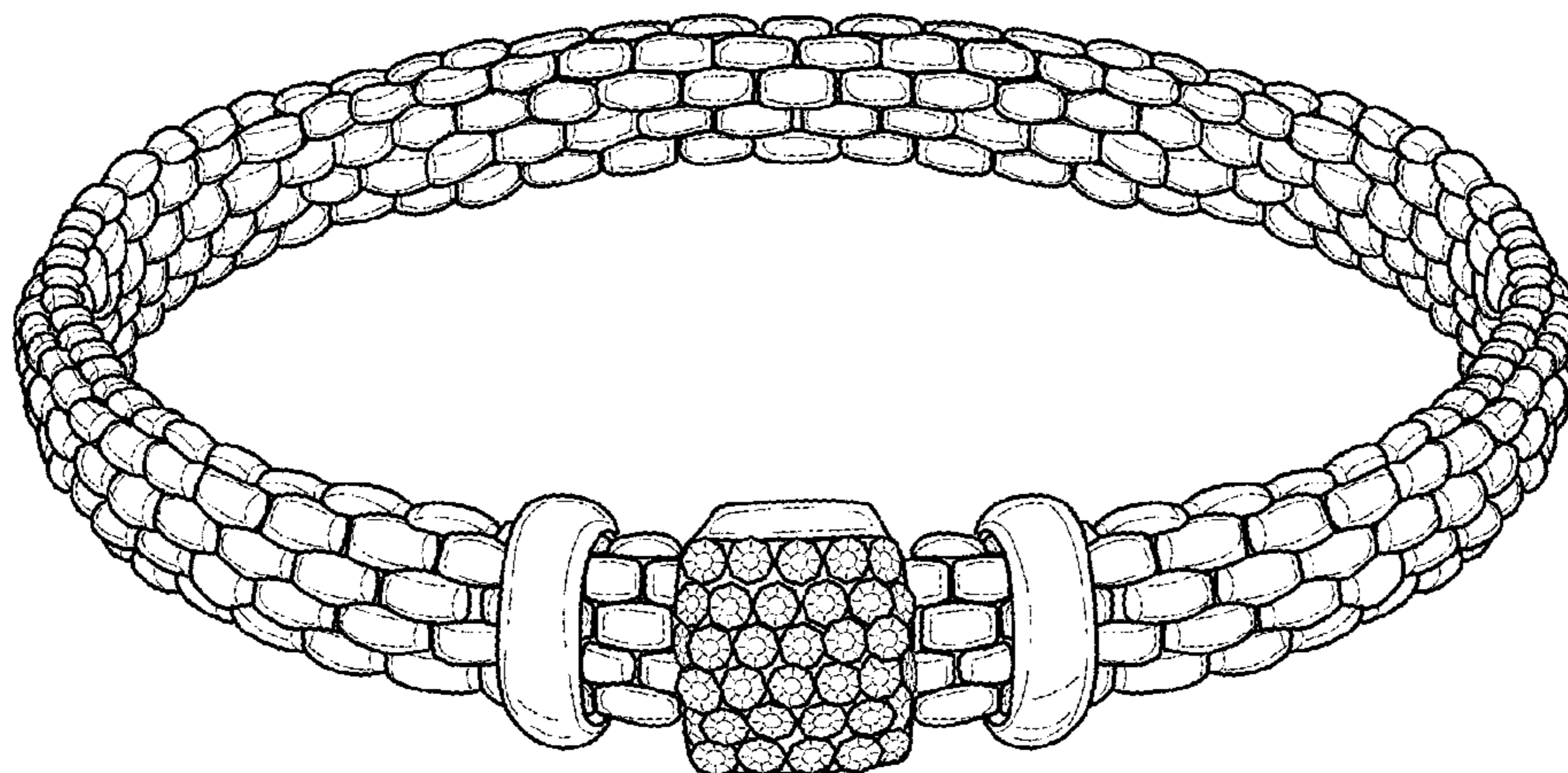
FIG. 2 is a rear perspective view thereof;

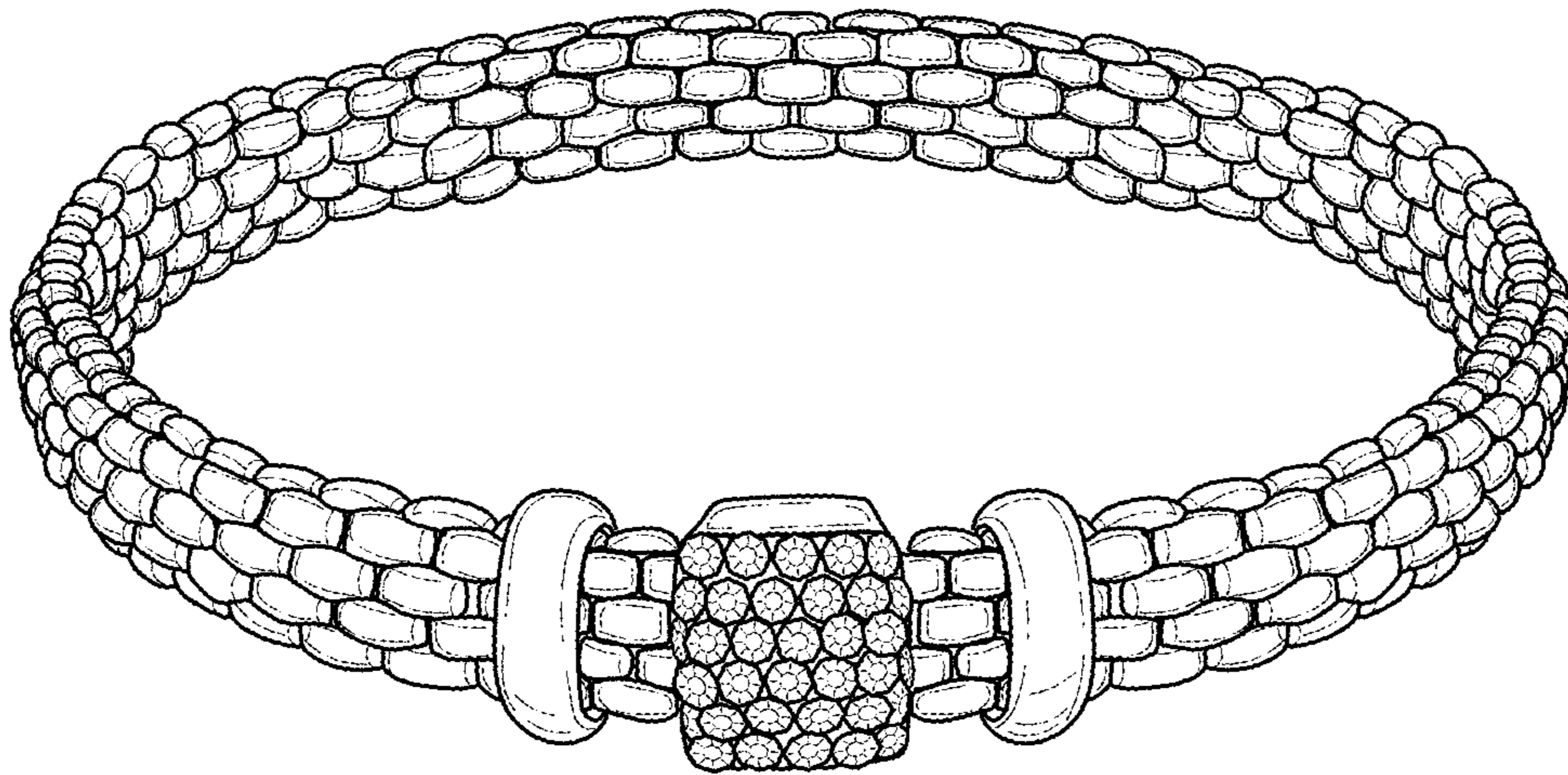

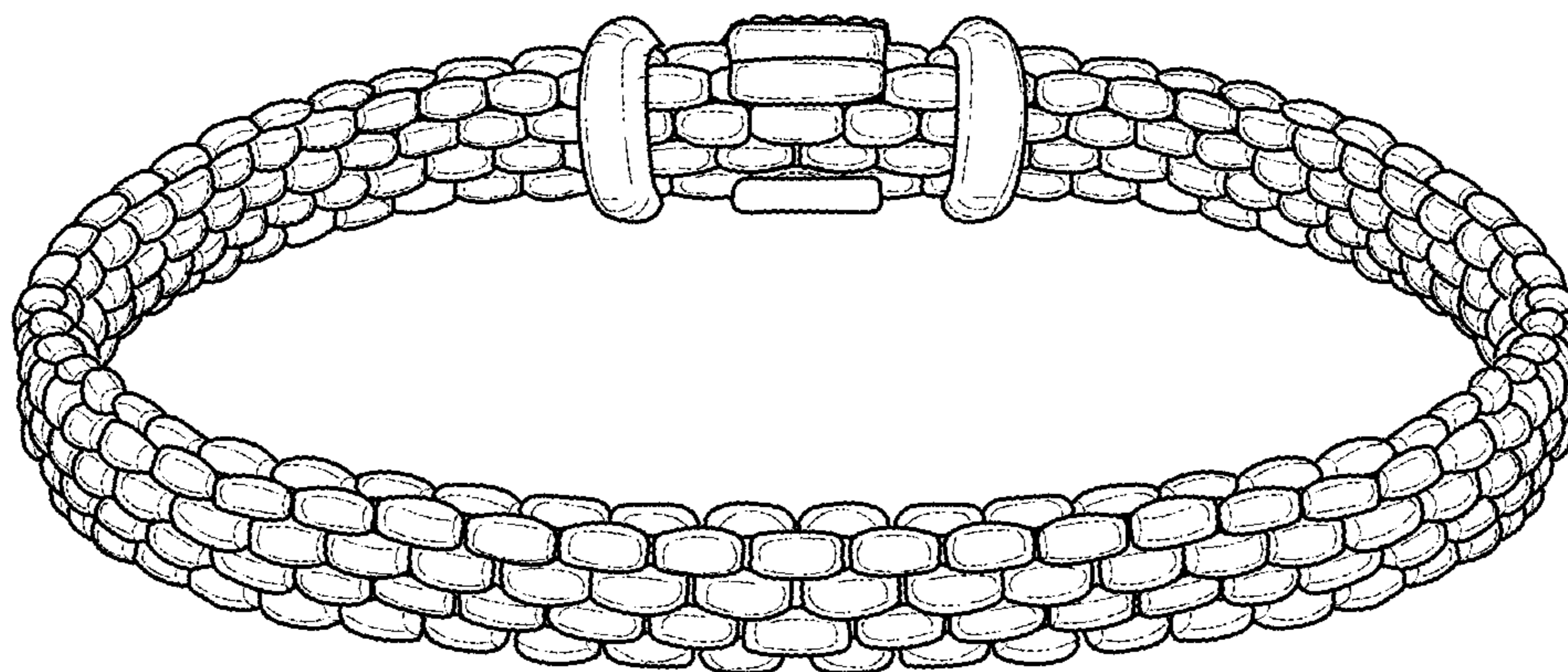

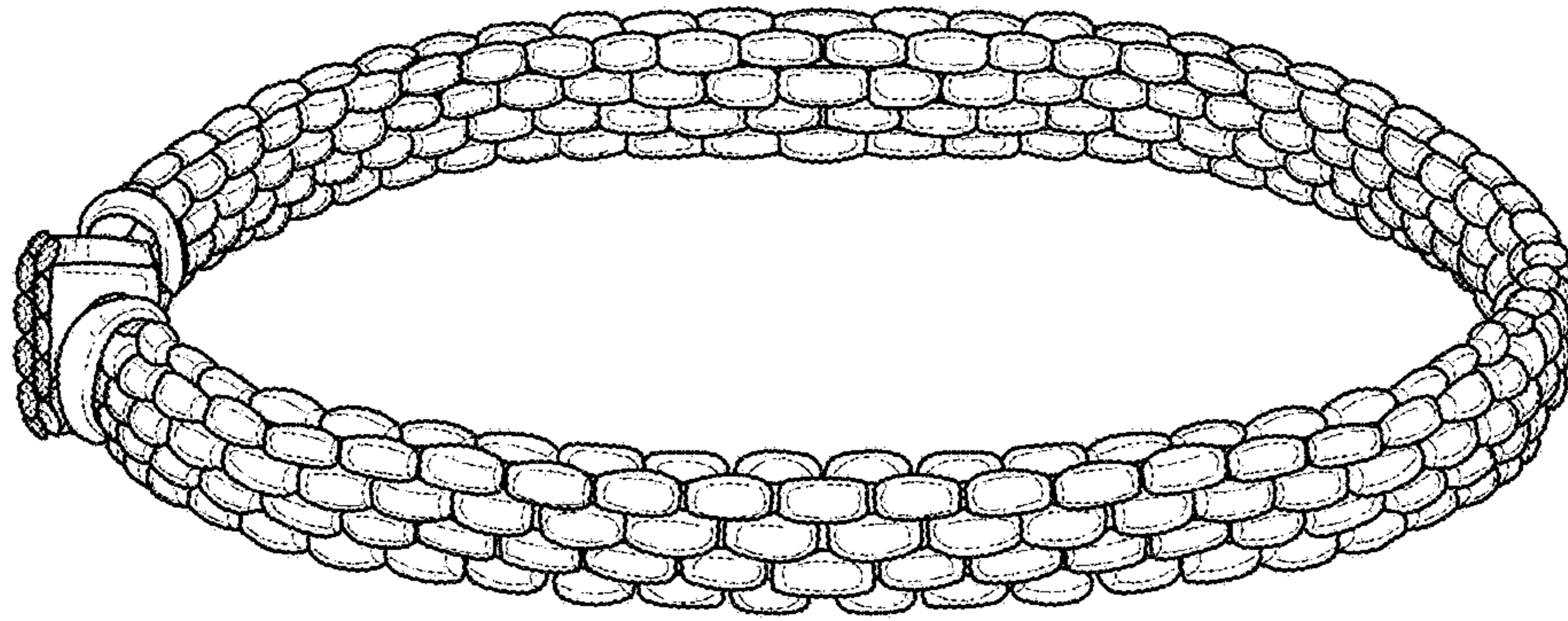

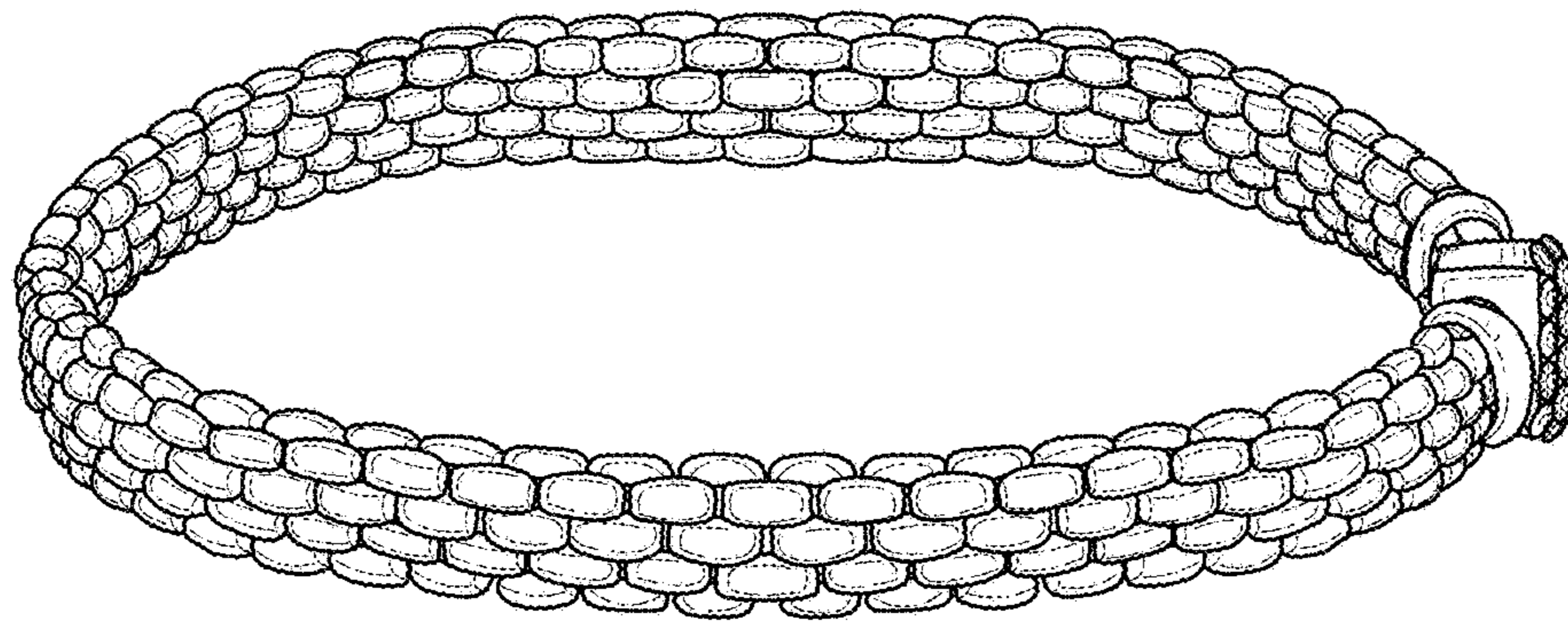
