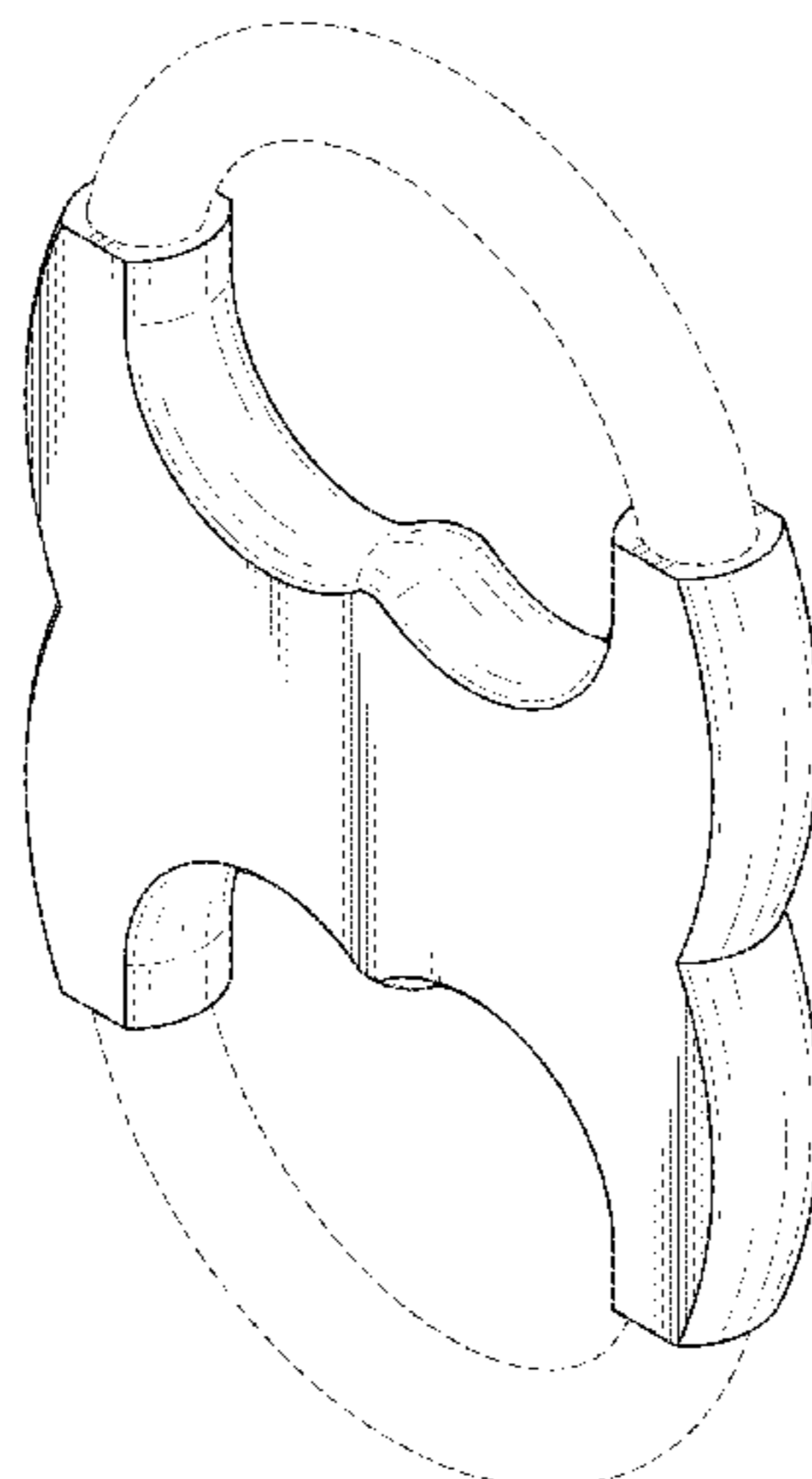
(57) **CLAIM**

The ornamental design for a decorative link, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of a decorative link. FIG. 2 is a front view of the decorative link of FIG. 1, with the rear view being a mirror image thereof. FIG. 3 is a right side view of the decorative link of FIG. 1, with the left side being a mirror image thereof; and, FIG. 4 is a top side view of the decorative link of FIG. 1, with the bottom view being a mirror image thereof. The broken lines illustrate portions of the decorative link that form no part of the claimed design.

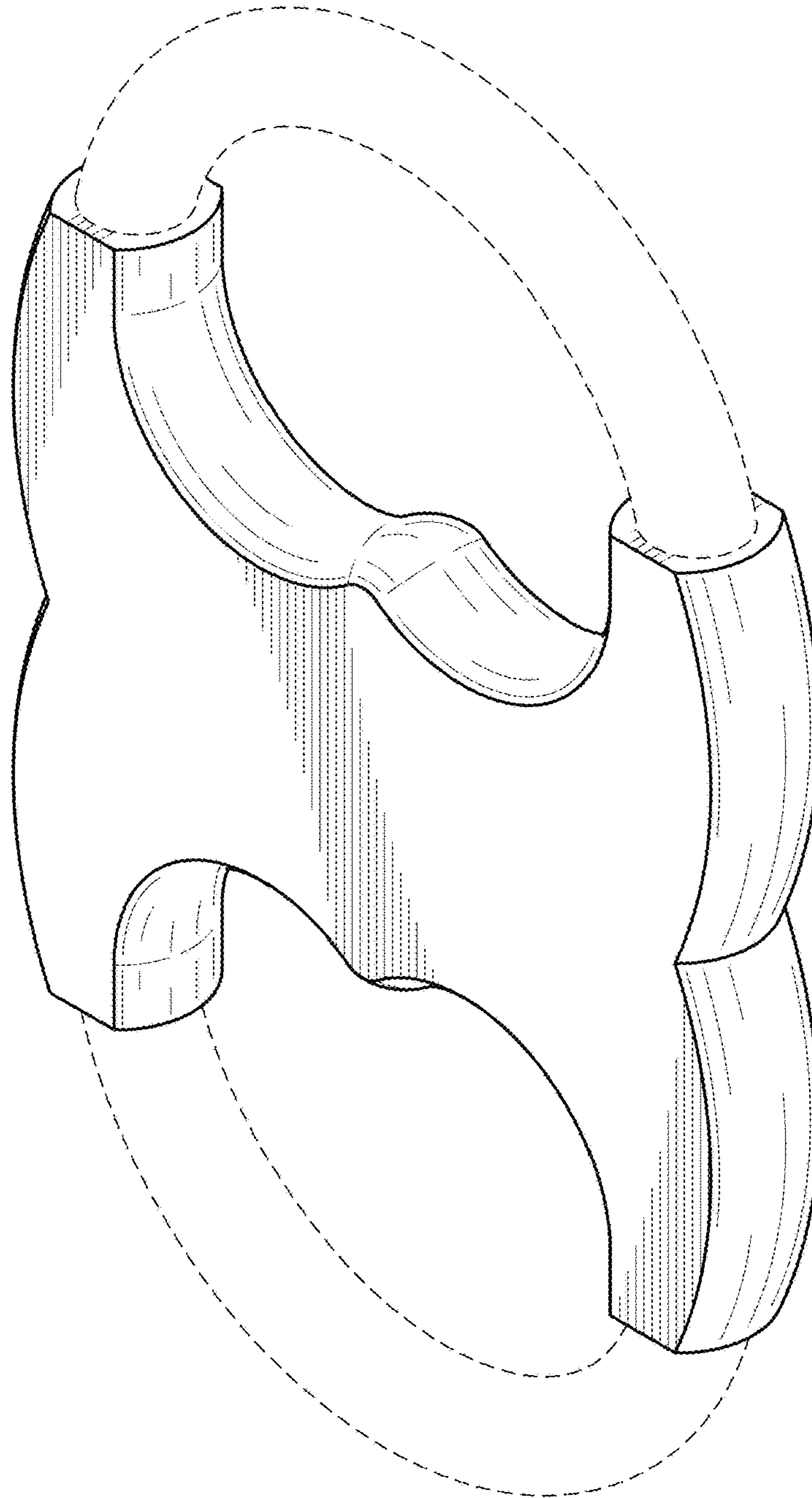

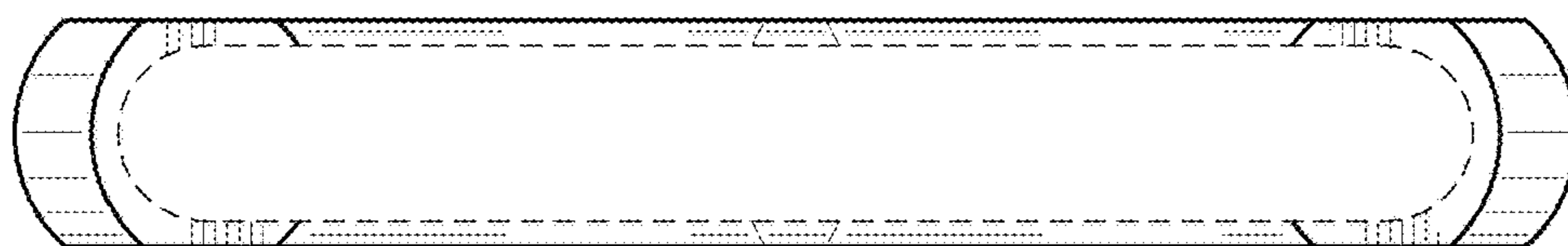

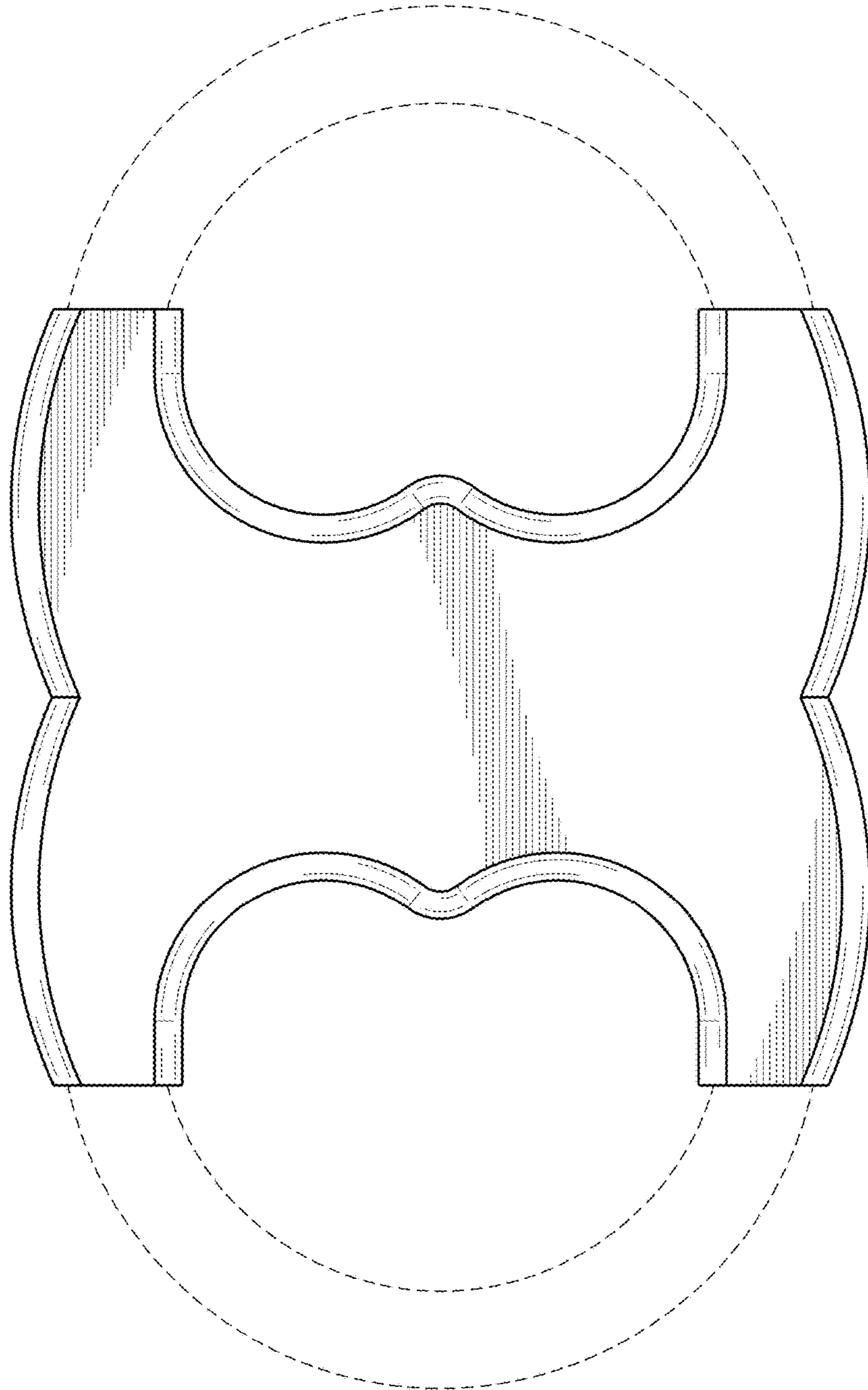

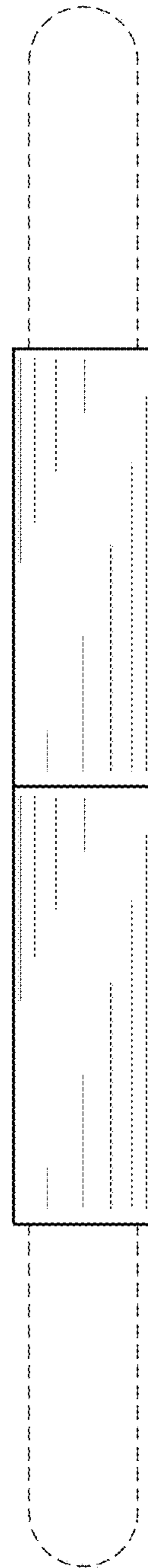
