FIG. 2 is a left, rear perspective view thereof;

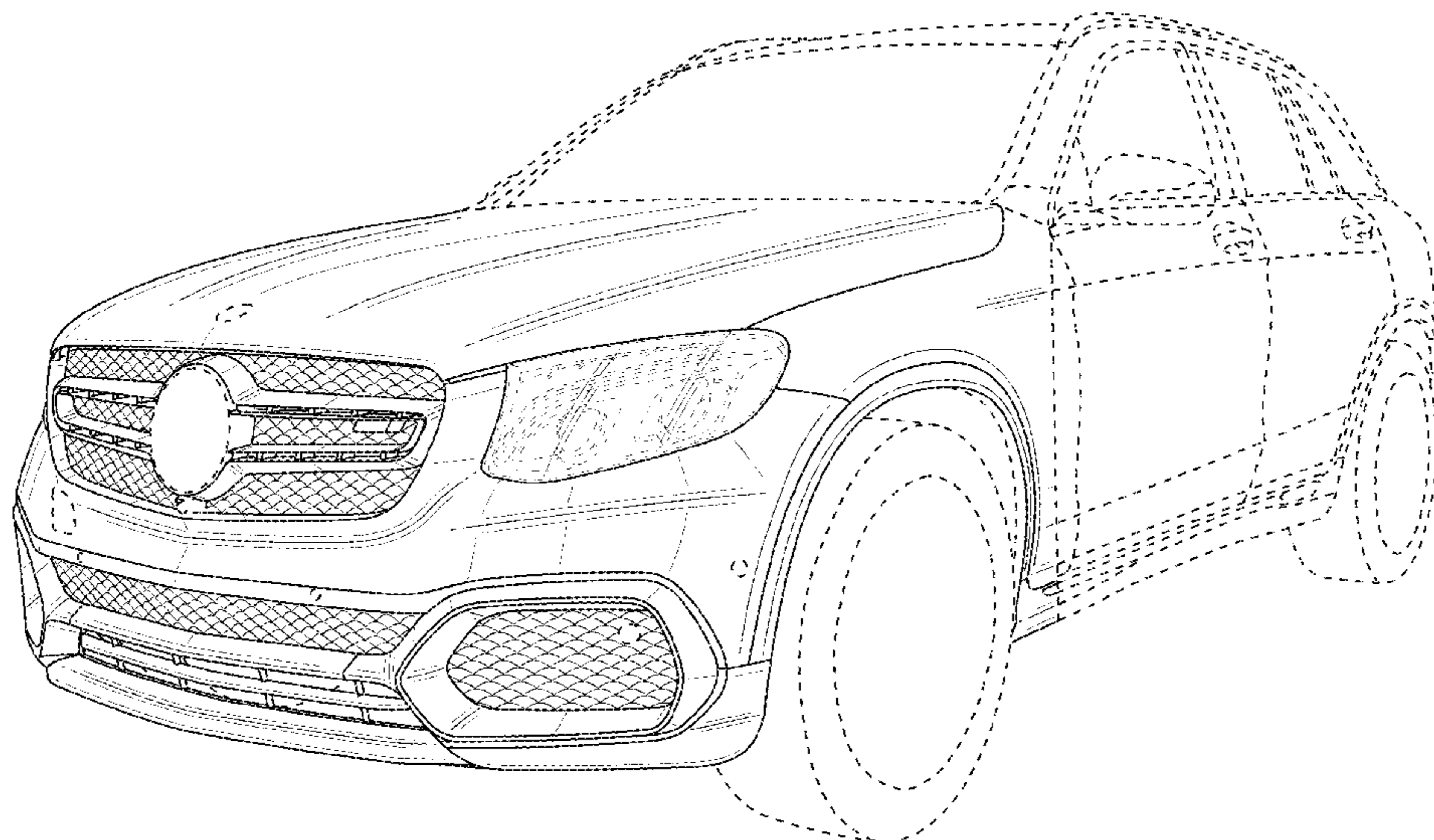
FIG. 3 is a front view thereof;

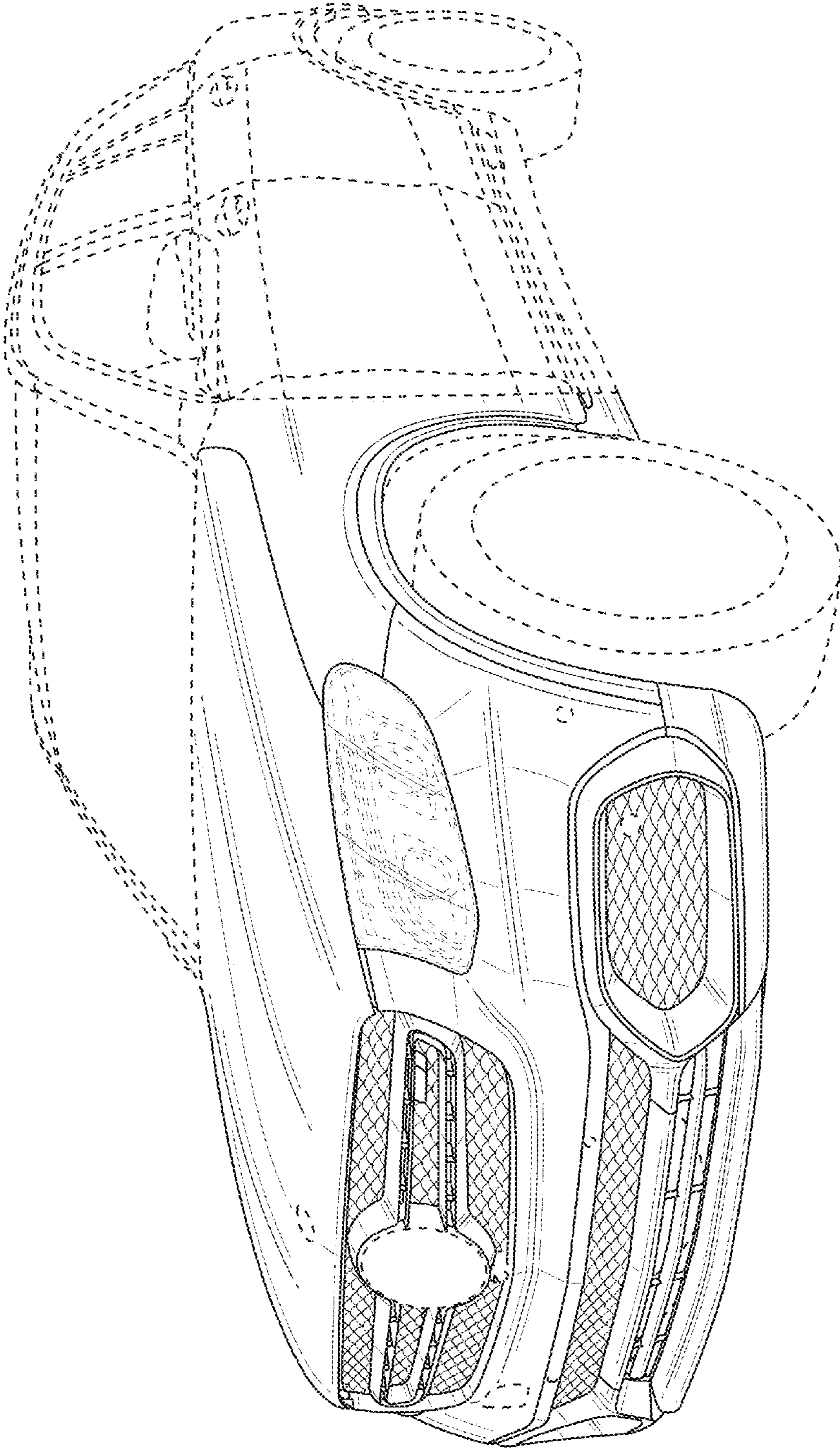

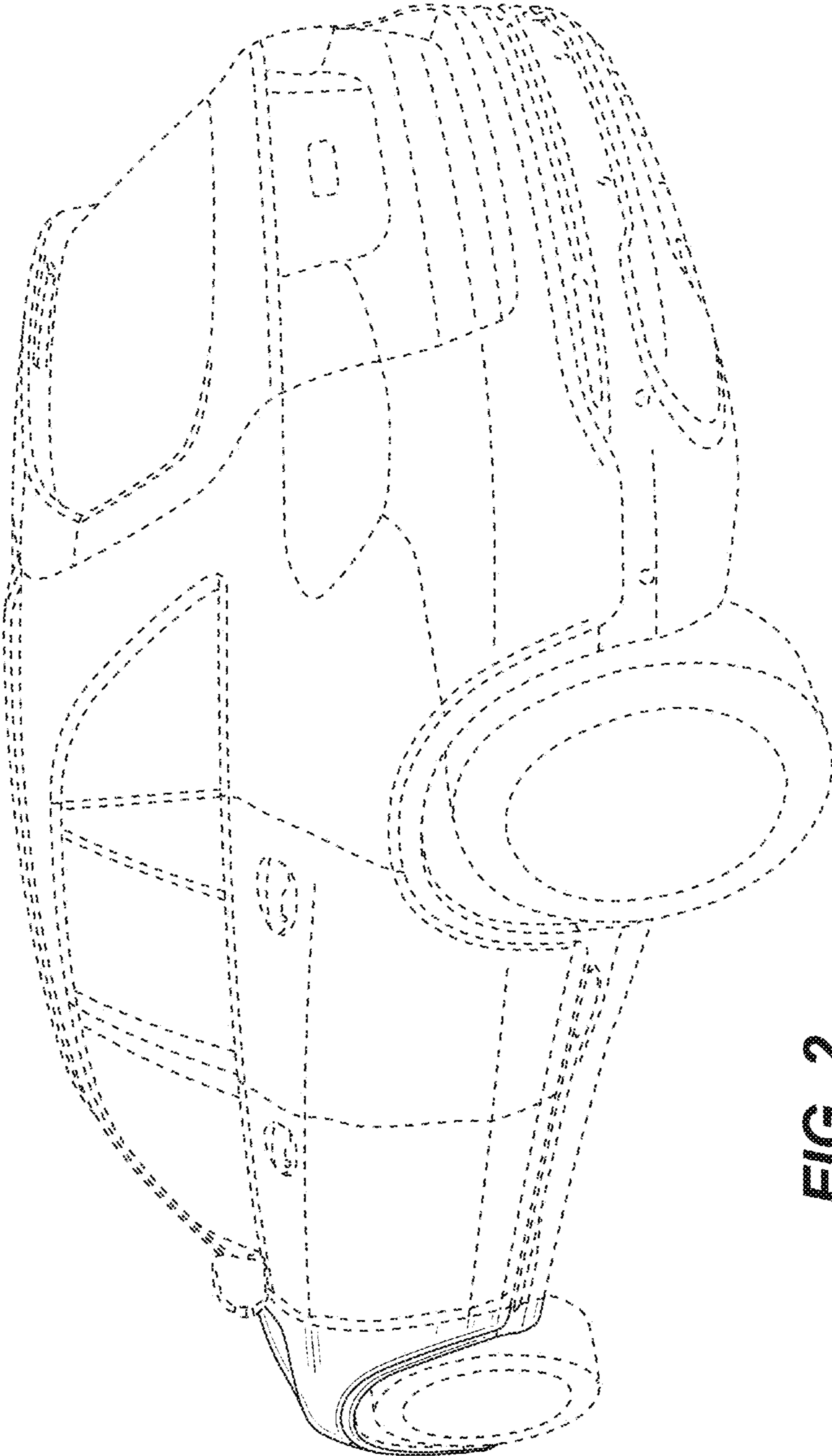

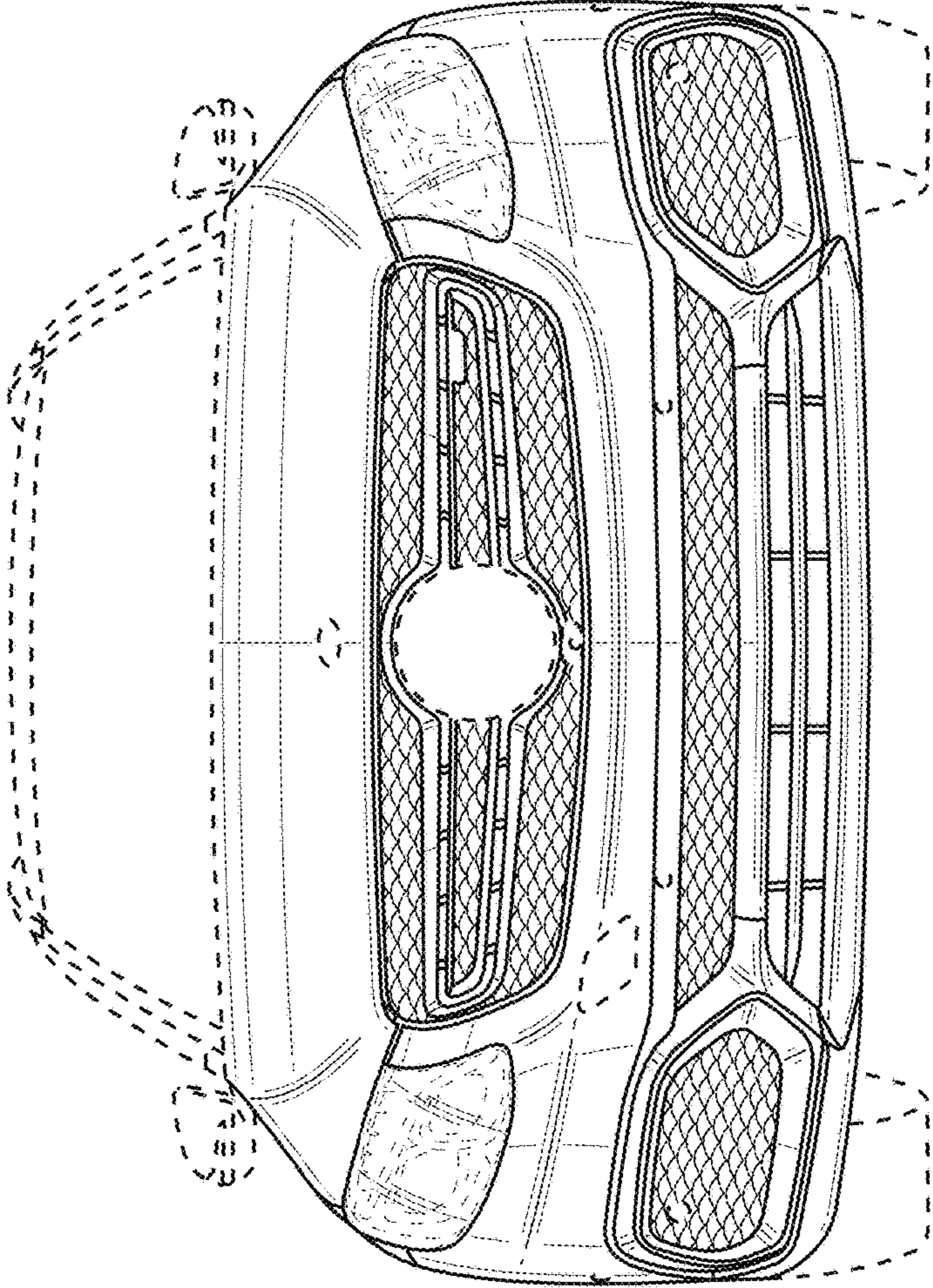

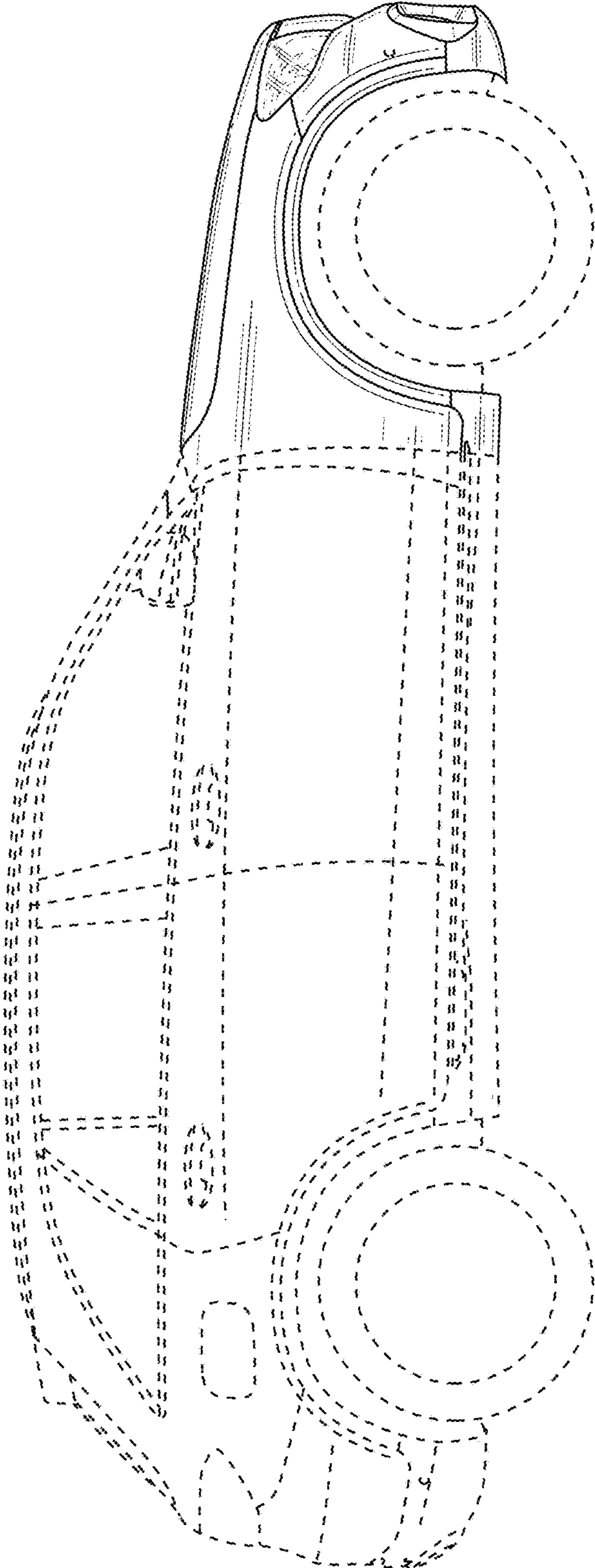

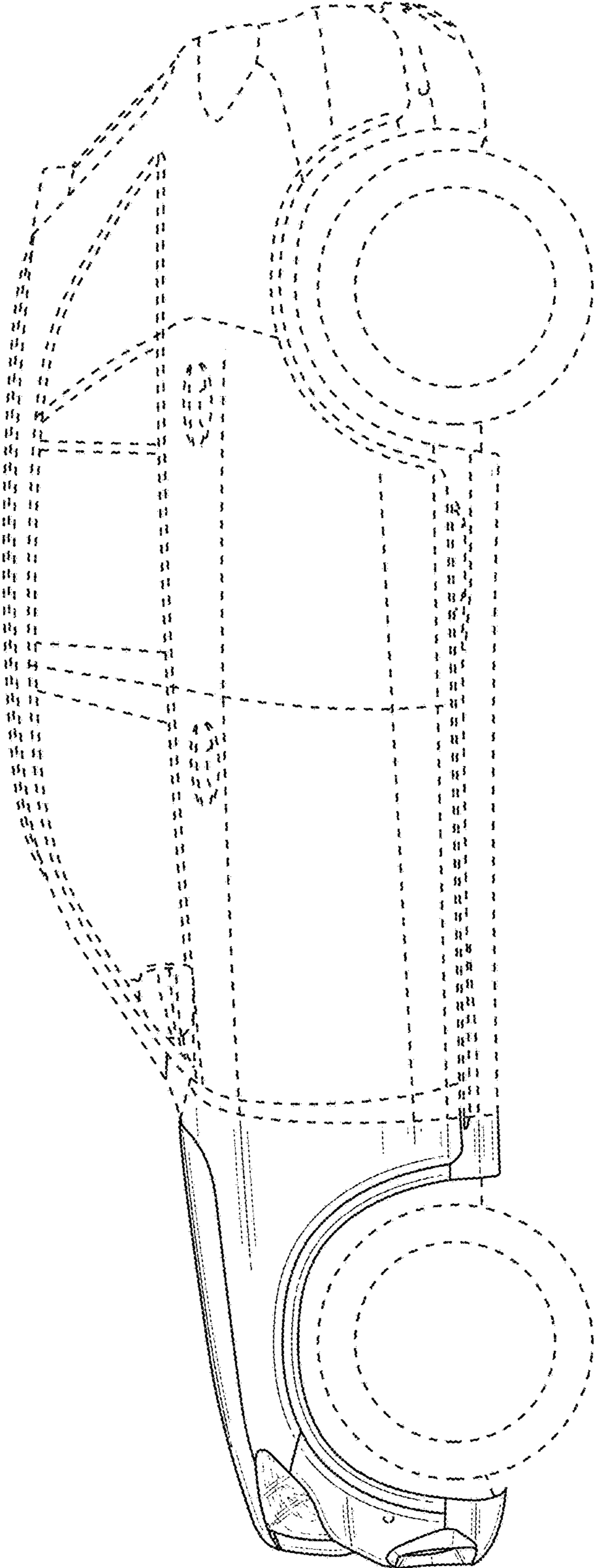
